FIG. 2 is a reduced left side view thereof;

FIG. 6 is a reduced top view thereof; and,

FIG. 7 is a reduced bottom view thereof.

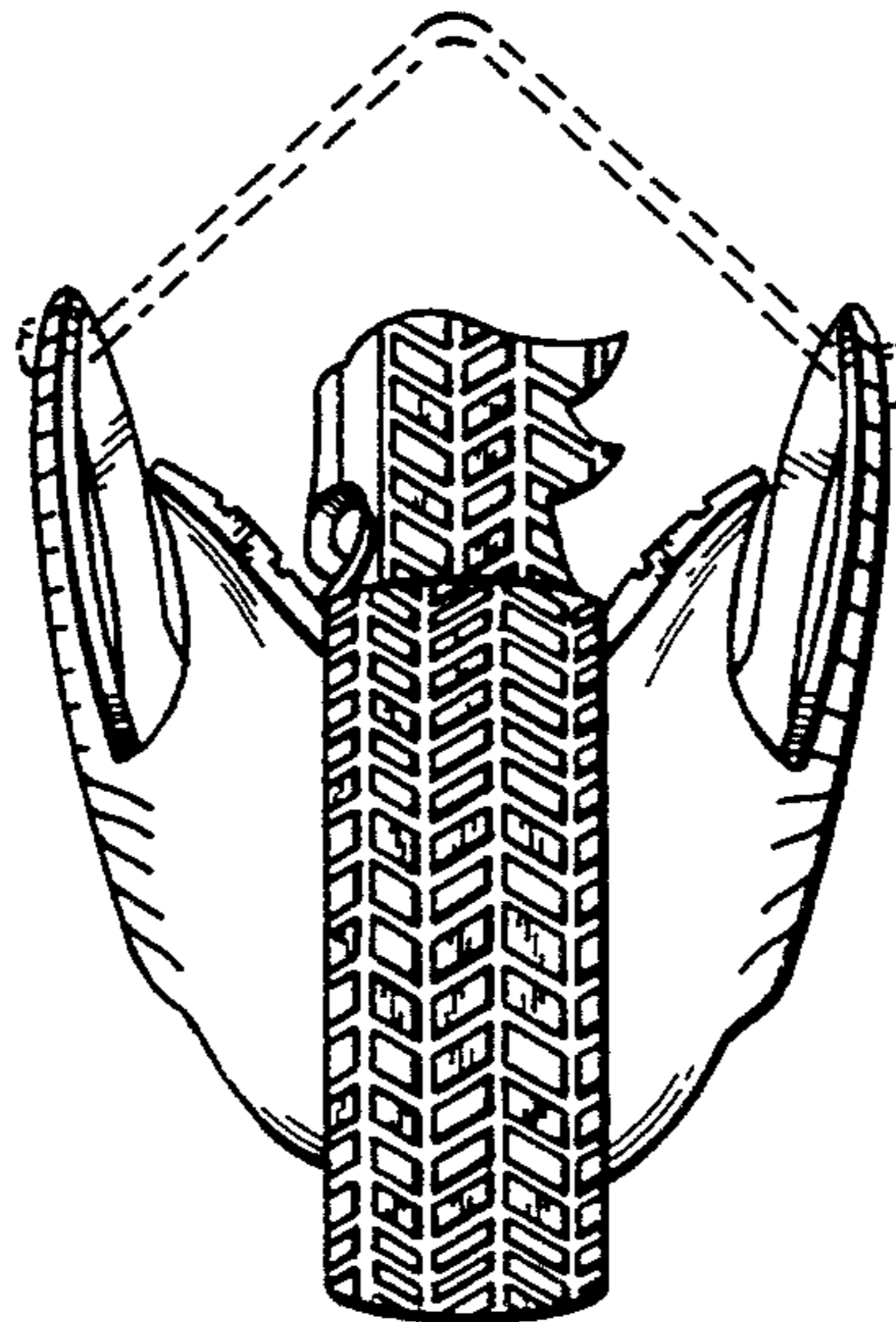
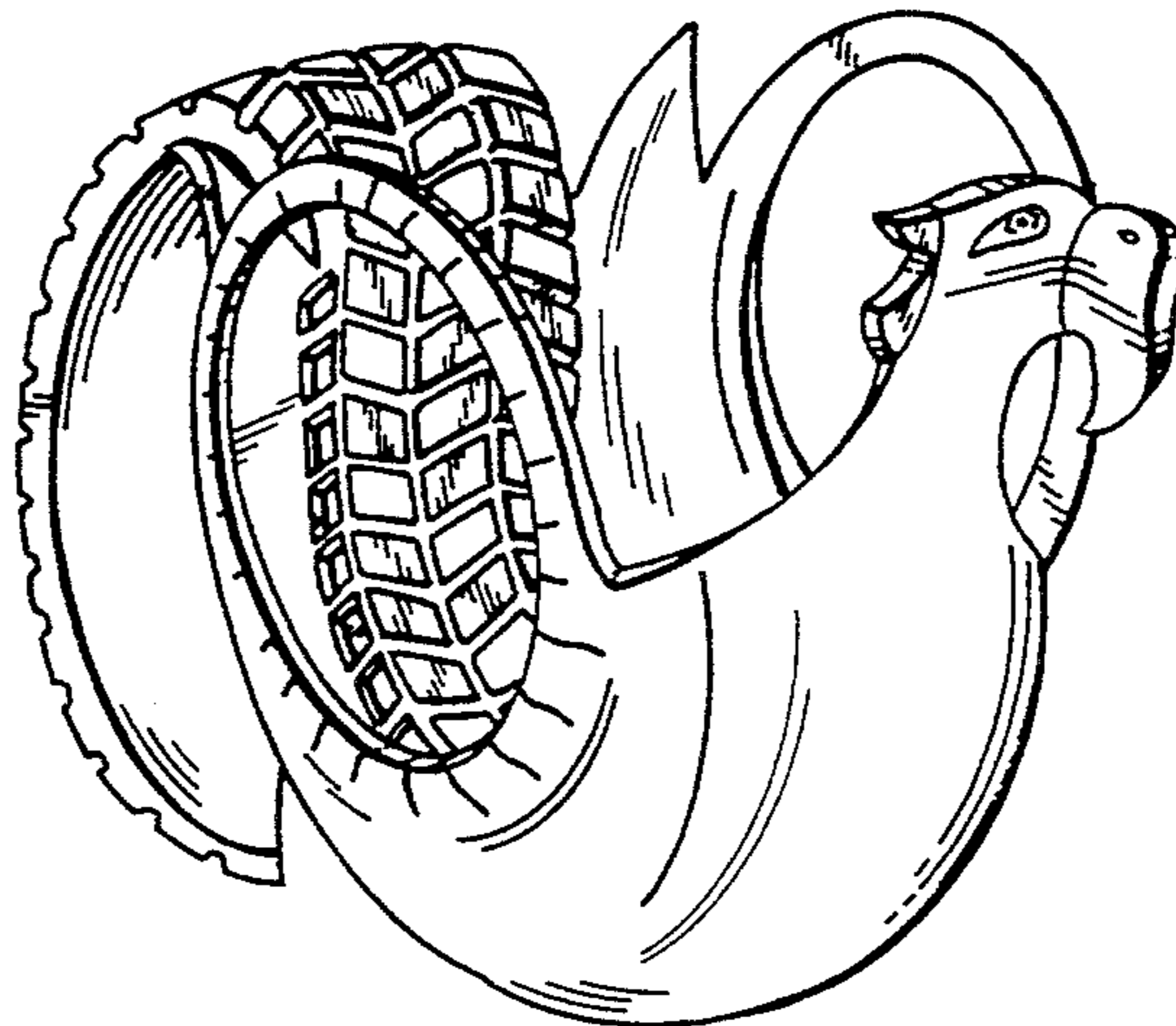

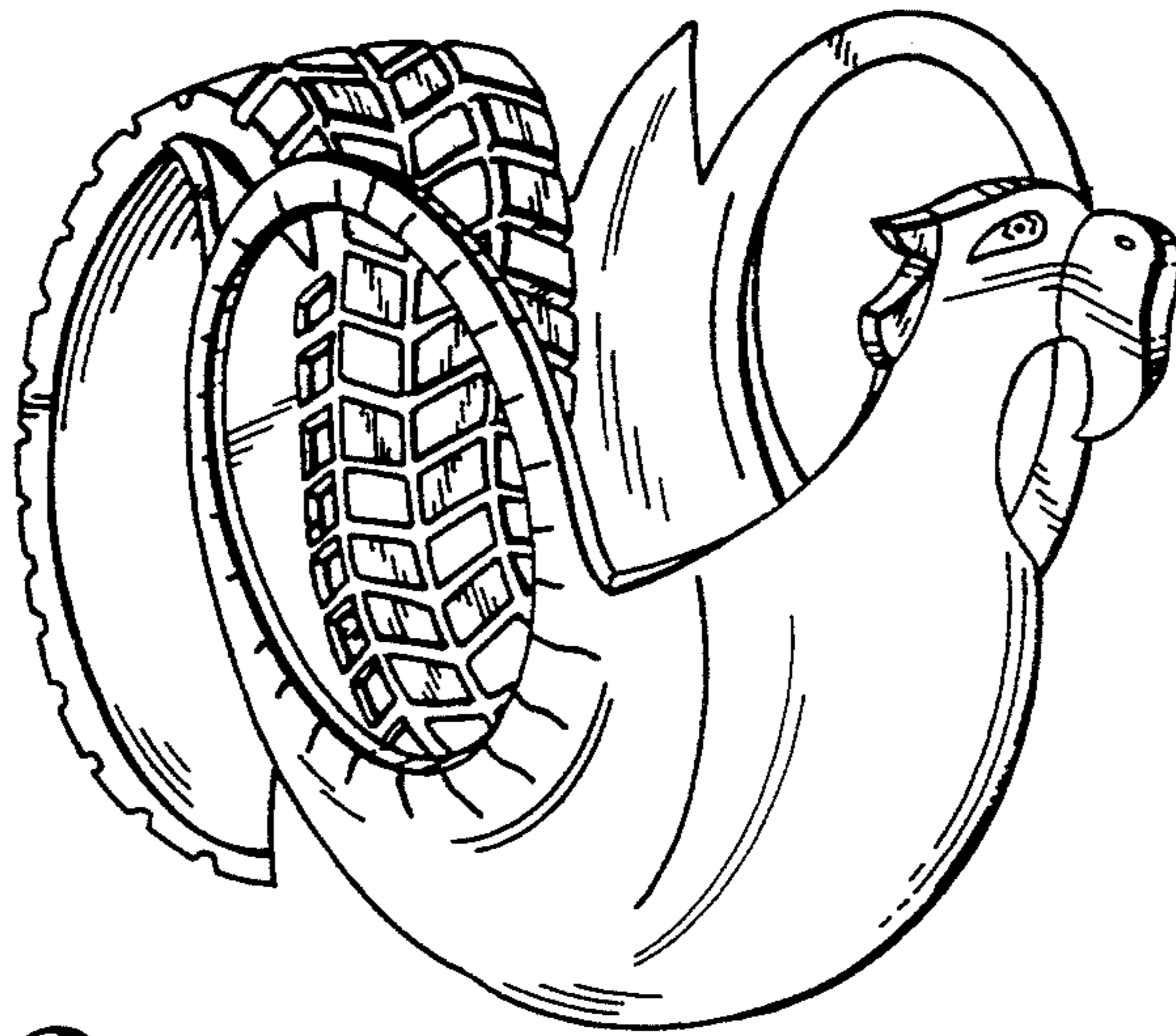

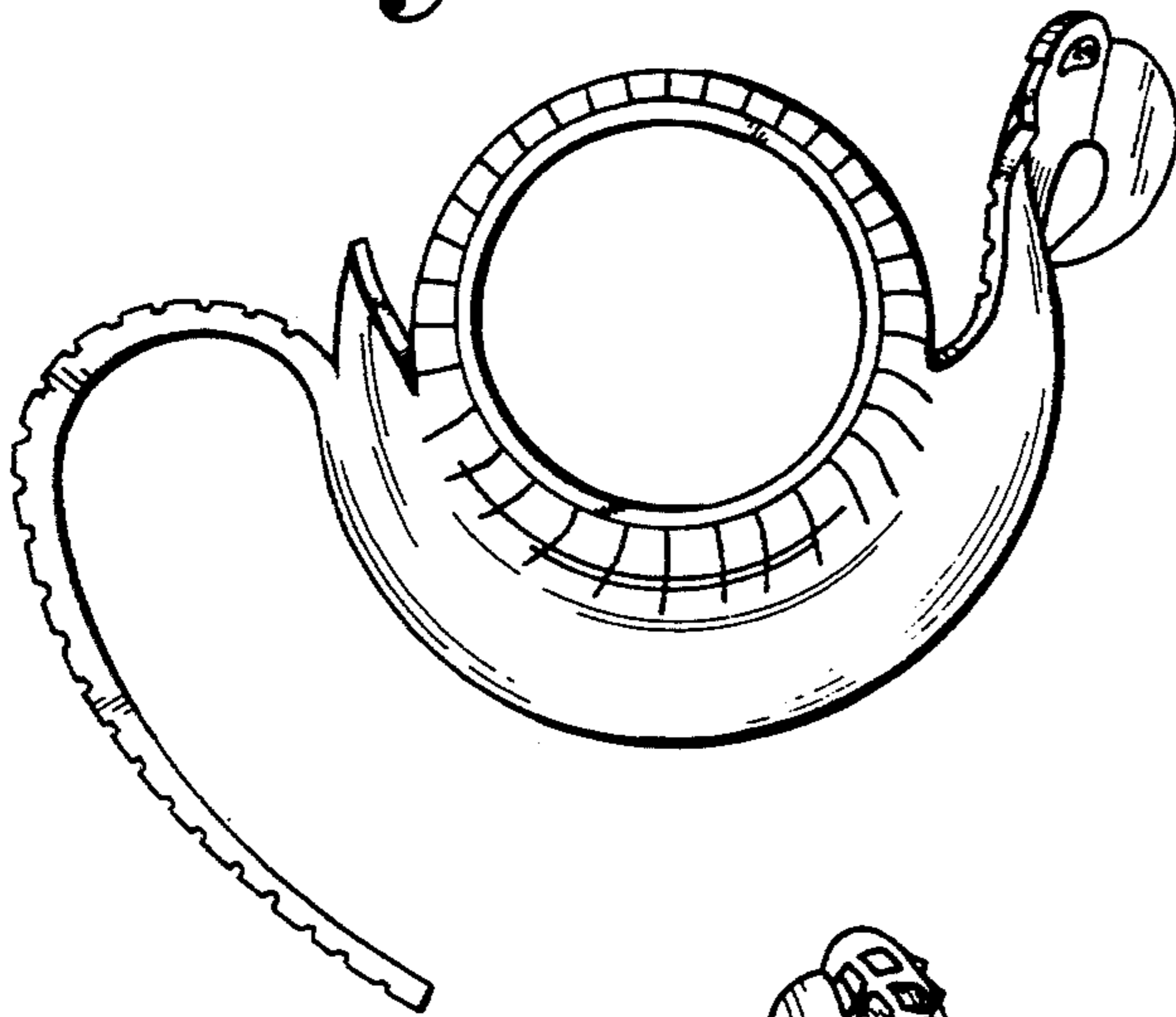

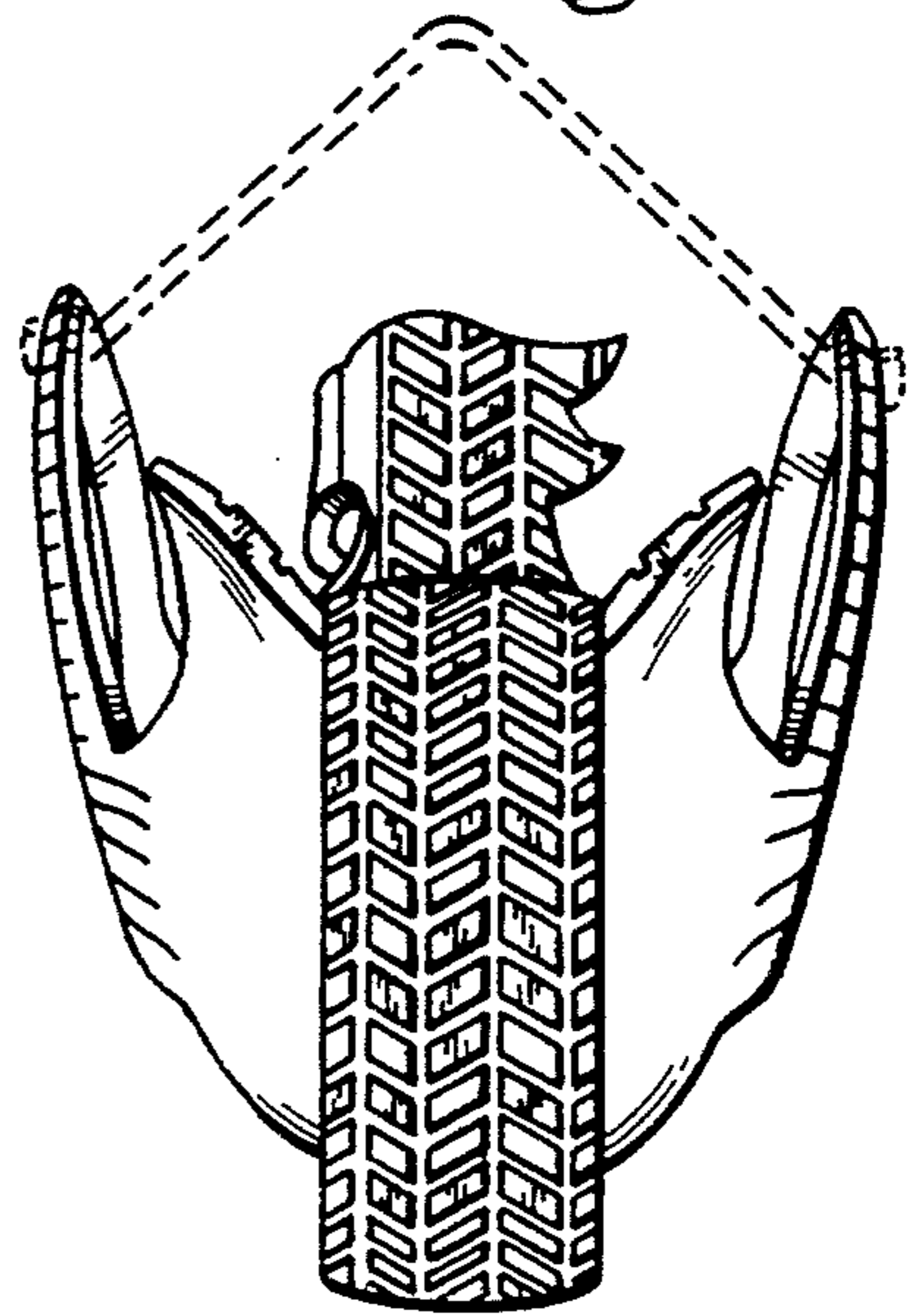
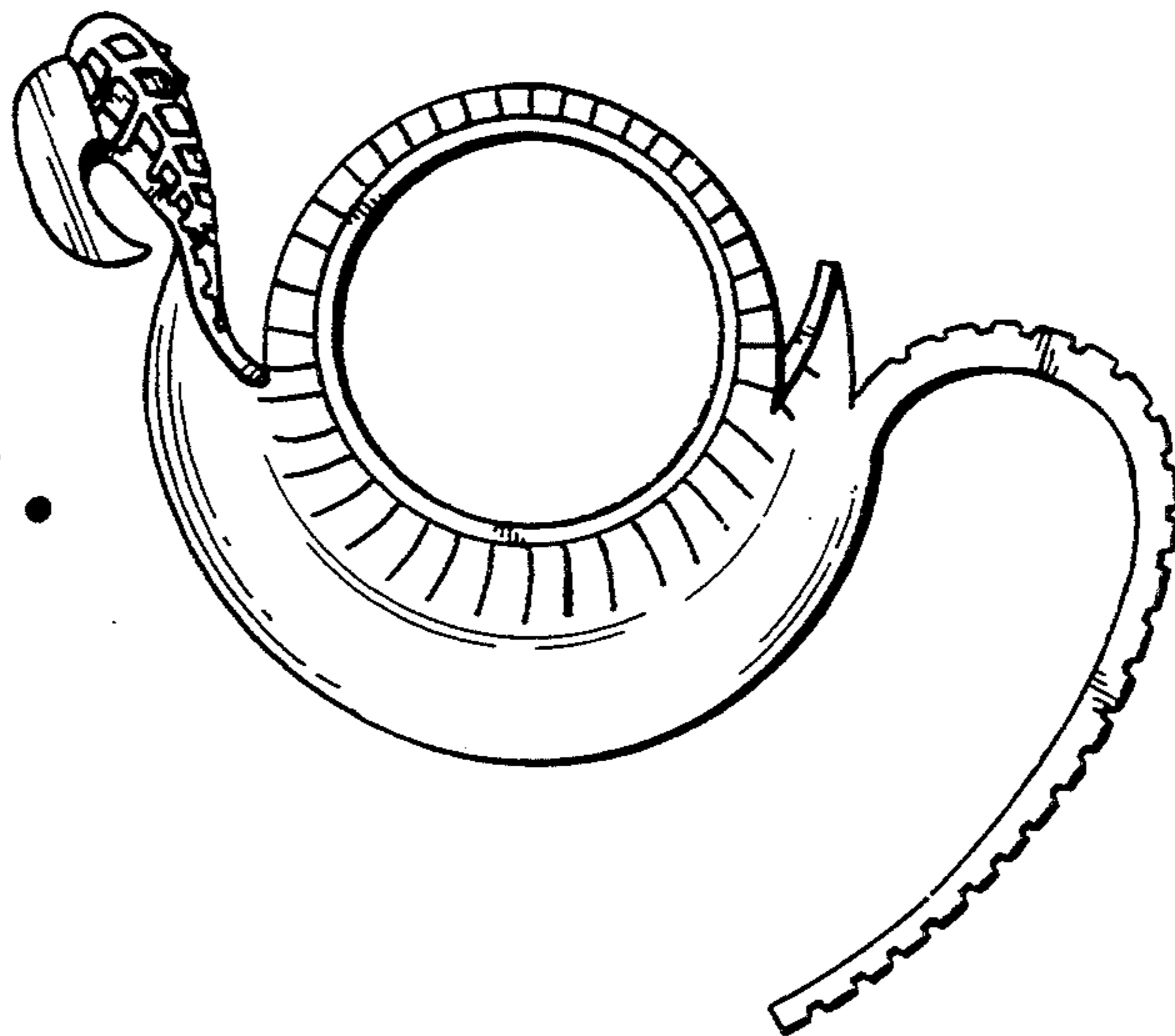

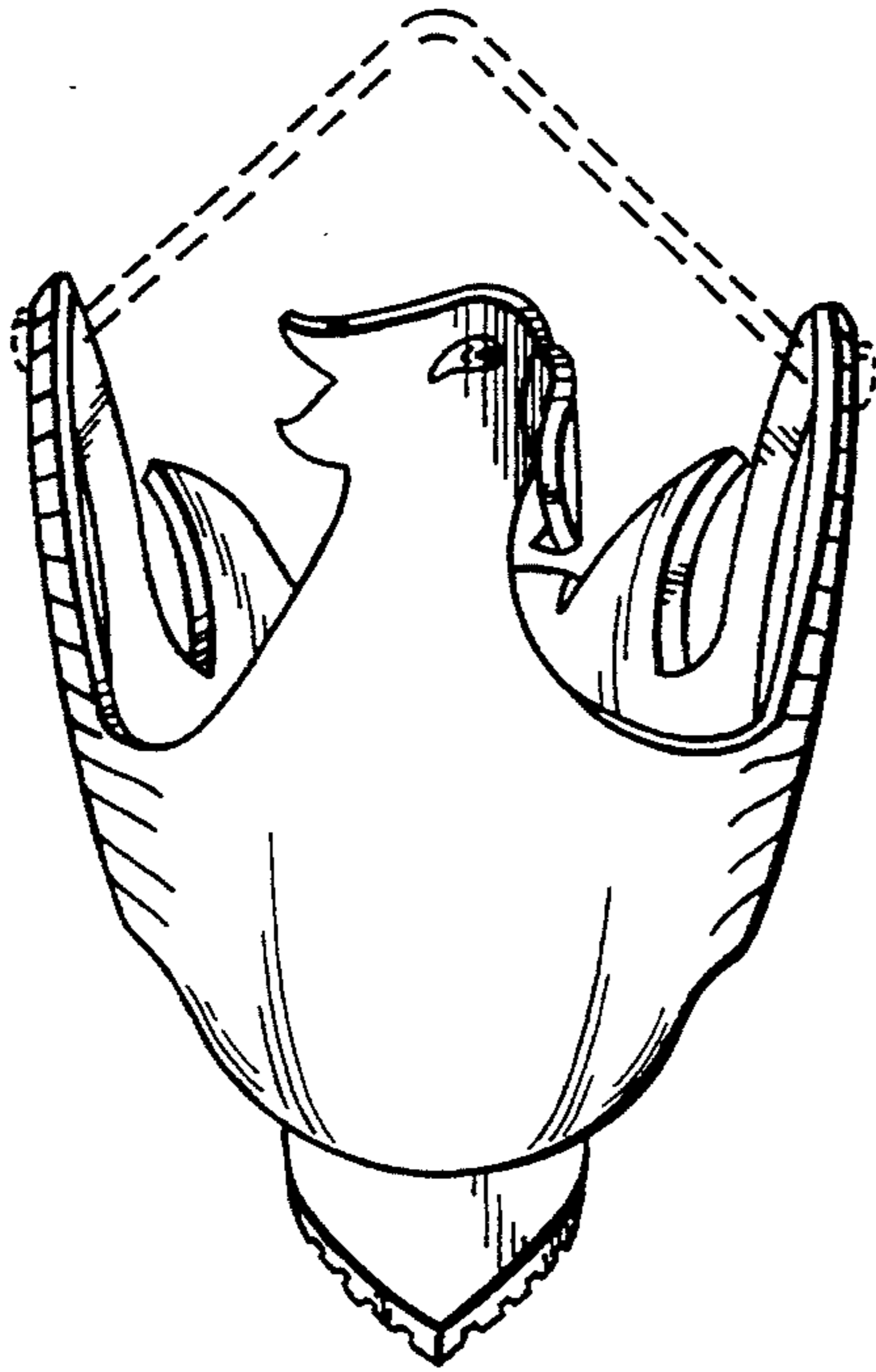

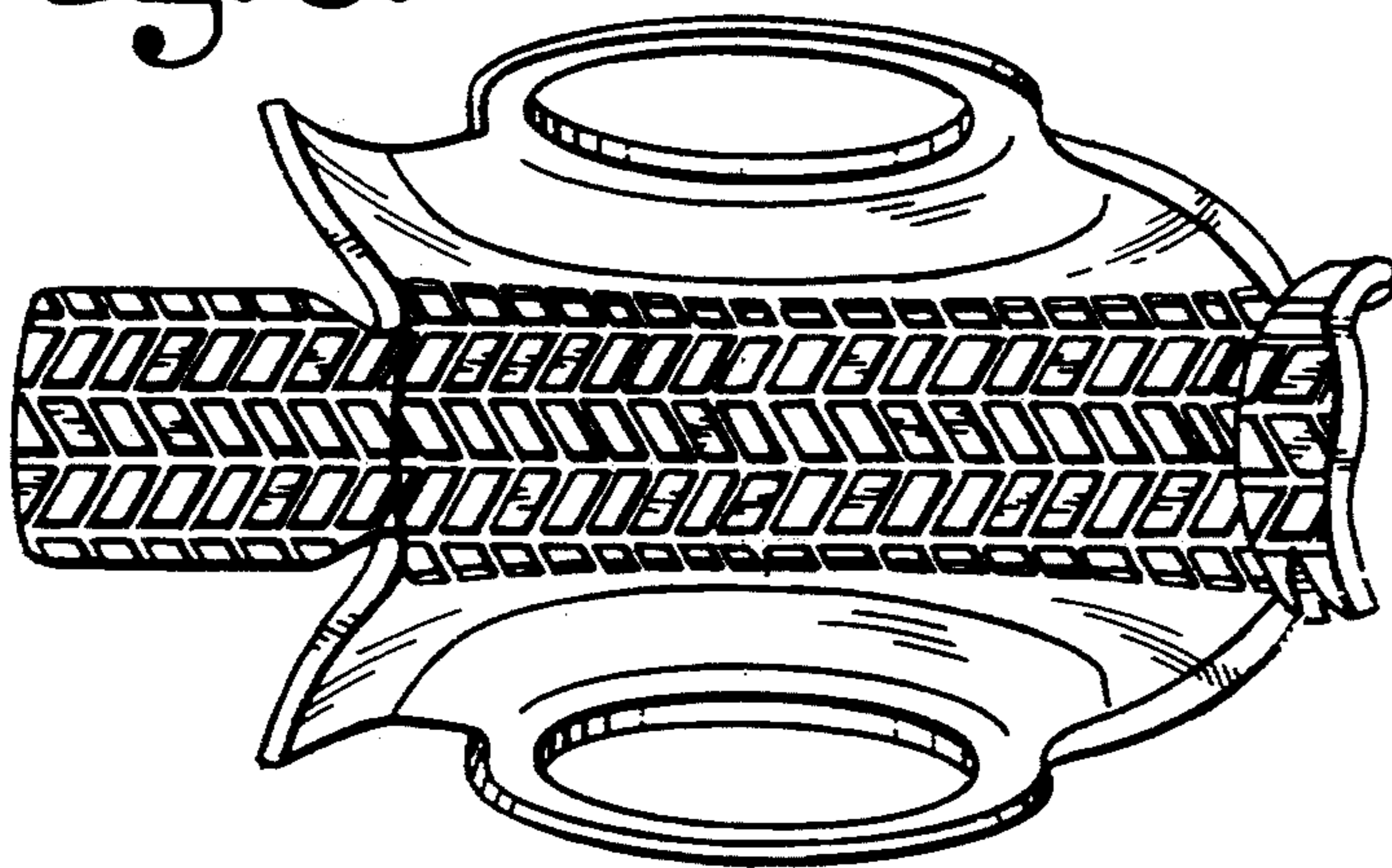
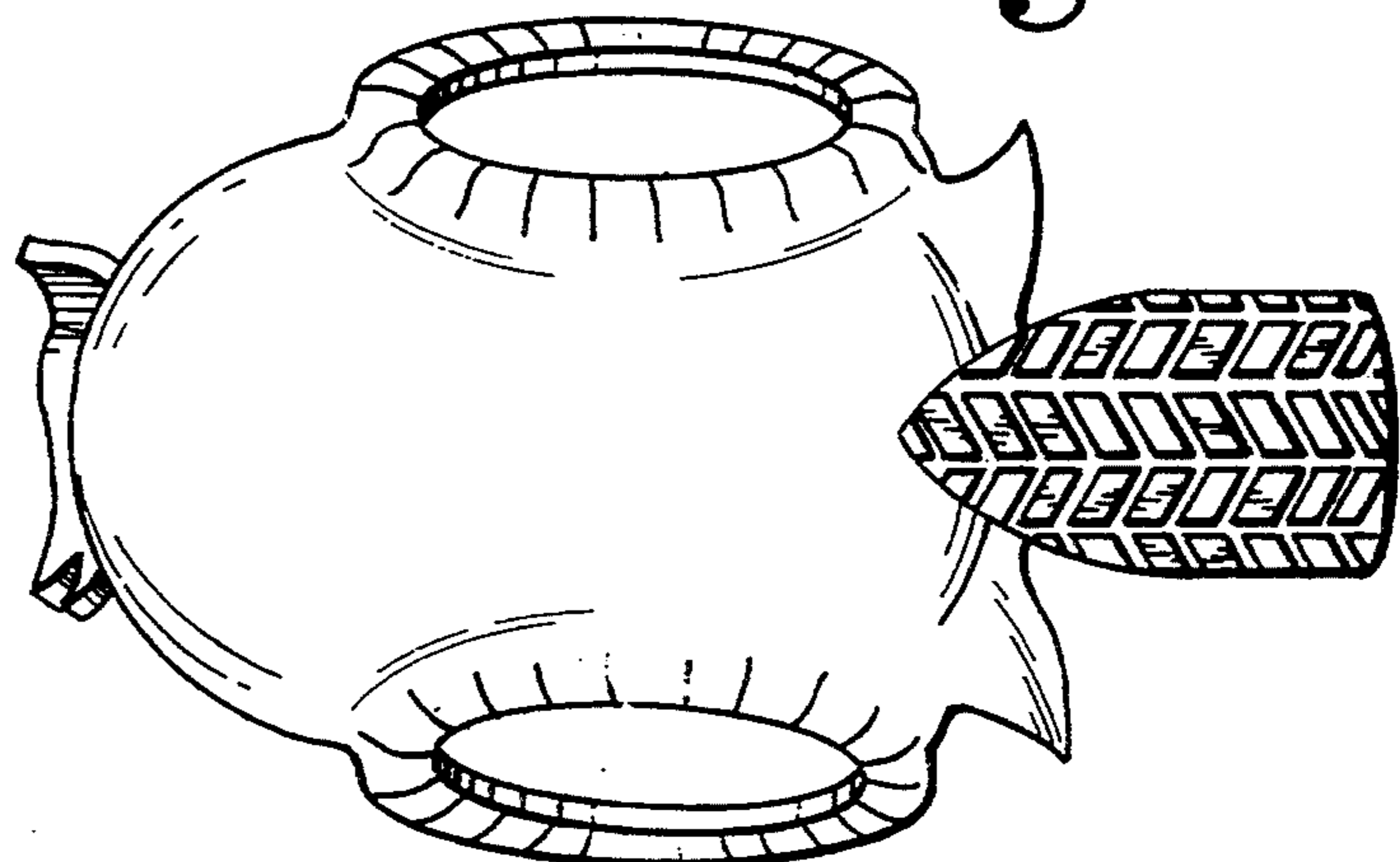
