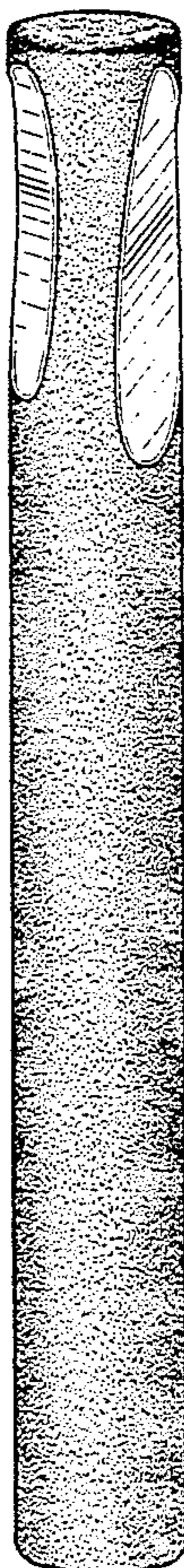

DESCRIPTION

FIG. 1 is a perspective of the mascara container; FIG. 2 is a right lateral view of the mascara container; FIG. 3 is a left lateral view of the mascara container; FIG. 4 is a central lateral view of the mascara container the side opposite being a mirror image of the side shown; FIG. 5 is a top plan view of the mascara container; and, FIG. 6 is a bottom plan view of the mascara container.



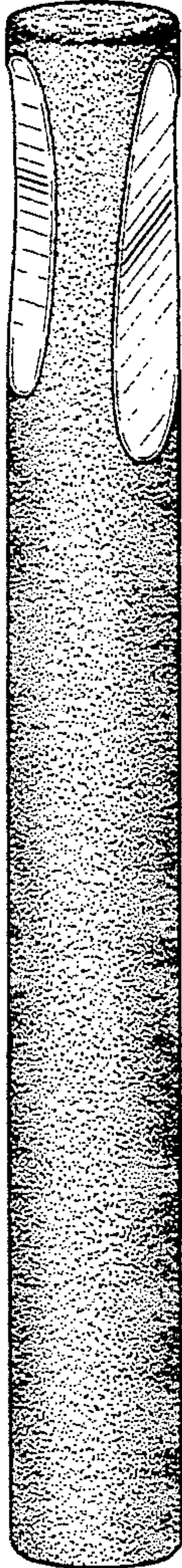

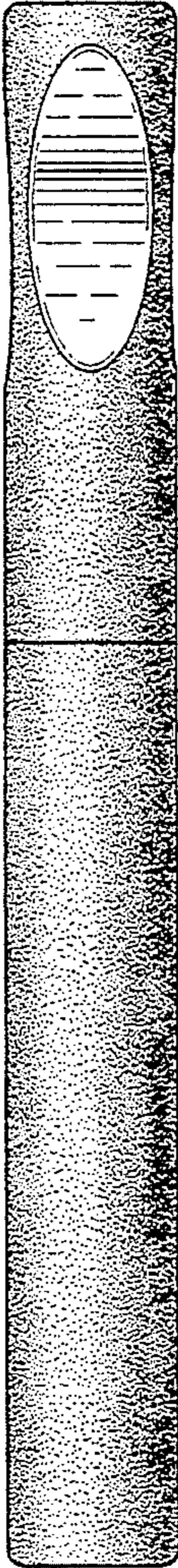

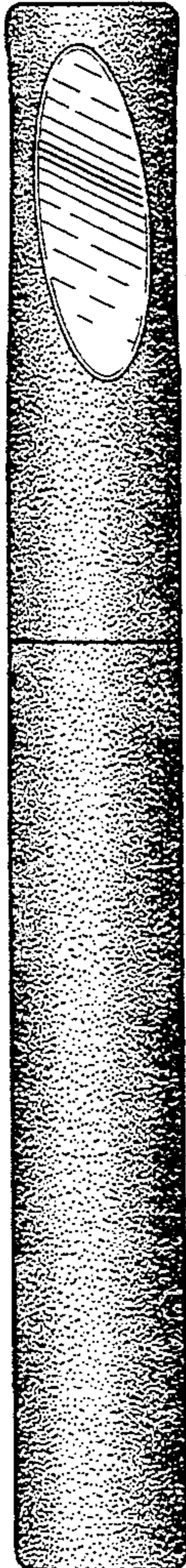

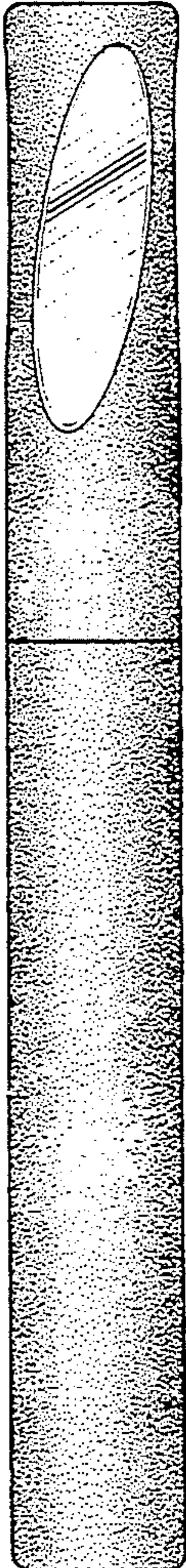

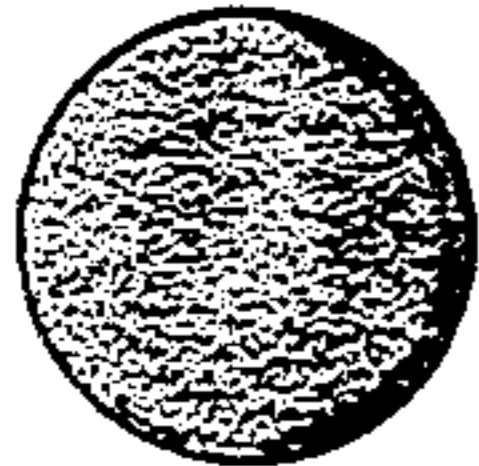
