The ornamental design for the squirrel guard, as shown and described.

## DESCRIPTION

FIG. 1 is a front elevational view of the squirrel guard showing my new design;  
FIG. 2 is a rear elevational view thereof, the broken line showing of the bird feeder for illustrative purposes only forming no part of the claimed design;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

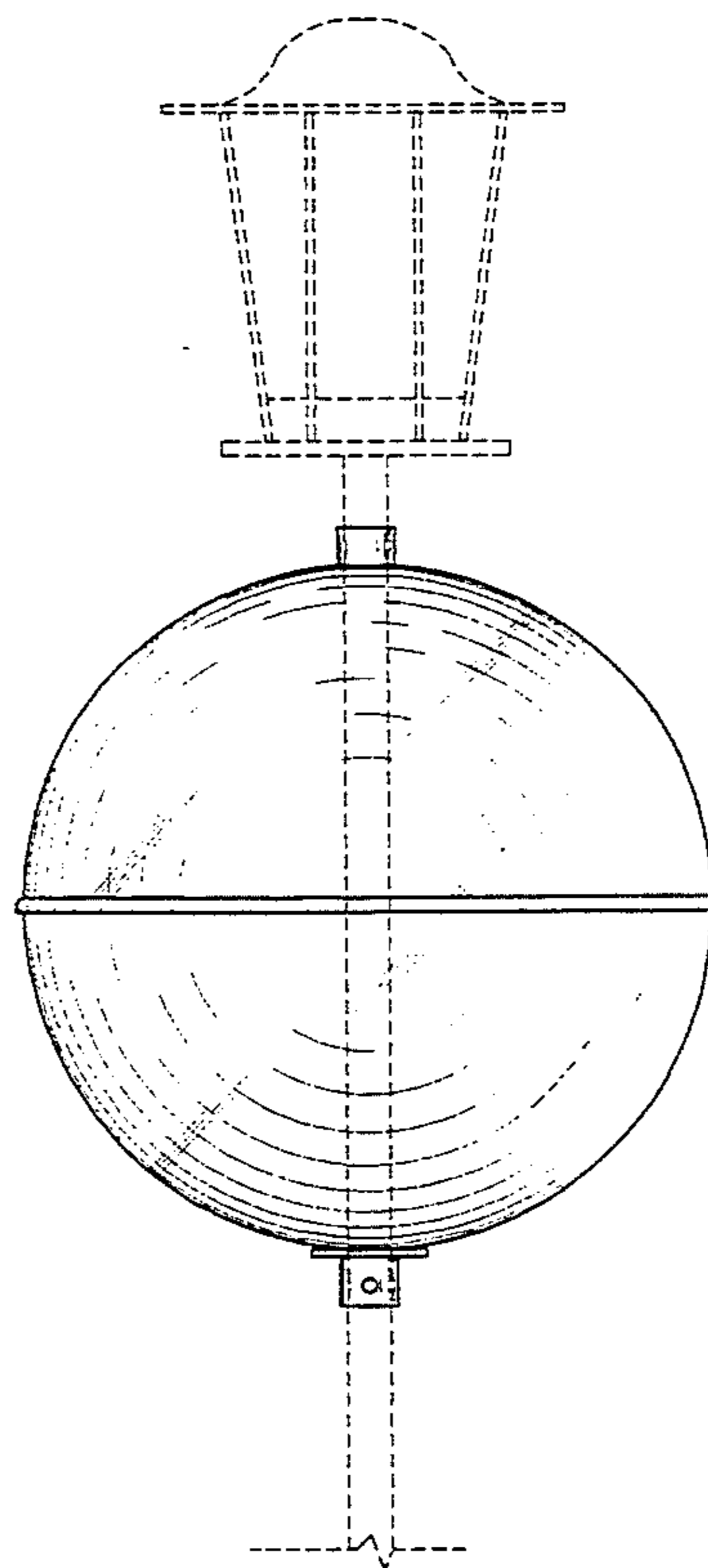

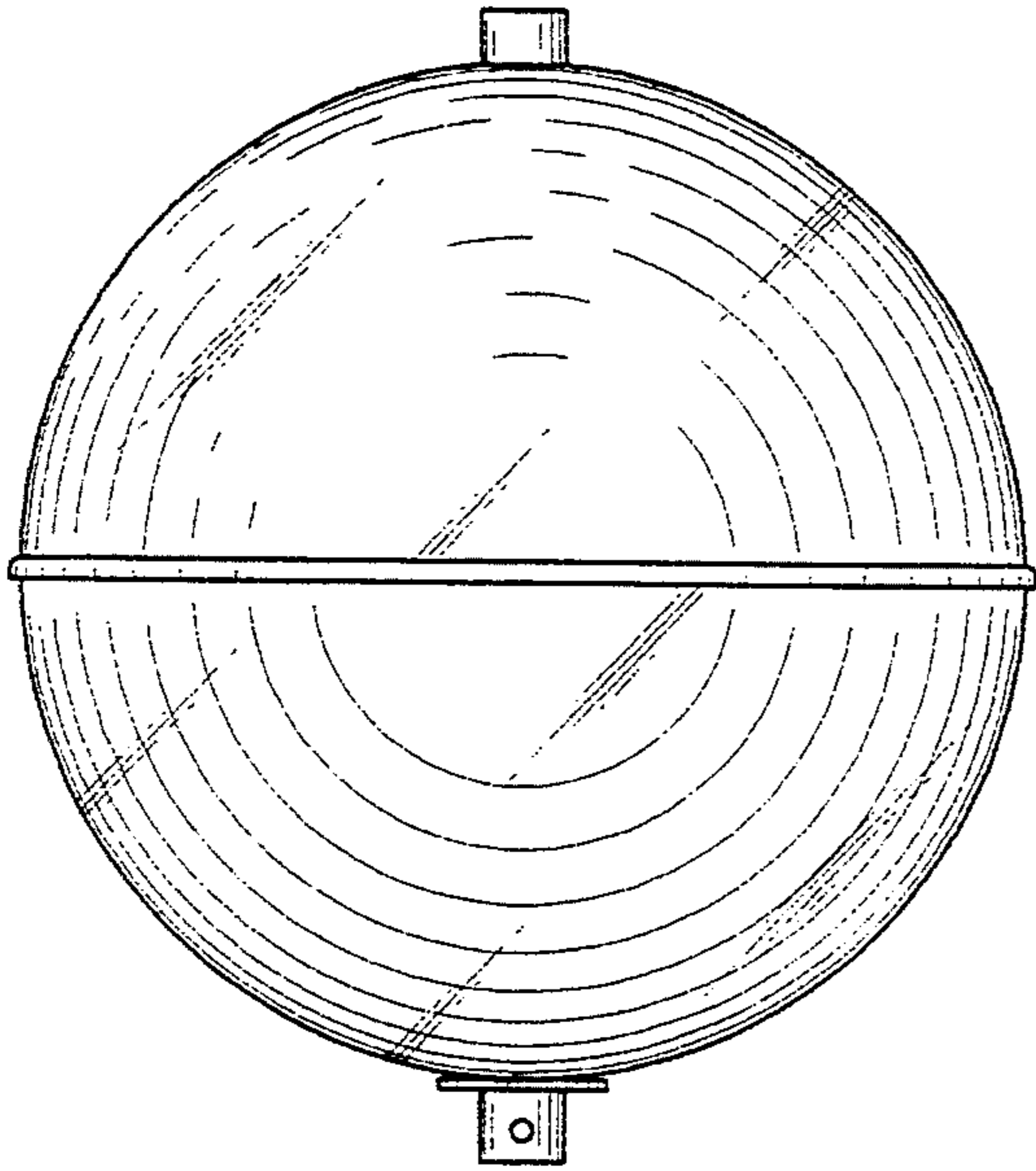

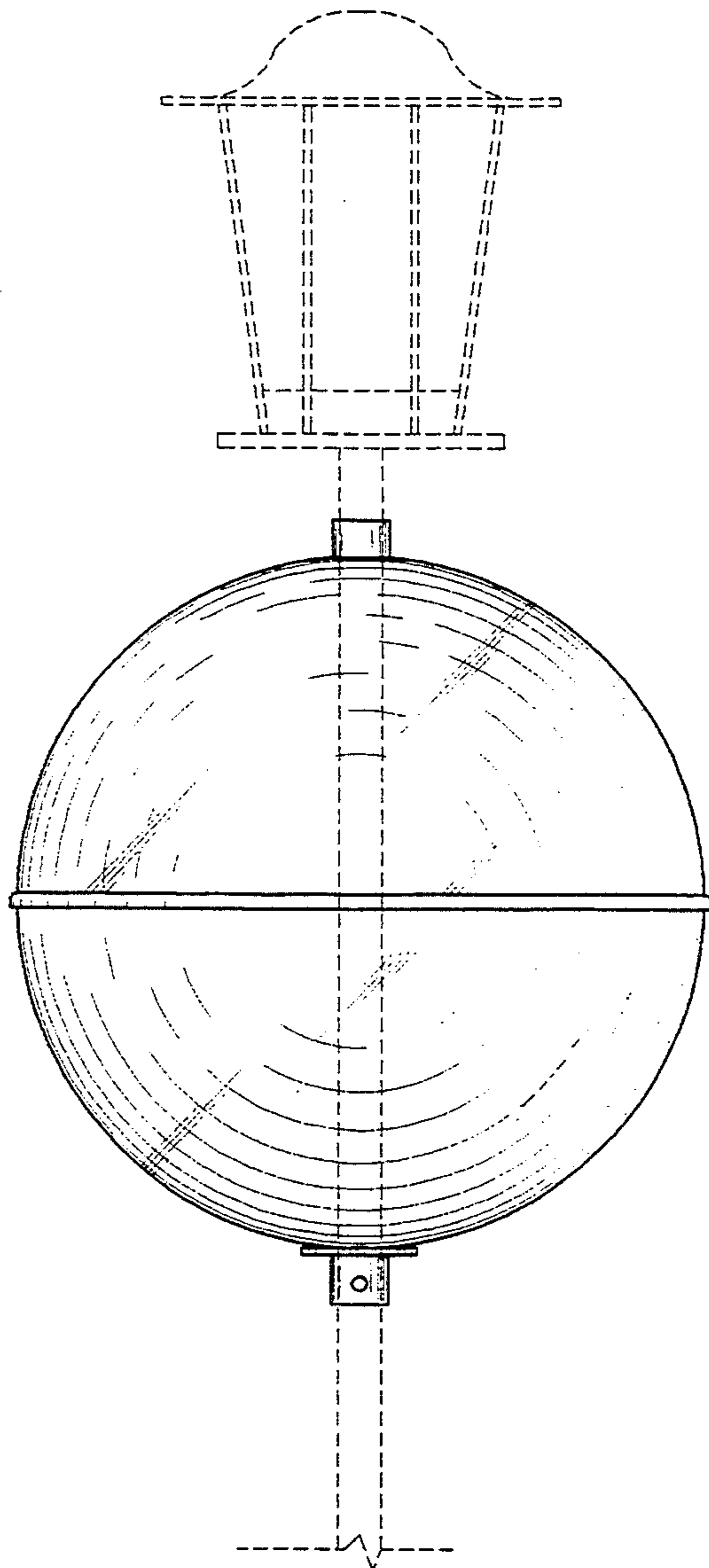

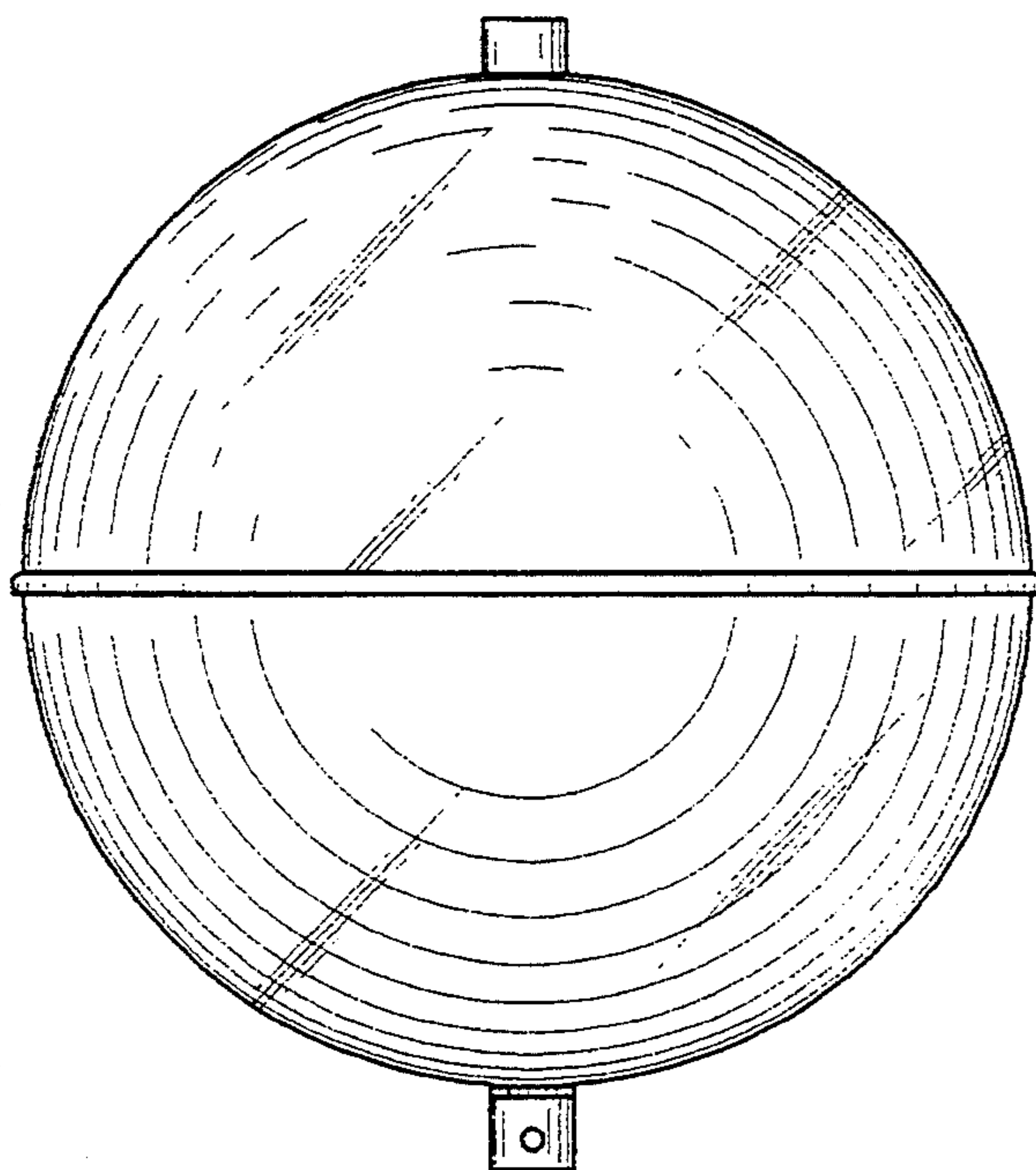
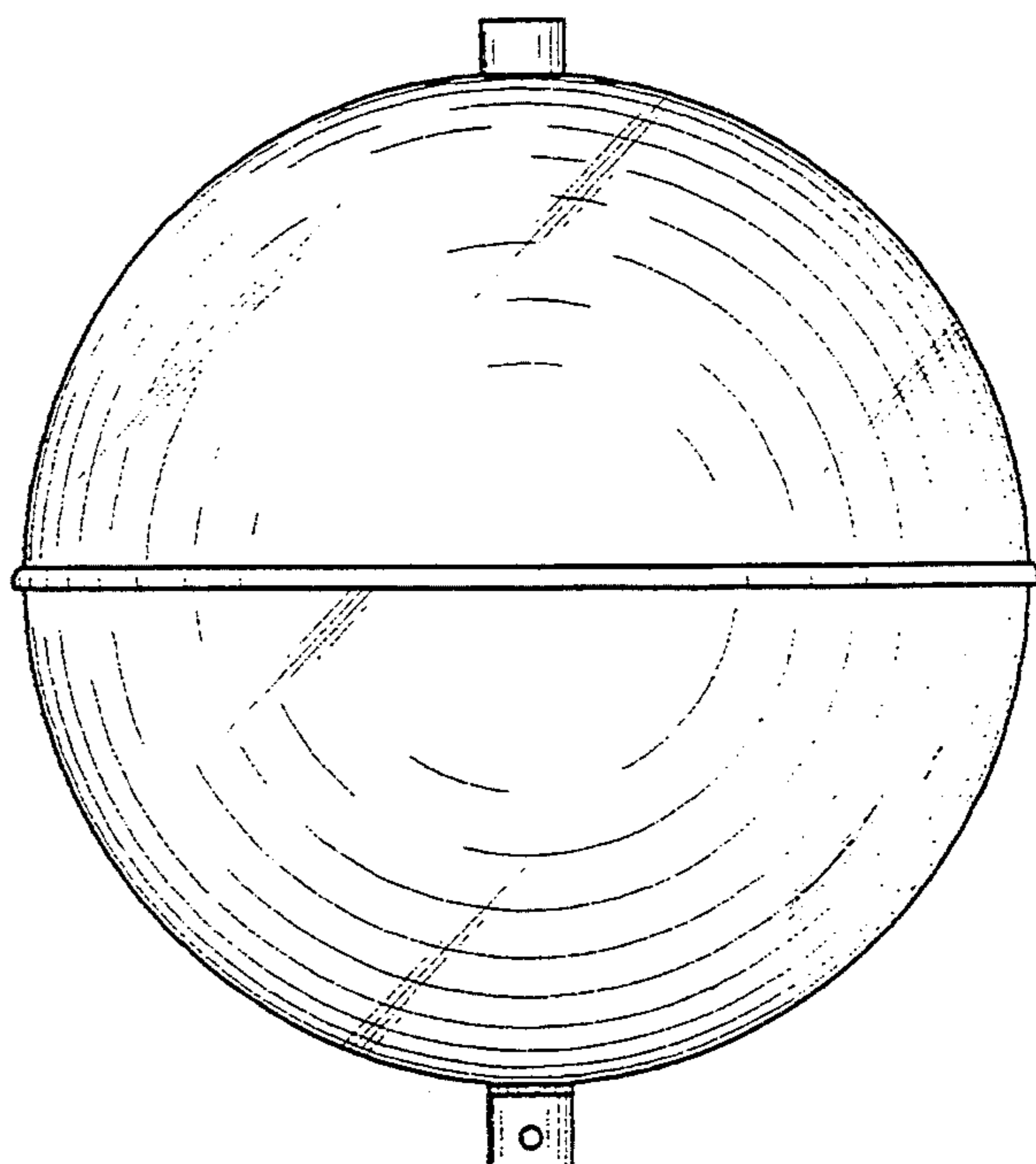
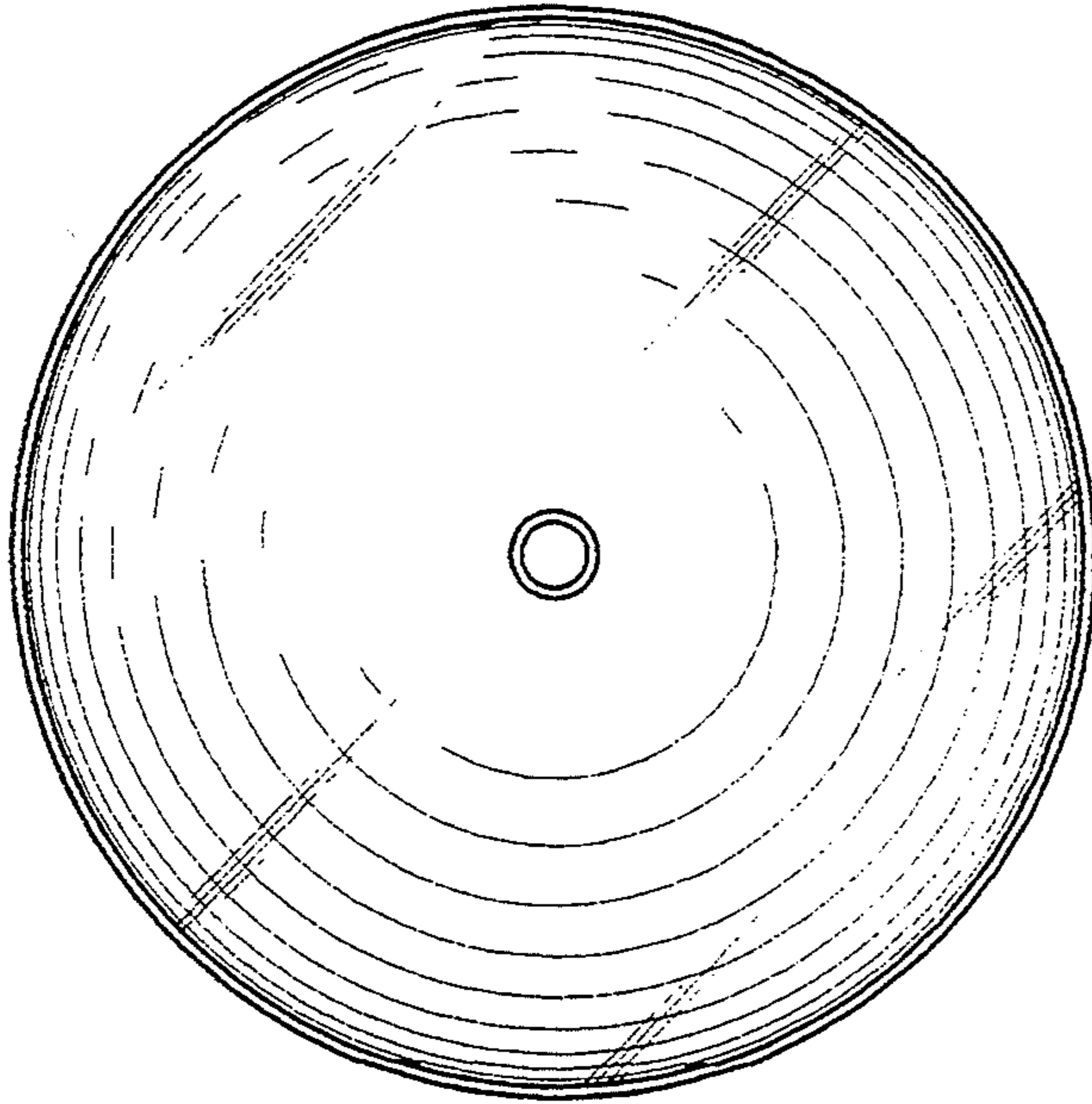
