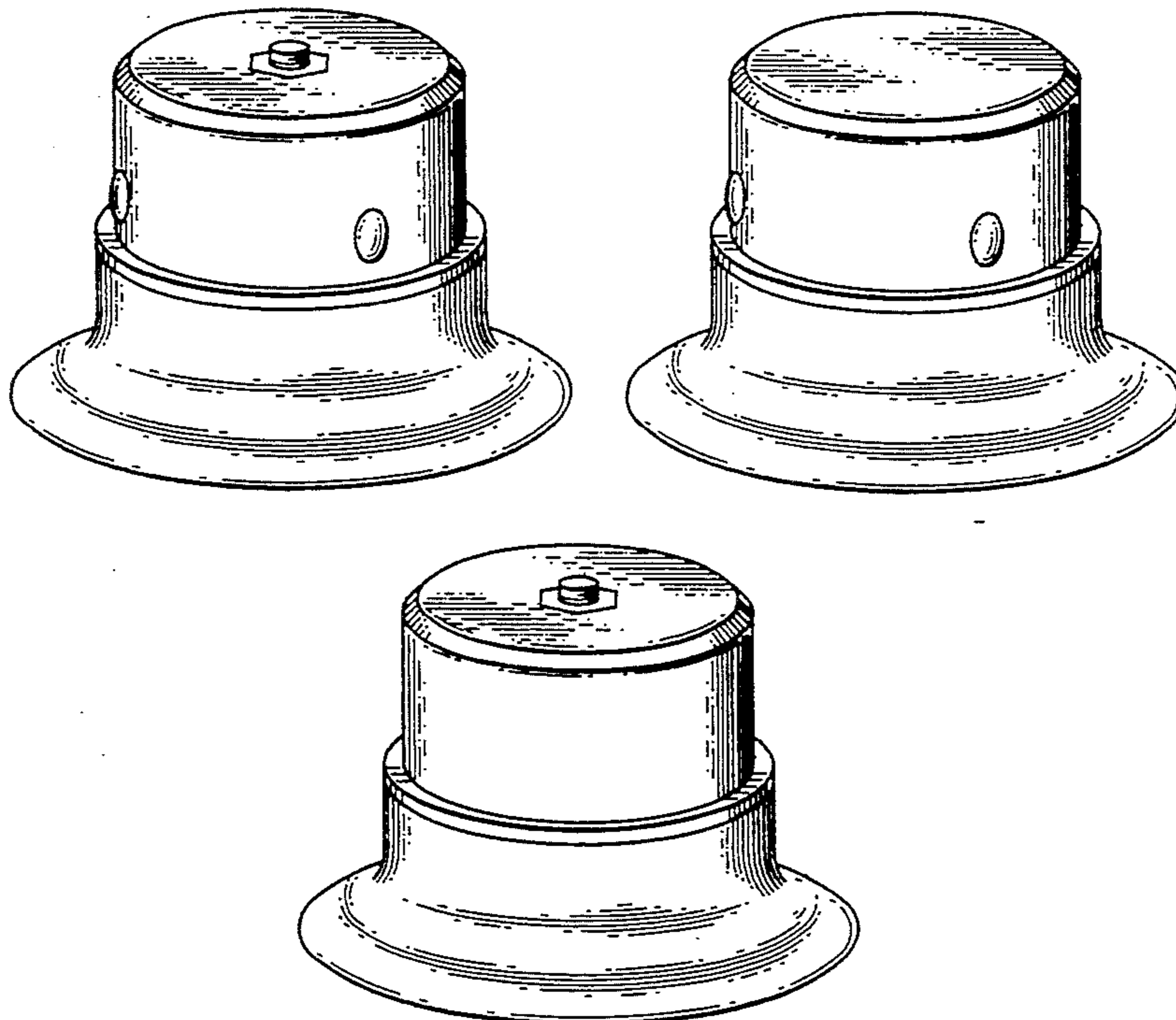
[57] **CLAIM**

The ornamental design for a support for holding a paint roller vertically while being cleaned, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a support

for holding a paint roller vertically while being cleaned showing my new design;
 FIG. 2 is a reduced front elevational view thereof, the rear being identical in appearance;
 FIG. 3 is a reduced side elevational view thereof, the opposite side being a mirror image of that shown;
 FIG. 4 is a reduced top plan view thereof;
 FIG. 5 is a reduced bottom plan view thereof;
 FIG. 6 is a top and front perspective view of a support for holding a paint roller vertically while being cleaned showing a second embodiment of my new design;
 FIG. 7 is a reduced front elevational view thereof, the rear being identical in appearance;
 FIG. 8 is a reduced side elevational view thereof, the opposite side being a mirror image of that shown;
 FIG. 9 is a reduced top plan view thereof;
 FIG. 10 is a reduced bottom plan view thereof;
 FIG. 11 is a top and front perspective view of a support for holding a paint roller vertically while being cleaned showing a third embodiment of my new design;
 FIG. 12 is a reduced front elevational view thereof, the rear being identical in appearance;
 FIG. 13 is a reduced side elevational view thereof, the opposite side being a mirror image of that shown;
 FIG. 14 is a reduced top plan view thereof;
 FIG. 15 is a reduced bottom plan view thereof;
 FIG. 16 is a top and front perspective view of a support for holding a paint roller vertically while being cleaned showing a fourth embodiment of my new design;
 FIG. 17 is a reduced front elevational view thereof, the rear being identical in appearance;
 FIG. 18 is a reduced side elevational view thereof, the opposite side being a mirror image of that shown;
 FIG. 19 is a reduced top plan view thereof; and,
 FIG. 20 is a reduced bottom plan view thereof.



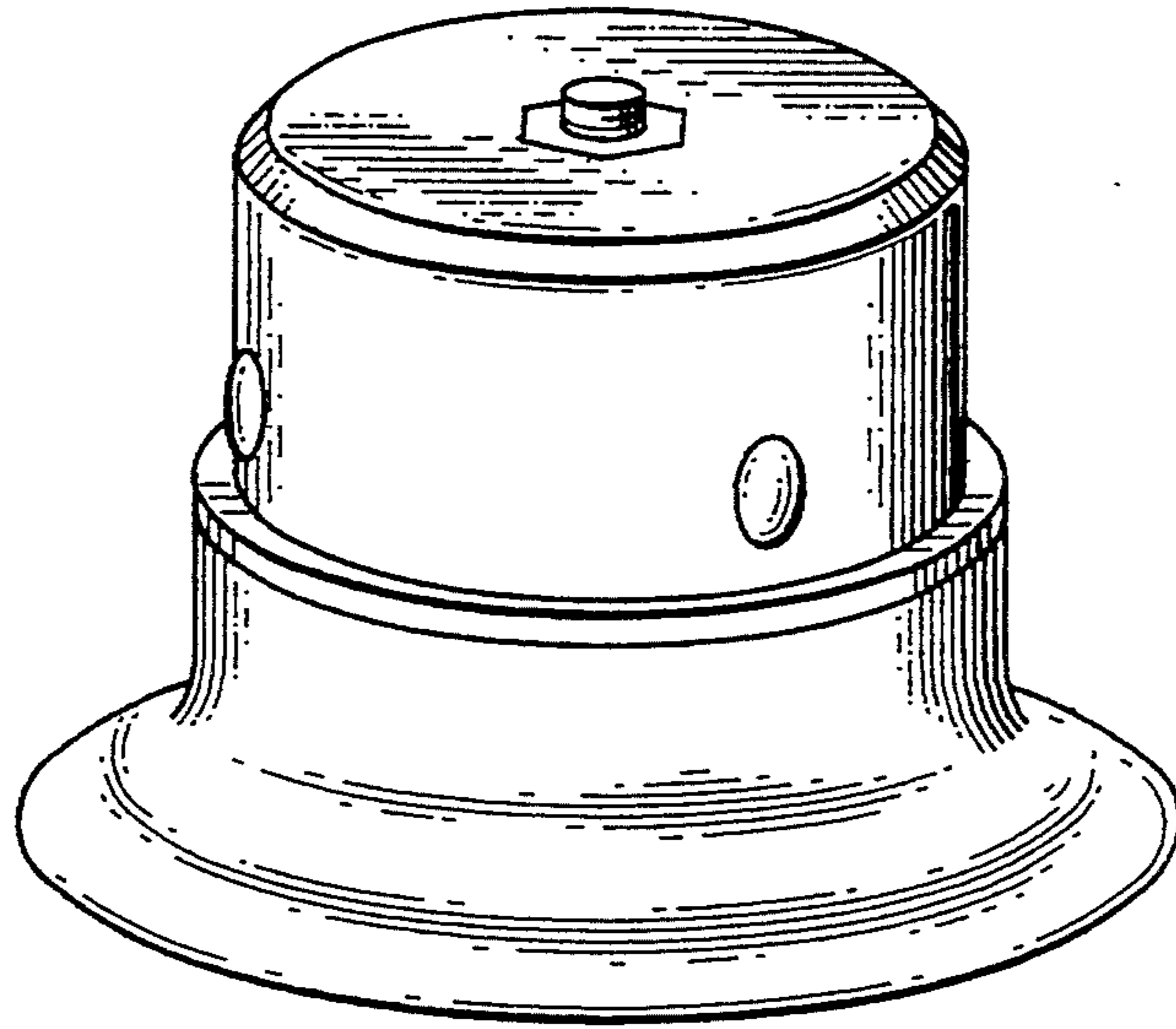

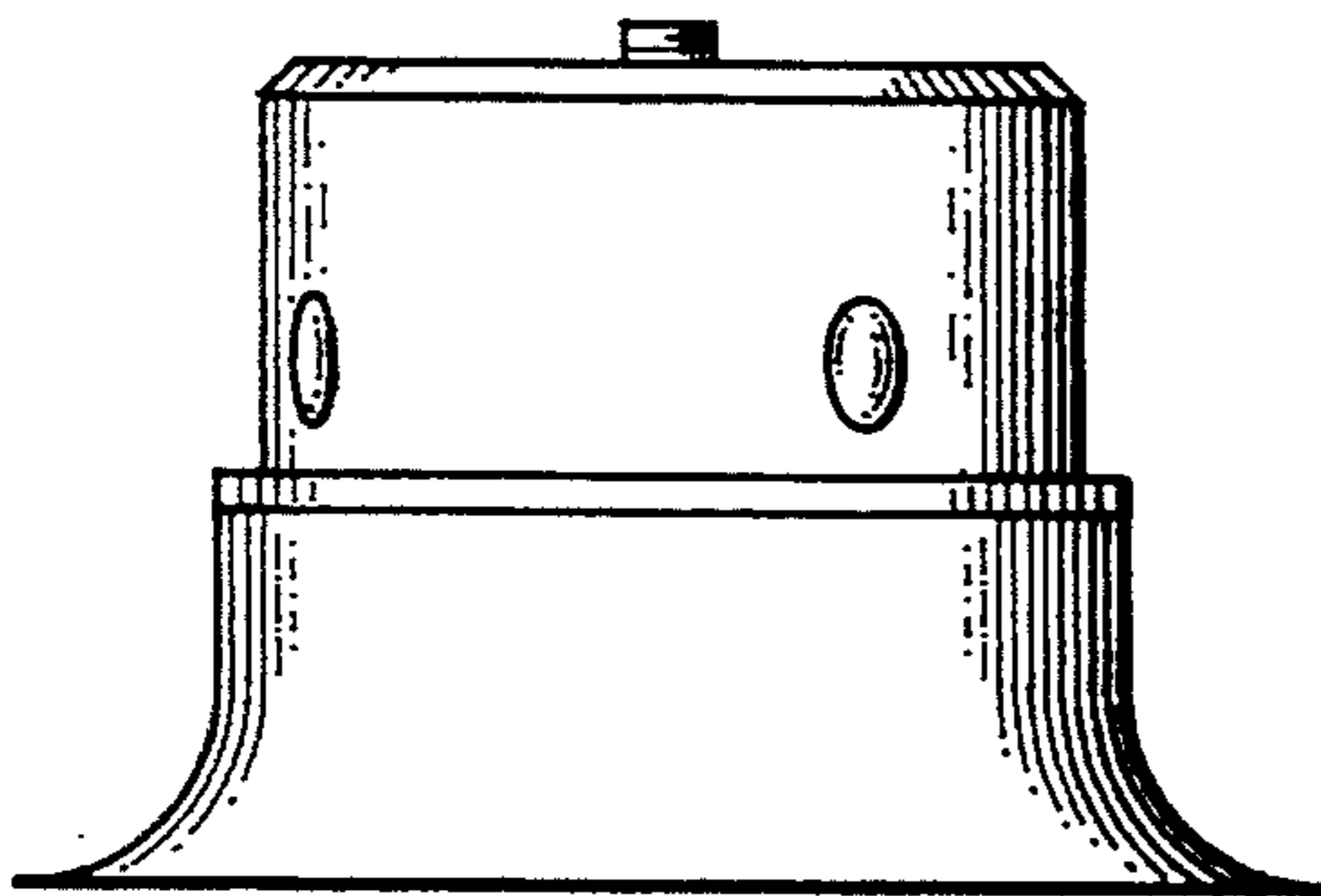

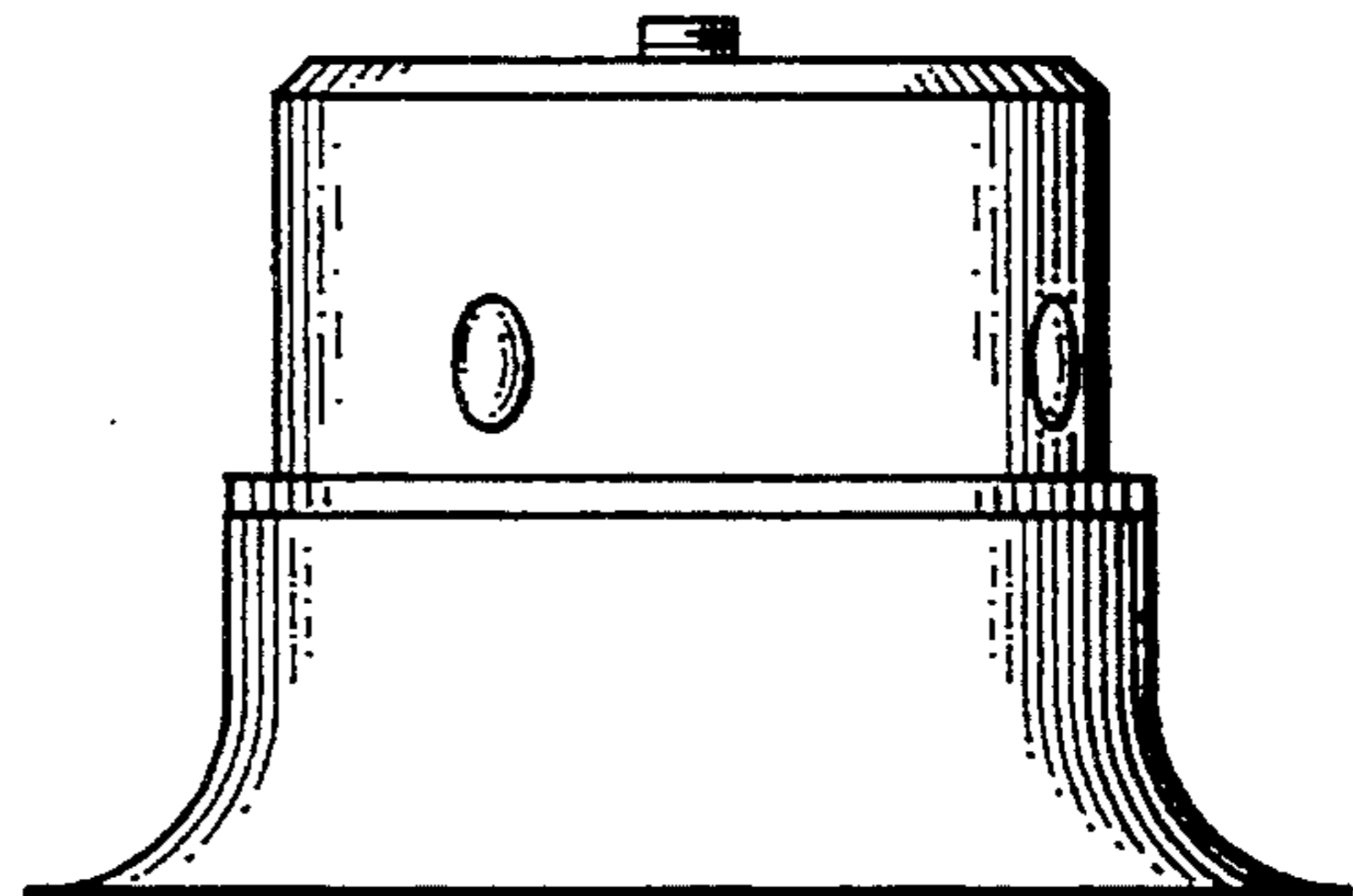

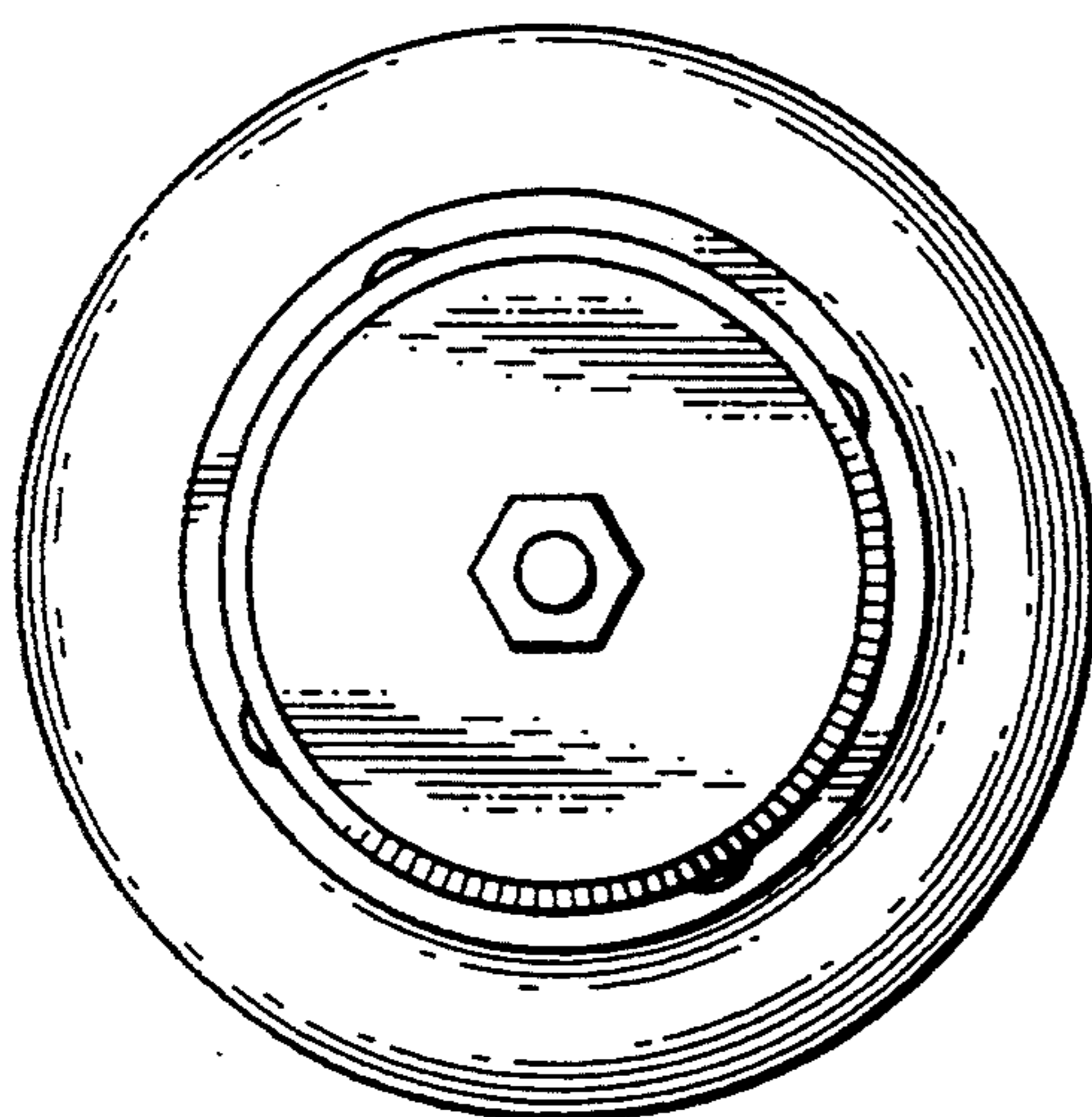

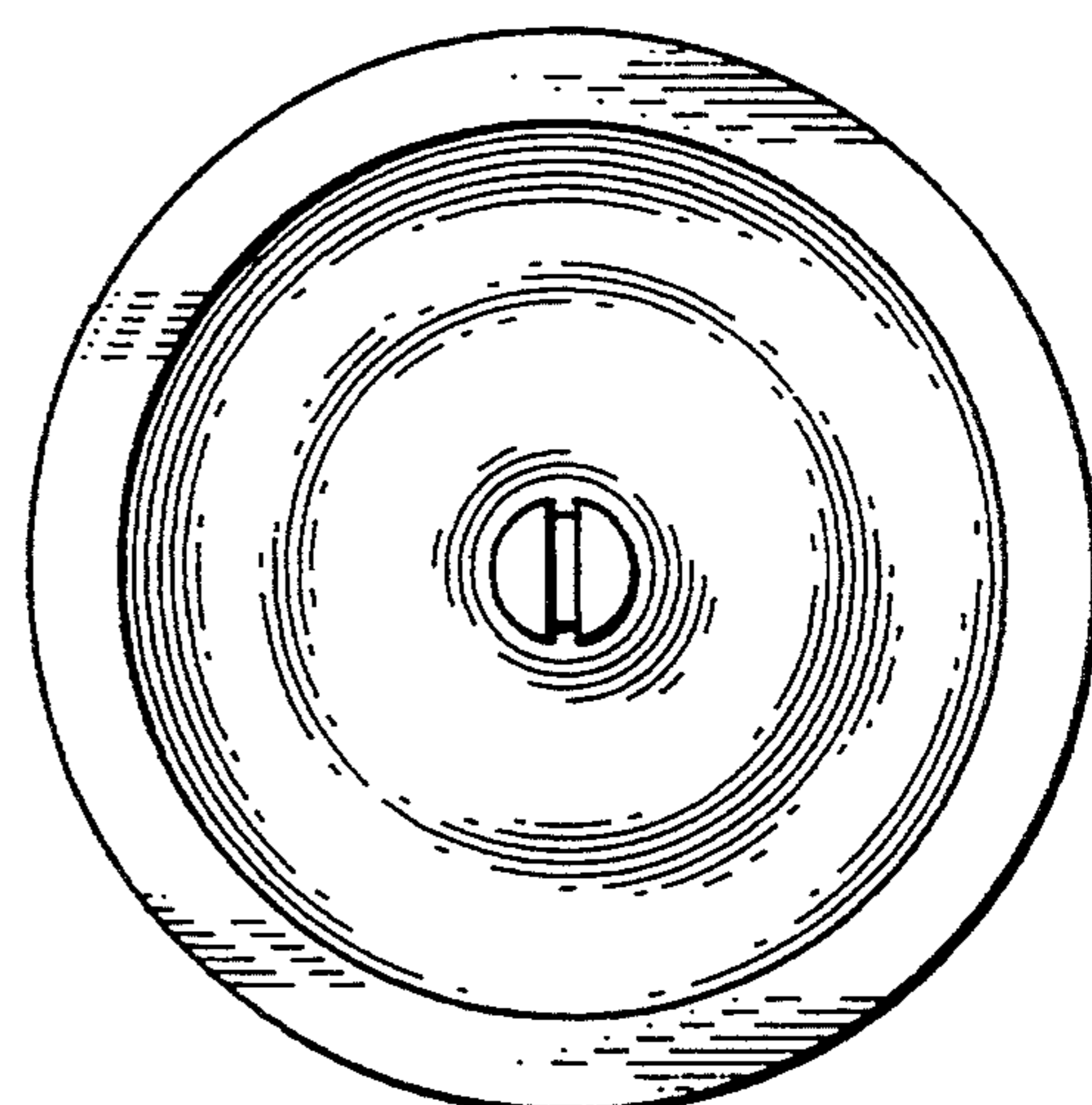

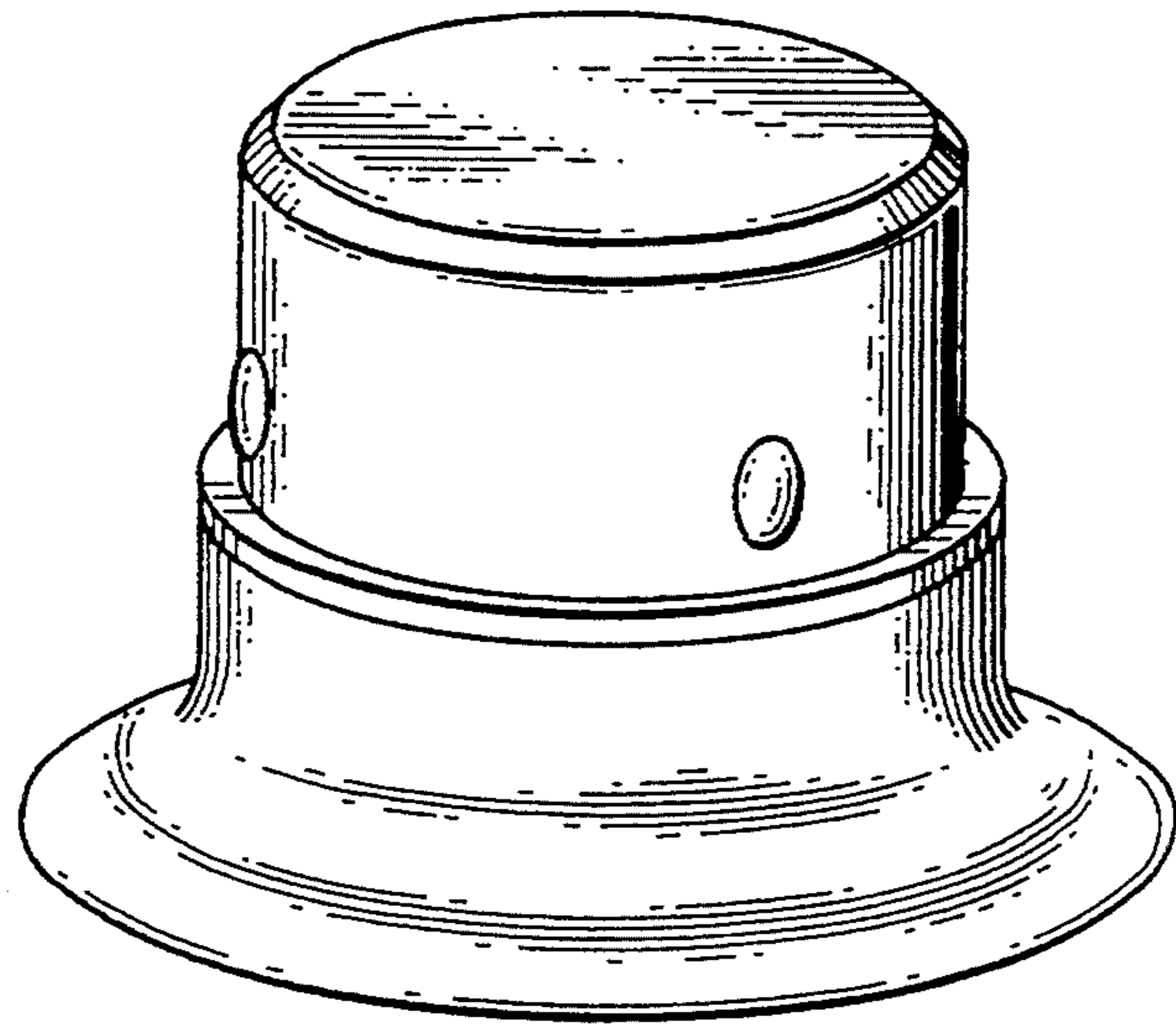

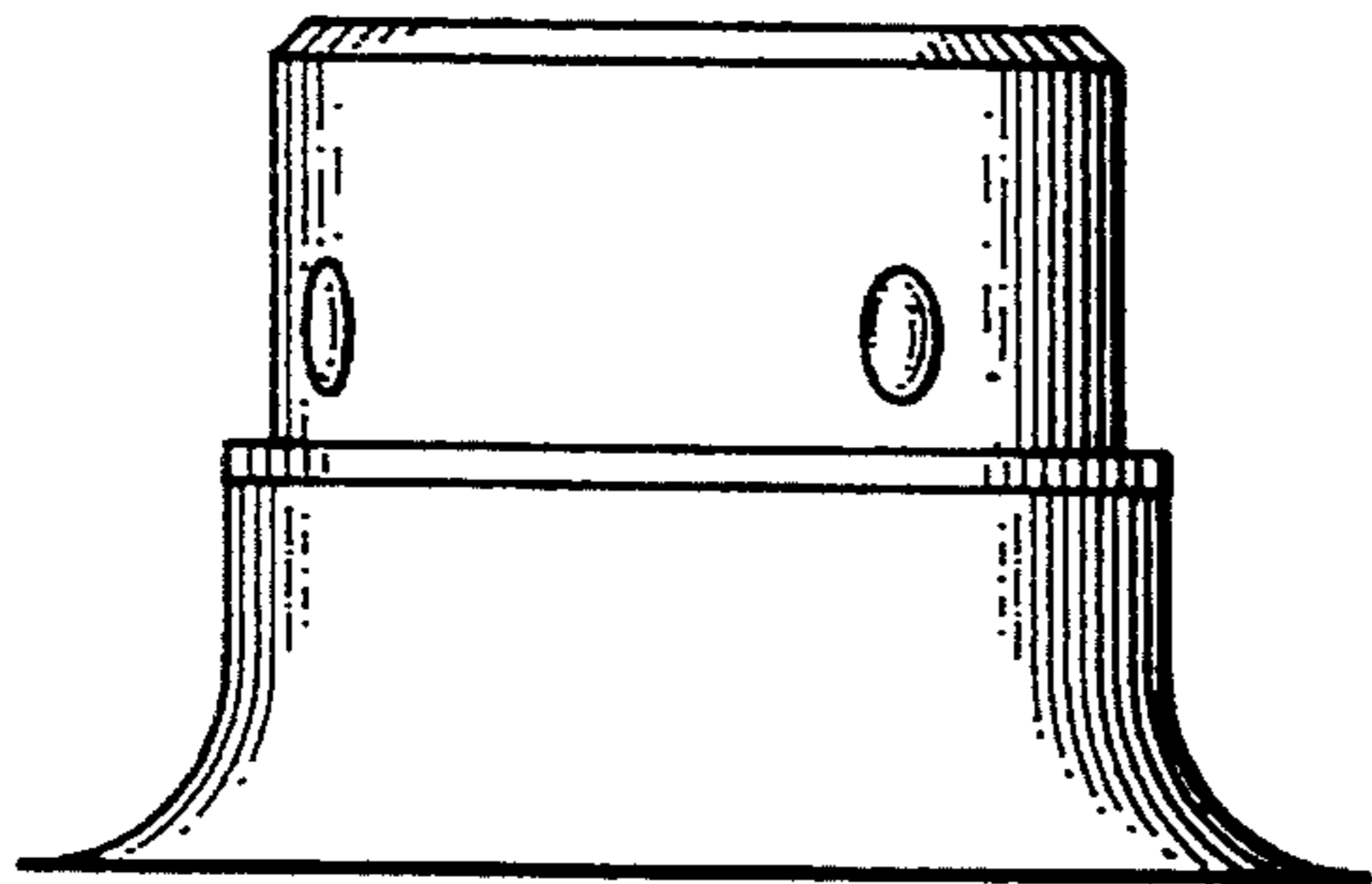

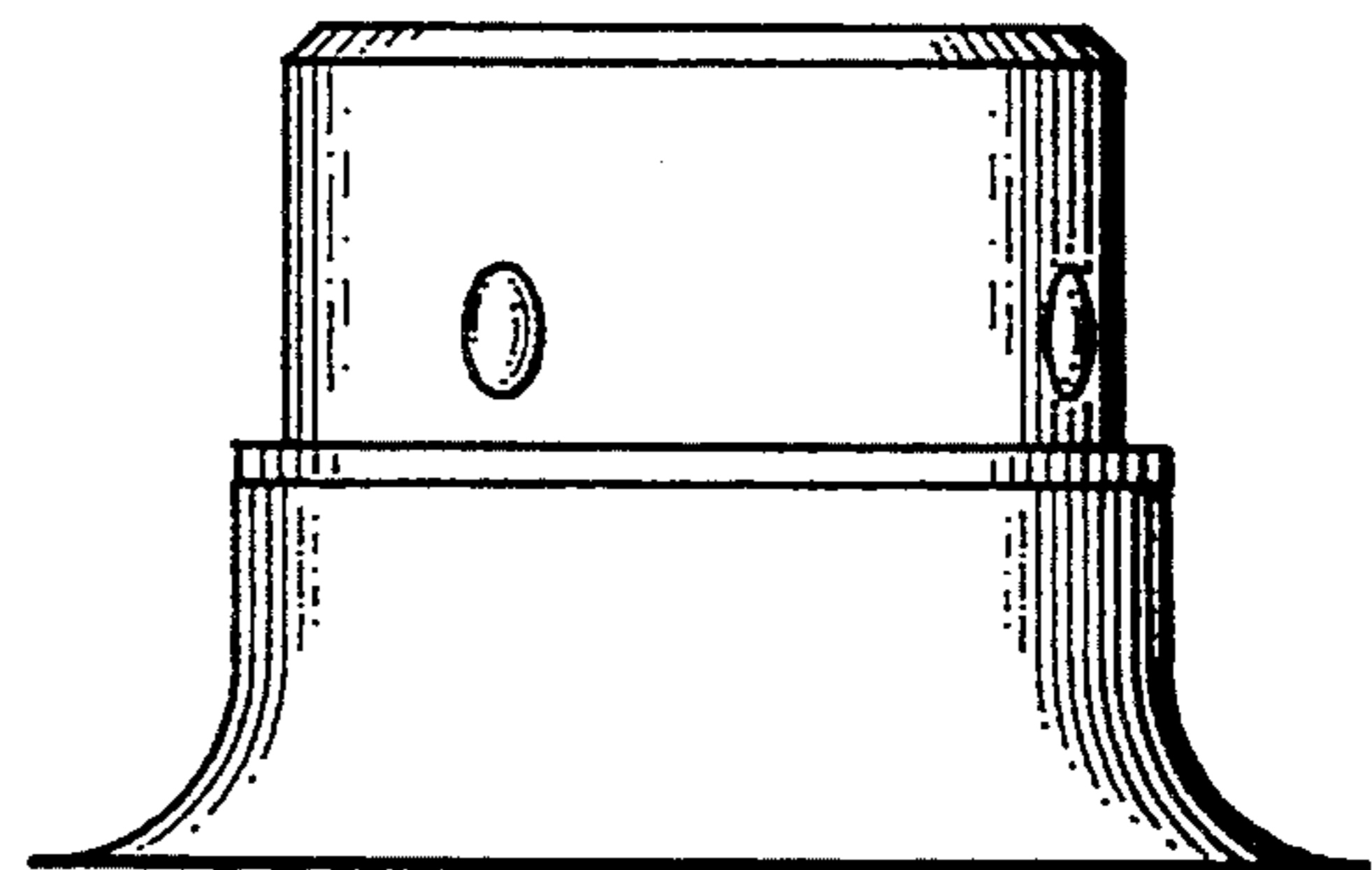

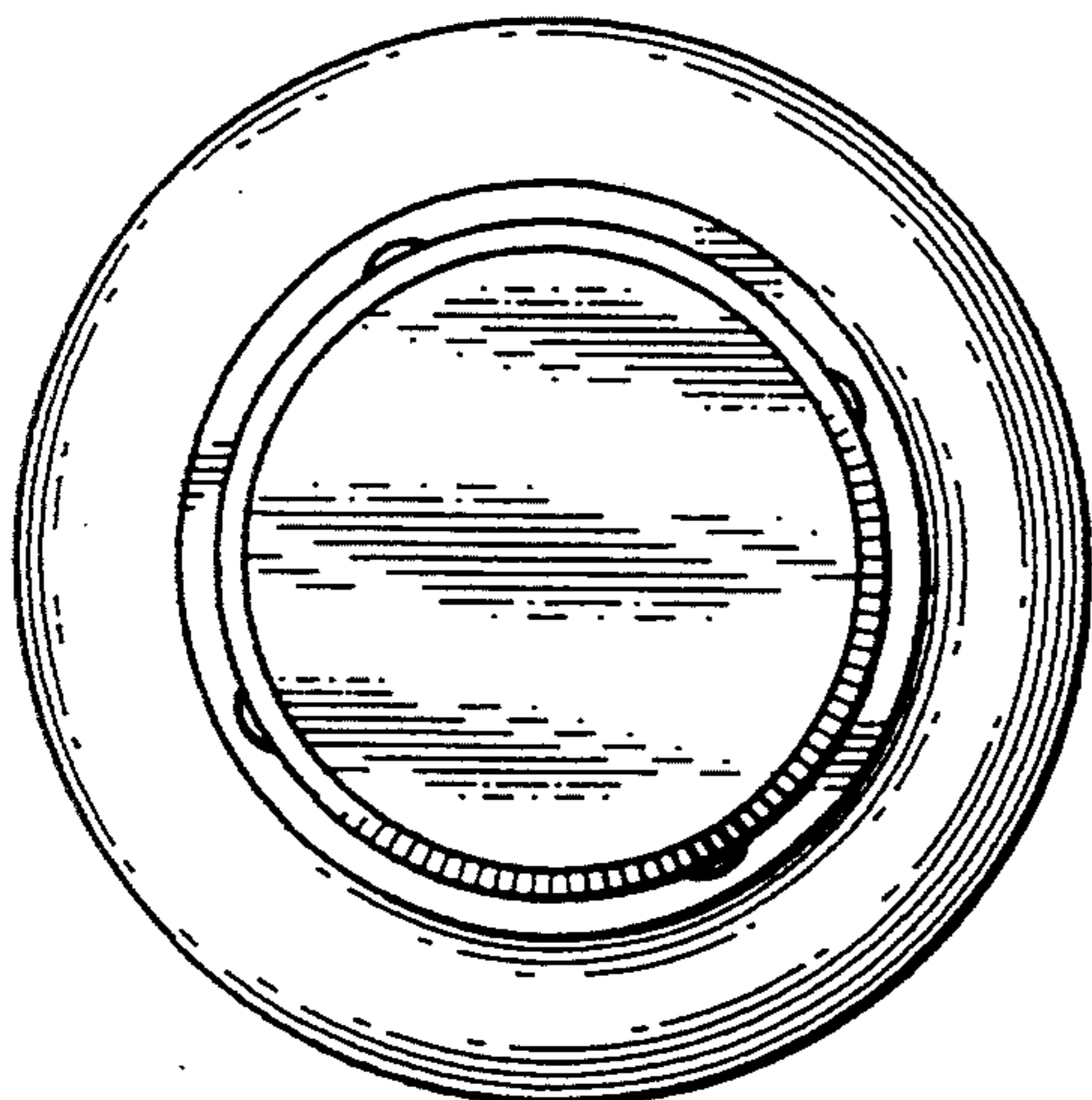

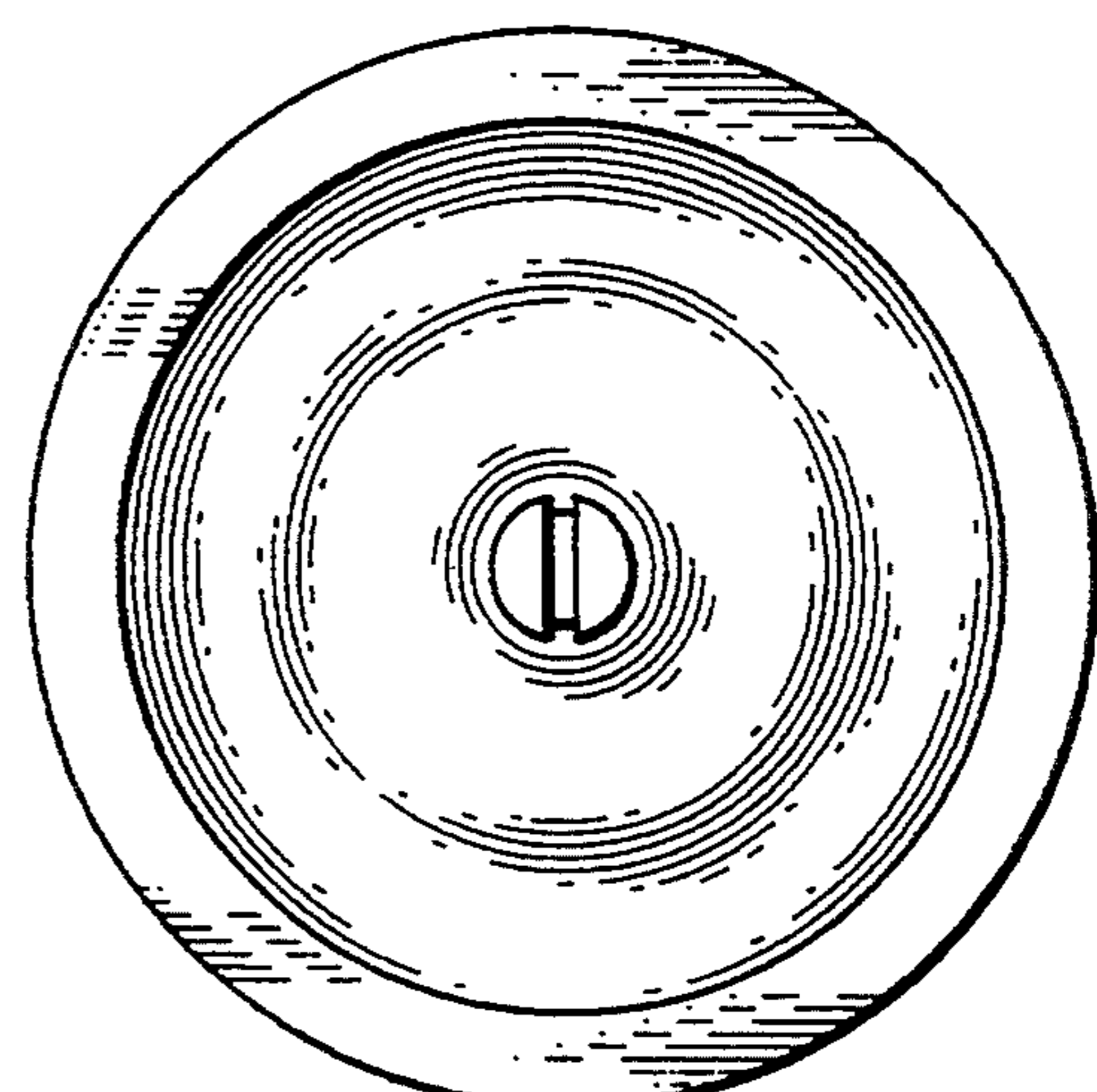

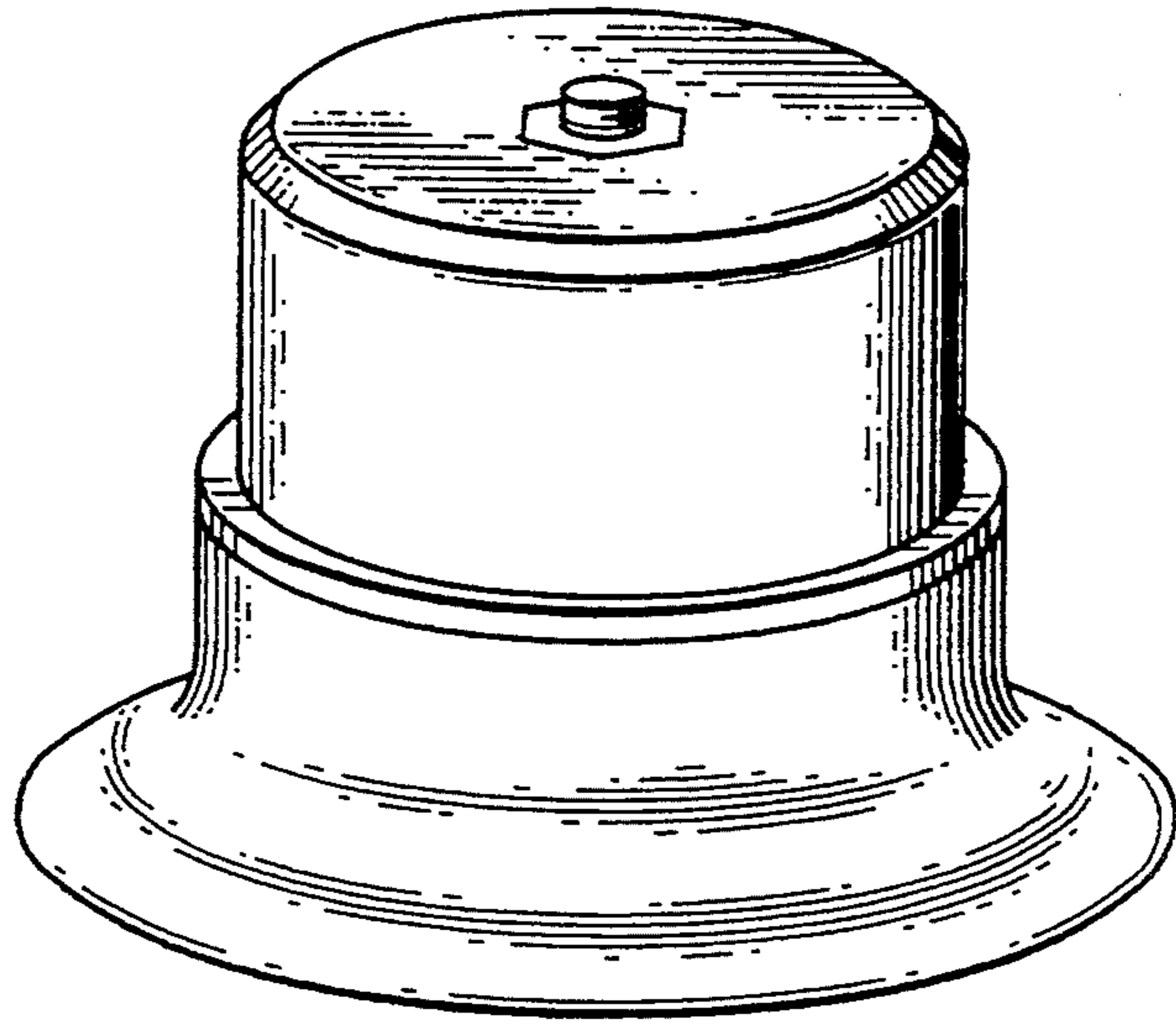

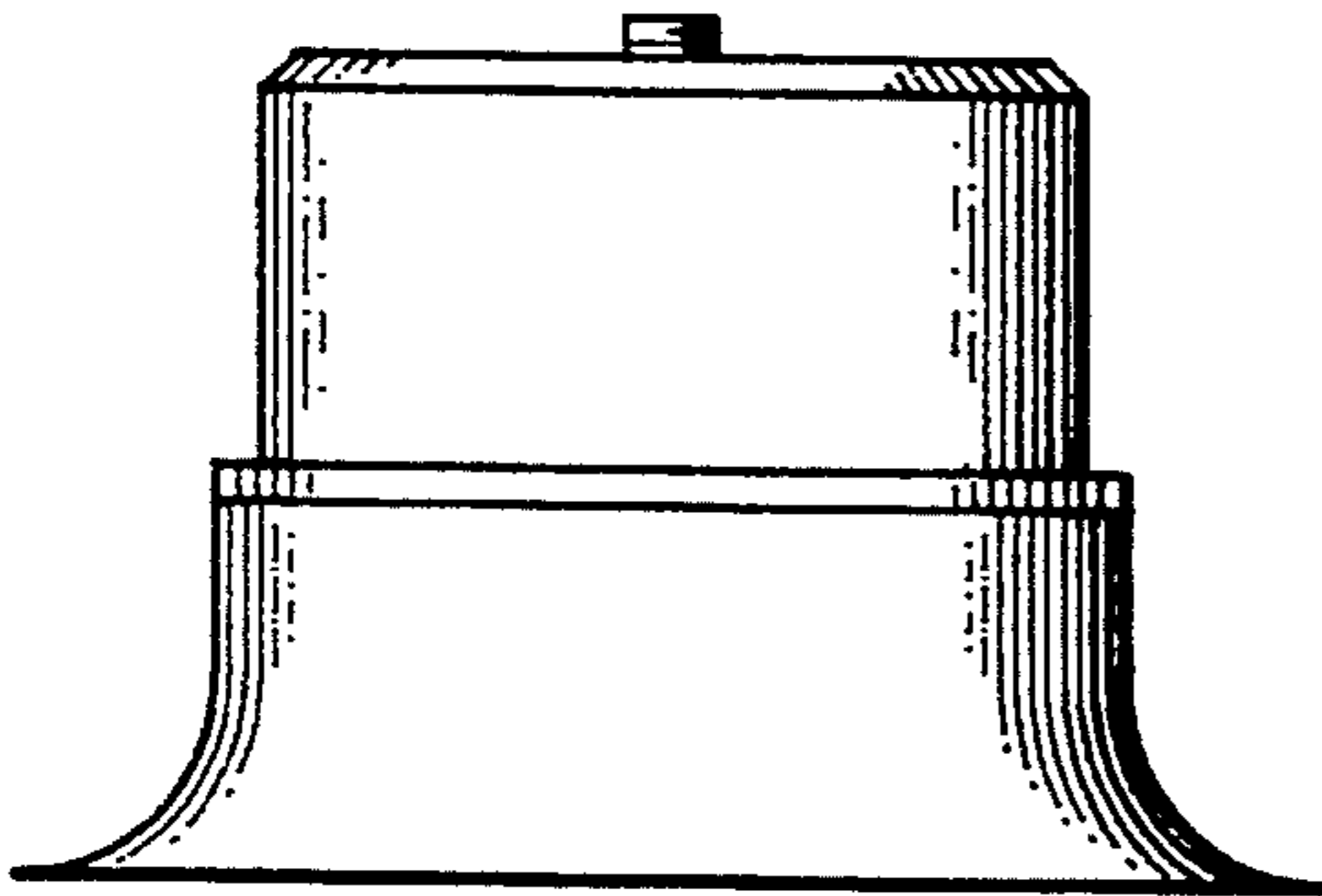

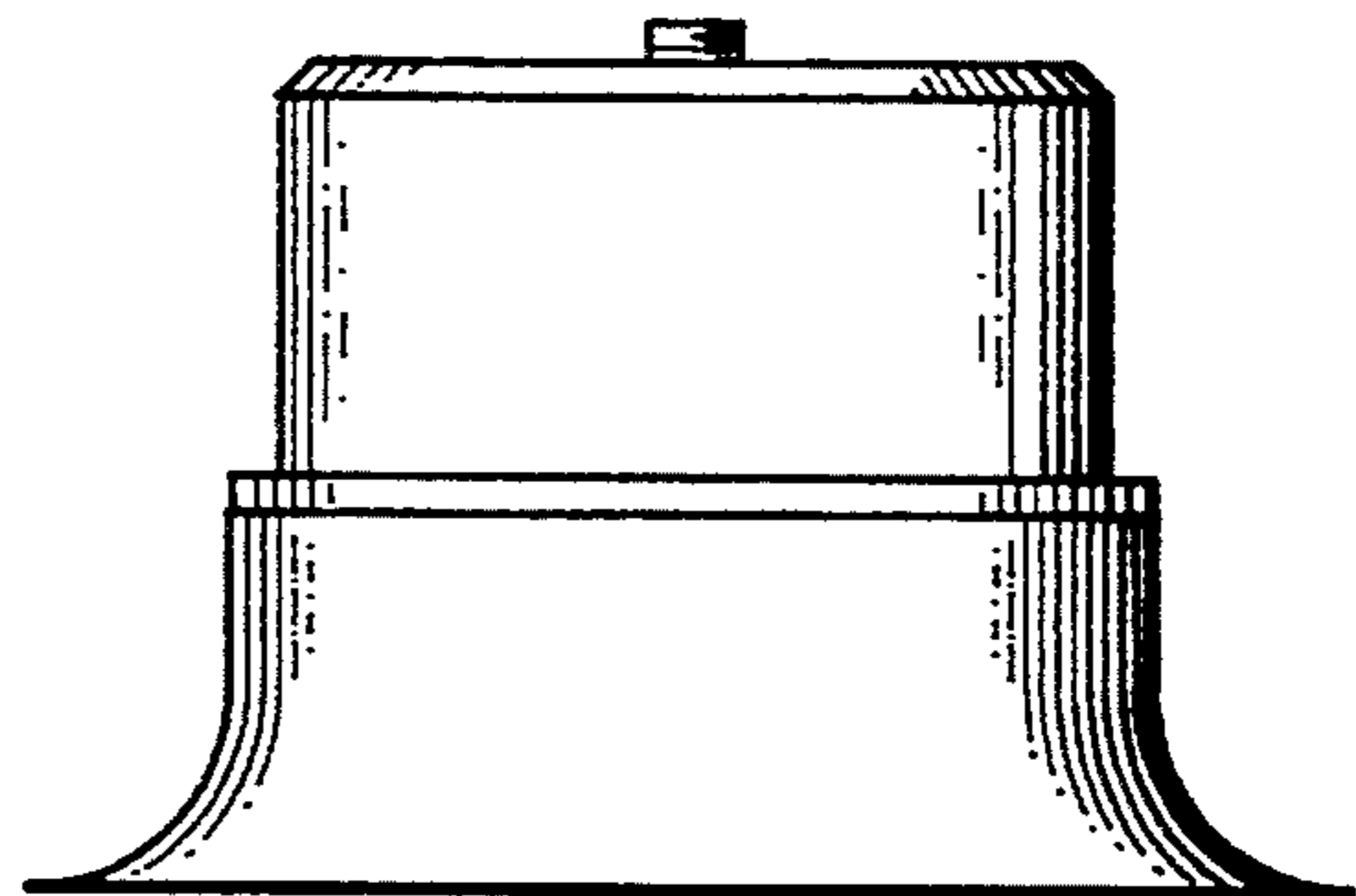

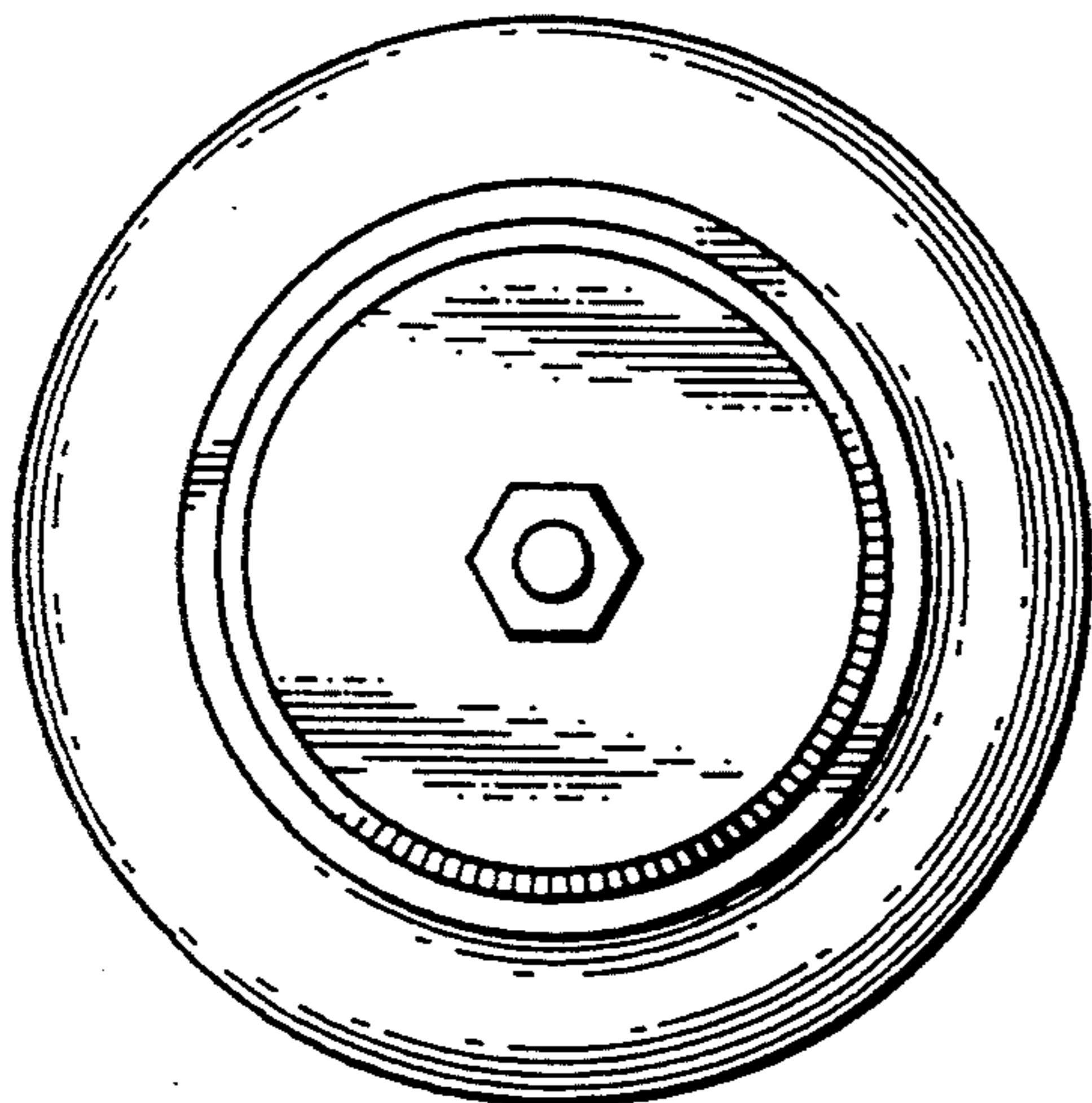

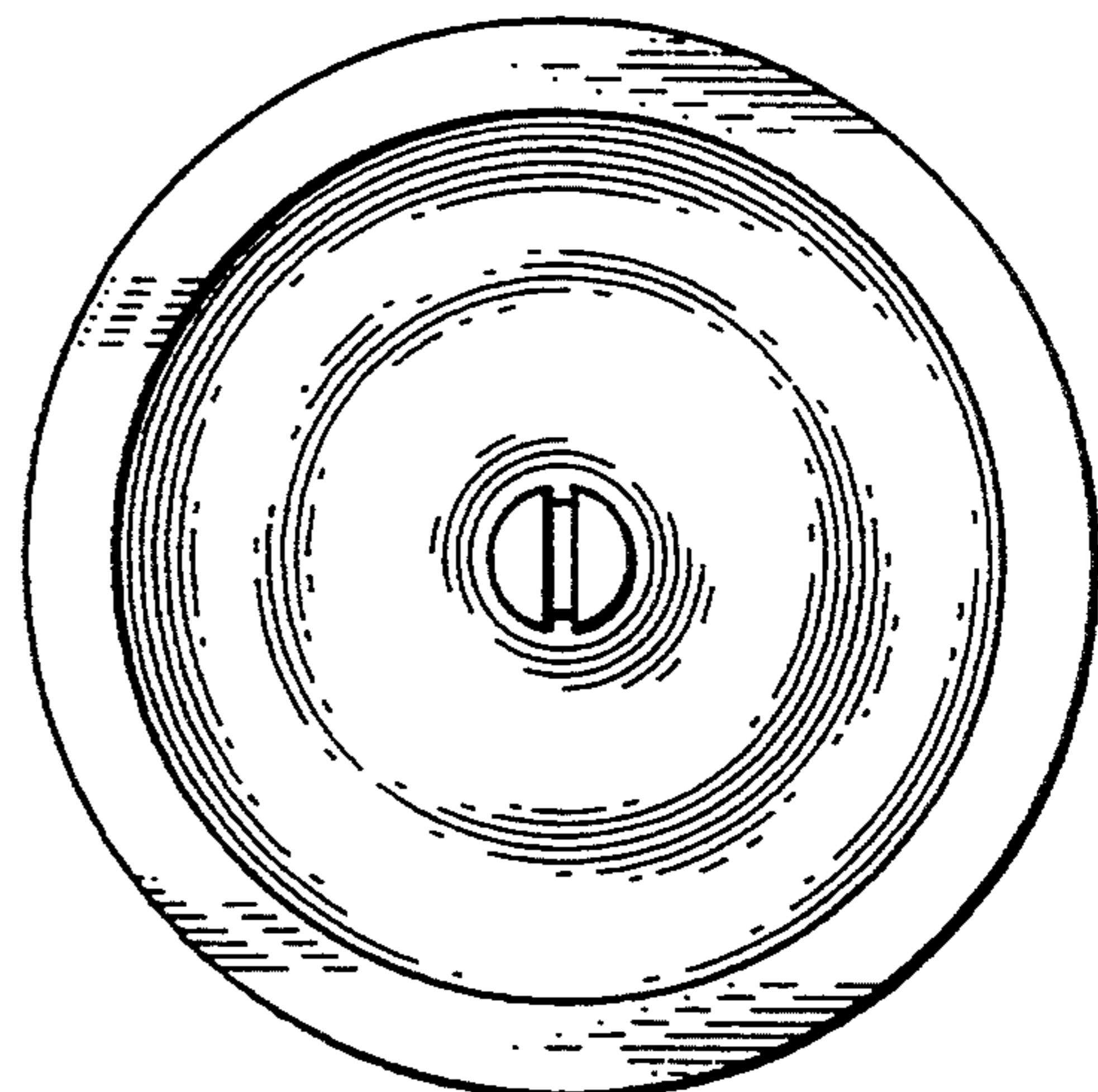

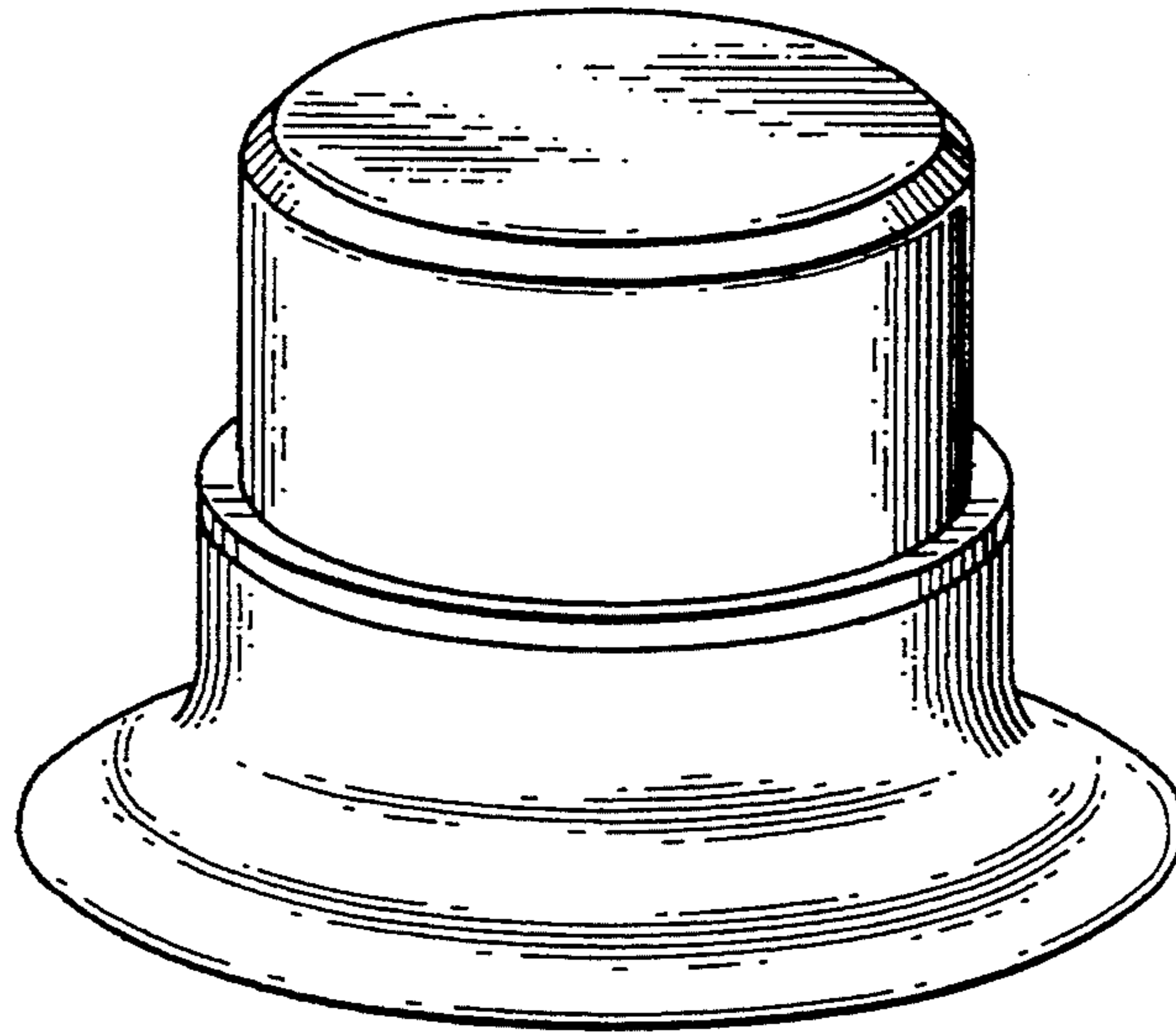

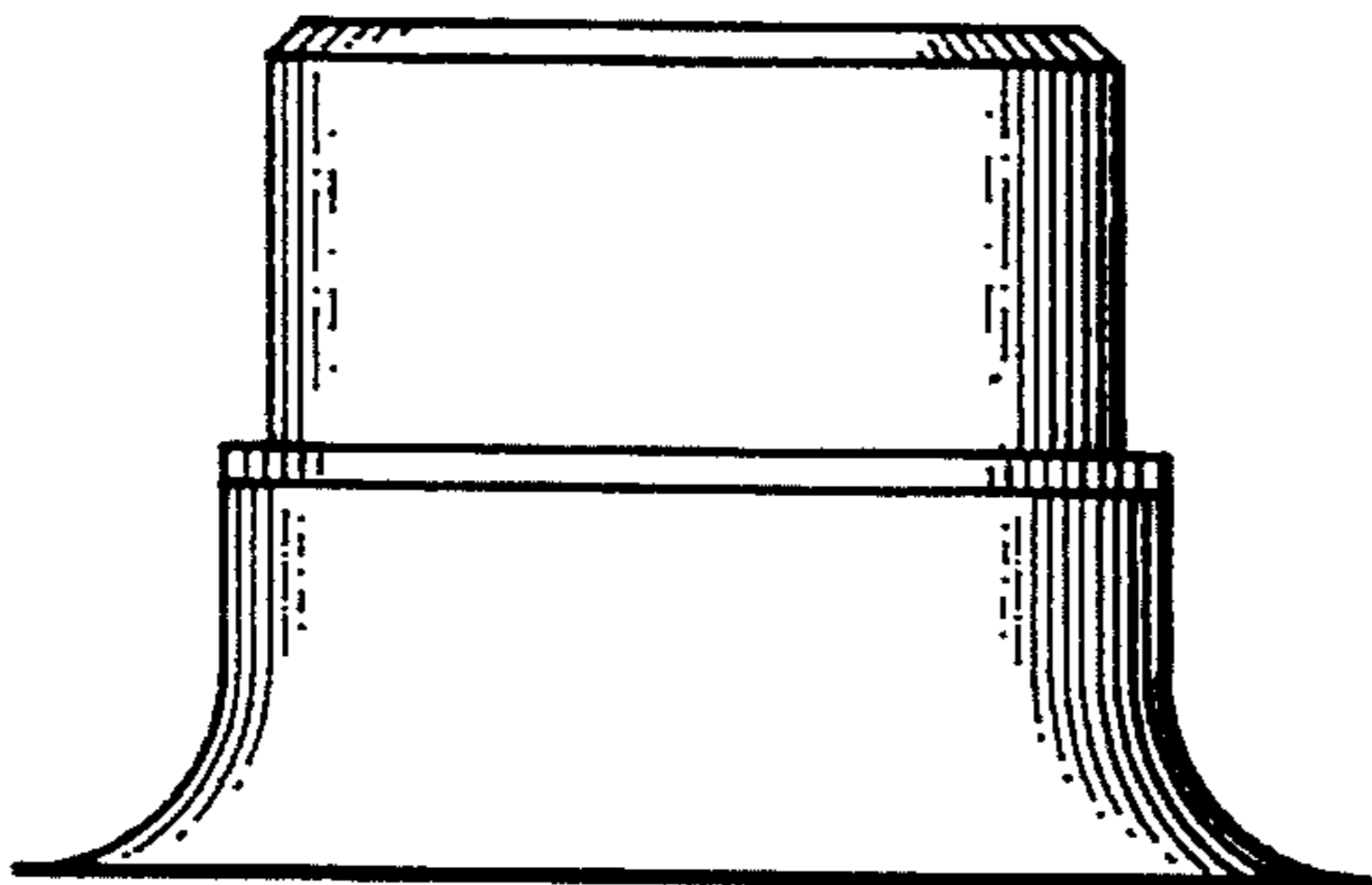

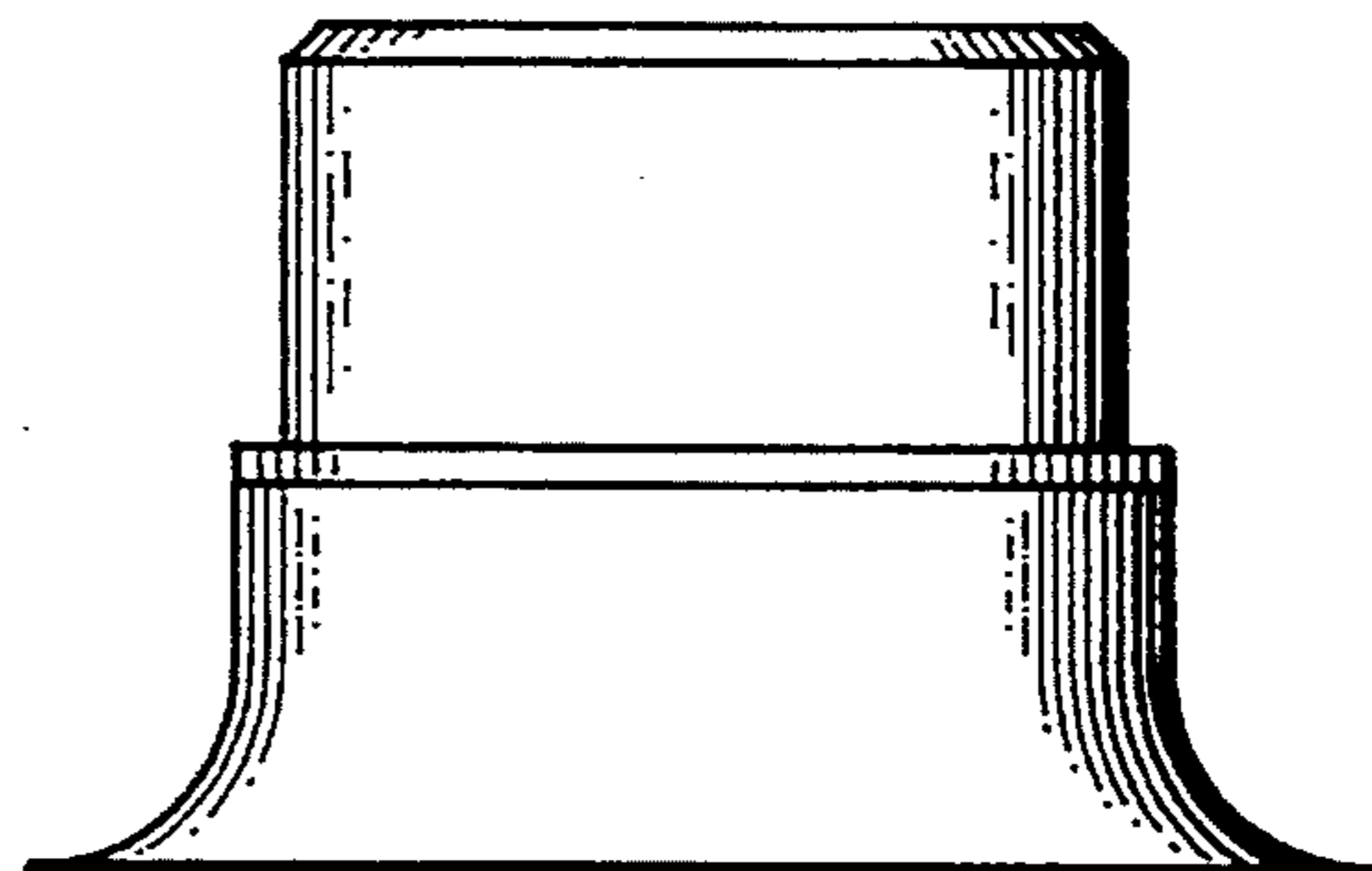

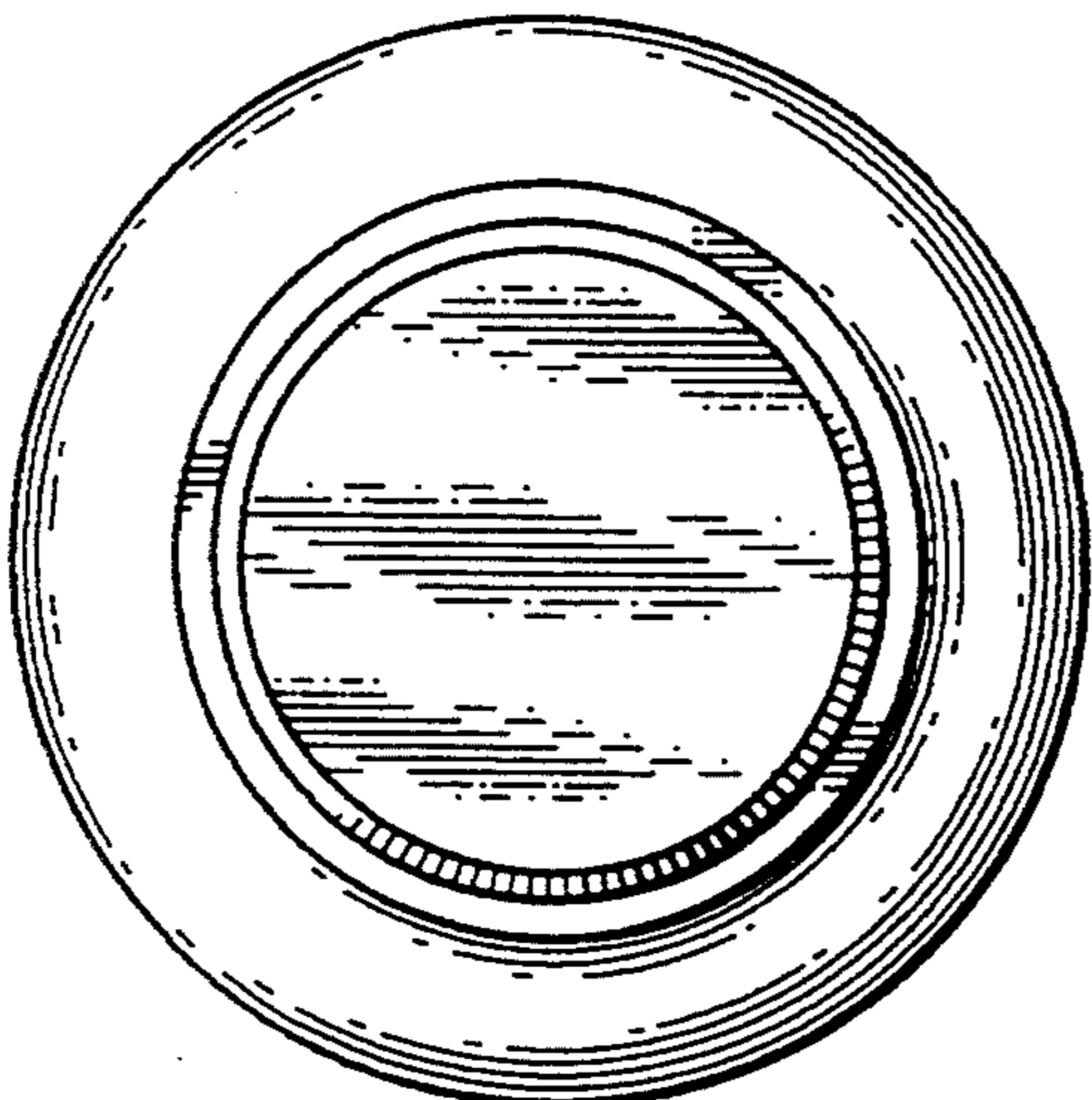

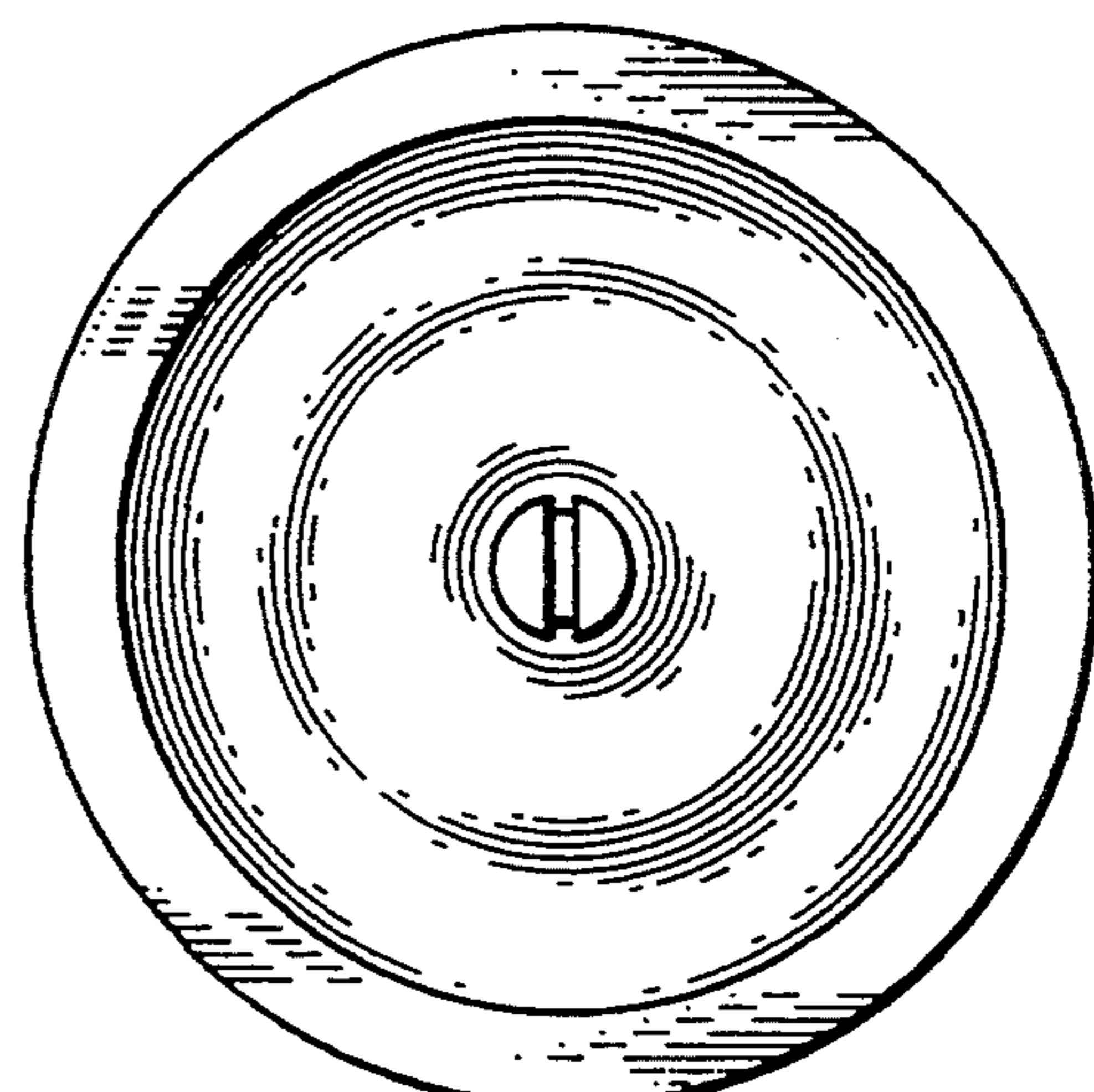
