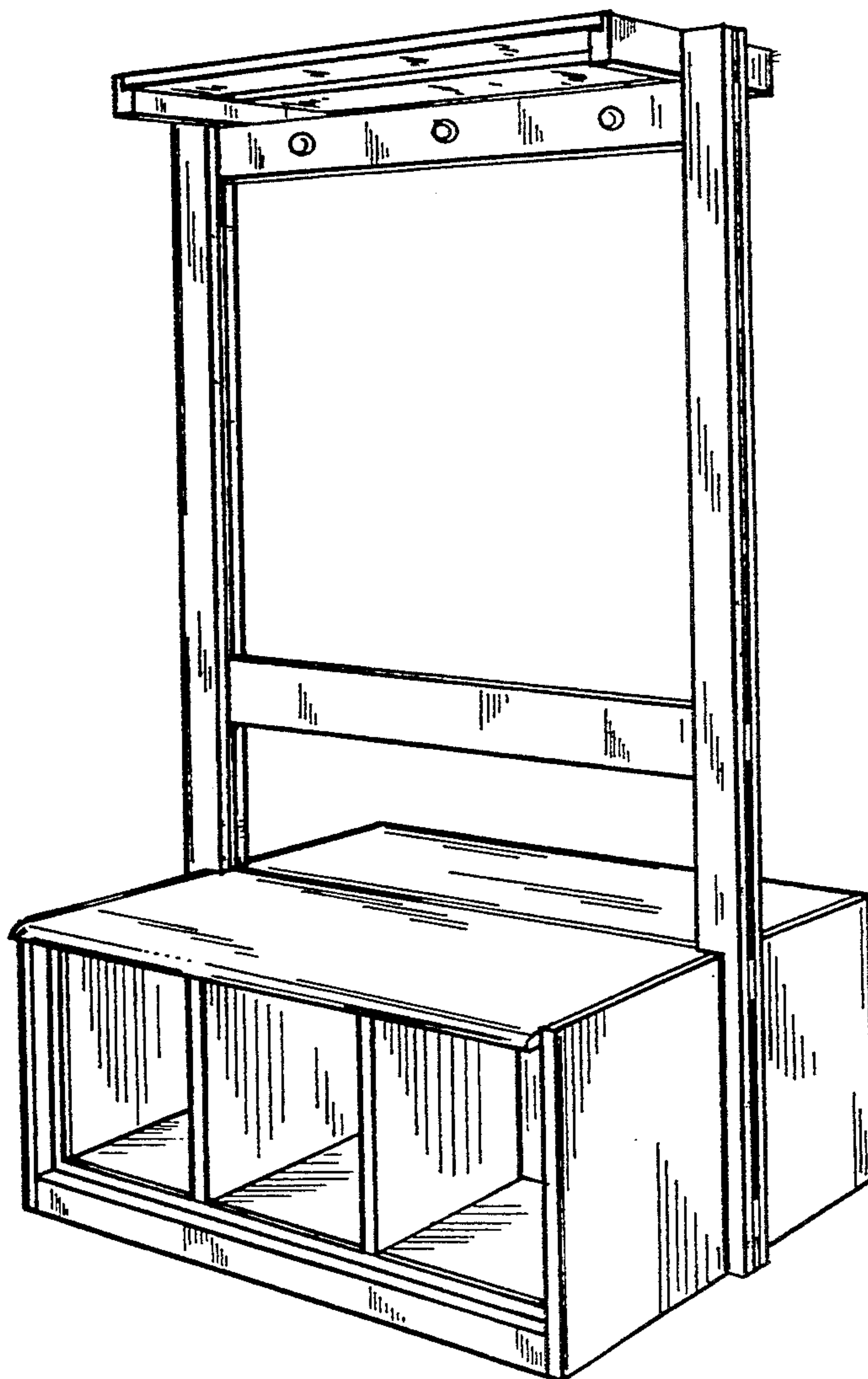

FIG. 1 is a frontal view (the rear view being identical) of the modular bench, embodying my new design; FIG. 2 is a lateral view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a plain view from below thereof; and, FIG. 5 is a perspective view thereof.



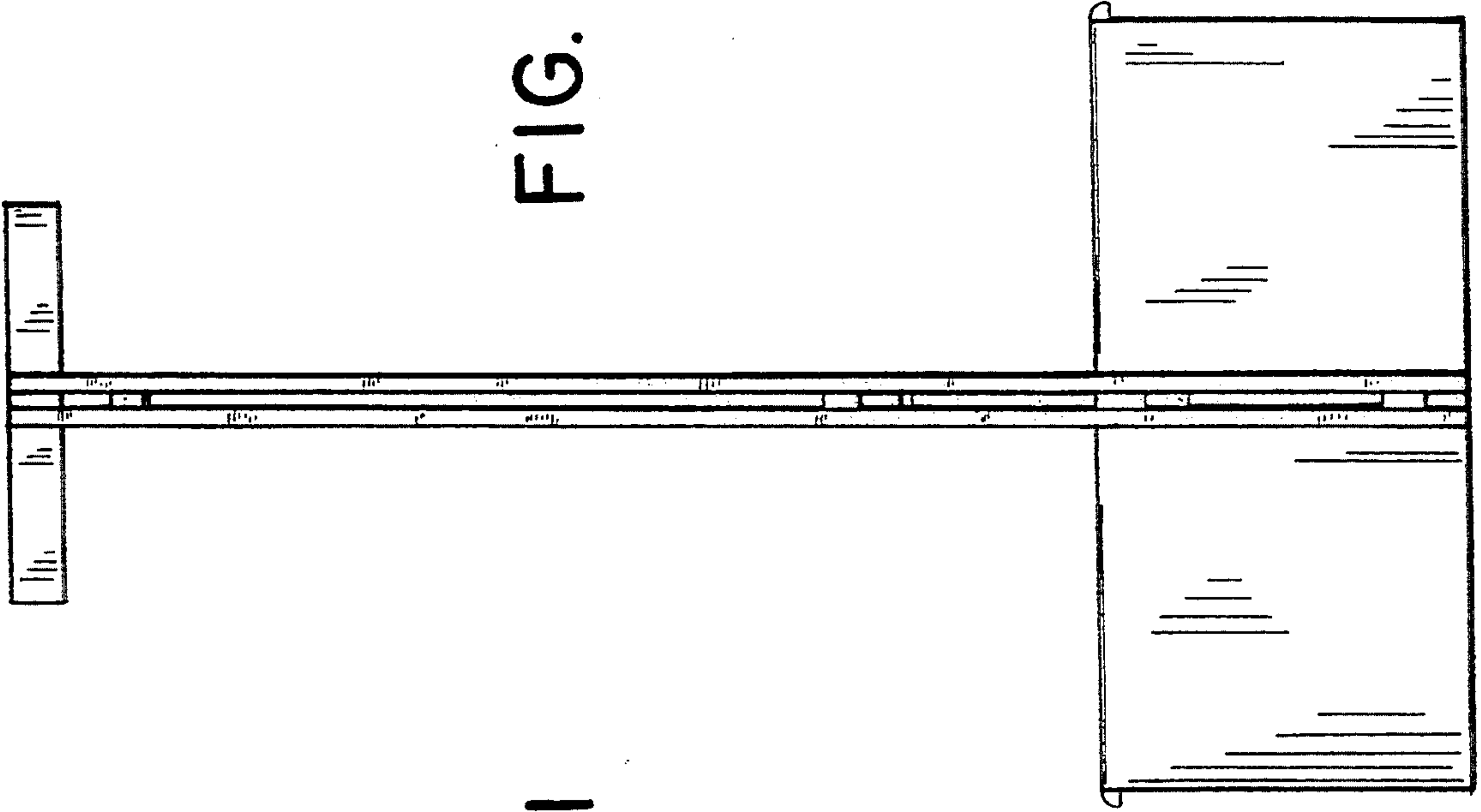

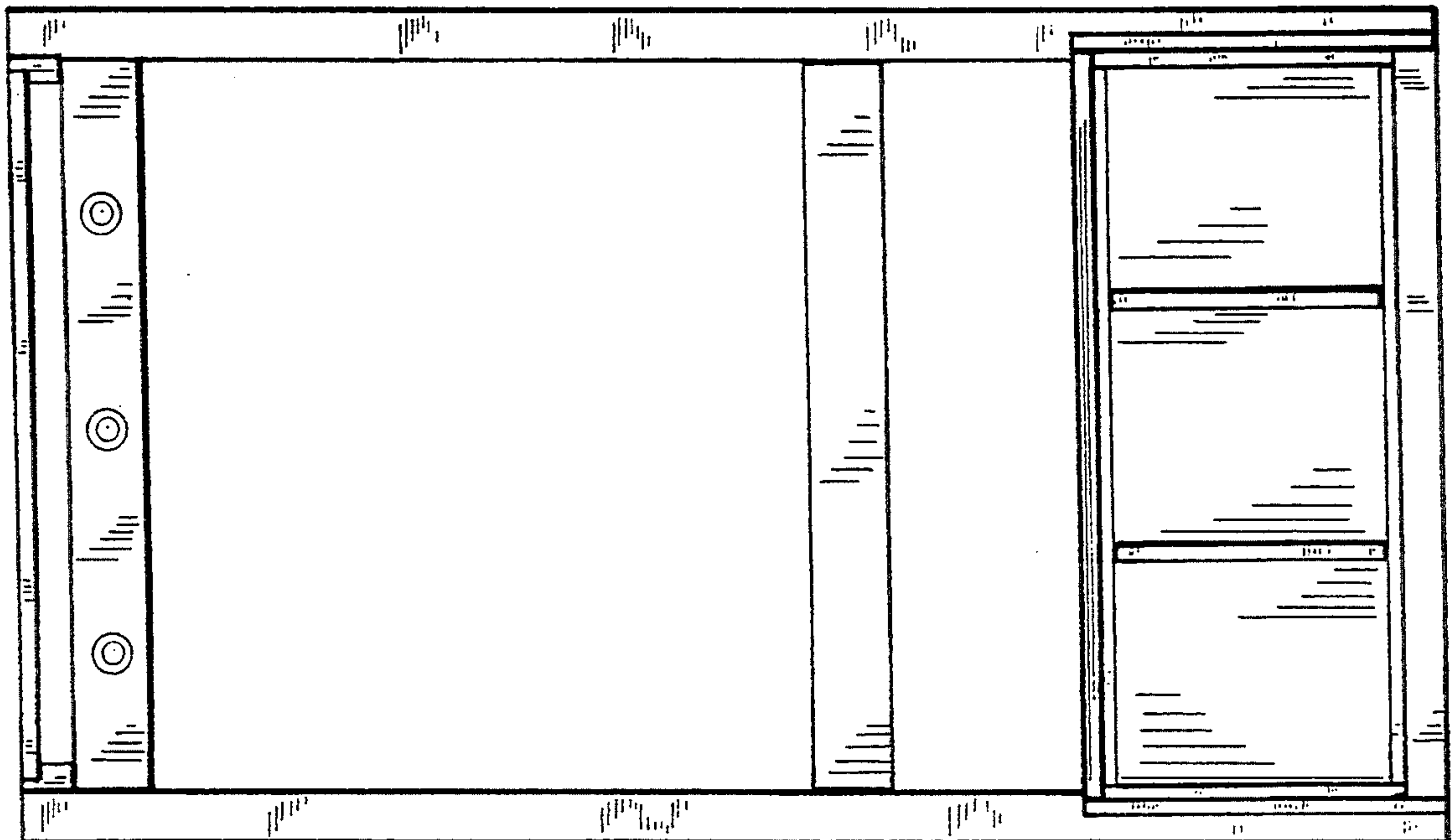

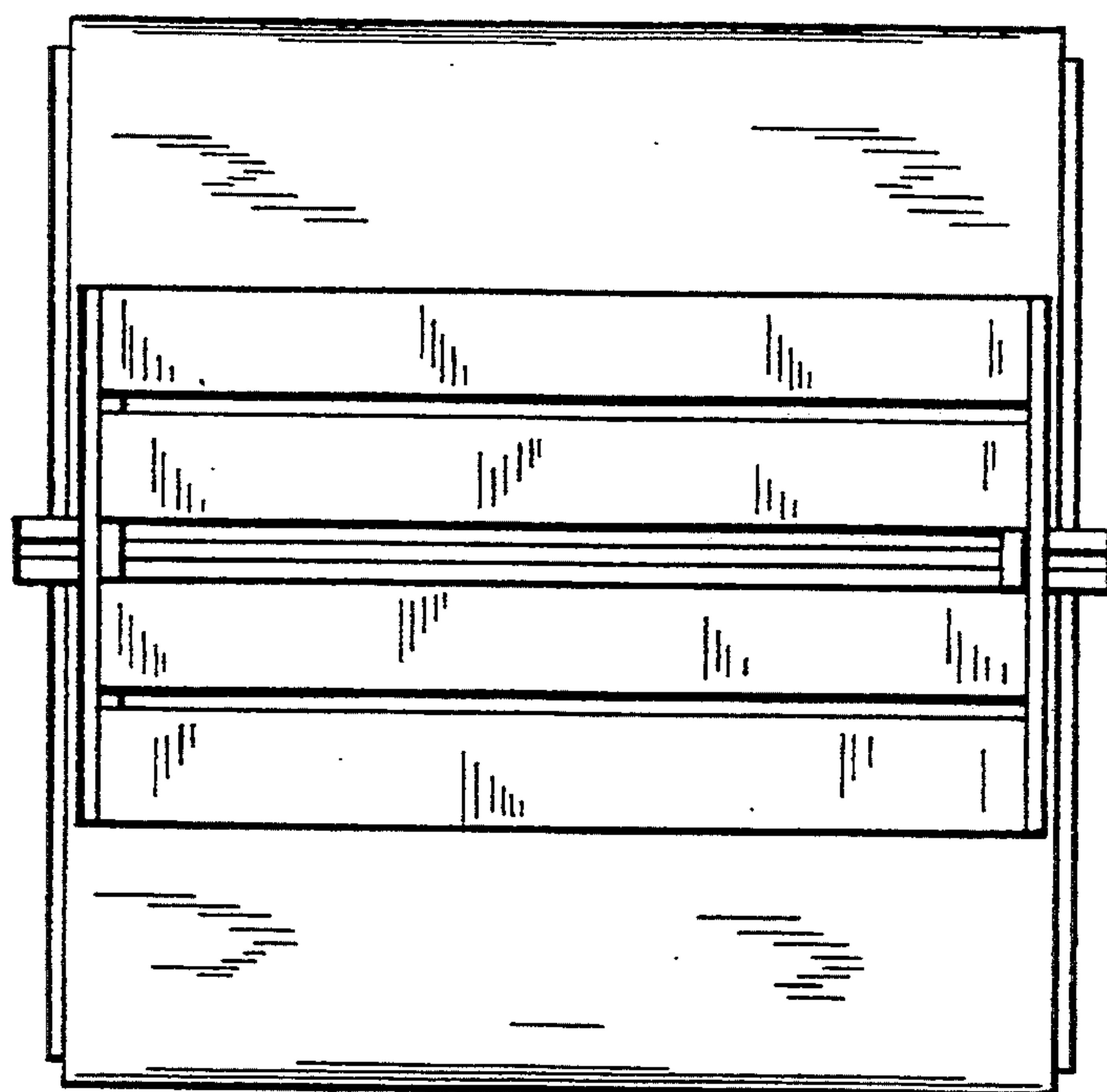

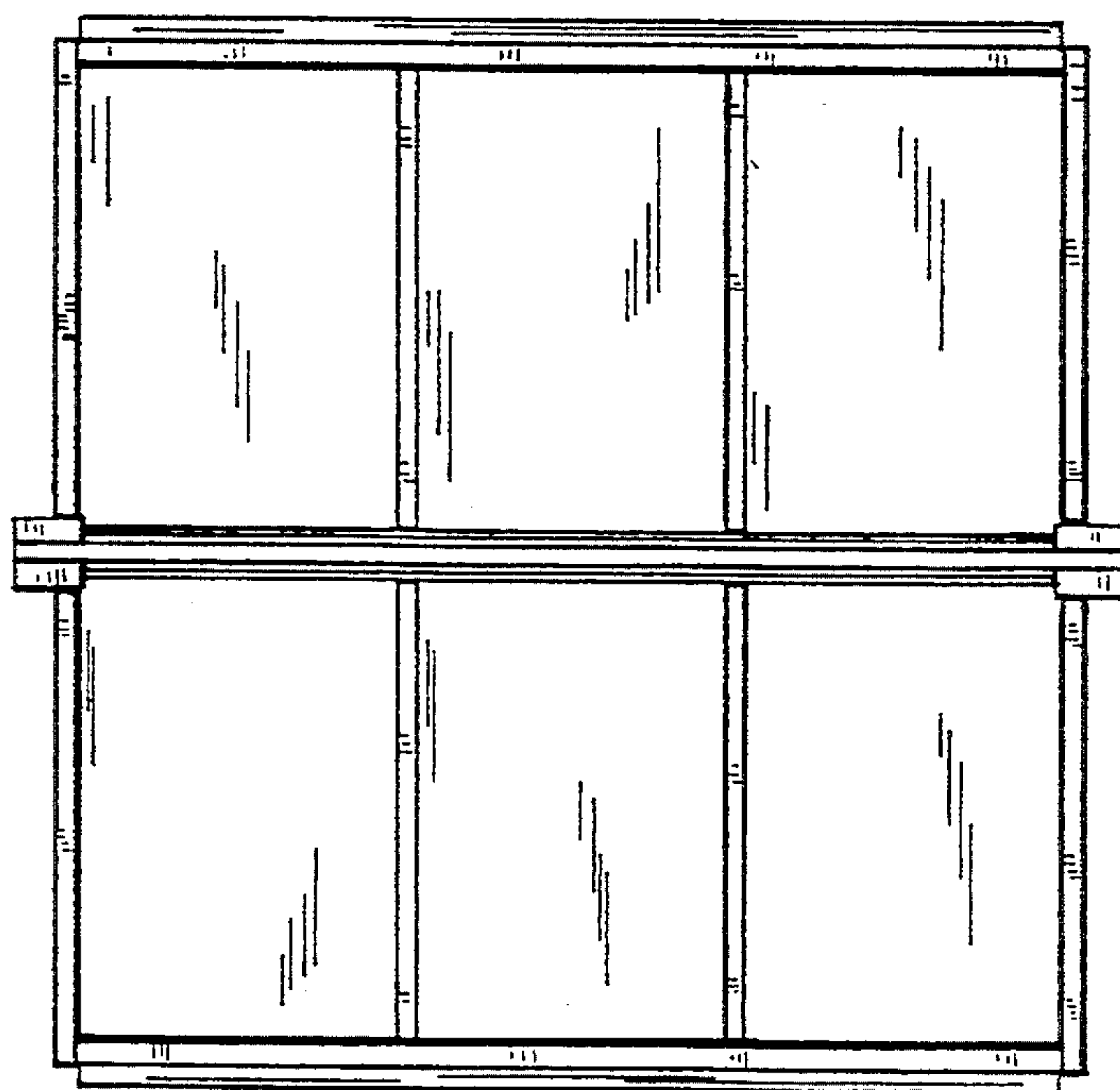
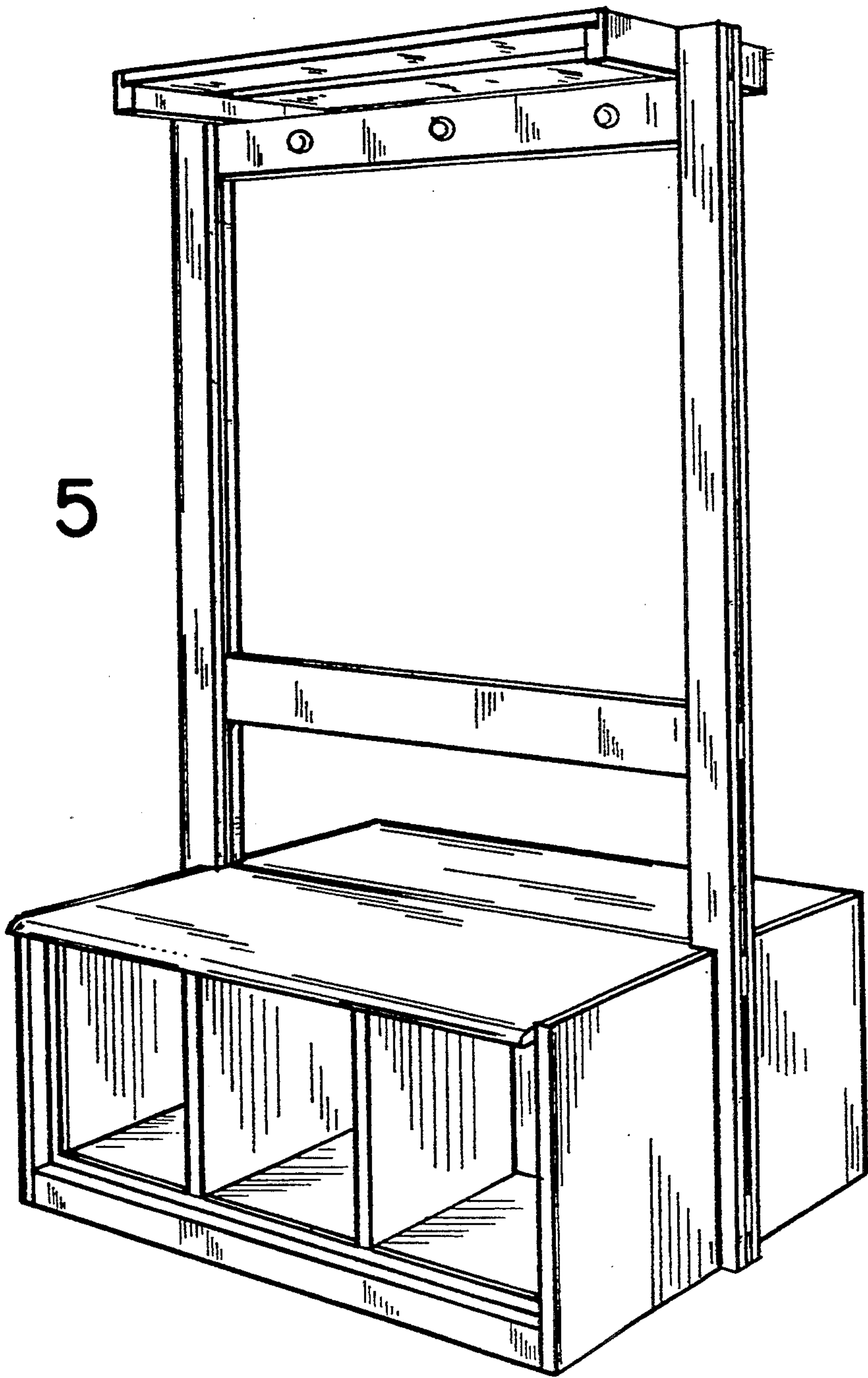
