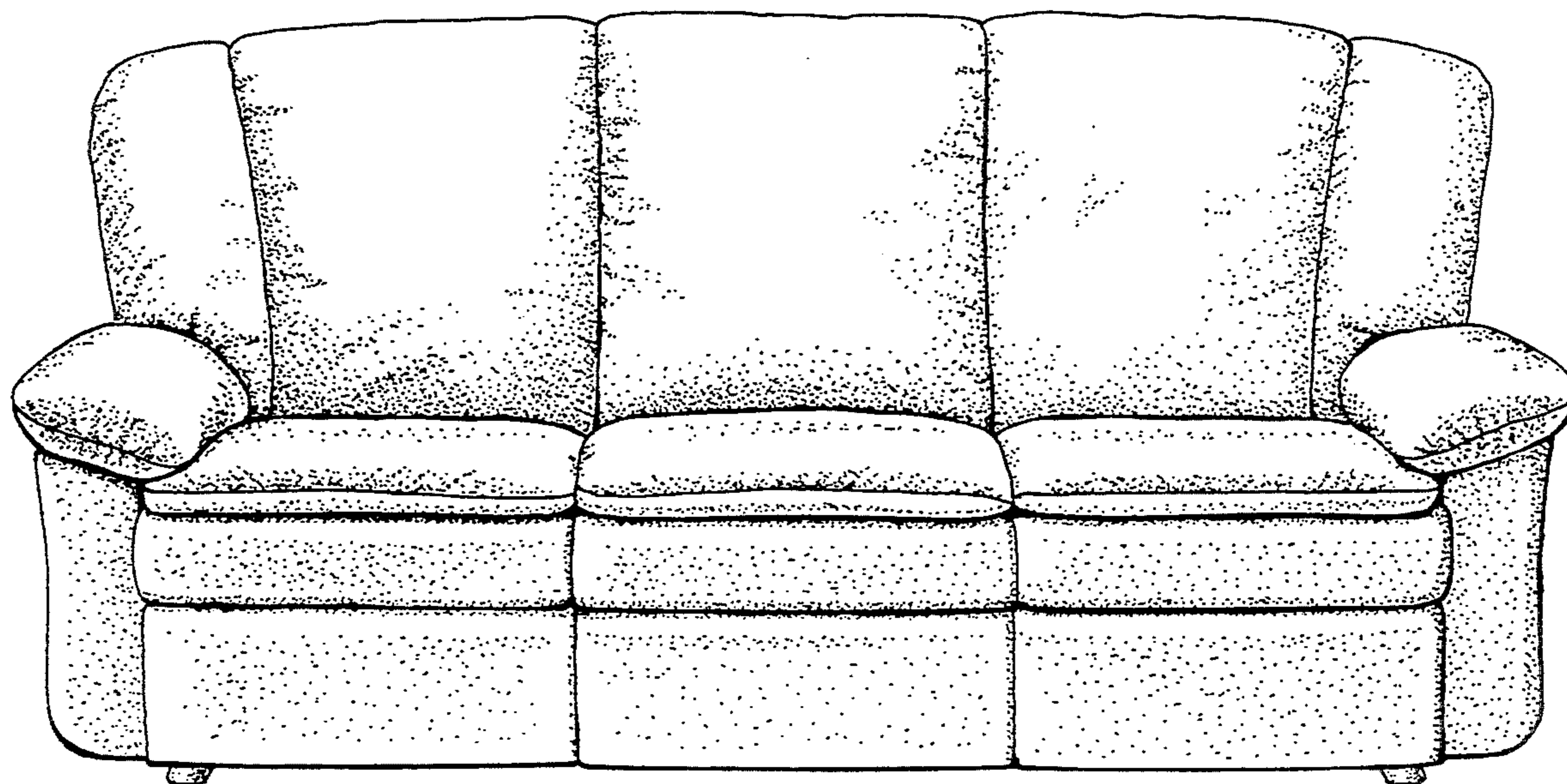

- FIG. 4 is a rear perspective view.



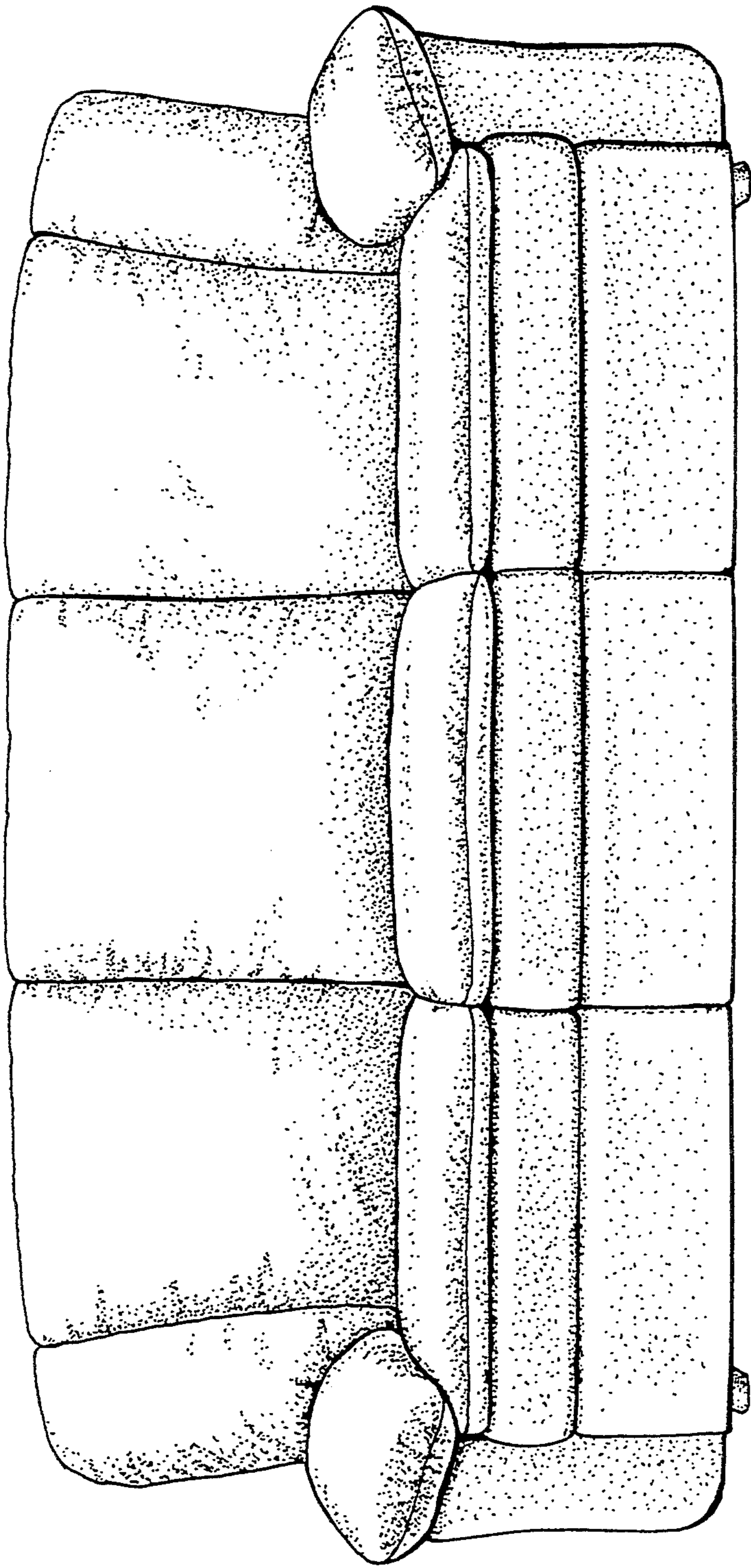

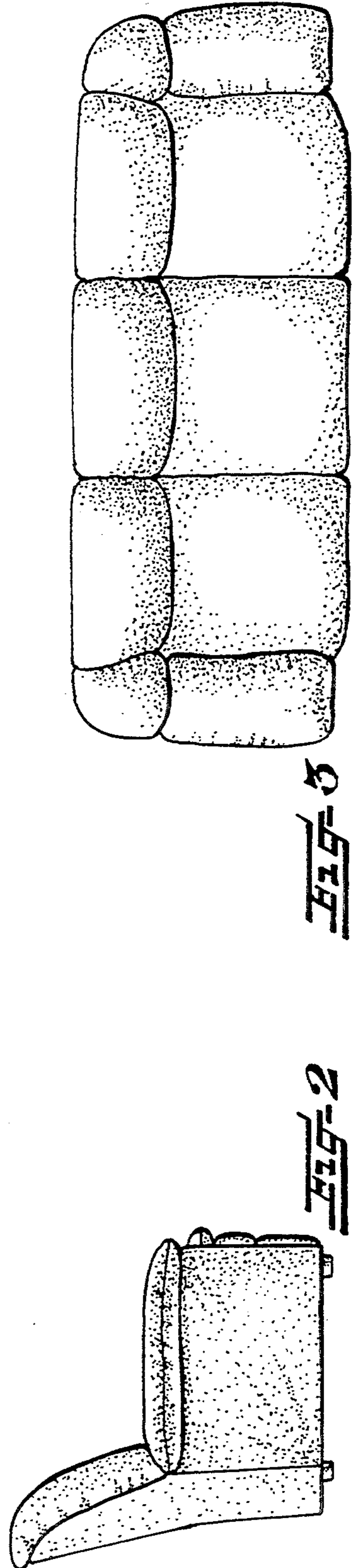
