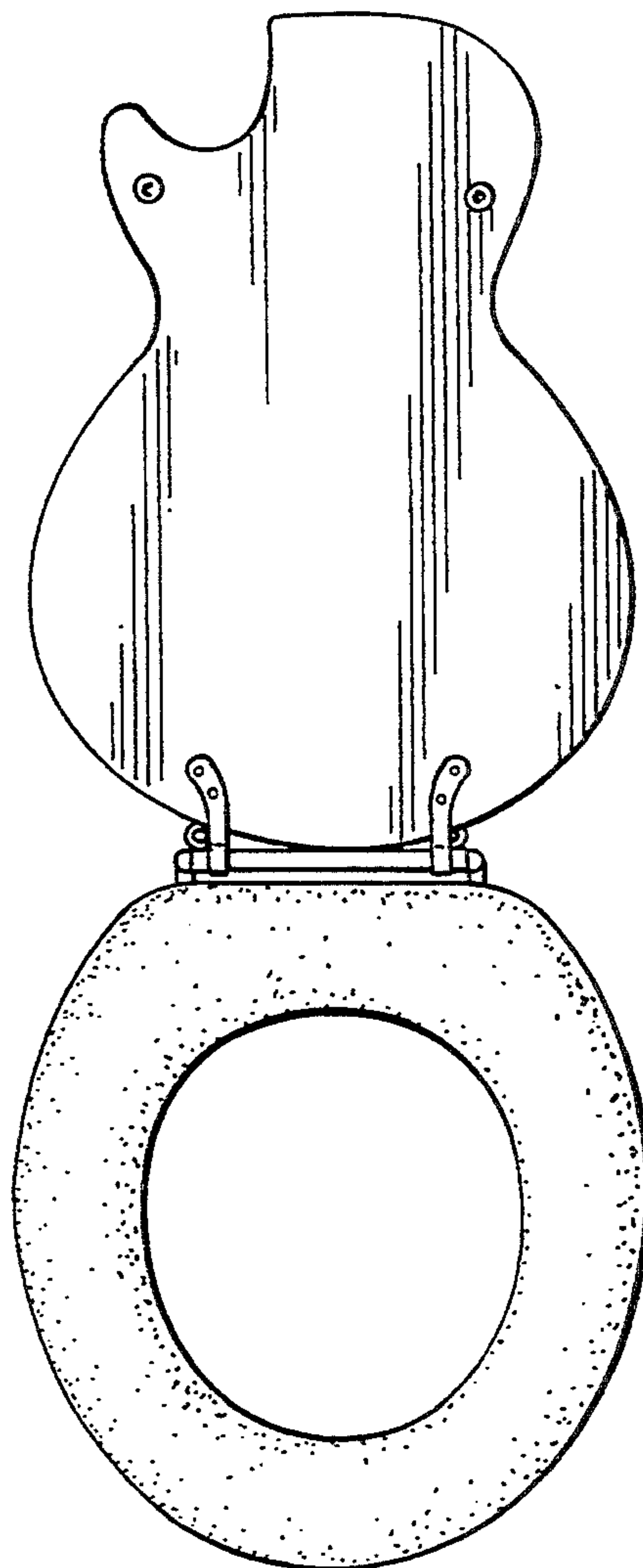

The ornamental design for a combined toilet seat and cover, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view with cover open of the combined toilet seat and cover;
FIG. 2 is a top plan view with cover closed of the combined toilet seat and cover;
FIG. 3 is a bottom plan view with cover closed of the combined toilet seat and cover;
FIG. 4 is a side elevation view with cover closed of the combined toilet seat and cover;
FIG. 5 is a reversed side elevation view of the opposite side of FIG. 4 with cover closed of the combined toilet seat and cover;

FIG. 7 is a front elevation view with cover closed of the combined toilet seat and cover.



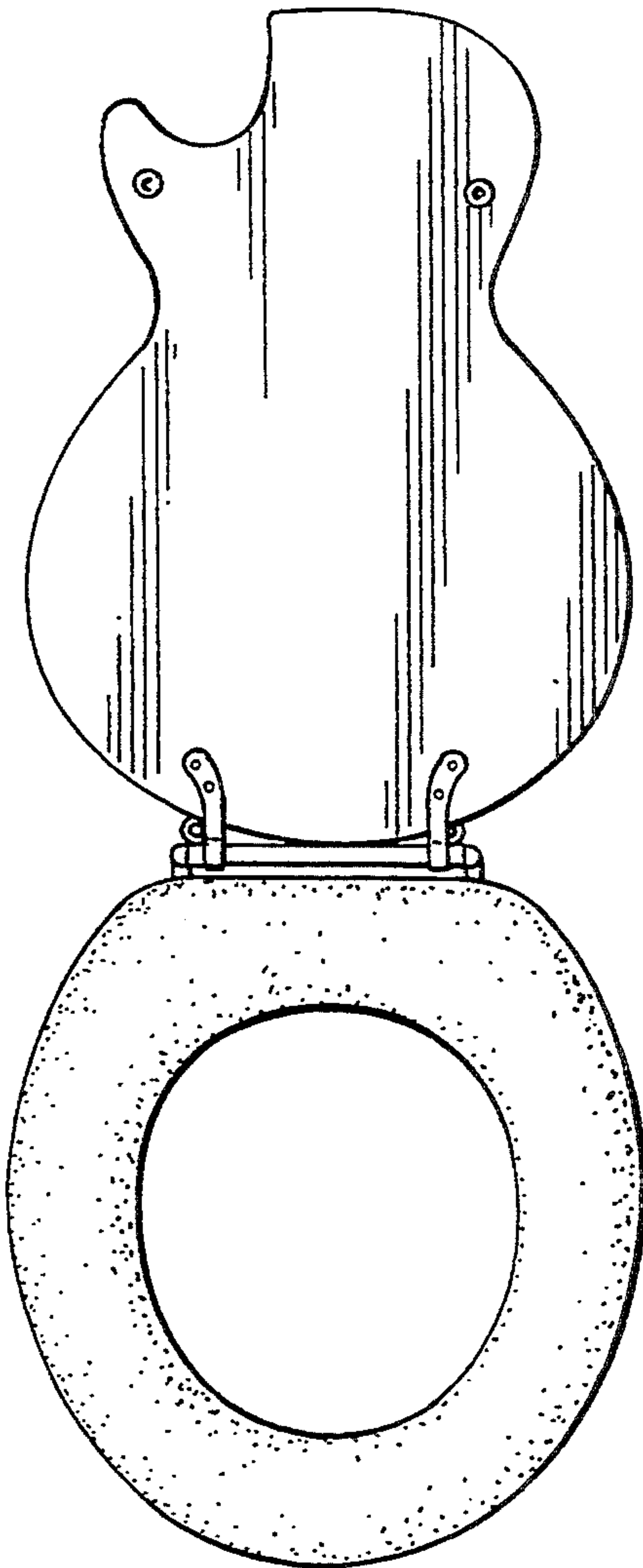

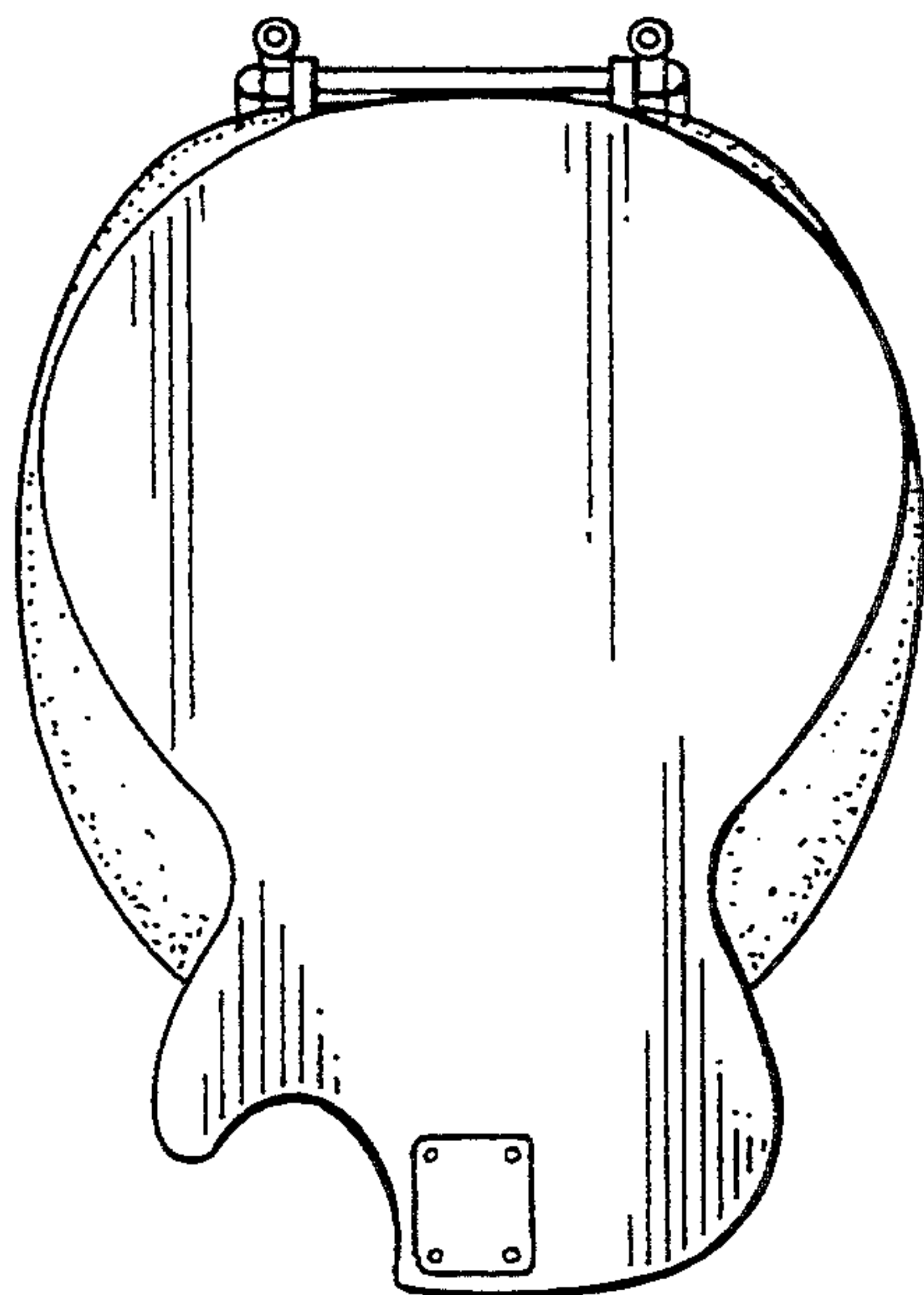

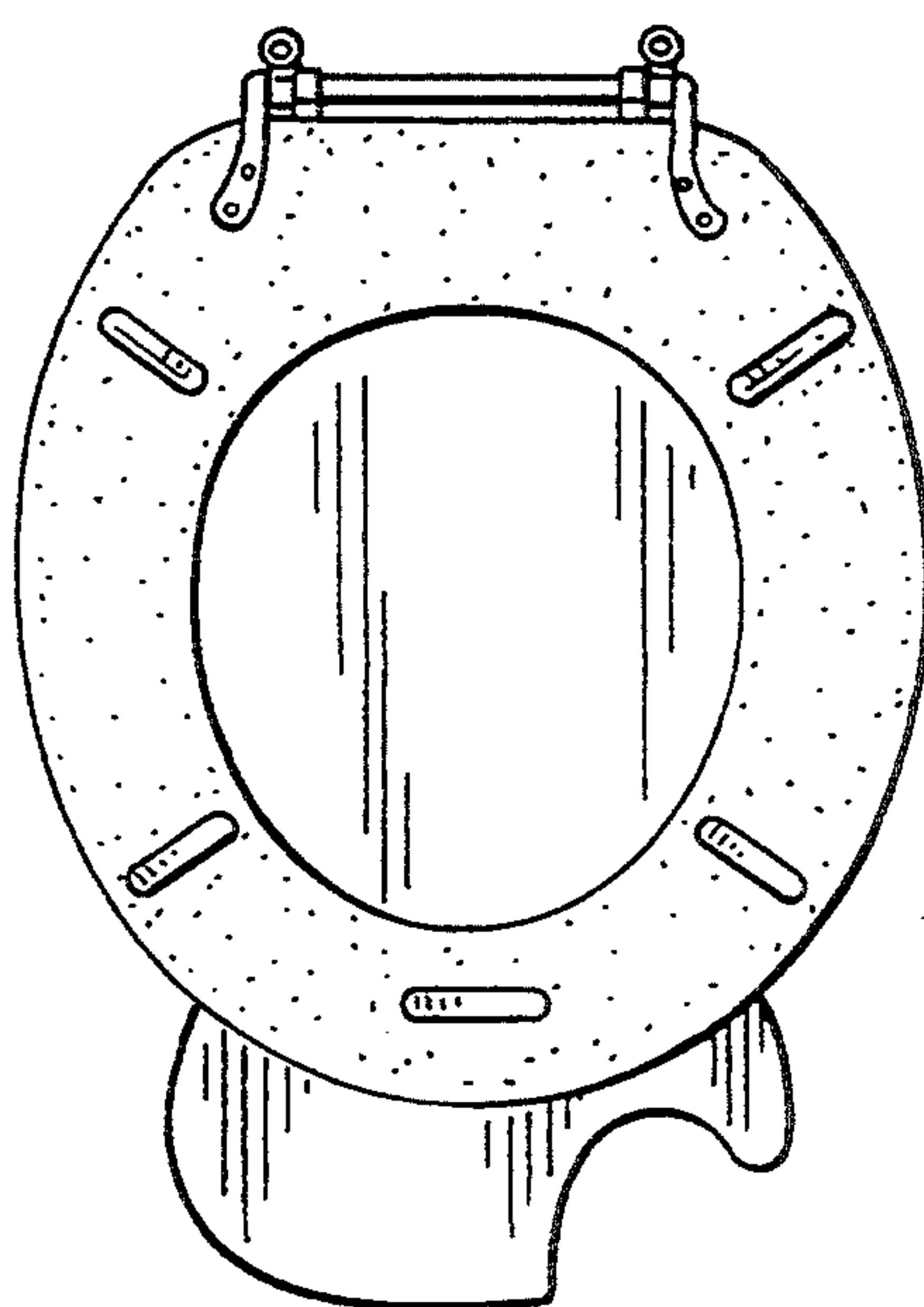

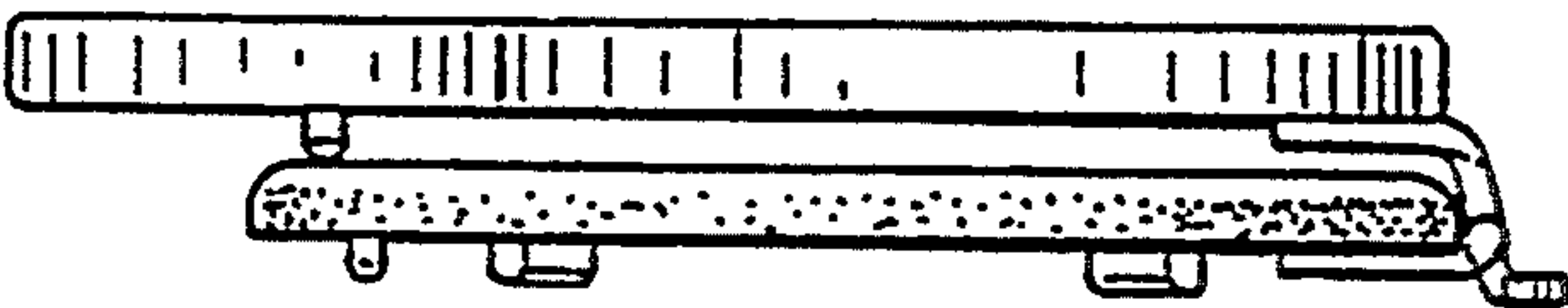

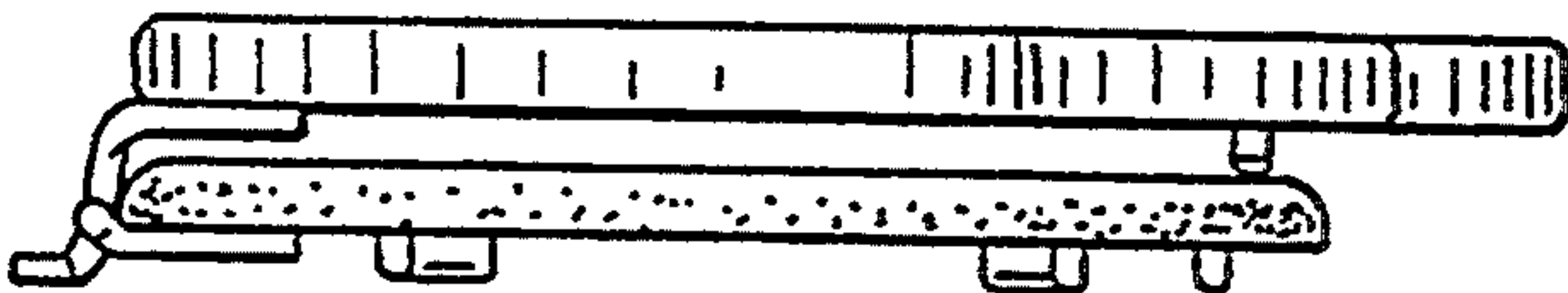

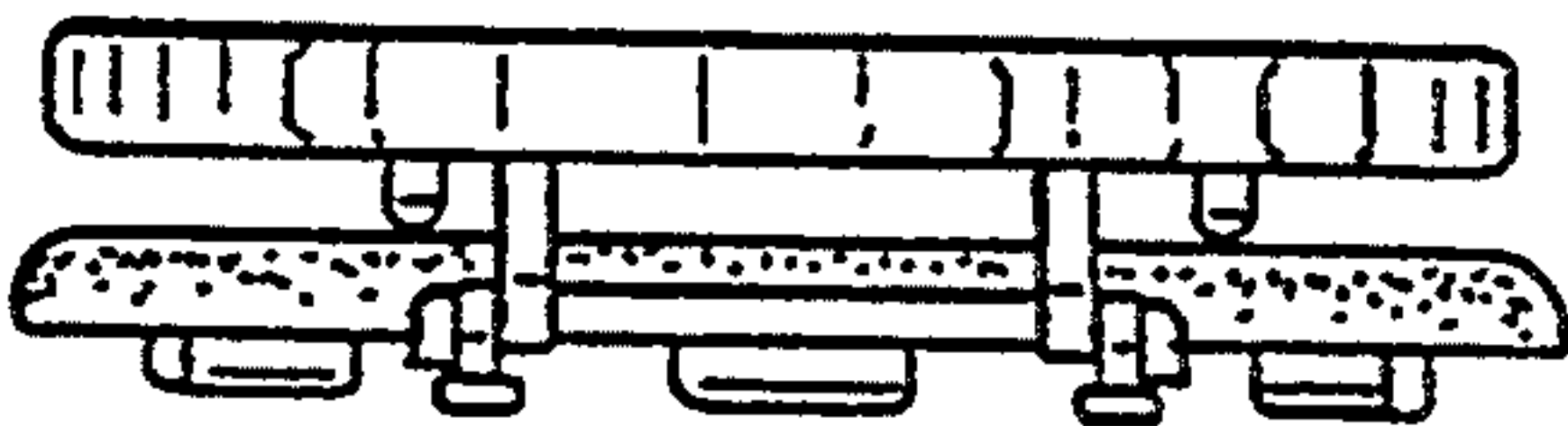

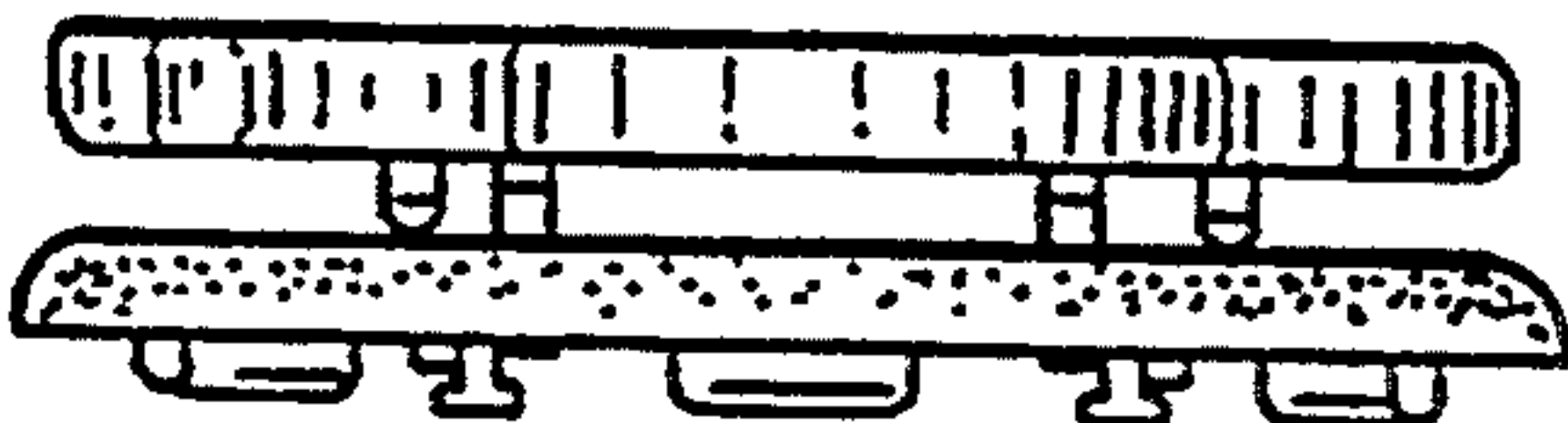

[57] CLAIM

The ornamental design for a combined toilet seat and cover, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view with cover open of the combined toilet seat and cover;

FIG. 2 is a top plan view with cover closed of the combined toilet seat and cover;

FIG. 3 is a bottom plan view with cover closed of the combined toilet seat and cover;

FIG. 4 is a side elevation view with cover closed of the combined toilet seat and cover;

FIG. 5 is a reversed side elevation view of the opposite side of FIG. 4 with cover closed of the combined toilet seat and cover;

FIG. 6 is a rear elevation view with cover closed of the combined toilet seat and cover; and,

FIG. 7 is a front elevation view with cover closed of the combined toilet seat and cover.
