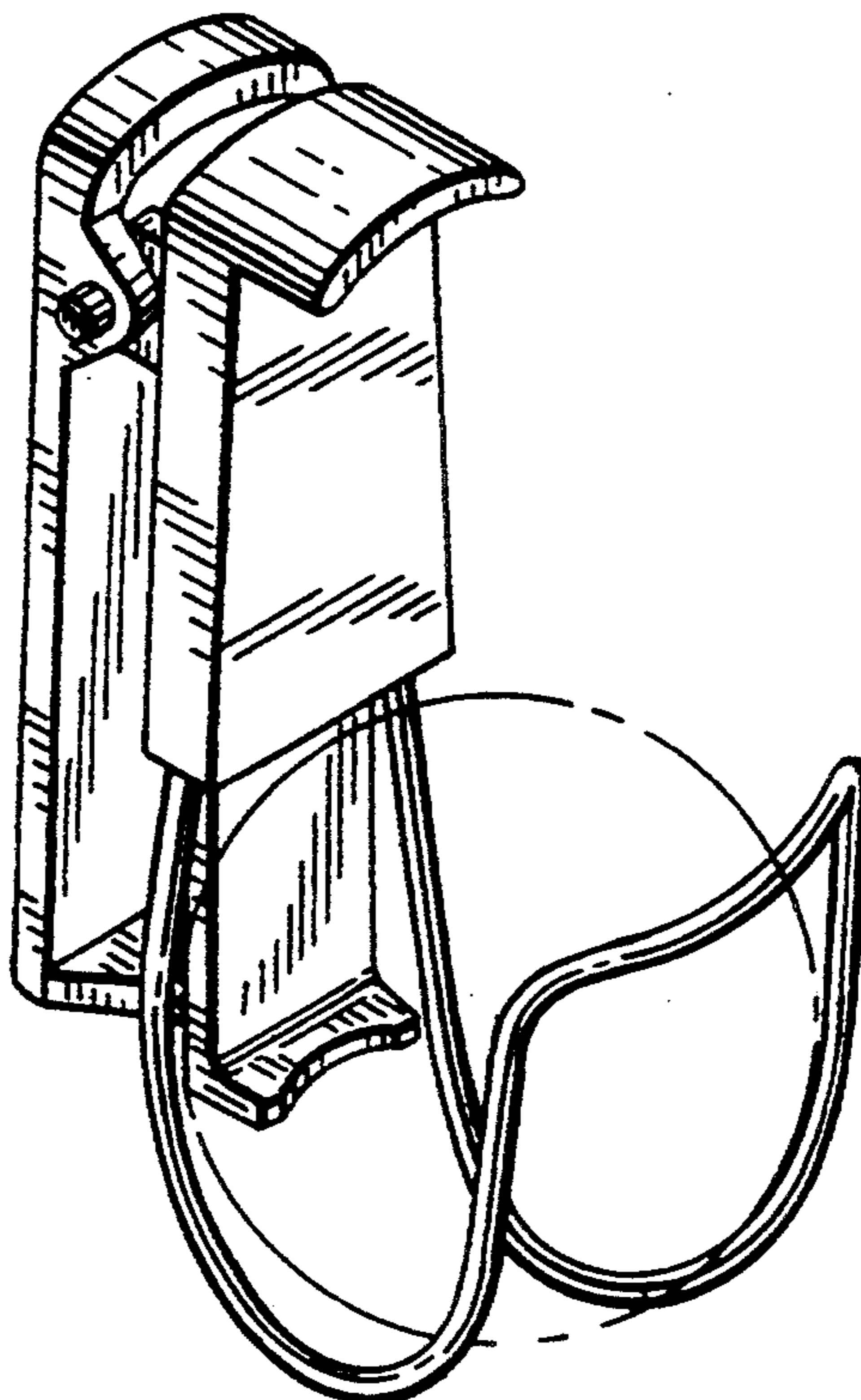

The ornamental design for clip-on golf ball holder, as shown and described.



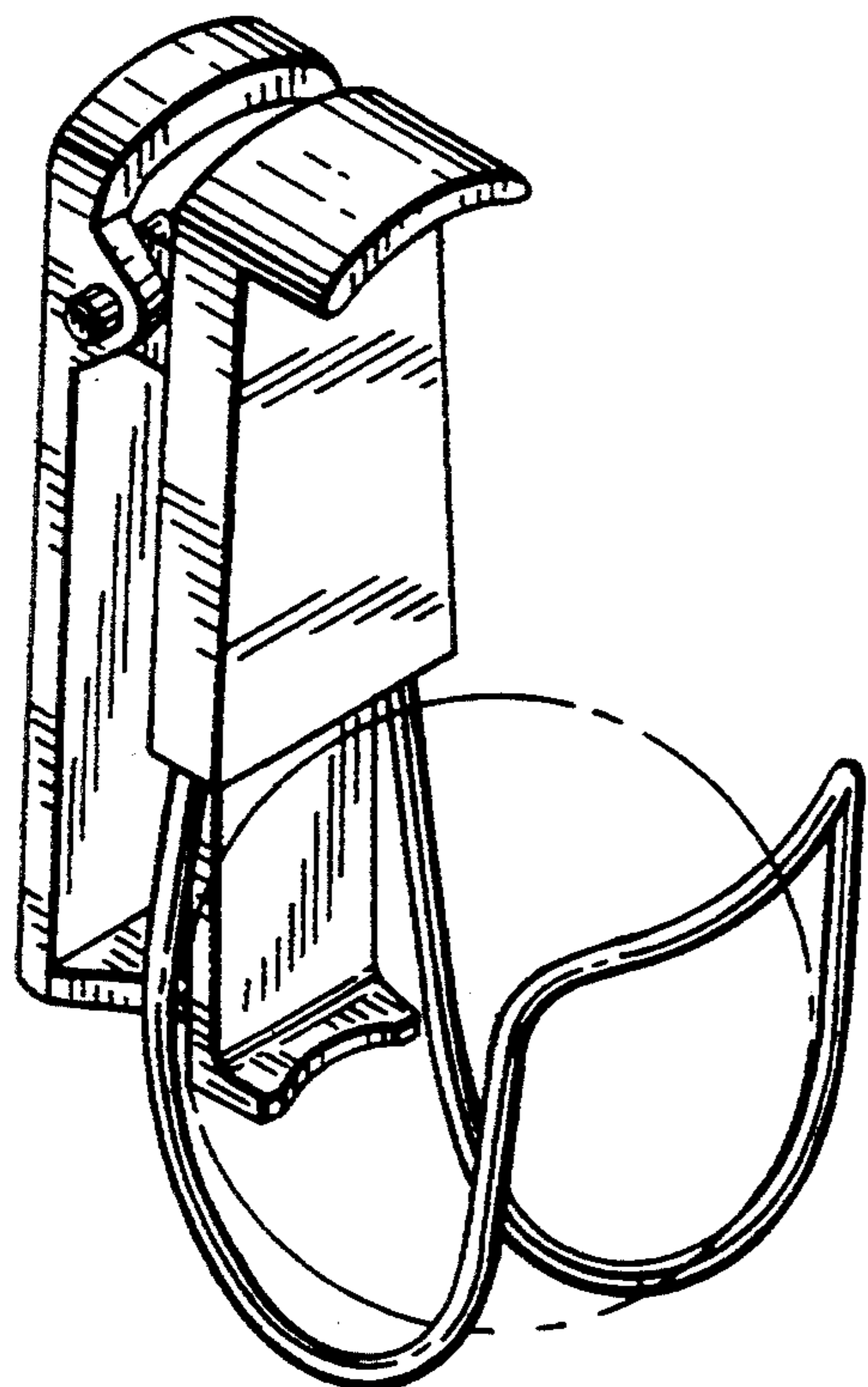
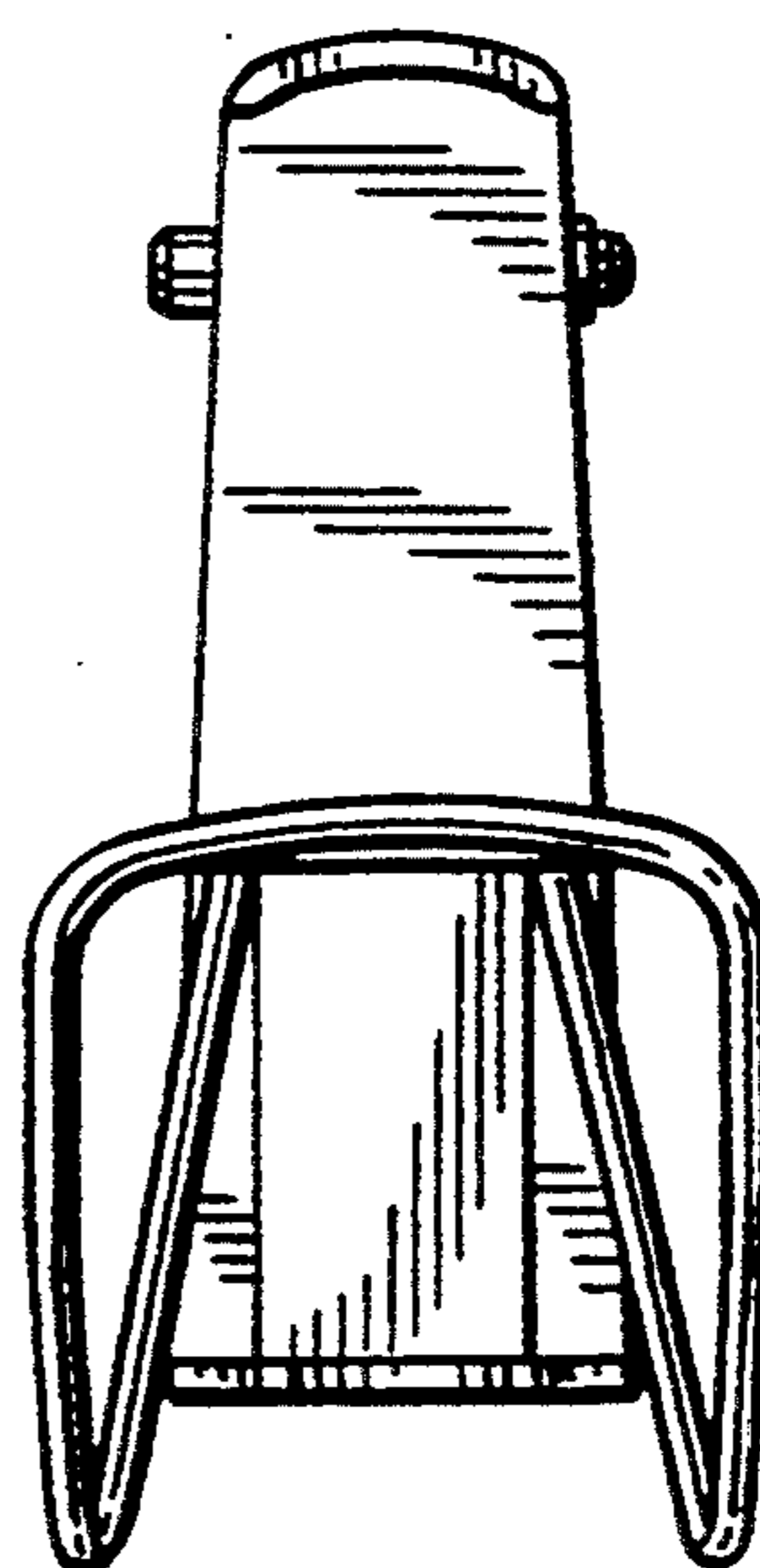

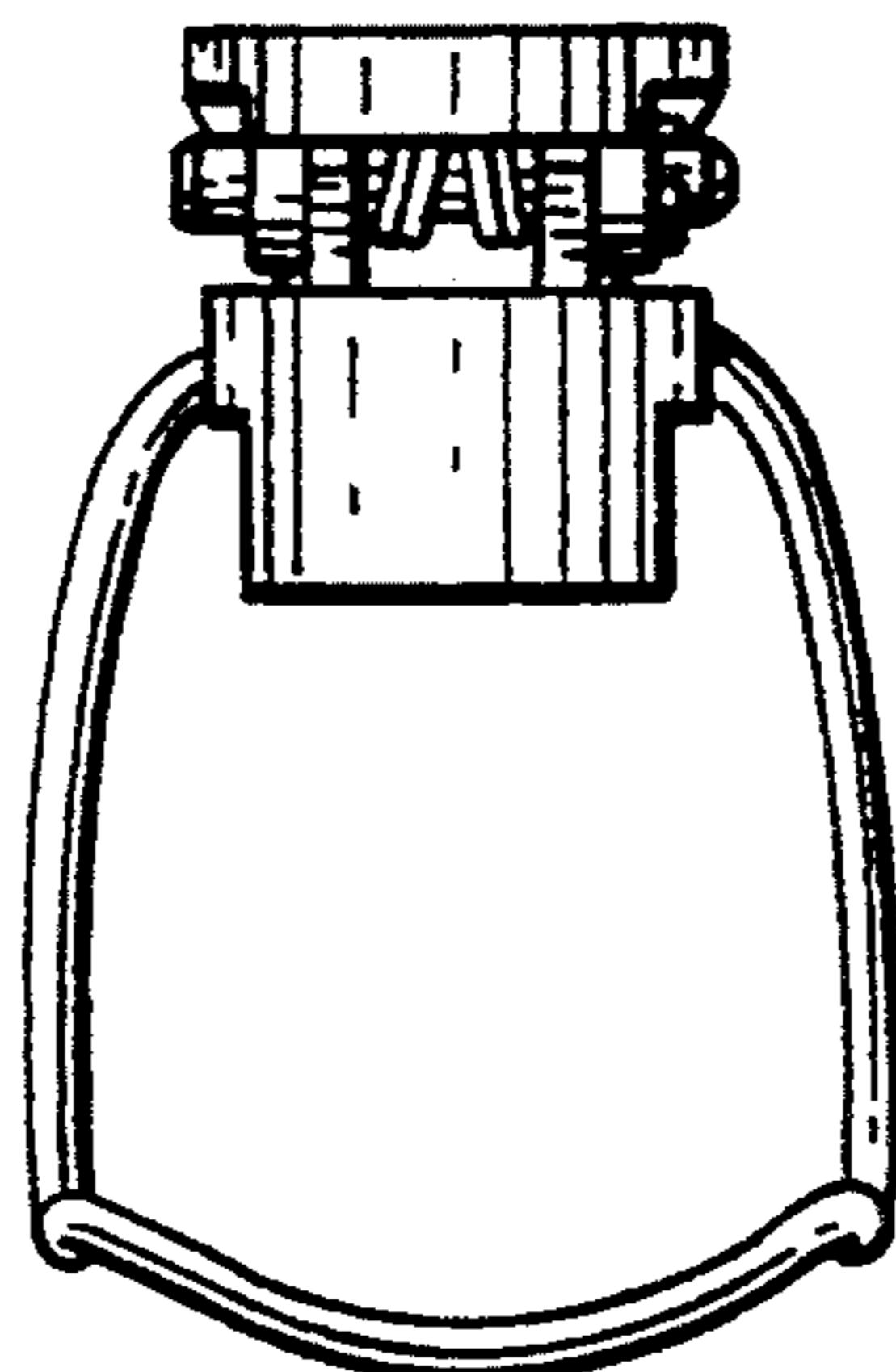

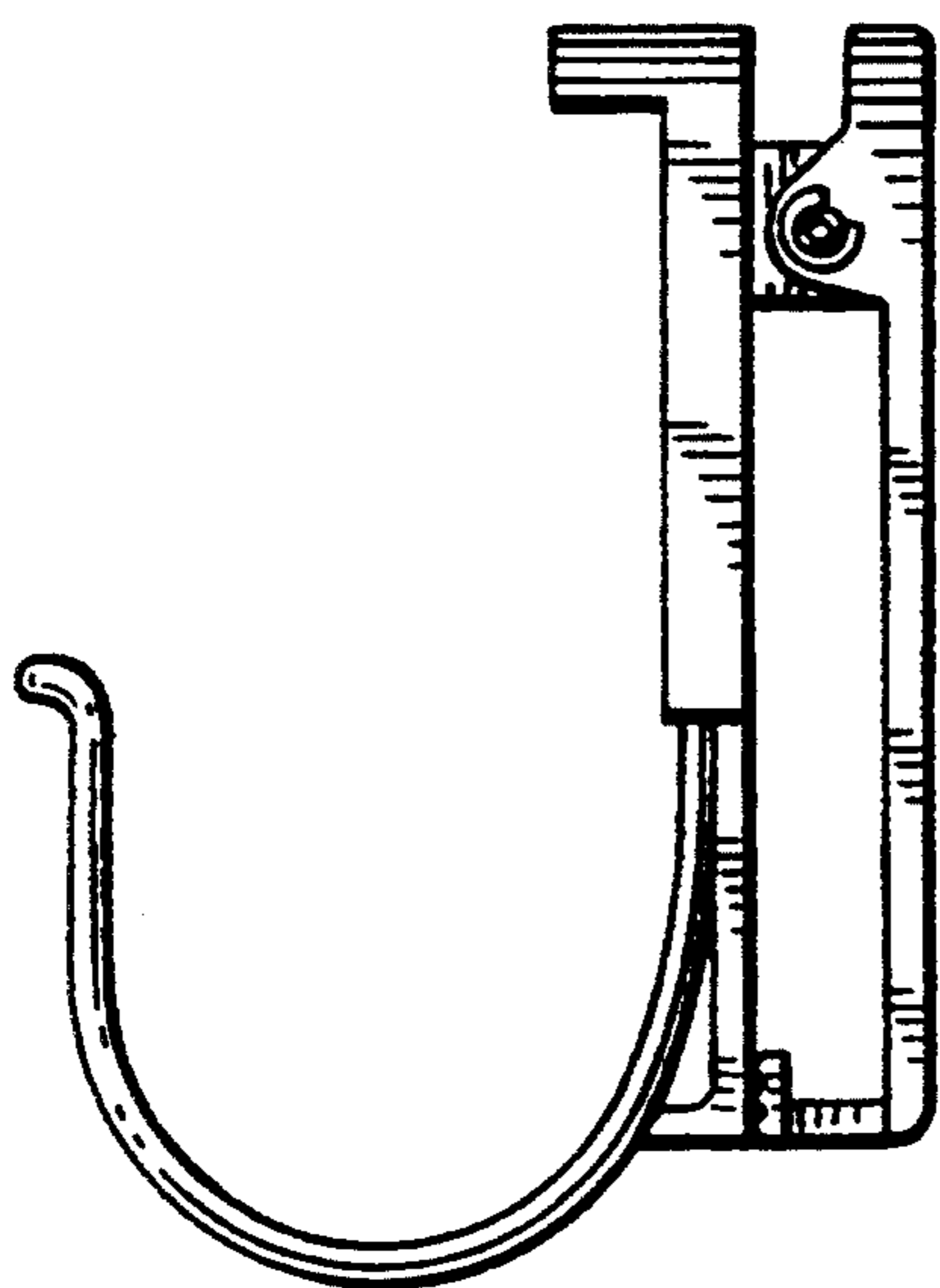

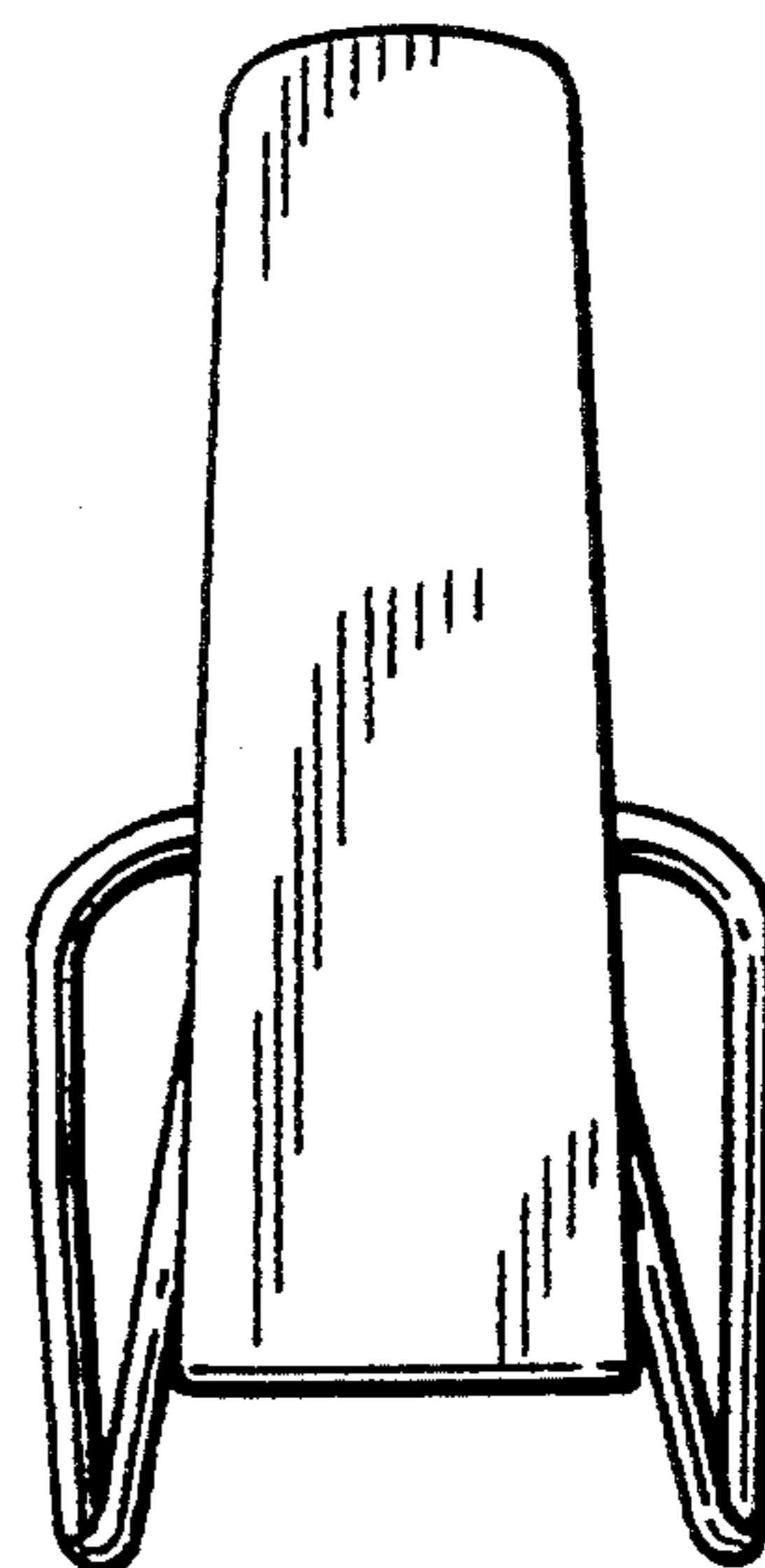

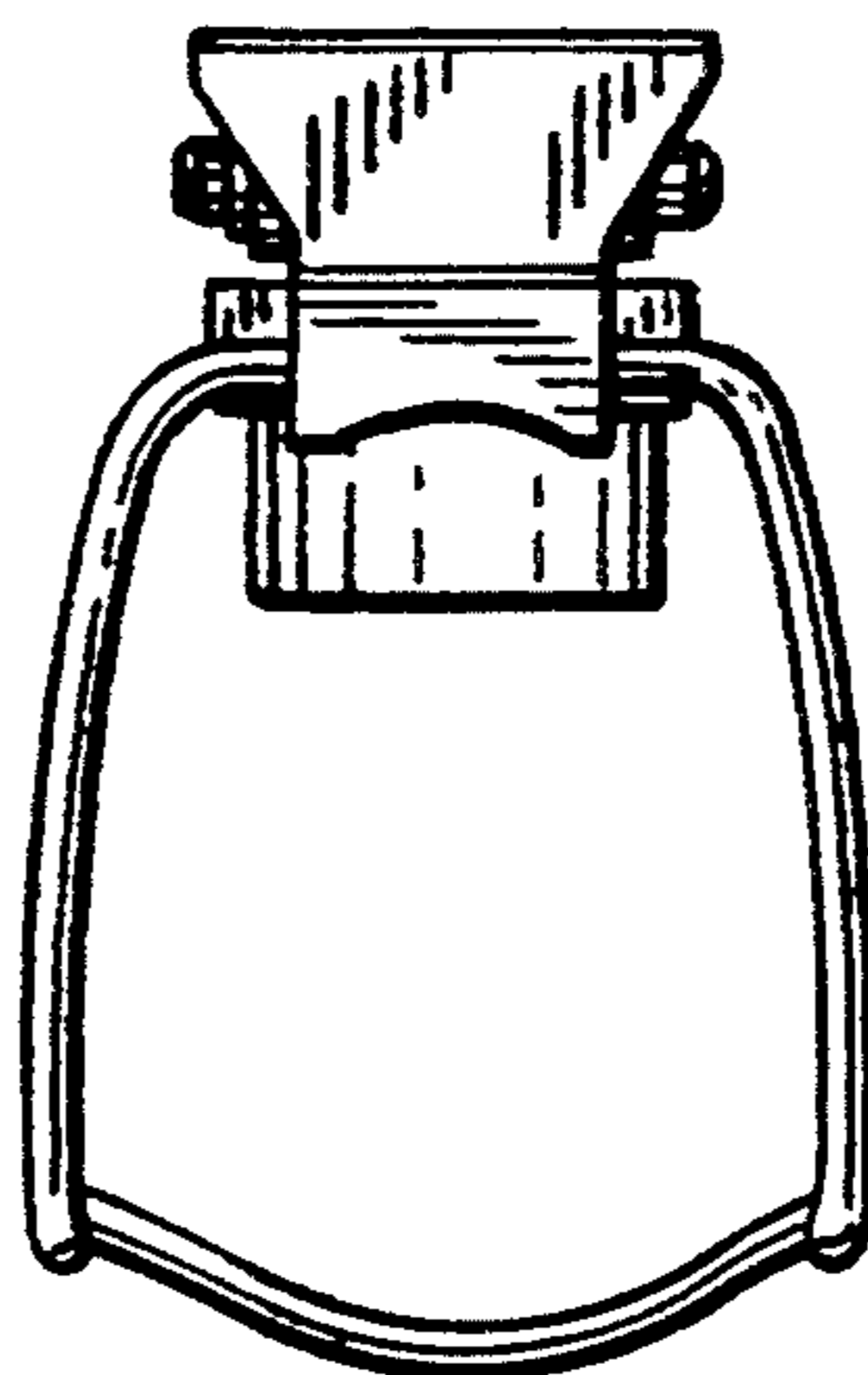
