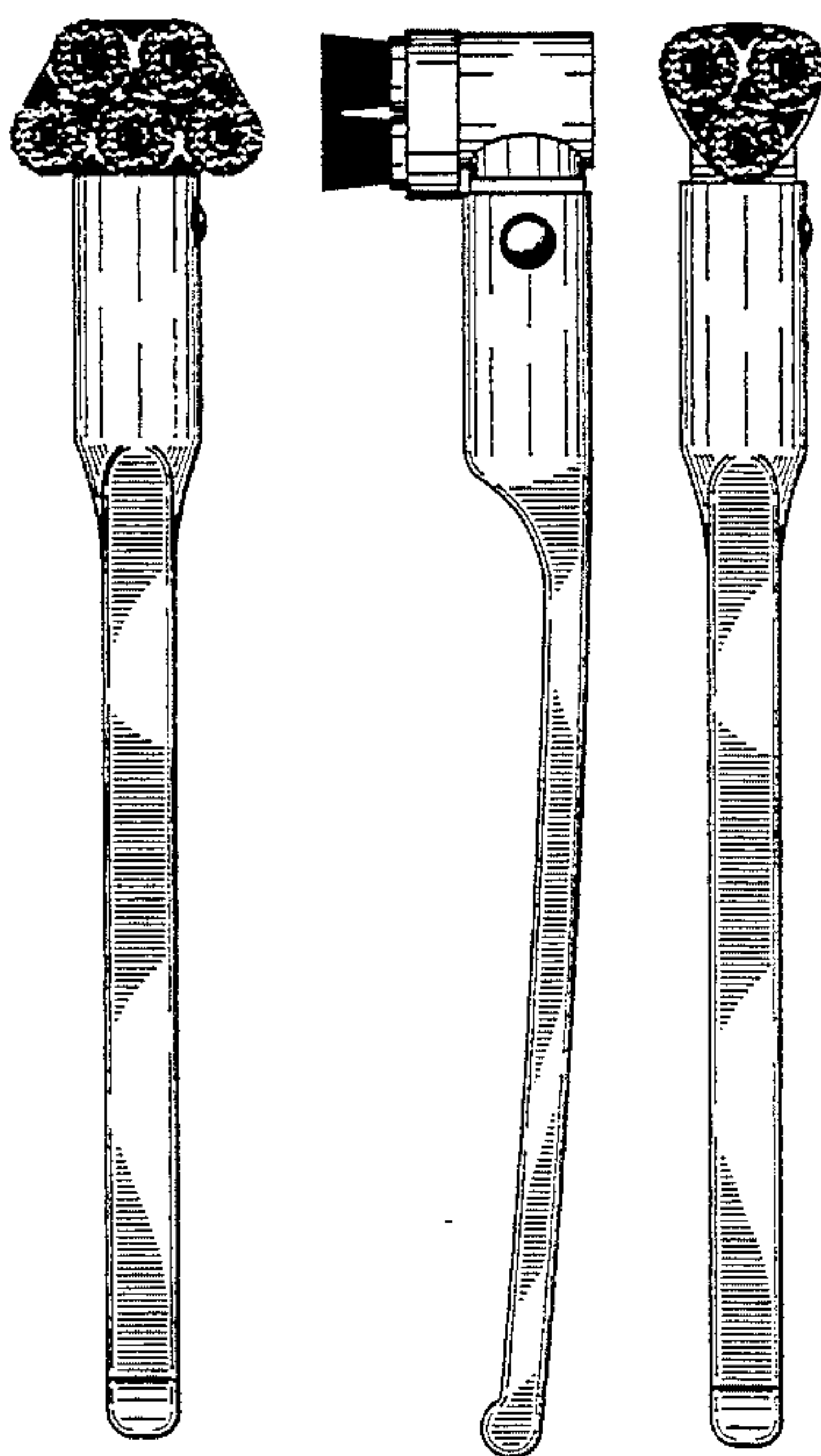
[57] **CLAIM**

The ornamental design for a bath brush, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the first embodiment of a bath brush showing my new design;
FIG. 2 is a left side elevational view of FIG. 1;

FIG. 3 is a front elevational view of the second embodiment of the bath brush;
FIG. 4 is a left side elevational view of FIG. 3;
FIG. 5 is an enlarged perspective view of the housing of the bath brush which is common to both embodiments and shown separately for clarity illustration only;
FIG. 6 is a rear elevational view of FIG. 5;
FIG. 7 is a bottom plan view of FIG. 5;
FIG. 8 is a top plan view of FIG. 5;
FIG. 9 is a right side elevational view of FIG. 5;
FIG. 10 is a front elevational view of FIG. 5;
FIG. 11 is a left side elevational view of FIG. 5;
FIG. 12 is an enlarged perspective view of the brush head of the second embodiment, shown separately for clarity of illustration only;
FIG. 13 is a top plan view of FIG. 12;
FIG. 14 is a bottom plan view of FIG. 12;
FIG. 15 is a front elevational view of FIG. 12;
FIG. 16 is a left side elevational view of FIG. 12, the right side being a mirror image thereof;
FIG. 17 is a rear elevational of FIG. 12;
FIG. 18 is an enlarged perspective view of the brush head of the first embodiment, shown separately for clarity of illustration only;
FIG. 19 is a top plan view of FIG. 18;
FIG. 20 is a bottom plan view of FIG. 18;
FIG. 21 is a front elevational view of FIG. 18;
FIG. 22 is a left side elevational view of FIG. 18, the right side being a mirror image thereof;
FIG. 23 is a rear elevational view of FIG. 18;
FIG. 24 is a top plan view of the handle of the bath brush which is common to both embodiments and shown separately for clarity of illustration only;
FIG. 25 is a right side elevational view of FIG. 24;
FIG. 26 is a left side elevational view of FIG. 24;
FIG. 27 is a front elevational view of FIG. 24;
FIG. 28 is a rear elevational view of FIG. 24; and,
FIG. 29 is a bottom plan view of FIG. 24.



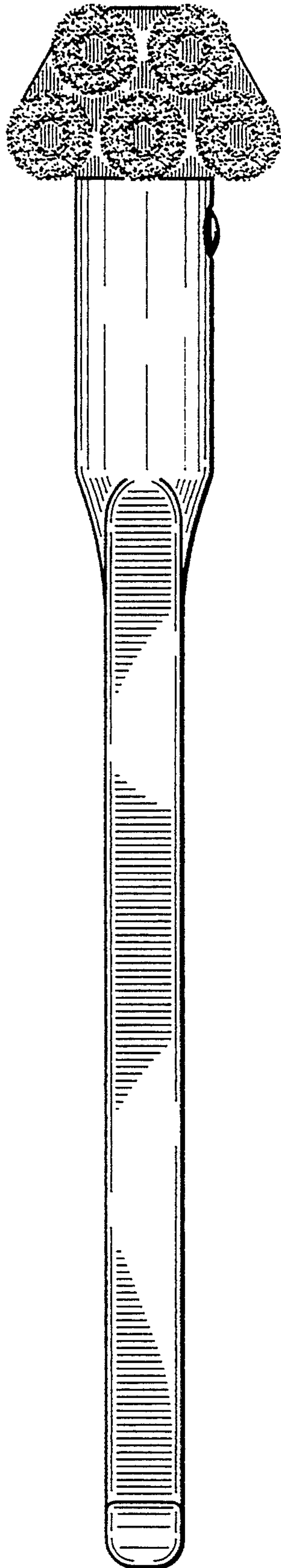

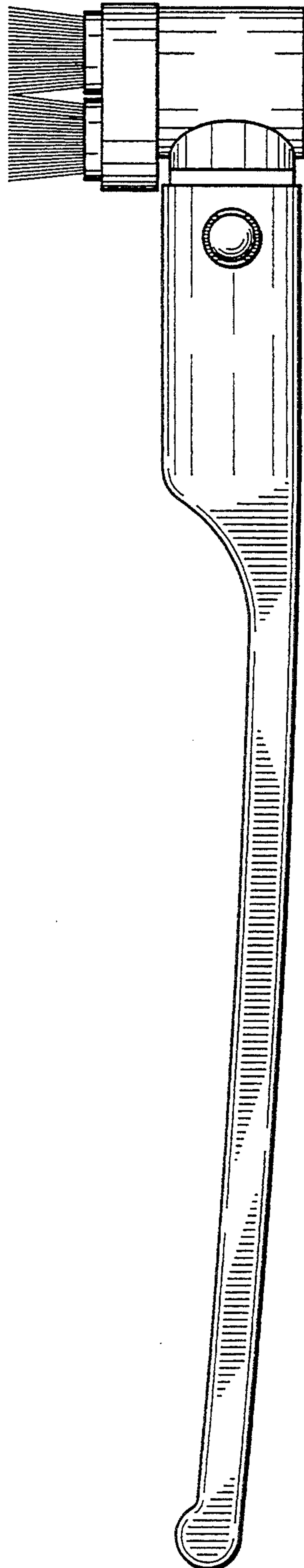

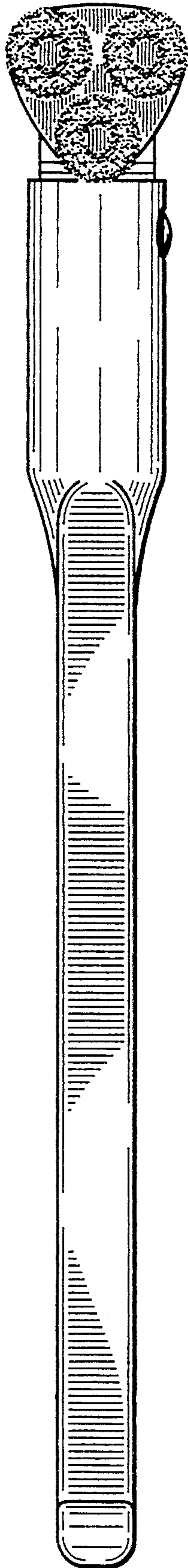

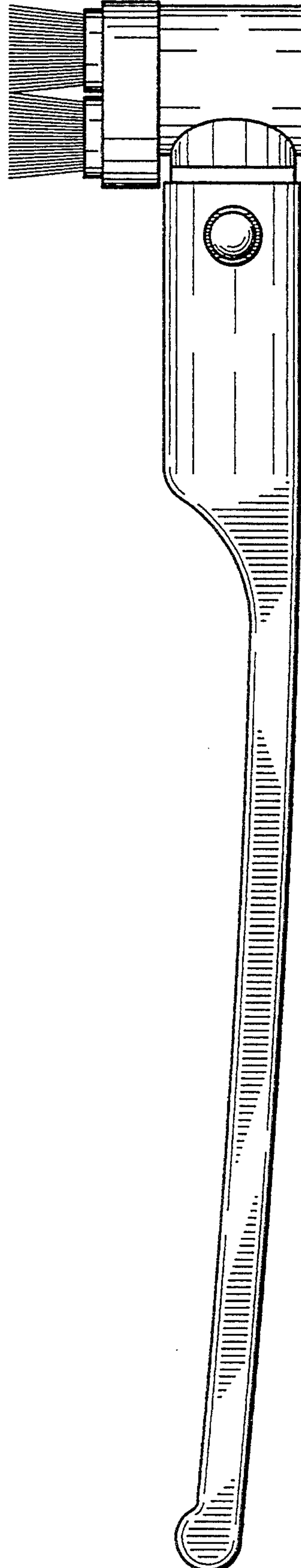

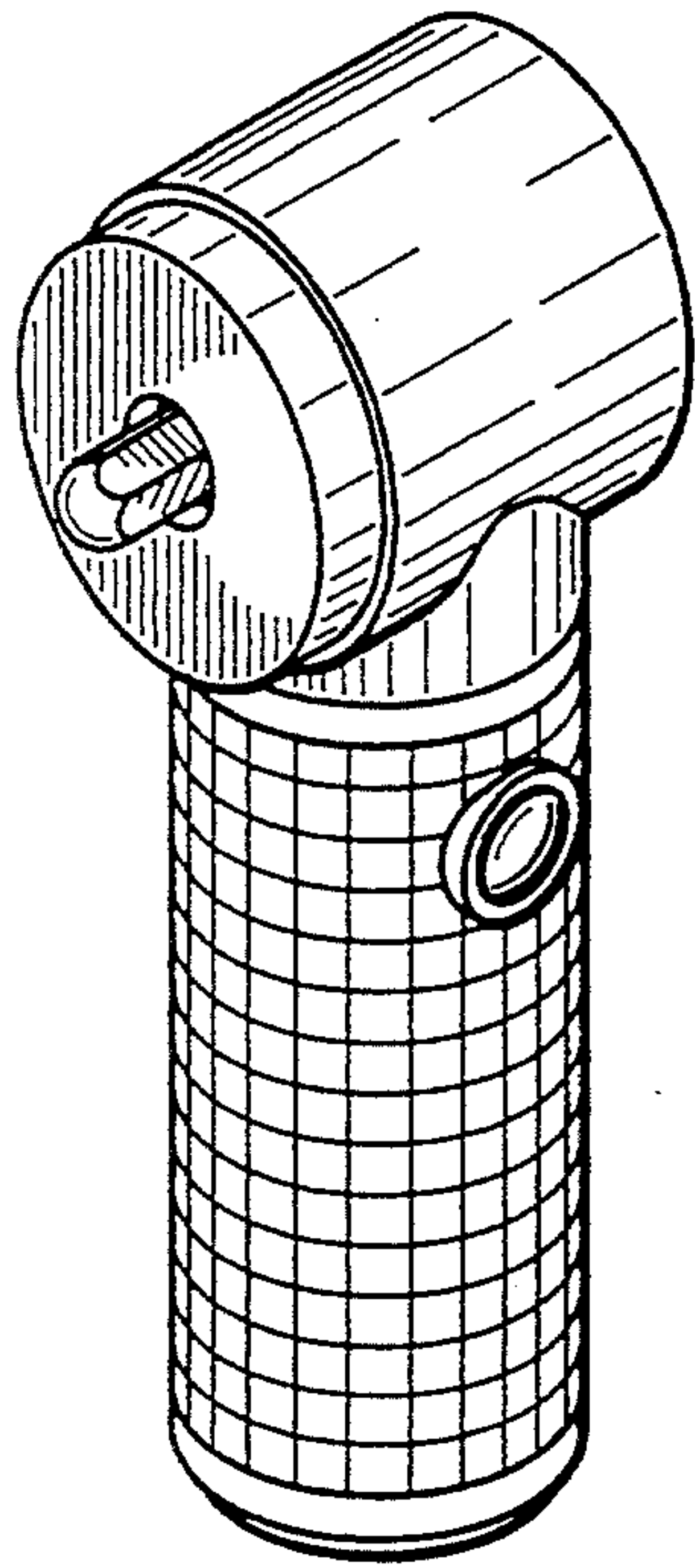

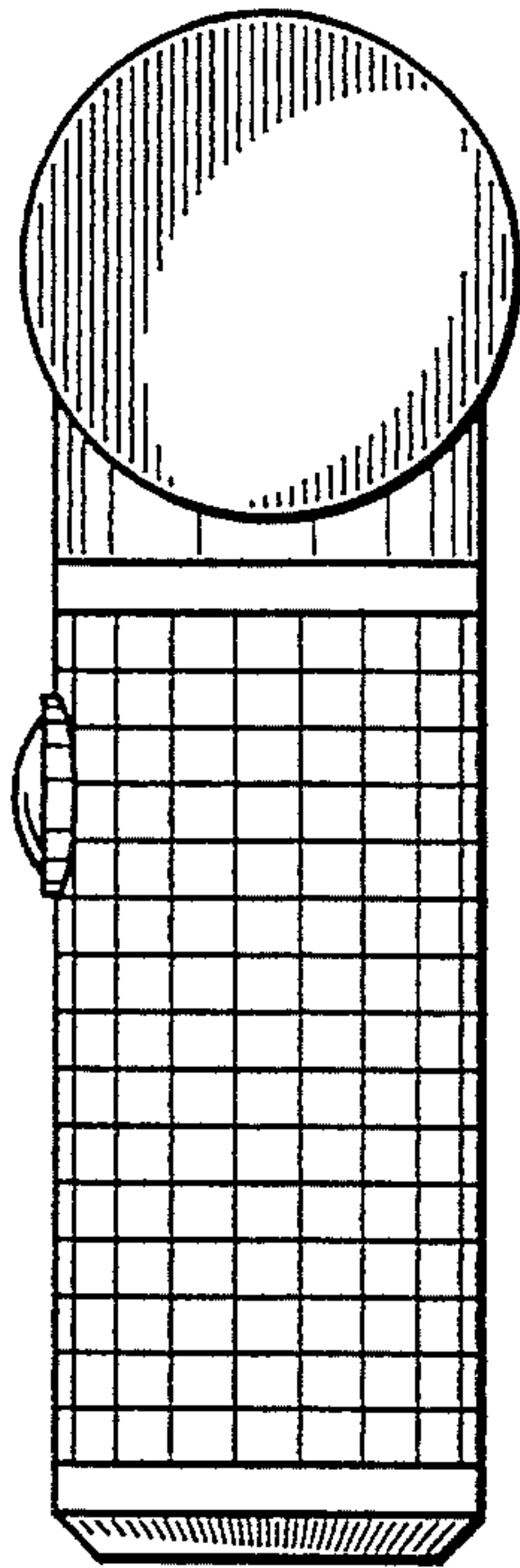

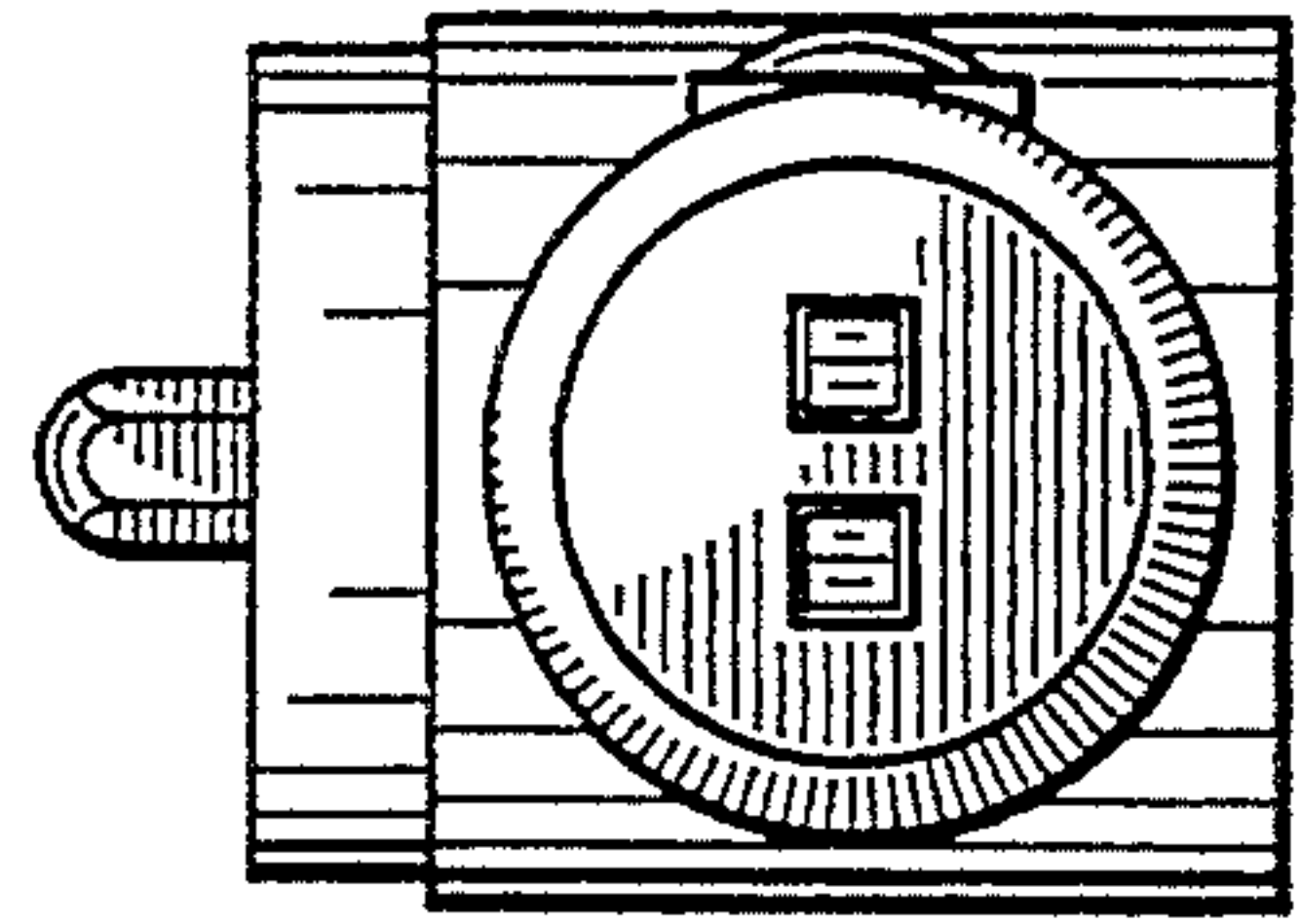

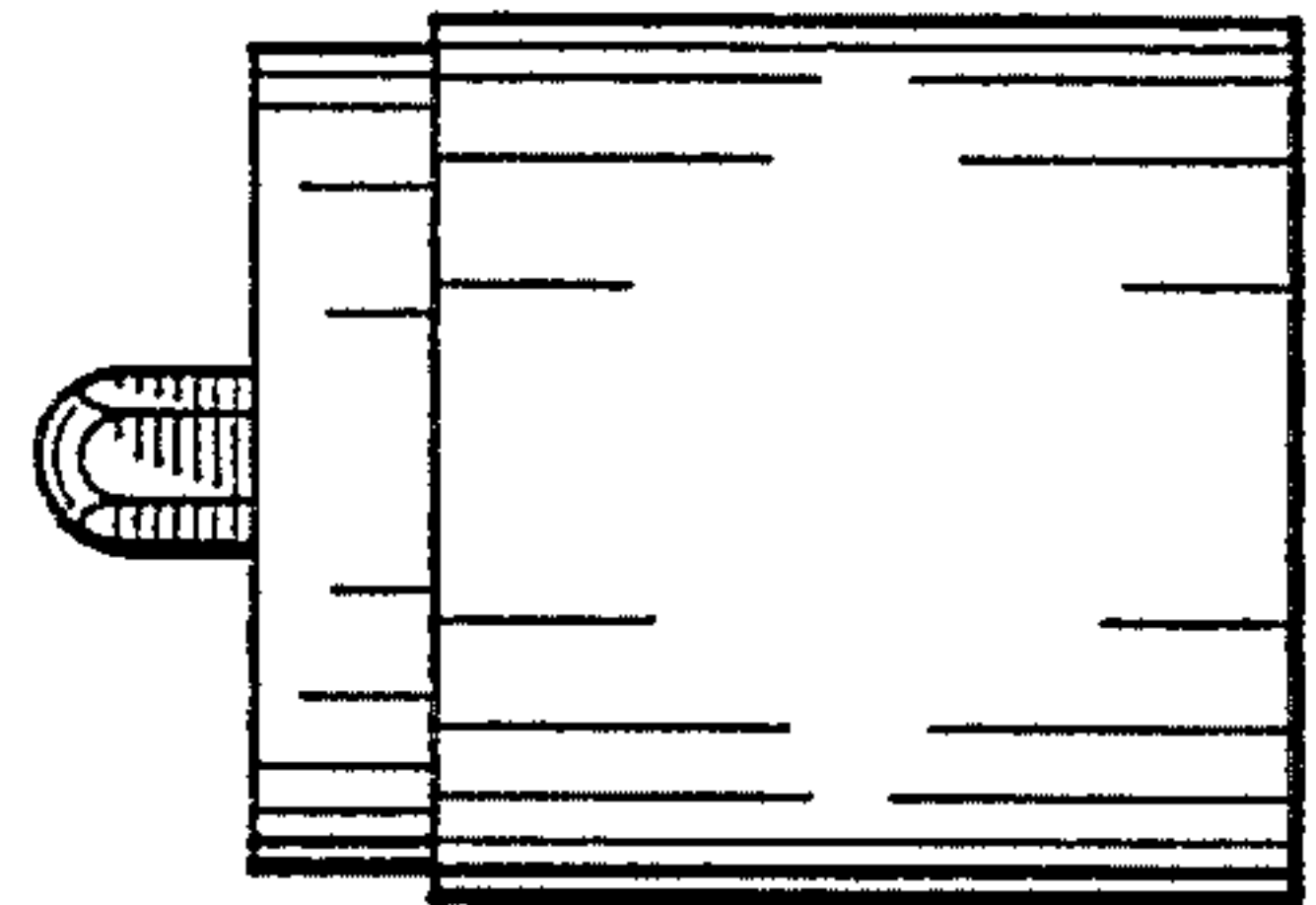

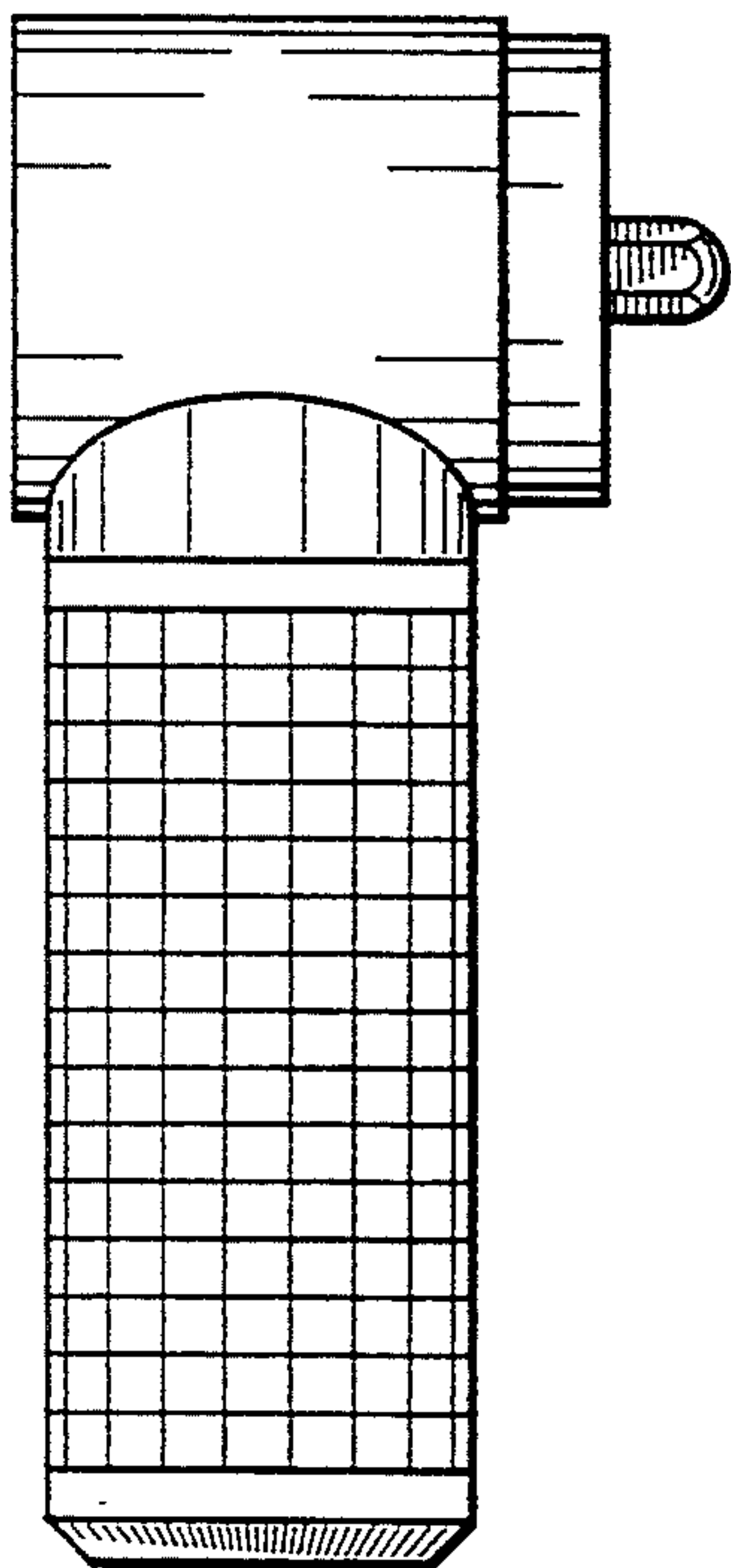

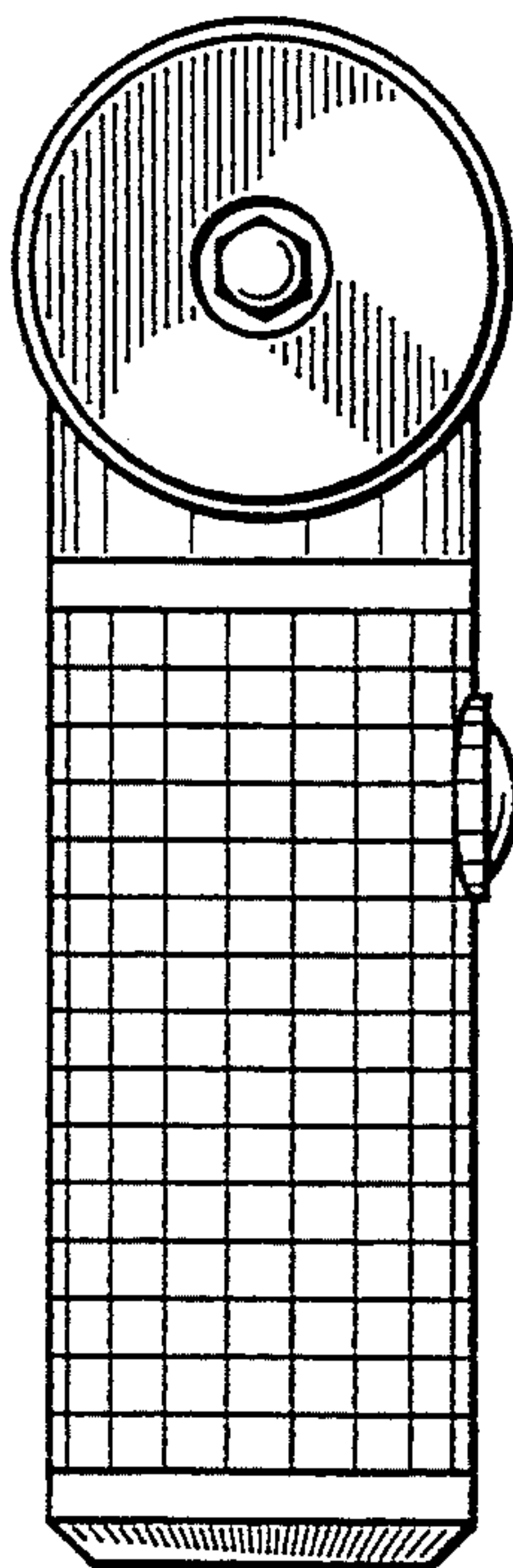

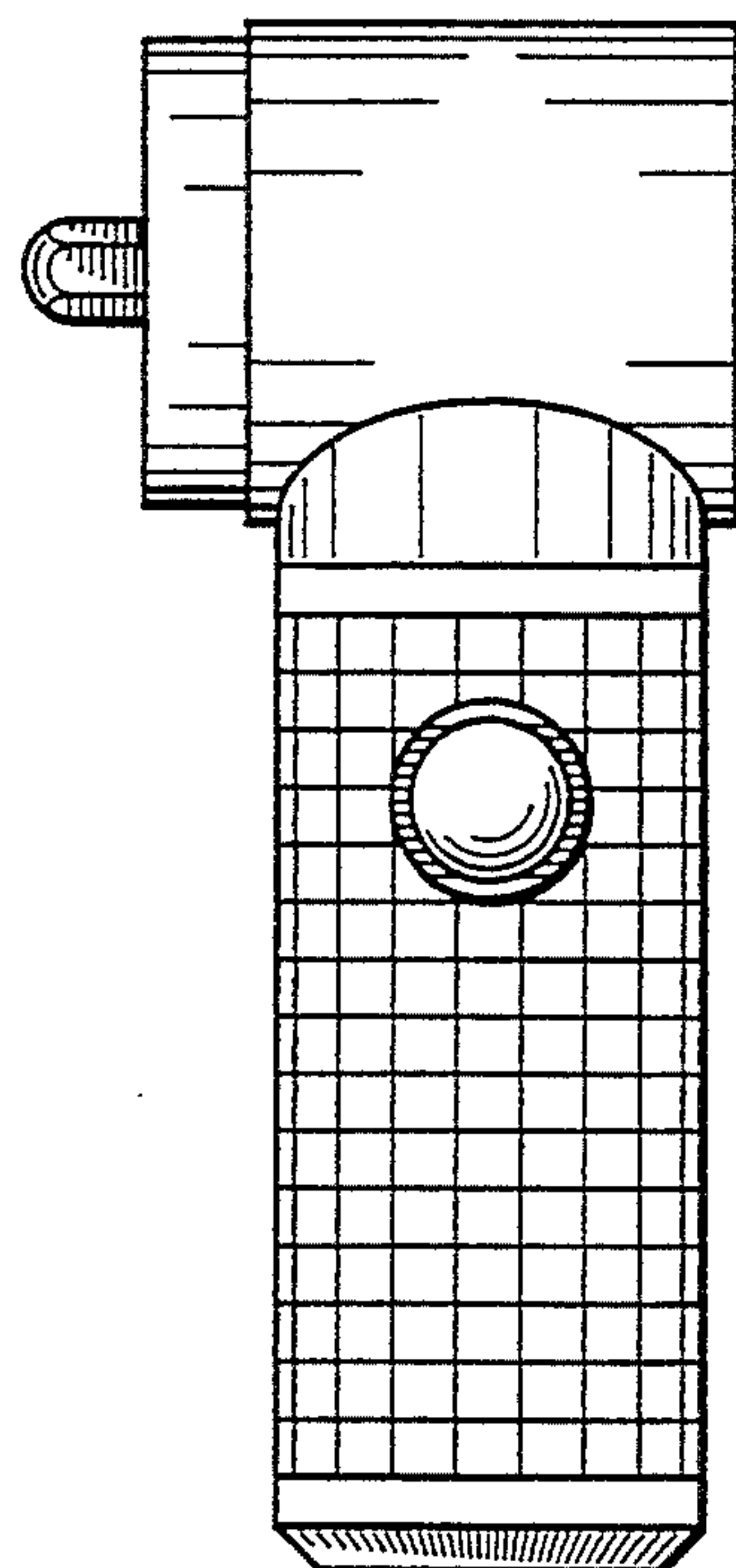

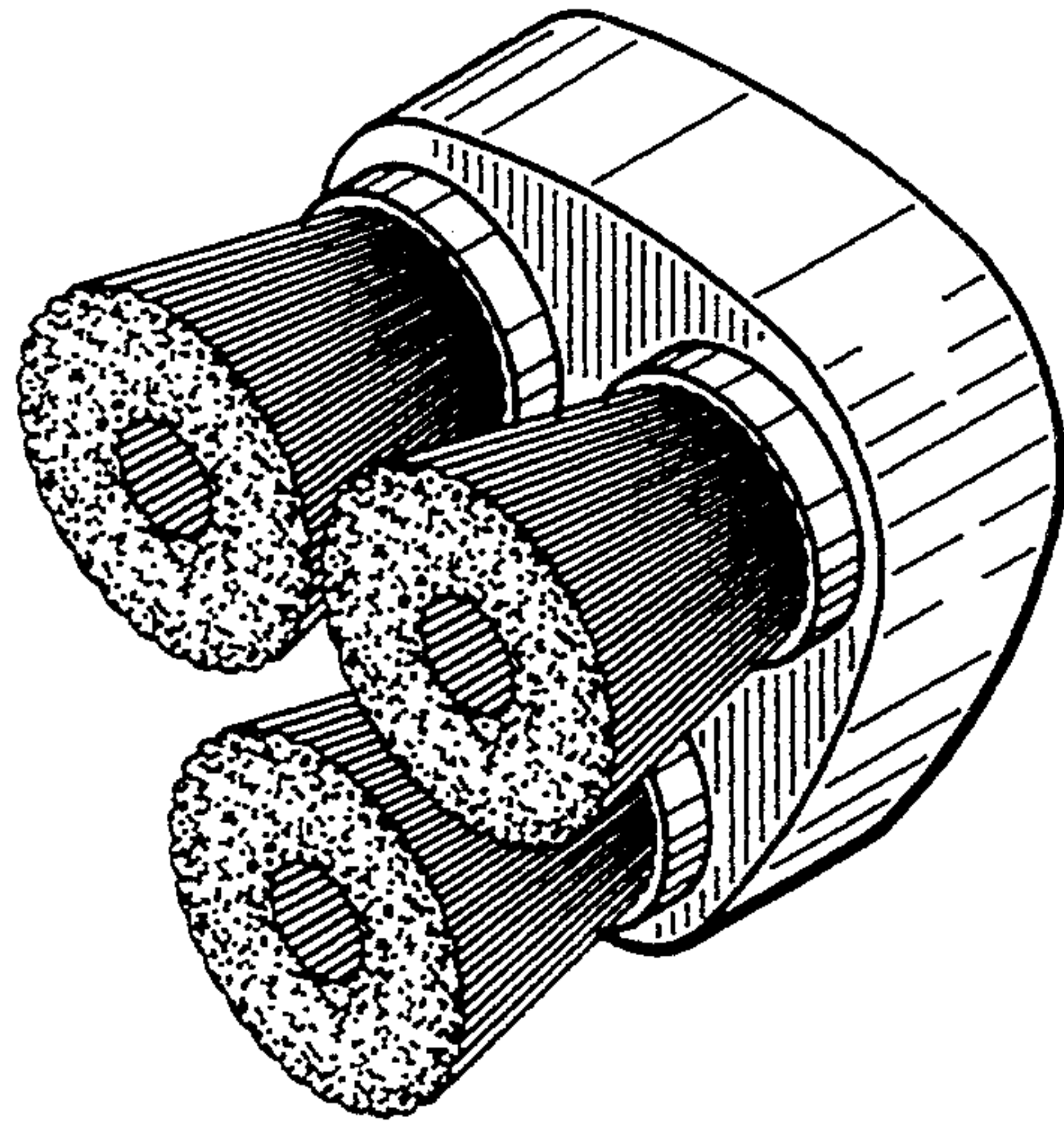

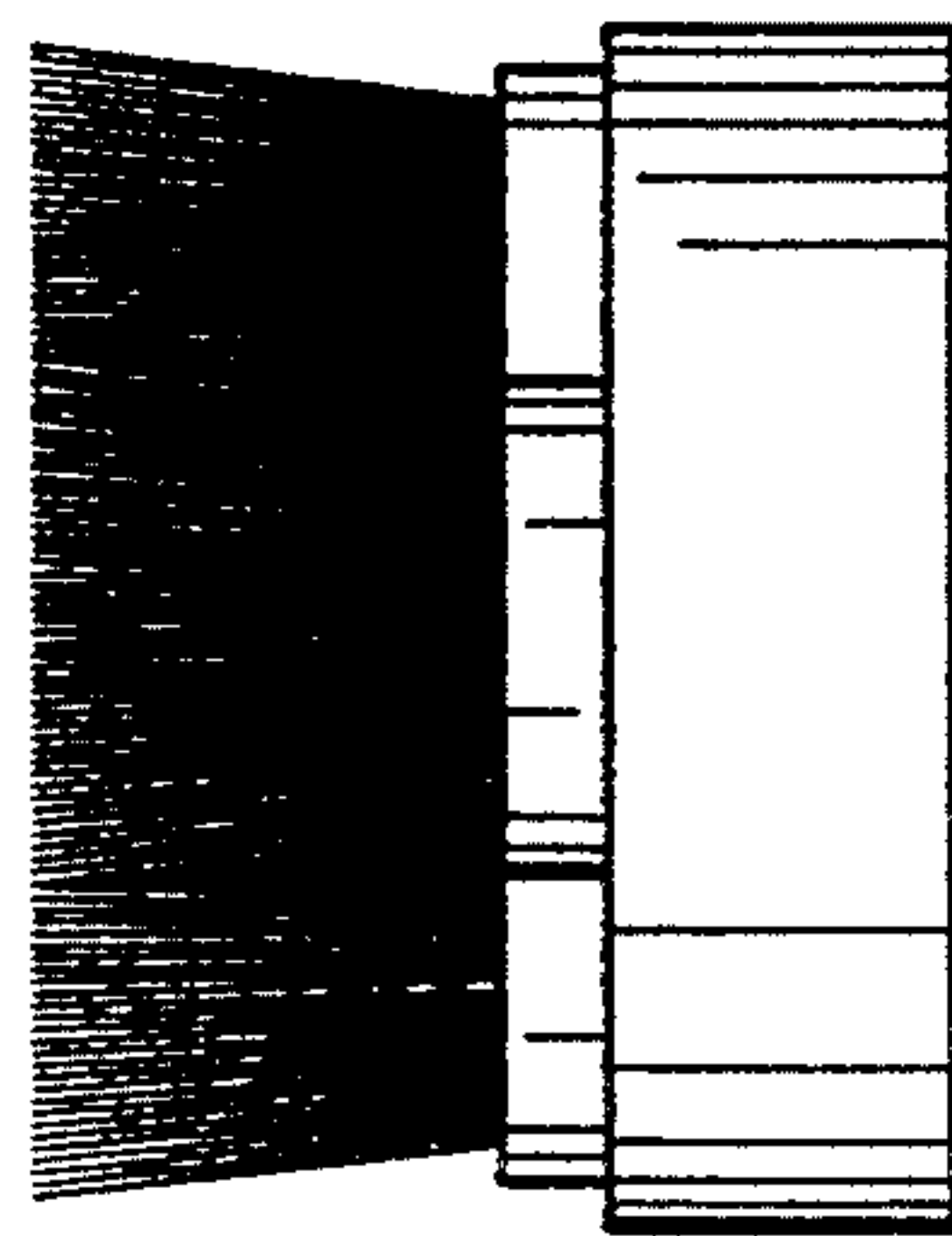

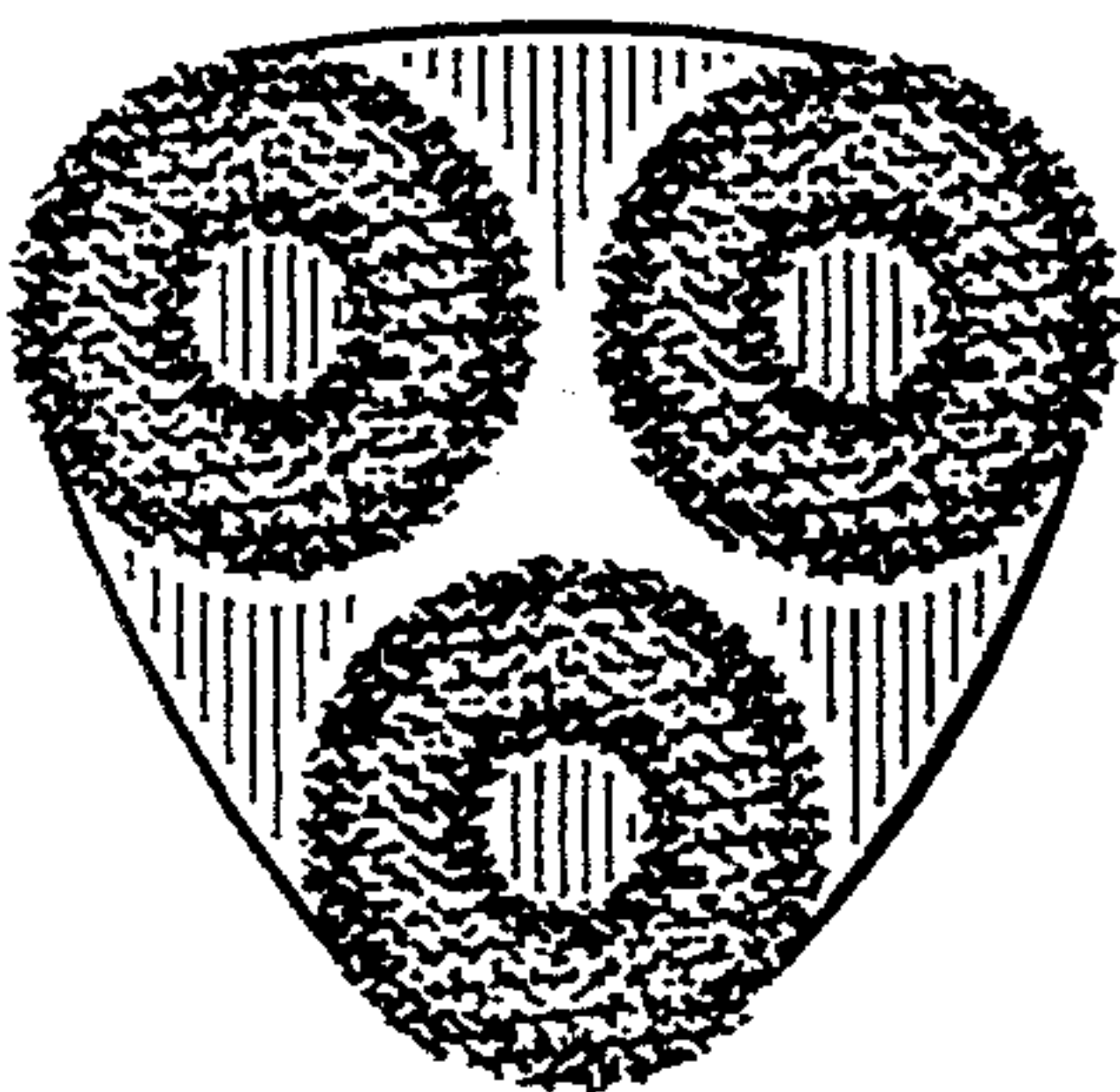

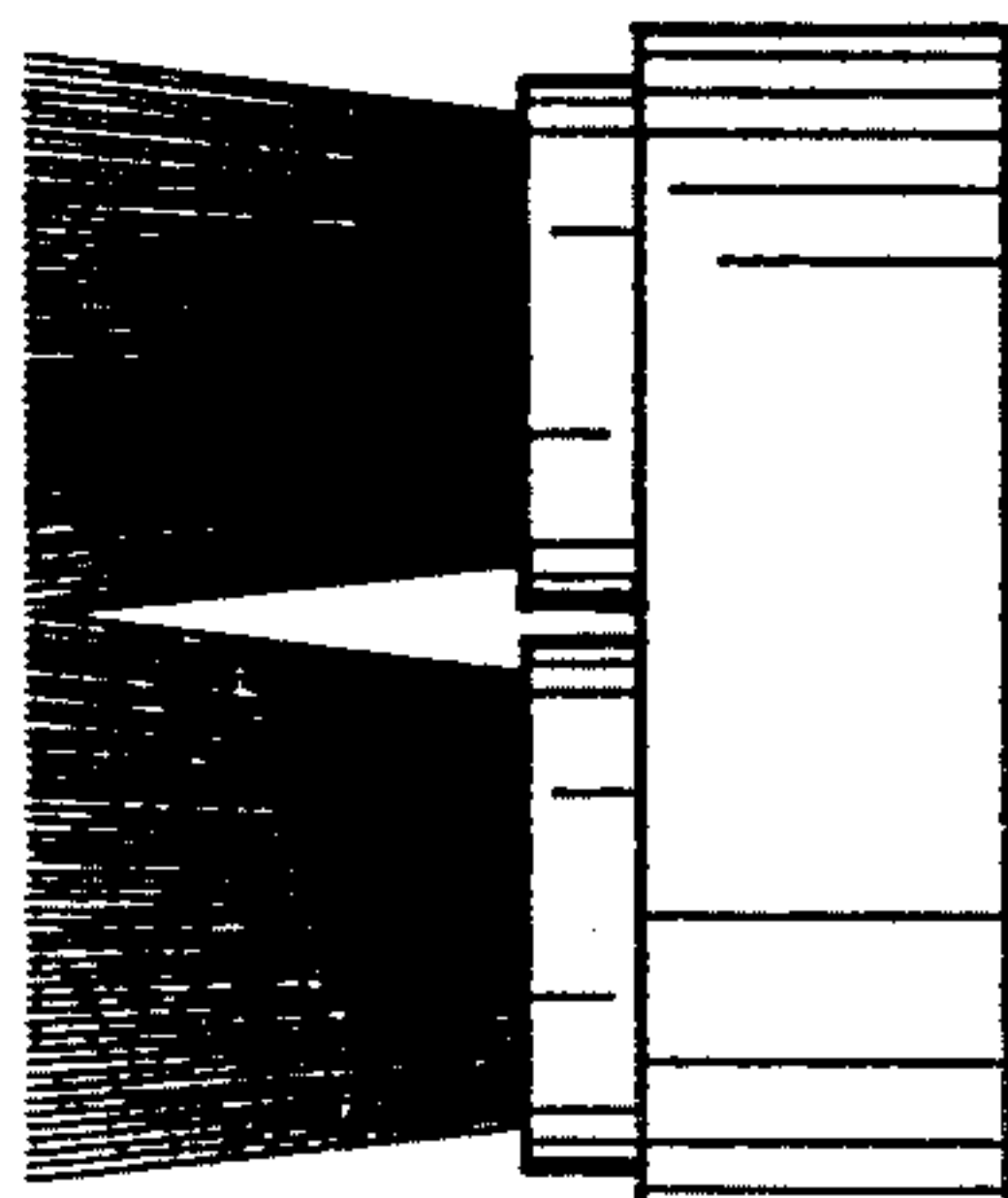

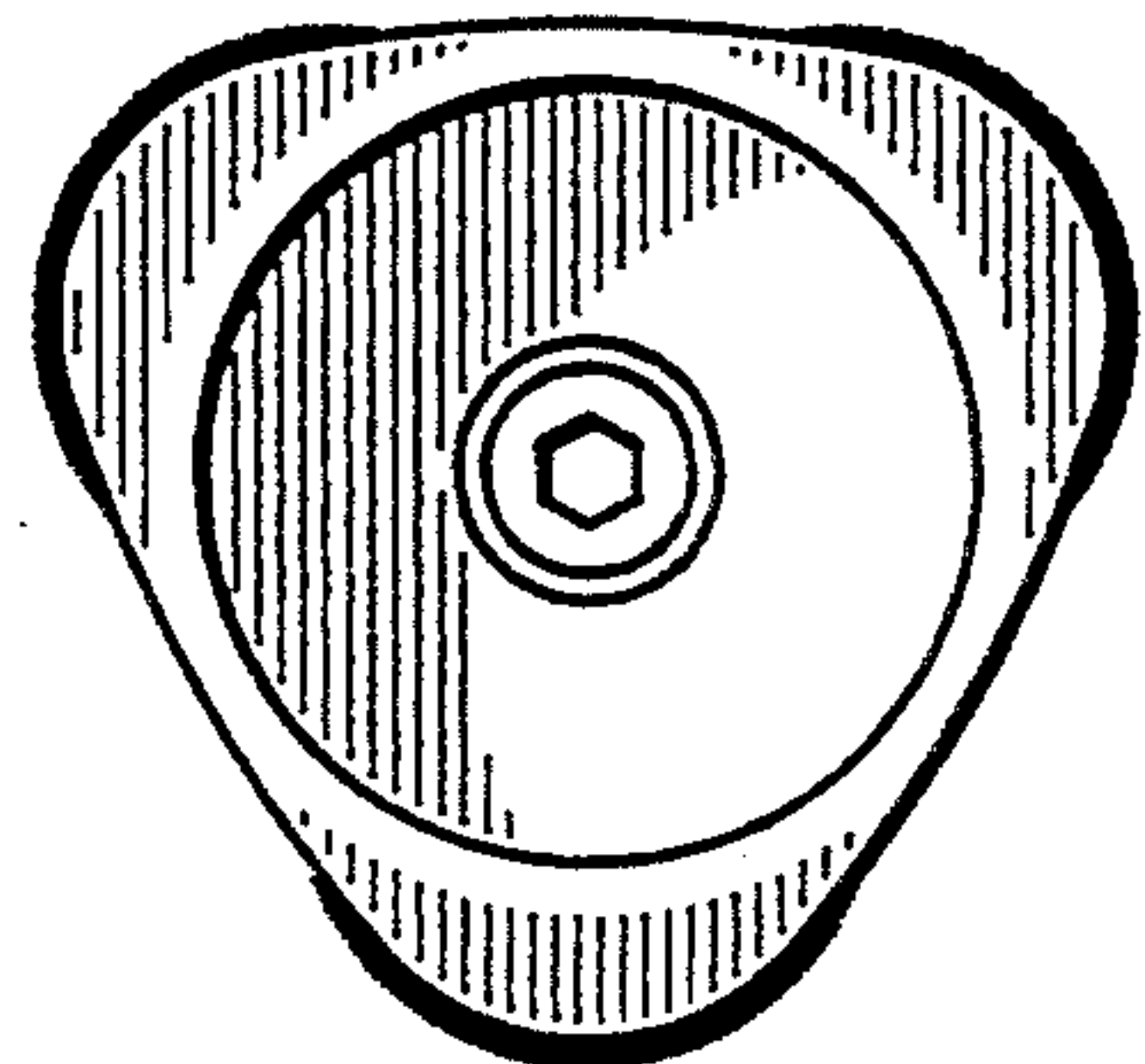

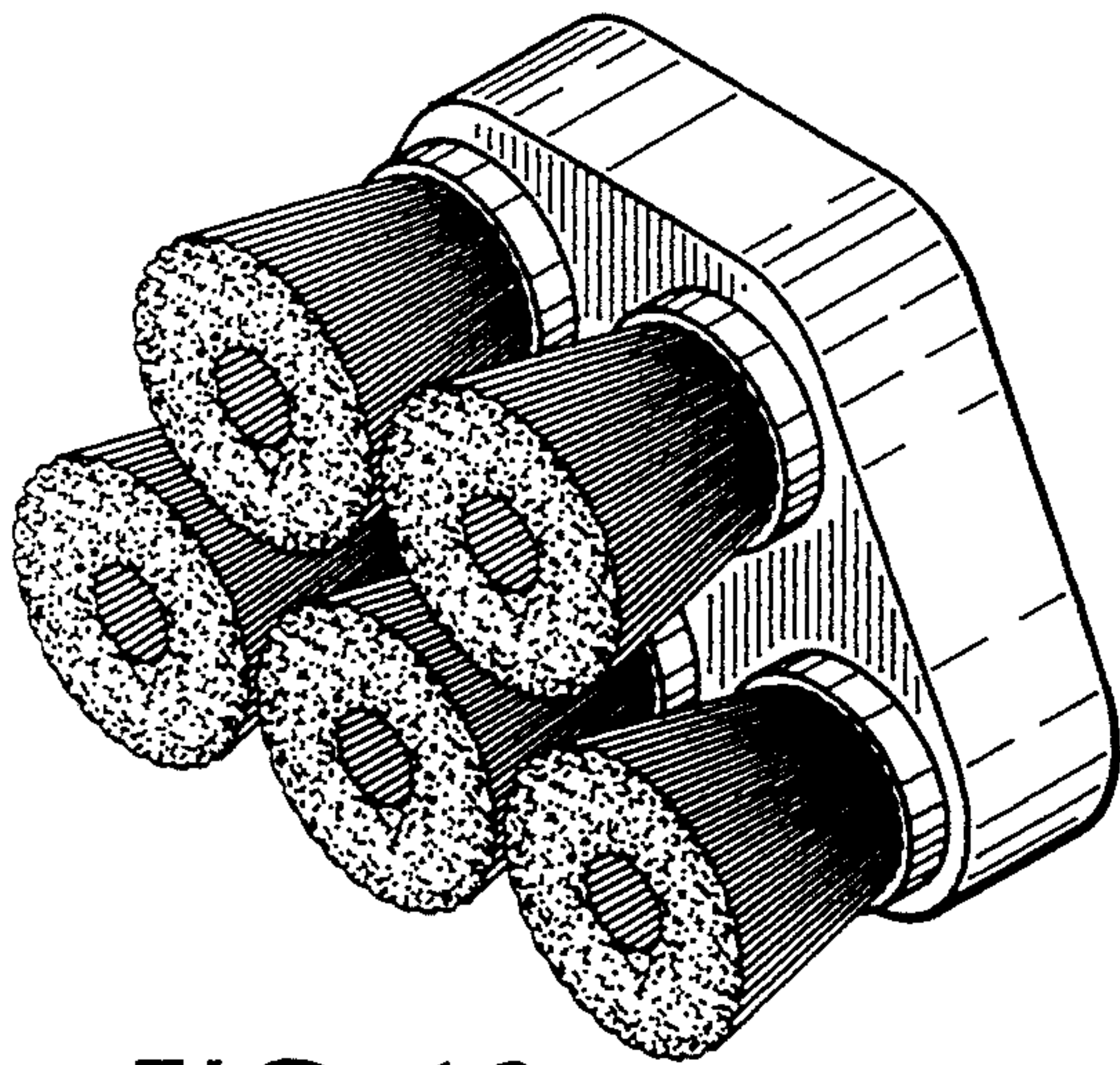

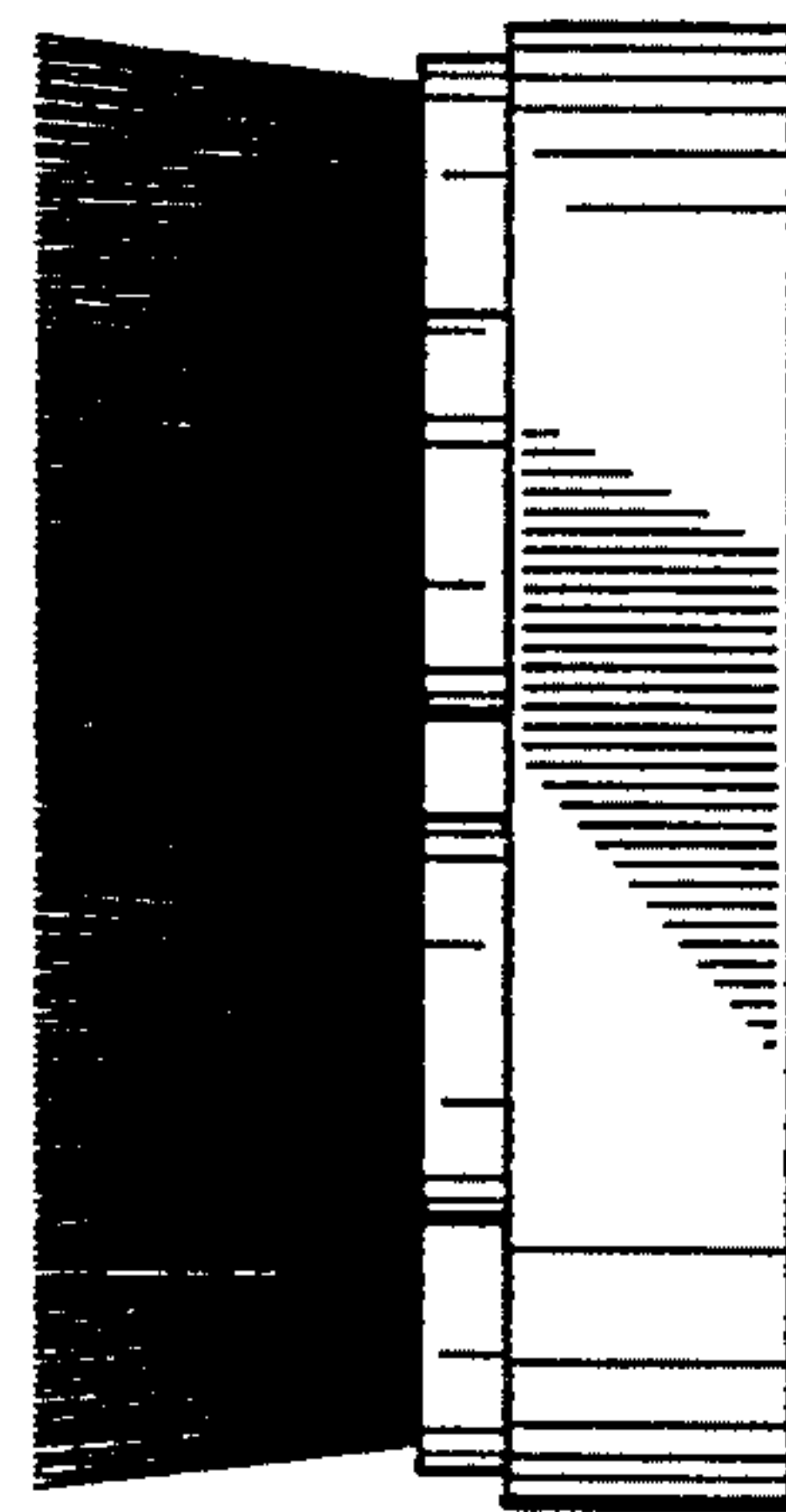

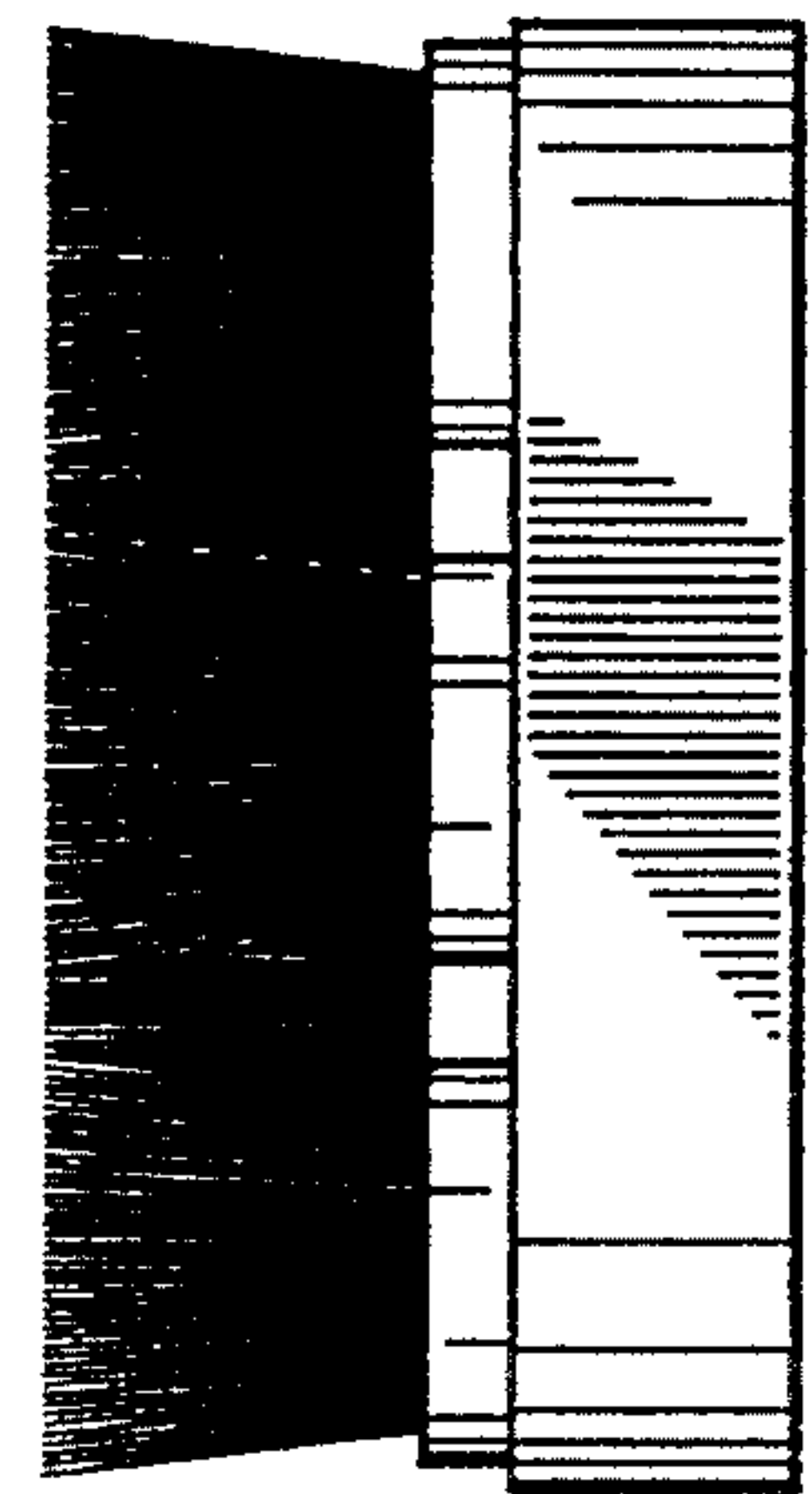

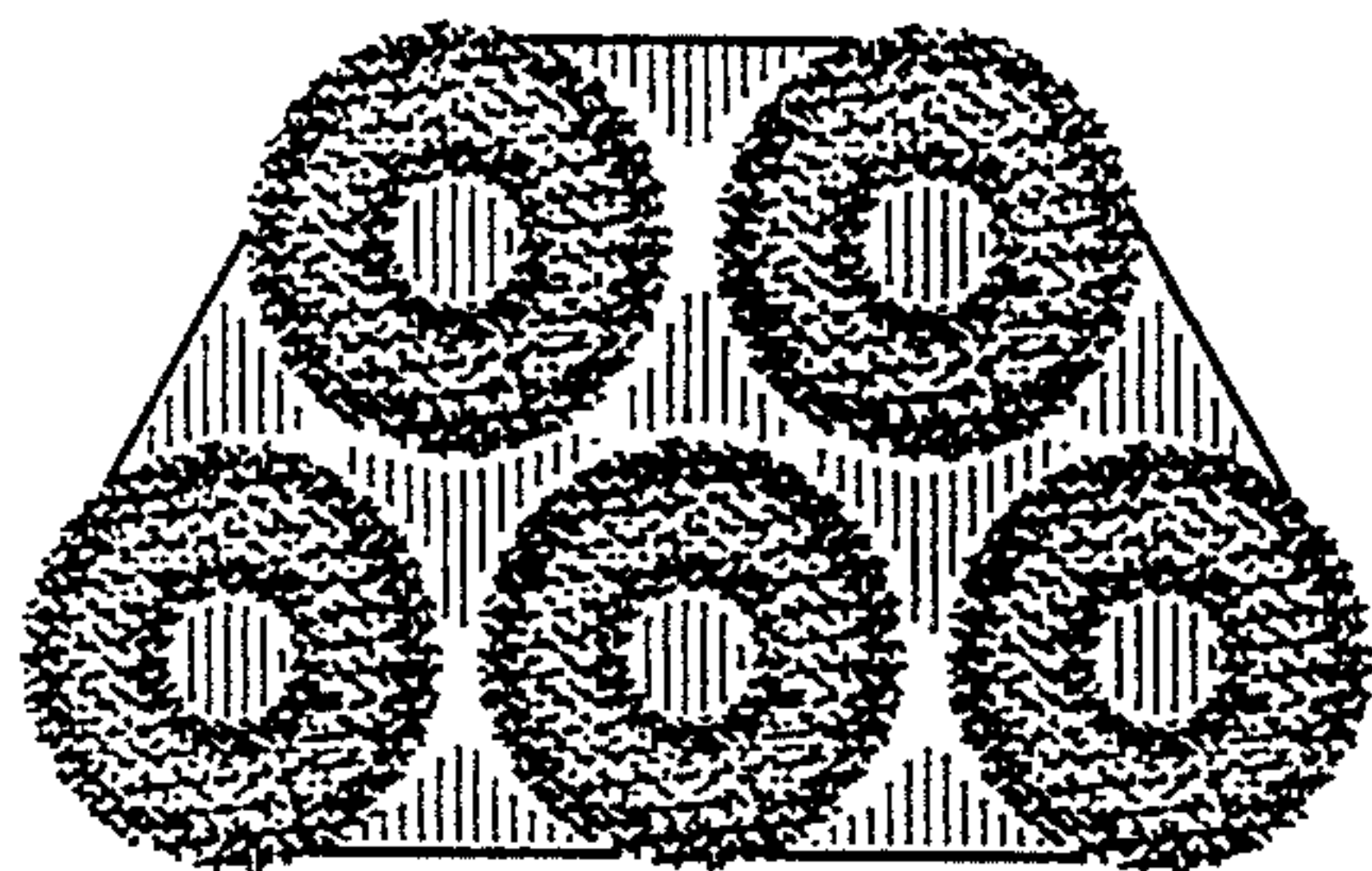

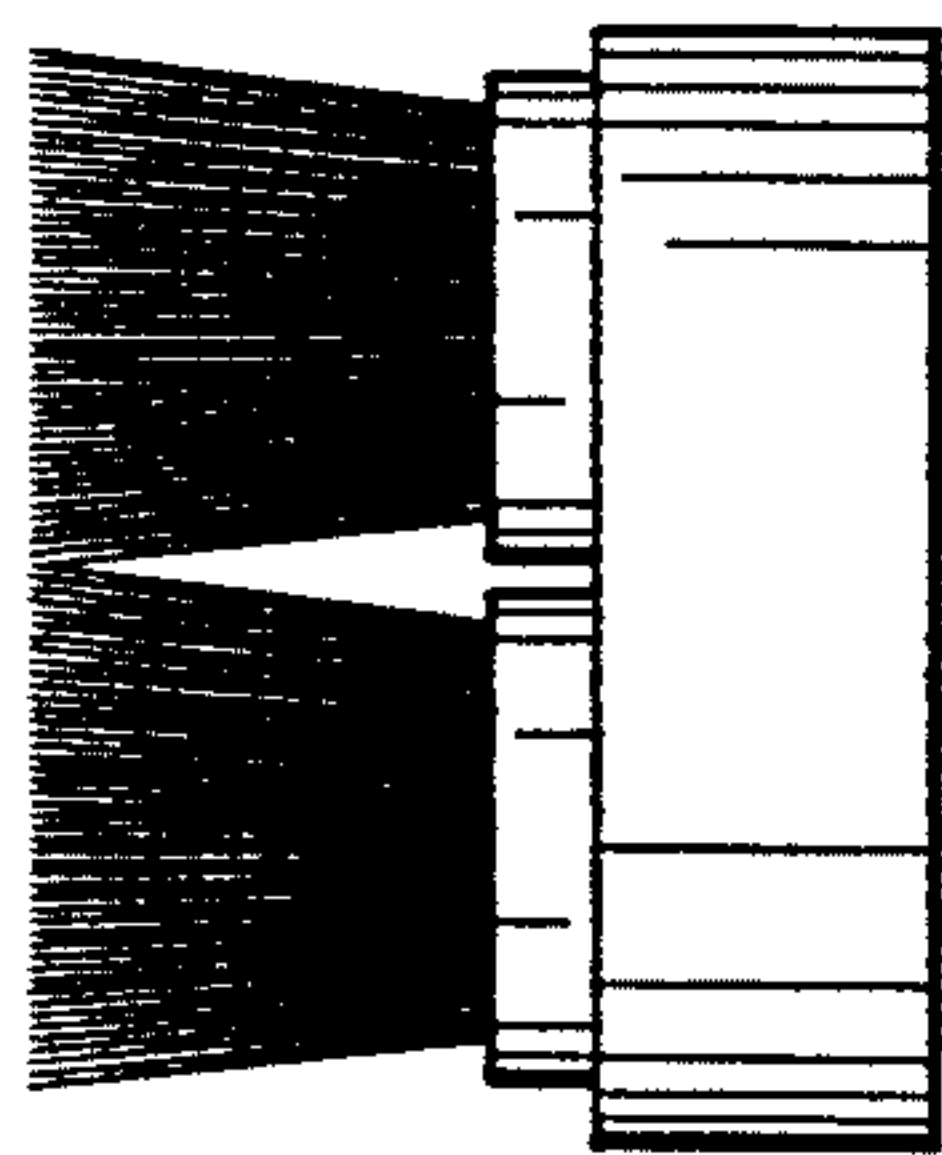

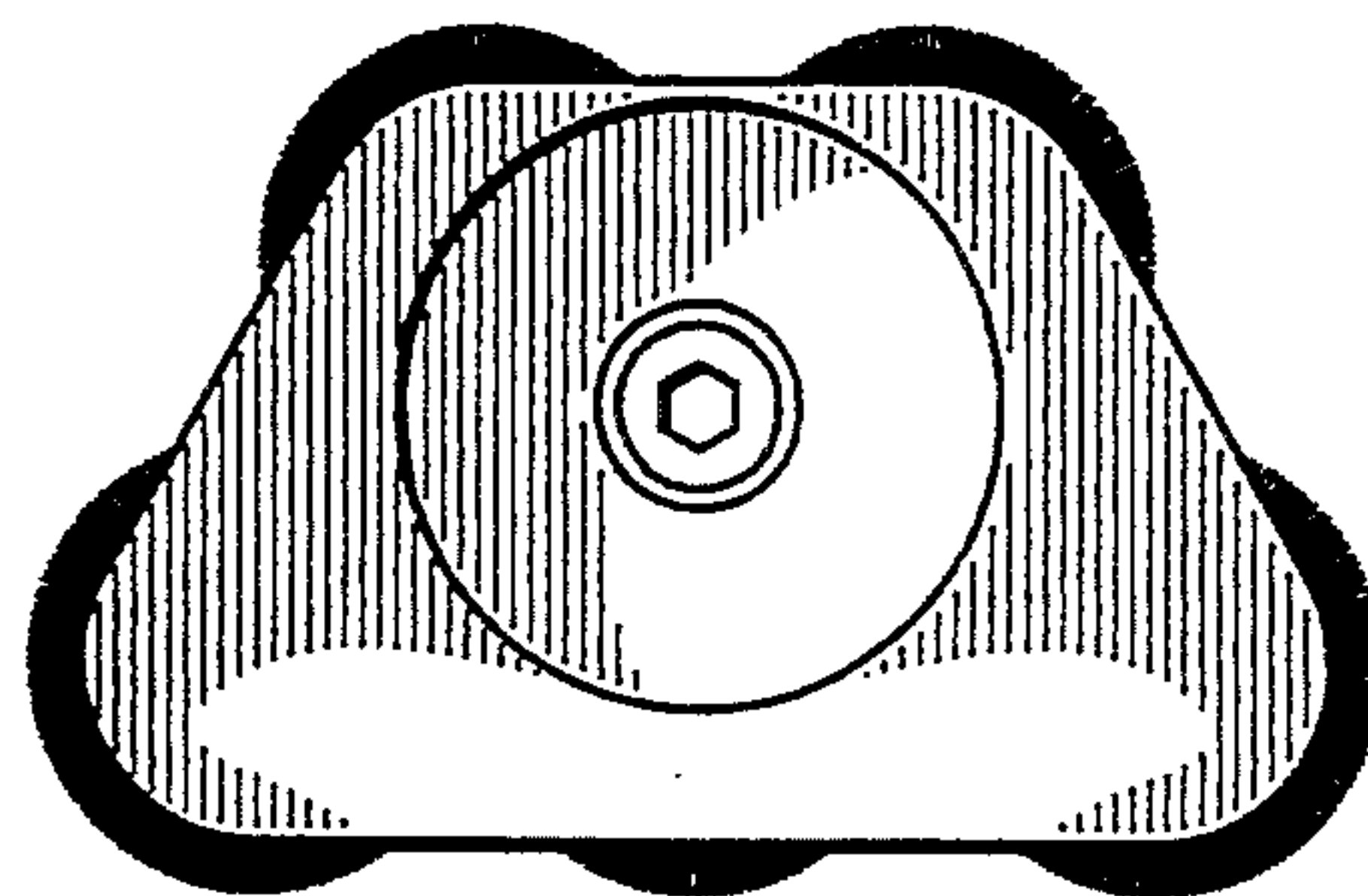

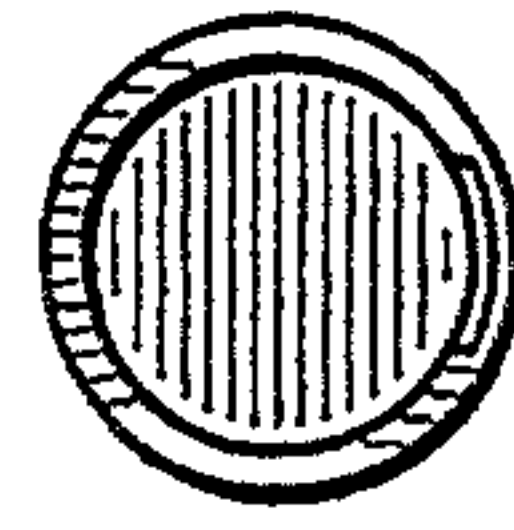

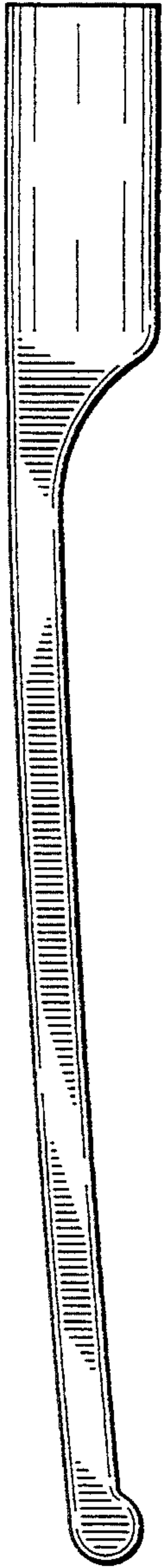

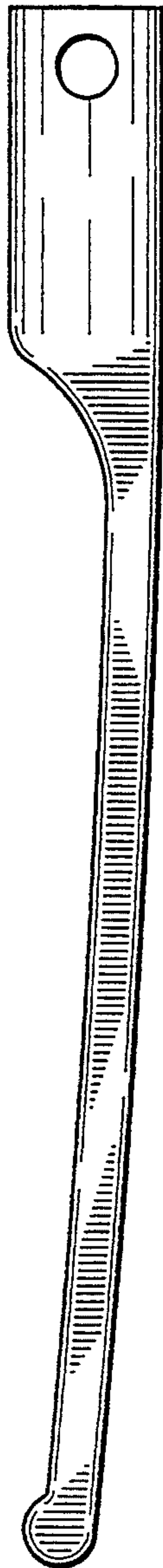

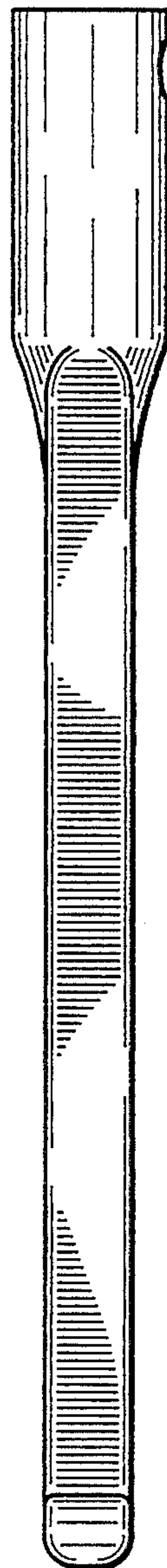

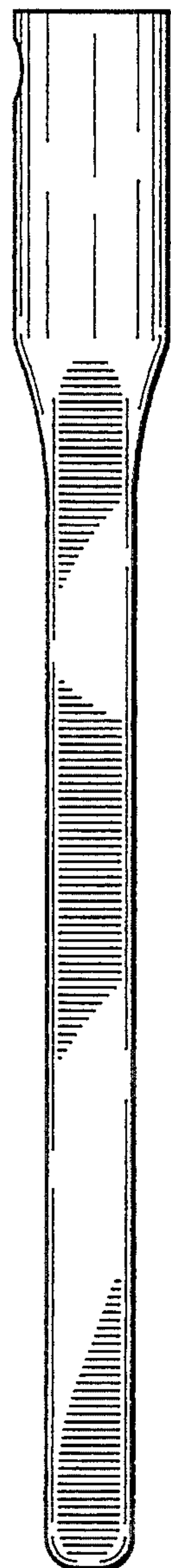
