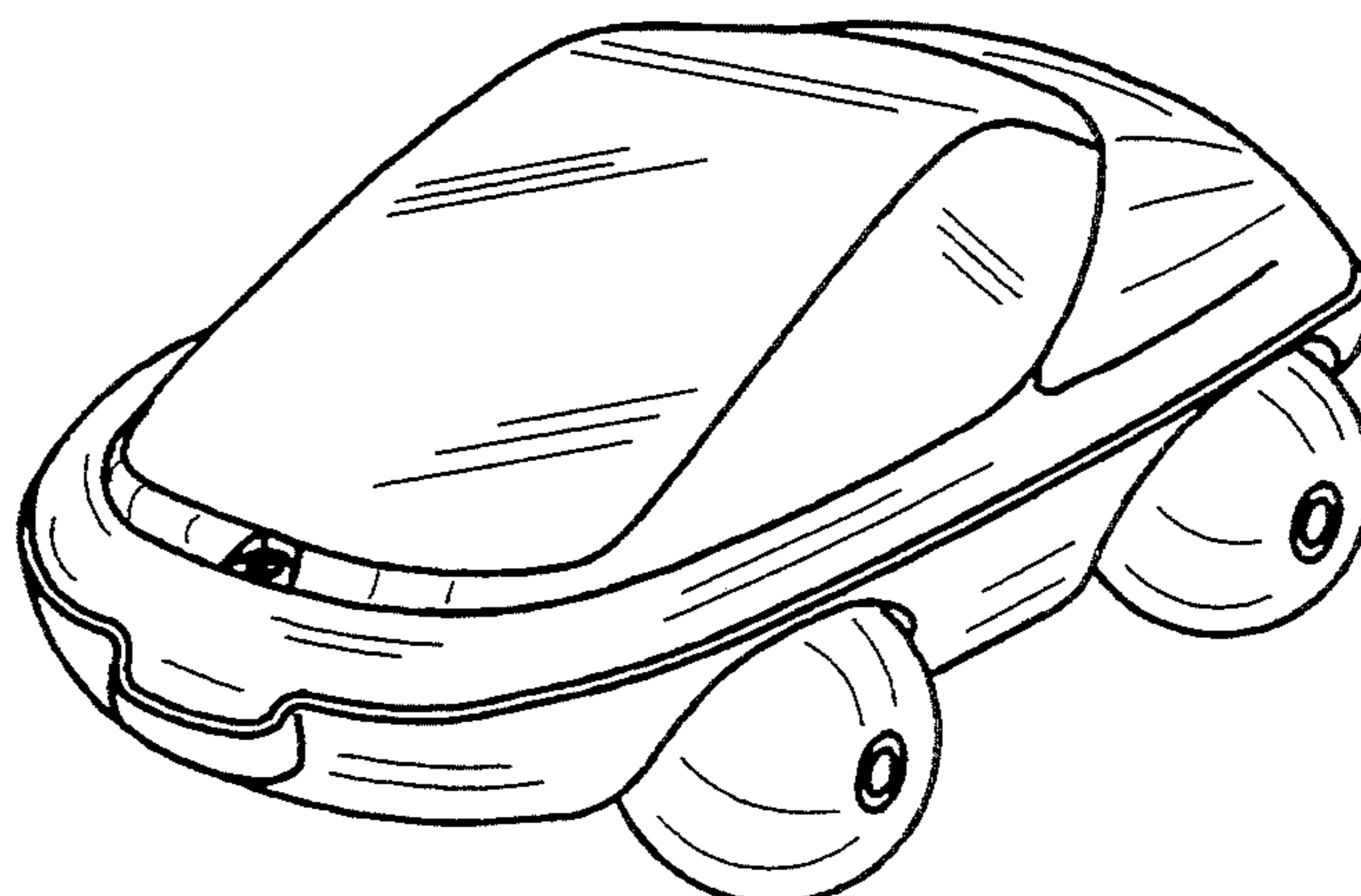
[57] **CLAIM**

The ornamental design for toy car, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a toy car;

FIG. 2 is a top plan view of the toy car;  
 FIG. 3 is a bottom plan view of the toy car;  
 FIG. 4 is a side elevational view of the toy car, the right and left sides being mirror images of each other;  
 FIG. 5 is a front elevational view of the toy car;  
 FIG. 6 is a back elevational view of the toy car;  
 FIG. 7 is a perspective view of a second embodiment of the toy car;  
 FIG. 8 is a top plan view of the toy car of FIG. 7;  
 FIG. 9 is a bottom plan view of the toy car of FIG. 7;  
 FIG. 10 is a side elevational view of the toy car of FIG. 7, the right and left sides being mirror images of each other;  
 FIG. 11 is a front elevational view of the toy car of FIG. 7;  
 FIG. 12 is a back elevational view of the toy car of FIG. 7;

 FIG. 18 is a back elevational view of the toy car of FIG. 13;  
 FIG. 19 is a perspective view of a fourth embodiment of the toy car;  
 FIG. 20 is a top plan view of the toy car of FIG. 19;  
 FIG. 21 is a bottom plan view of the toy car of FIG. 19;  
 FIG. 22 is a side elevational view of the toy car of FIG. 19, the right and left sides being mirror images of each other;  
 FIG. 23 is a front elevational view of the toy car of FIG. 19; and,  
 FIG. 24 is a back elevational view of the toy car of FIG. 19.



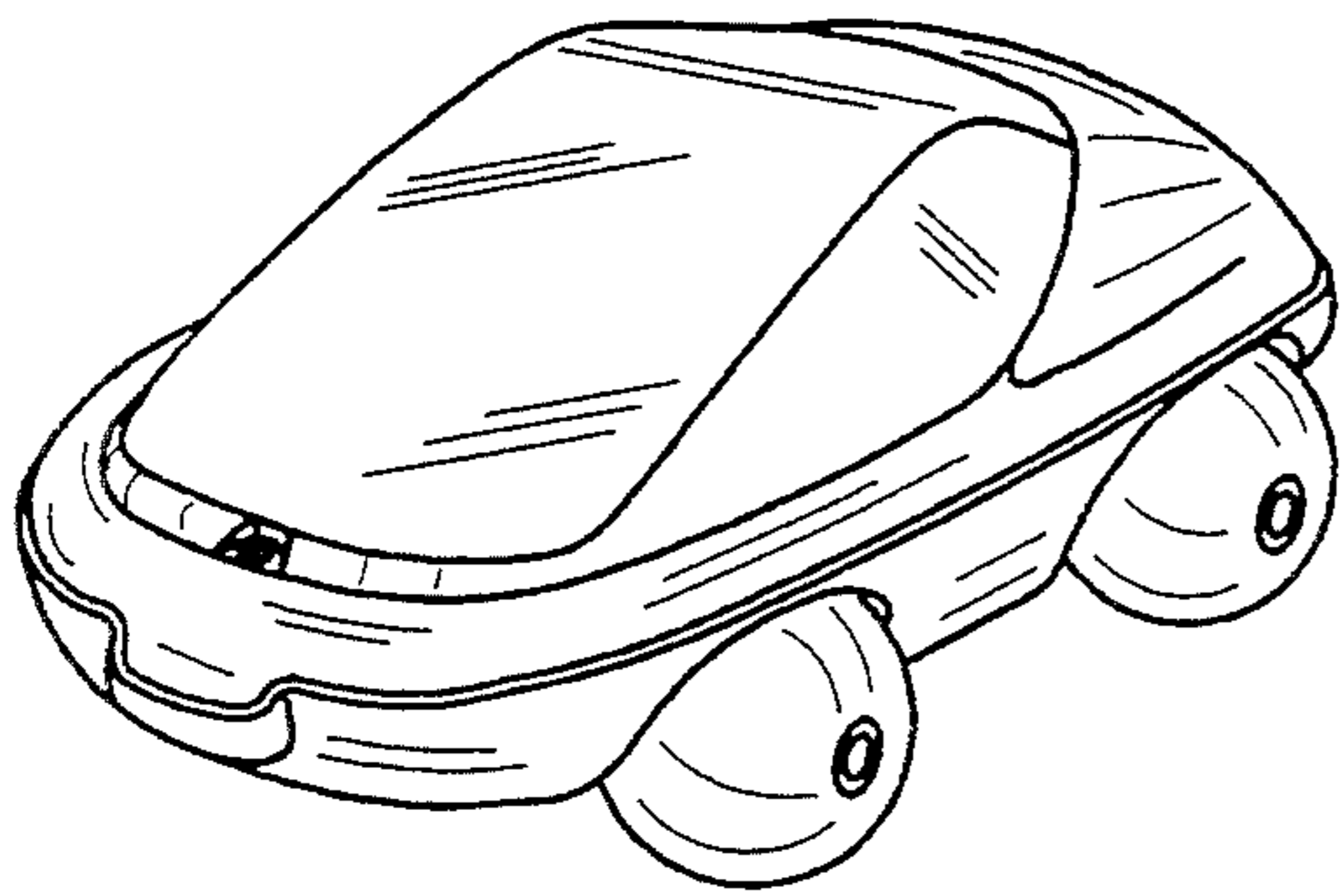

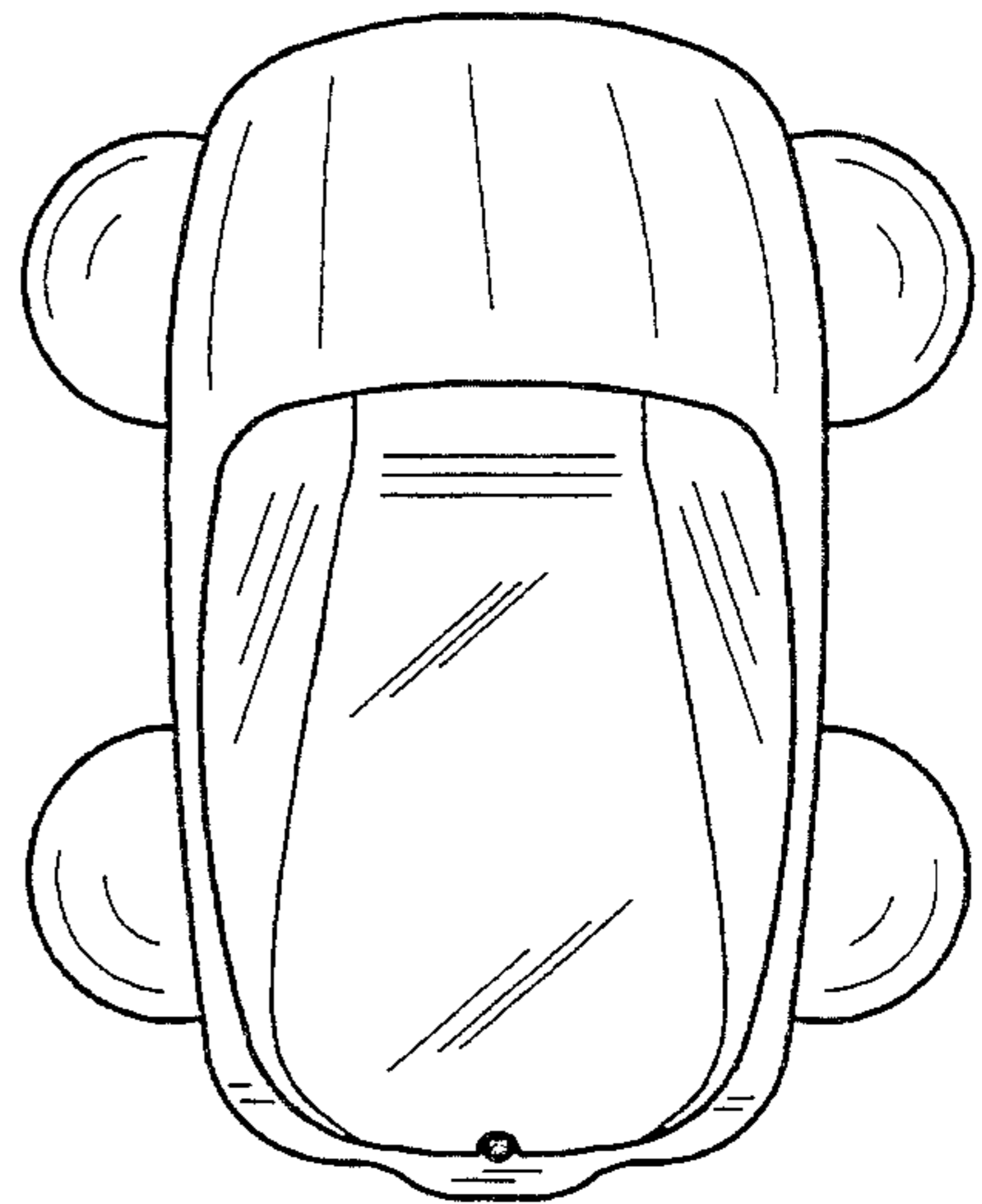

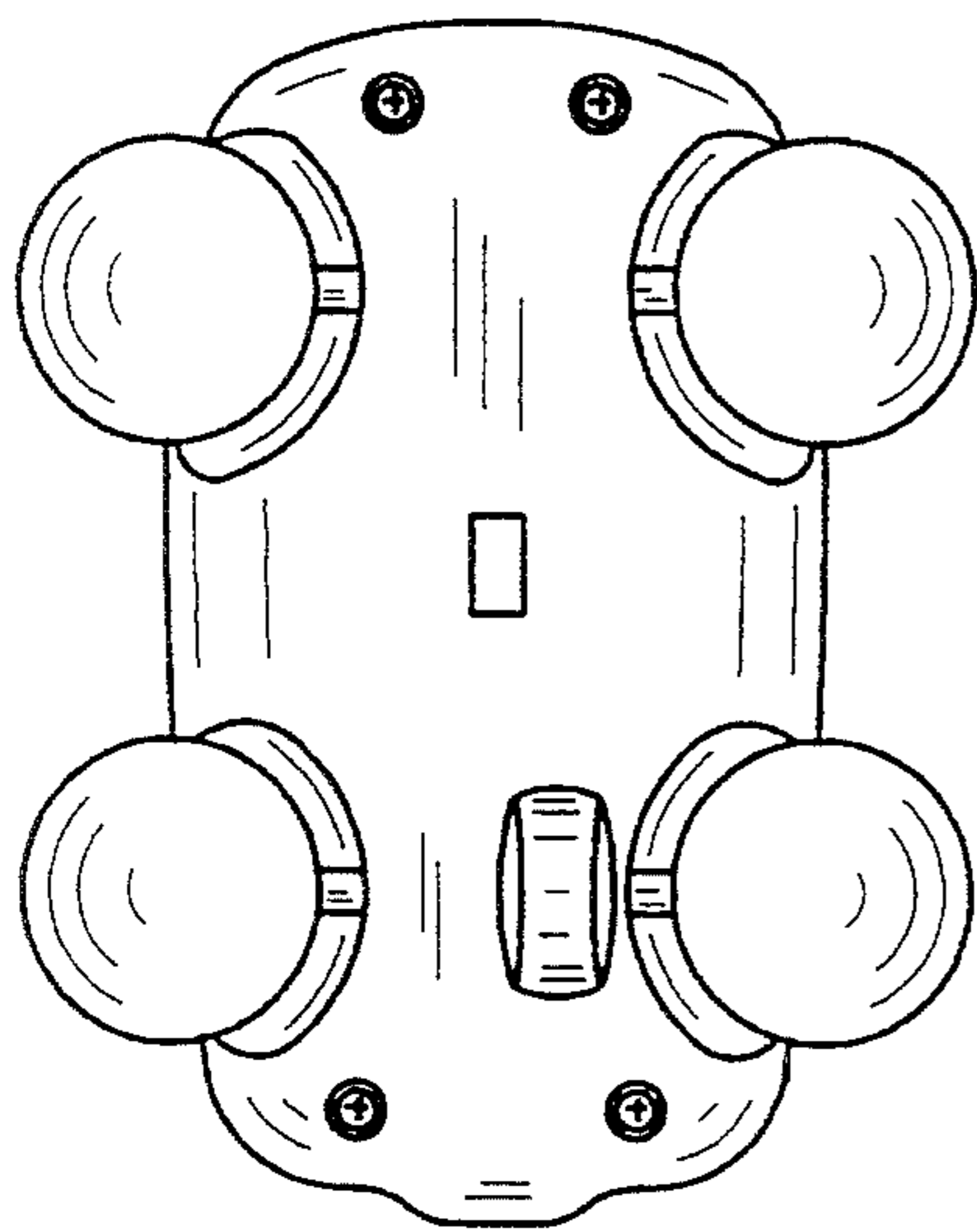

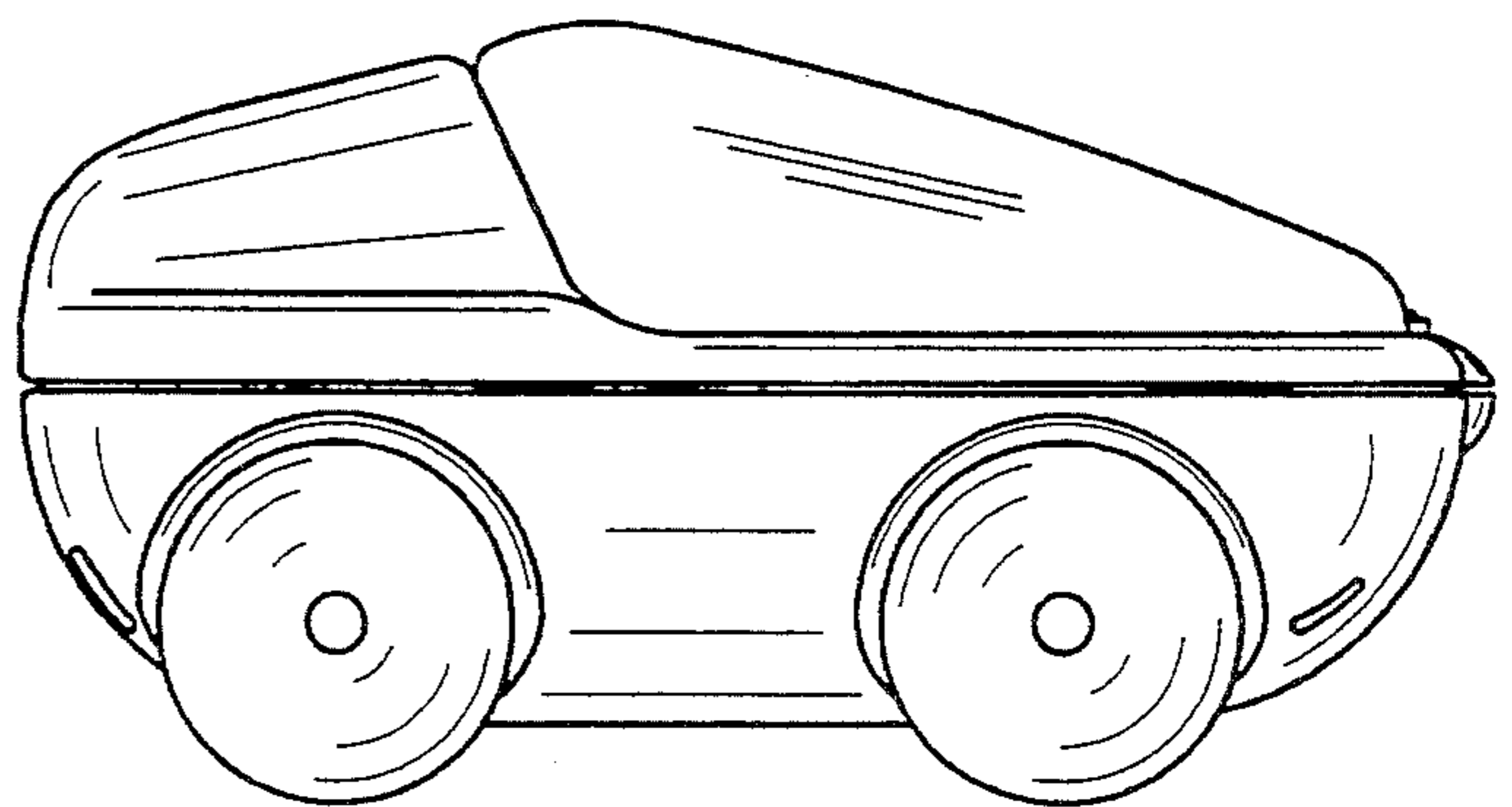

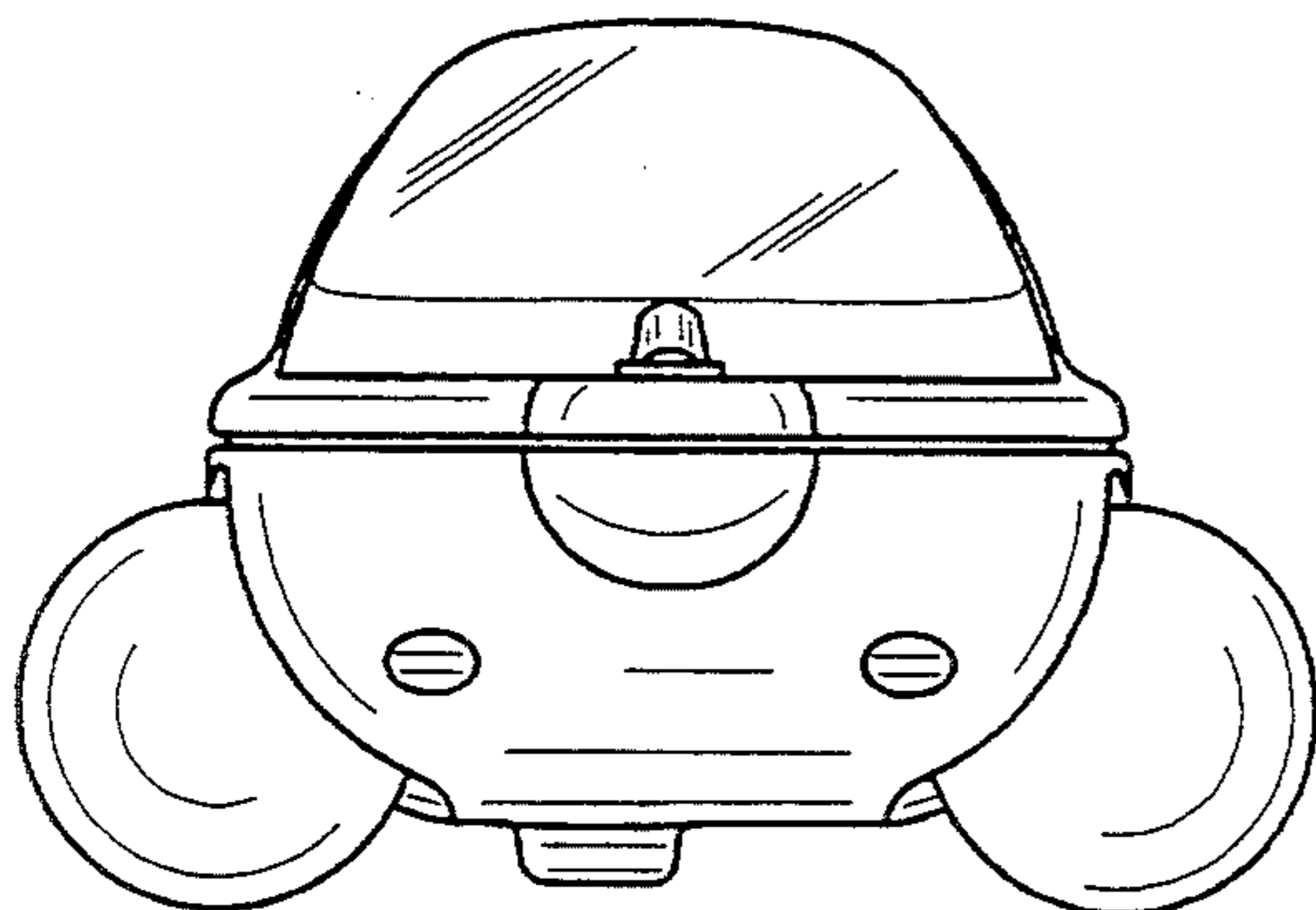

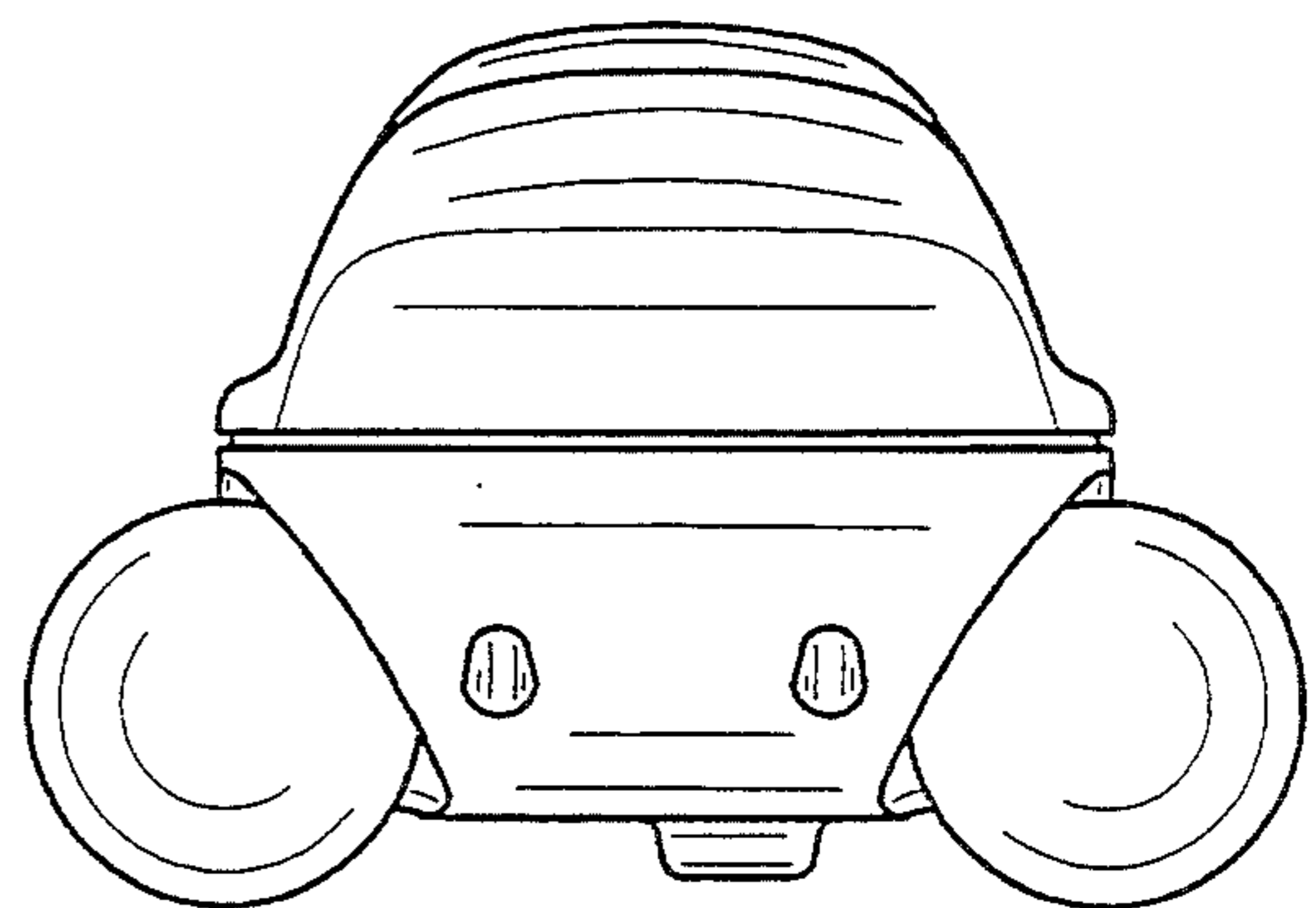

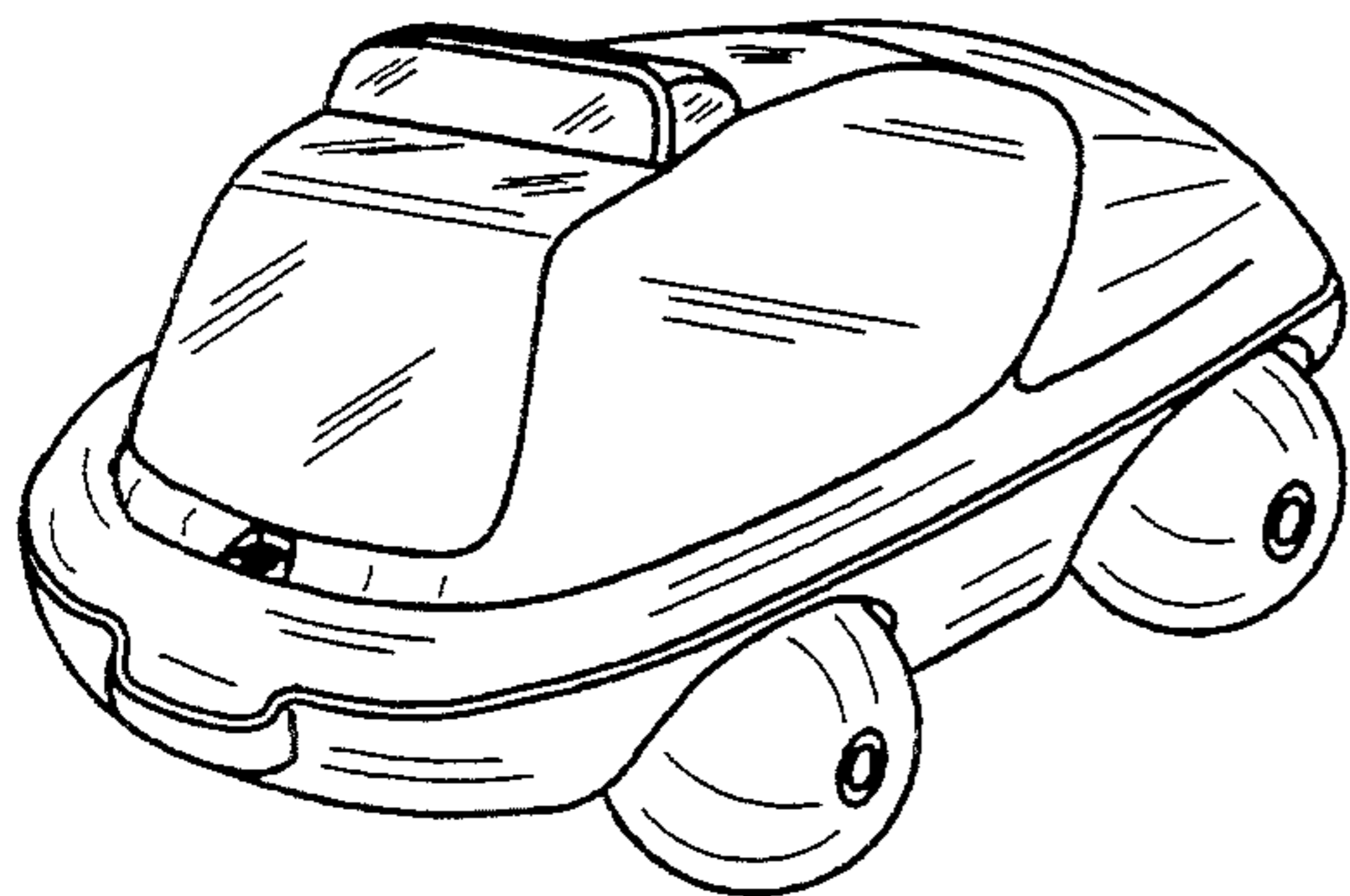

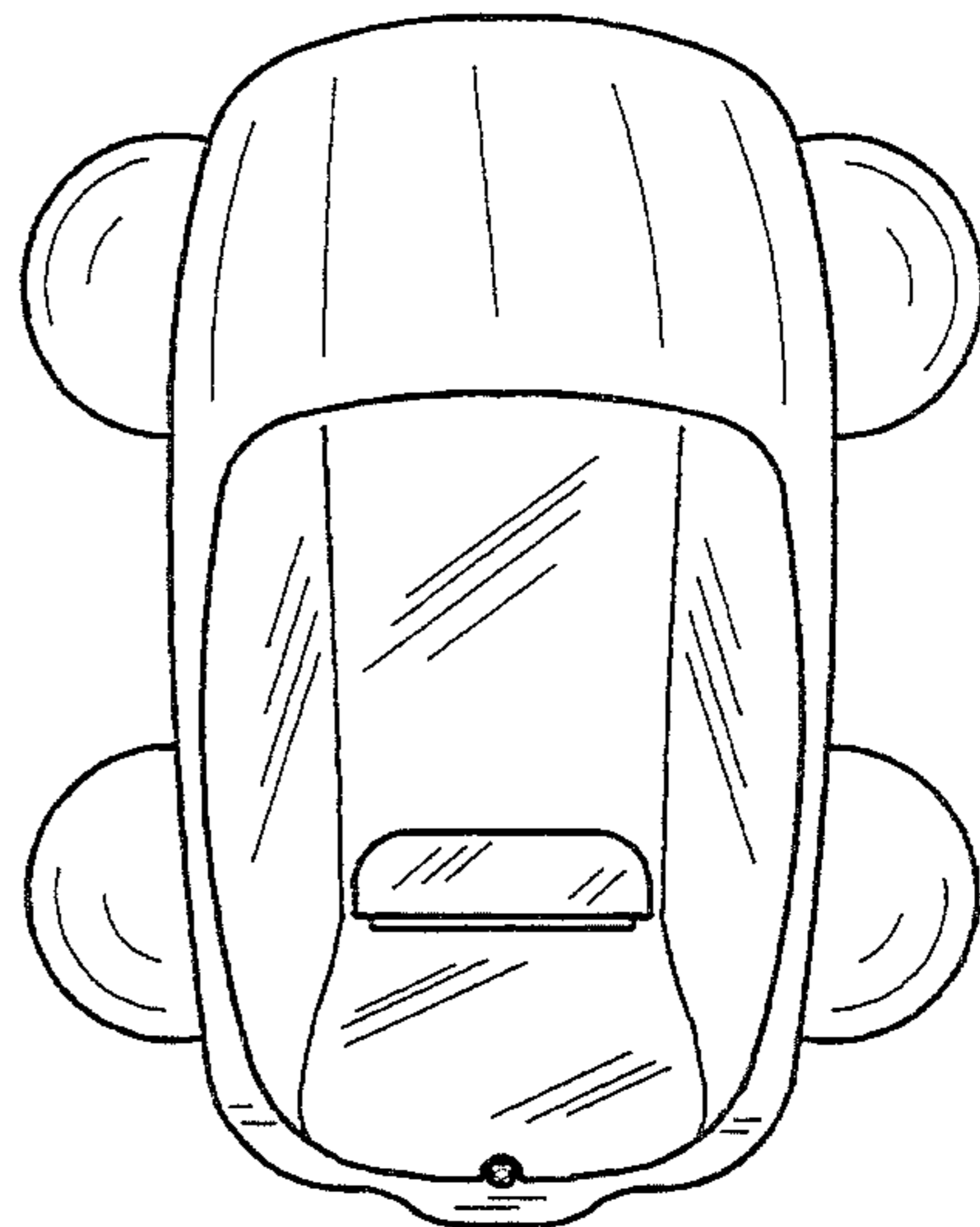

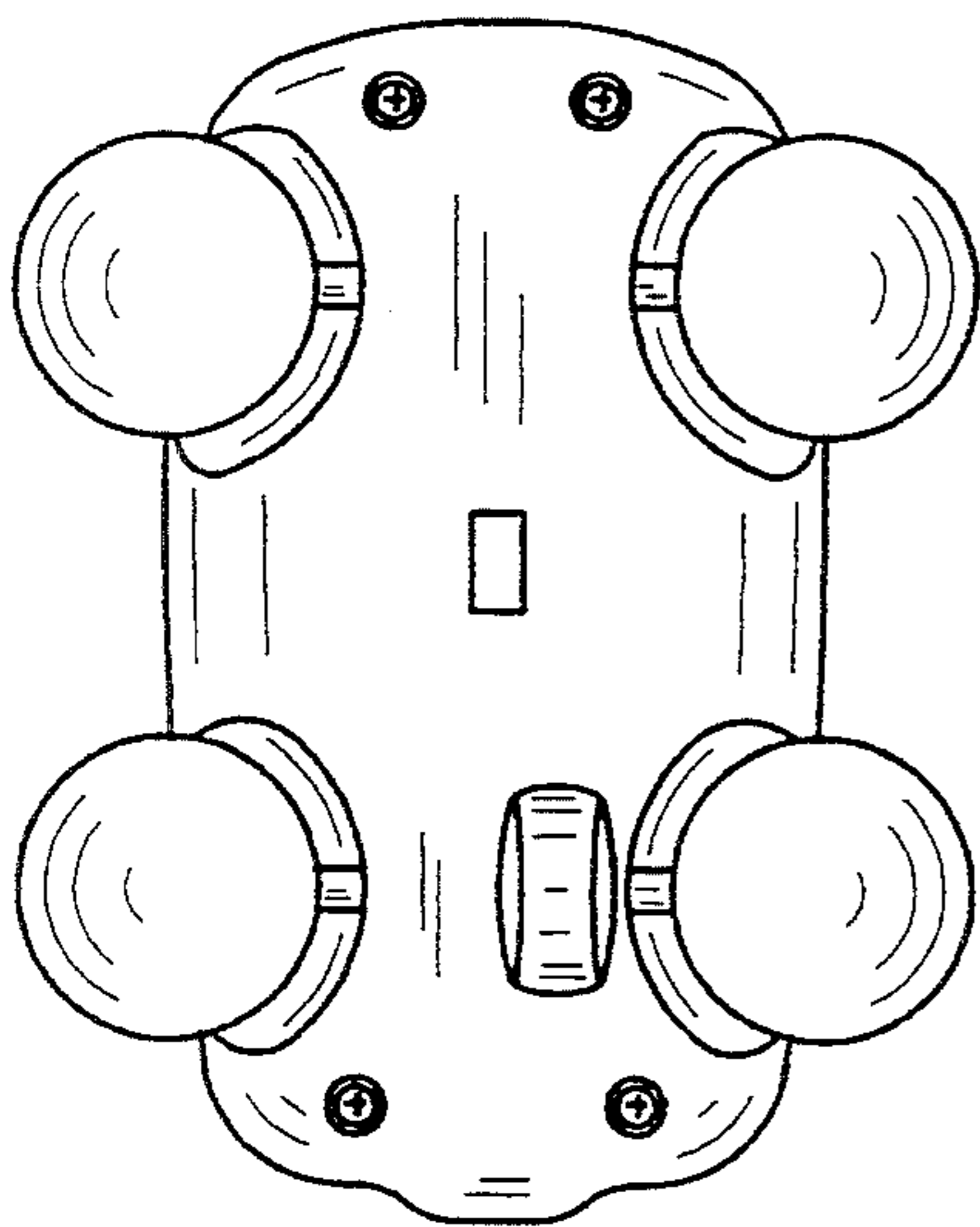

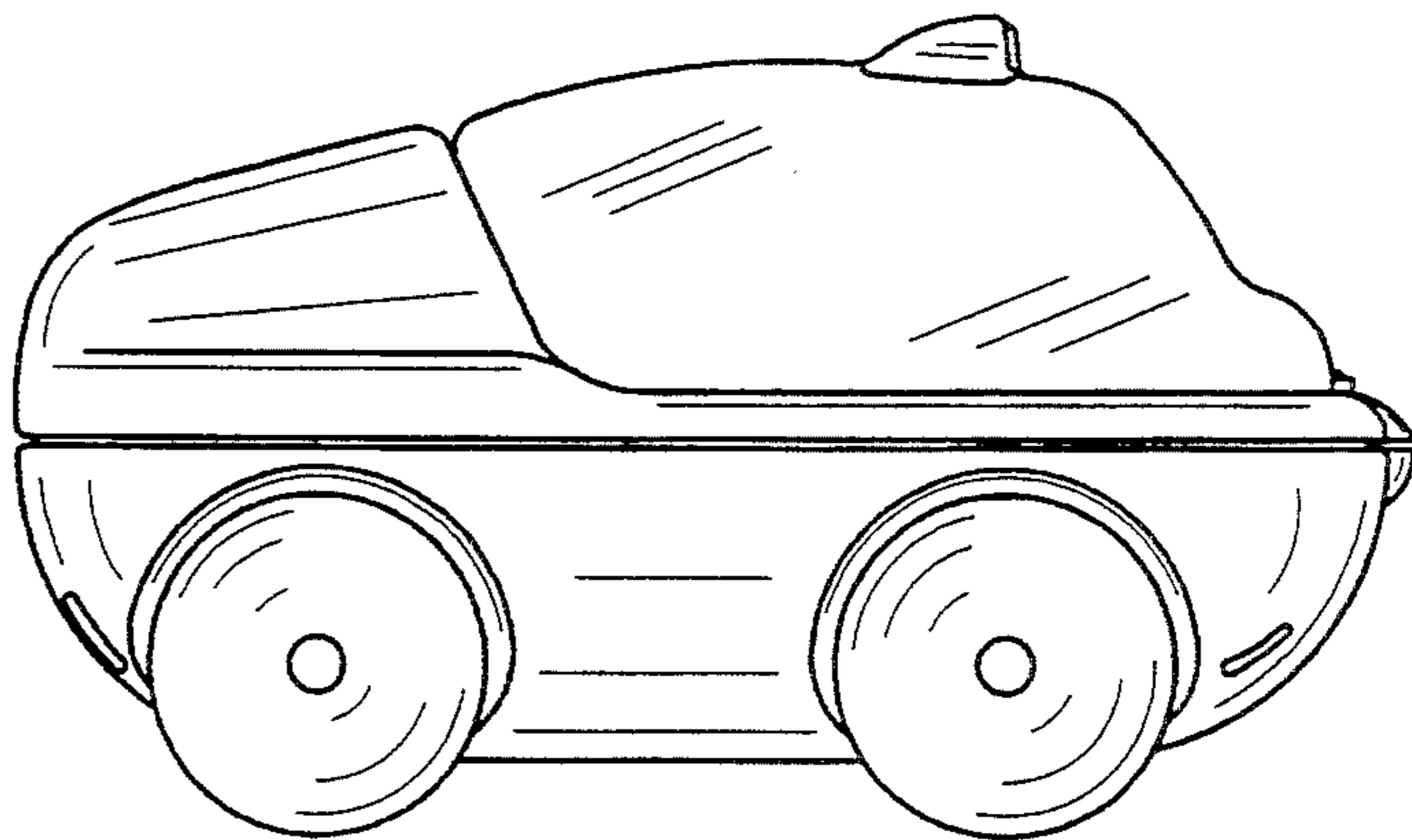

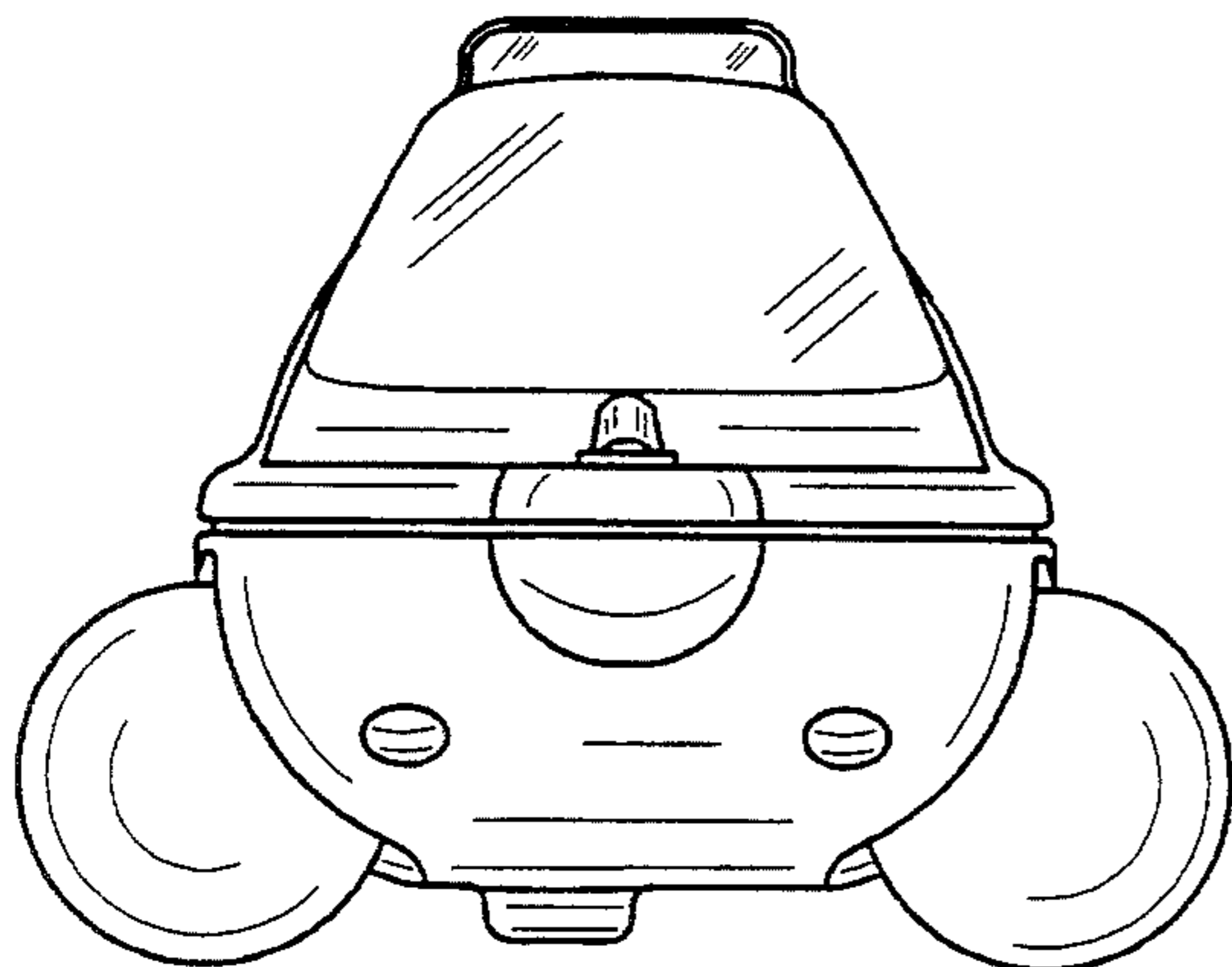

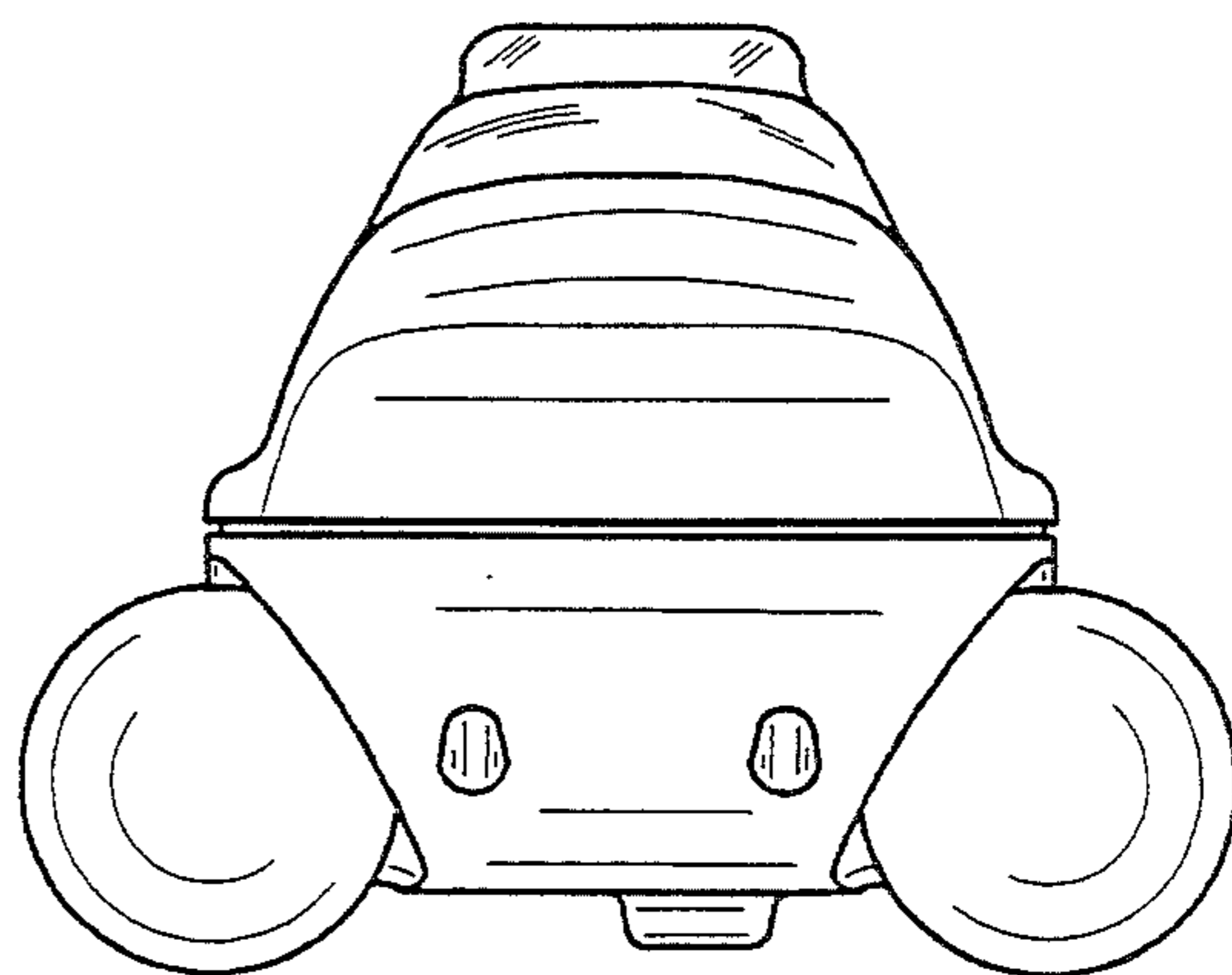

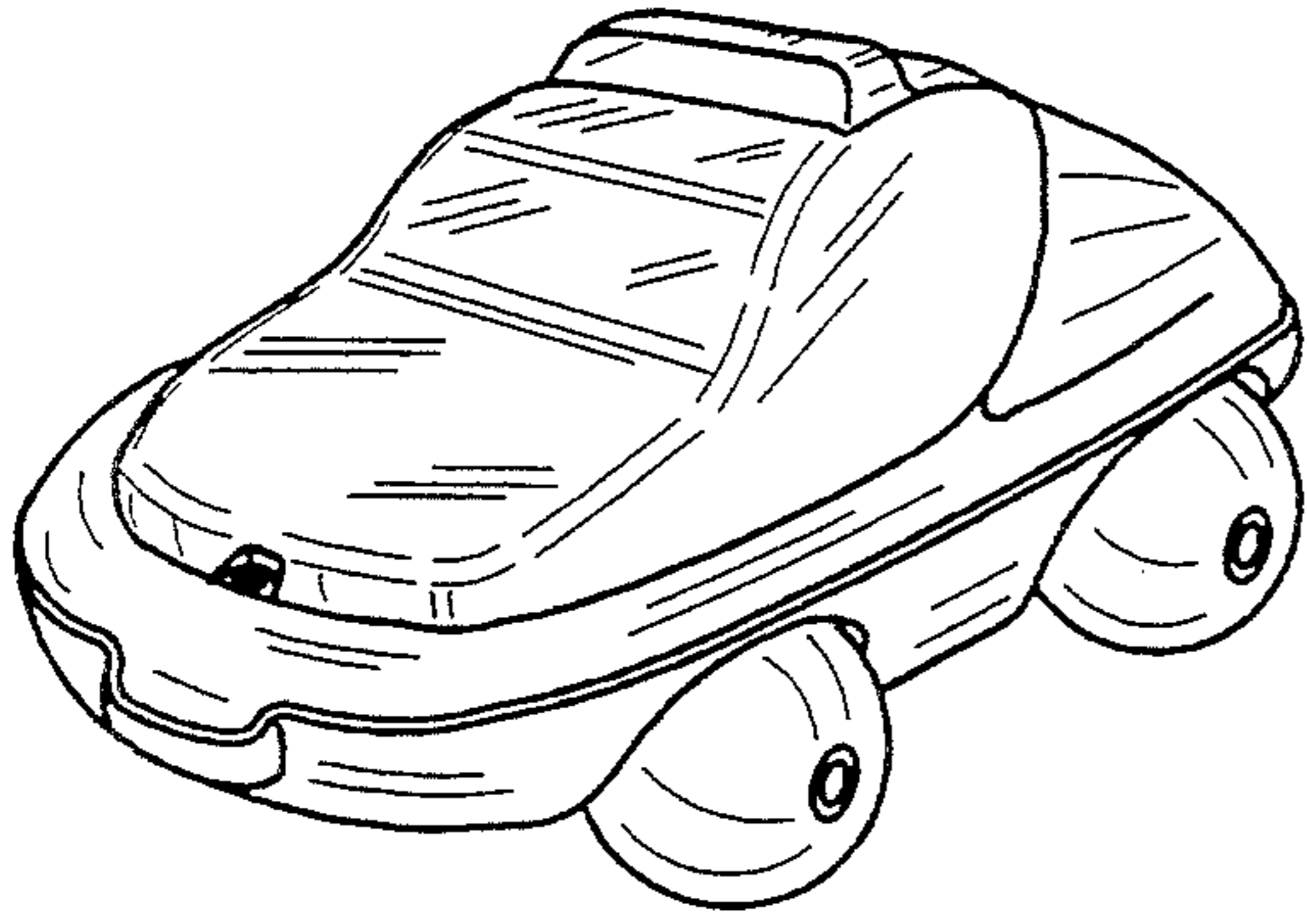

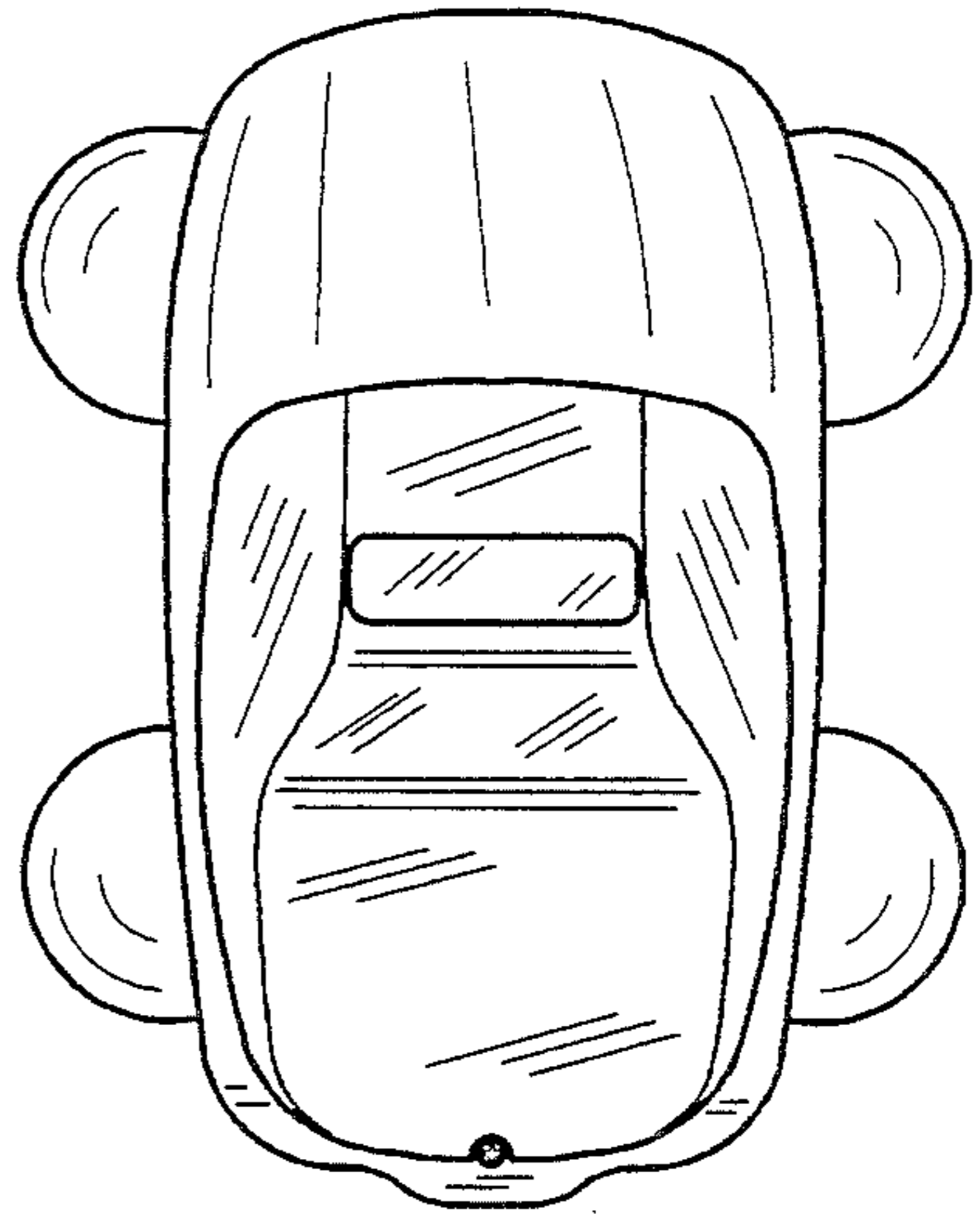

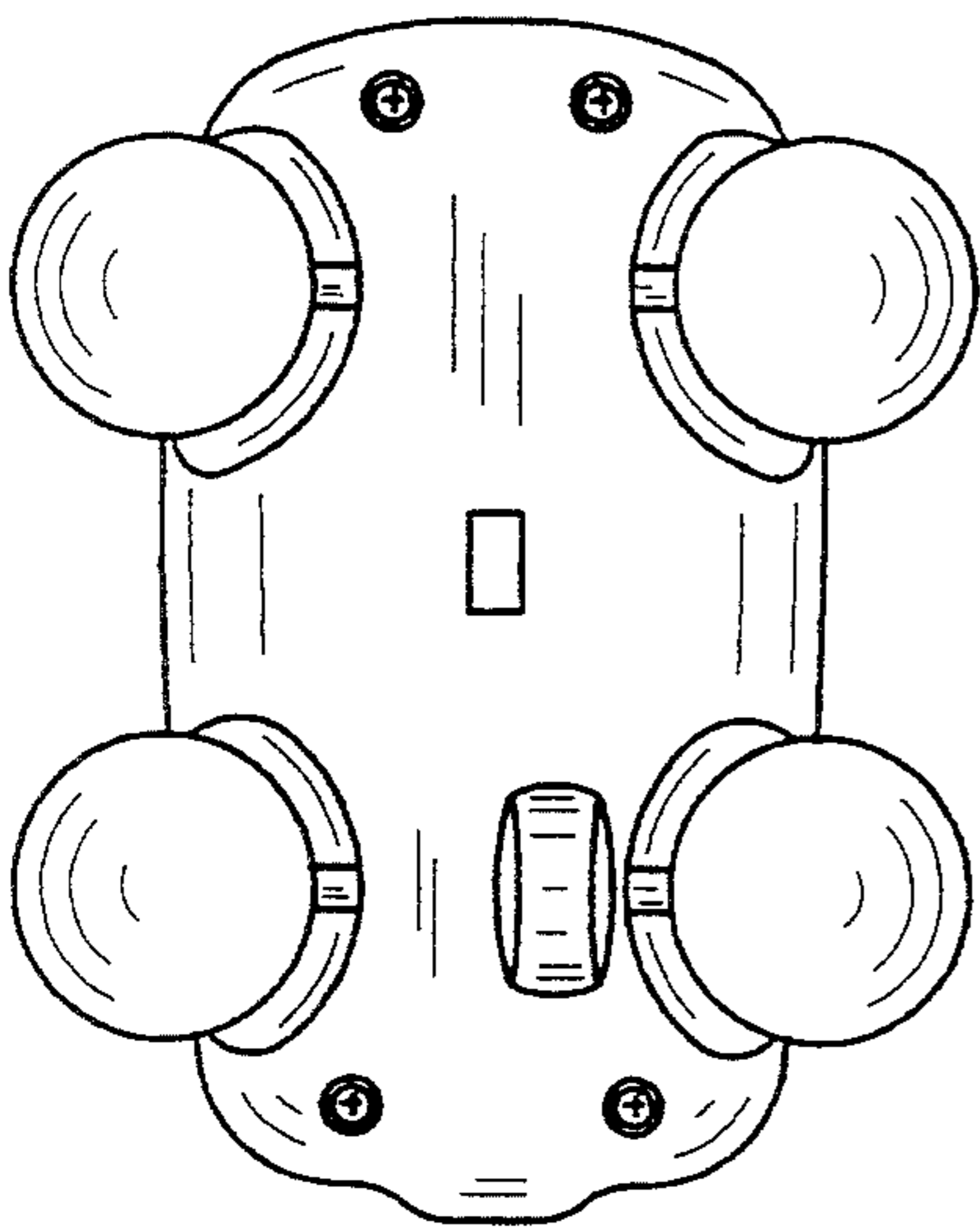

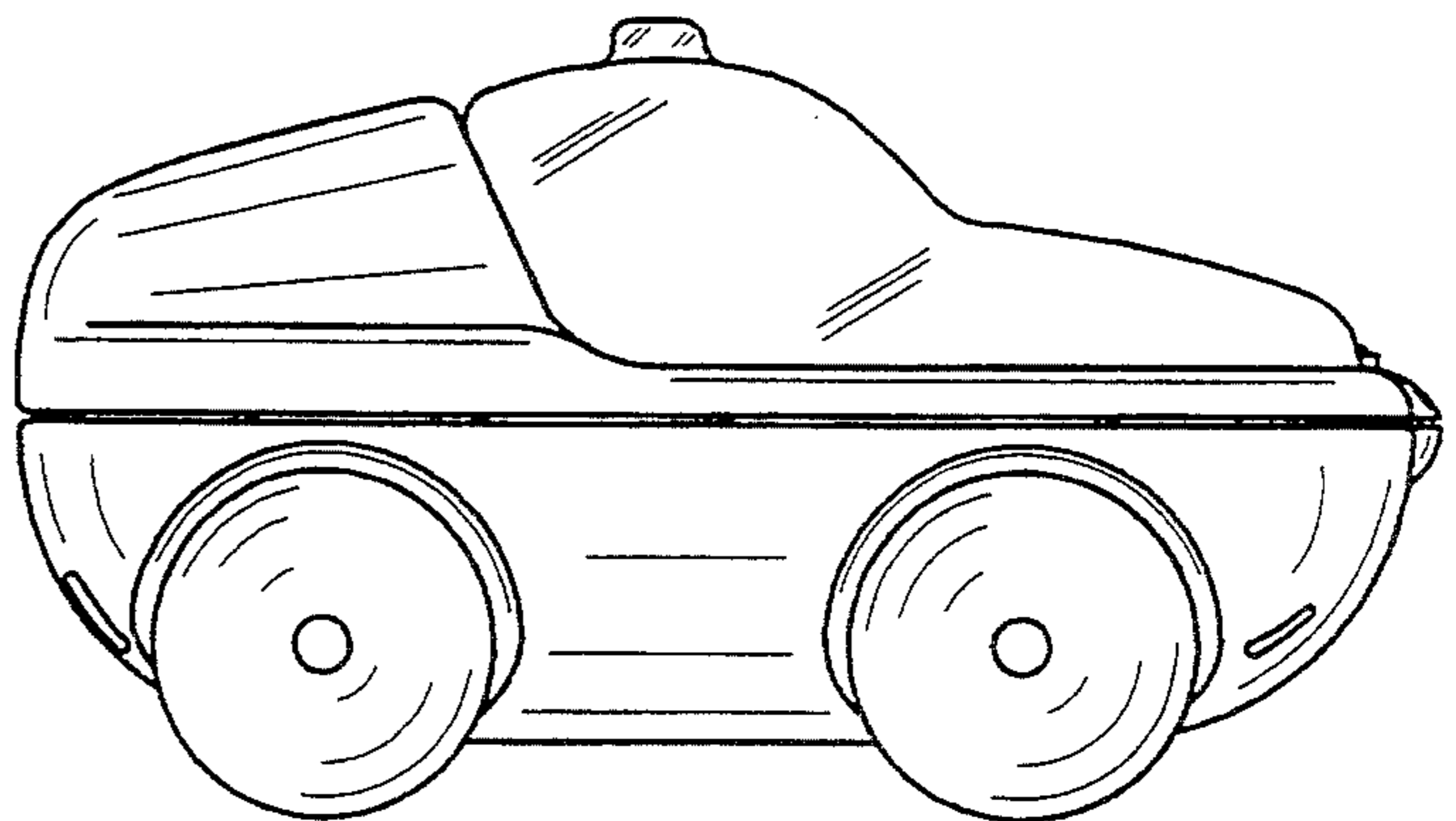

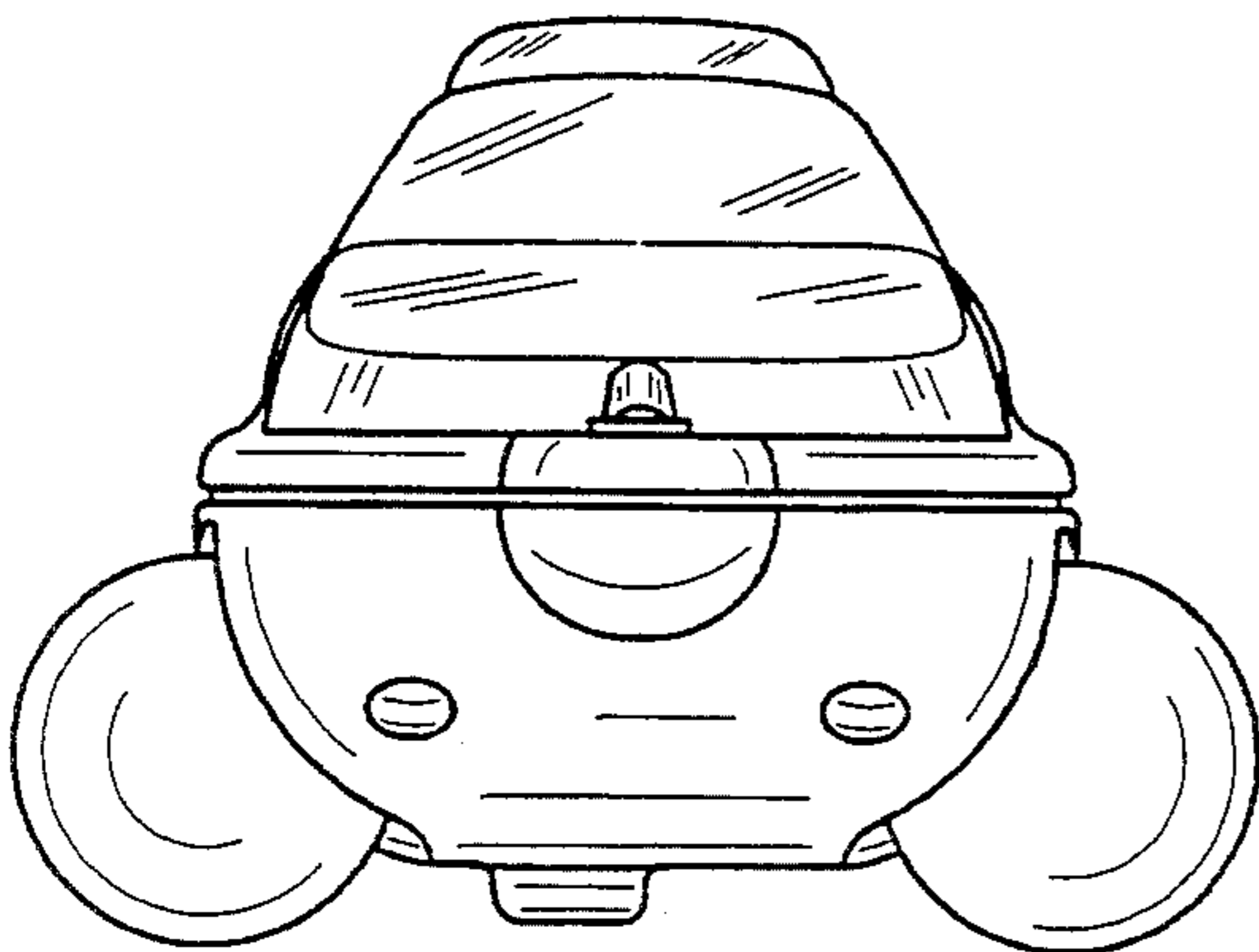

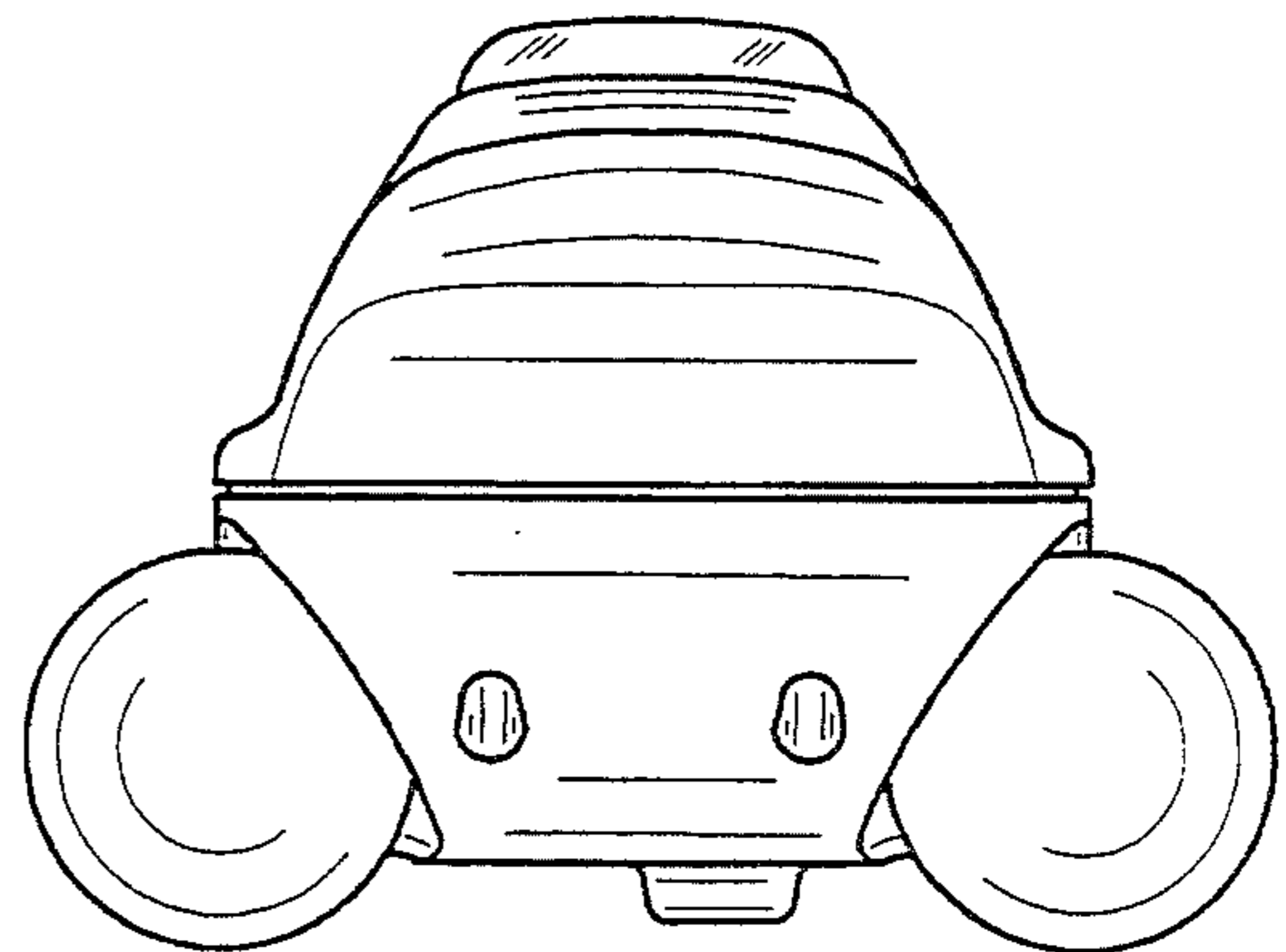

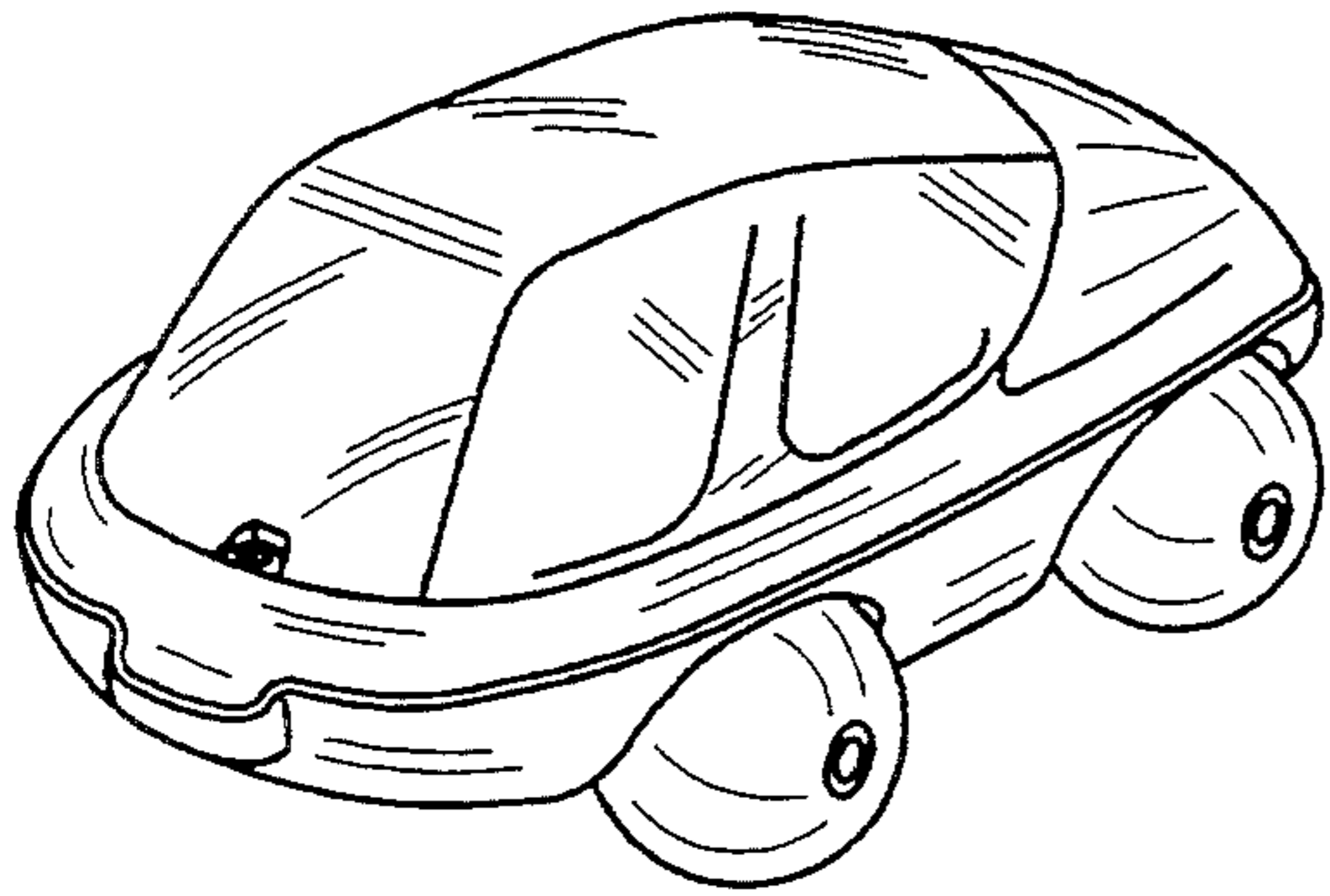

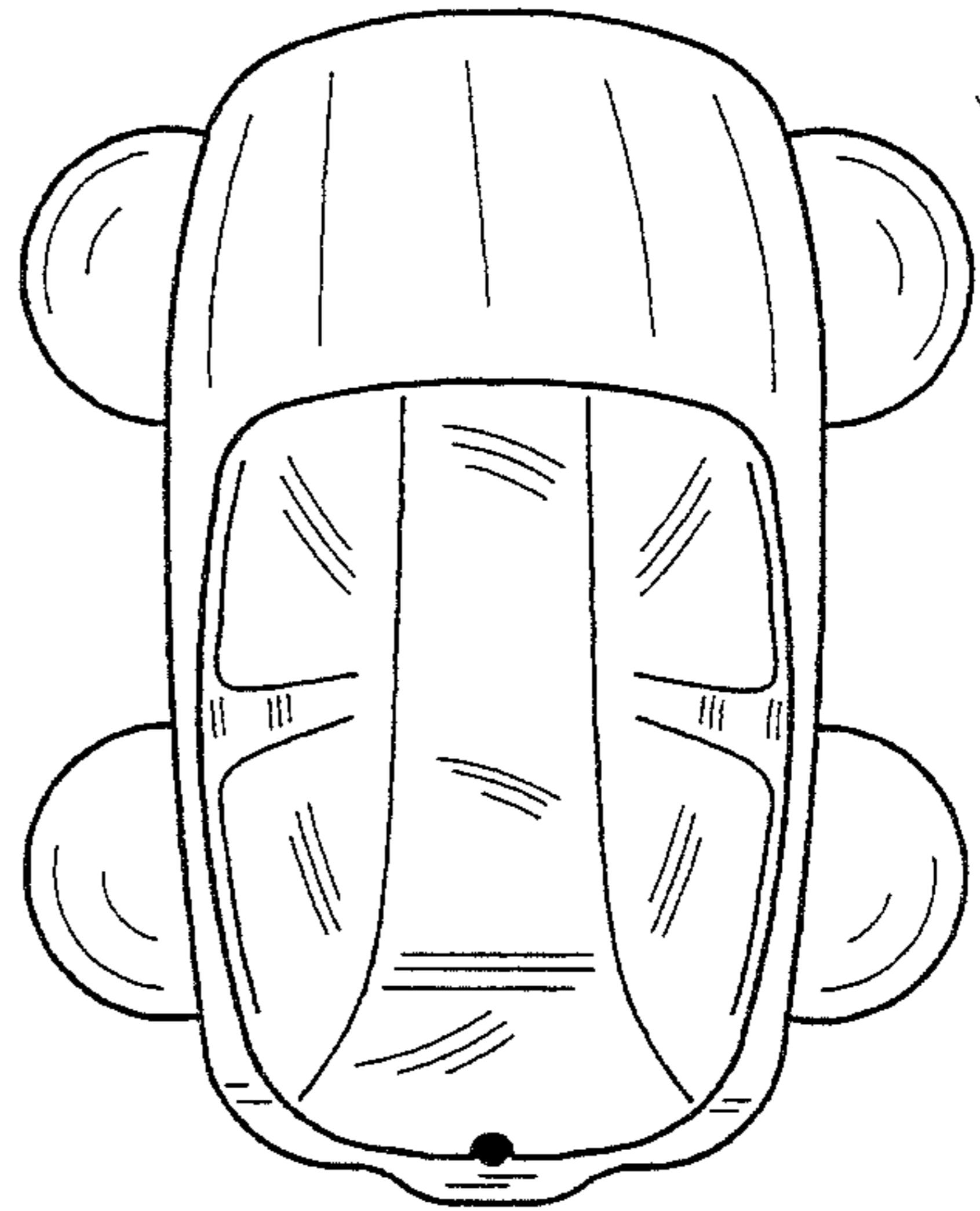

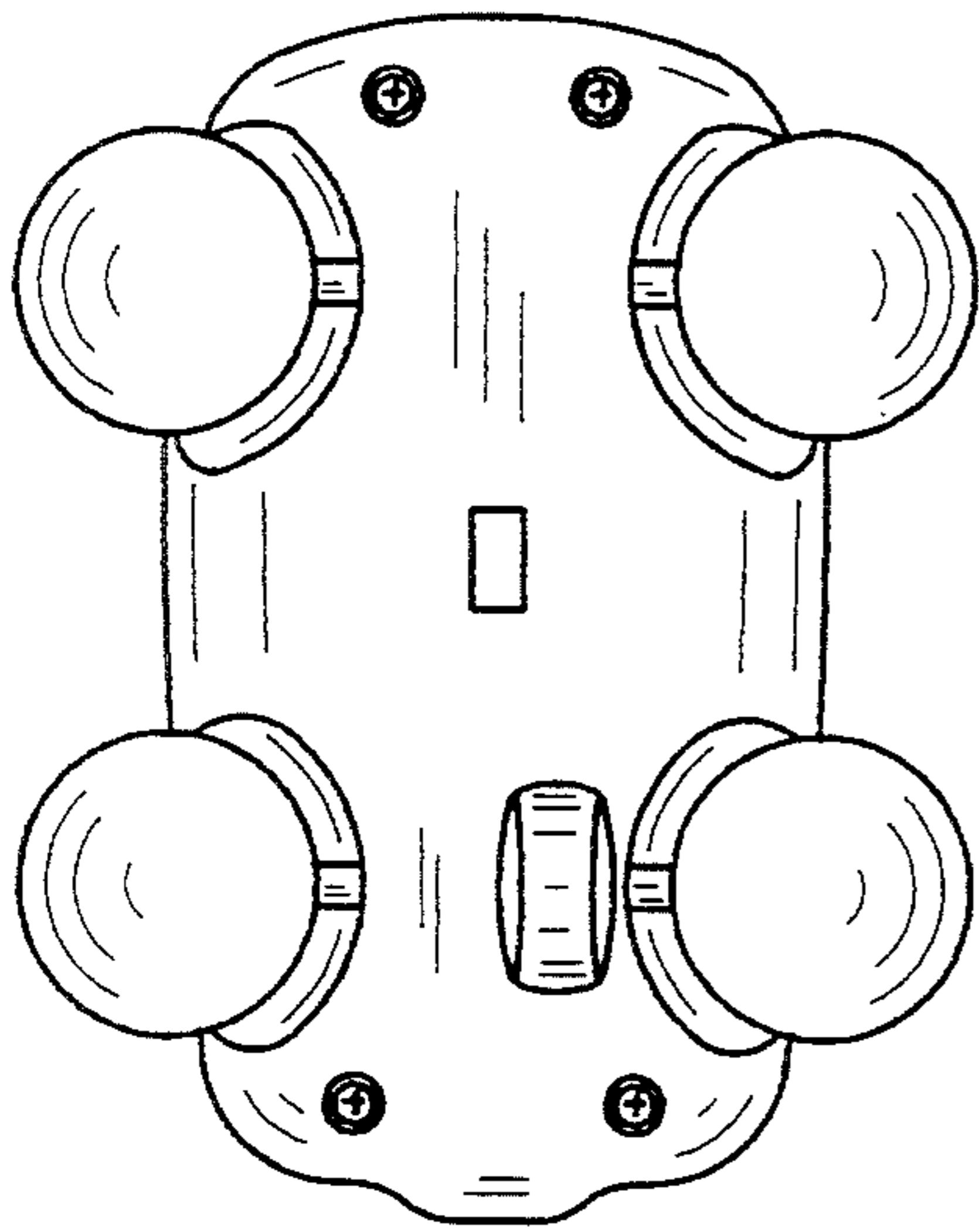

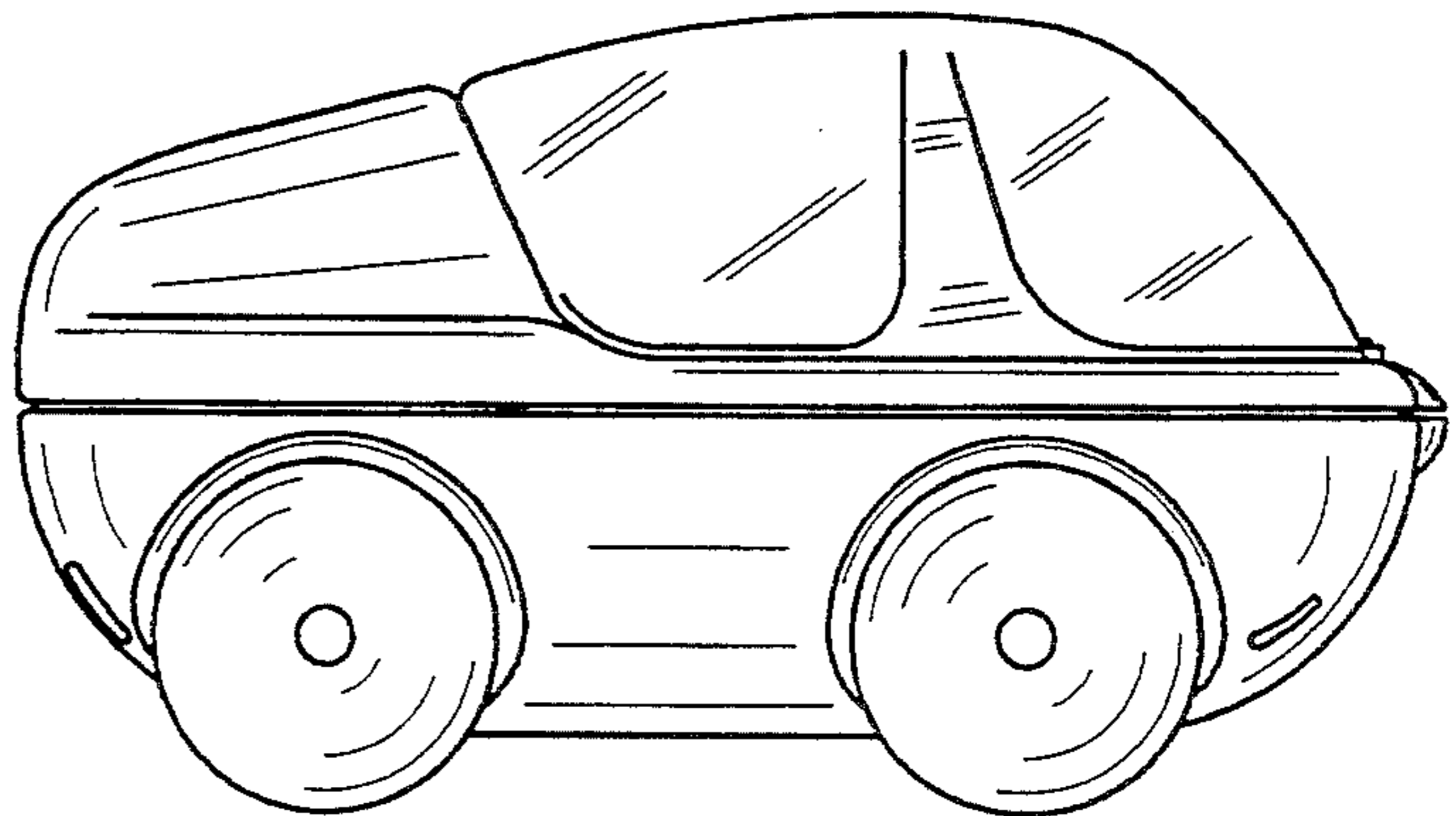

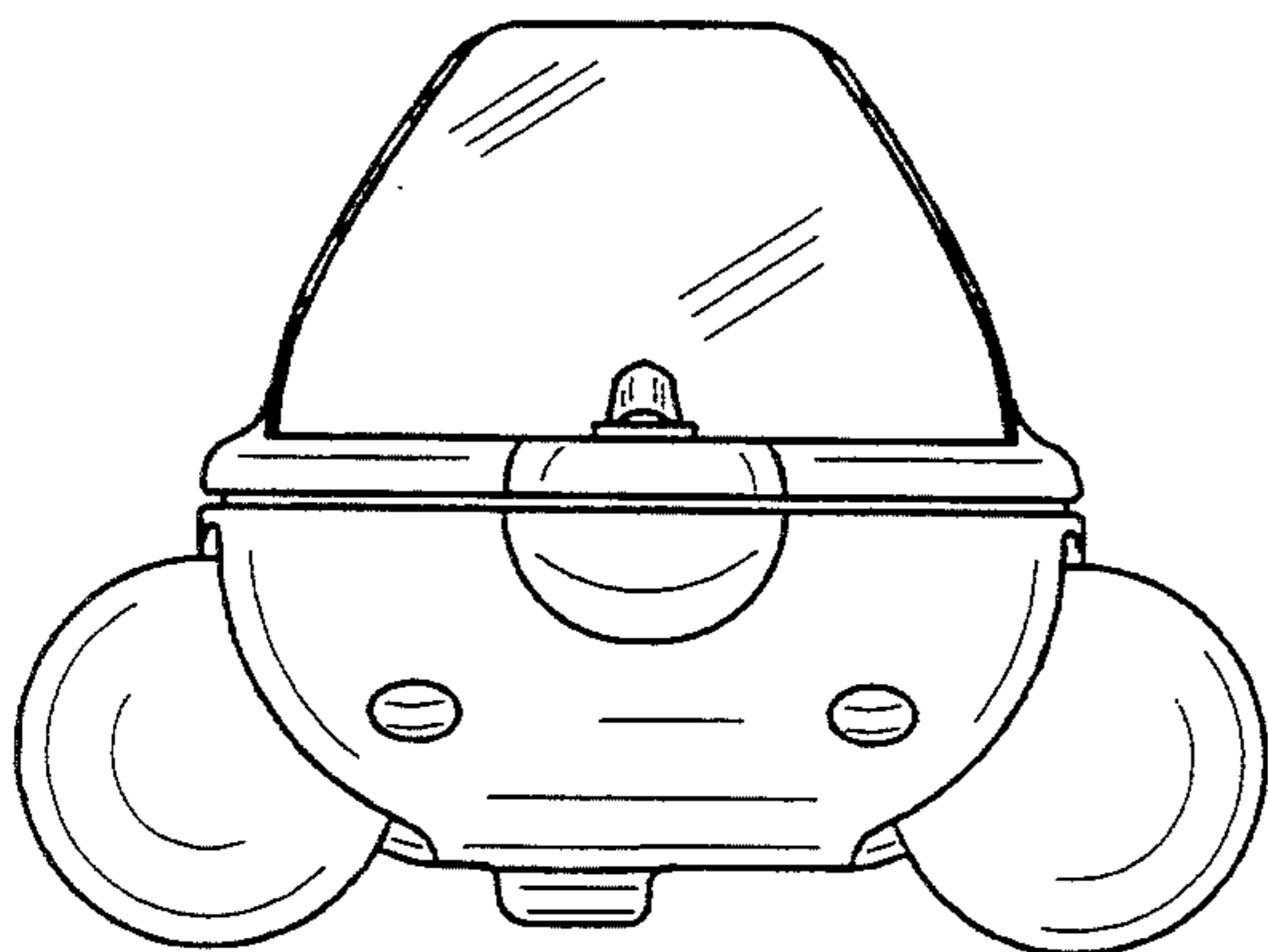

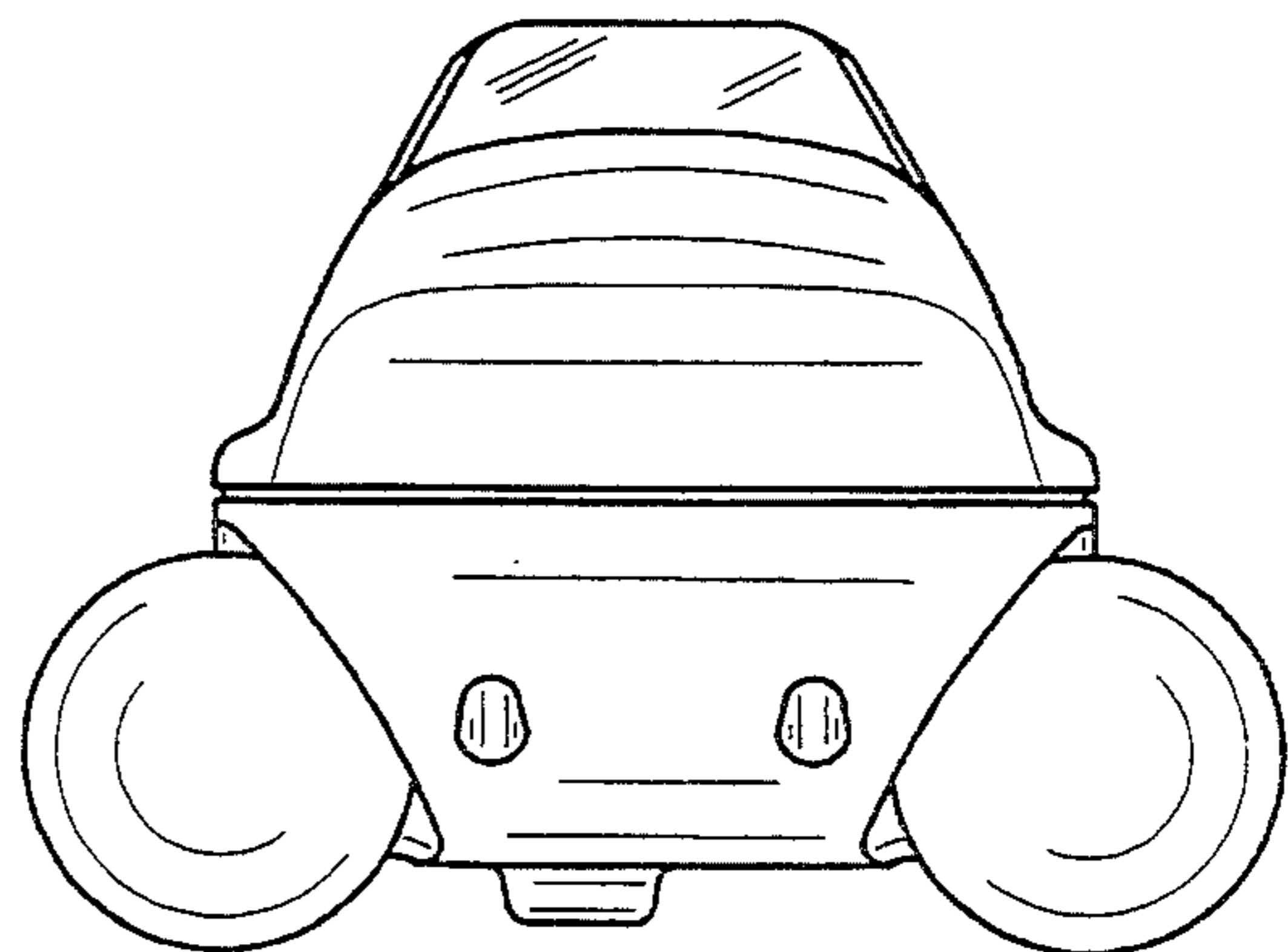
