The ornamental design for a handle portion for a tilt truck, as shown and described.

DESCRIPTION

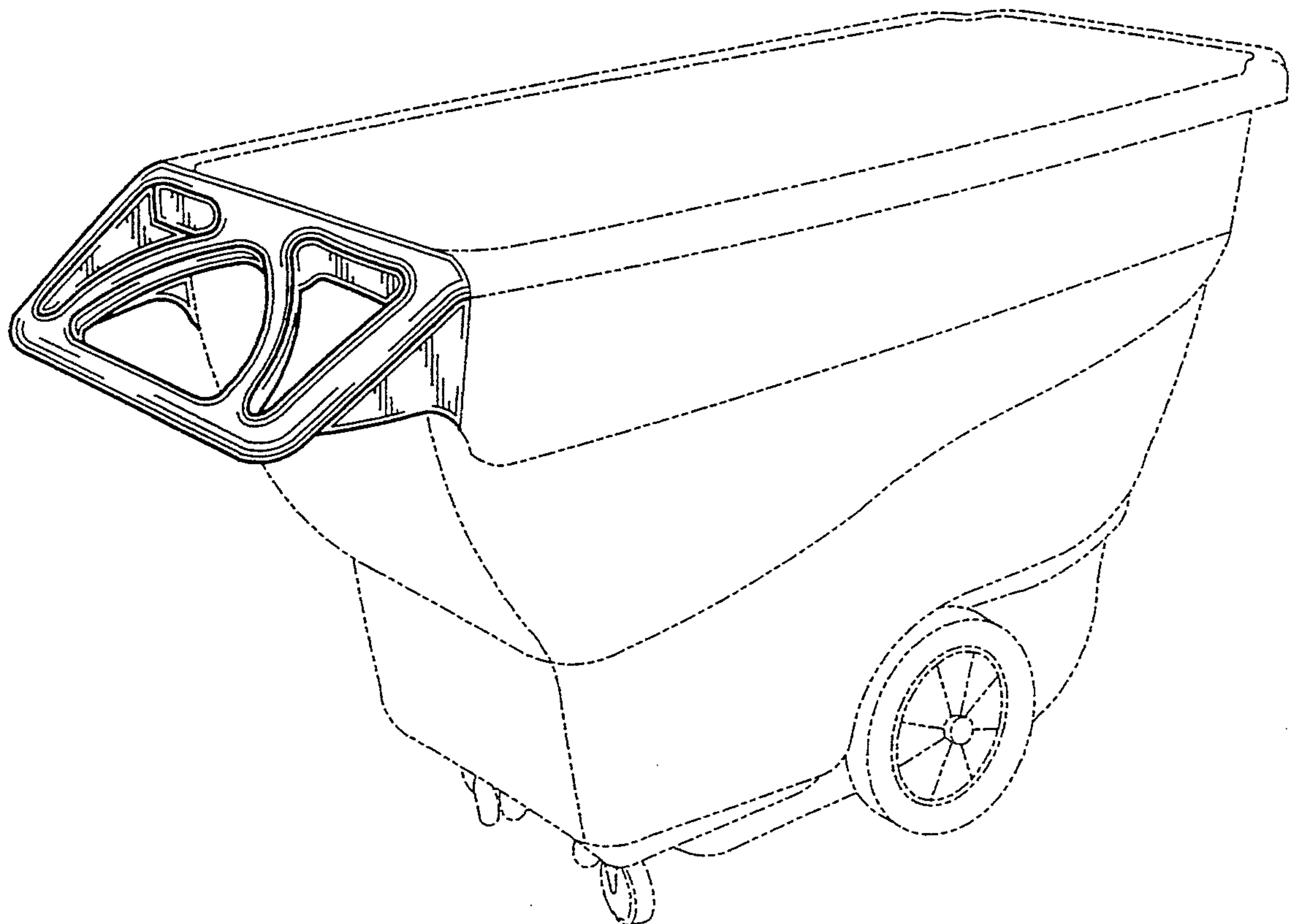
FIG. 2 is a left side elevational view thereof; the right side elevational view being a mirror image;

FIG. 6 is a front elevational view thereof.



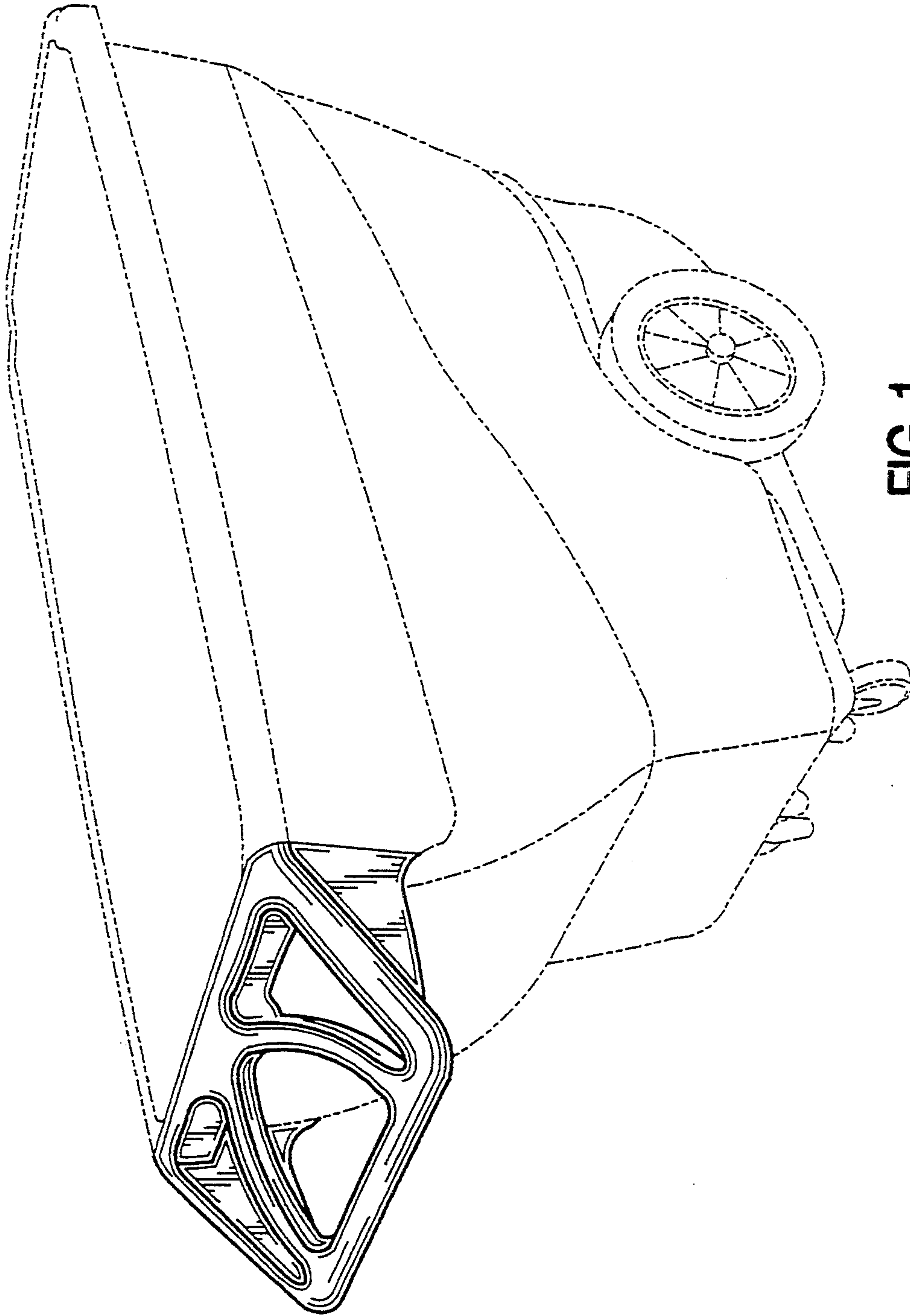

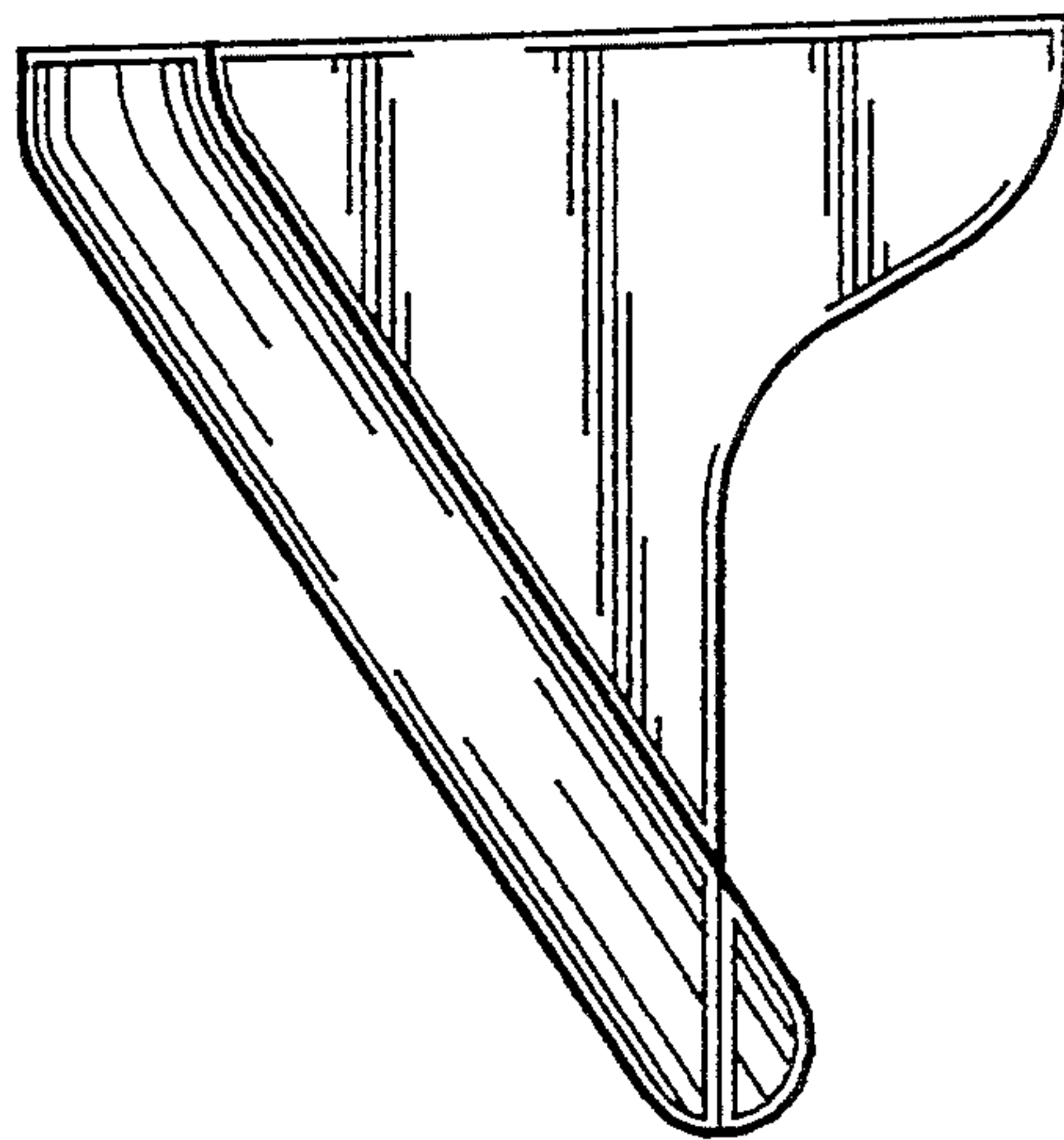

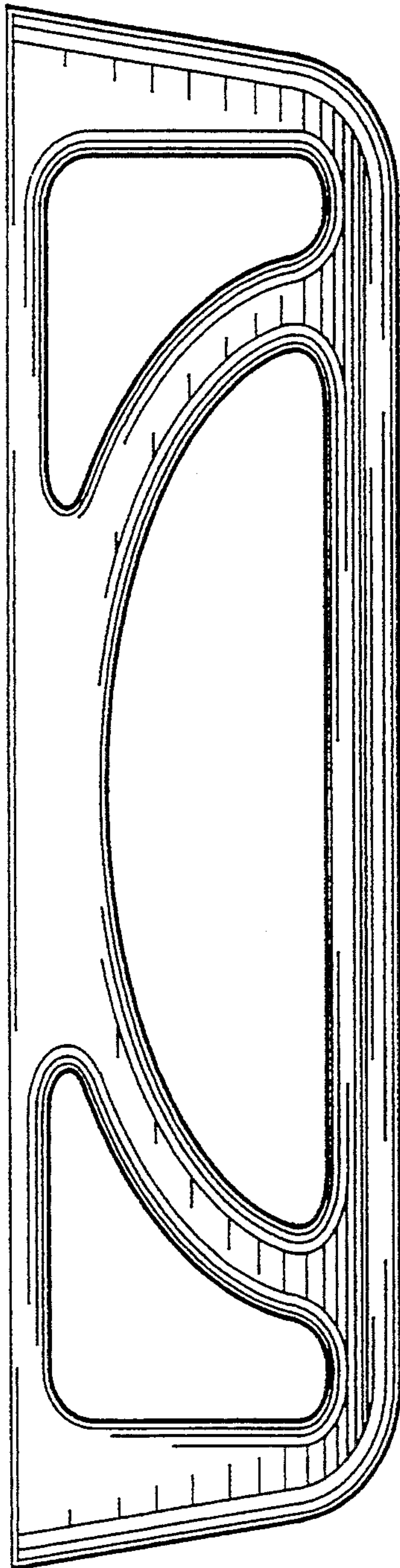

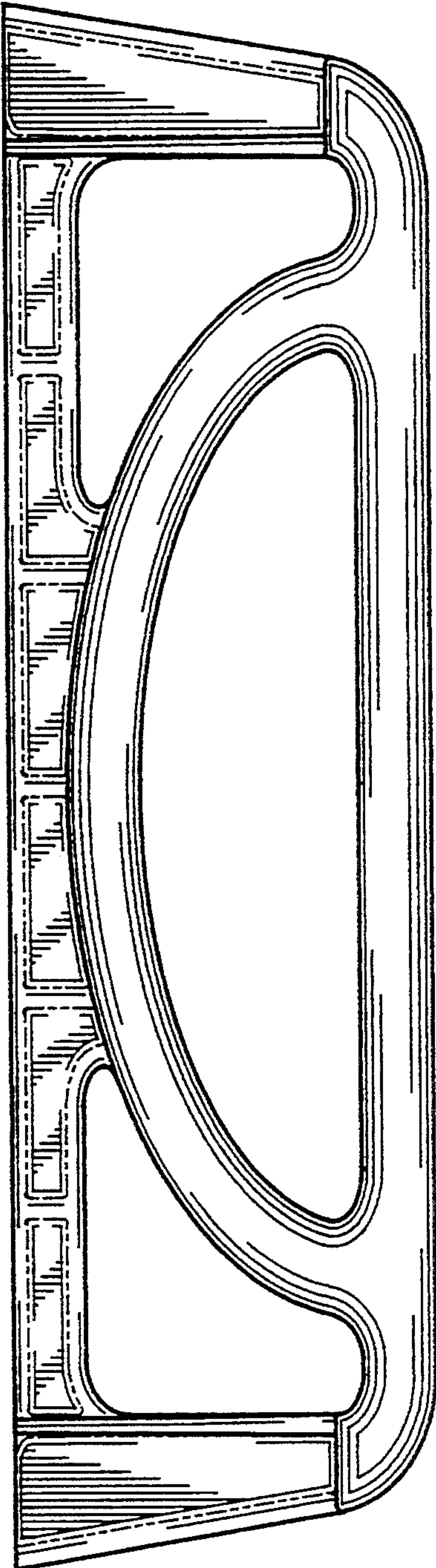

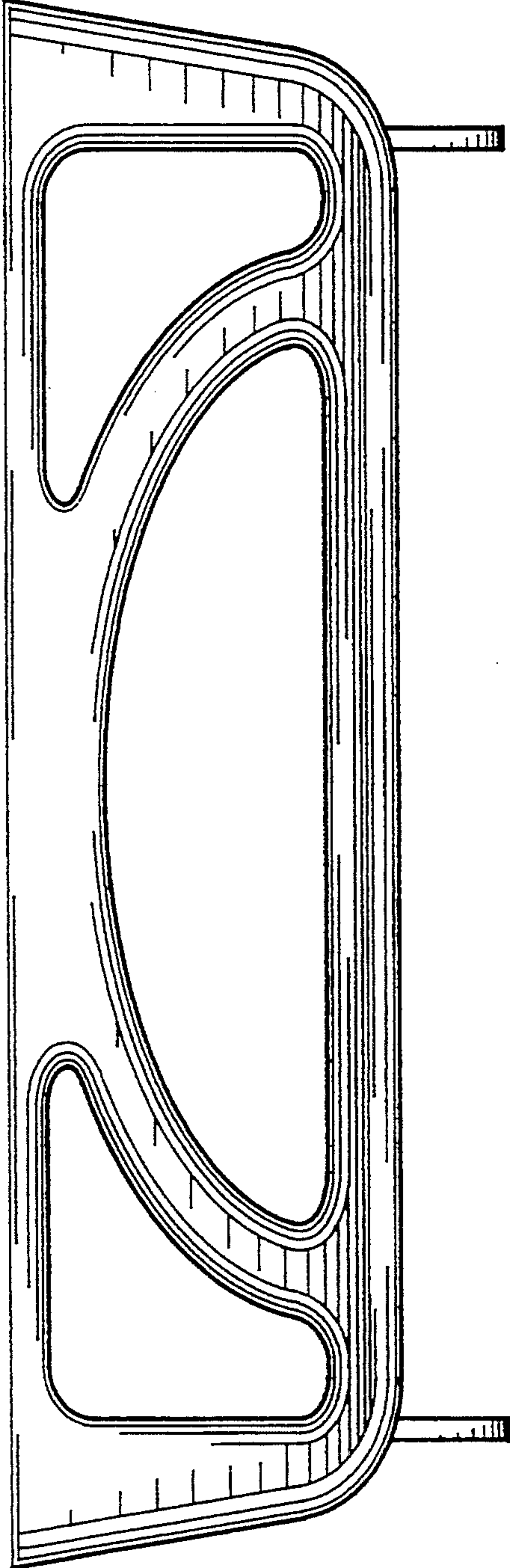

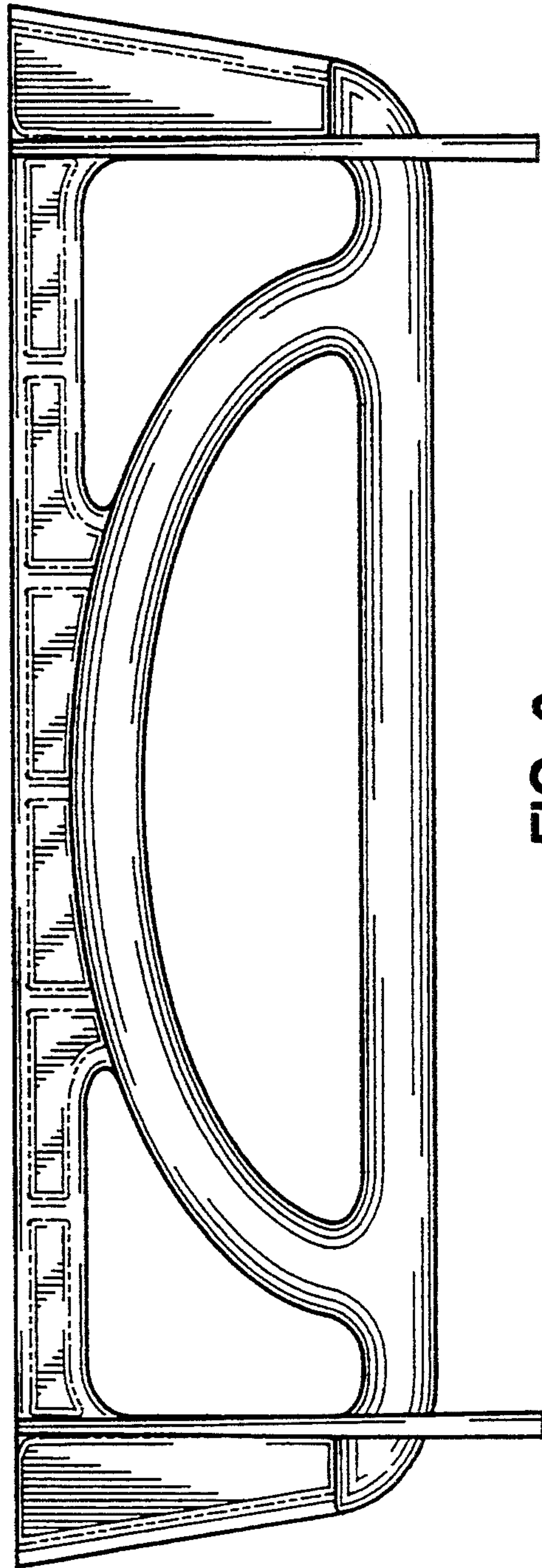
