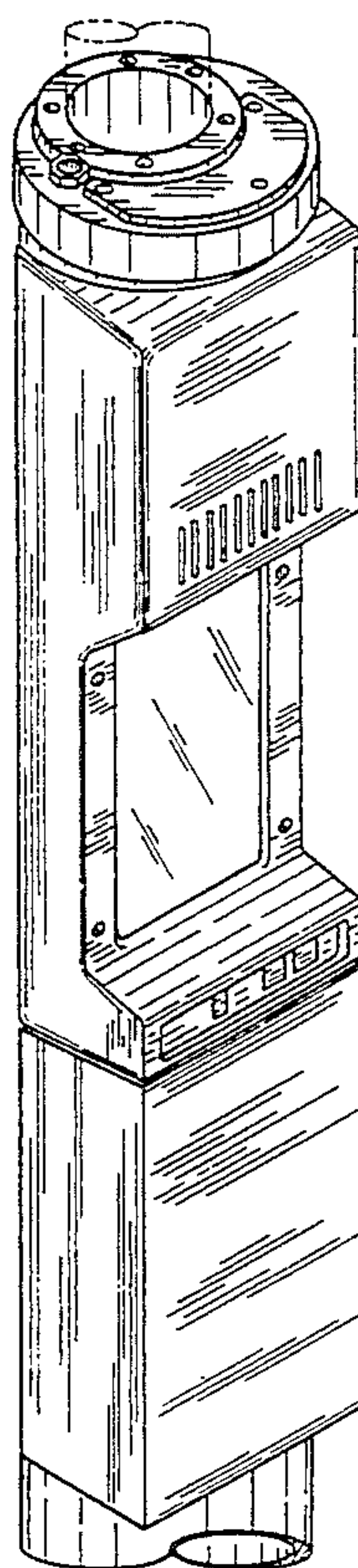

FIG. 14 is a rear view thereof.



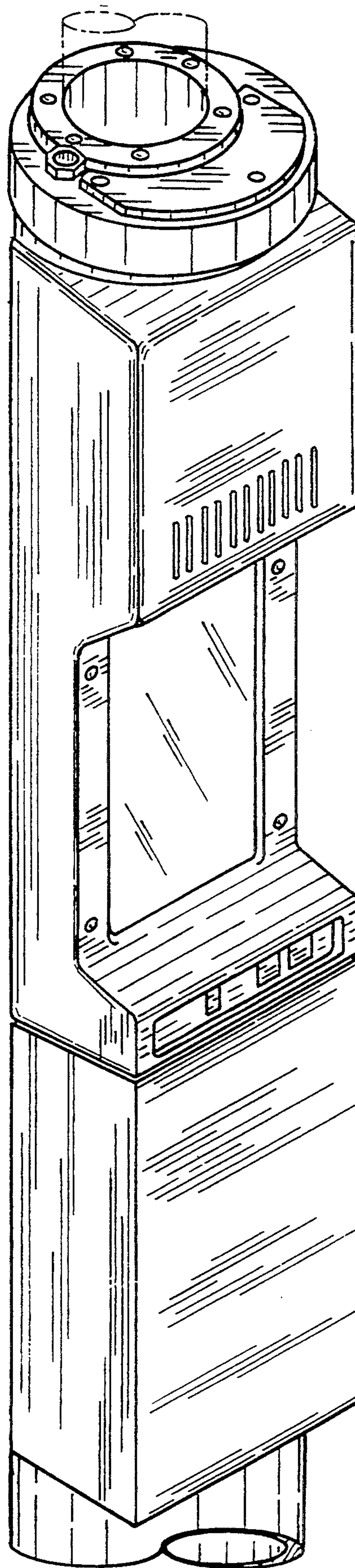

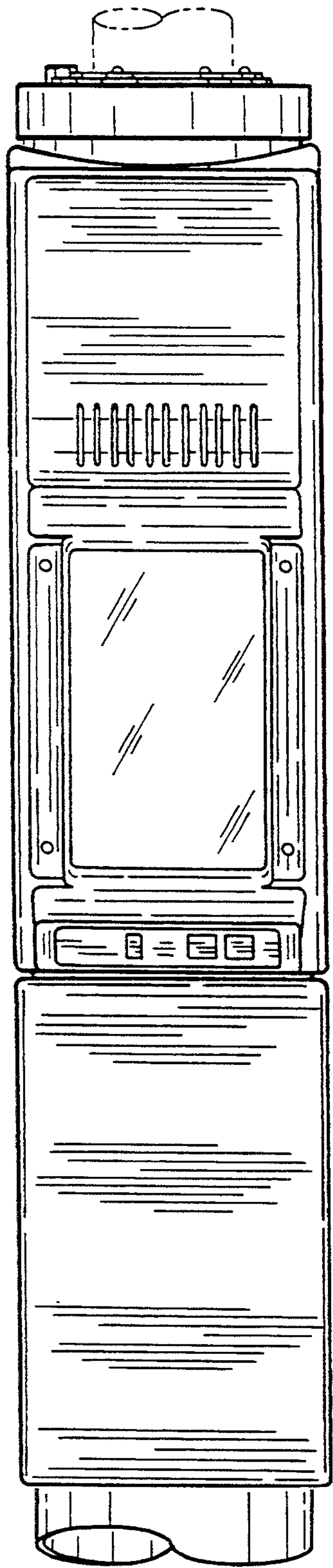

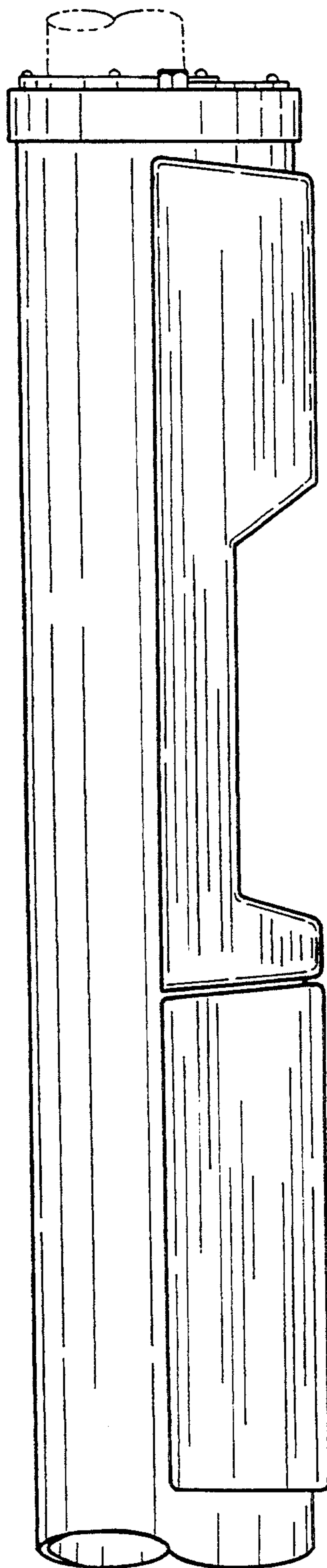

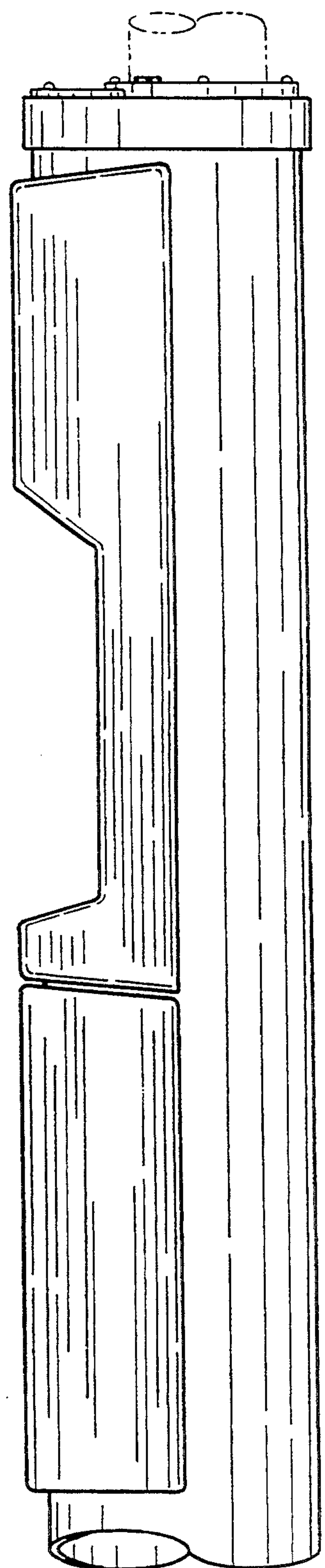

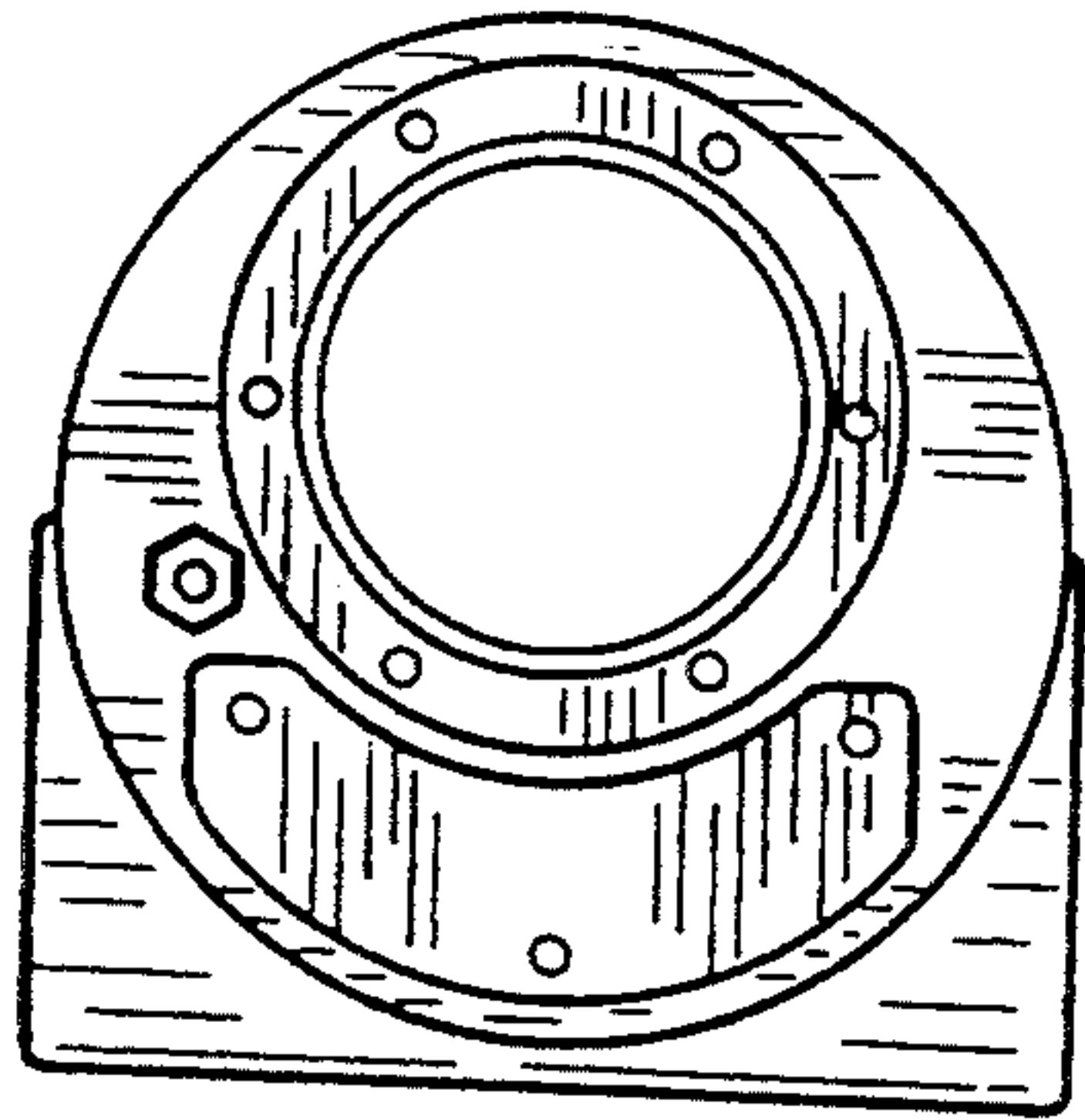

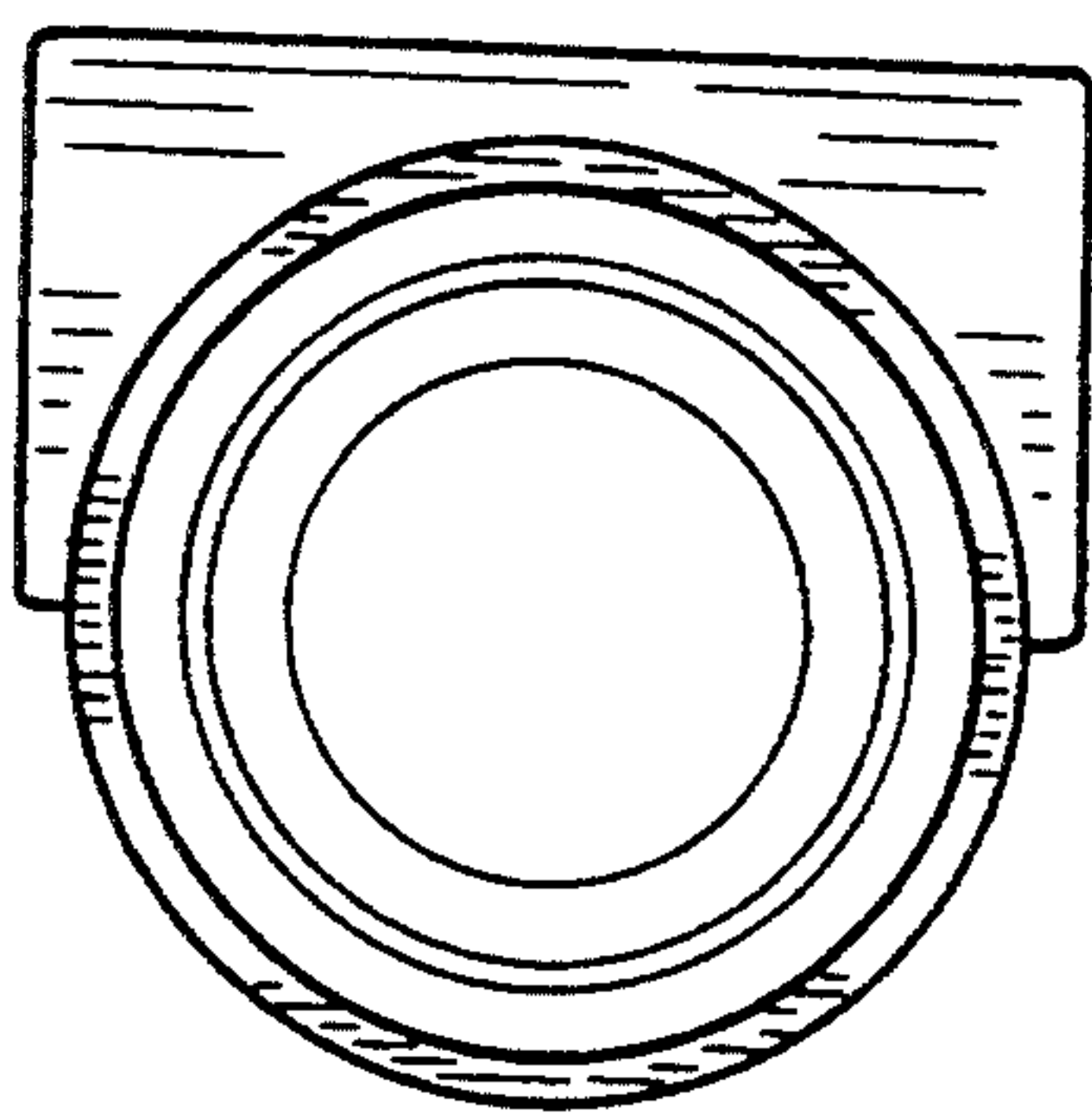

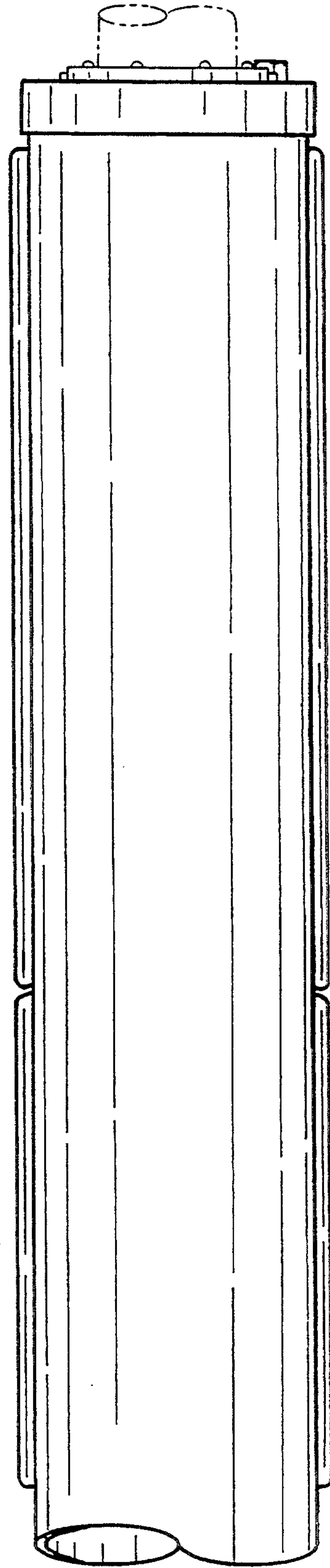

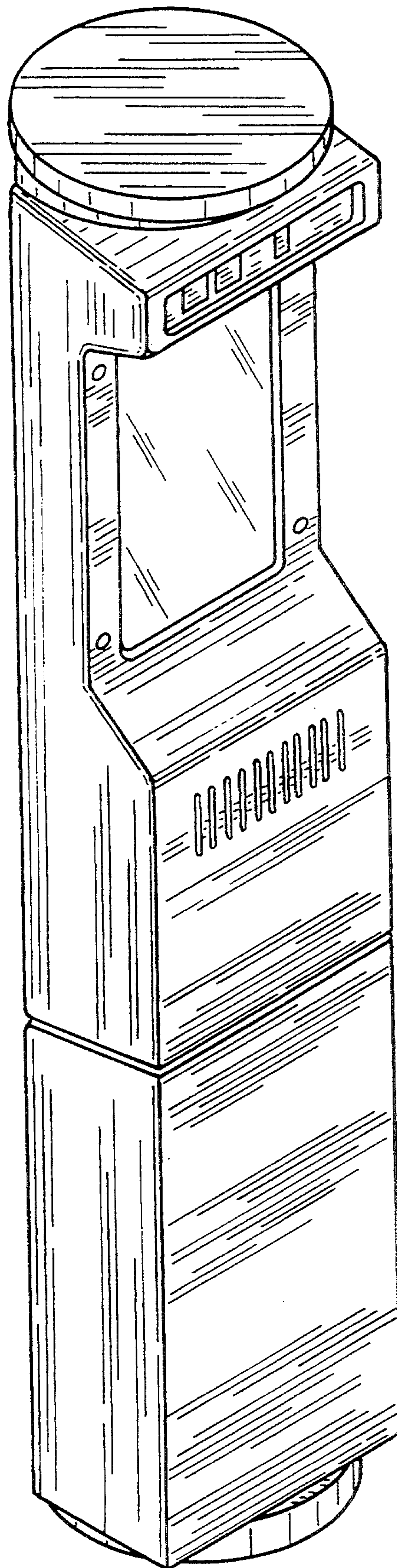

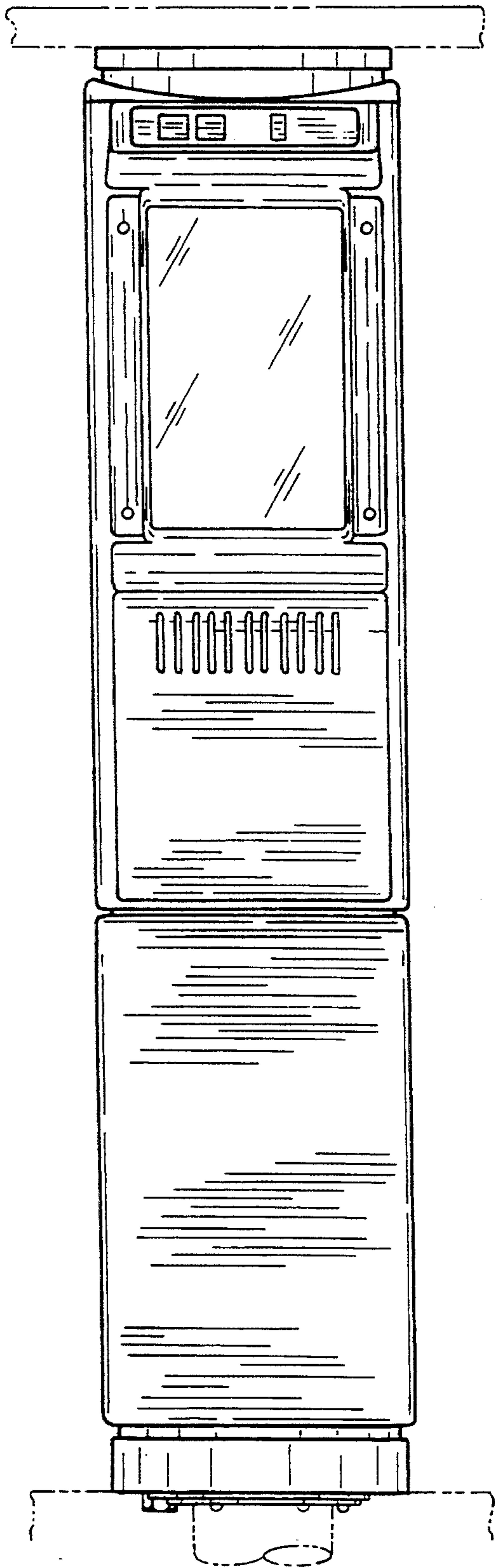

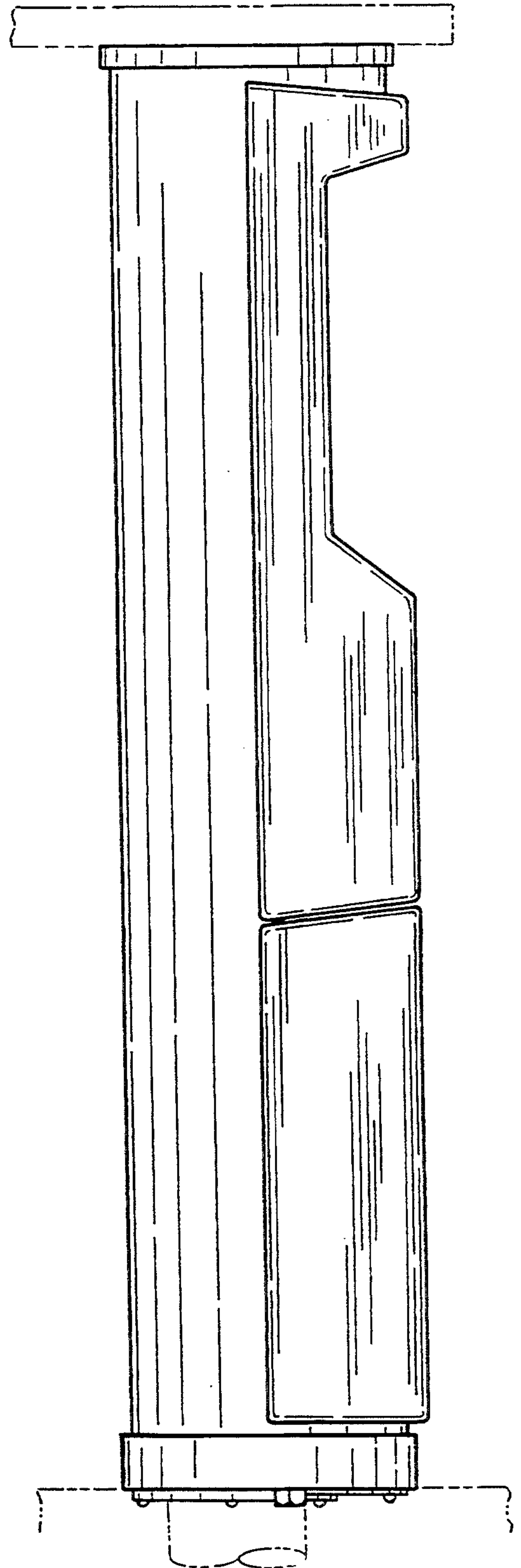

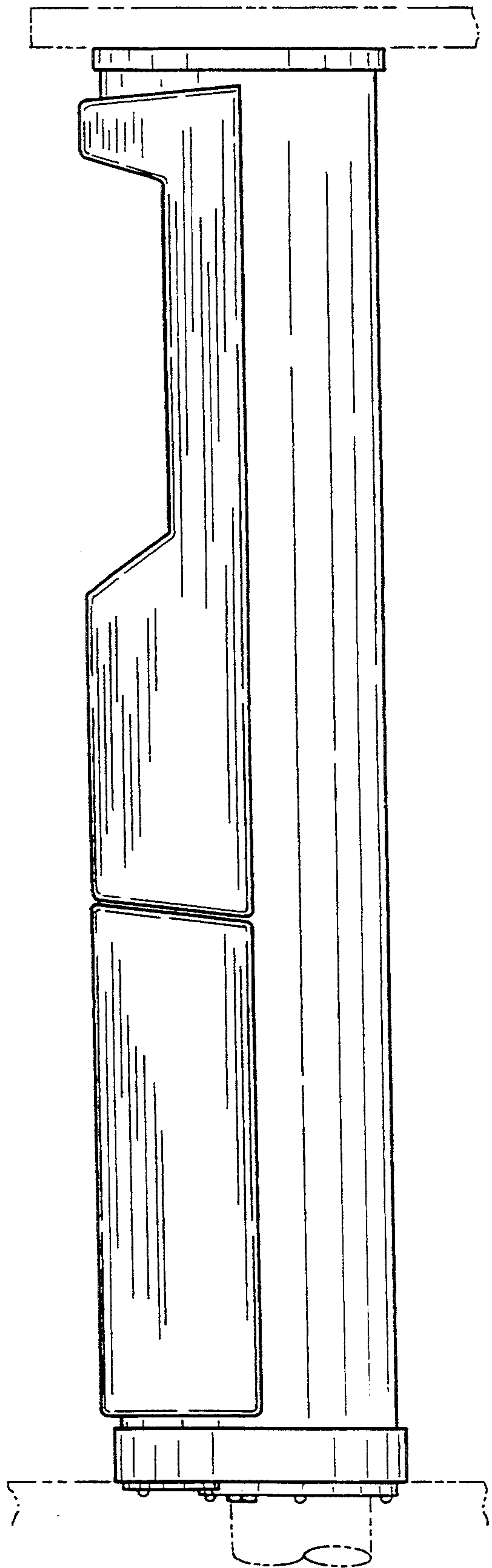

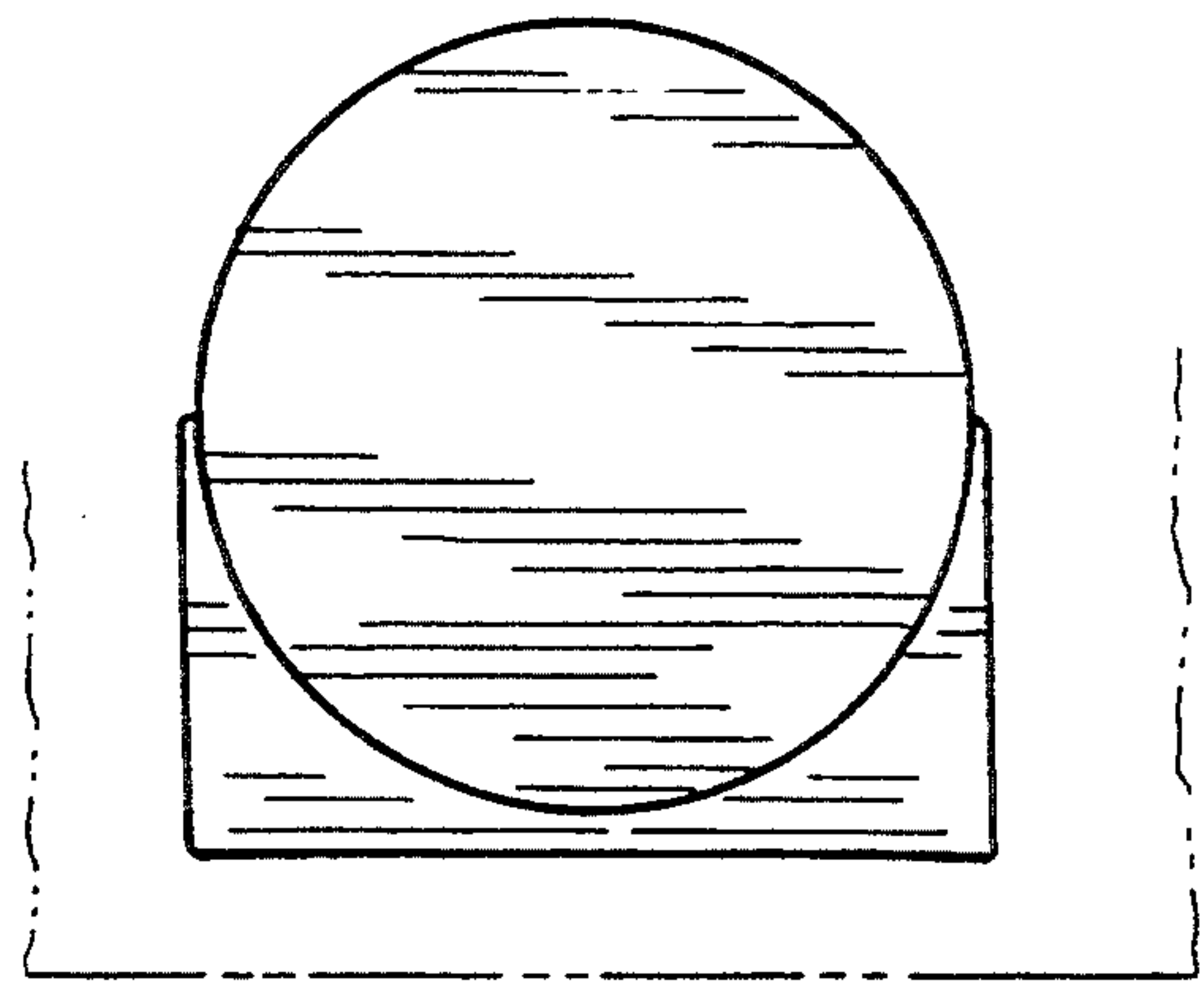

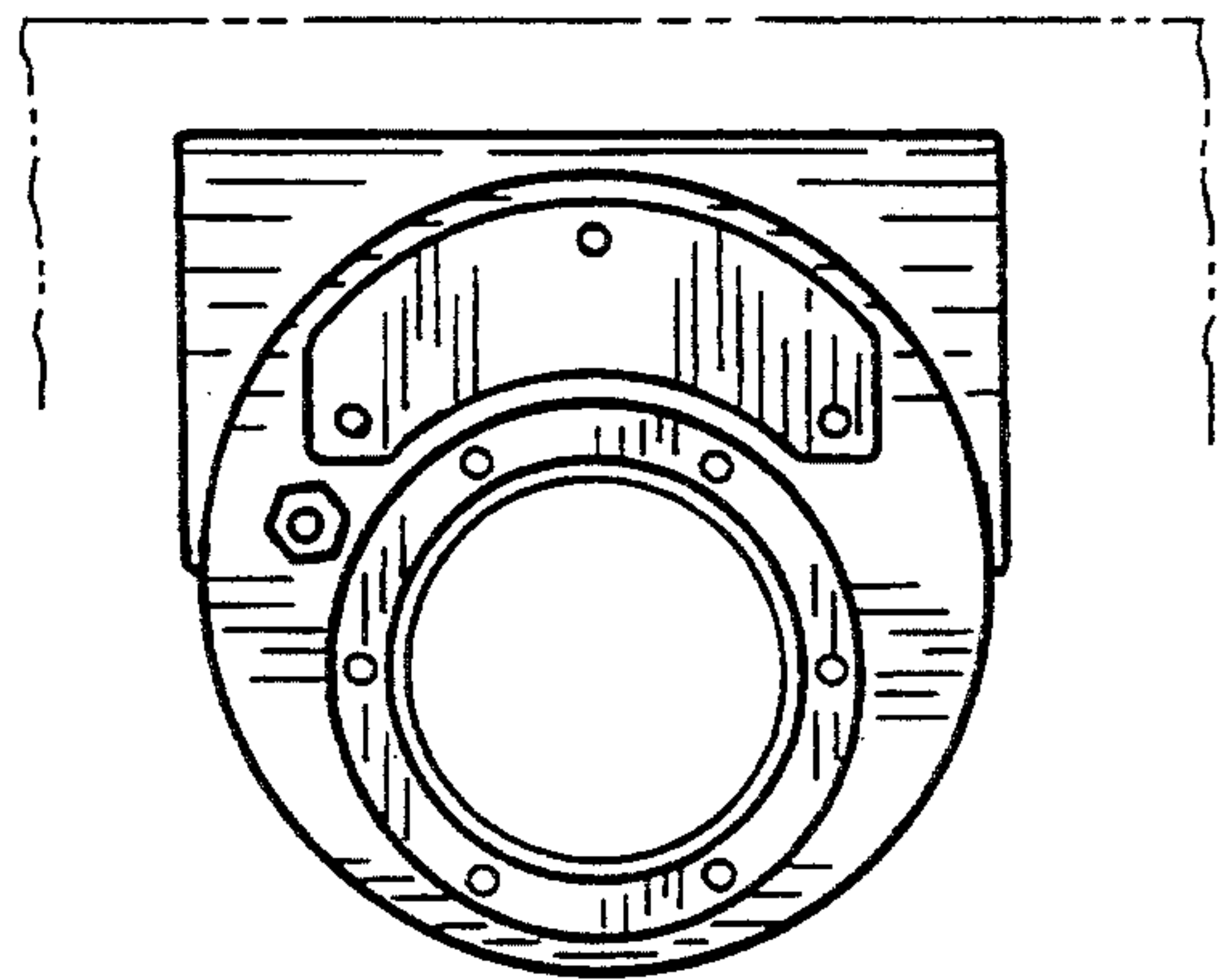

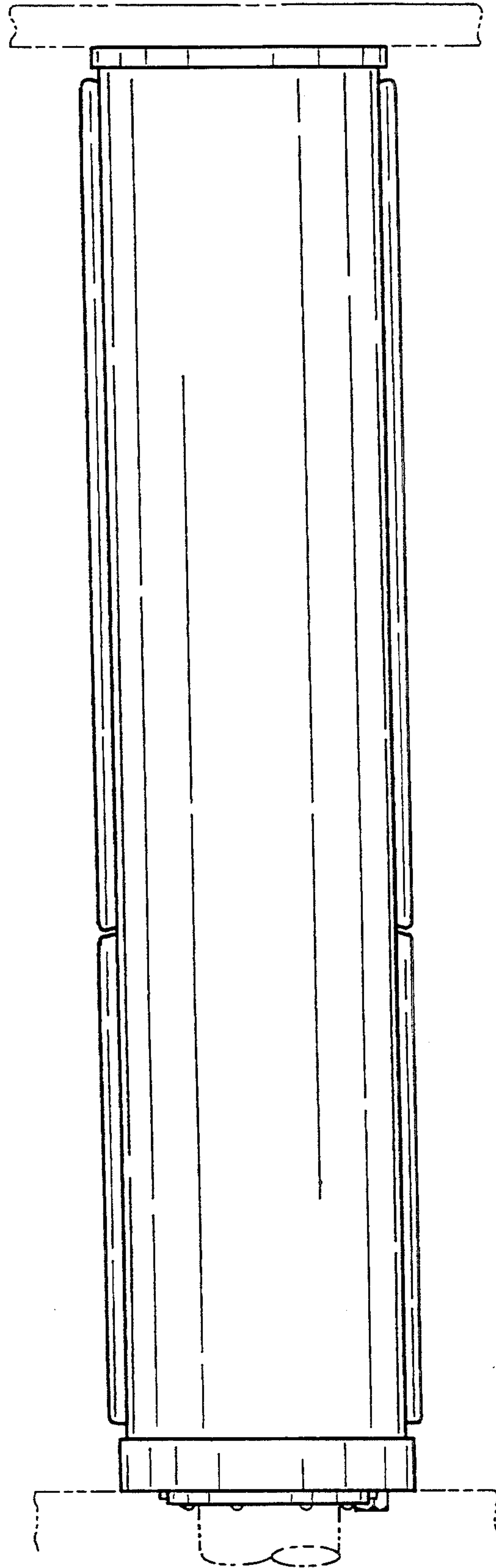
