[57] **CLAIM**

The ornamental design for a telephone, as shown and described.

### DESCRIPTION

FIG. 1 is a combined perspective view of the telephone receiver and of the base showing our new design; FIG. 2 is a perspective view of the telephone receiver at rest on the base; FIG. 3 is a bottom plan view of the receiver; FIG. 4 is a top plan view of the receiver; FIG. 5 is a front elevation of the receiver; FIG. 6 is a rear elevation of the receiver; FIG. 7 is a right side elevation of the receiver; FIG. 8 is a left side elevation of the receiver; FIG. 9 is a top plan view of the base; FIG. 10 is a bottom plan view of the base; FIG. 11 is a rear elevation of the base; FIG. 12 is a front elevation of the base; FIG. 13 is a left side elevation of the base; and, FIG. 14 is a right side elevation of the base. The receiver in FIGS. 3-8 and the base in FIGS. 9-14 are shown separately for convenience of illustration.

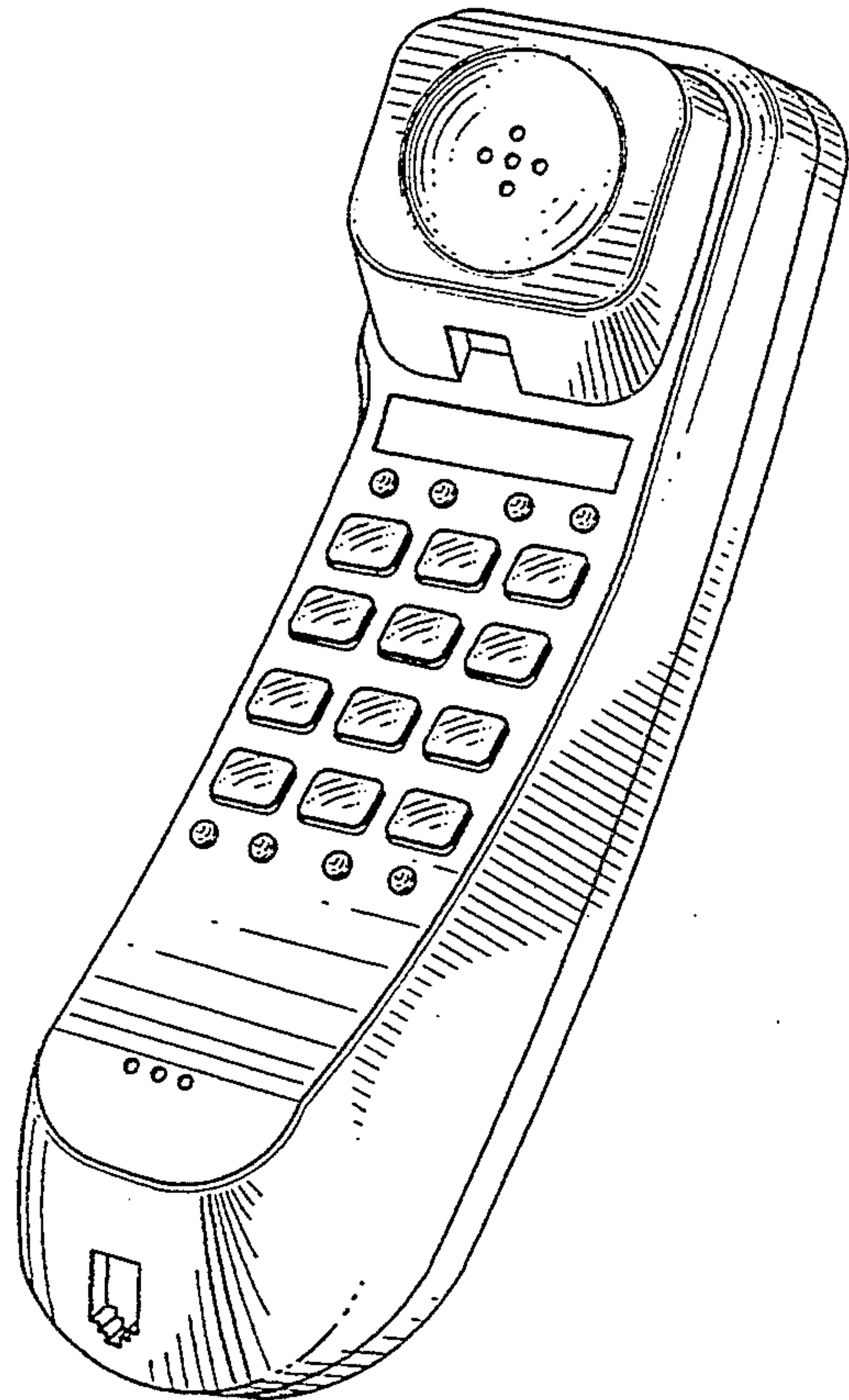
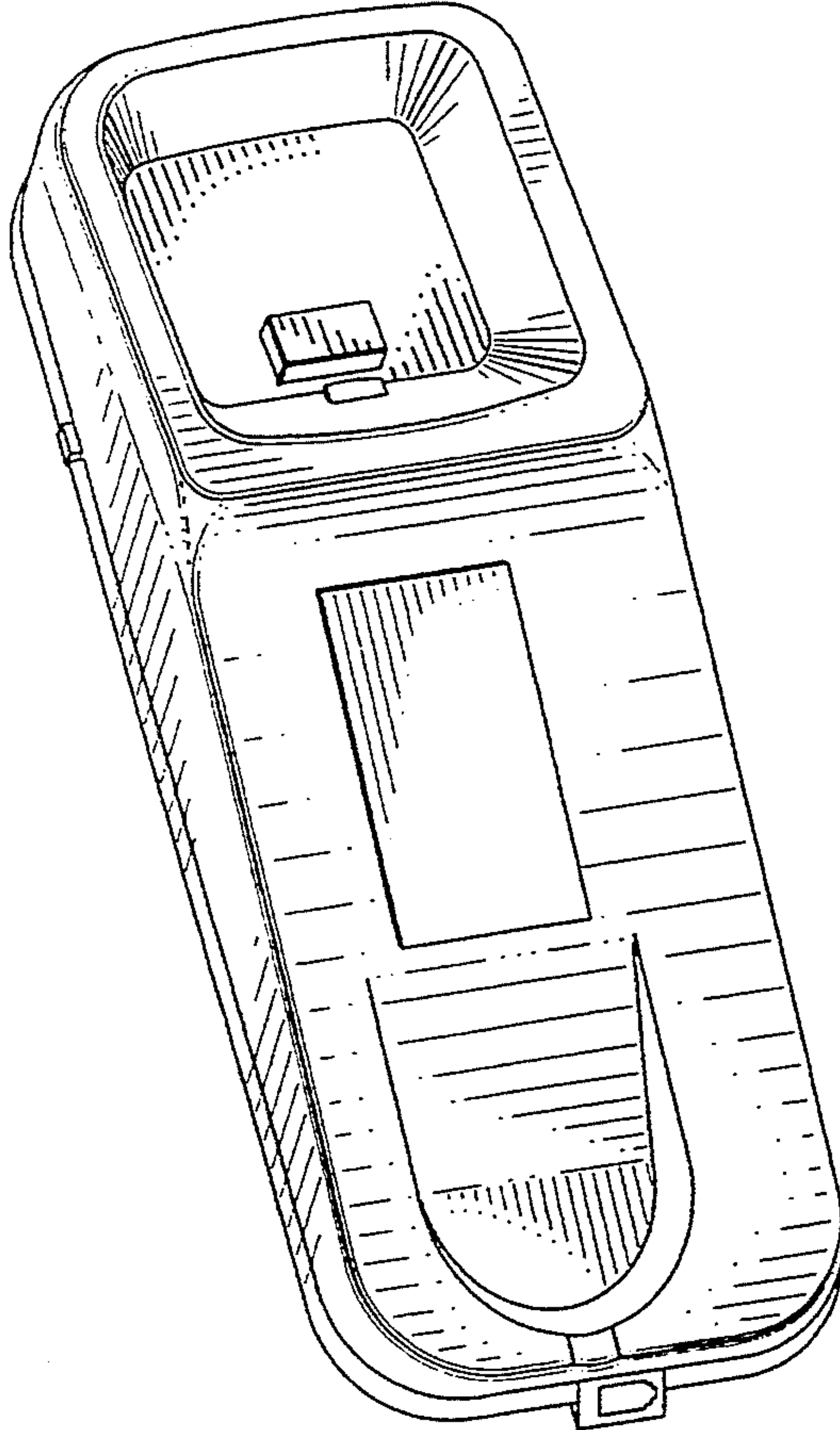

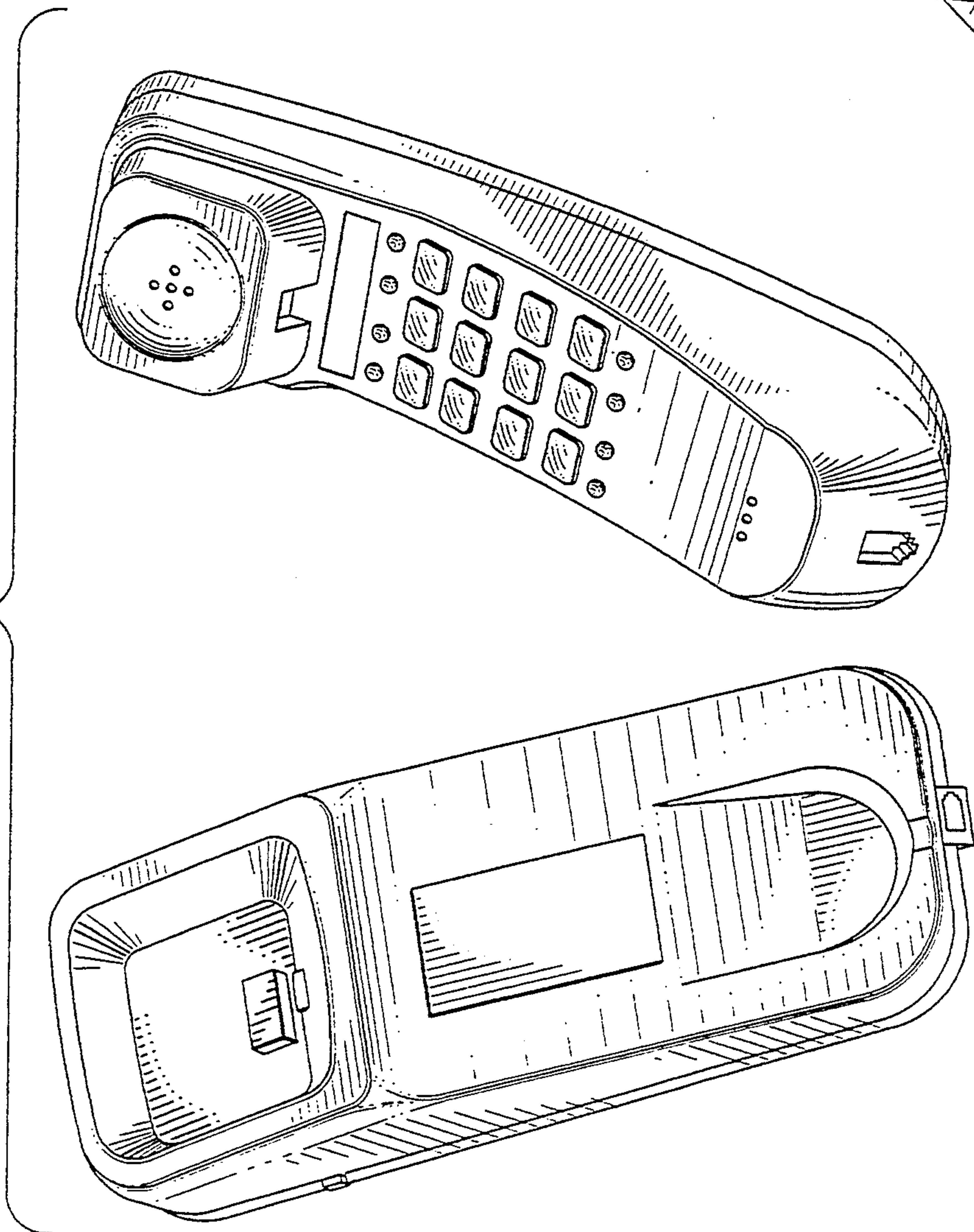
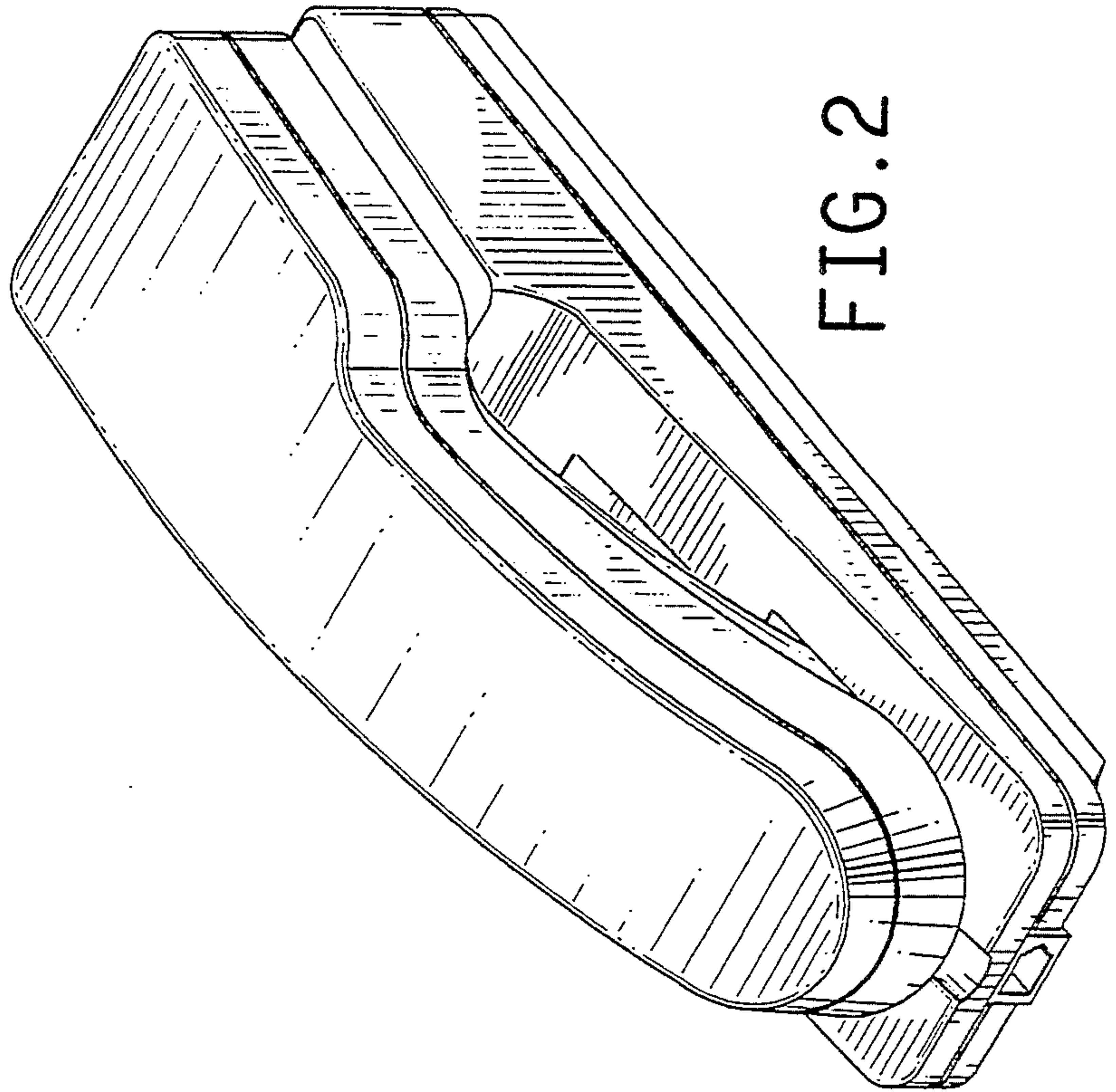

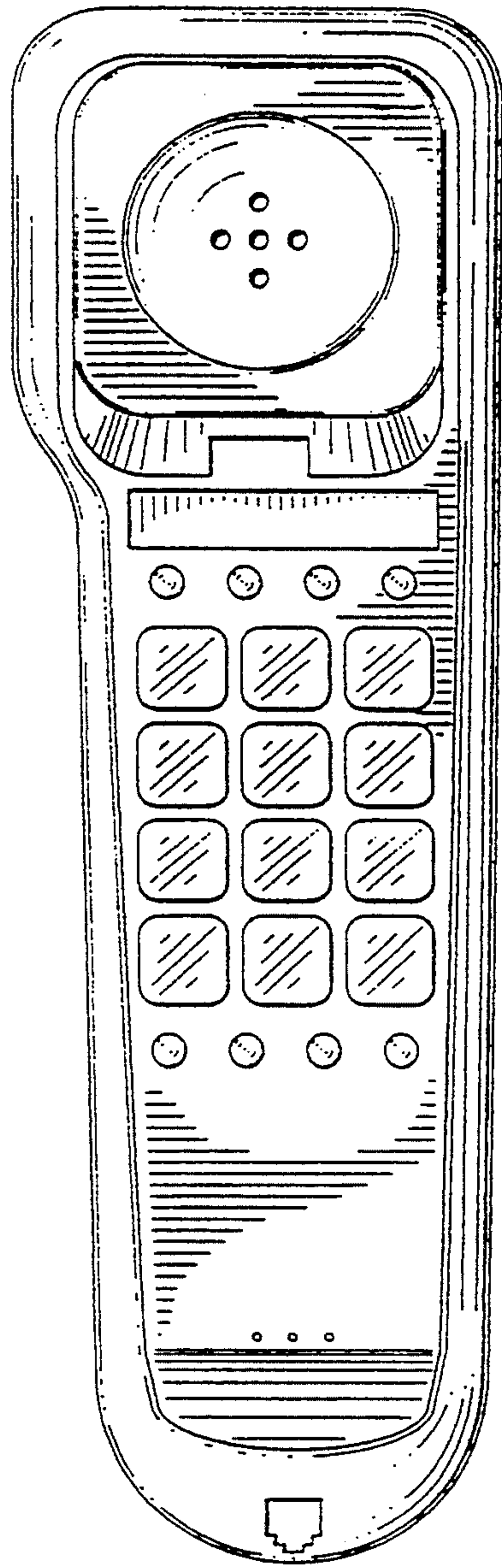

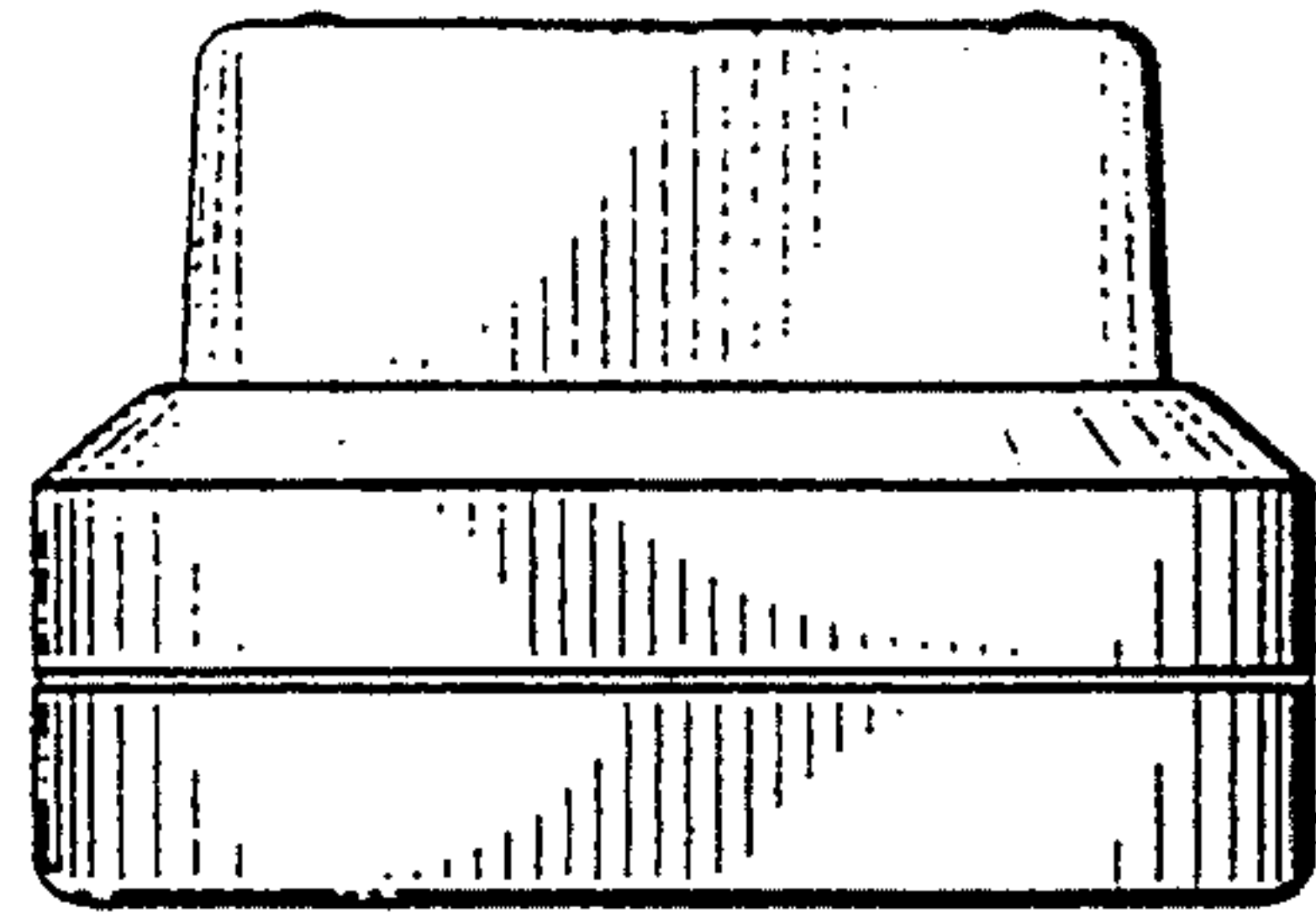

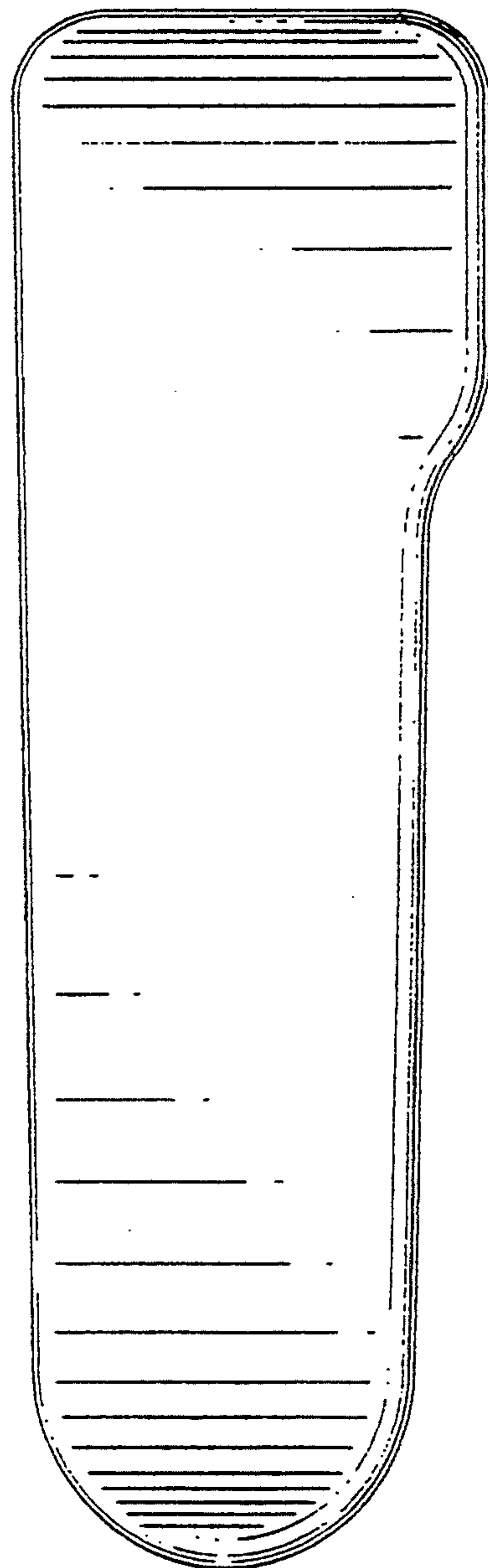

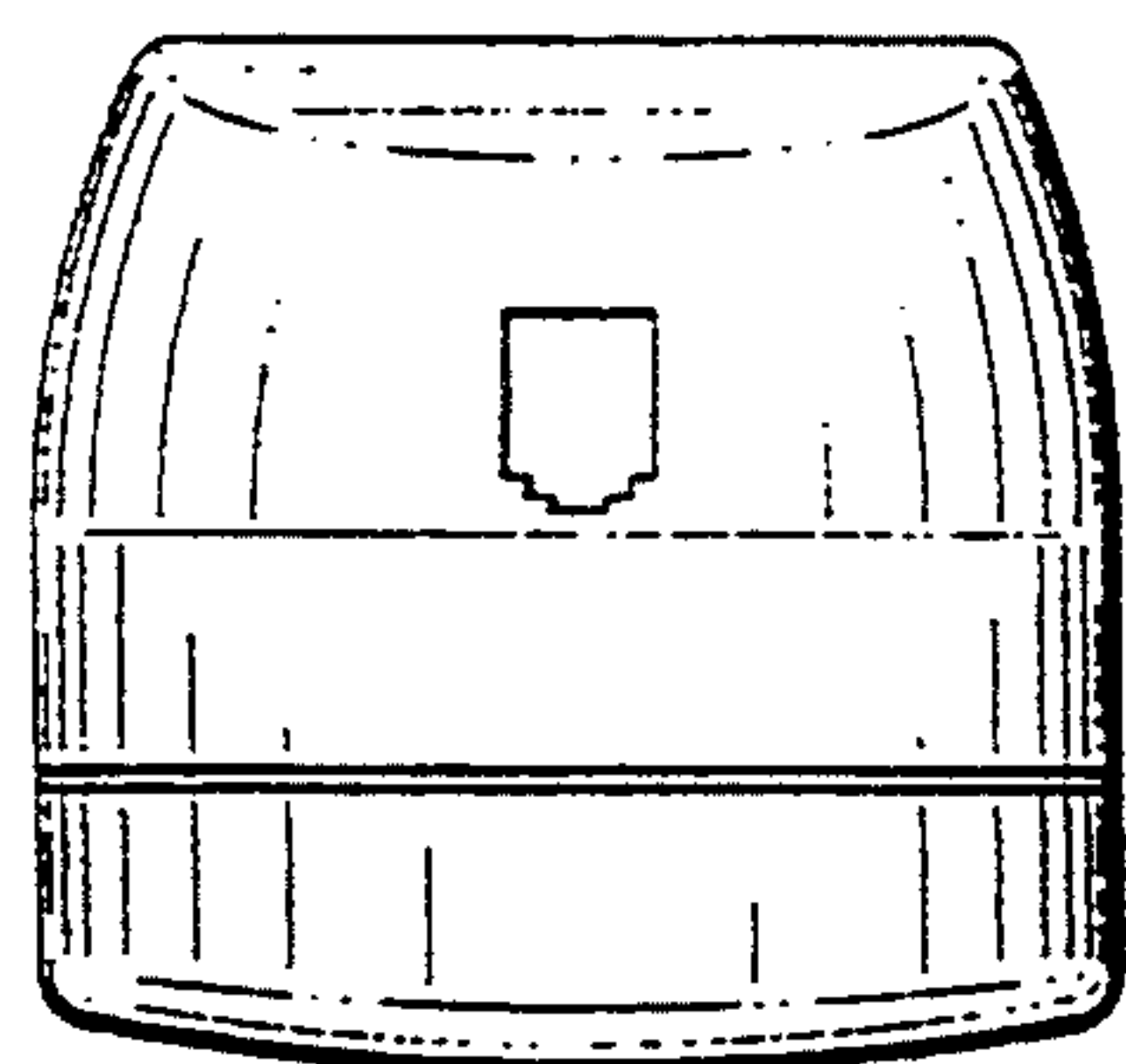

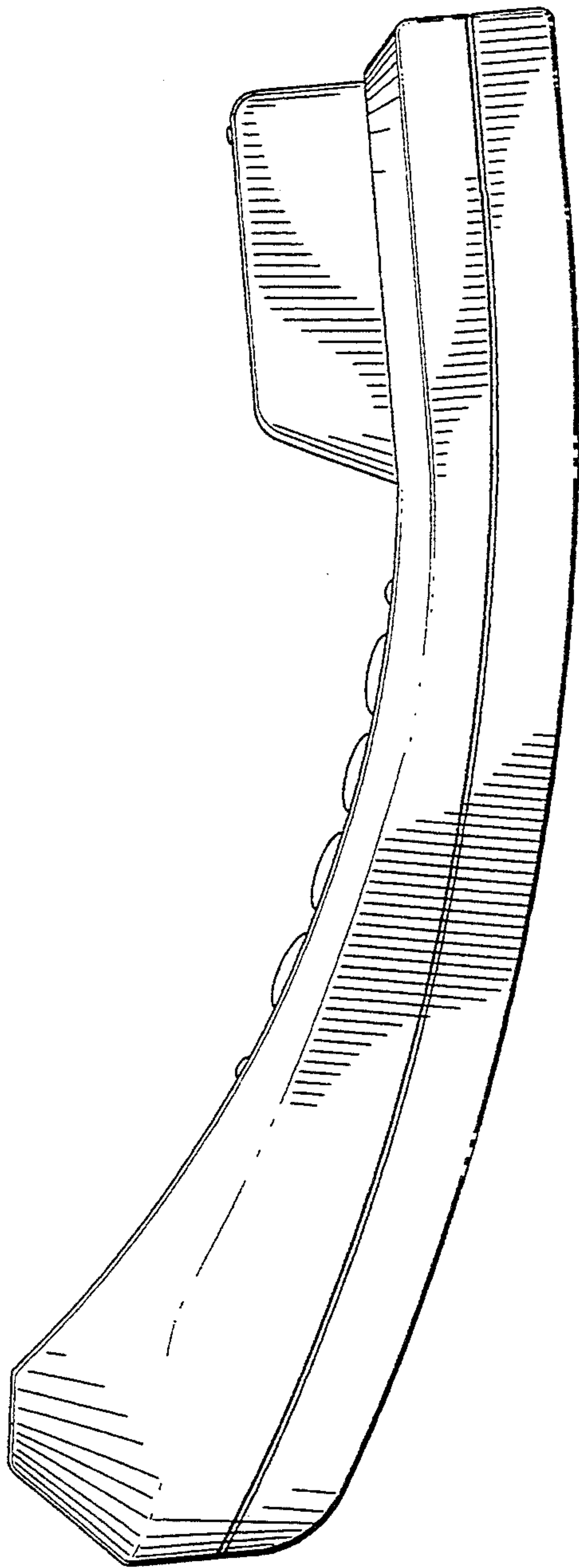

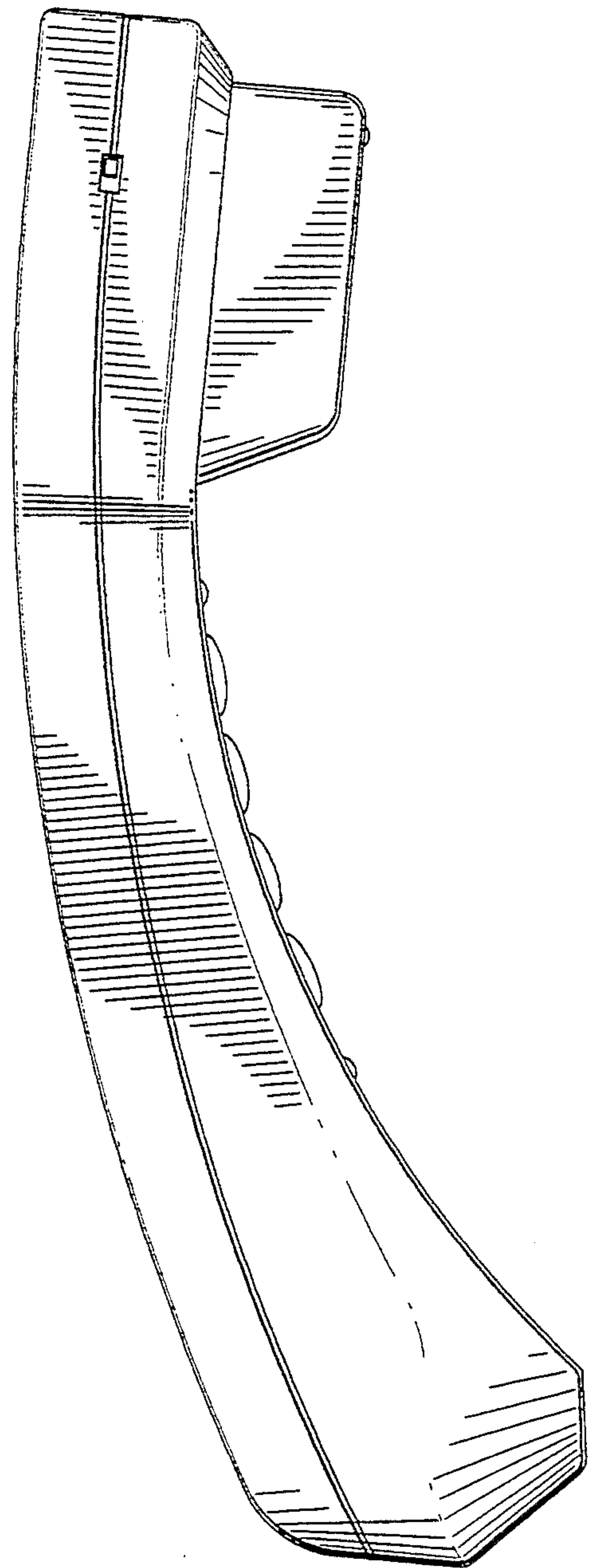

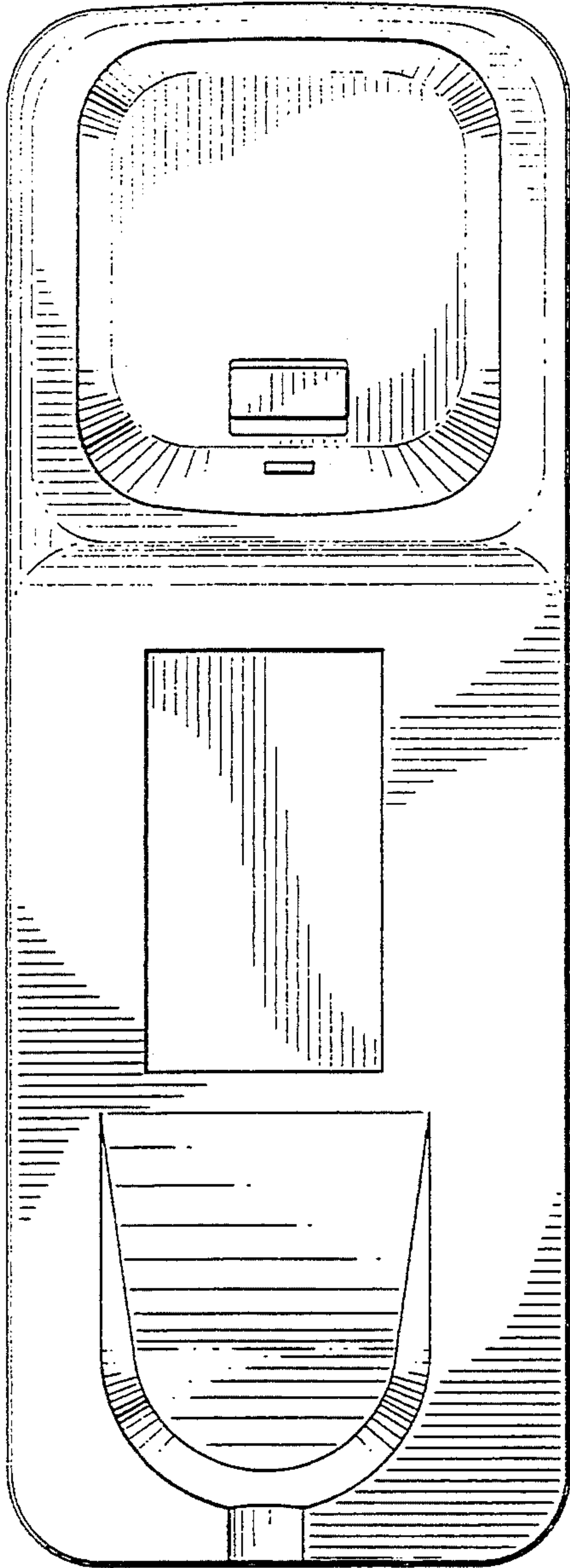

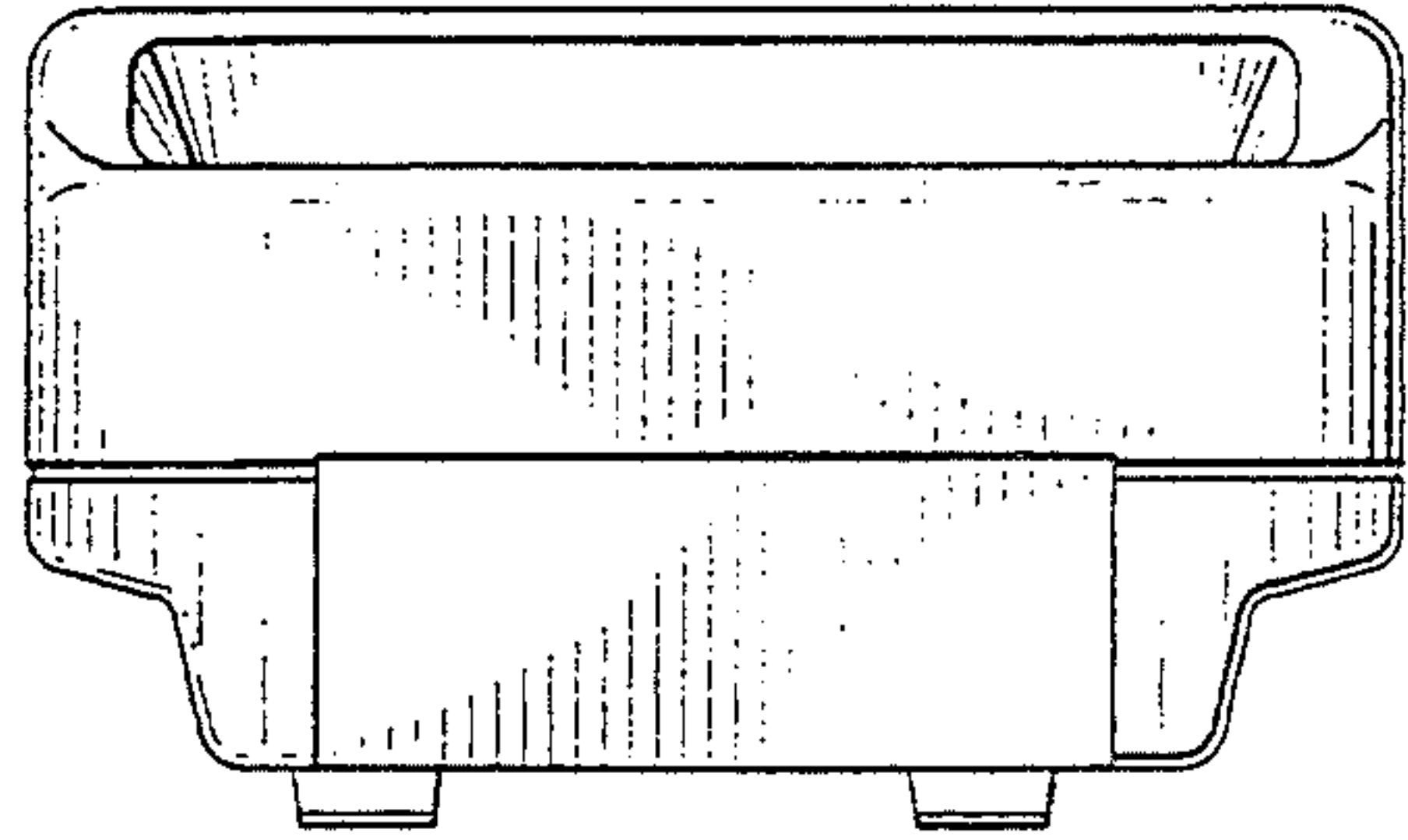

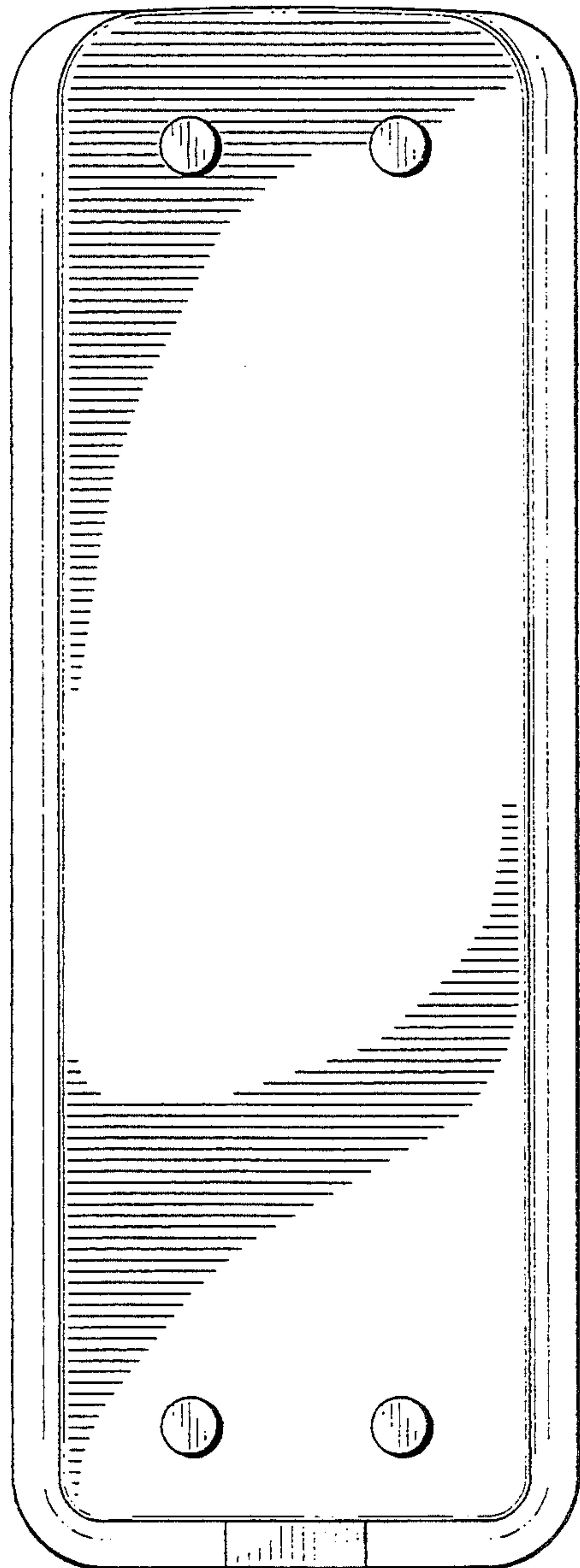

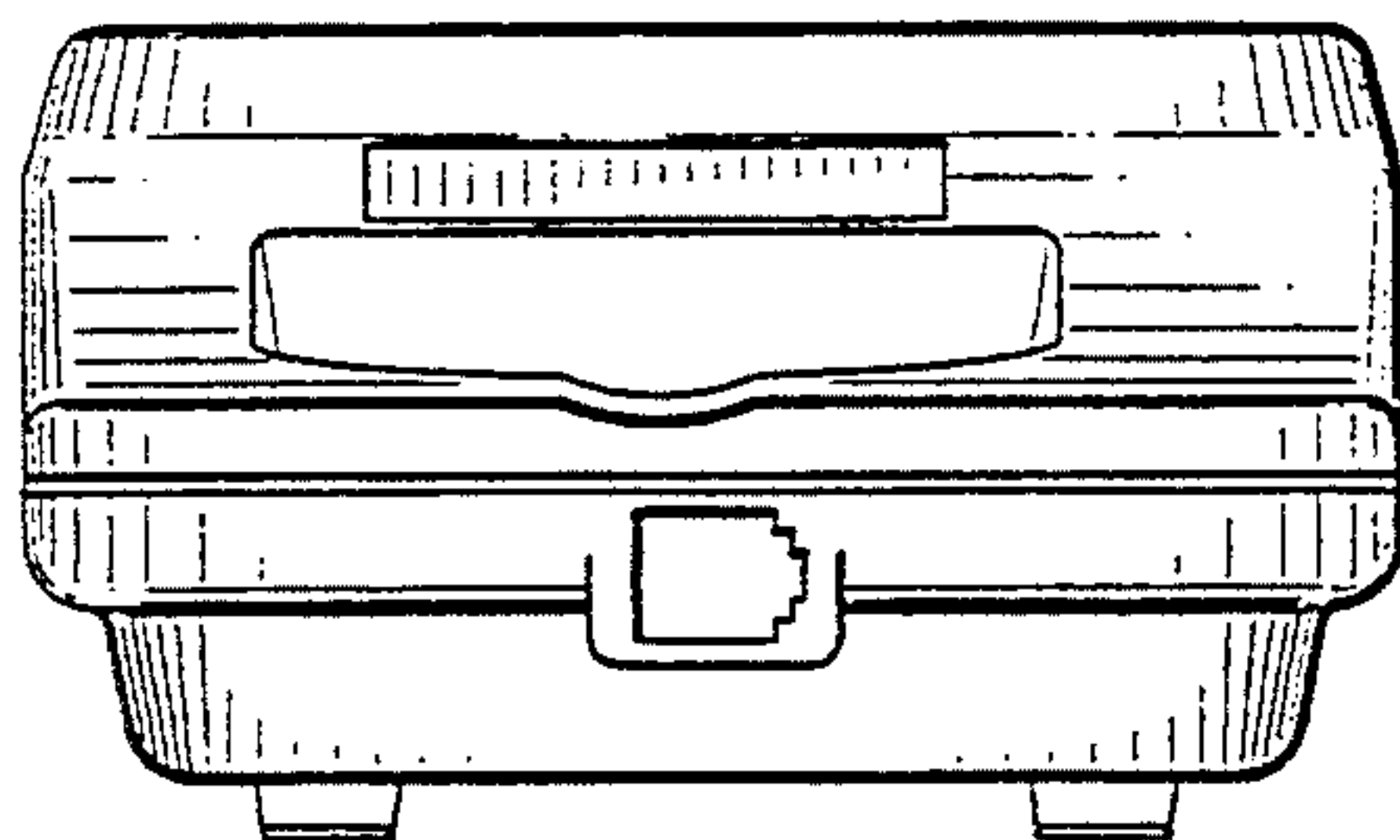

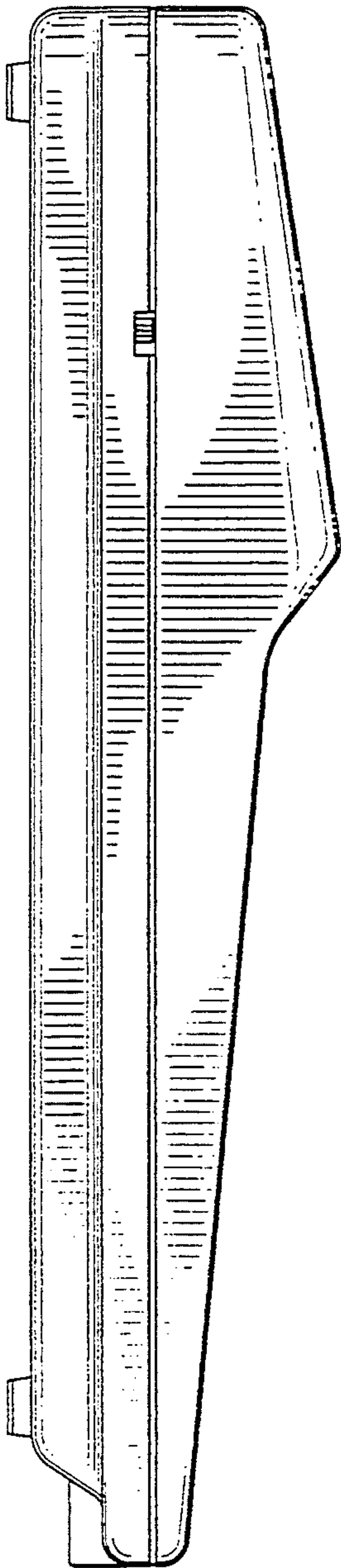

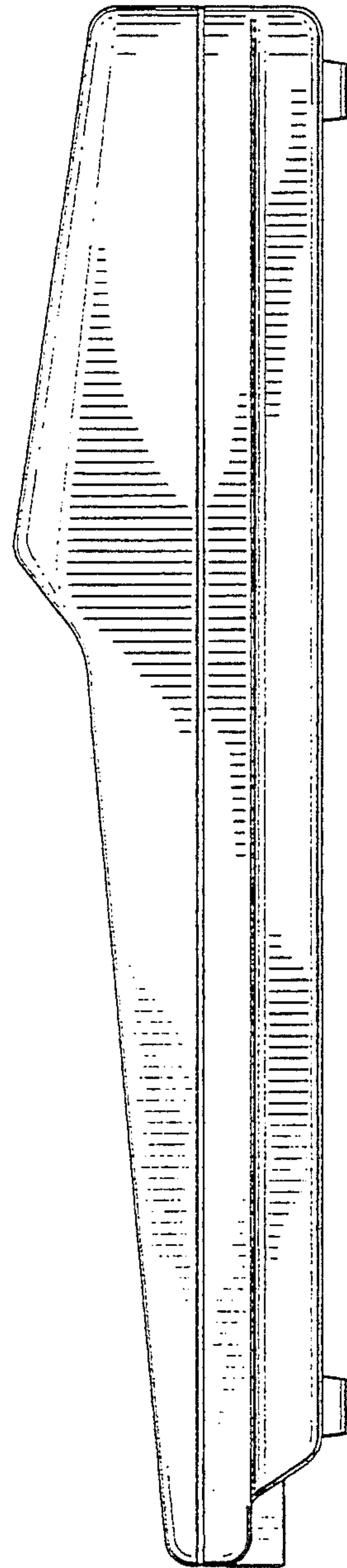
