DESCRIPTION

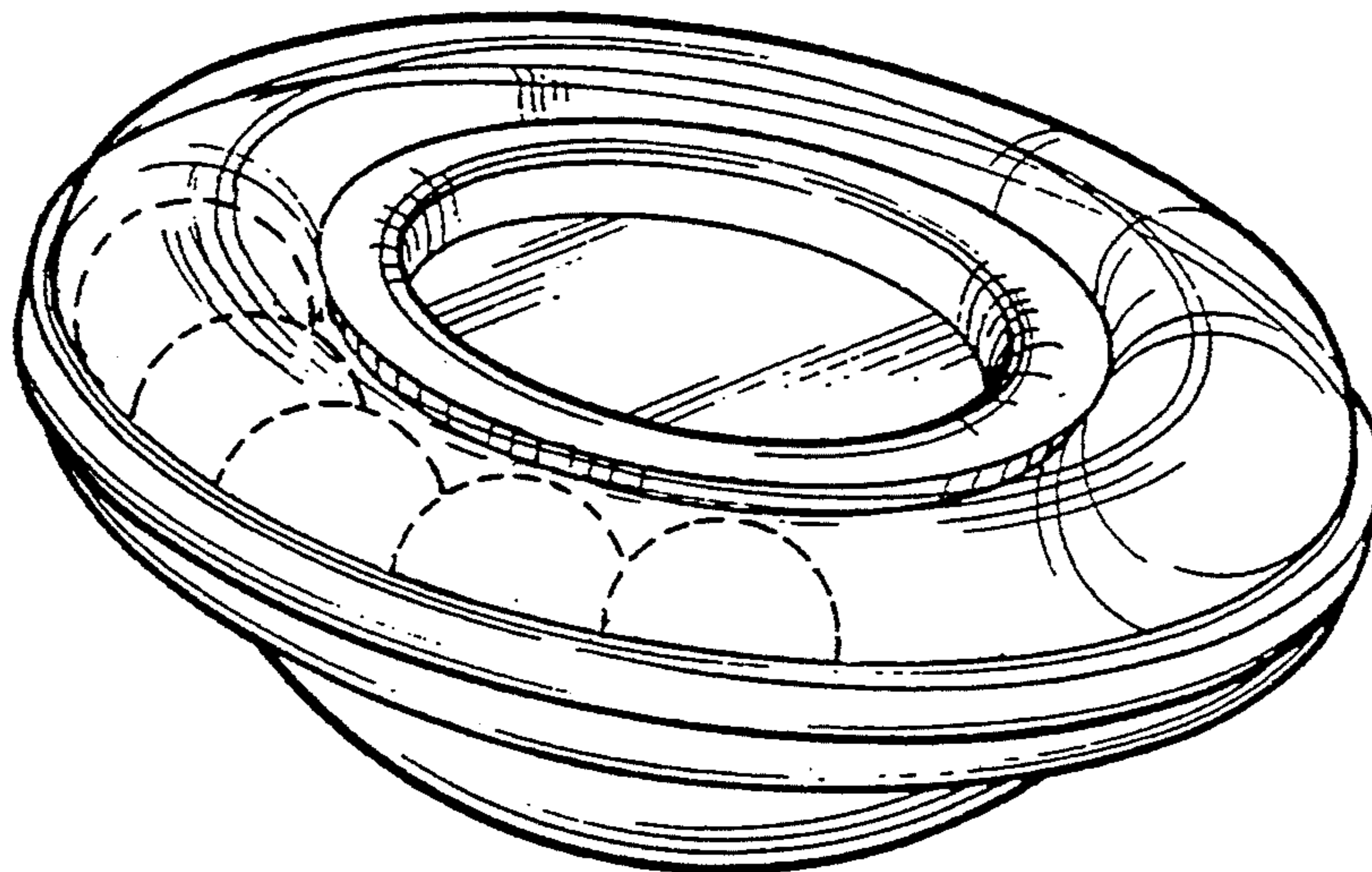
FIG. 1 is a front perspective view of a spinning toy showing my new design, the balls shown in broken lines for illustrative purposes only and from no part of the claim;

FIG. 5 is a rear elevational view thereof.



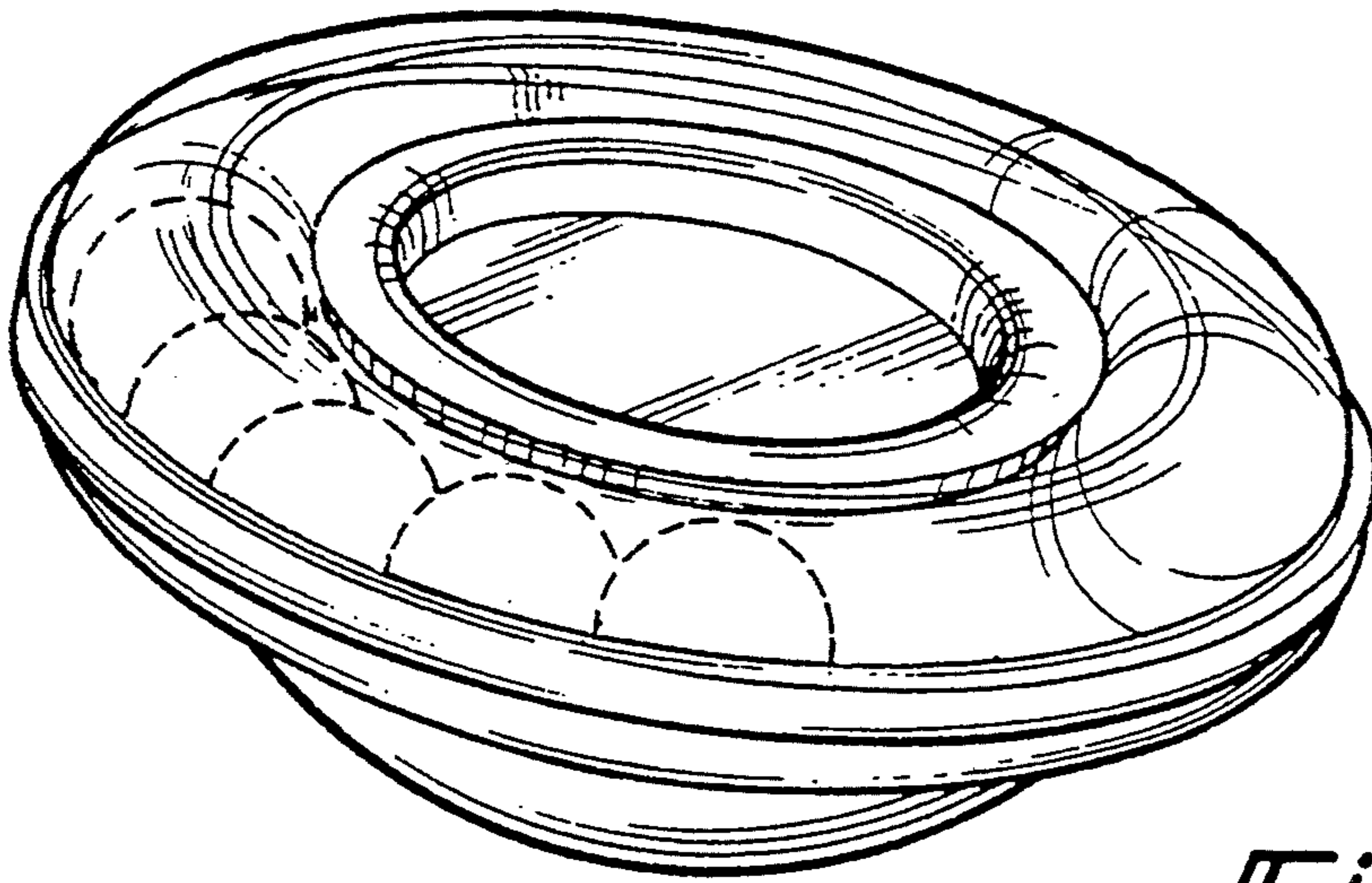

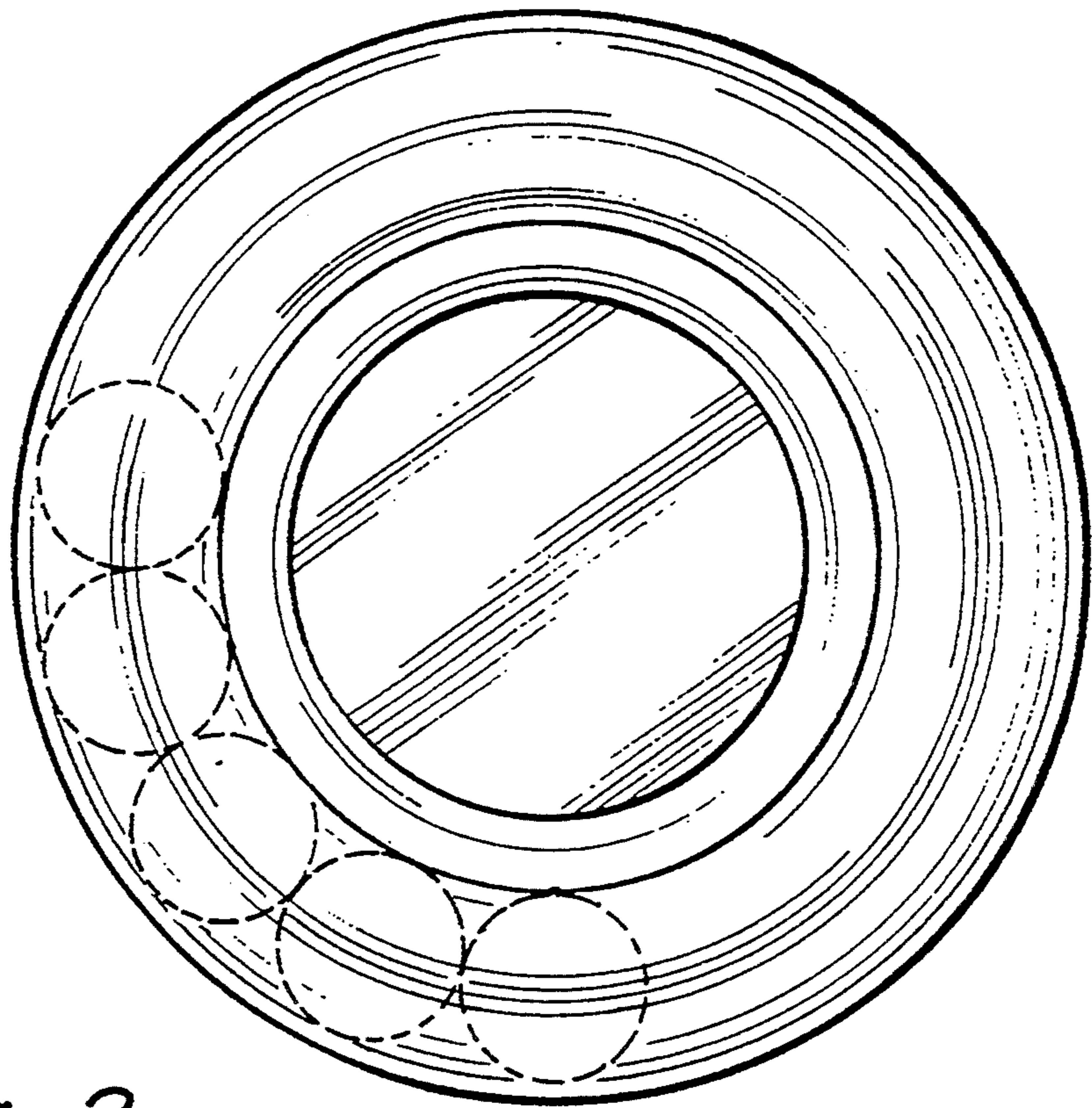

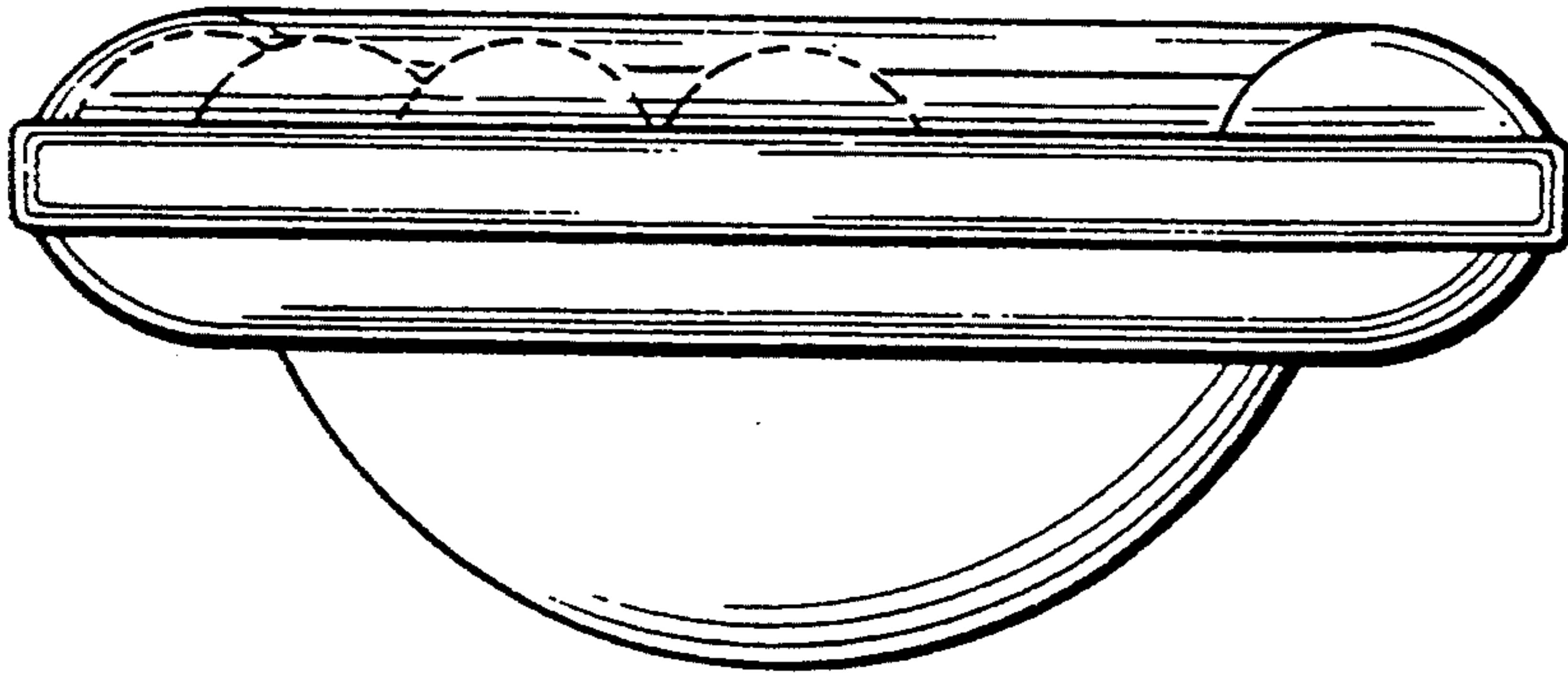

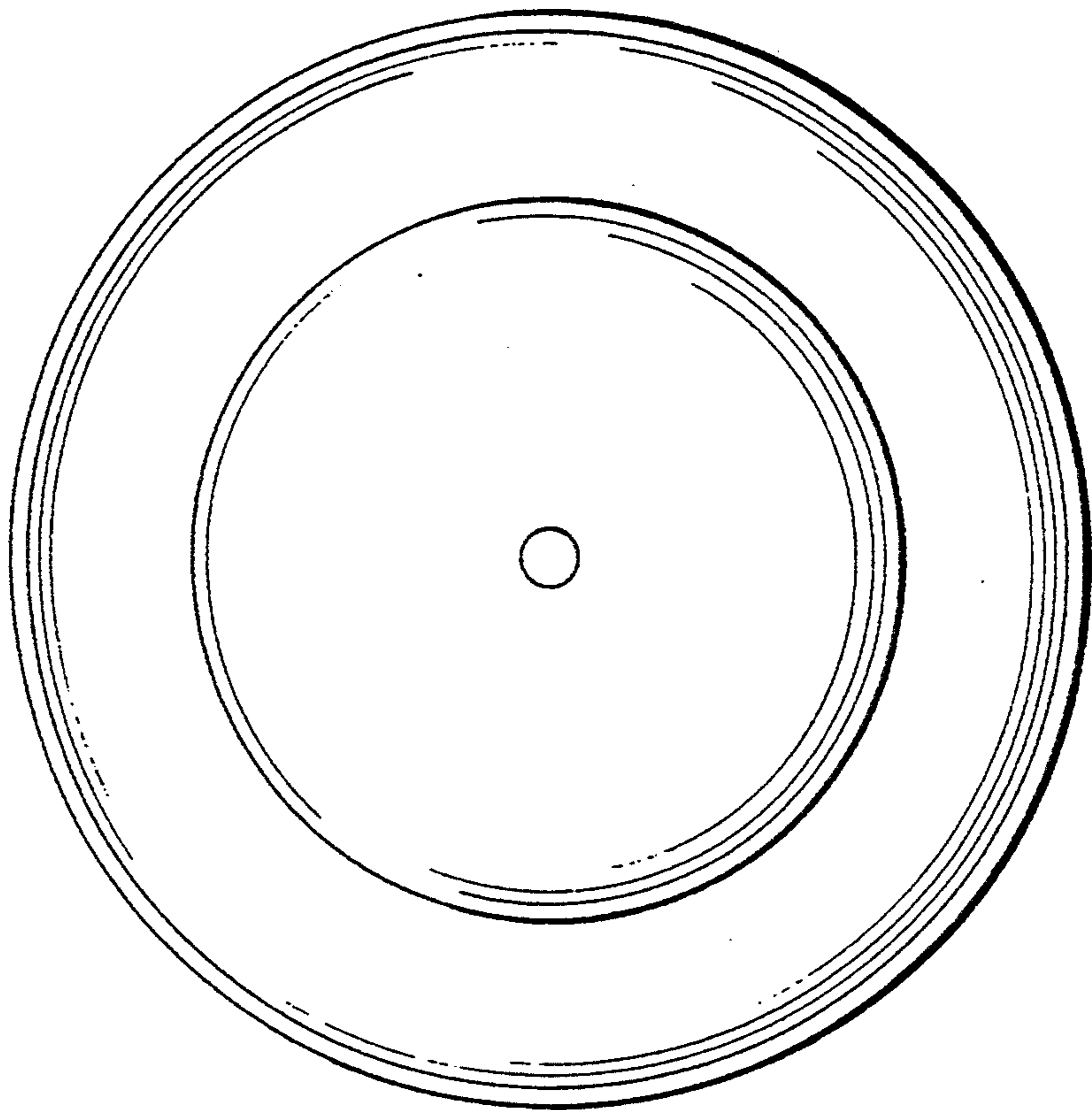

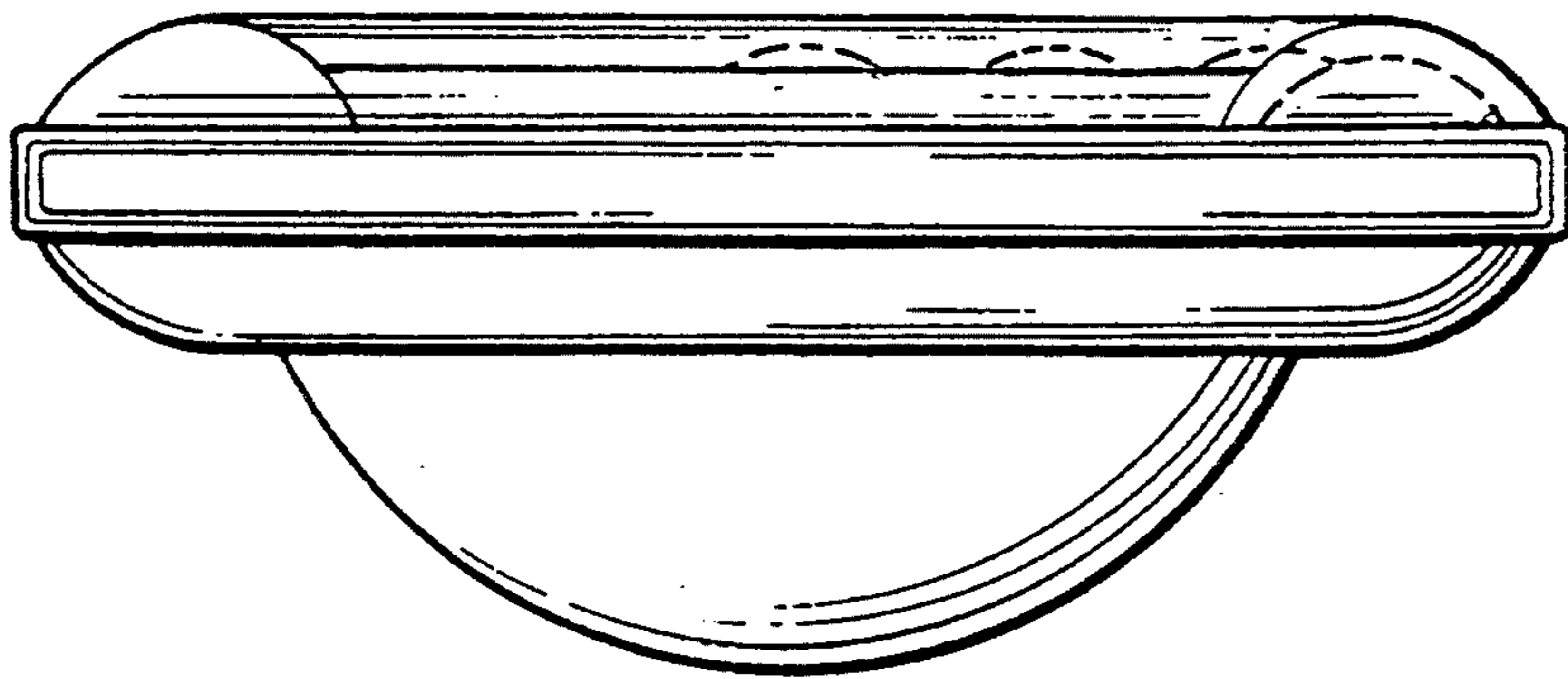
