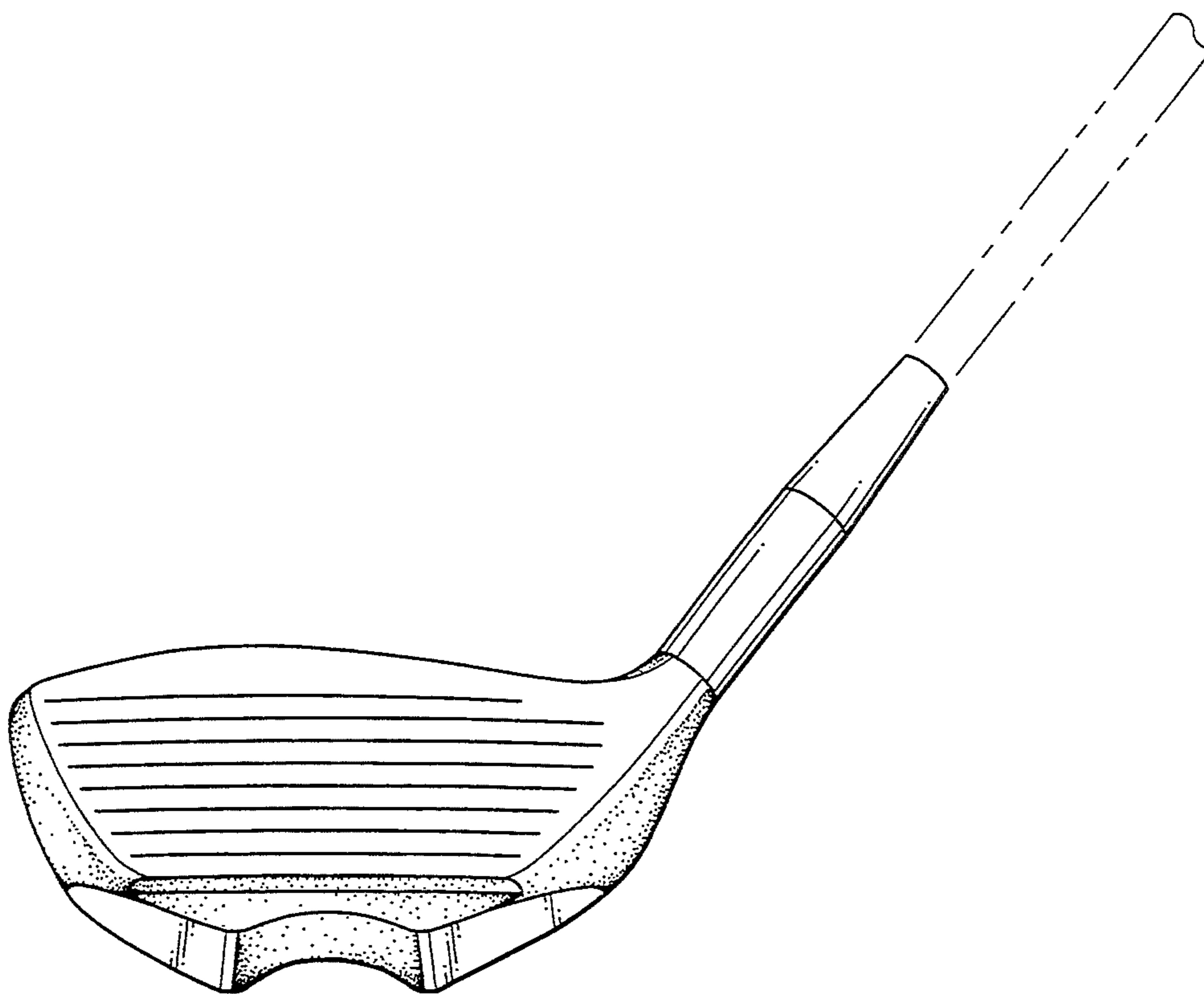

[57] **CLAIM**

The ornamental design for a golf club head, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a golf club head  
showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
The broken line showing of a fragmented shaft in FIG.  
1 is for illustrative purposes only and forms no part of  
the claimed design.



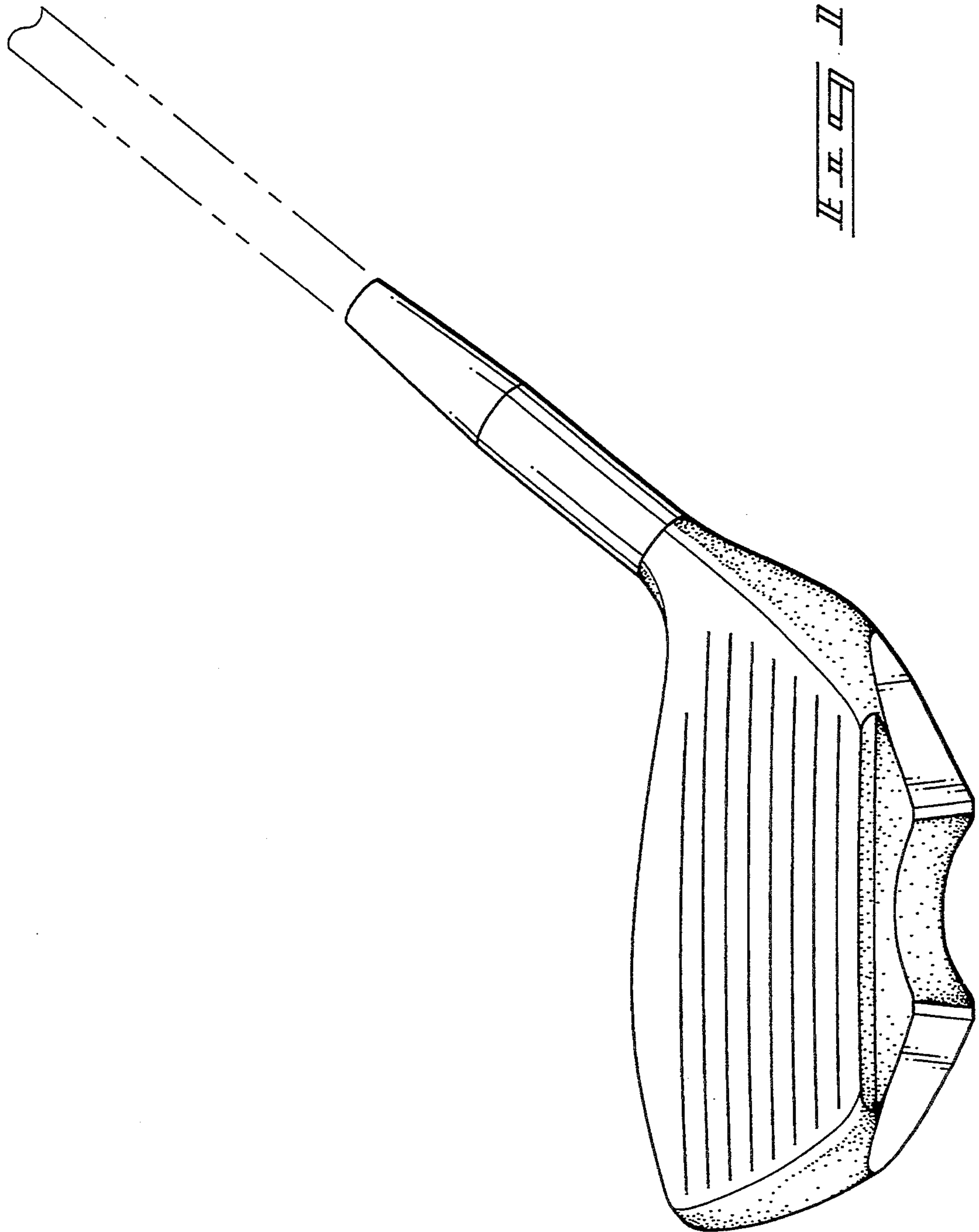
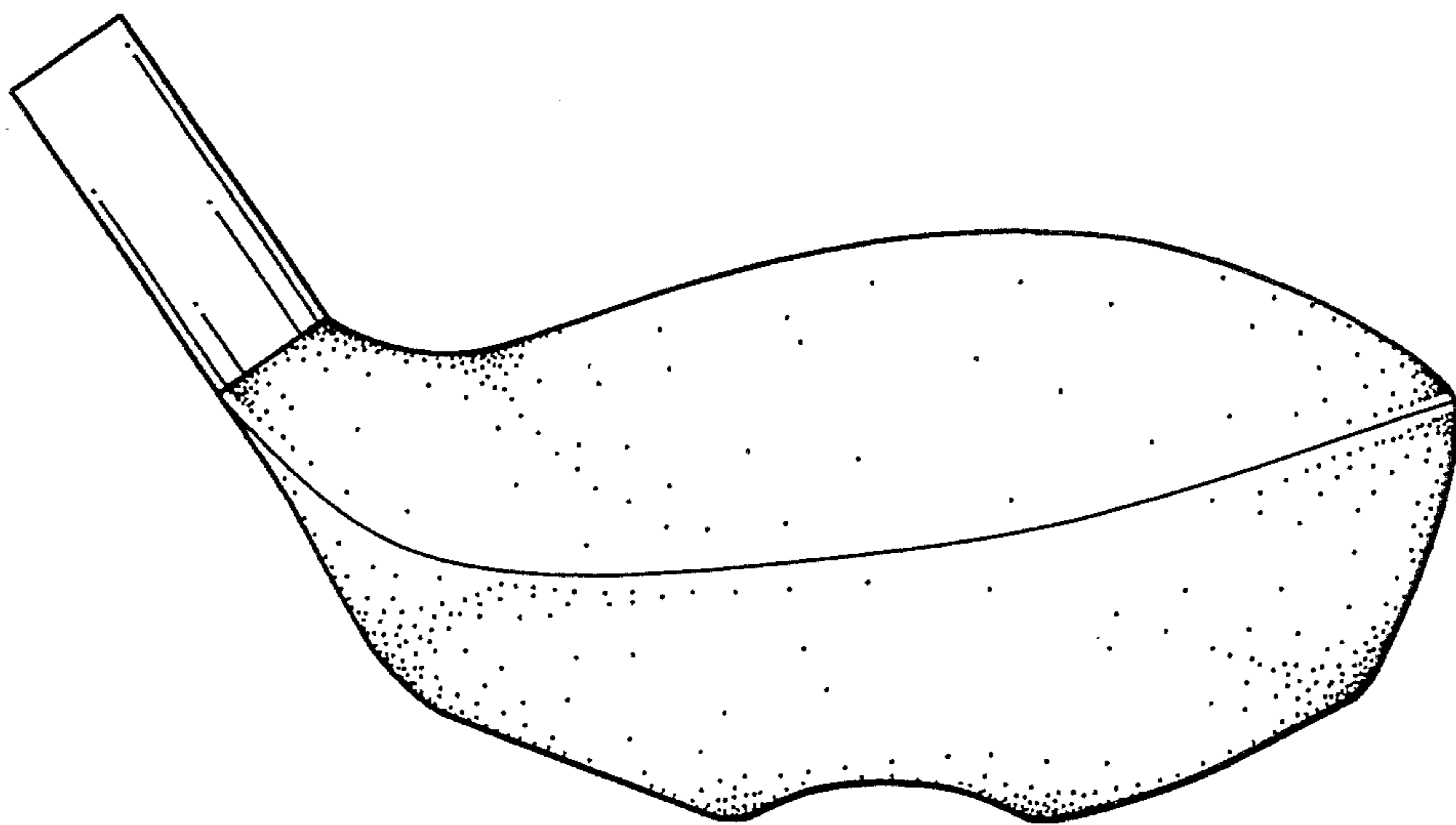
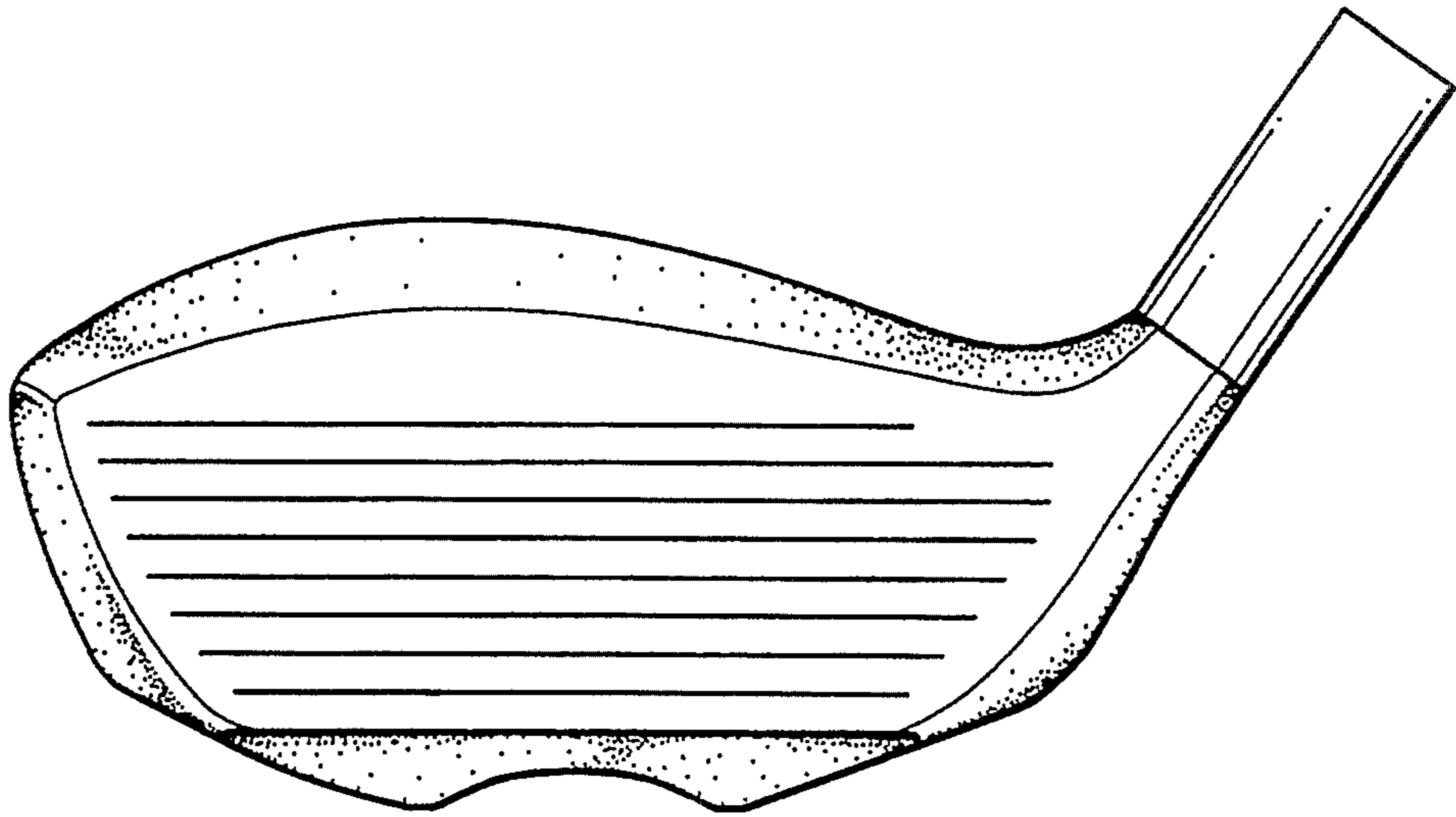

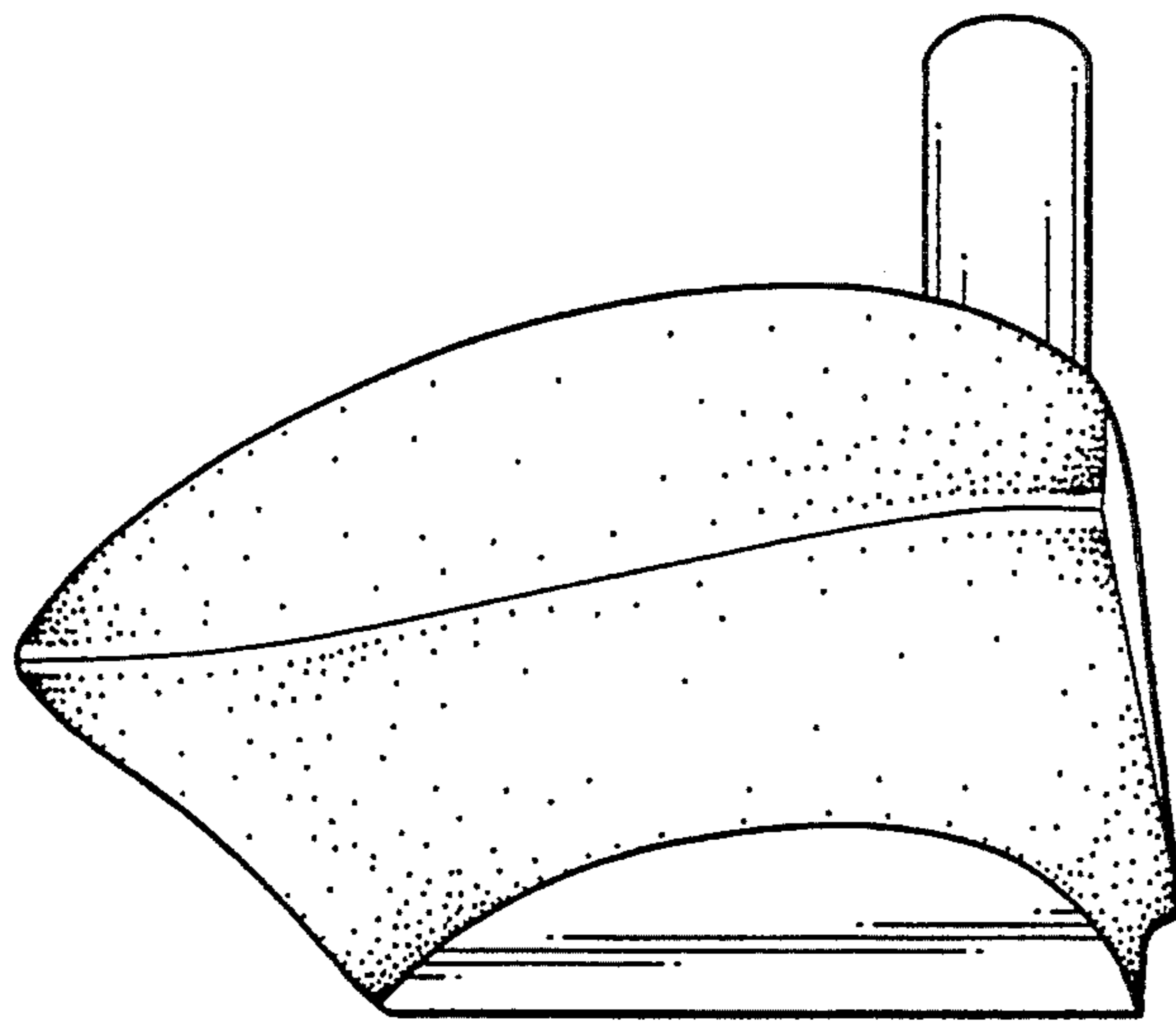

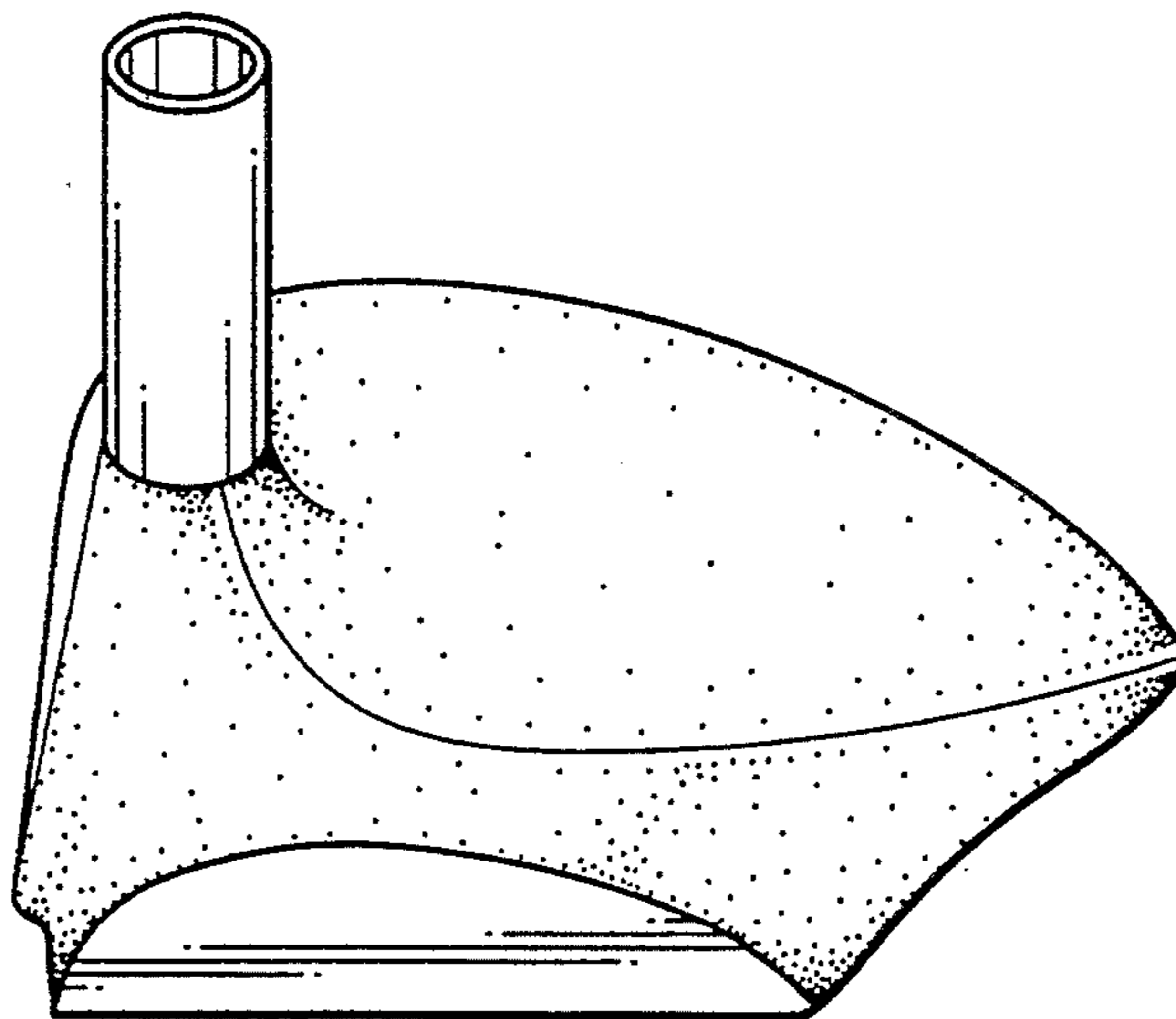

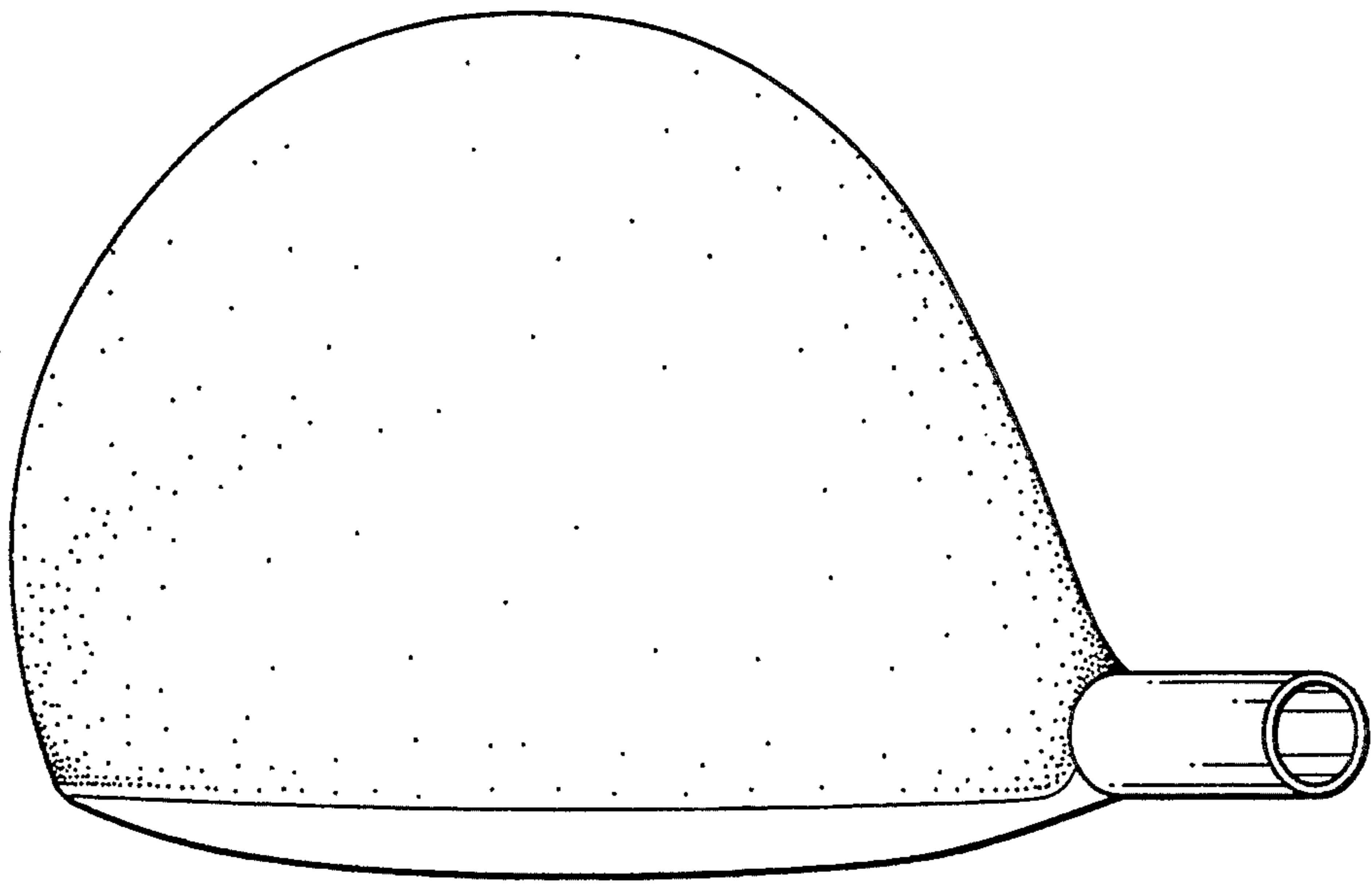

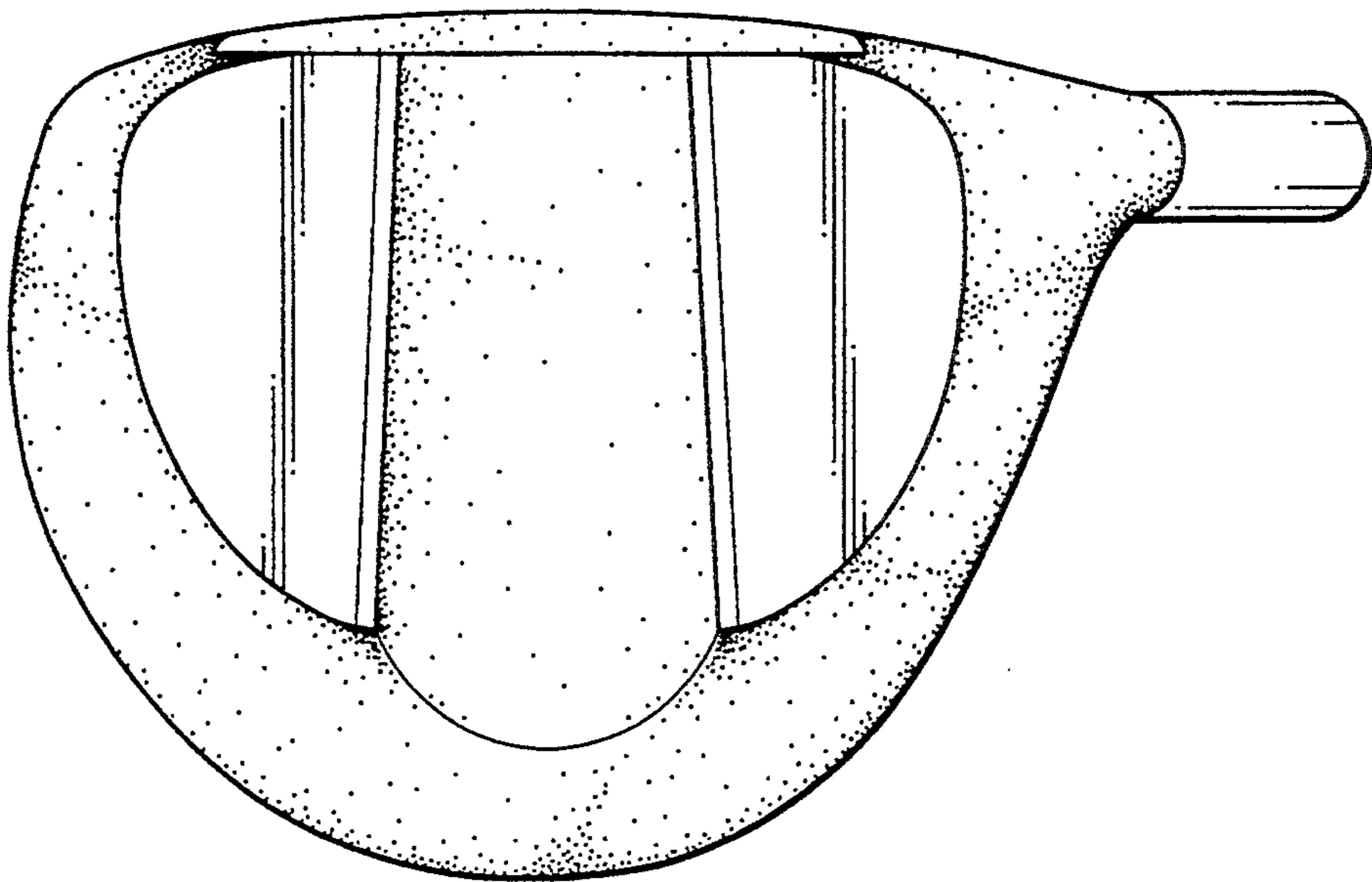
