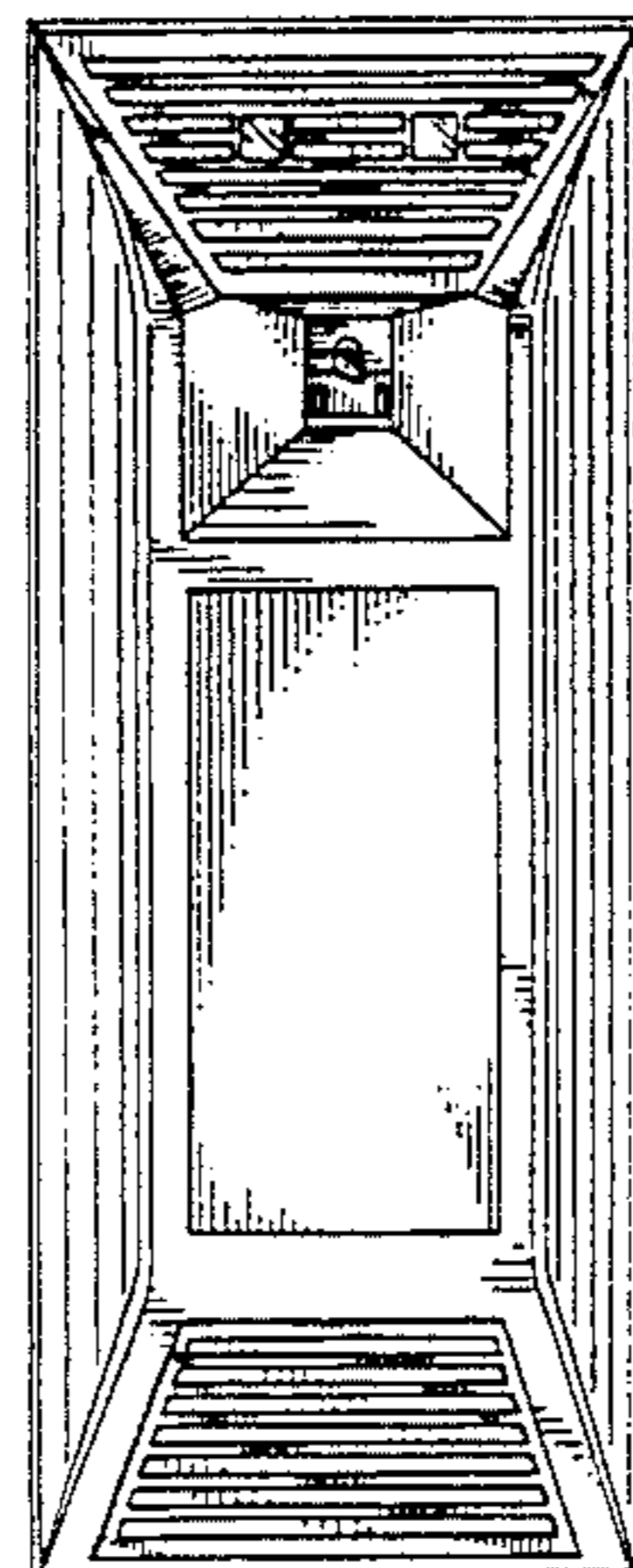
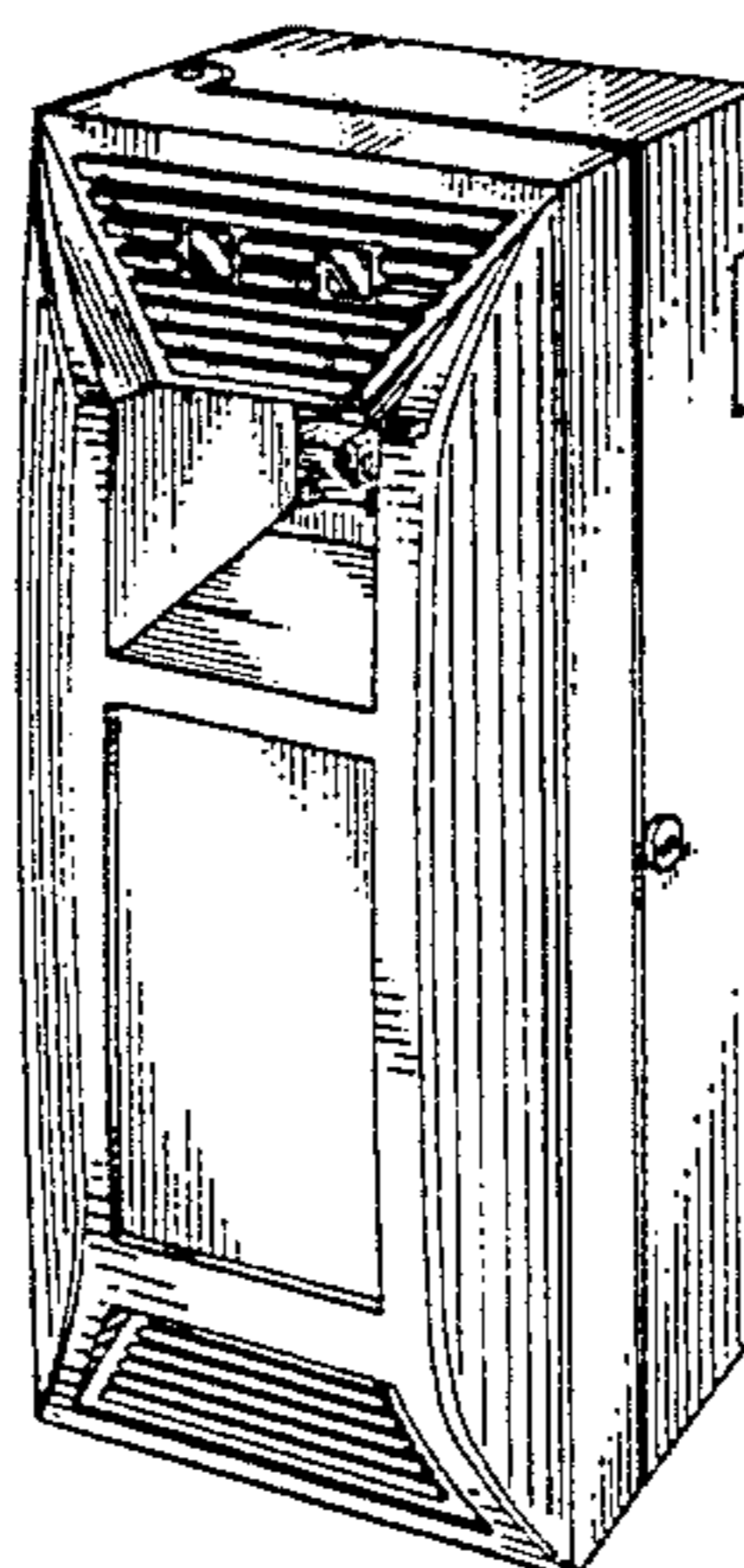

[57] **CLAIM**

The ornamental design for an aerosol dispensing cabinet, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an aerosol dispensing cabinet according to the invention;  
FIG. 2 is a front elevation of the cabinet of FIG. 1;  
FIG. 3 is a right side elevation of the cabinet of FIG. 1;  
FIG. 4 is a rear elevation of the cabinet of FIG. 1;  
FIG. 5 is a left side elevation of the cabinet of FIG. 1;  
FIG. 6 is a top plan view of the cabinet of FIG. 1;  
FIG. 7 is a bottom plan view of the cabinet of FIG. 1;  
and  
FIG. 8 is a perspective view of the interior of the cabinet of FIG. 1. The cabinet is opened periodically when it is used.

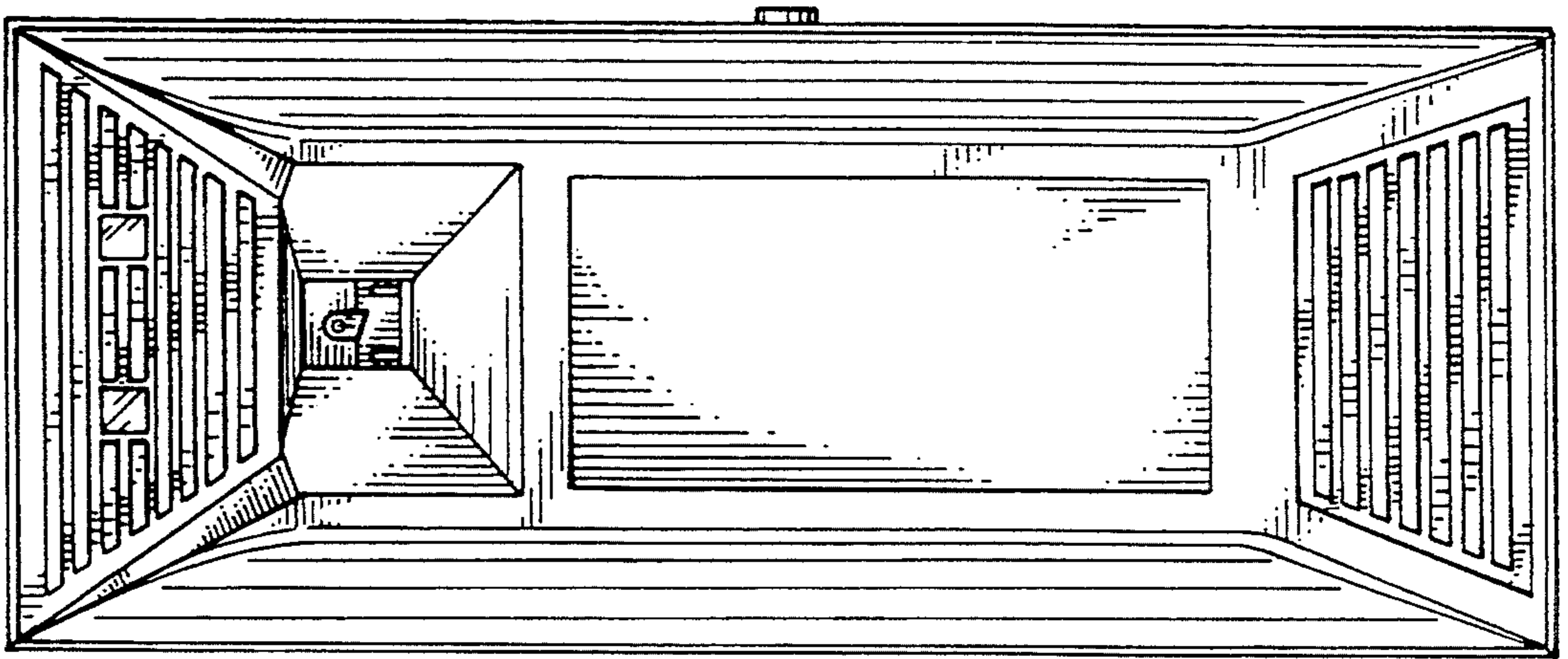

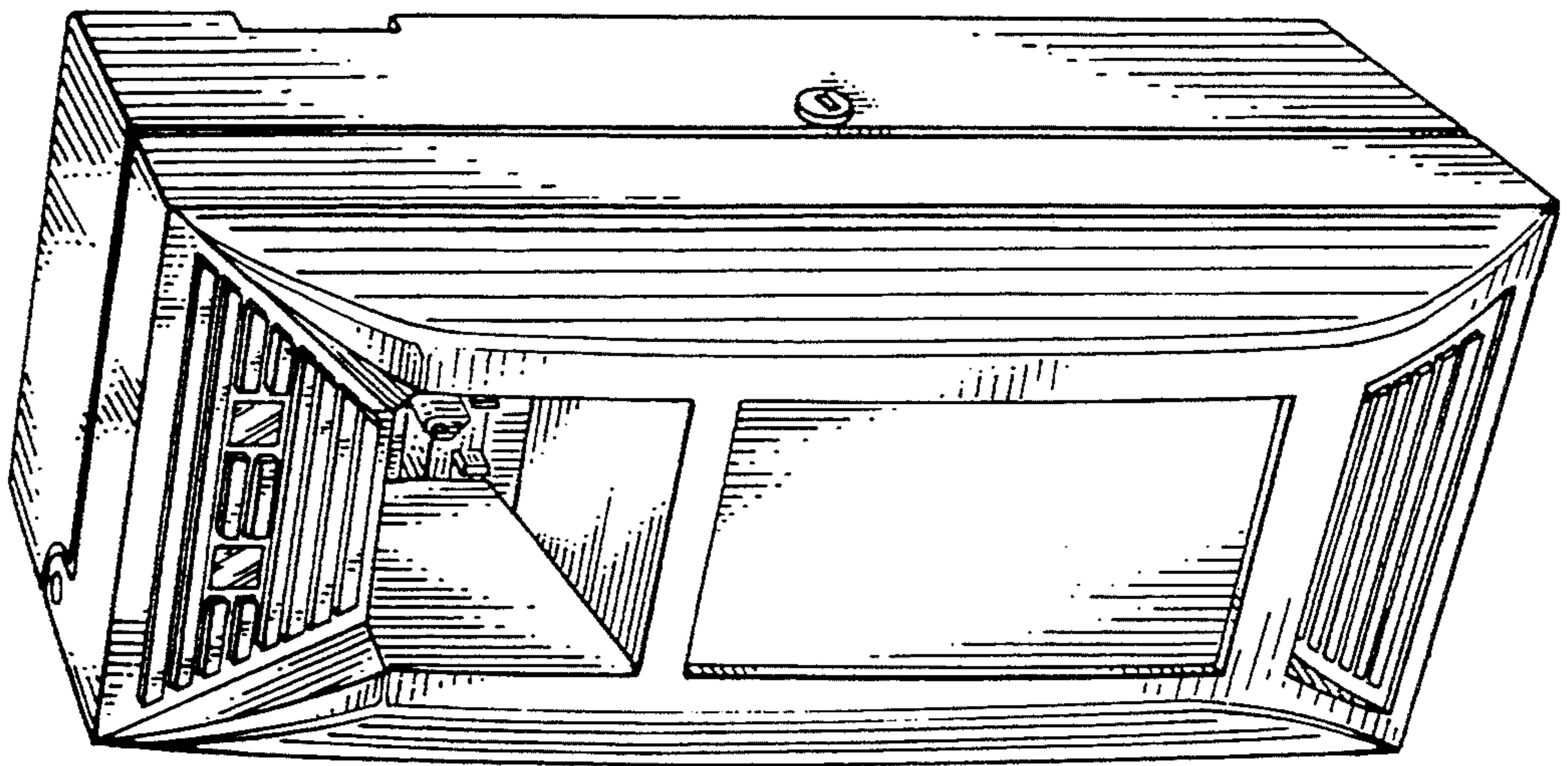

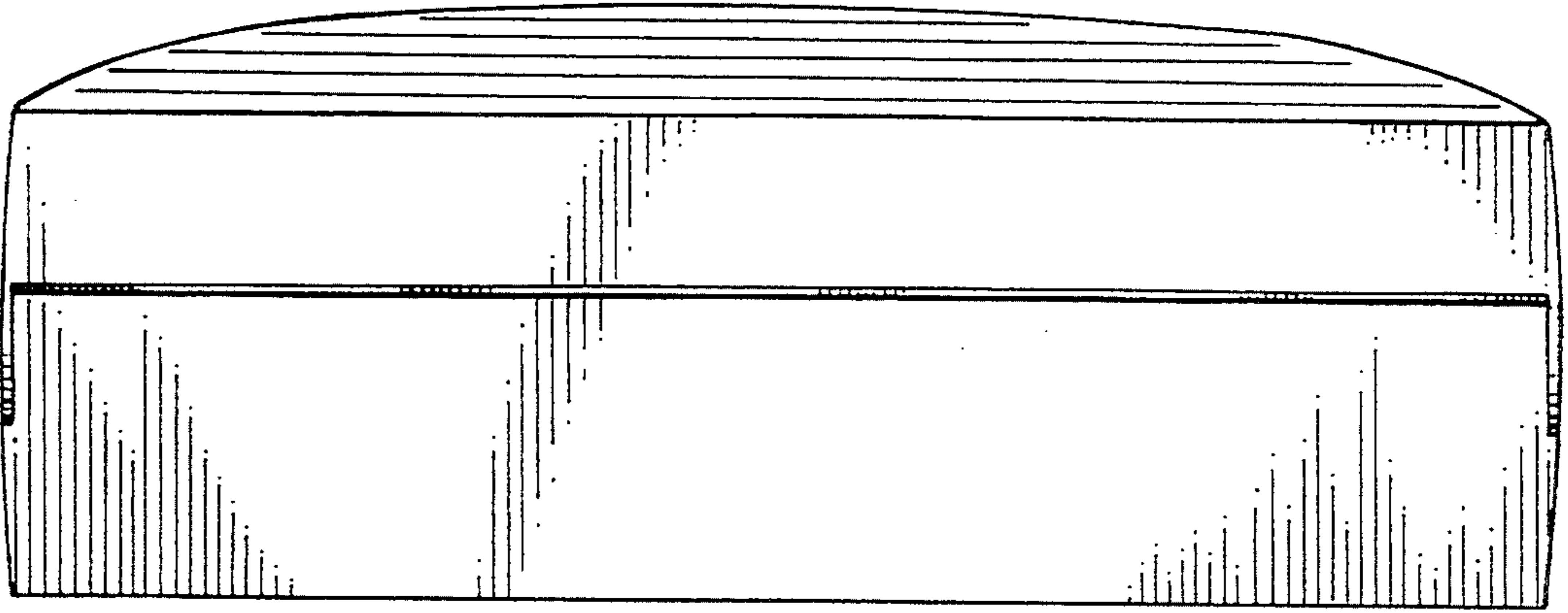

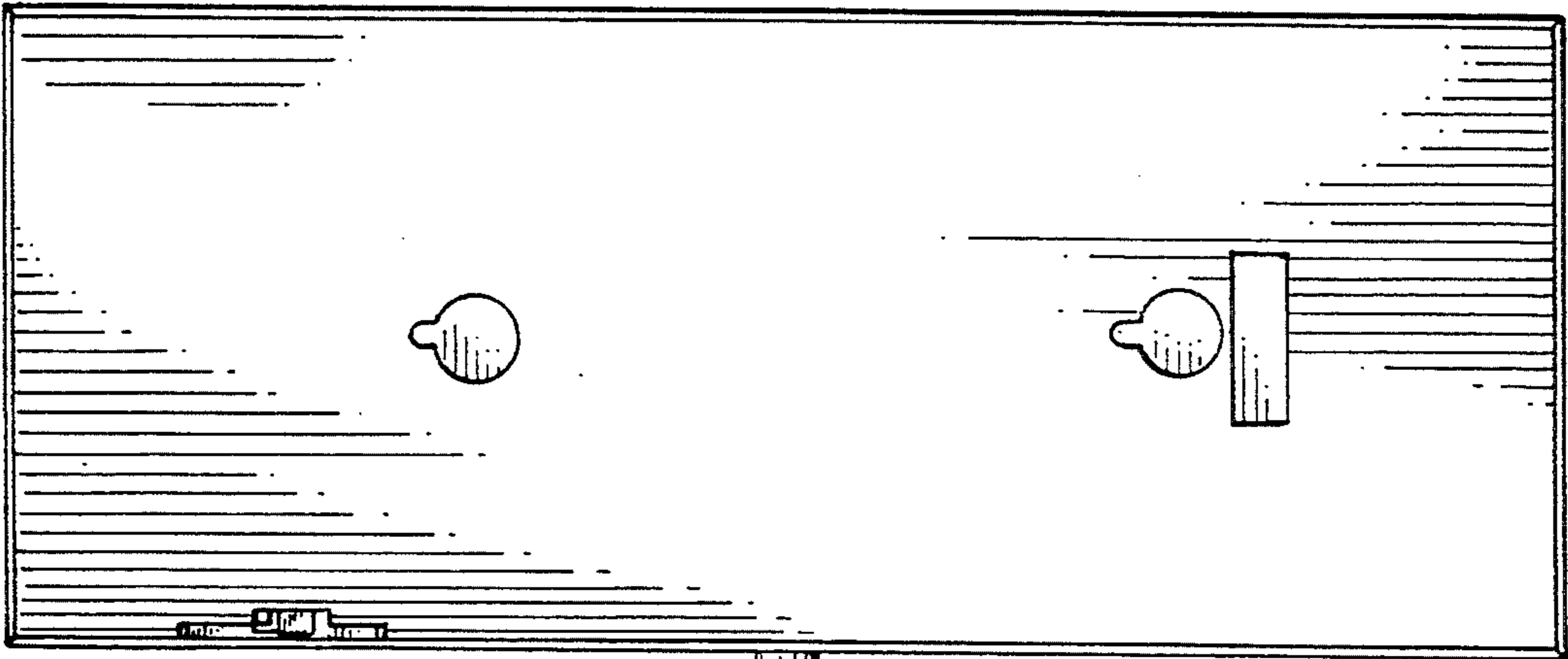
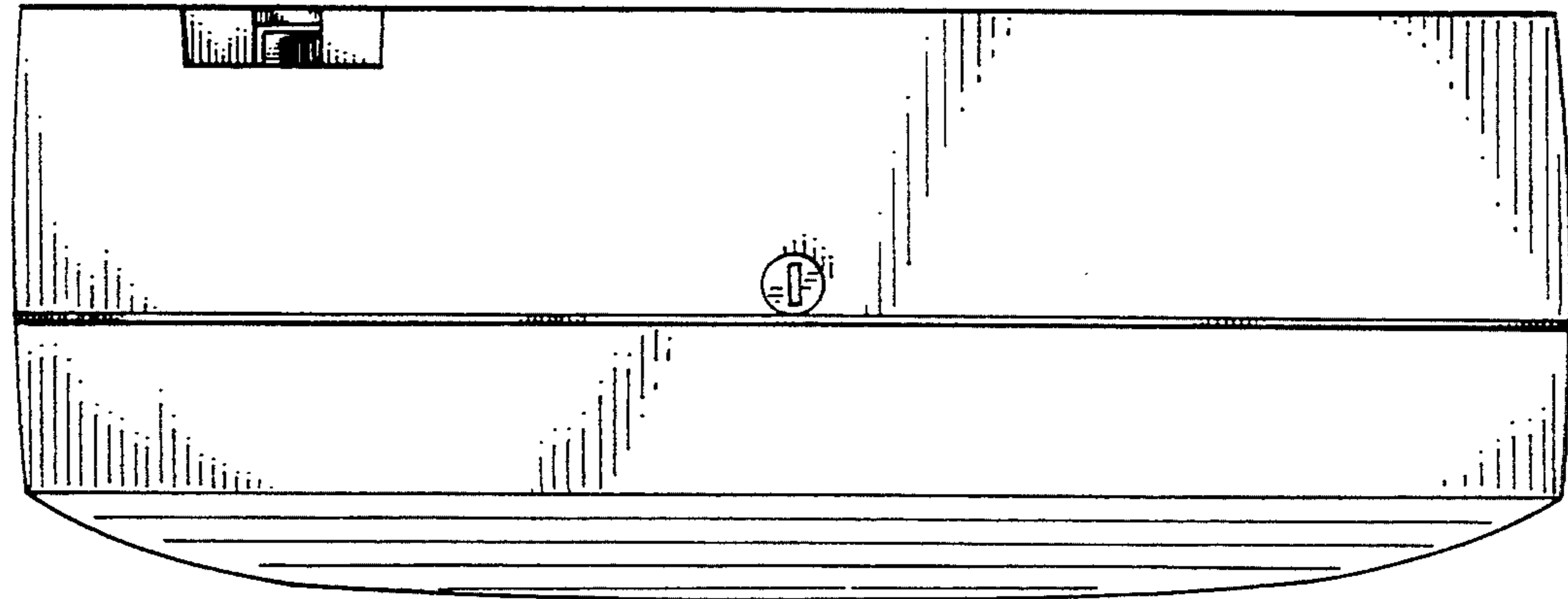
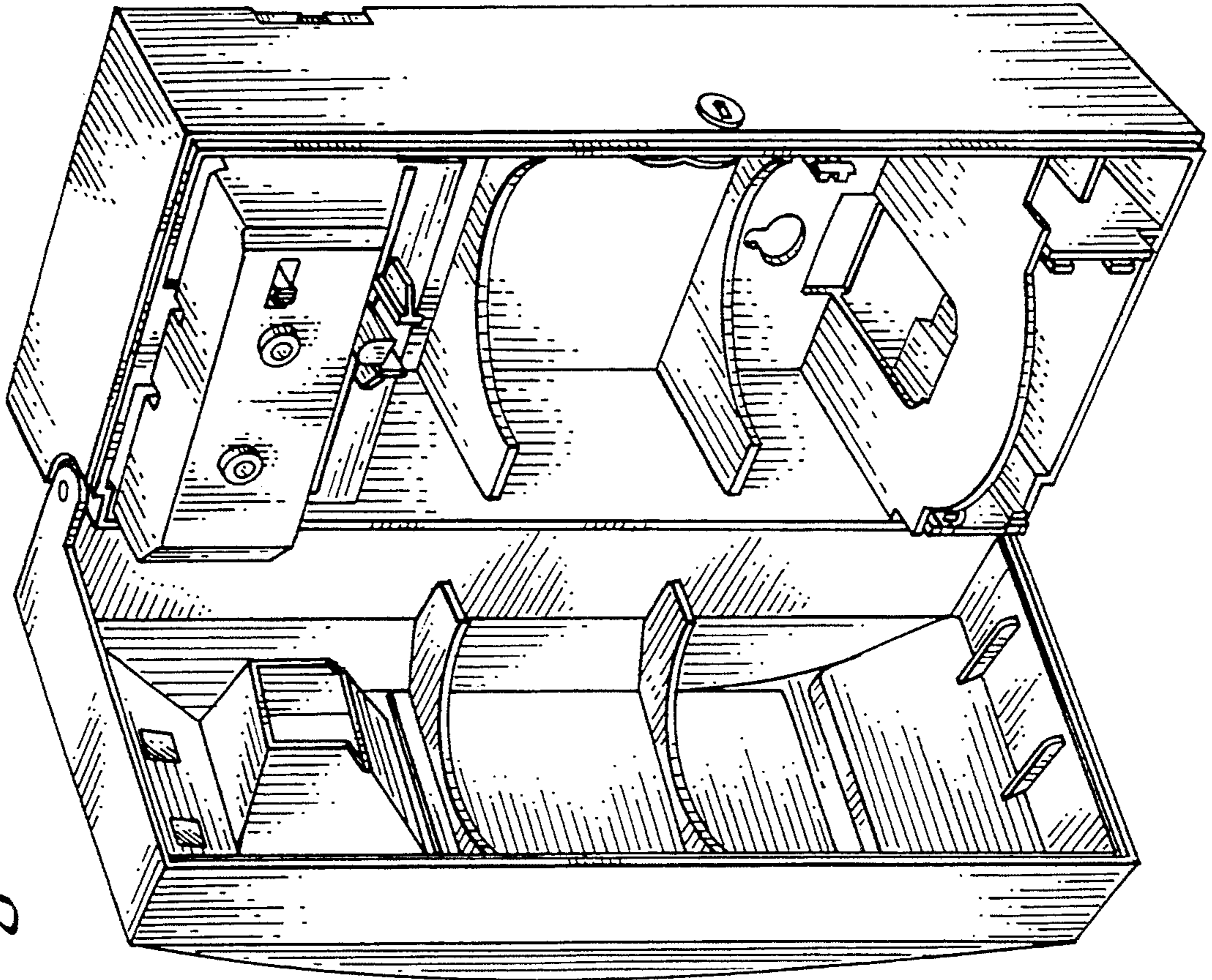

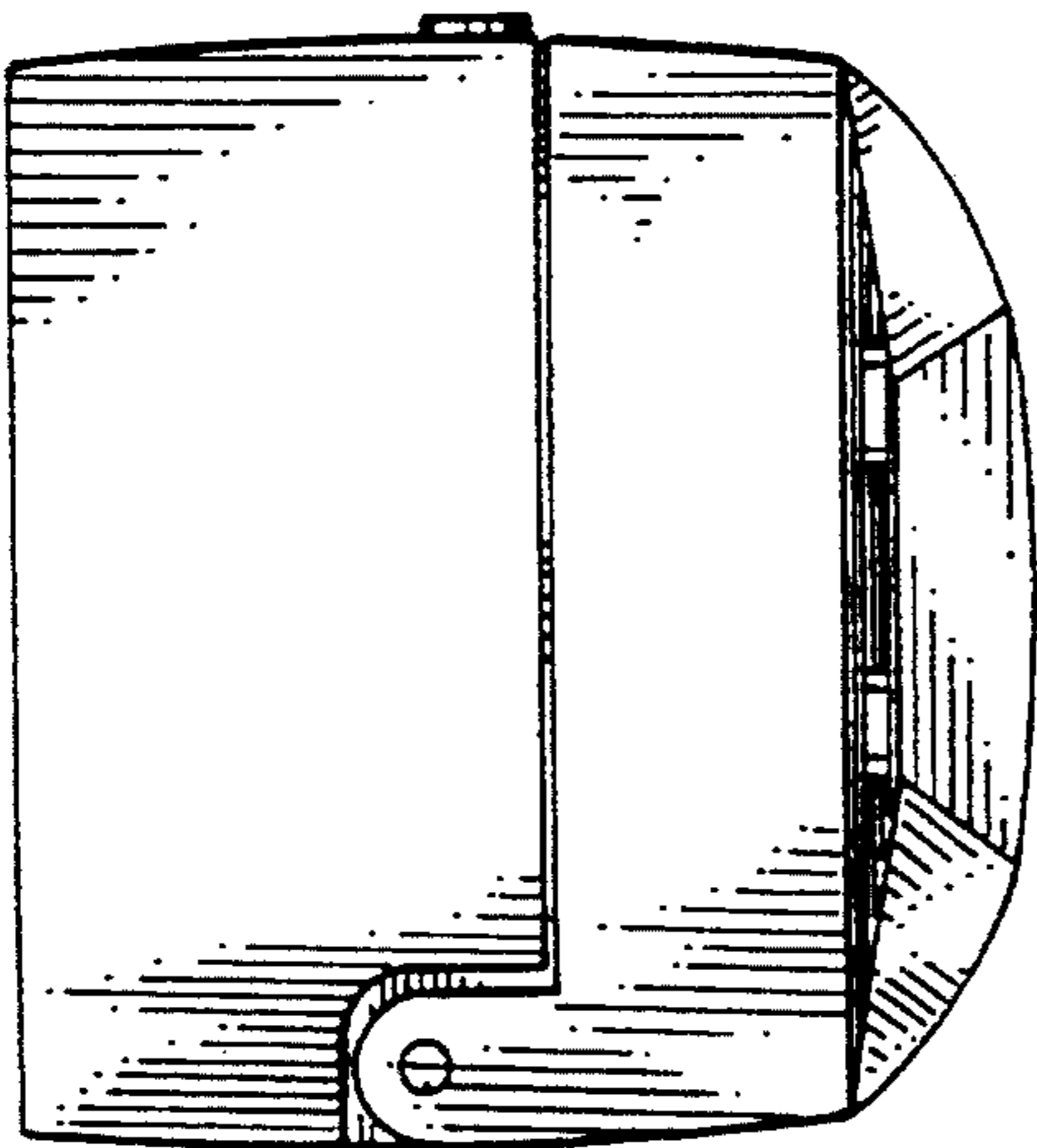
