### [57] CLAIM

The ornamental design for a compartmented sport bag, as shown and described.

### DESCRIPTION

FIG. 1 is a left side elevational view of a compartmented sport bag showing my new design;  
 FIG. 2 is a right side elevational view of the compartmented sport bag shown in FIG. 1;  
 FIG. 3 is an elevational view taken at one end of the compartmented sport bag shown in FIG. 1;  
 FIG. 4 is an elevational view taken at the other end of the compartmented sport bag shown in FIG. 1;  
 FIG. 5 is a top plan view of the compartmented sport bag shown in FIG. 1;  
 FIG. 6 is a bottom plan view of the compartmented sport bag shown in FIG. 1; and,  
 FIG. 7 is a perspective view of the compartmented sport bag of FIG. 1.

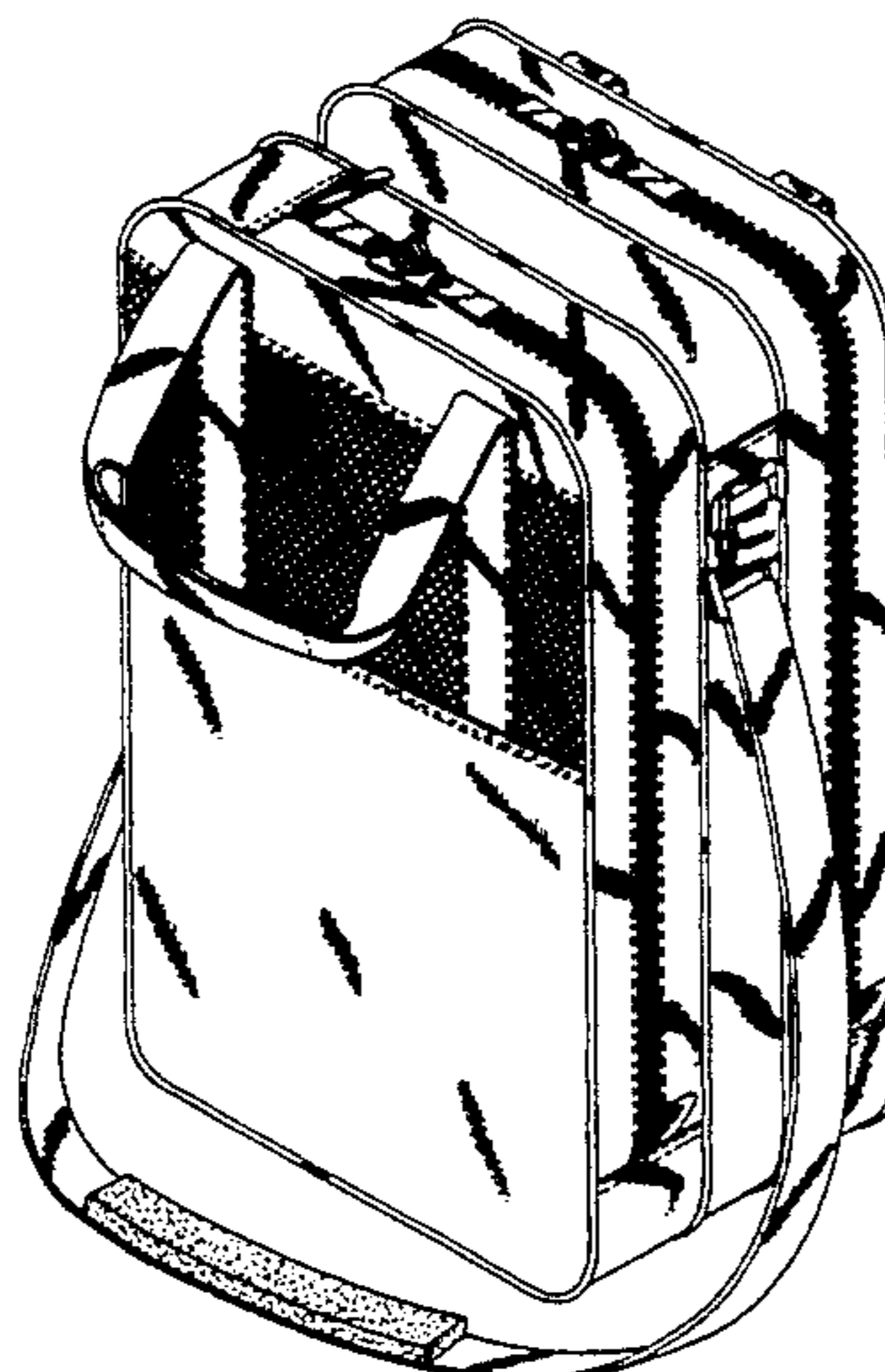

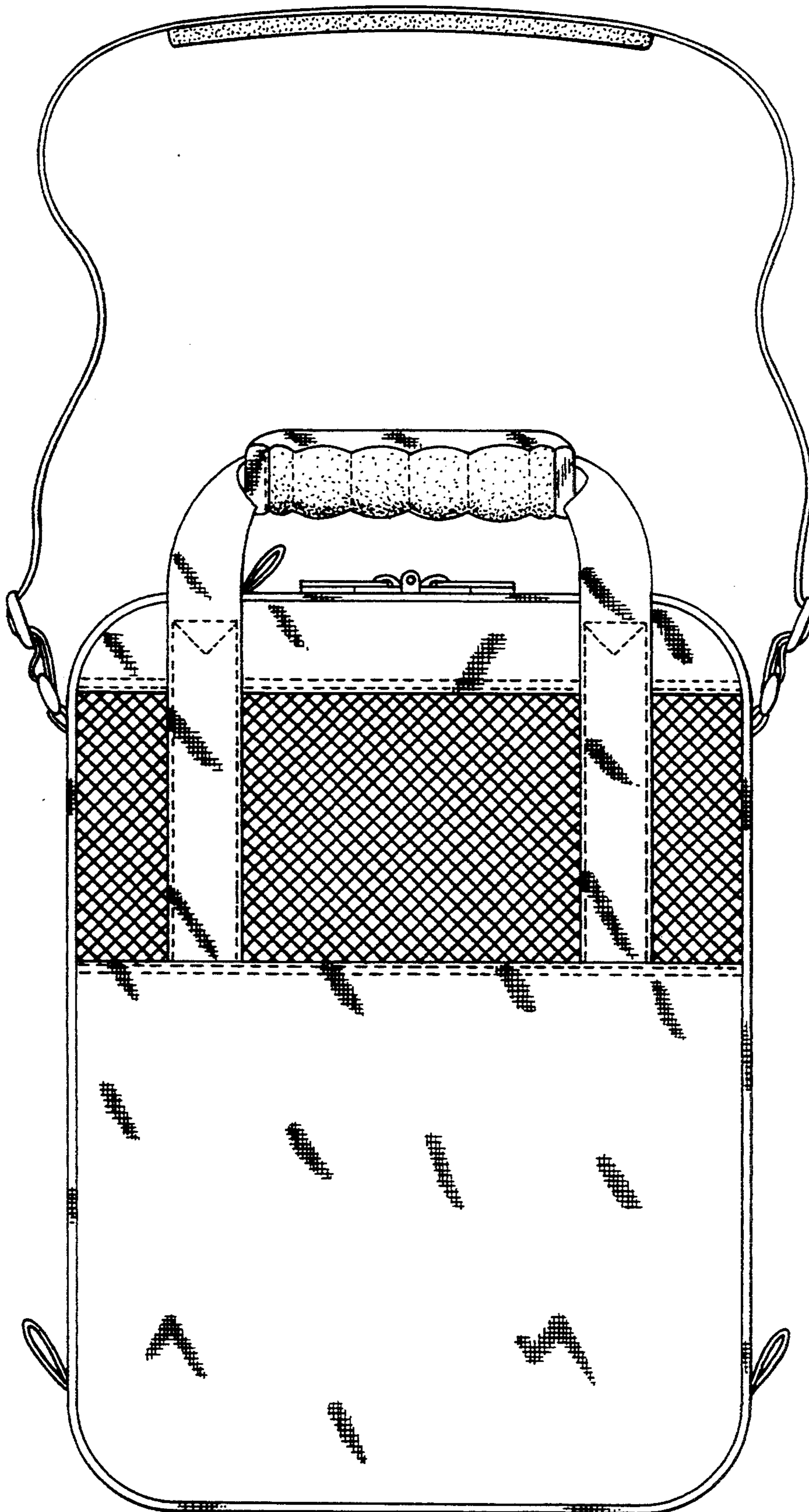

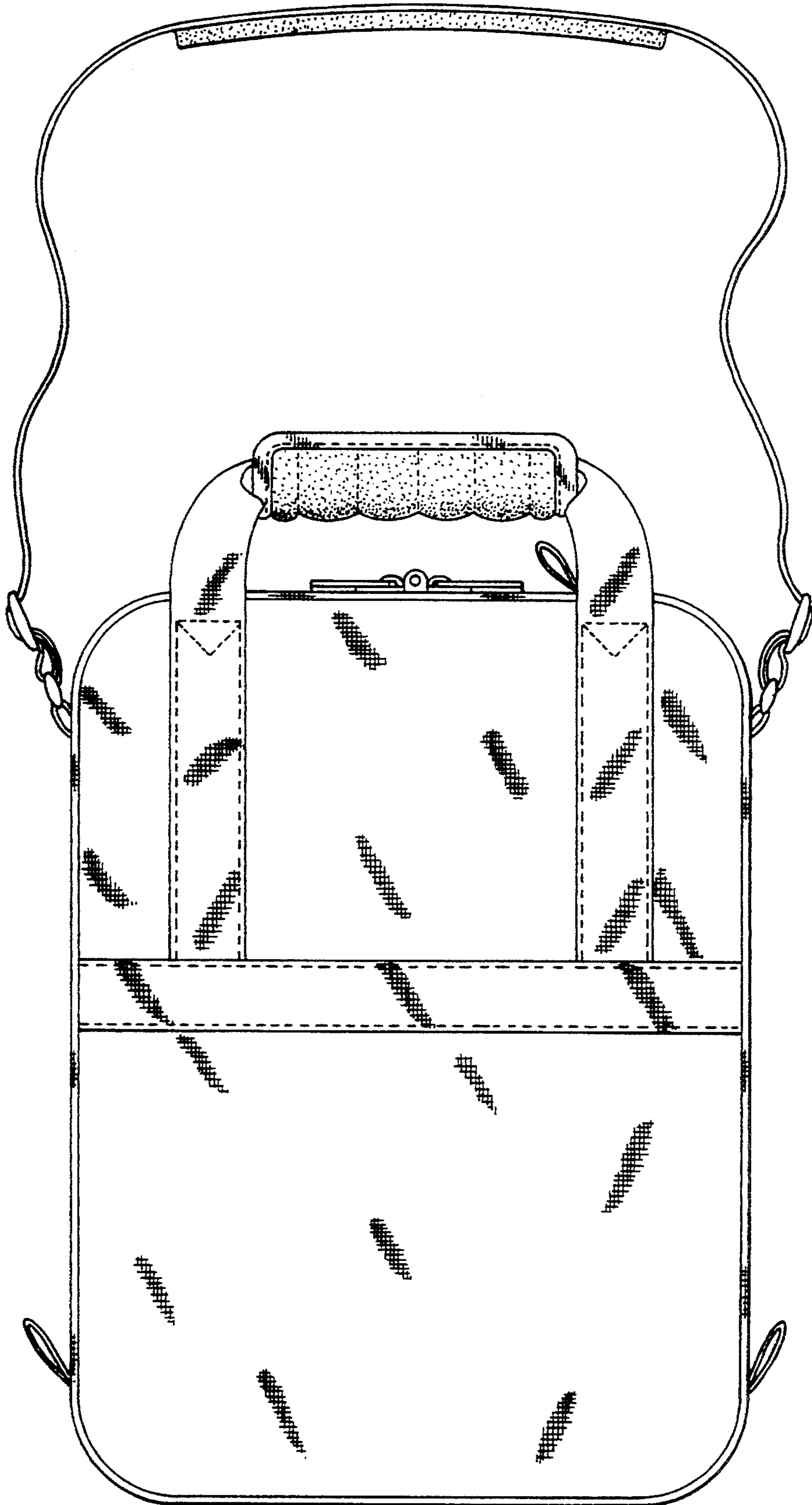

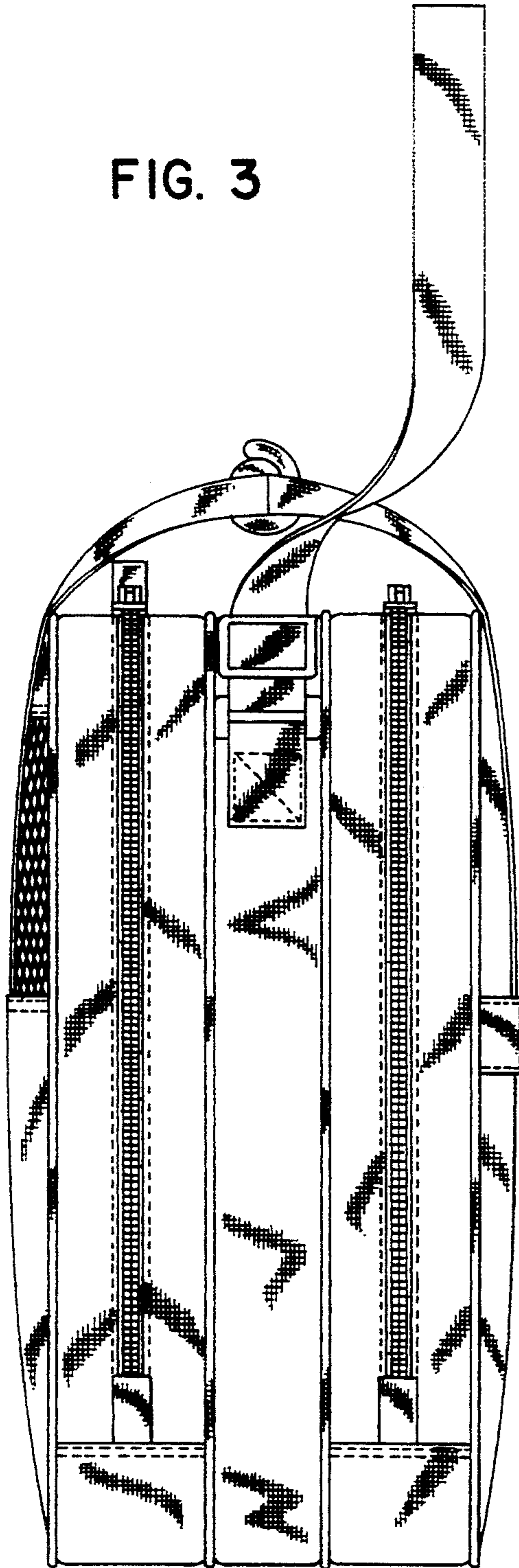

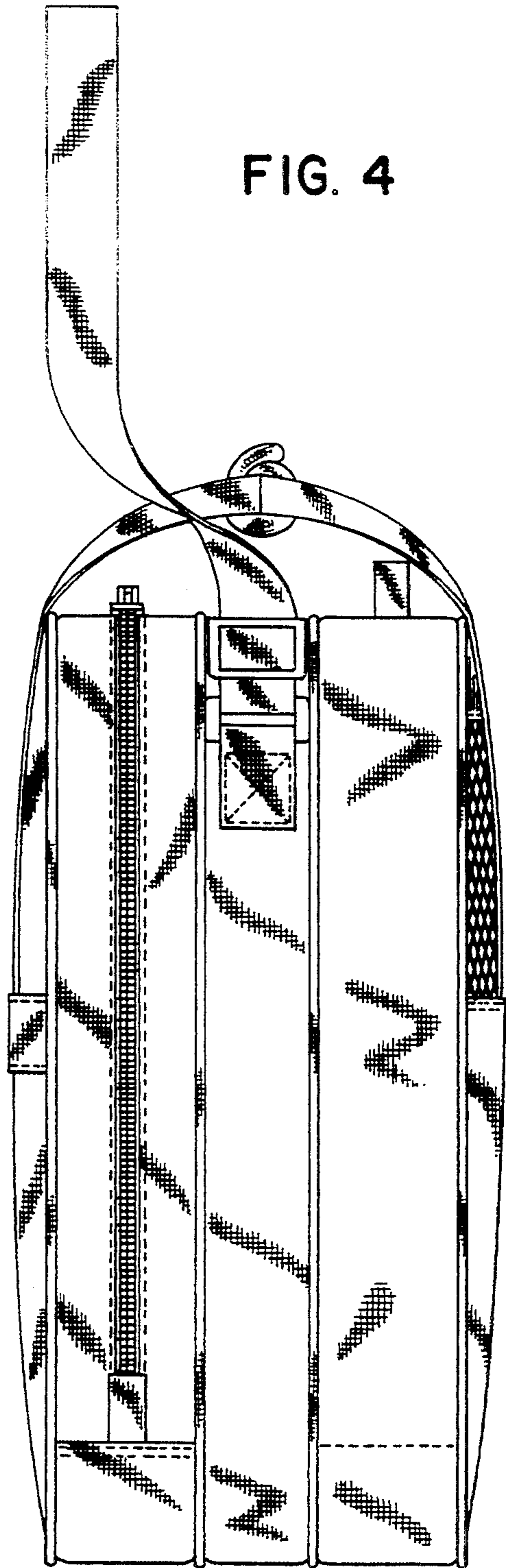

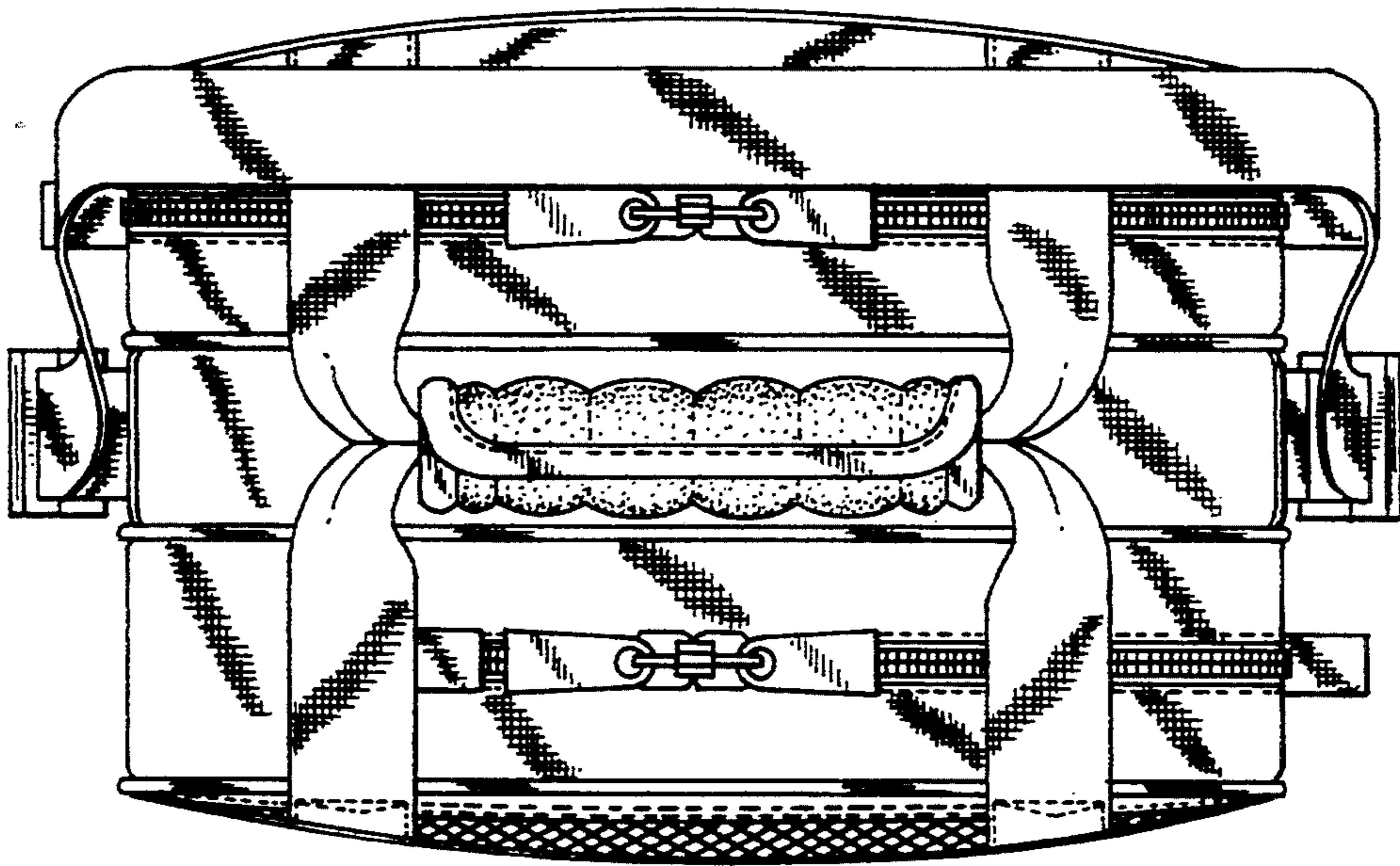

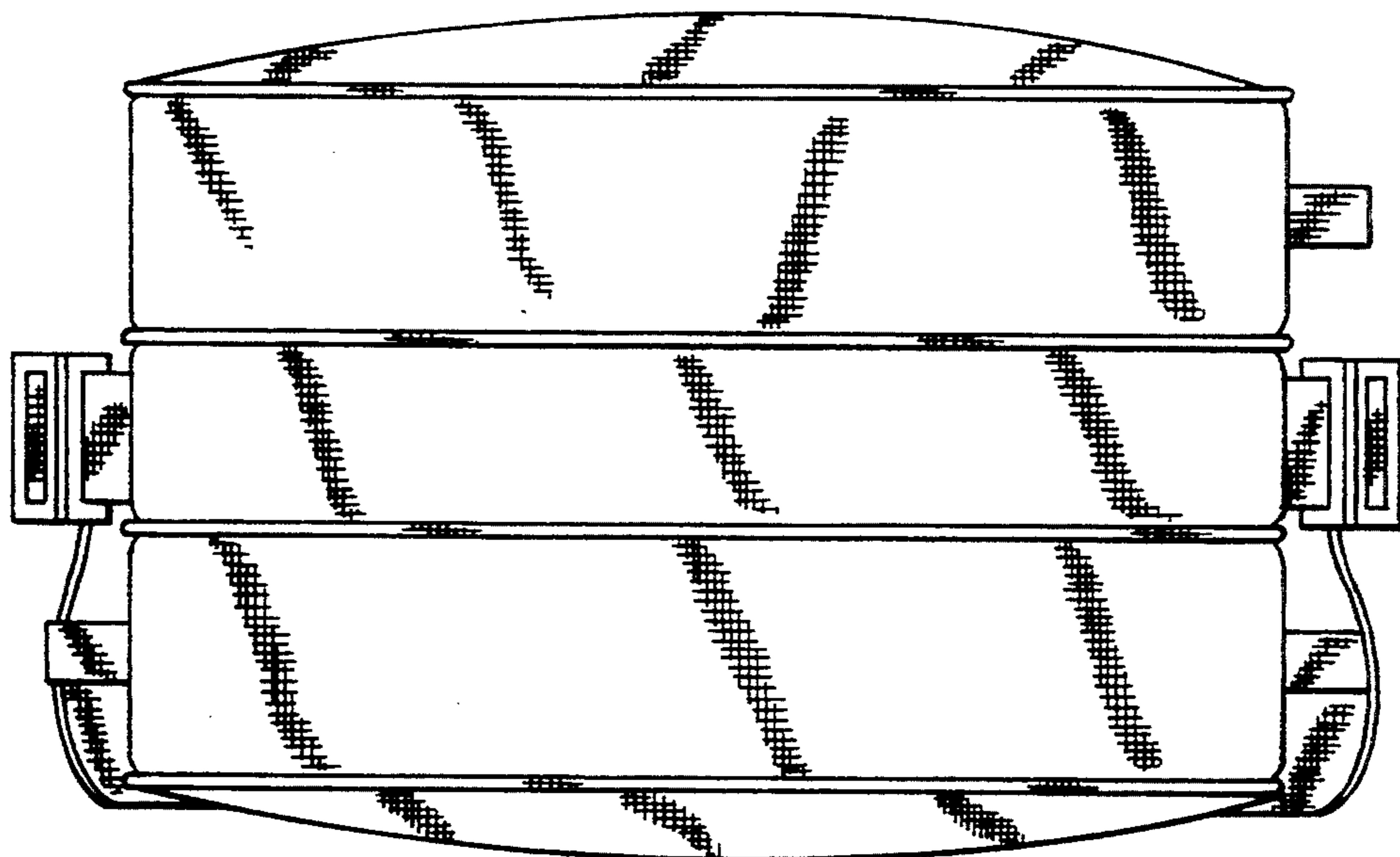
