FIG. 7 is a cross sectional view thereof taken along line 7-7 of FIG. 3;

FIG. 8 is a cross sectional view thereof taken along line 8-8 of FIG. 3;

FIG. 9 is a cross sectional view thereof taken along line 9-9 of FIG. 3; and,

FIG. 10 is a fragmentary perspective view of a corner area thereof.

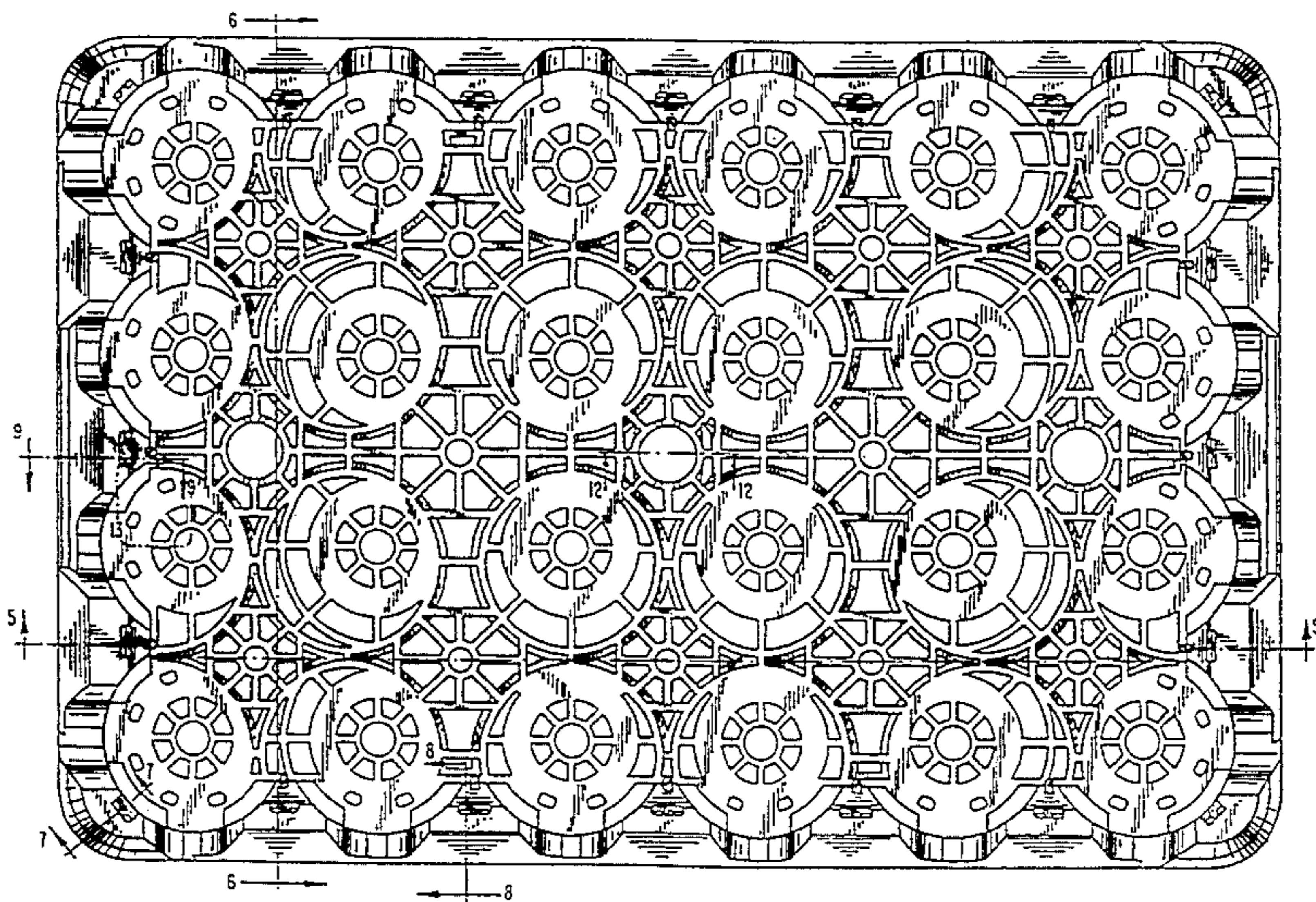
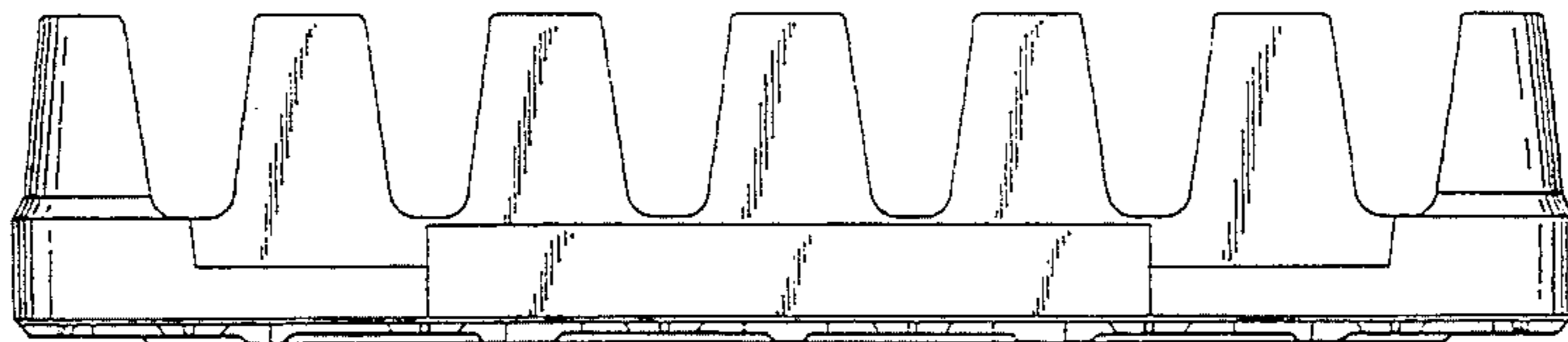

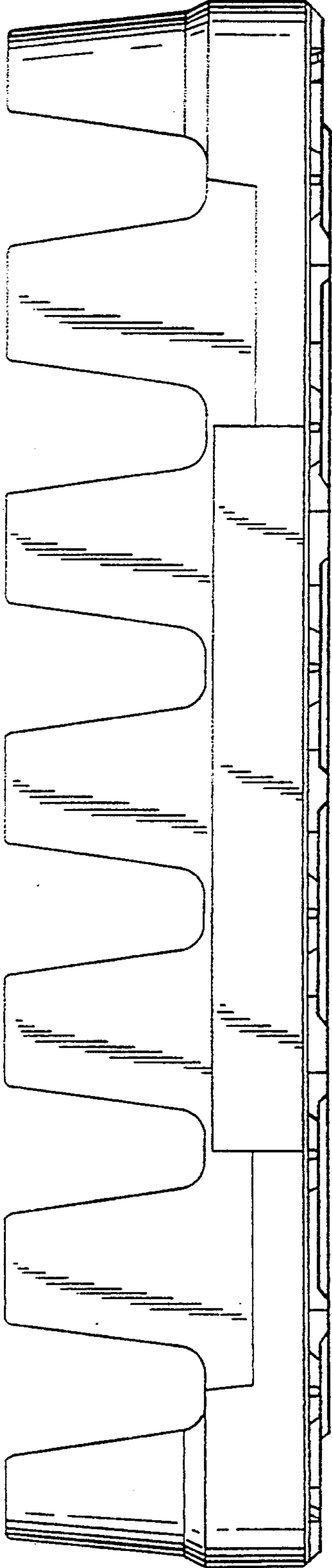

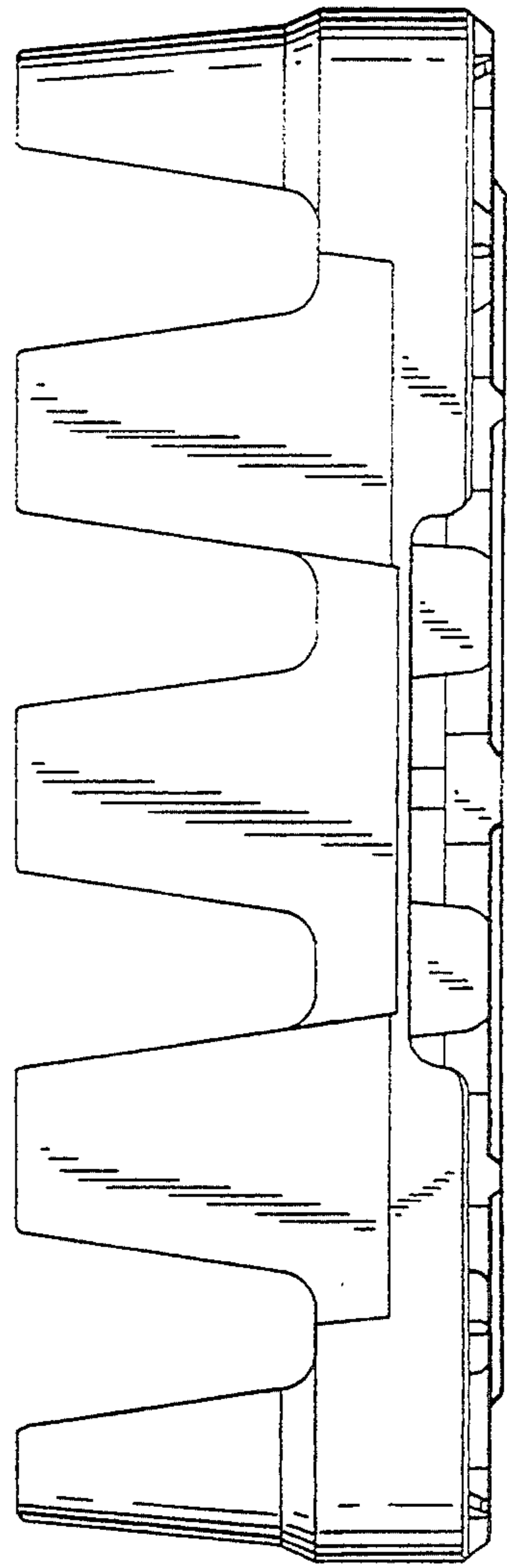

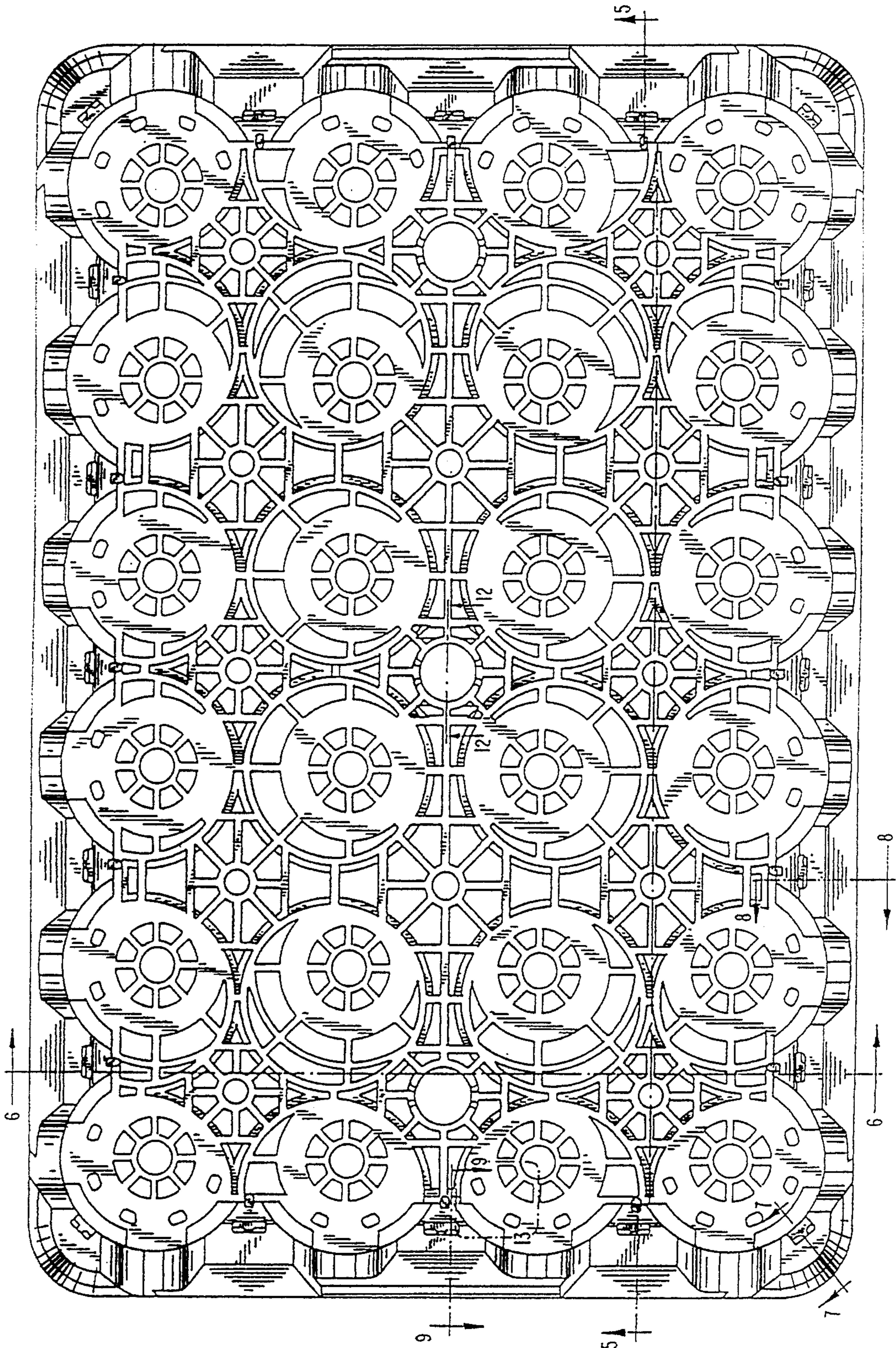

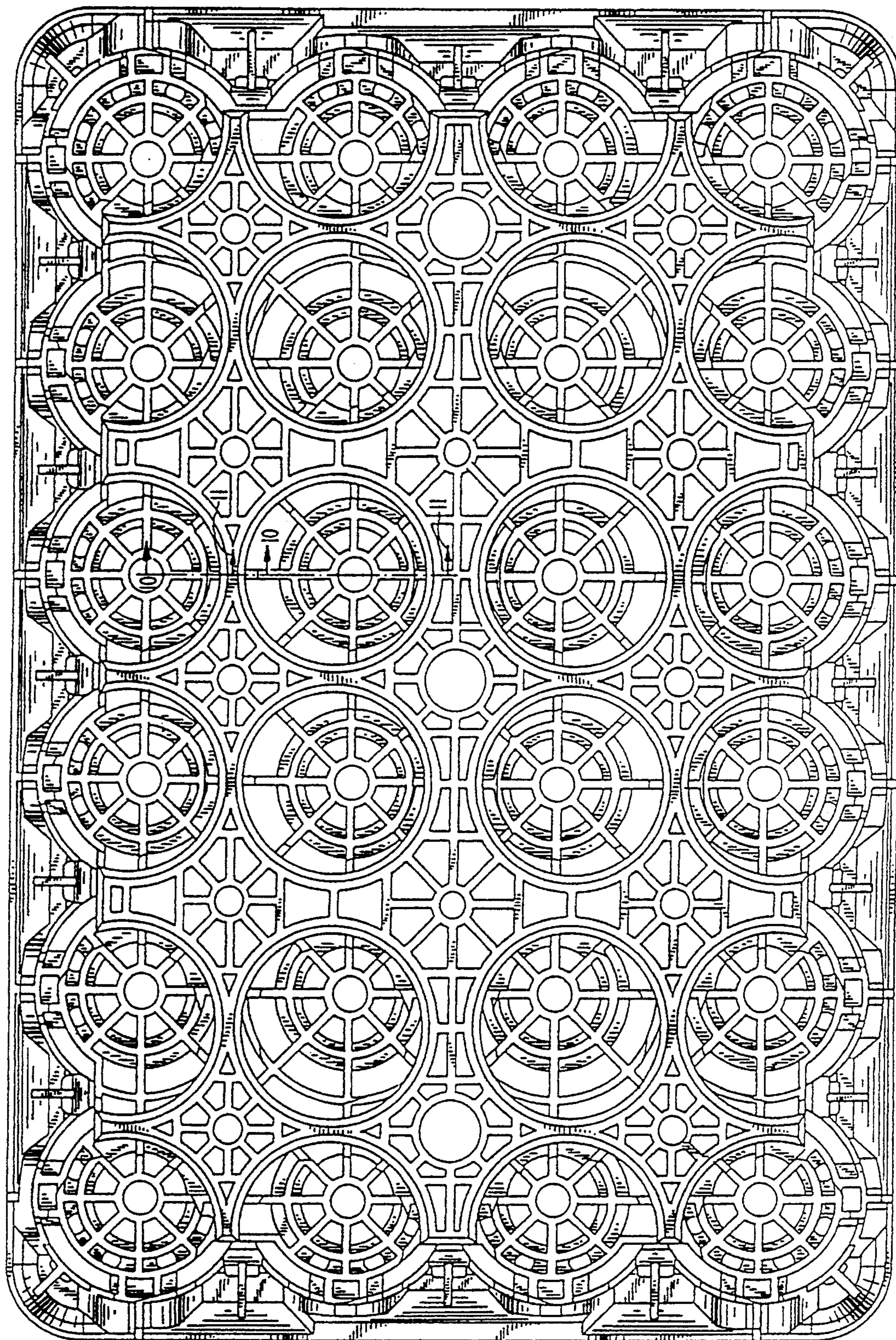

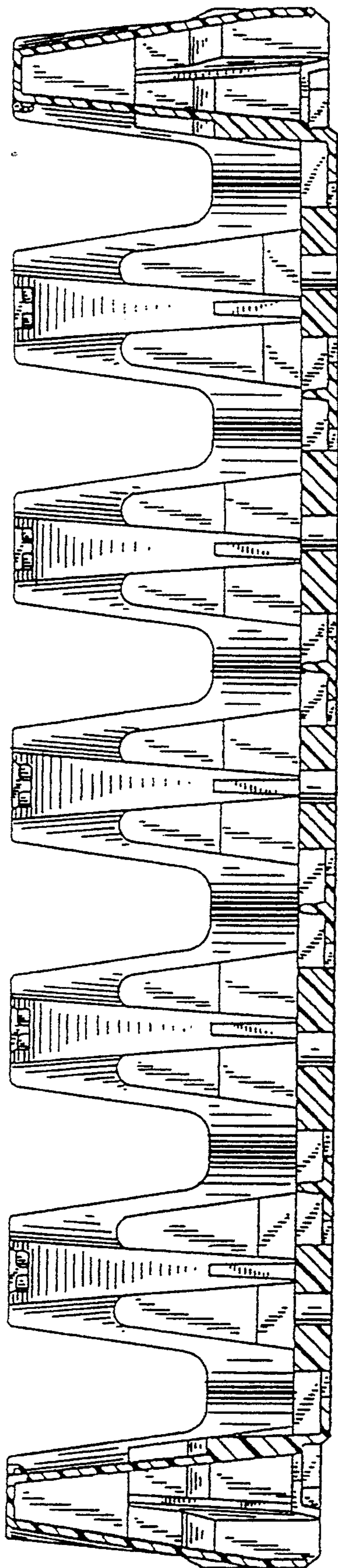

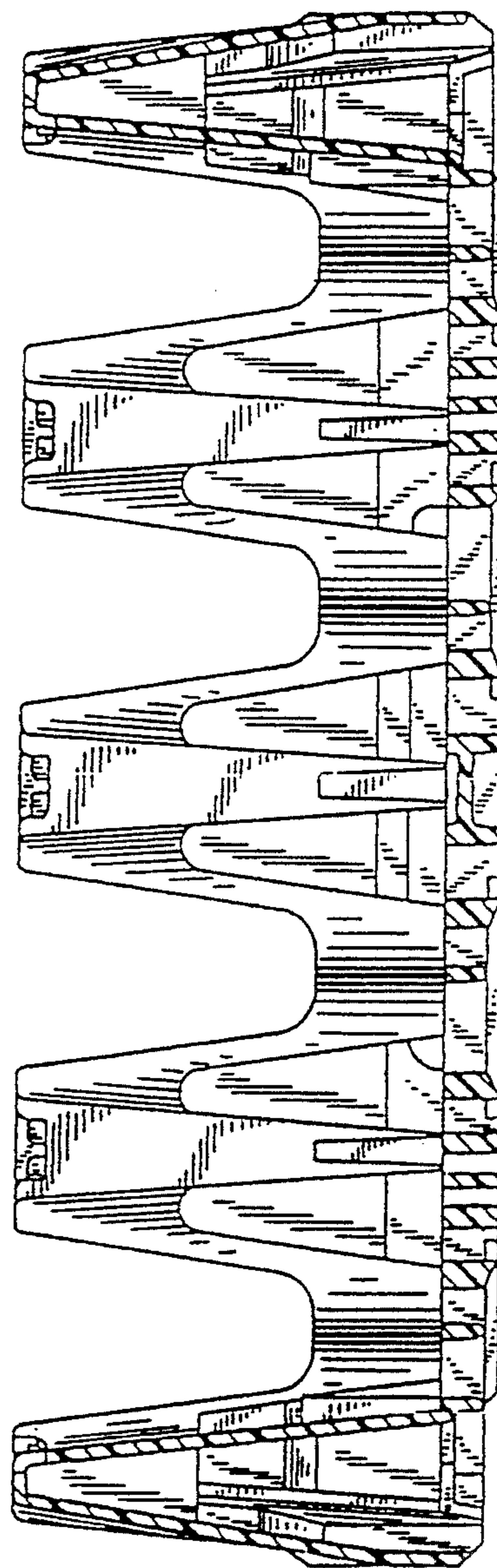

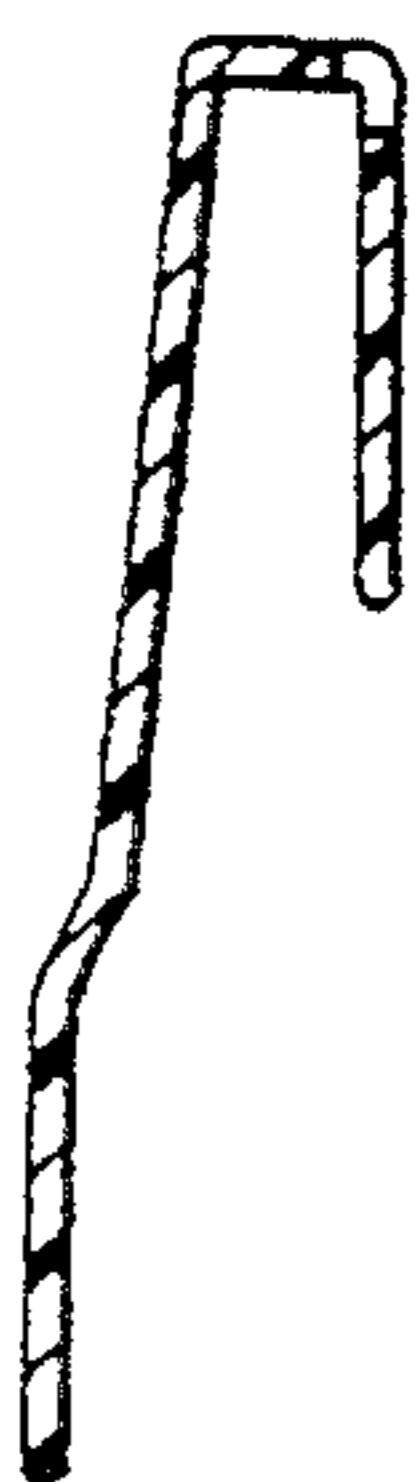

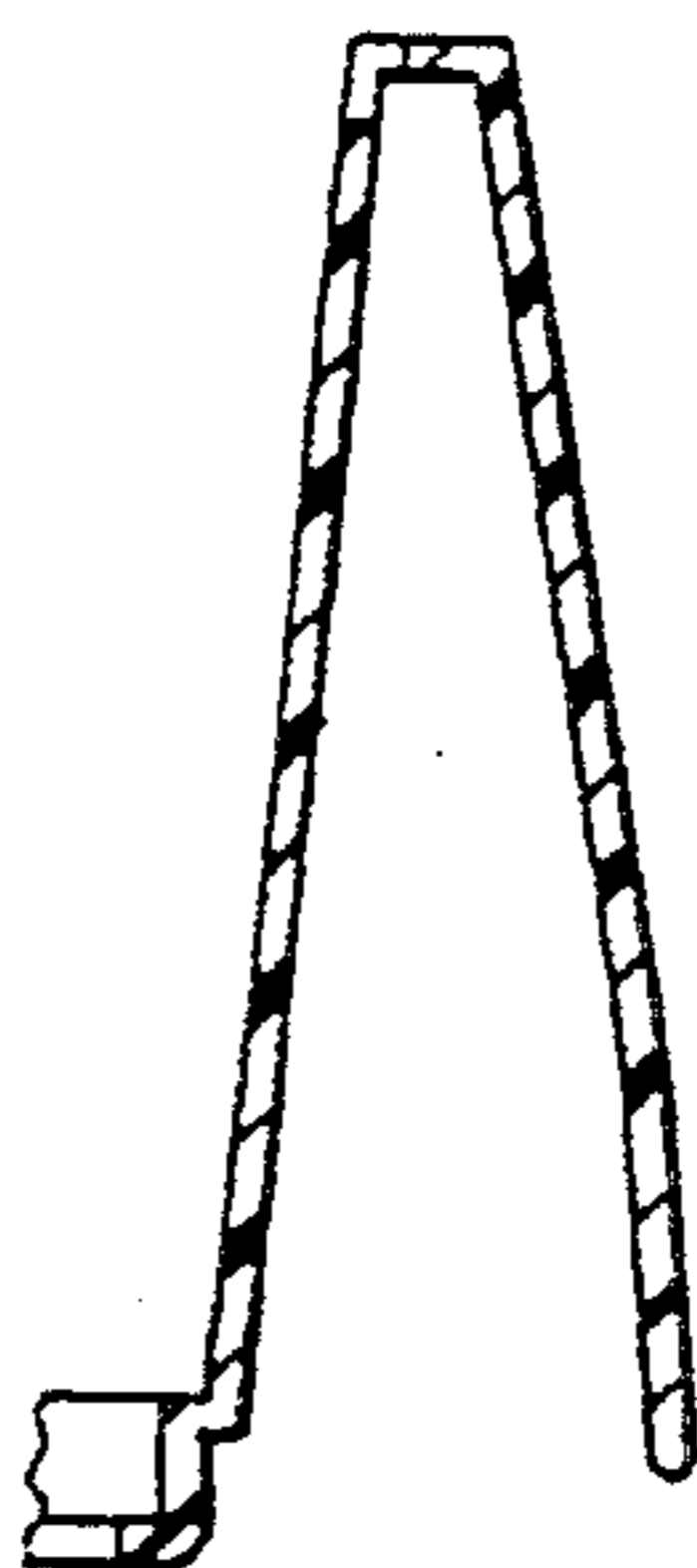

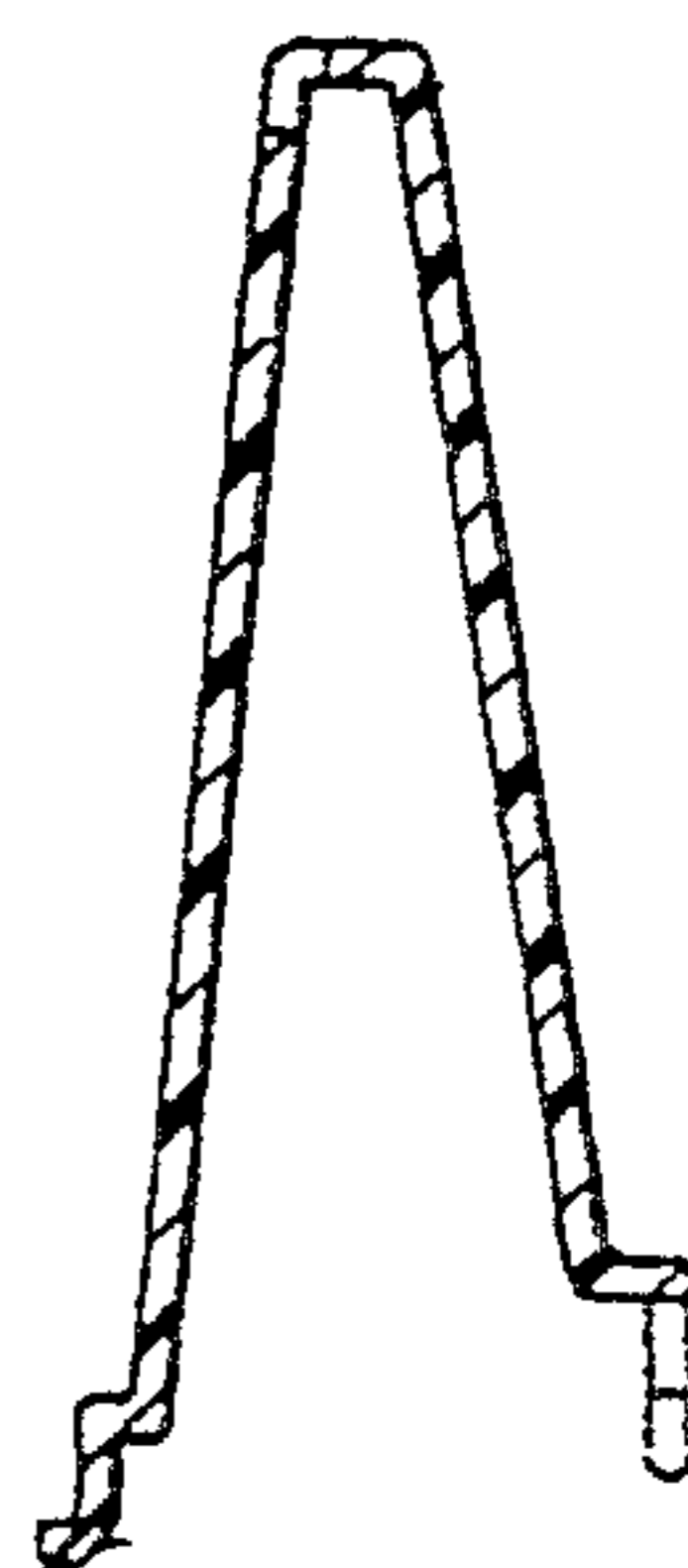
