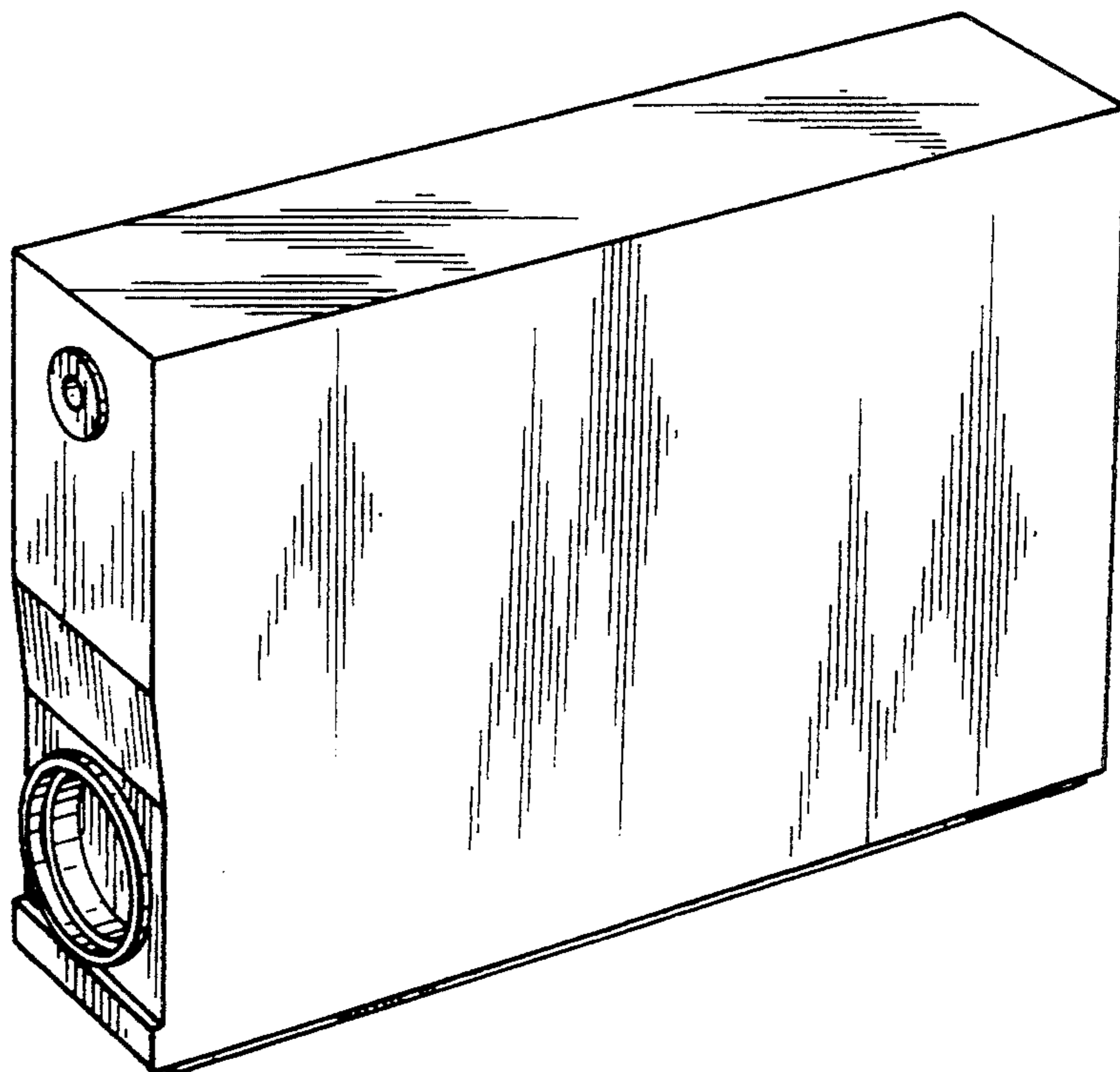

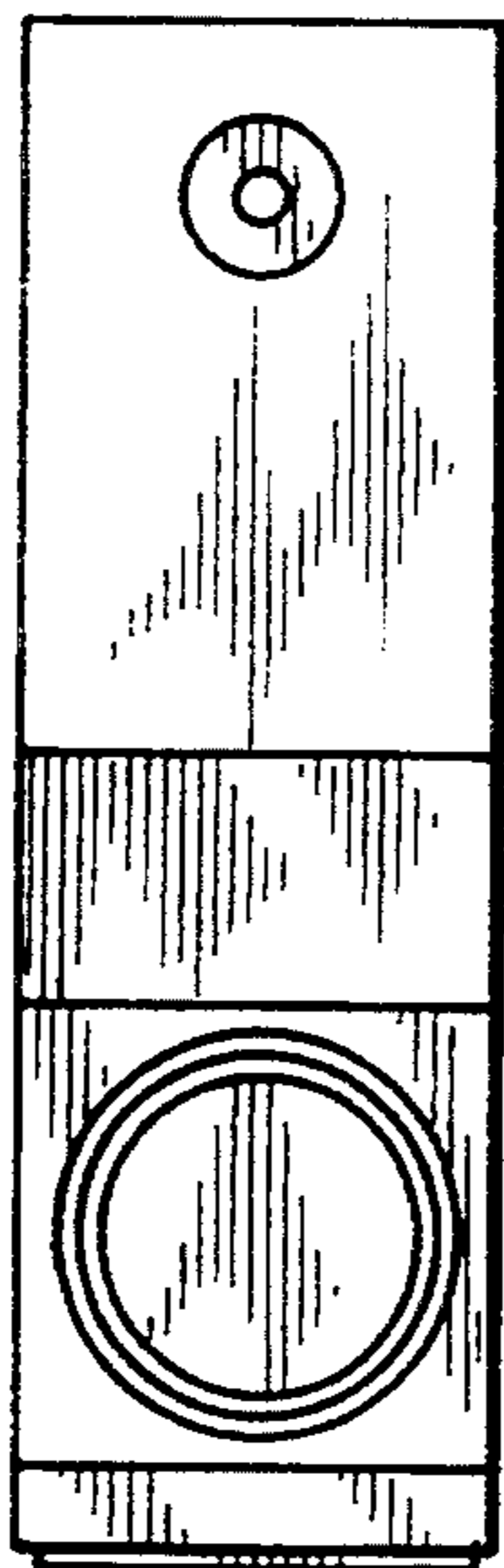
The ornamental design for an ink cartridge for printer, as shown and described.

**DESCRIPTION**

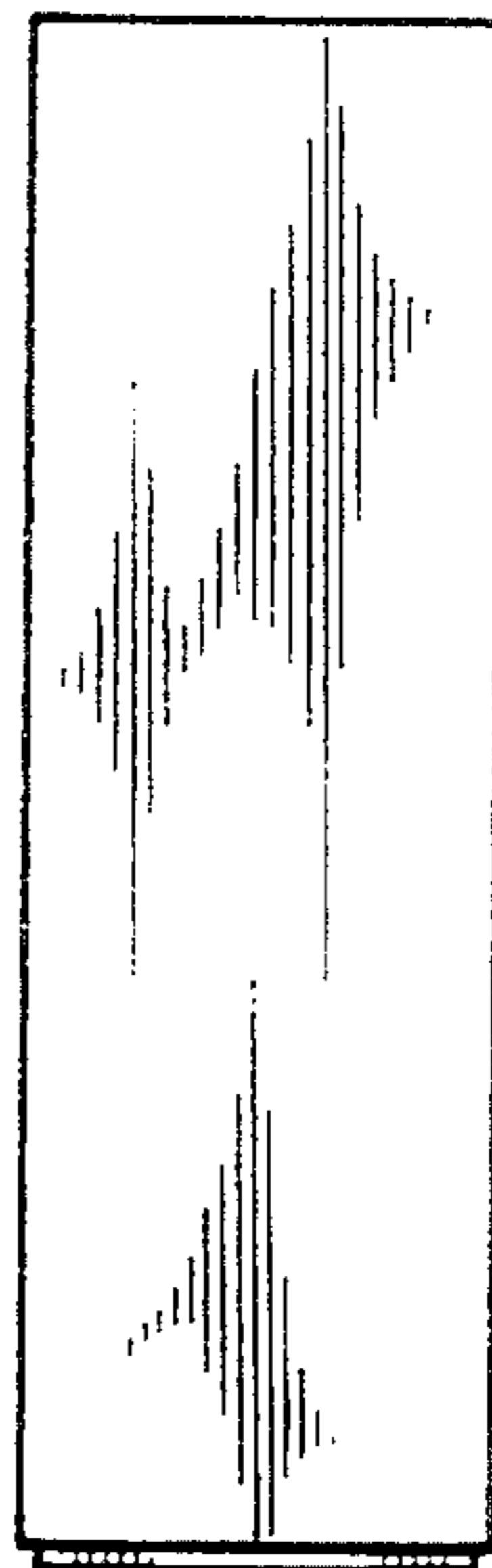
FIG. 1 is a front elevational view of an ink cartridge for printer showing our new design;

FIG. 6 is a perspective view thereof.



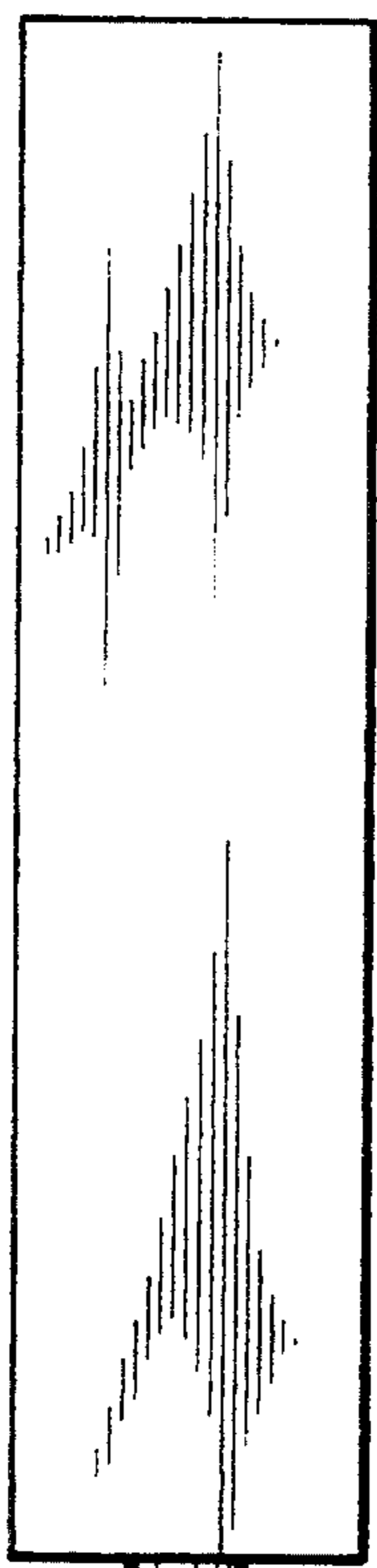

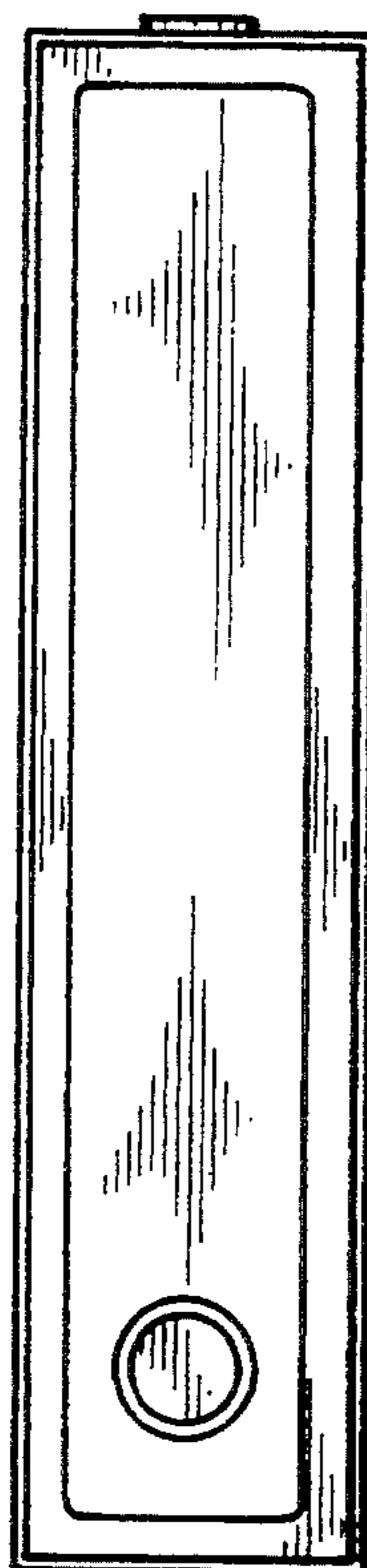

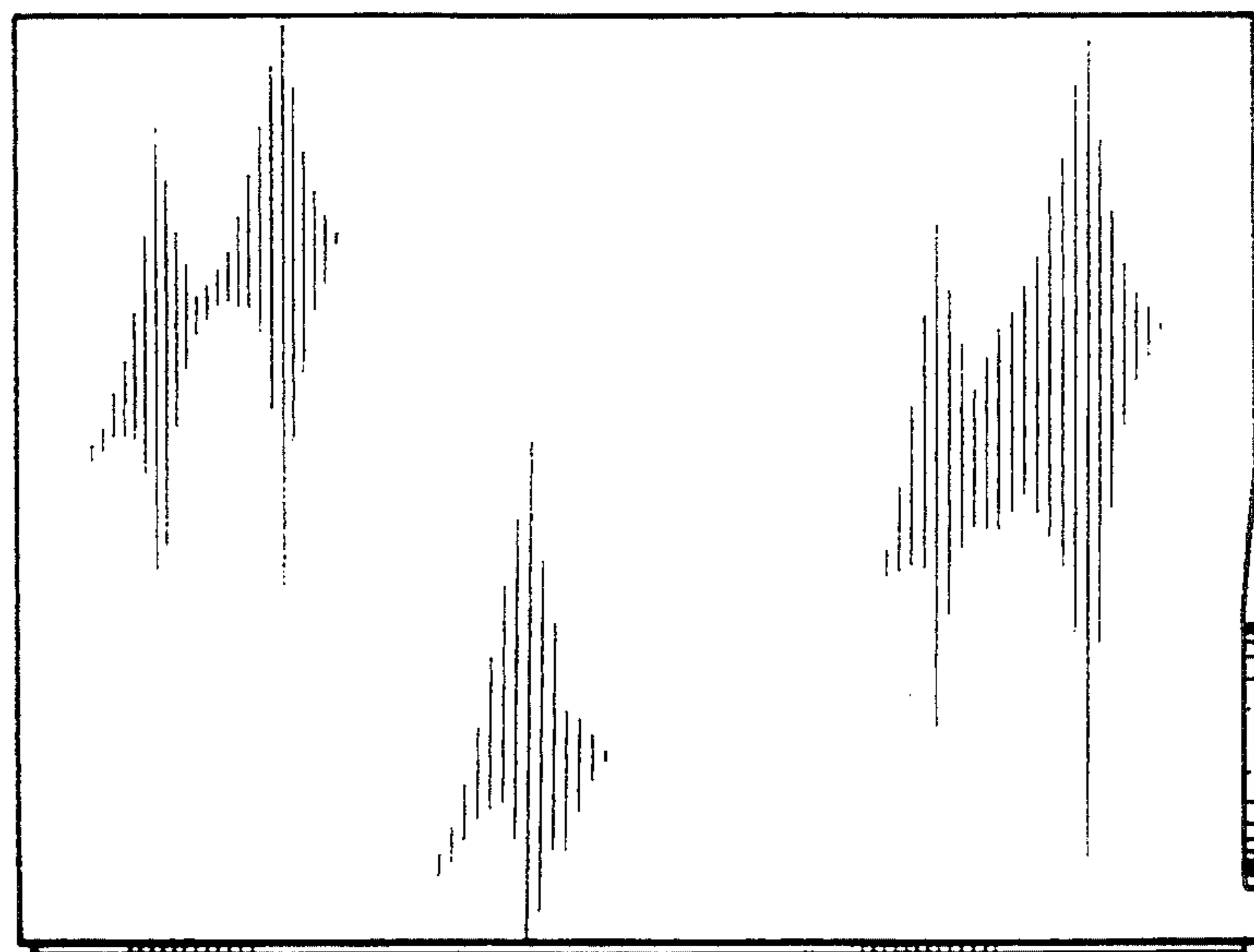
