[57] **CLAIM**

The ornamental design for a combined harness and tool belt, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the combined harness and tool belt showing my new design, with the outer belt unfastened;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a right side perspective view - for clarity of illustration the strap is not shown;

FIG. 4 is a left side perspective view - for clarity of illustration the strap is not shown;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front perspective view of the combined harness and tool belt of FIG. 1, showing the outer belt fastened;

FIG. 8 is a front perspective view of a second embodiment, the broken line showing of a drill being for illustrative purposes only and forming no part of the claimed design;

FIG. 9 is a rear perspective view of the embodiment of FIG. 8;

FIG. 10 is a front perspective view of a third embodiment, the broken line showing of tools being for illustrative purposes only and forming no part of the claimed design; and,

FIG. 11 is a rear perspective view of the embodiment of FIG. 10.

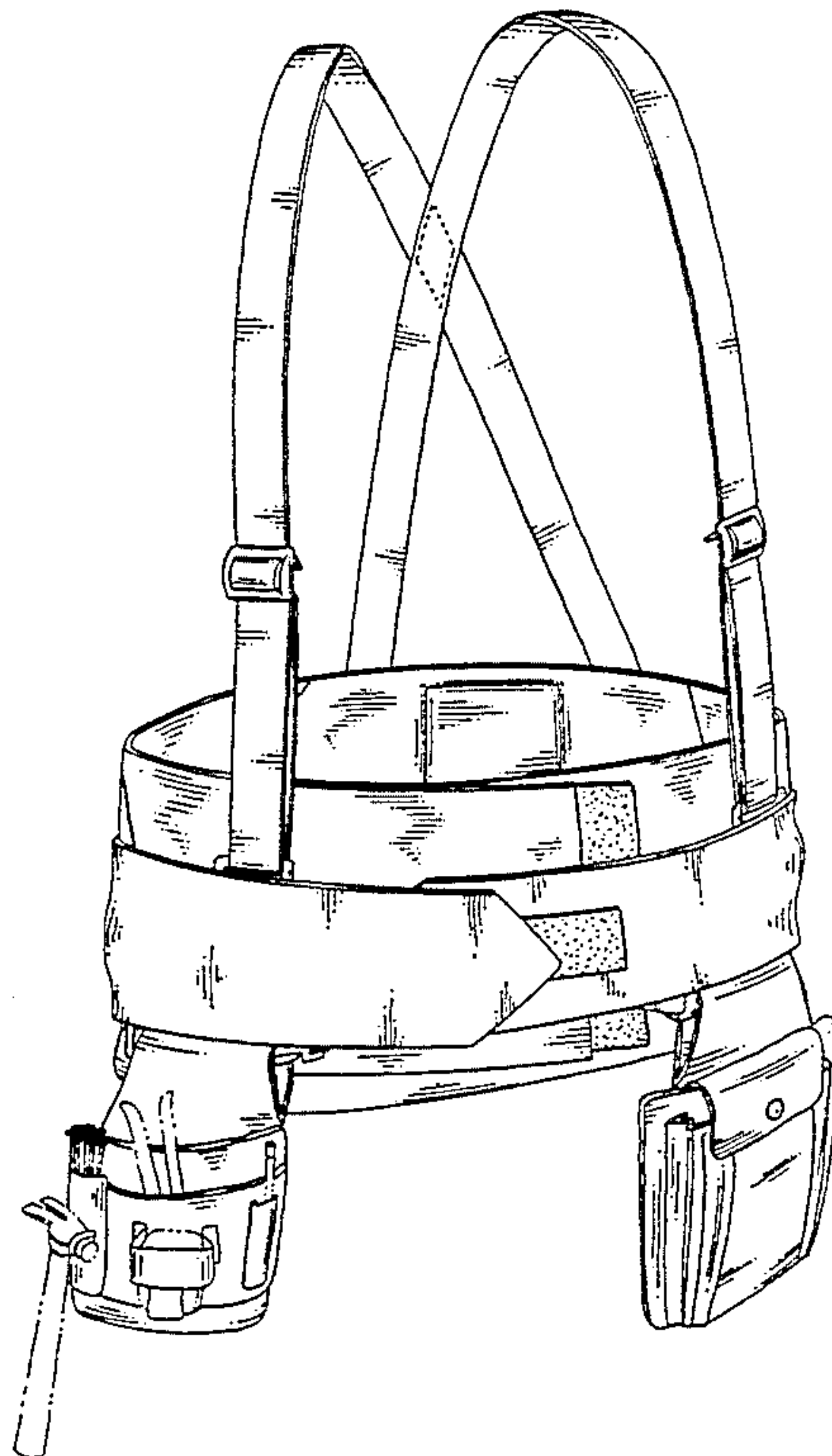

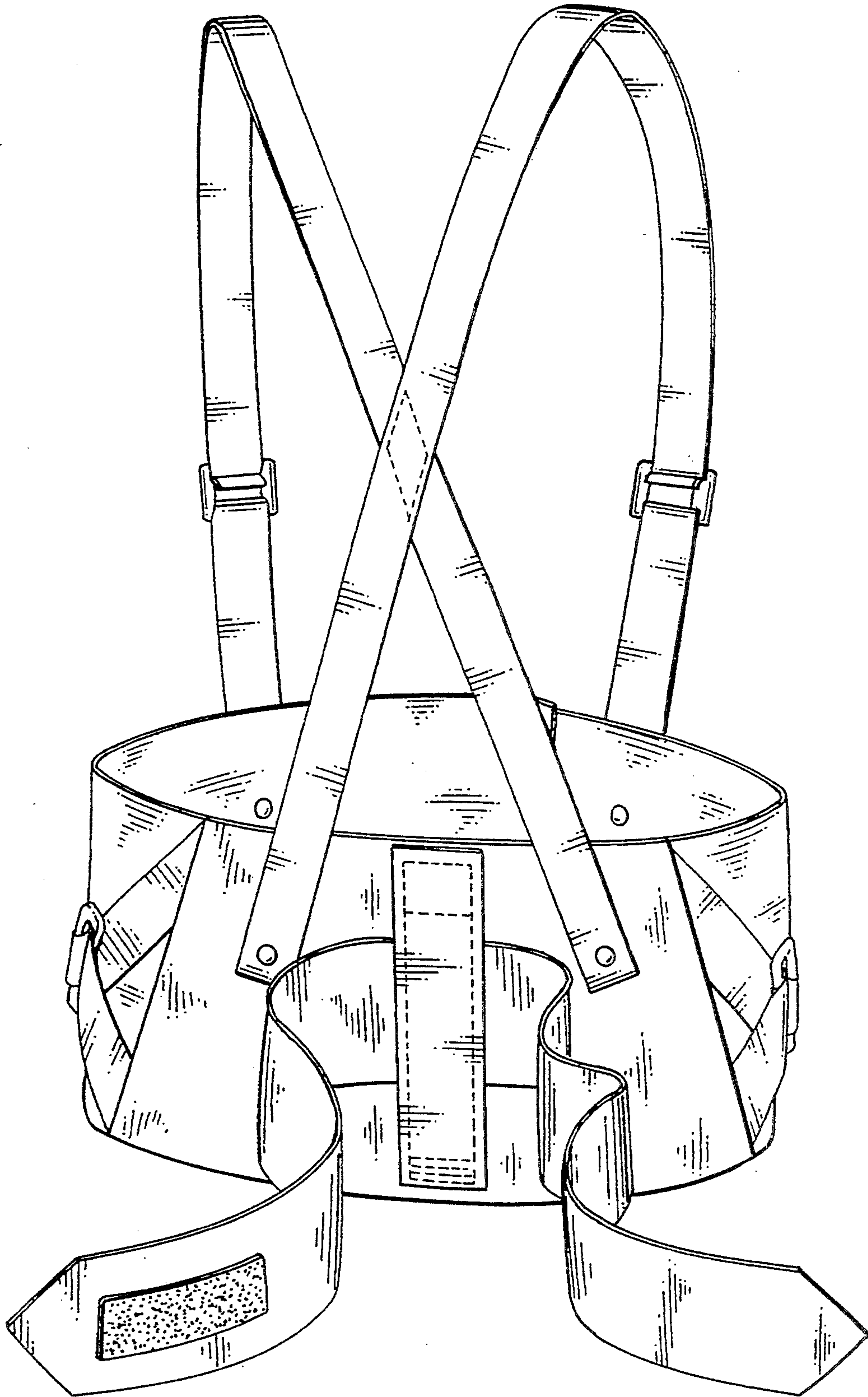

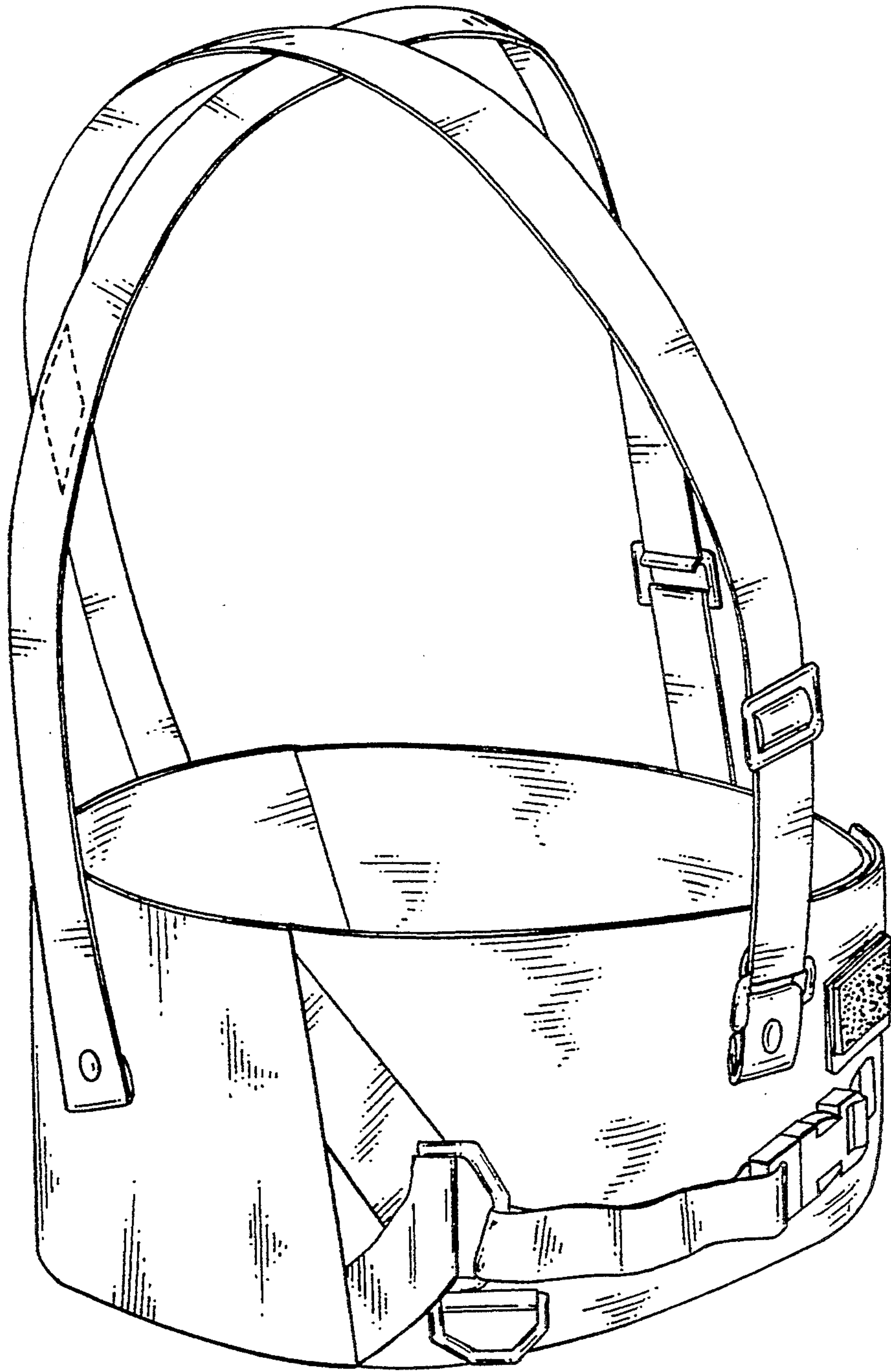

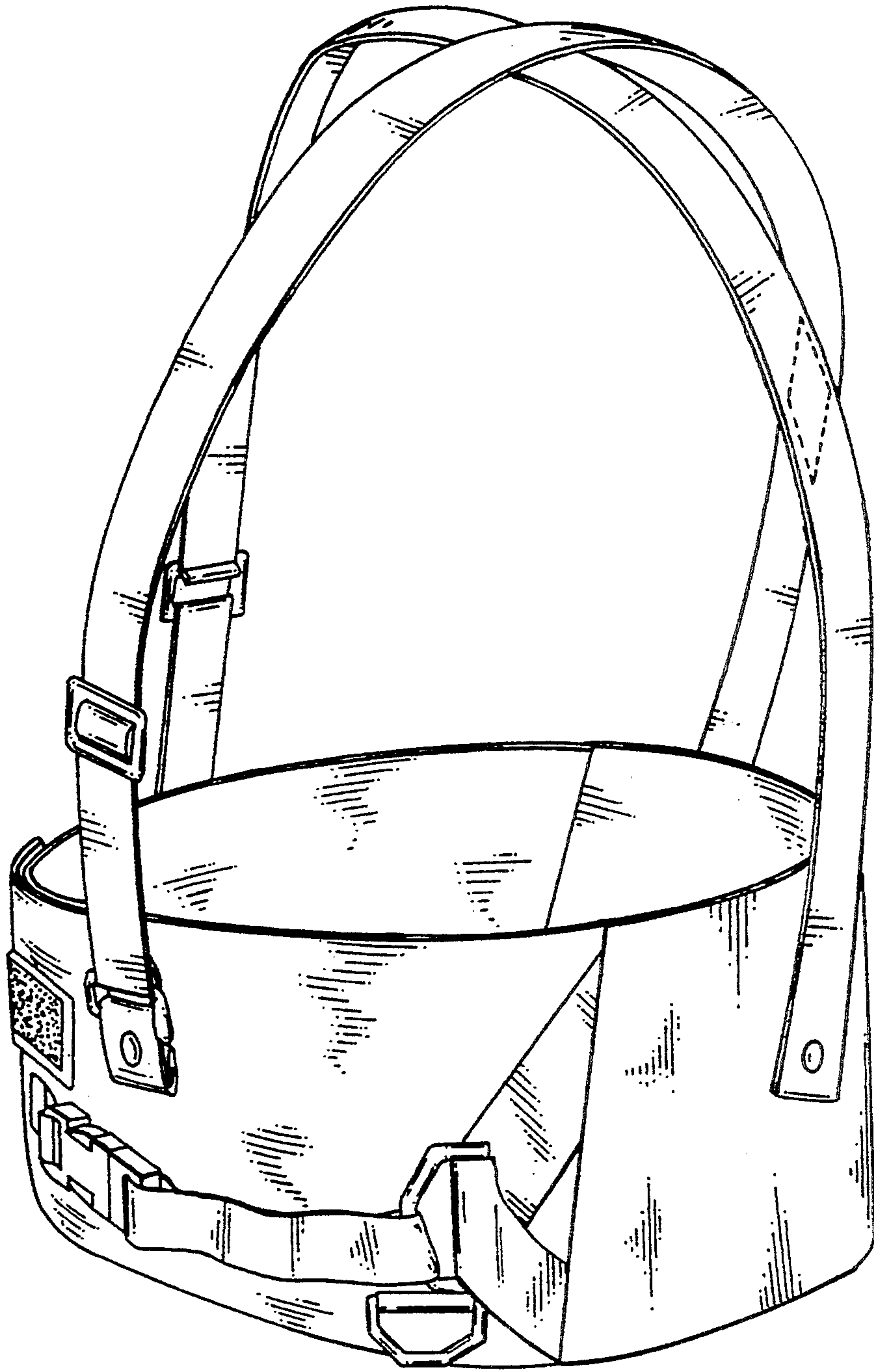

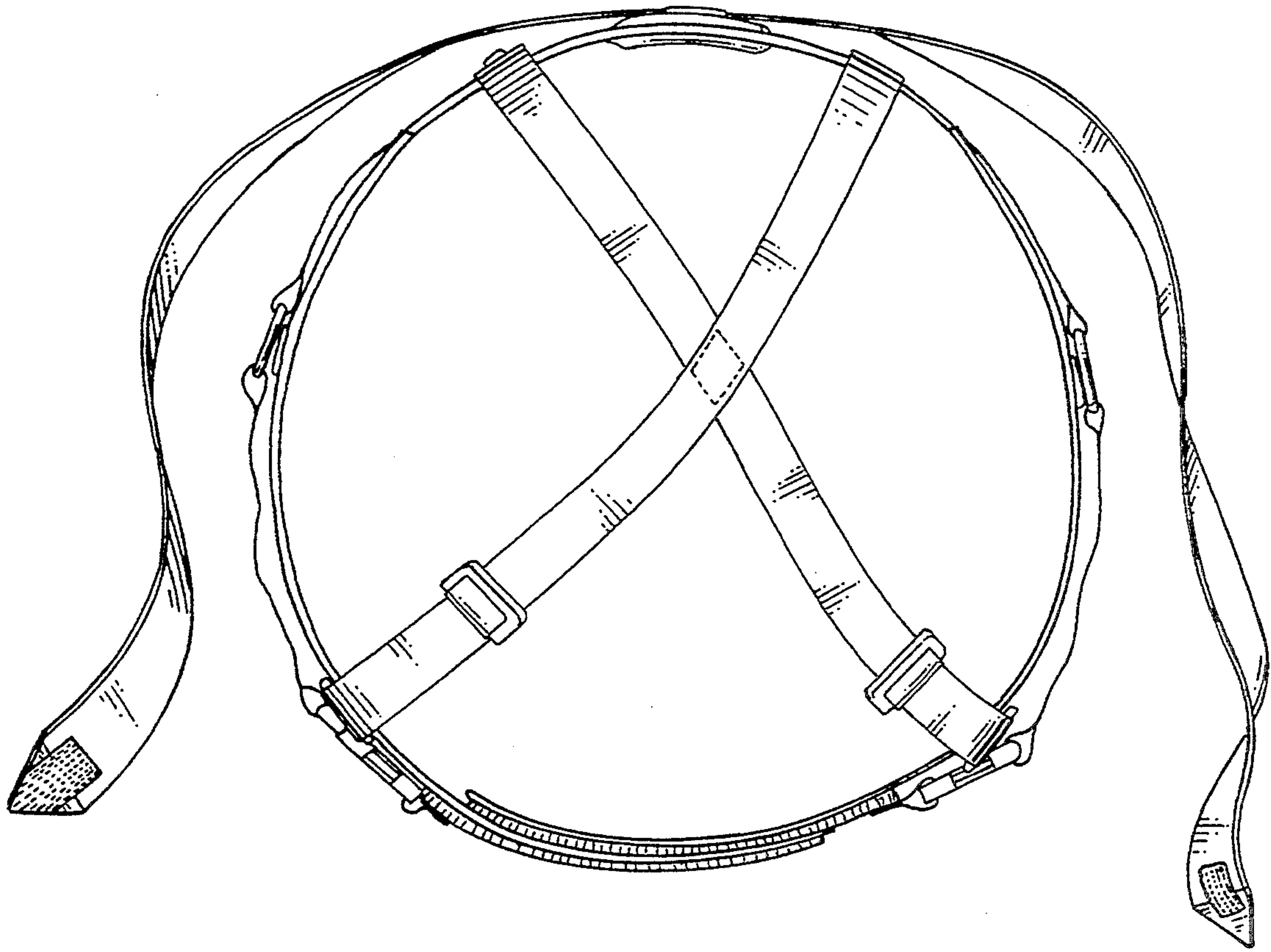

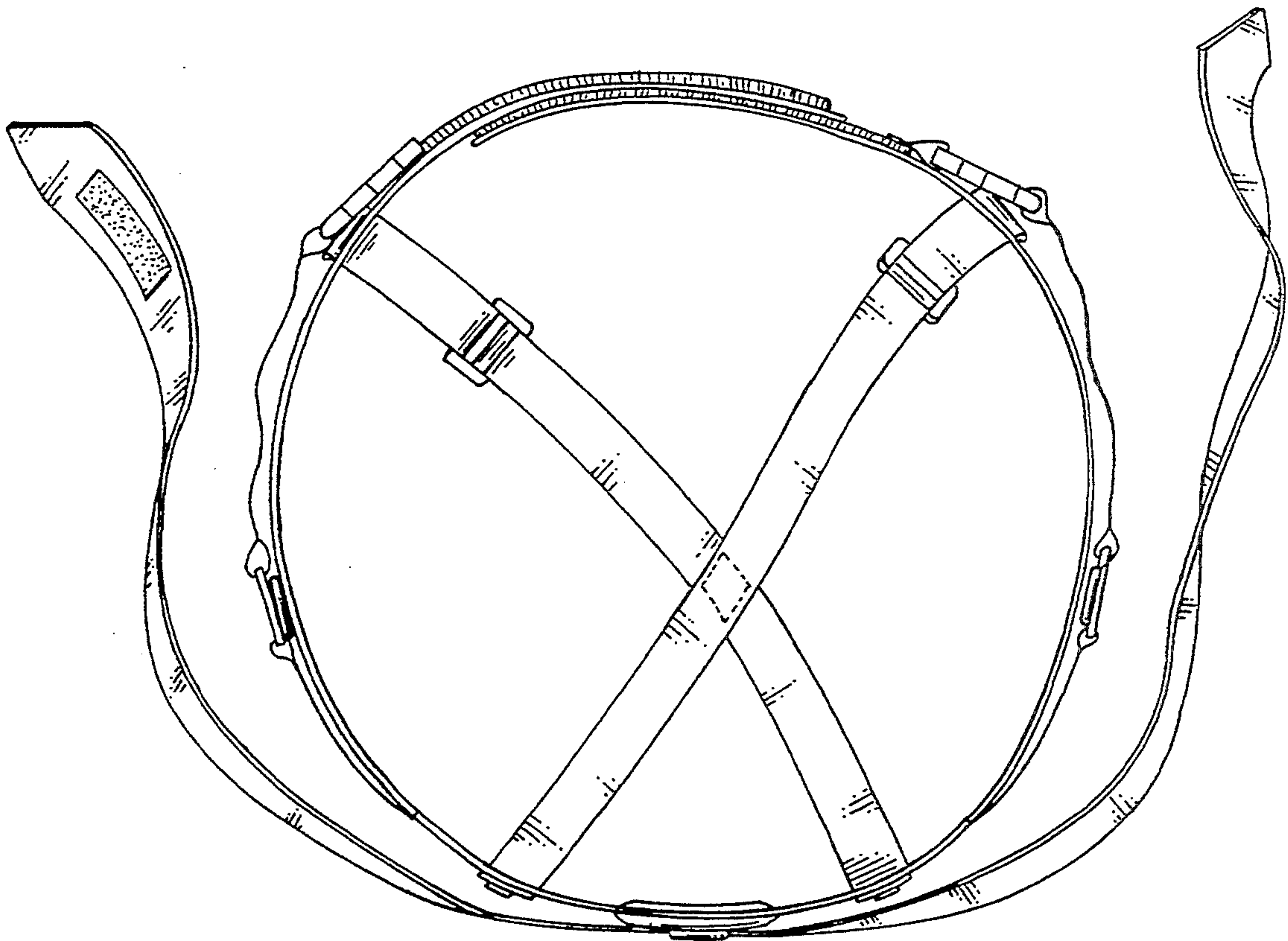

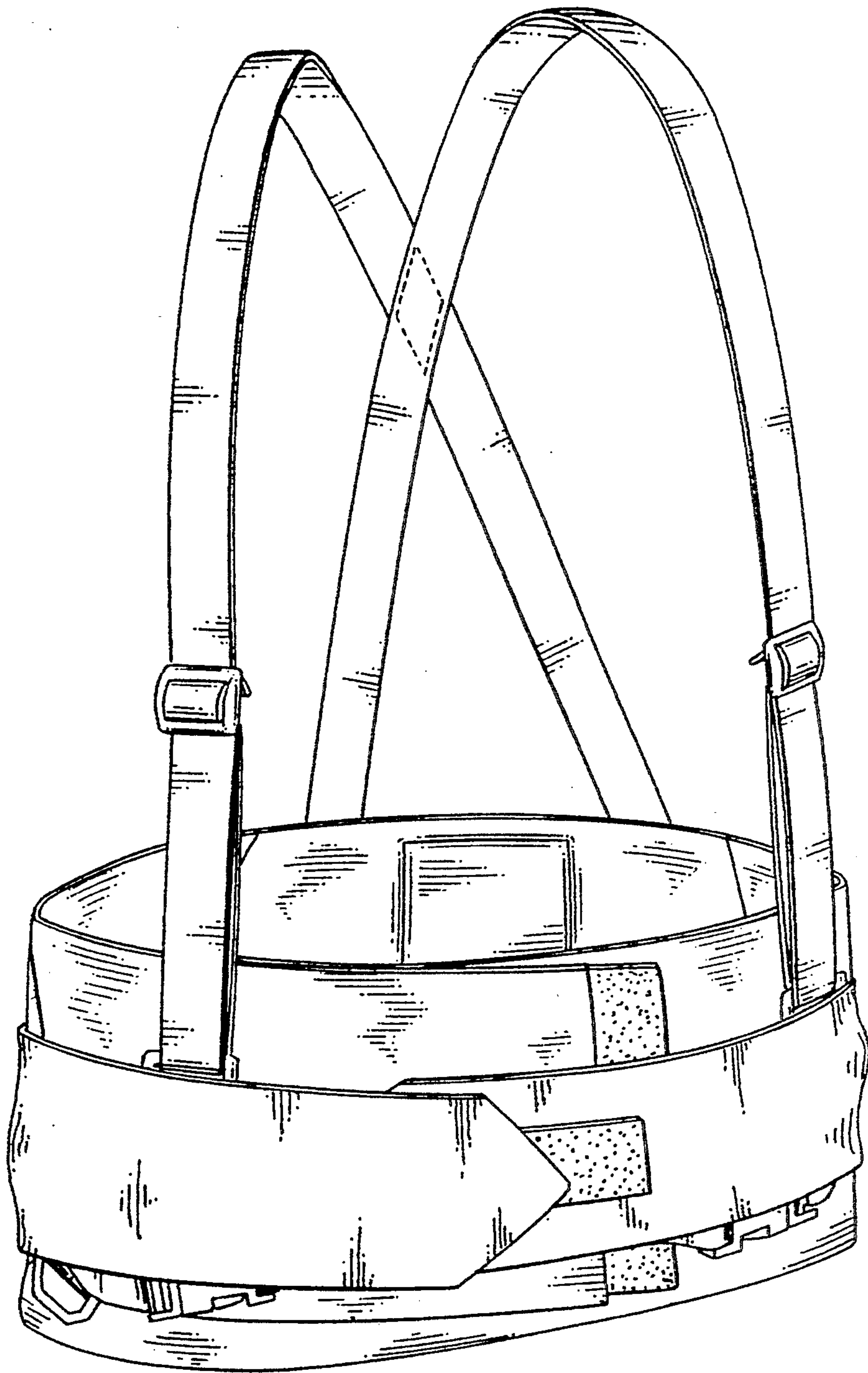

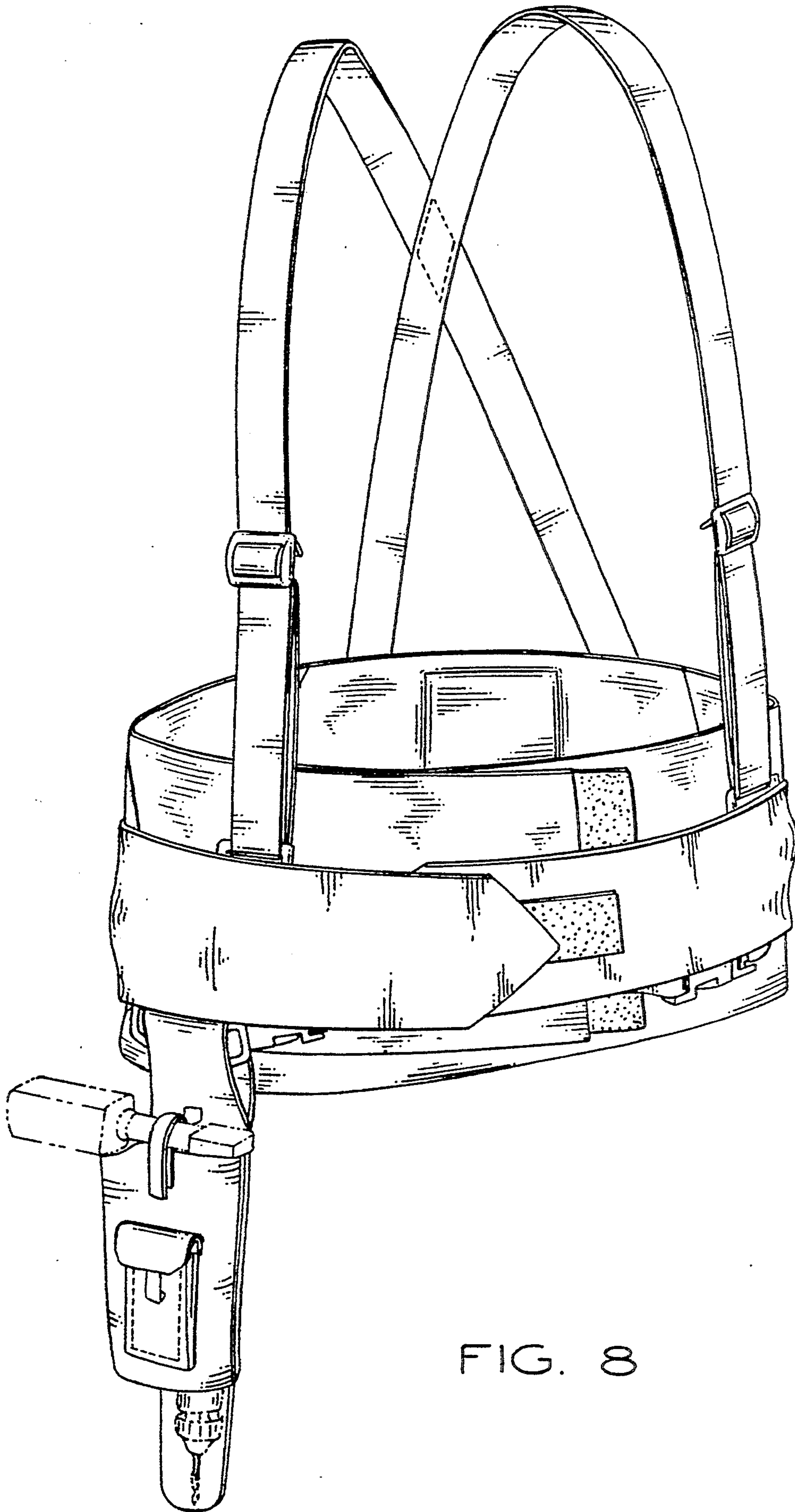

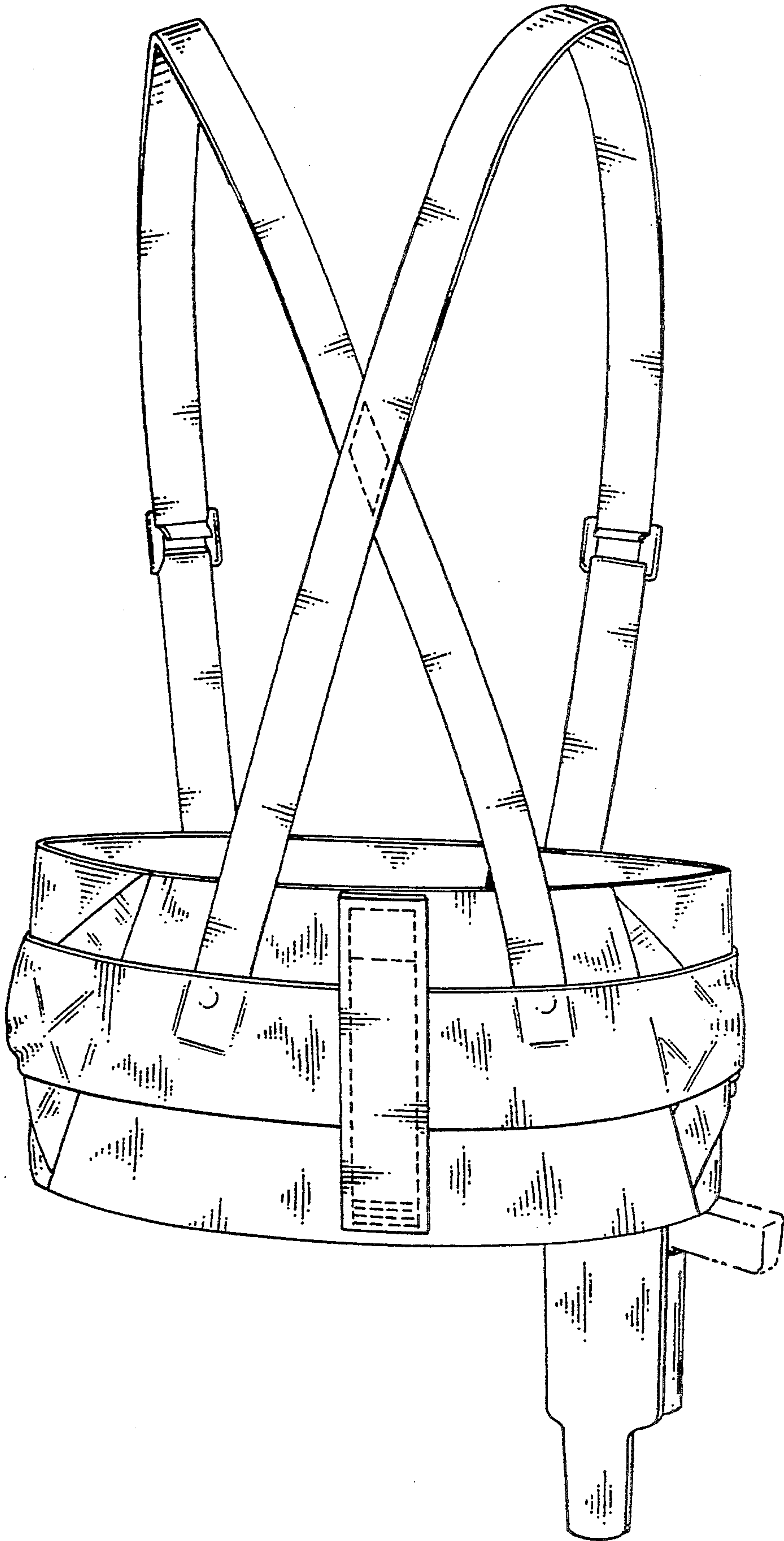

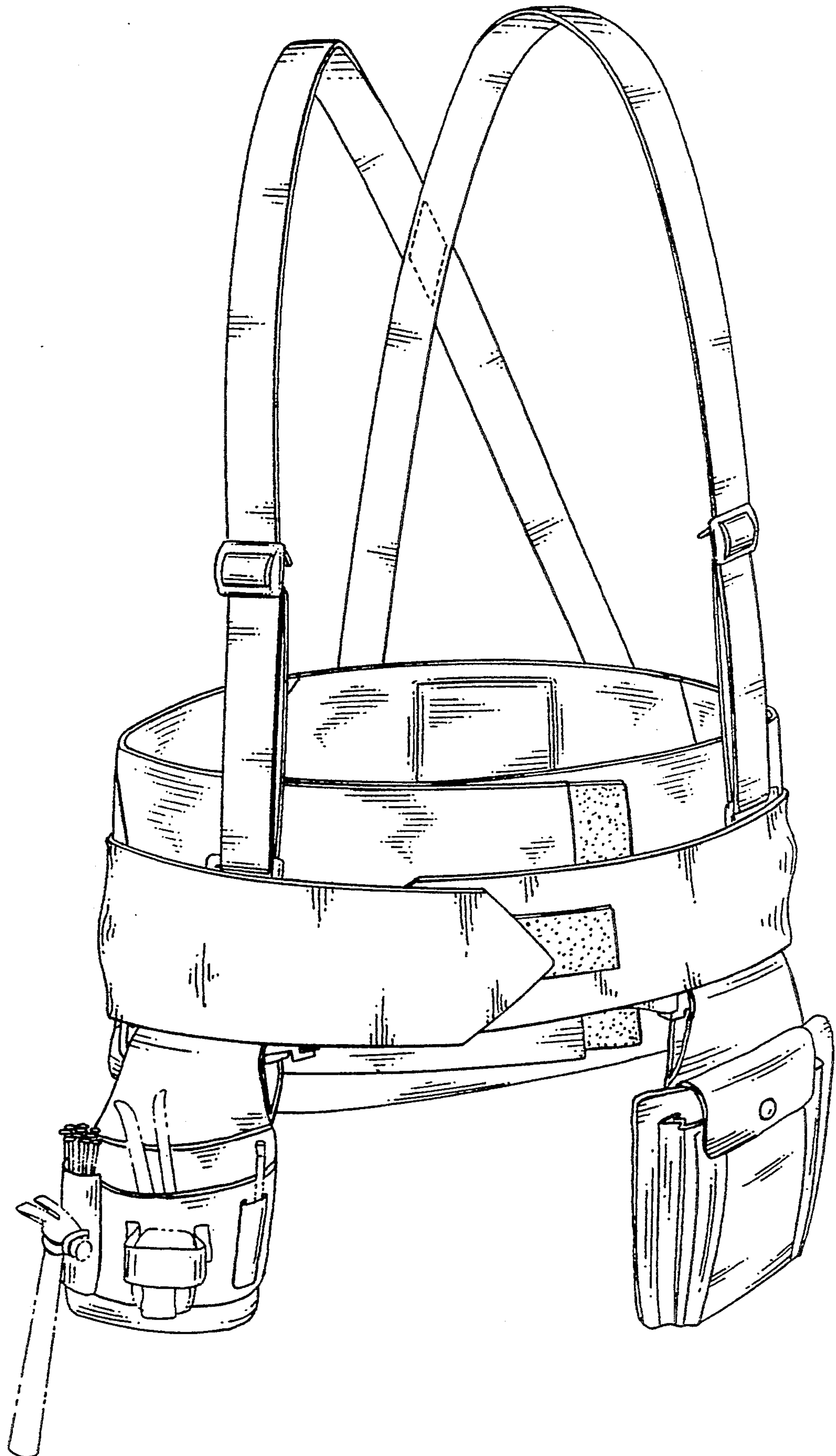

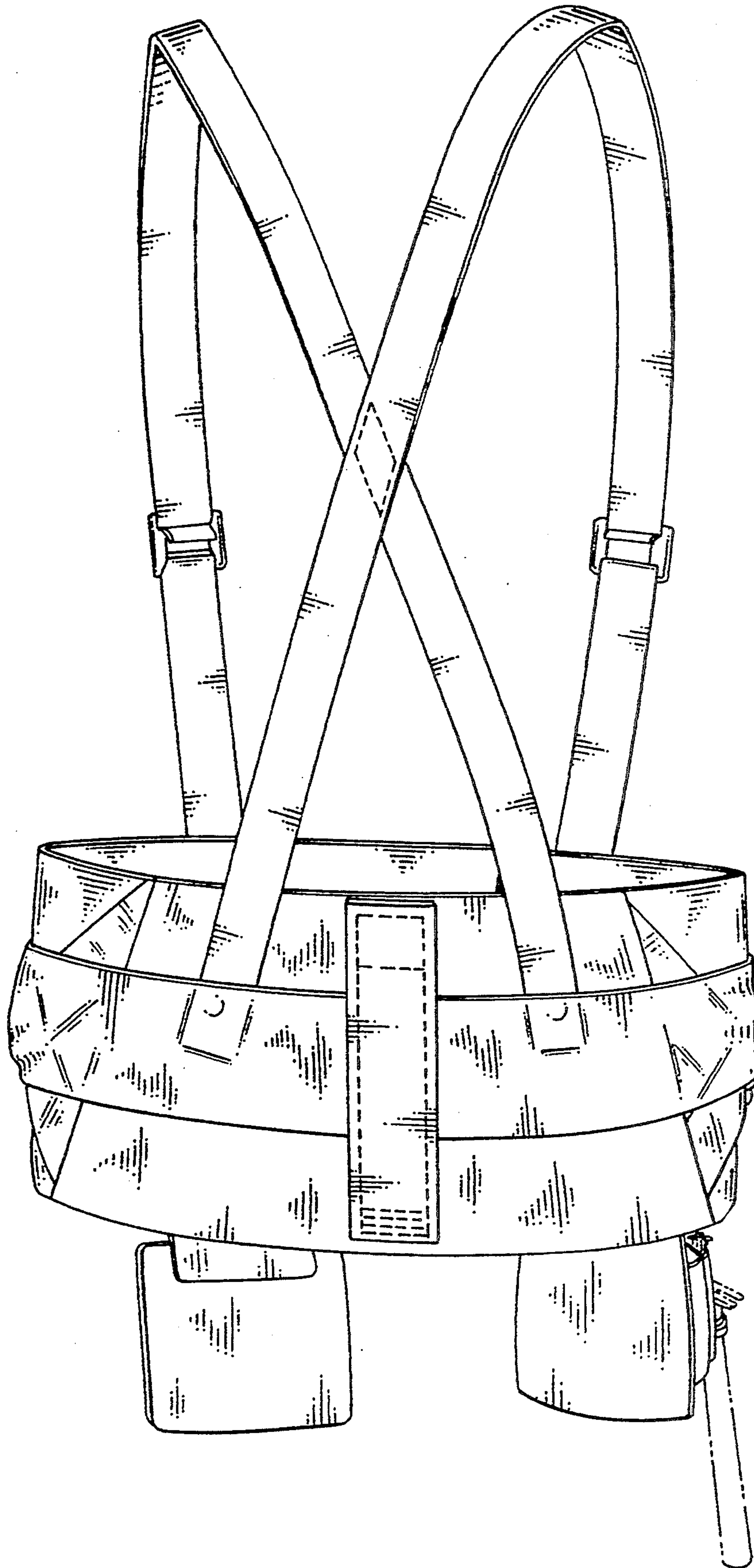
