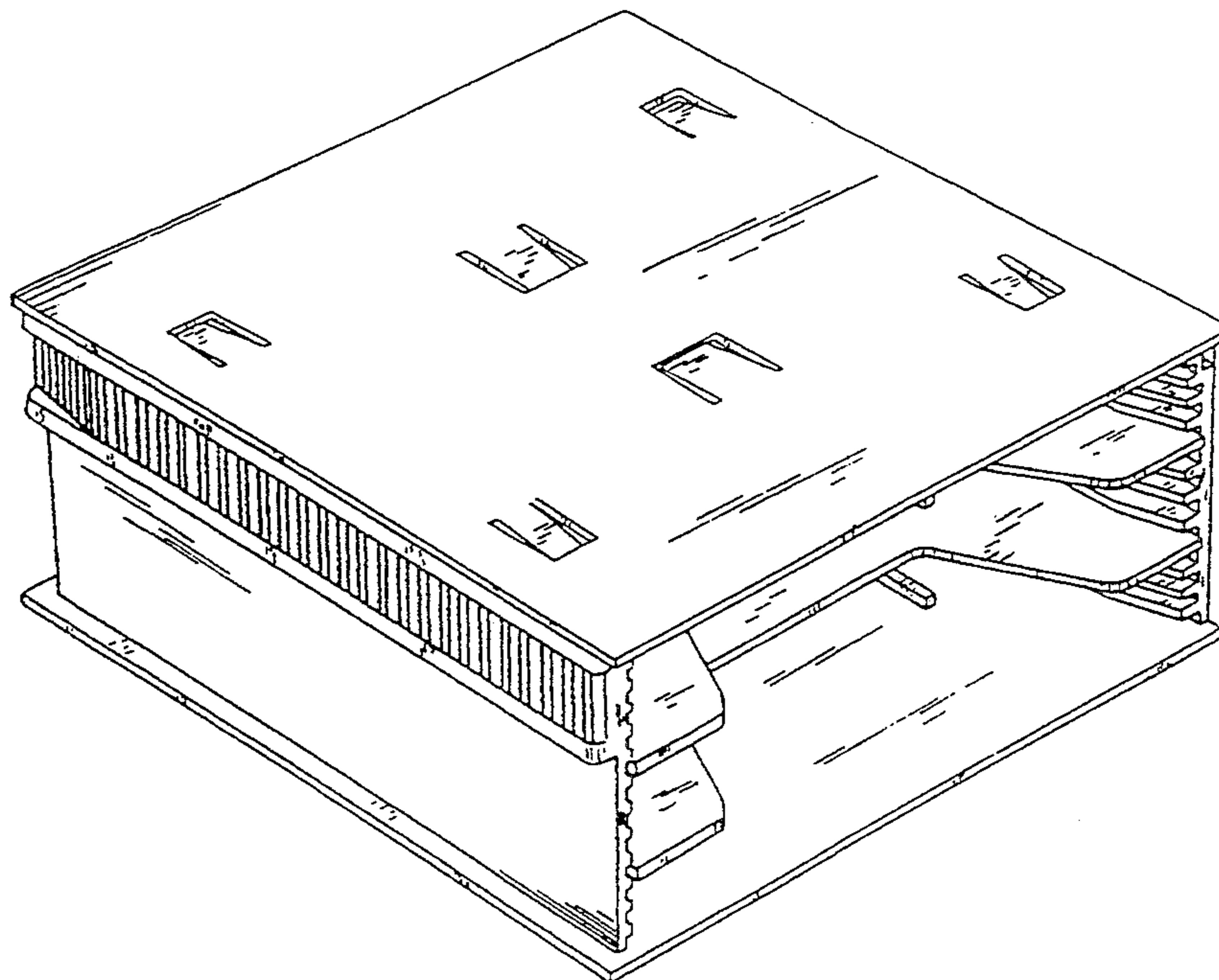

FIG. 10 is a perspective view from below showing the interior of one end of the magazine of FIG. 1.



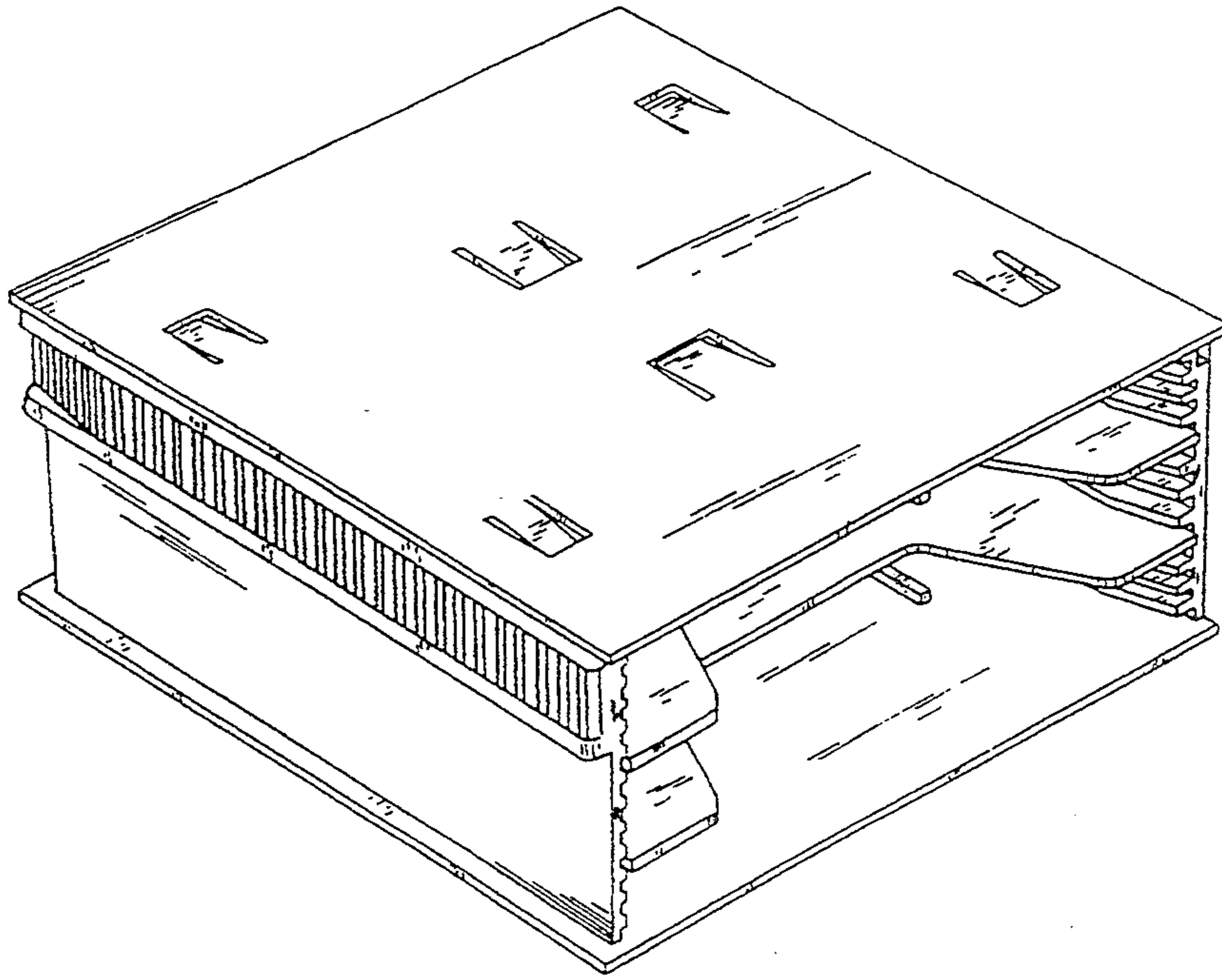

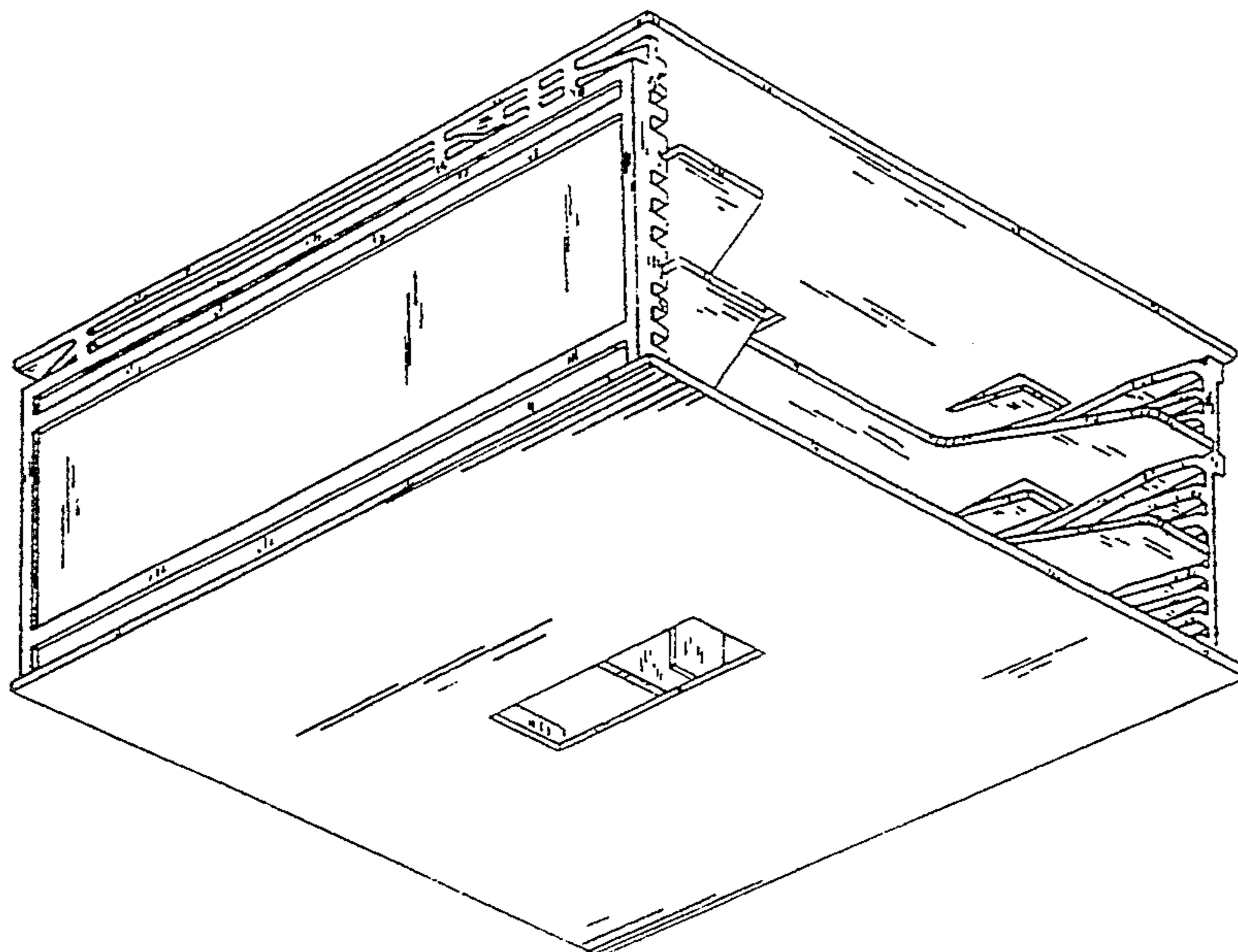

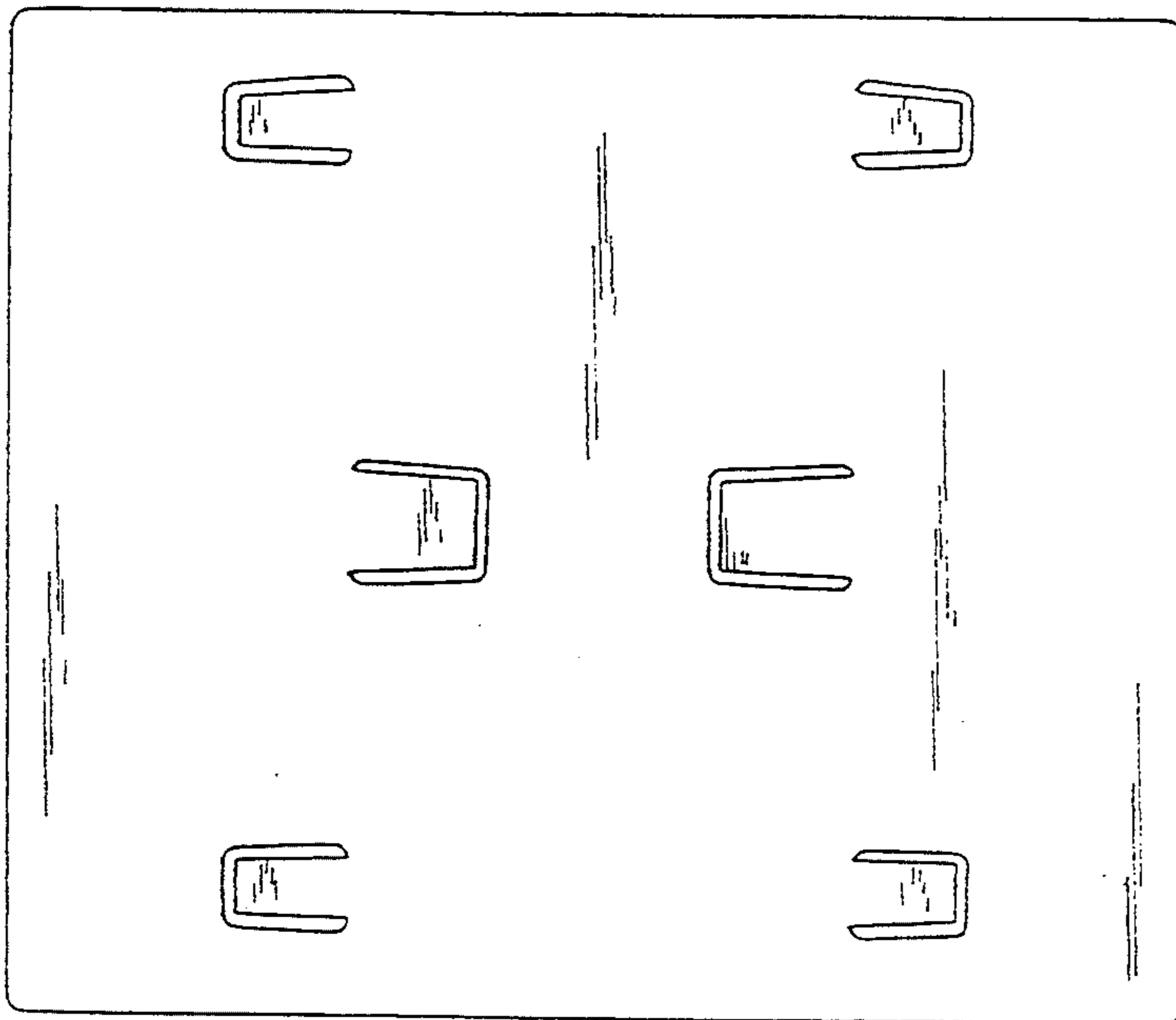

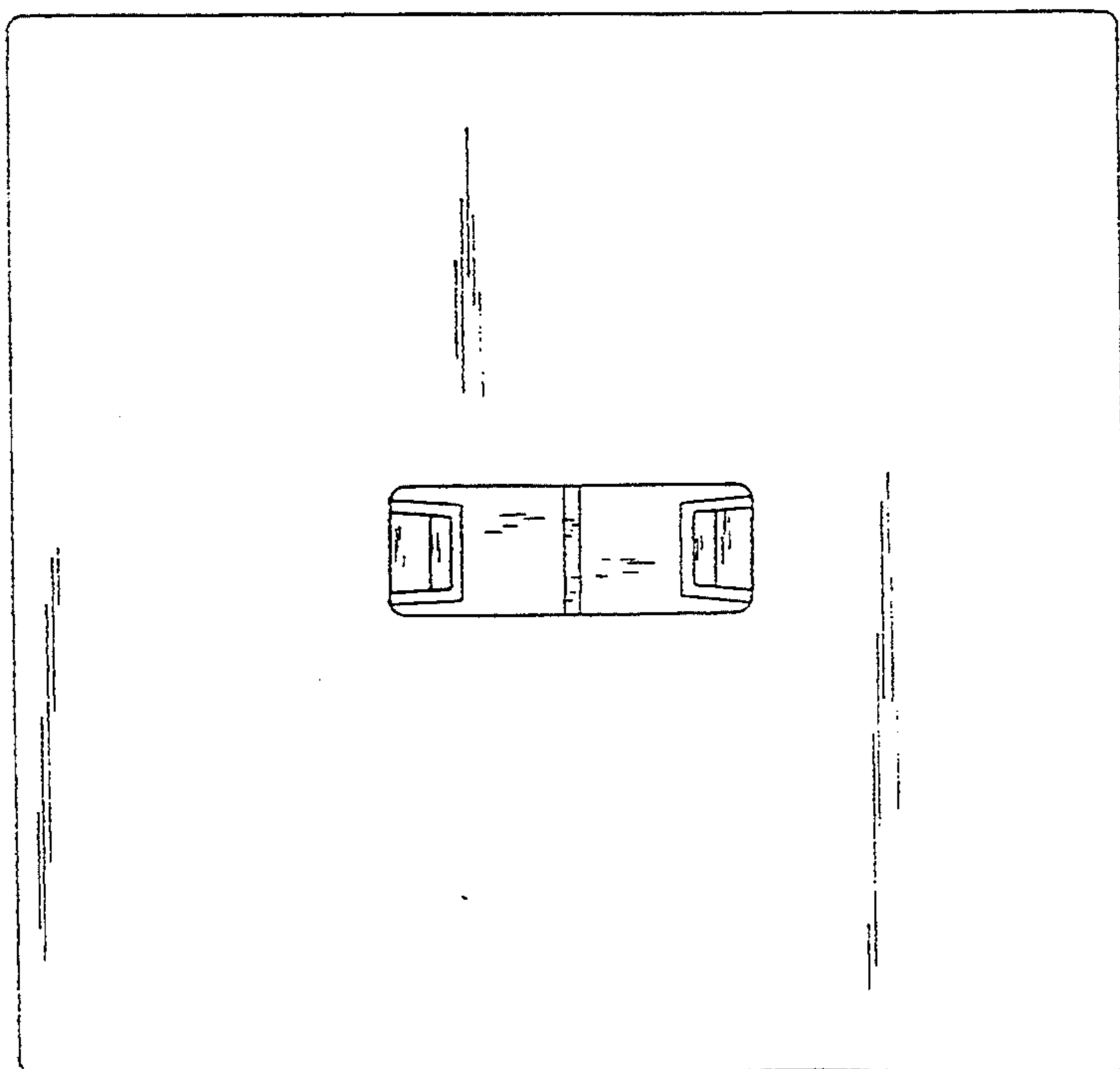

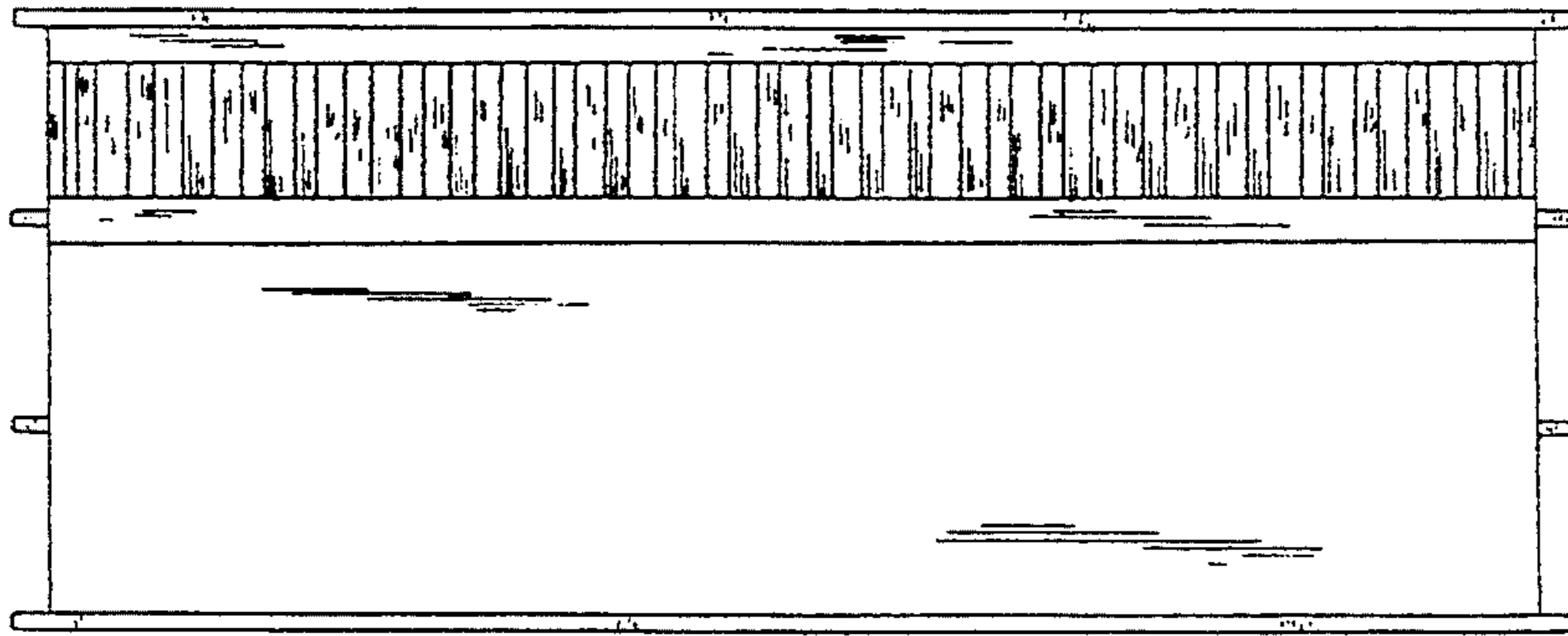

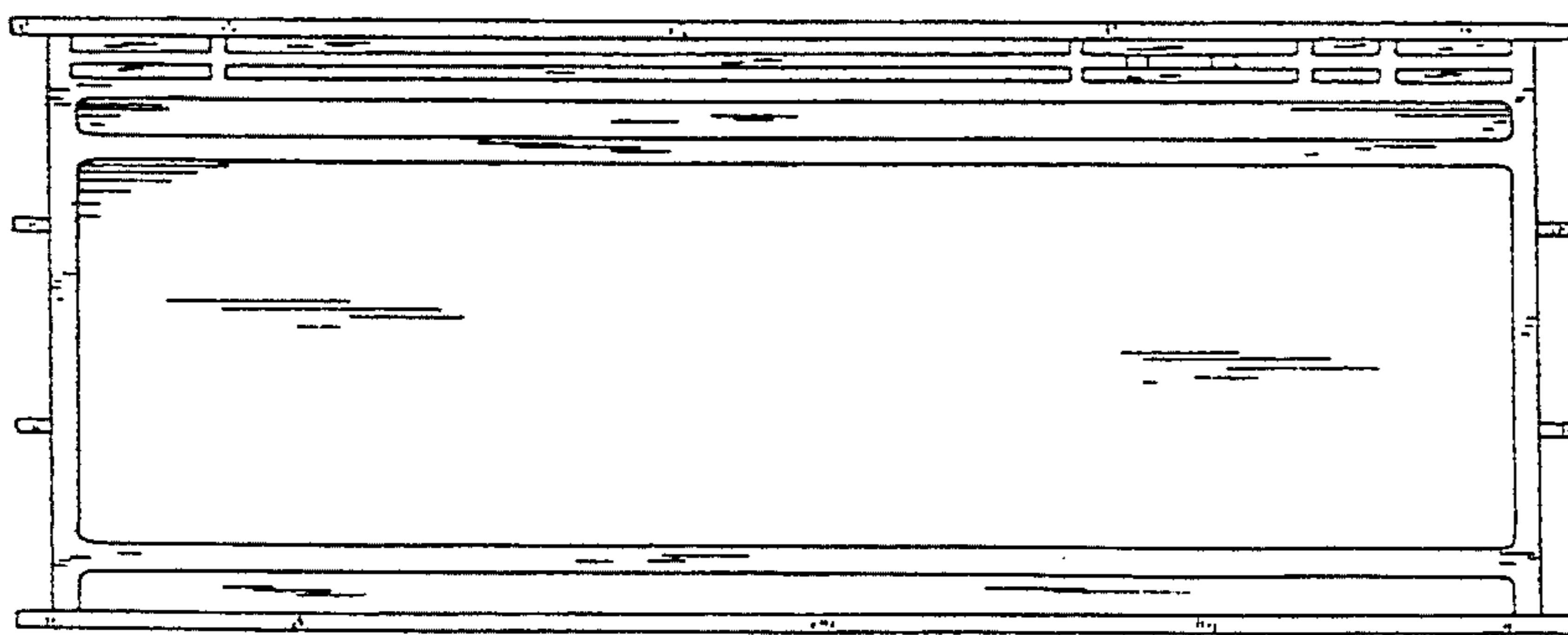

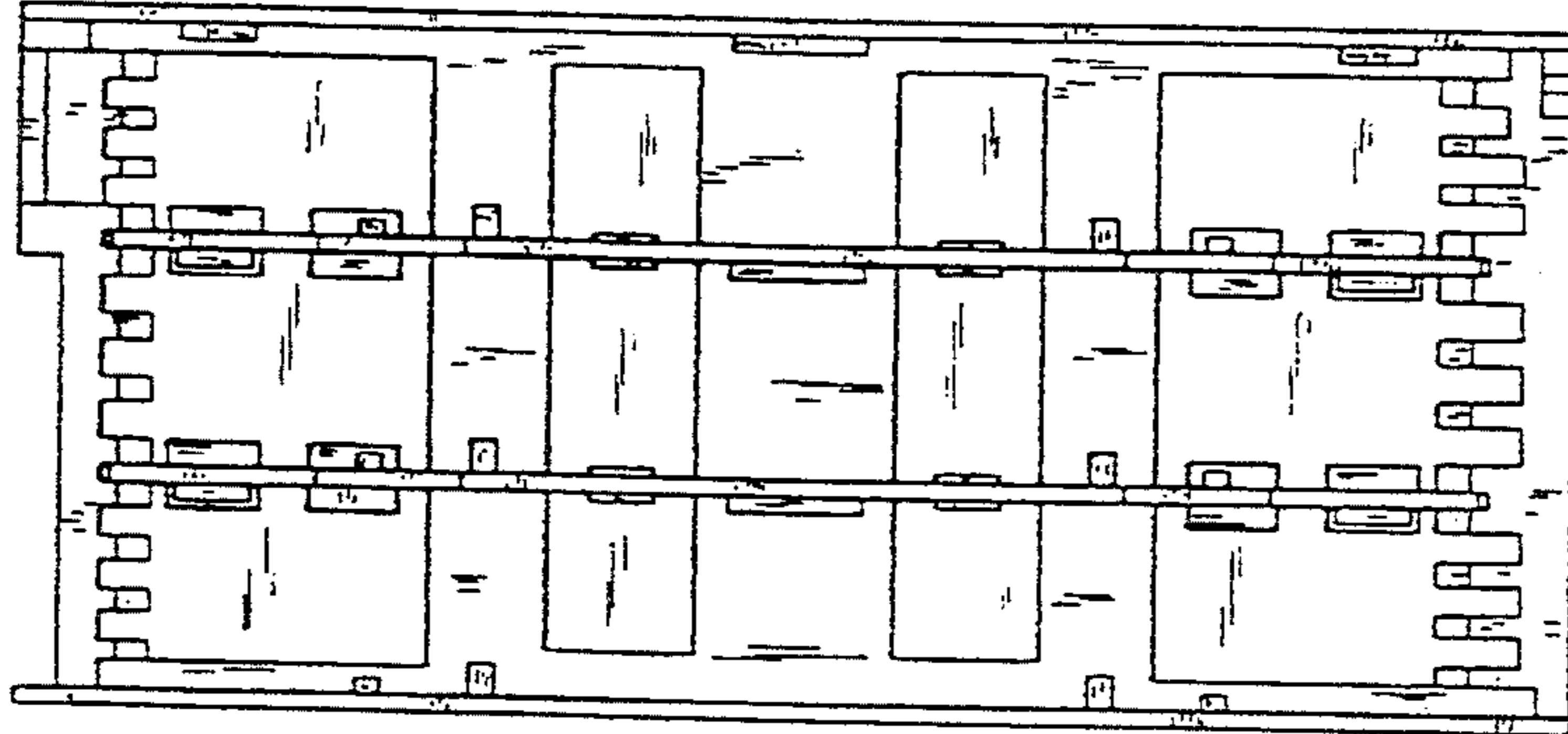

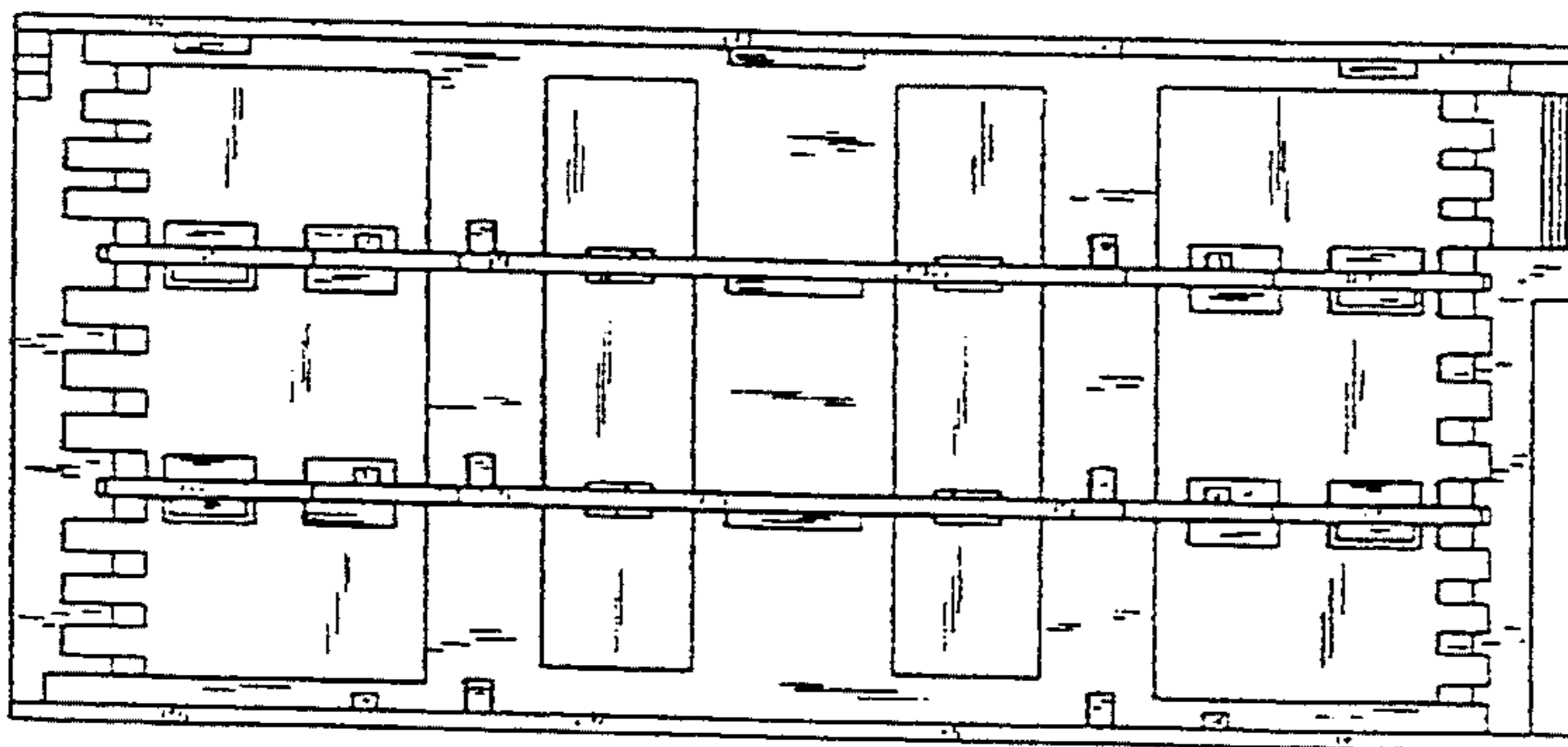

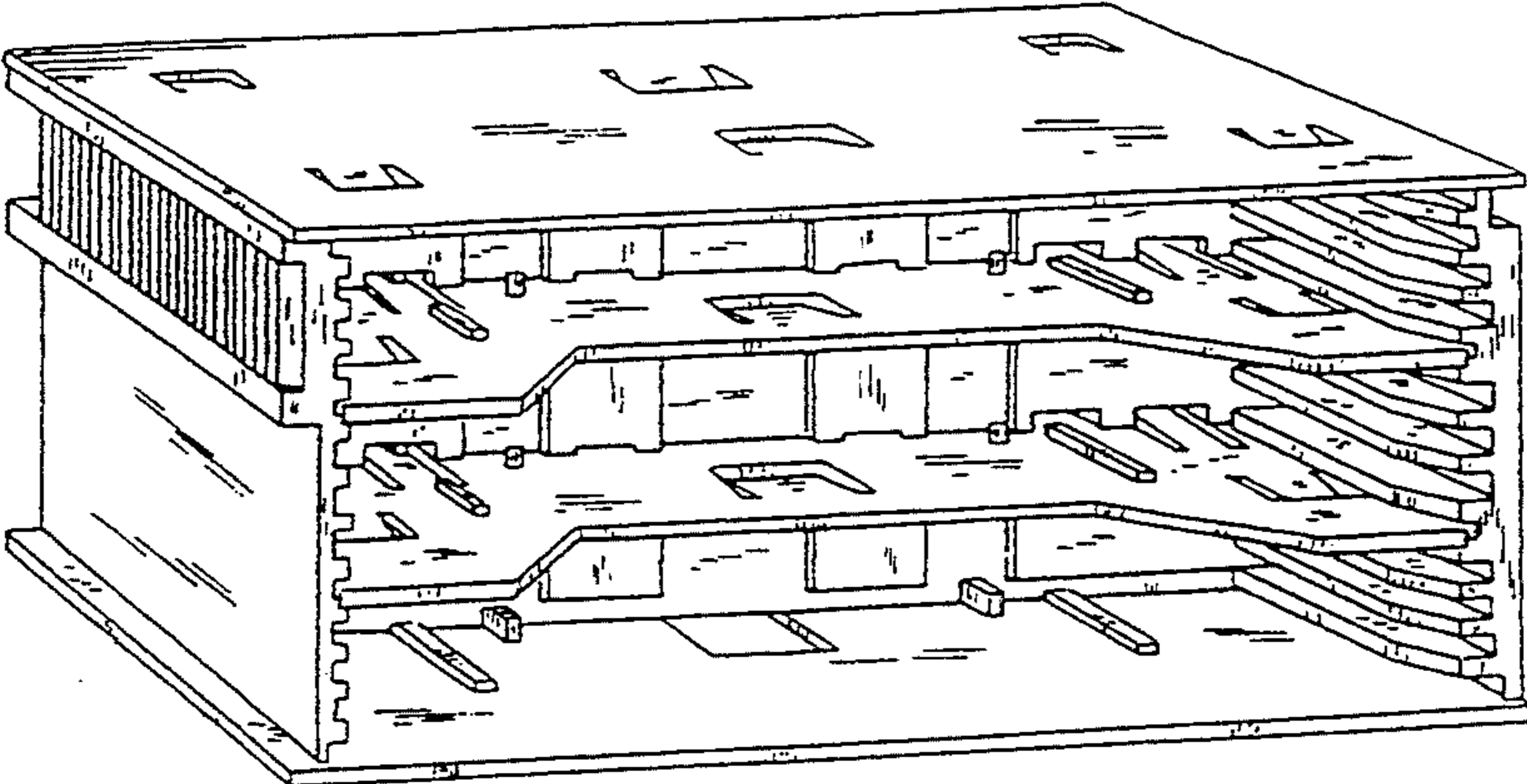

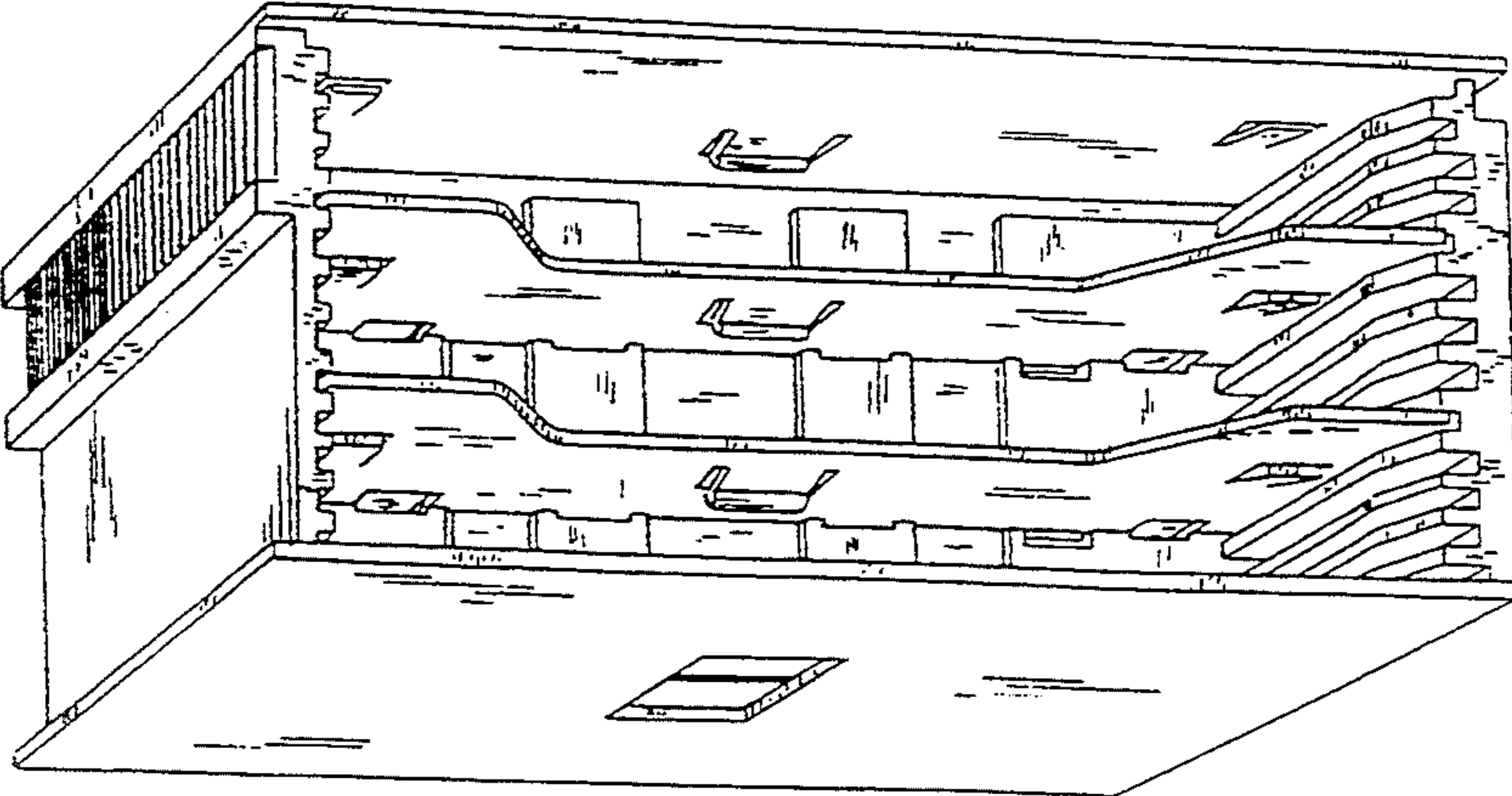
