FIG. 11 is a fragmentary front elevational view, on an enlarged scale, showing the region of the needle of the sewing machine;

FIG. 12 is a front perspective view taken from the right of FIG. 11; and,

FIG. 13 is a rear perspective view taken from the left of FIG. 11.

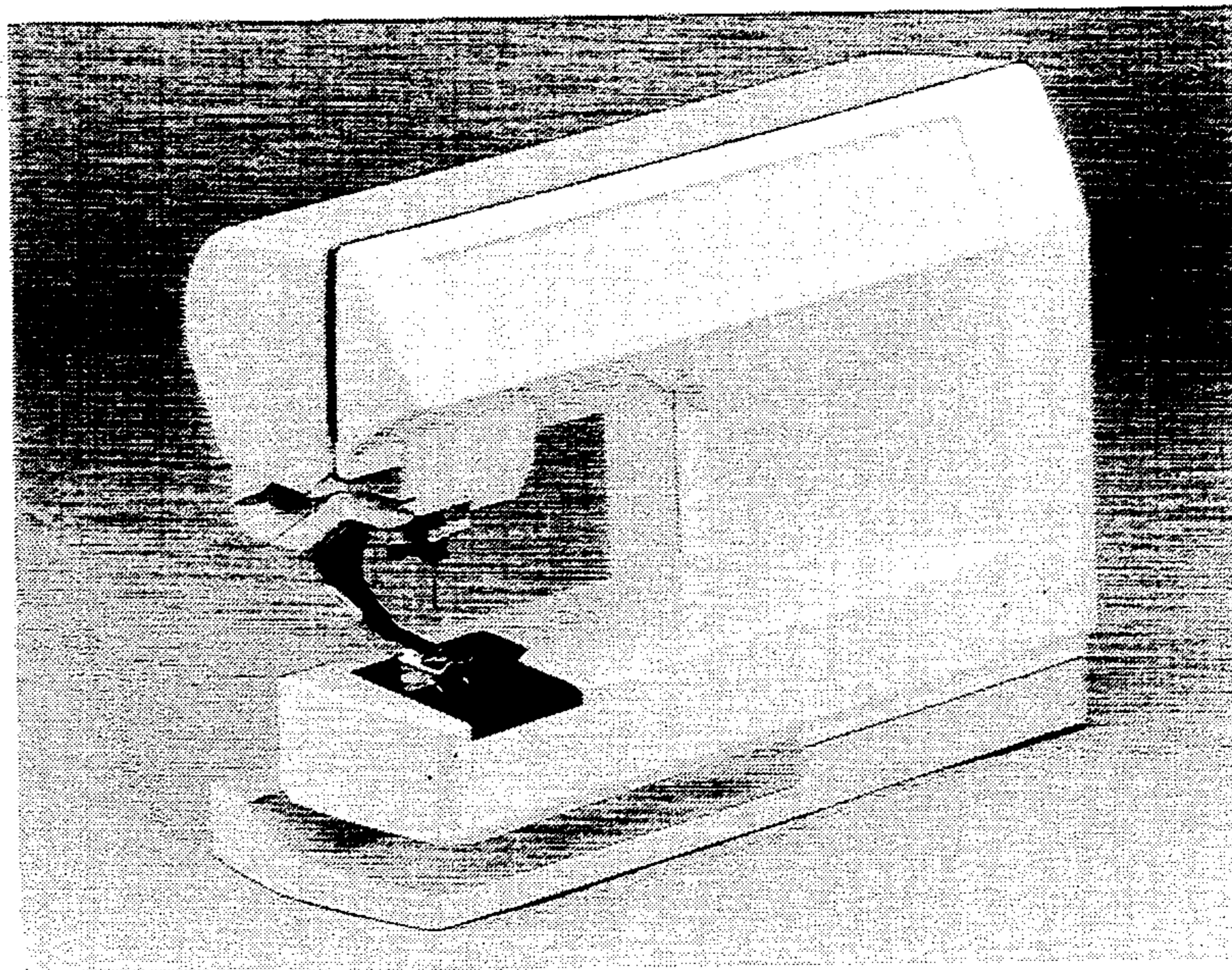

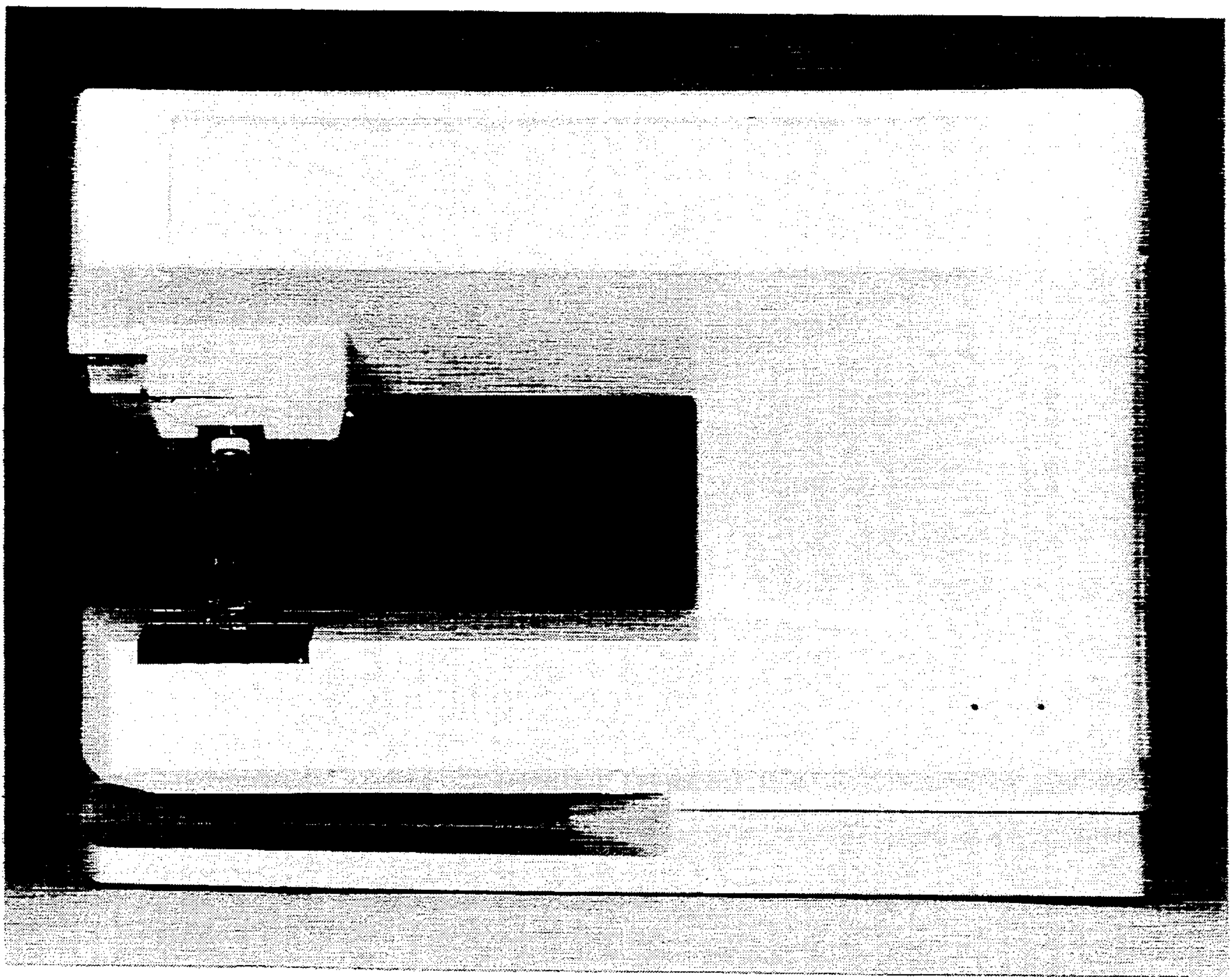

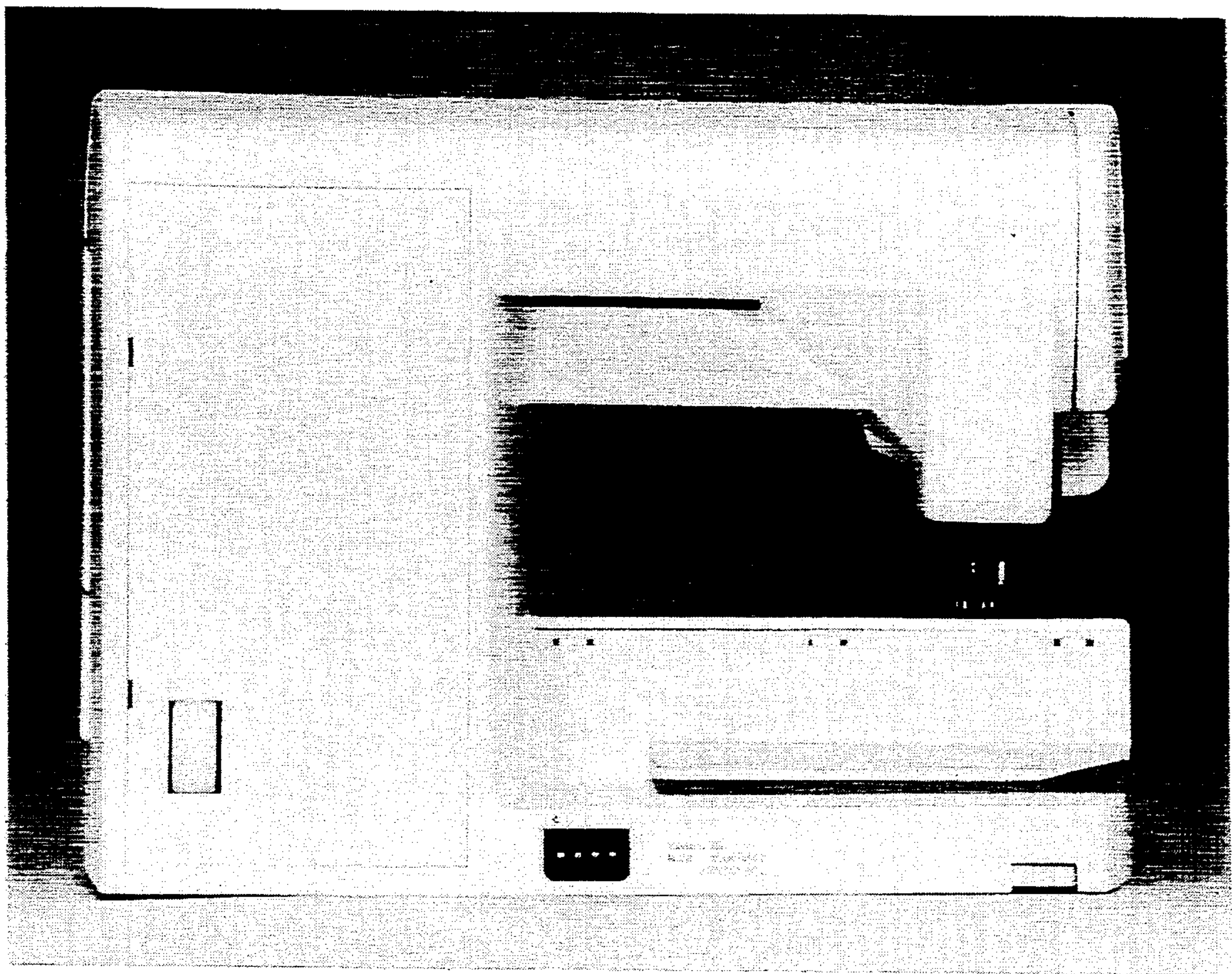

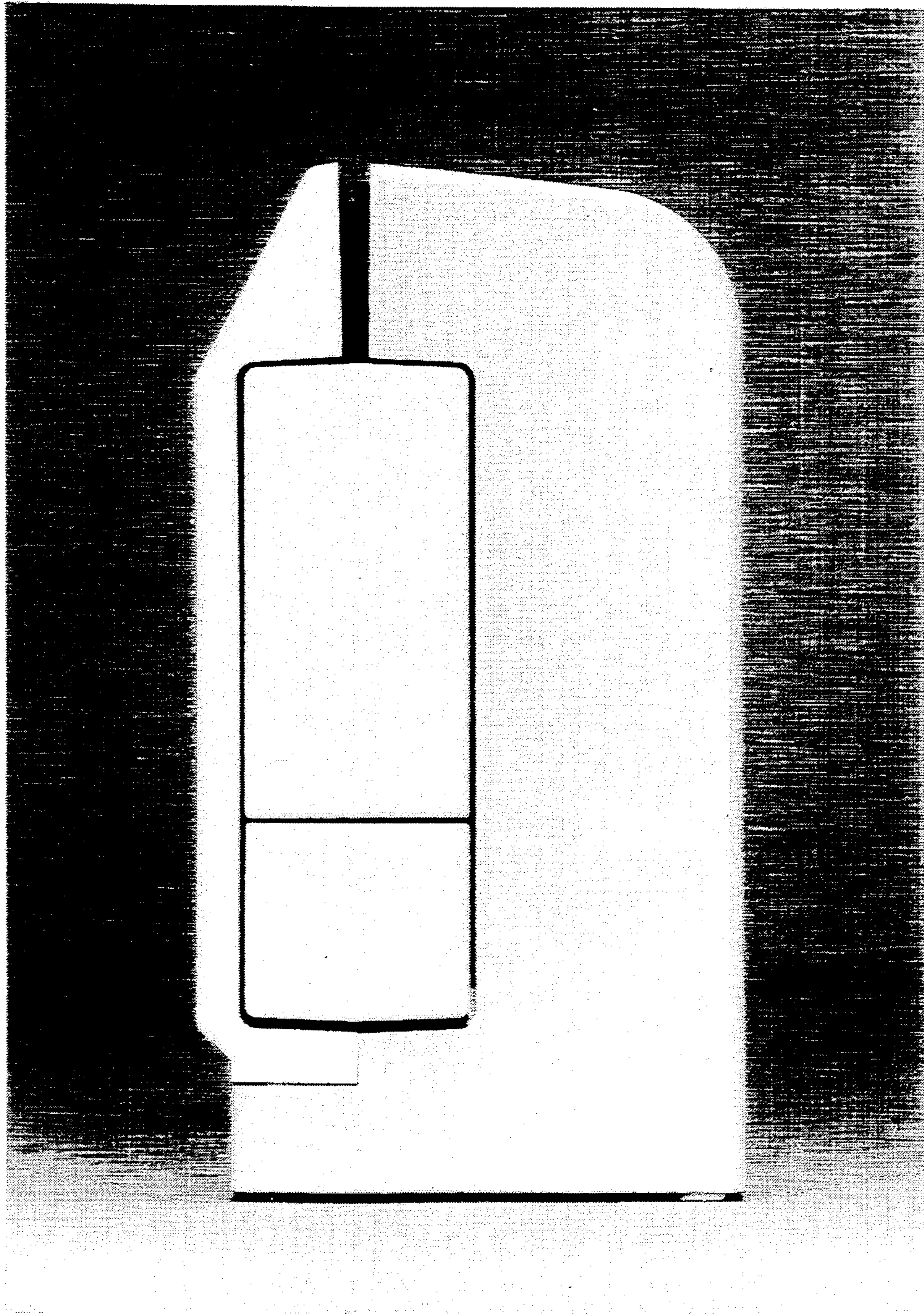

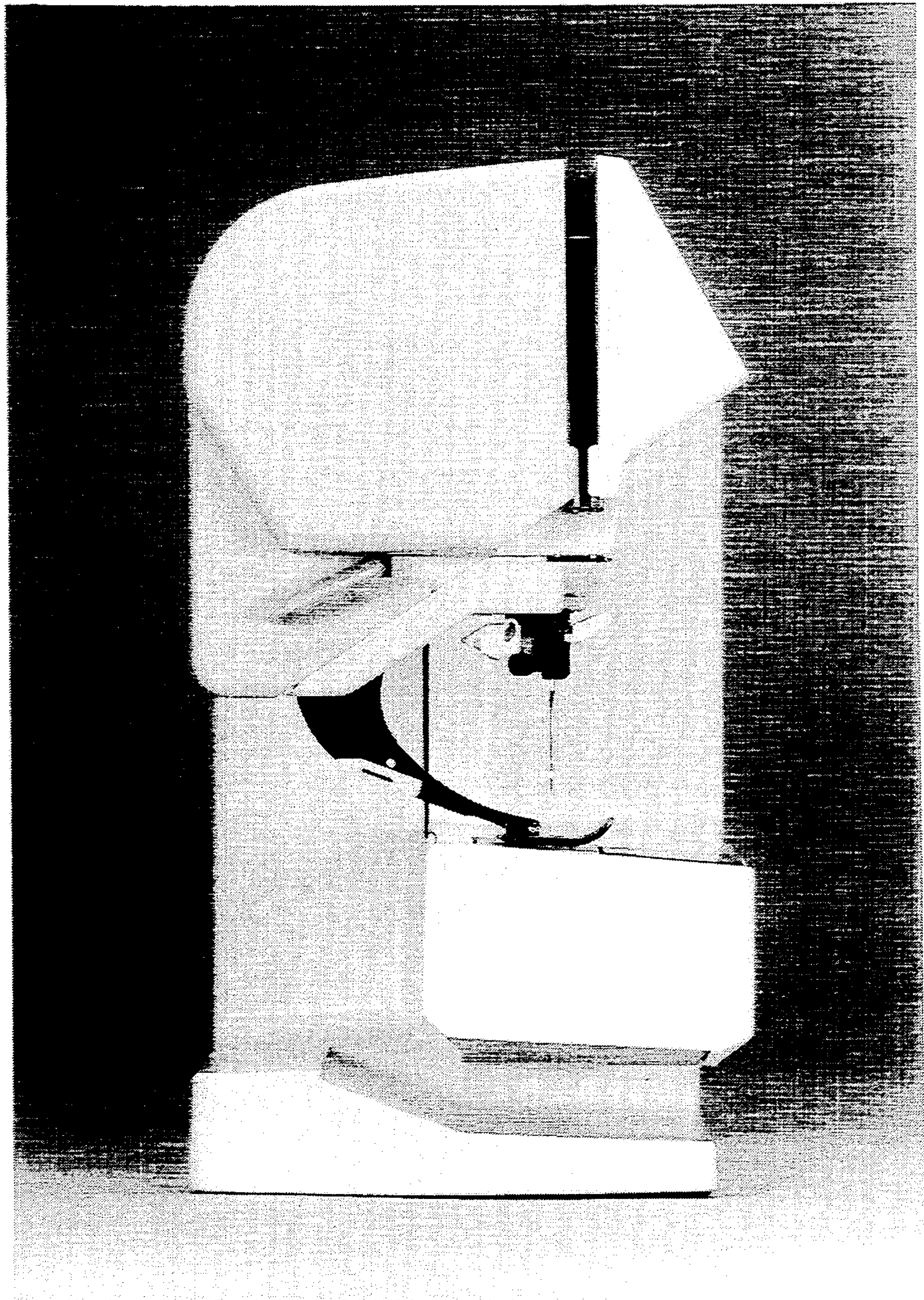

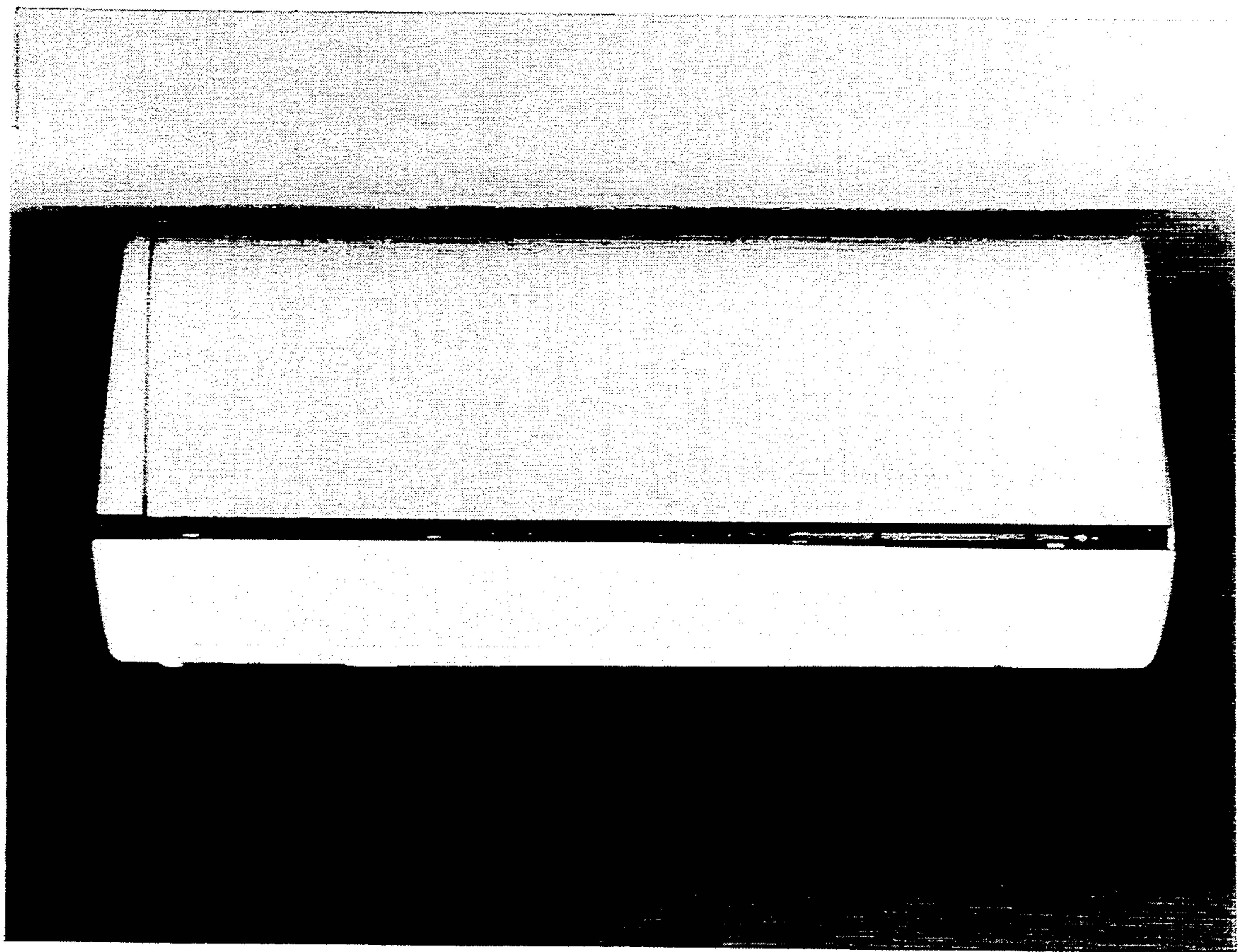

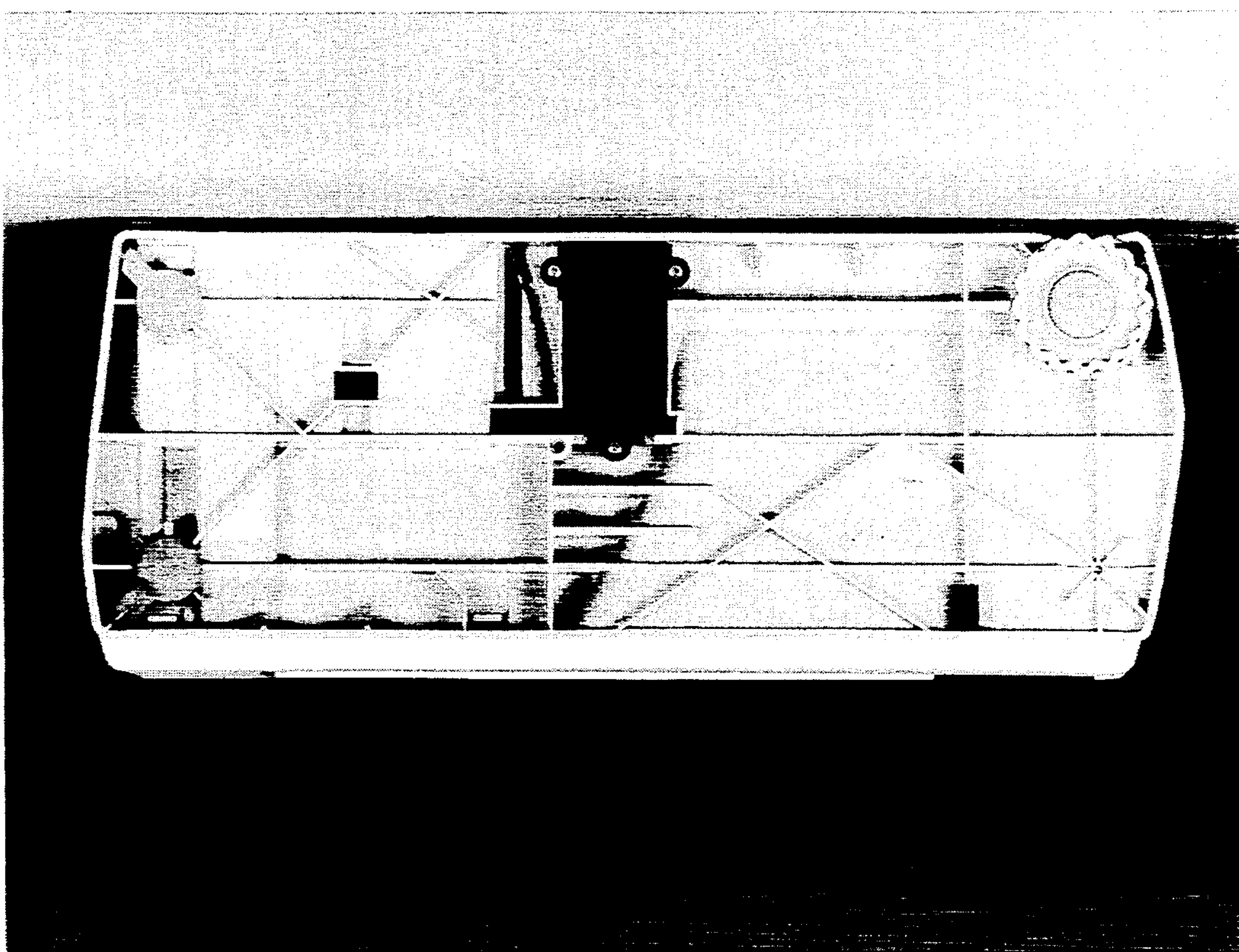

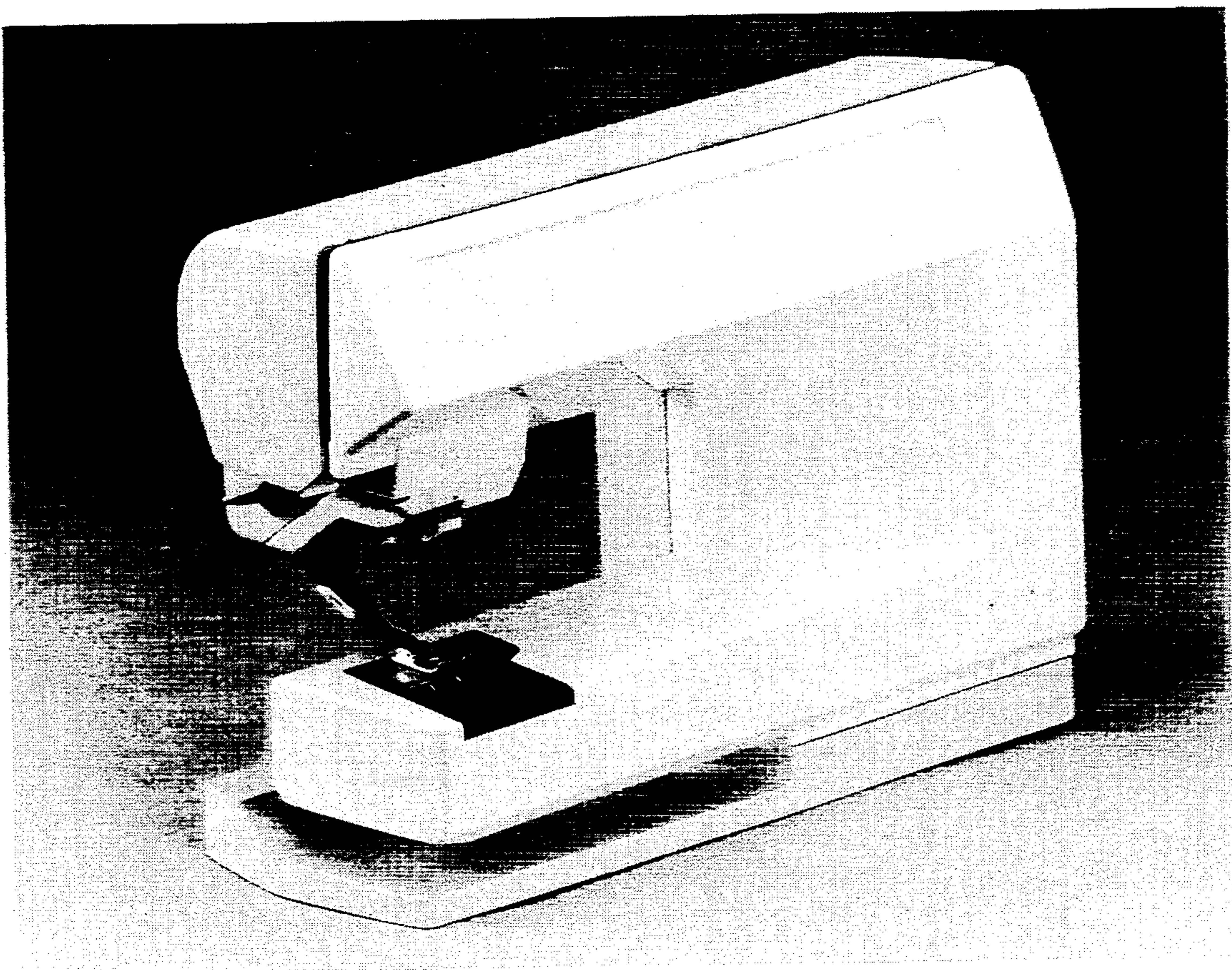

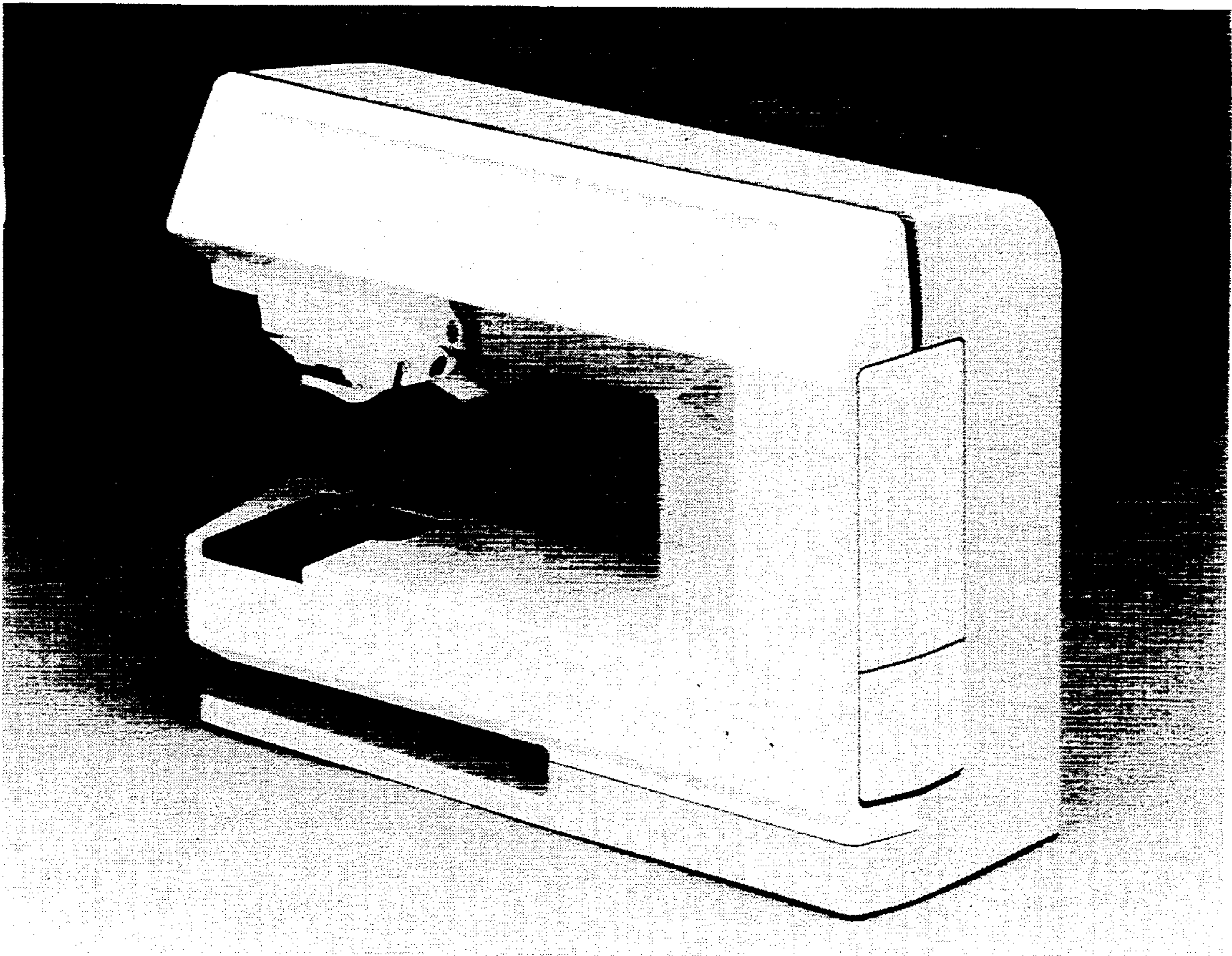

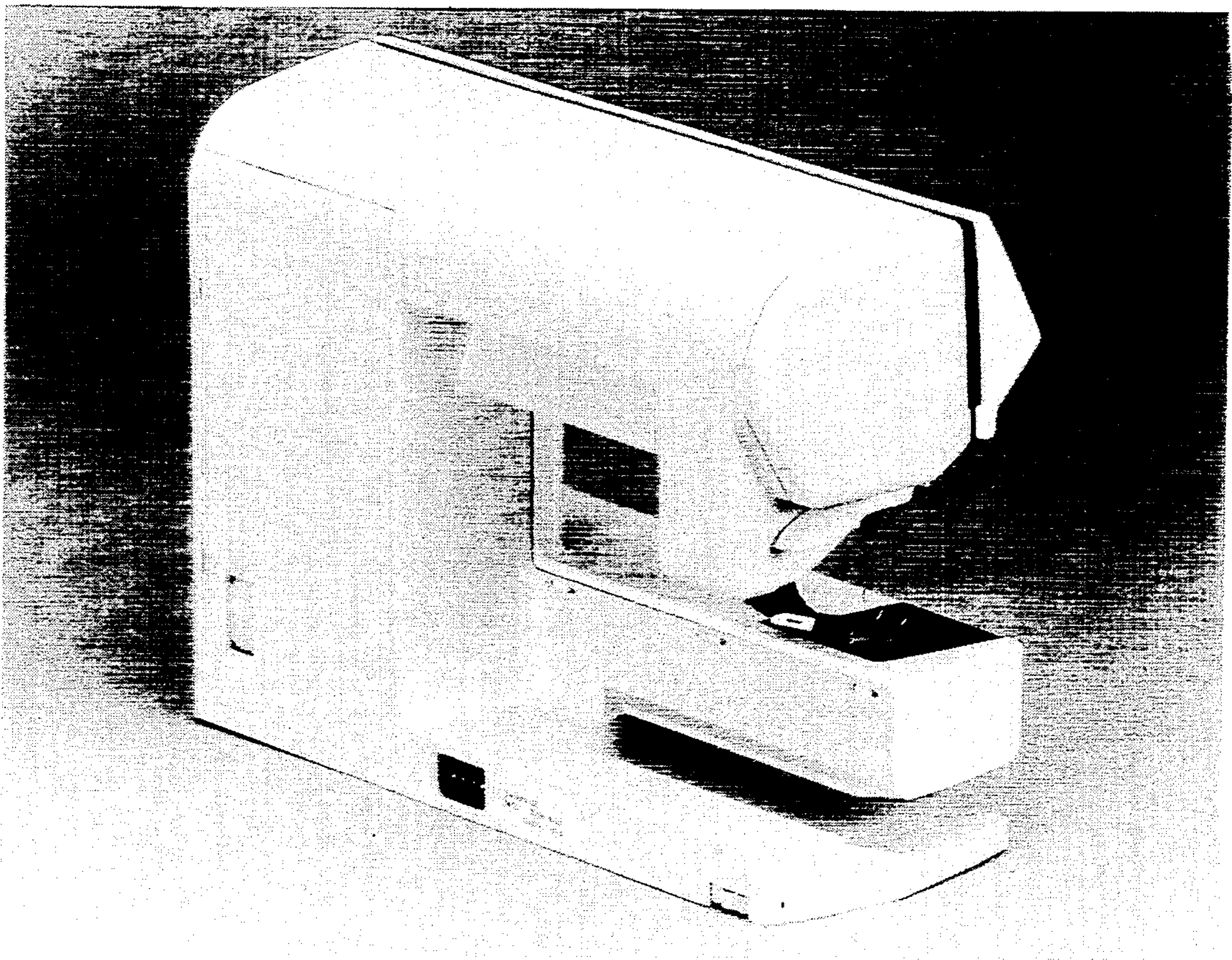

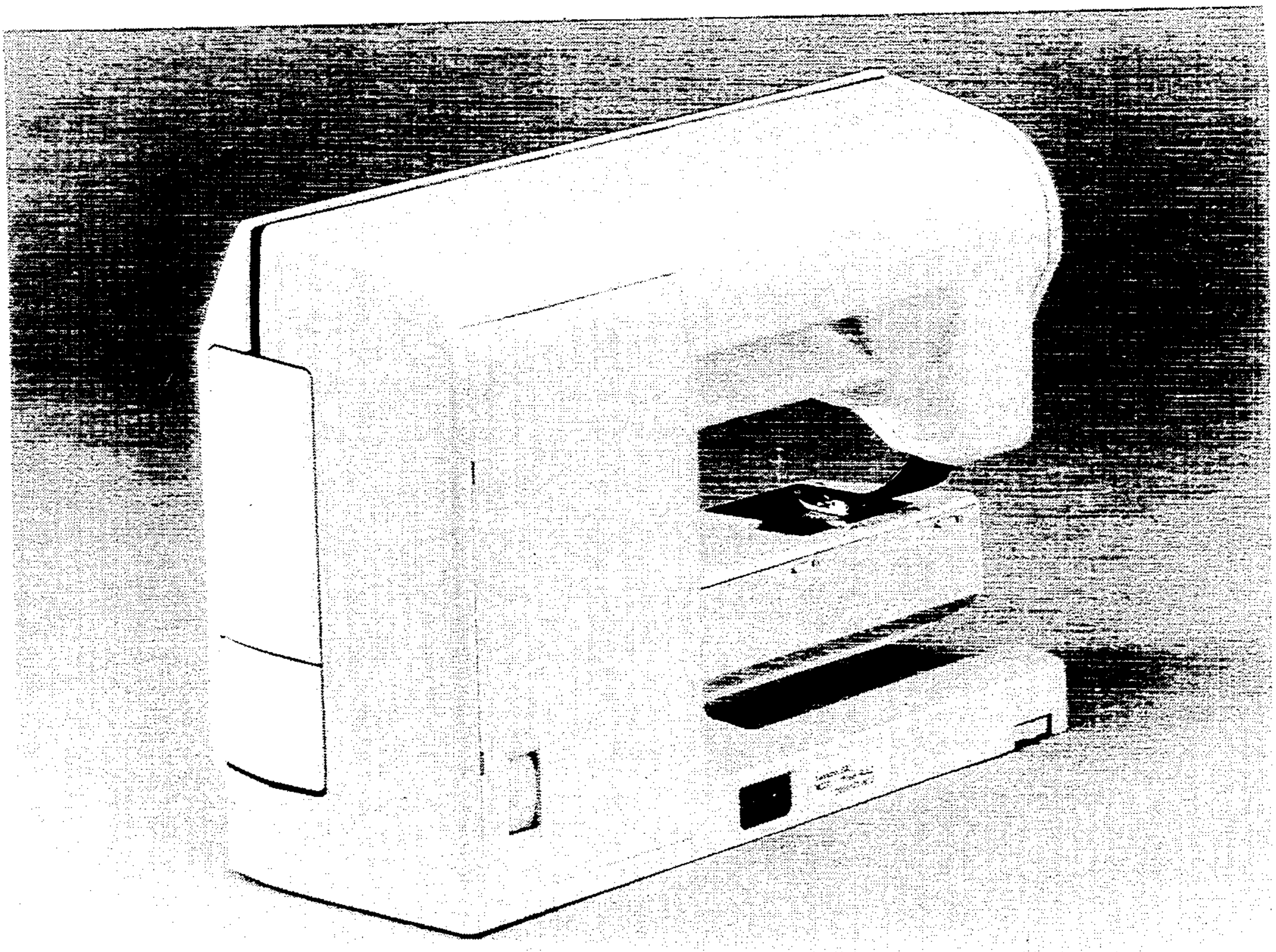

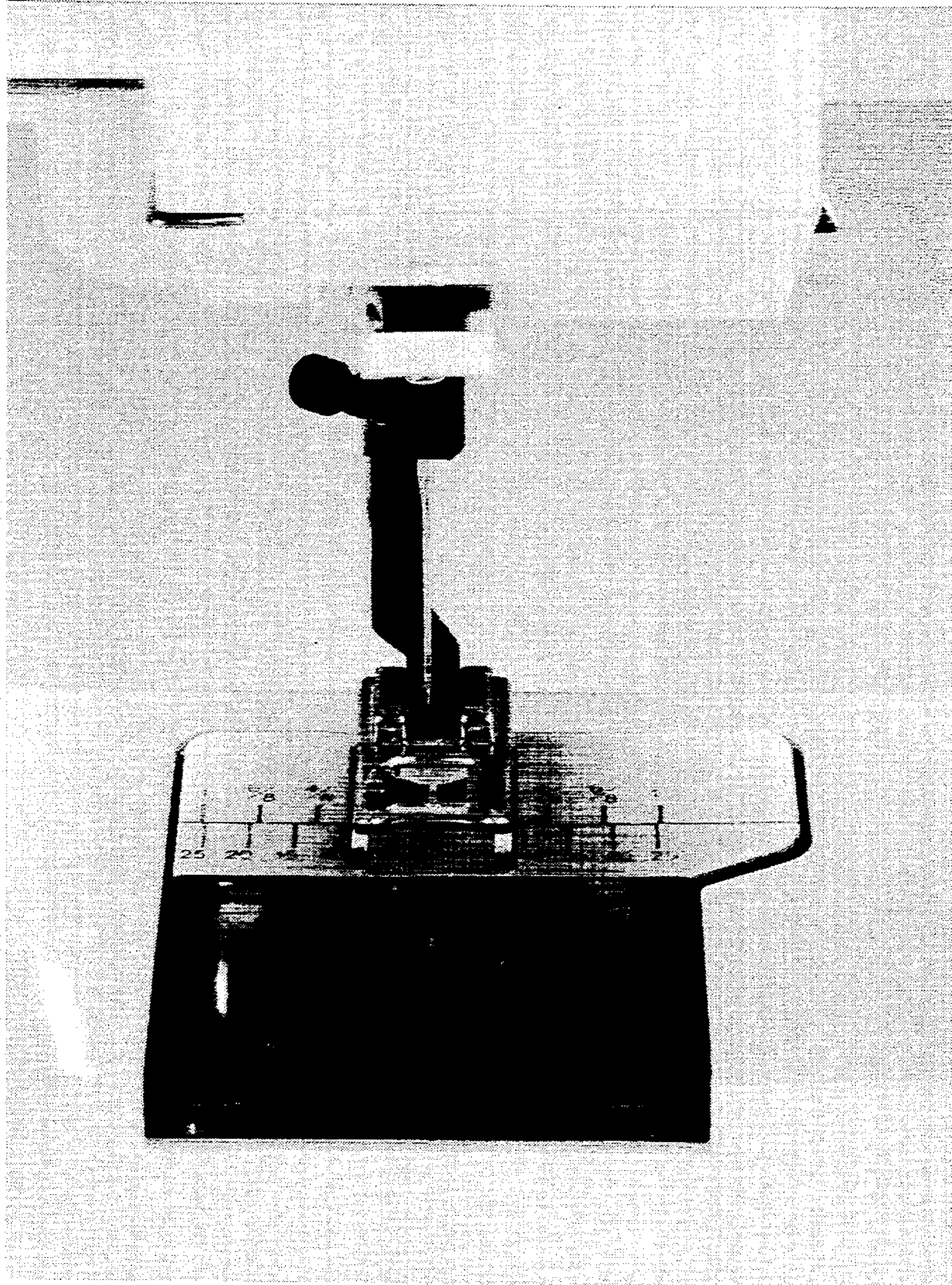

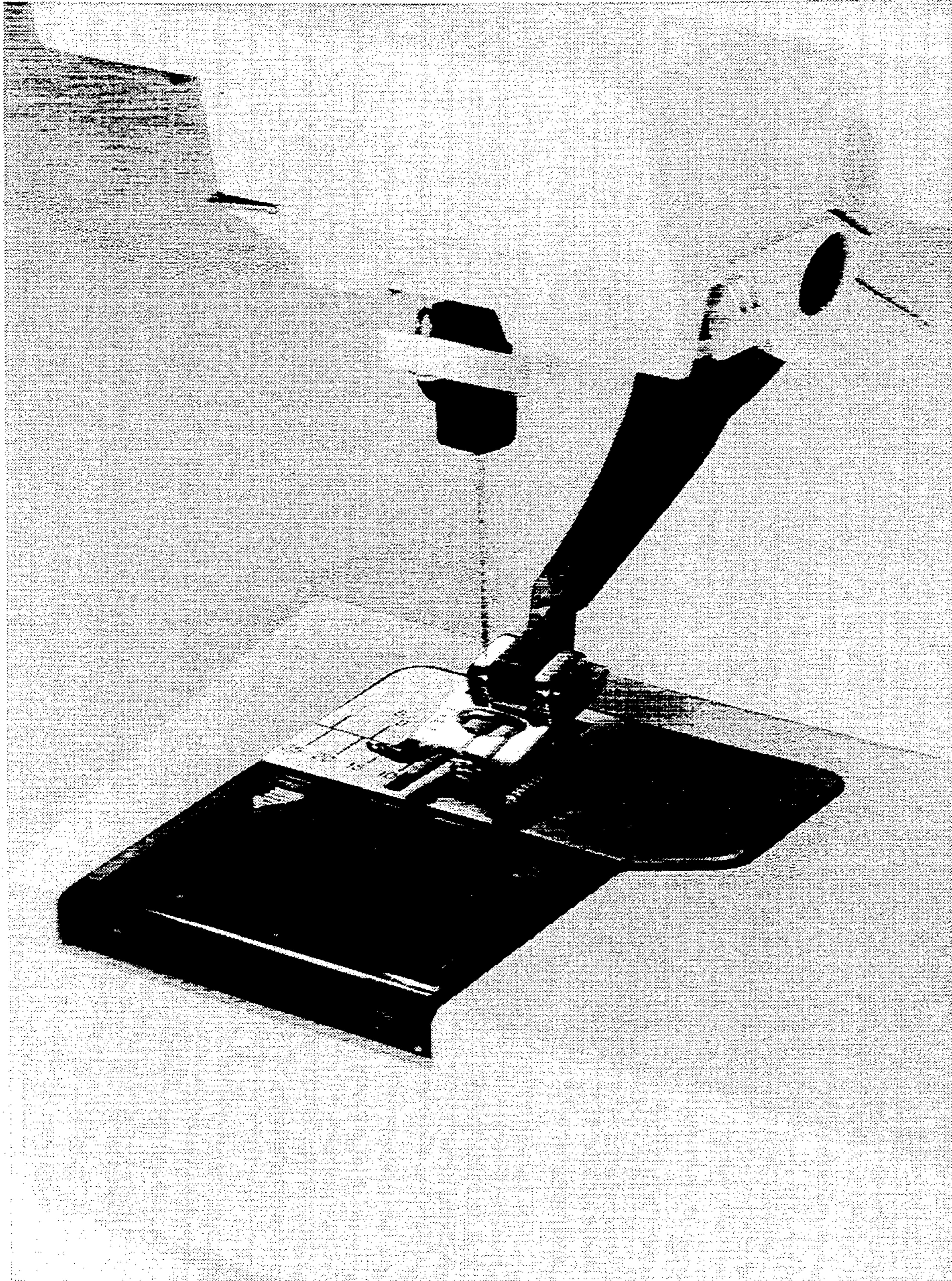

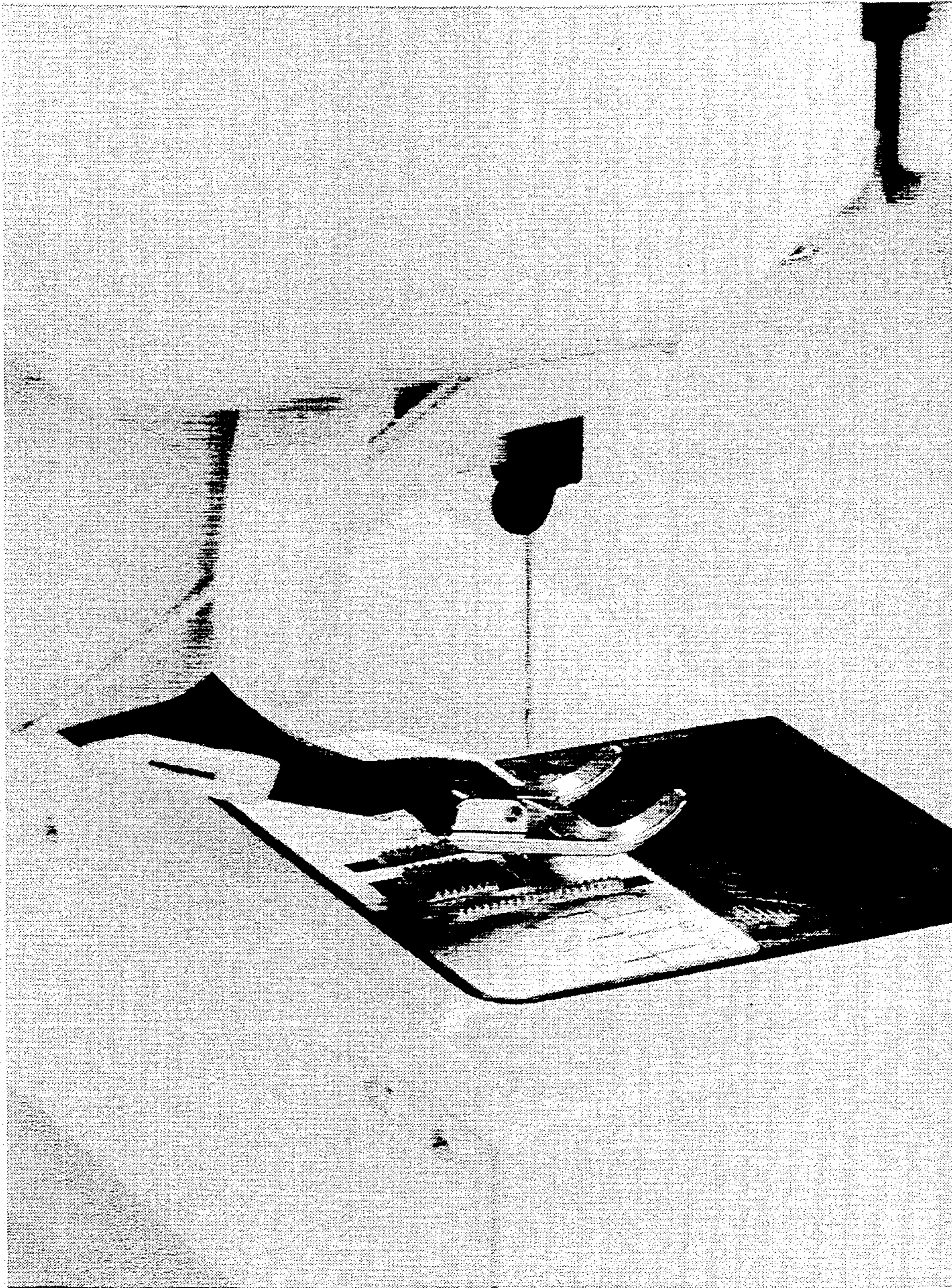
