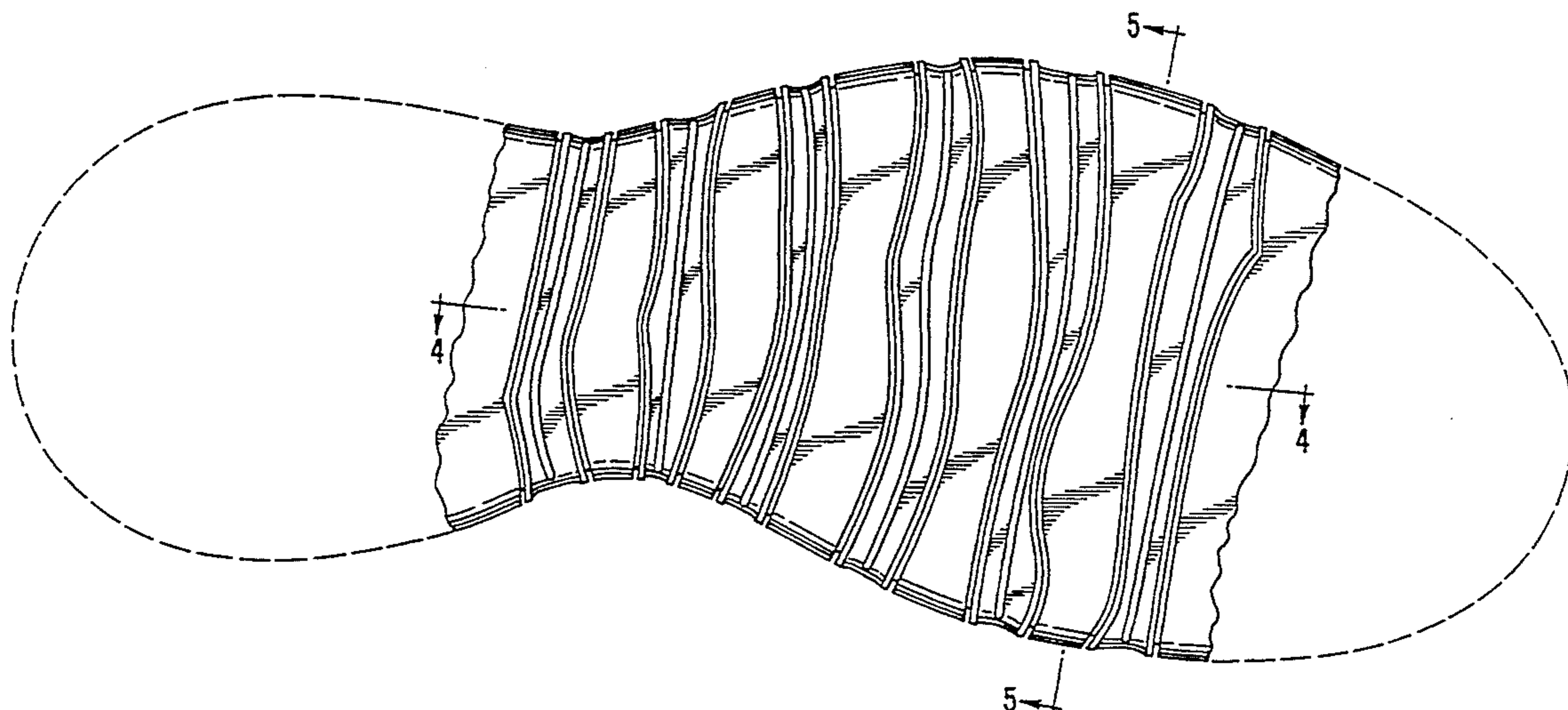

[57] CLAIM

The ornamental design for a portion of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a portion of a shoe outsole showing my new design;
 FIG. 2 is a side elevational view of the portion of a shoe outsole;
 FIG. 3 is a side elevational view of the other side thereof;
 FIG. 4 is a cross section view of the portion of a shoe outsole taken through line 4—4 of FIG. 1; and,
 FIG. 5 is a cross section view of the portion of a shoe outsole taken through line 5—5 of FIG. 1.
 The broken line showing of a shoe sole and upper in FIGS. 1-3 is for illustrative purposes and forms no part of the claimed design.



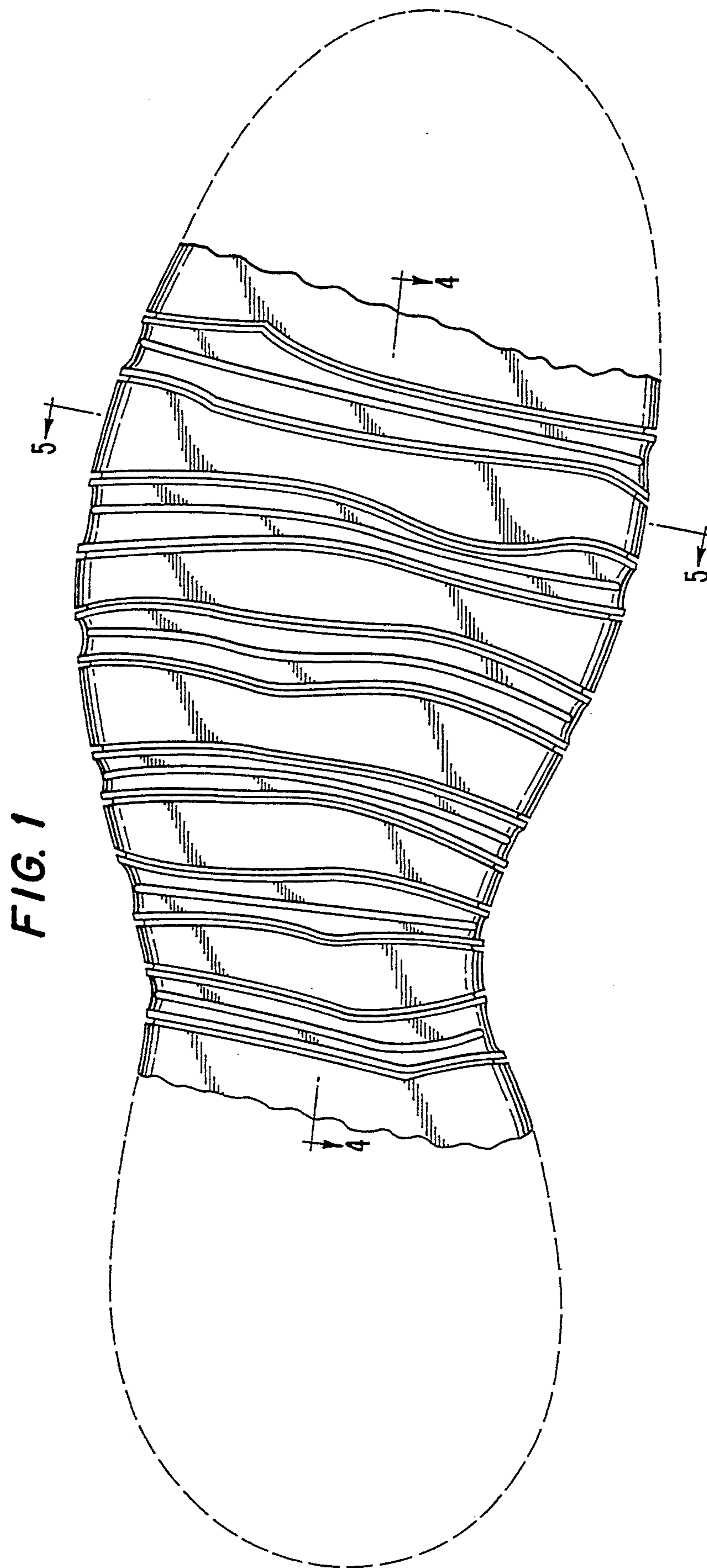
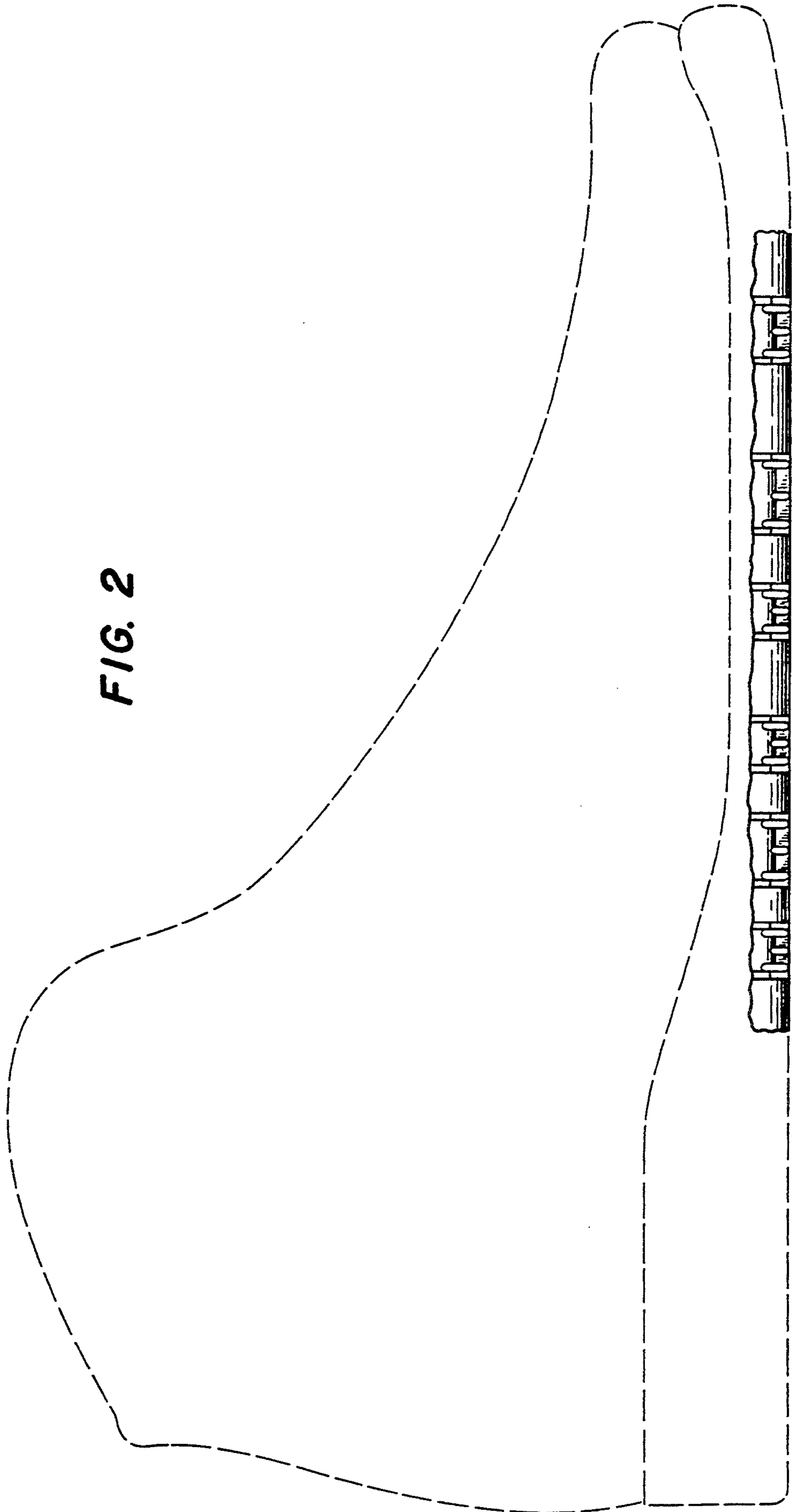

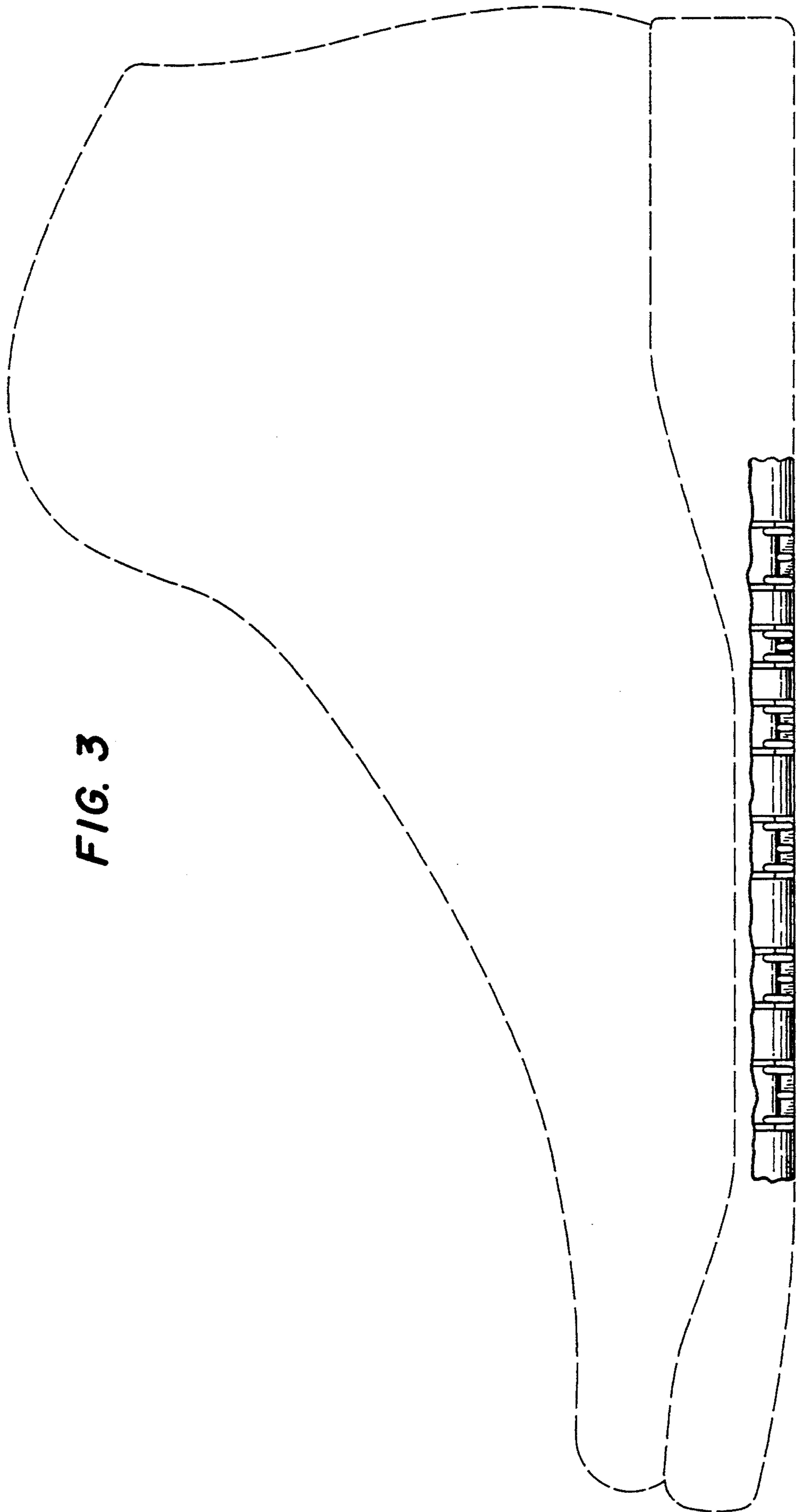
