[57] **CLAIM**

The ornamental design for a bag for a car cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a bag for a car cover showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a sectional view taken along line A—A of FIG. 1;
 FIG. 8 is a sectional view taken along line B—B of FIG. 6;
 FIG. 9 is a front perspective view thereof;
 FIG. 10 is a front perspective view in use thereof, the broken away portion of the strap is for illustrative purposes, the broken line showing of the car cover is for illustrative purposes only and forms no part of the claimed design;
 FIG. 11 is a front perspective view in use with the flap in an open position, the broken line showing of the car and cover is for illustrative purposes only and forms no part of the claimed design; and,
 FIG. 12 is an exploded front perspective view thereof. The broken line showing car and cover is for illustrative purposes only and forms no part of the claimed design.

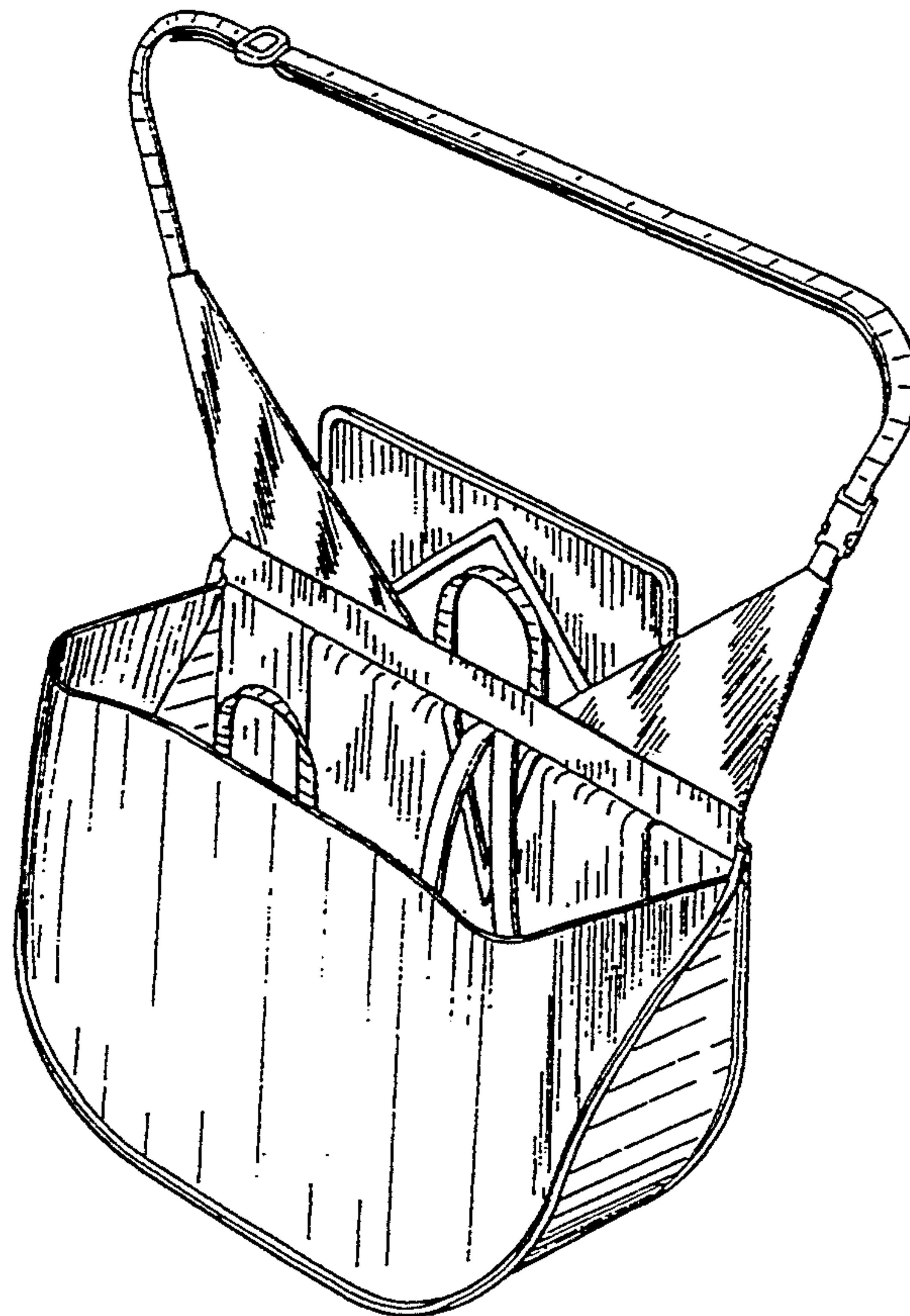

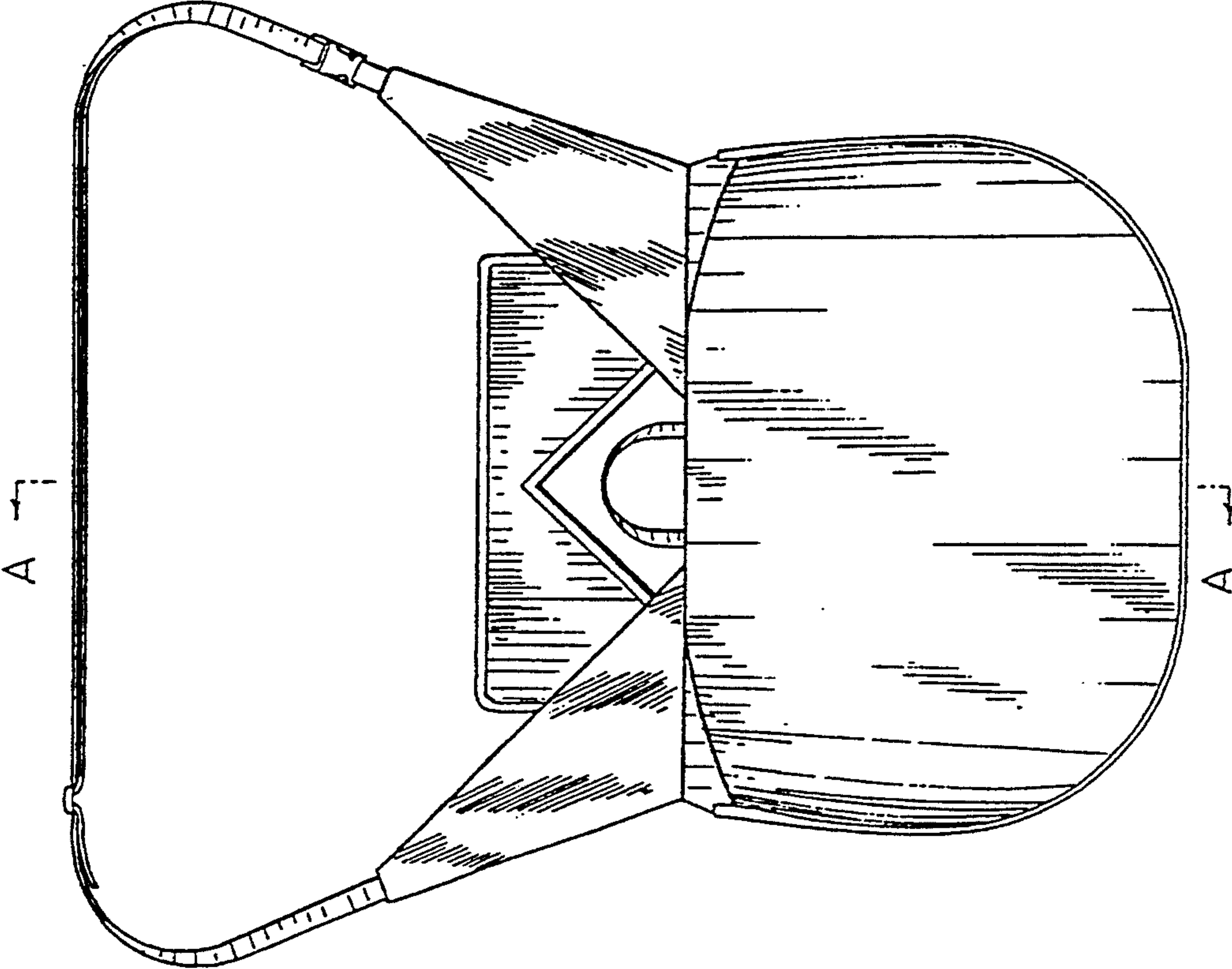

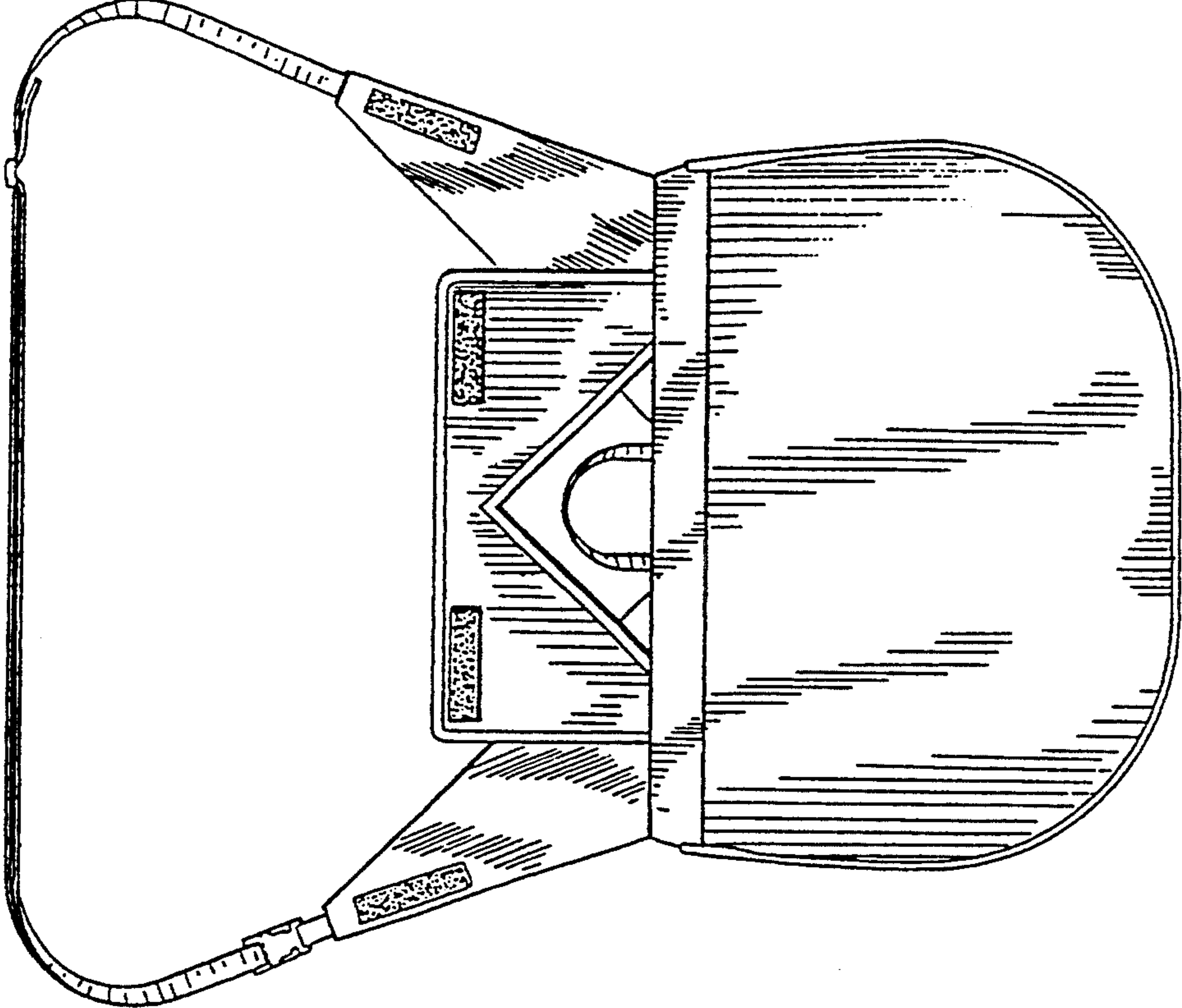

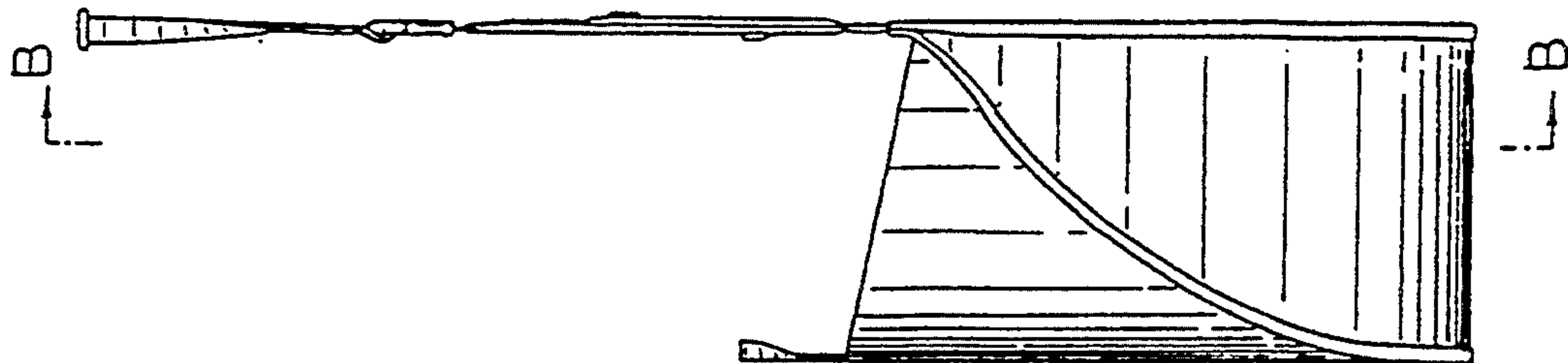

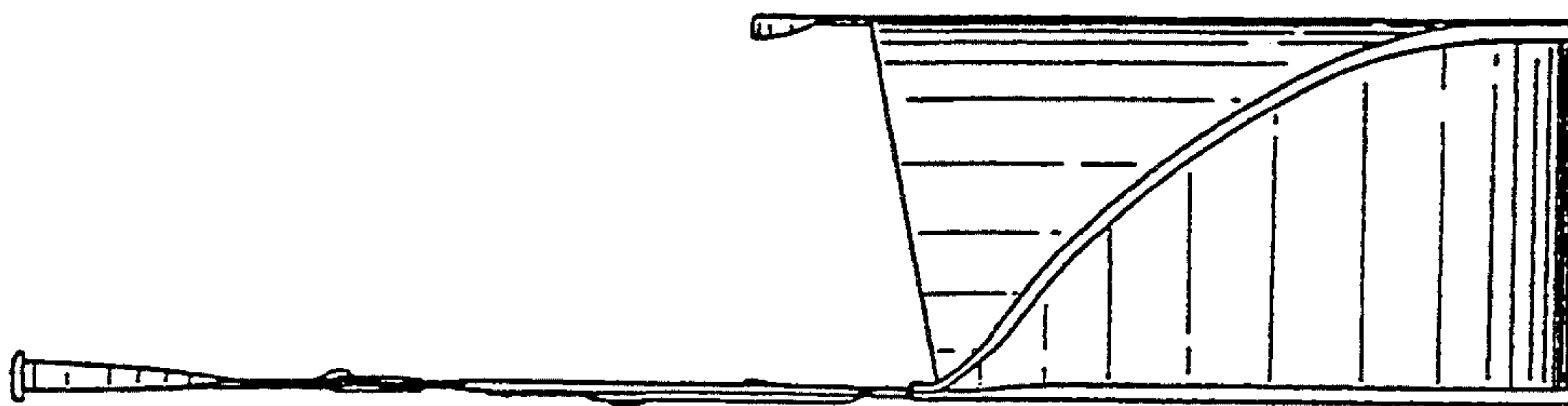

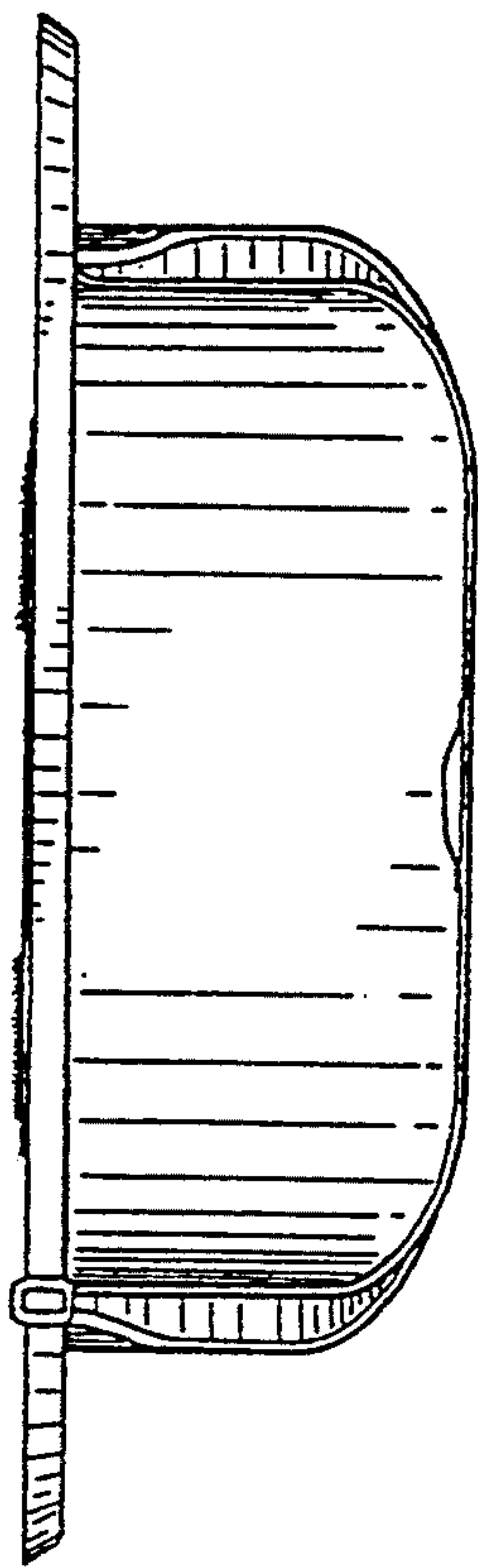

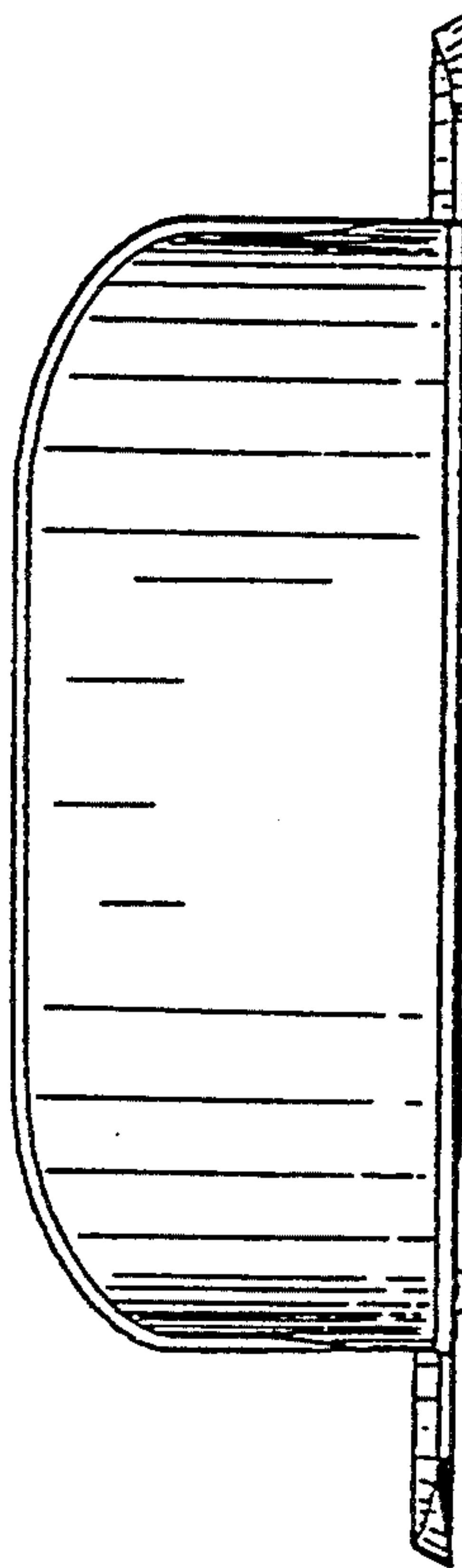

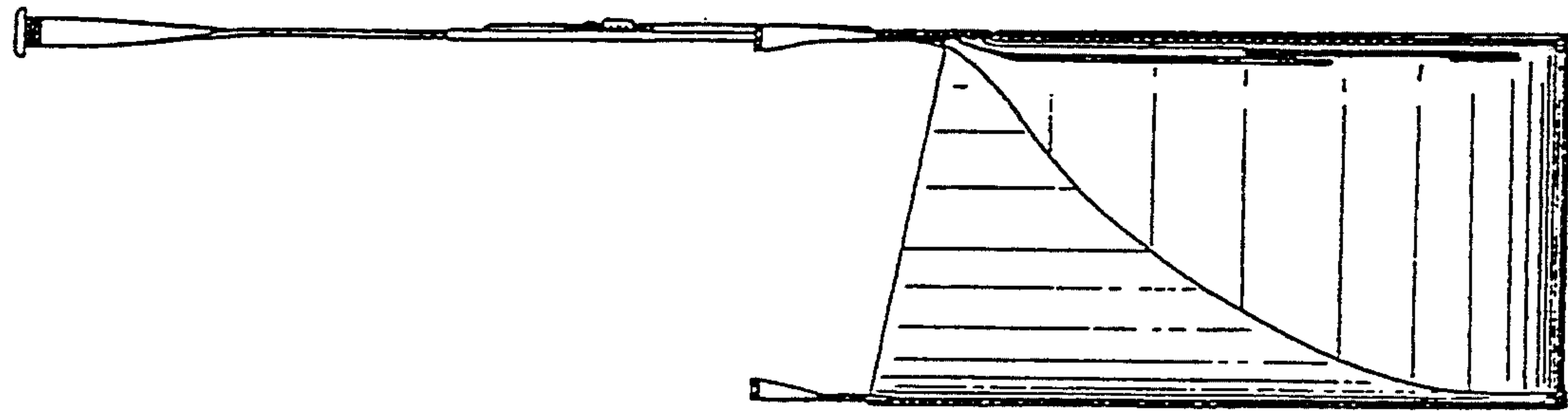

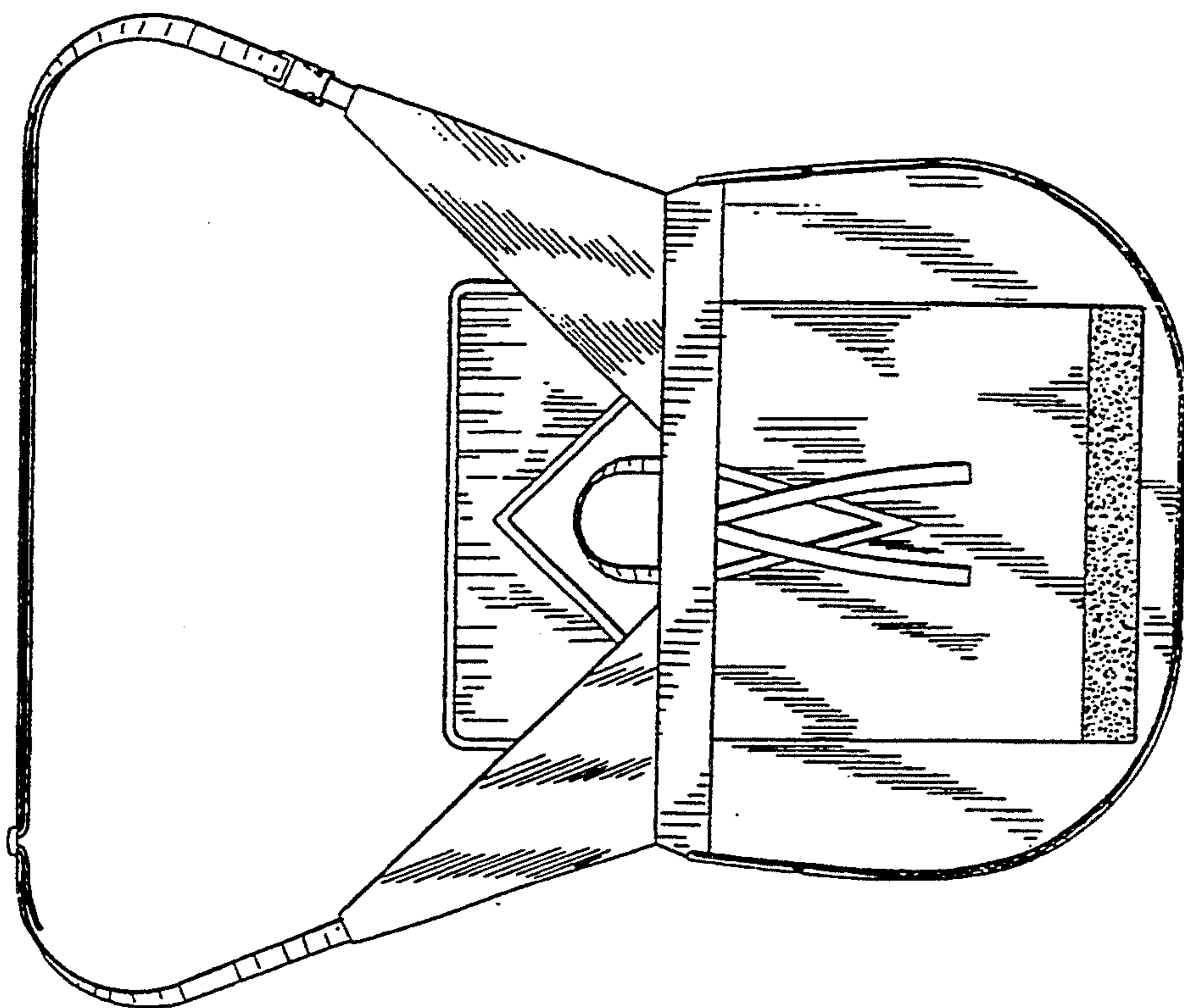

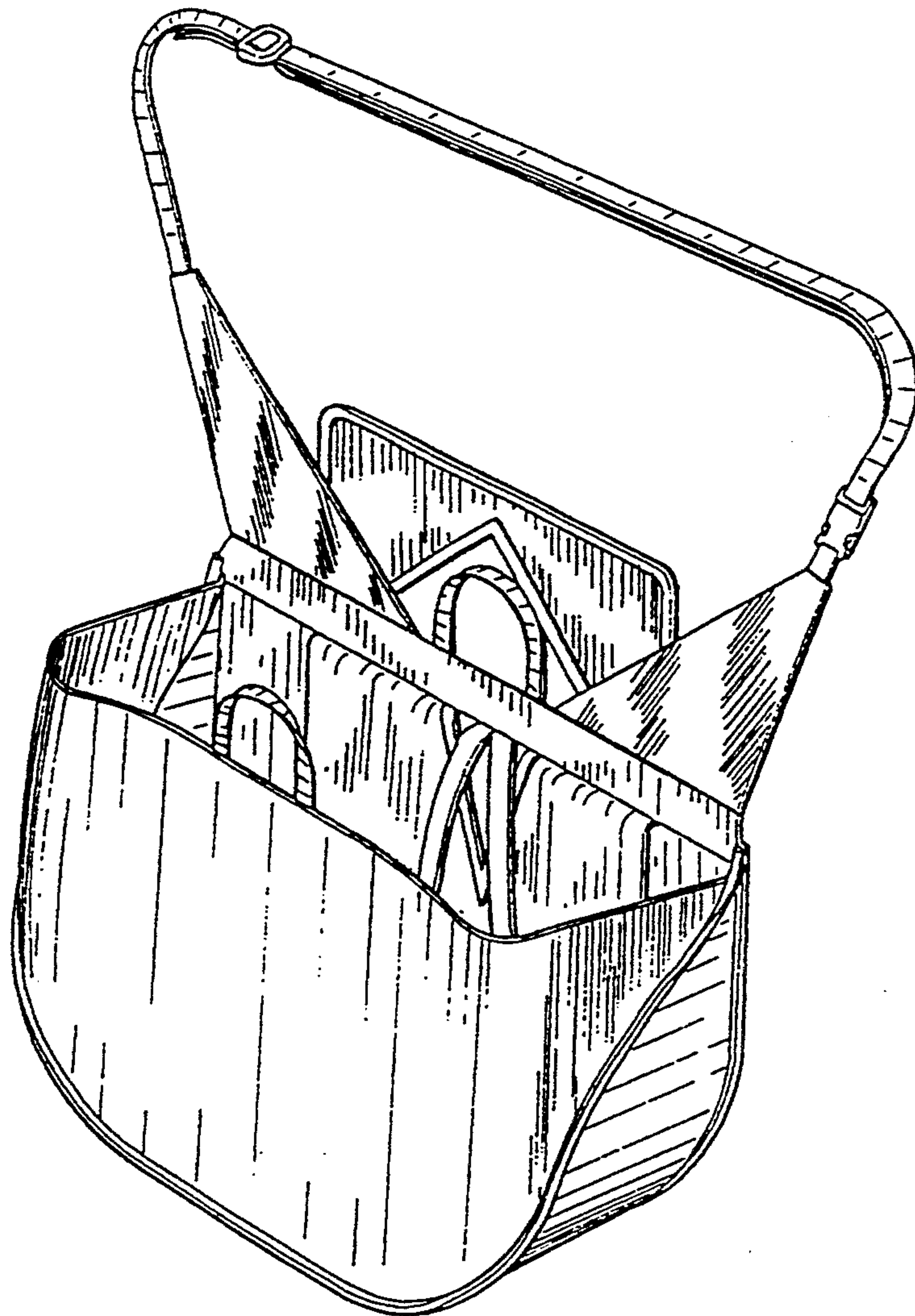

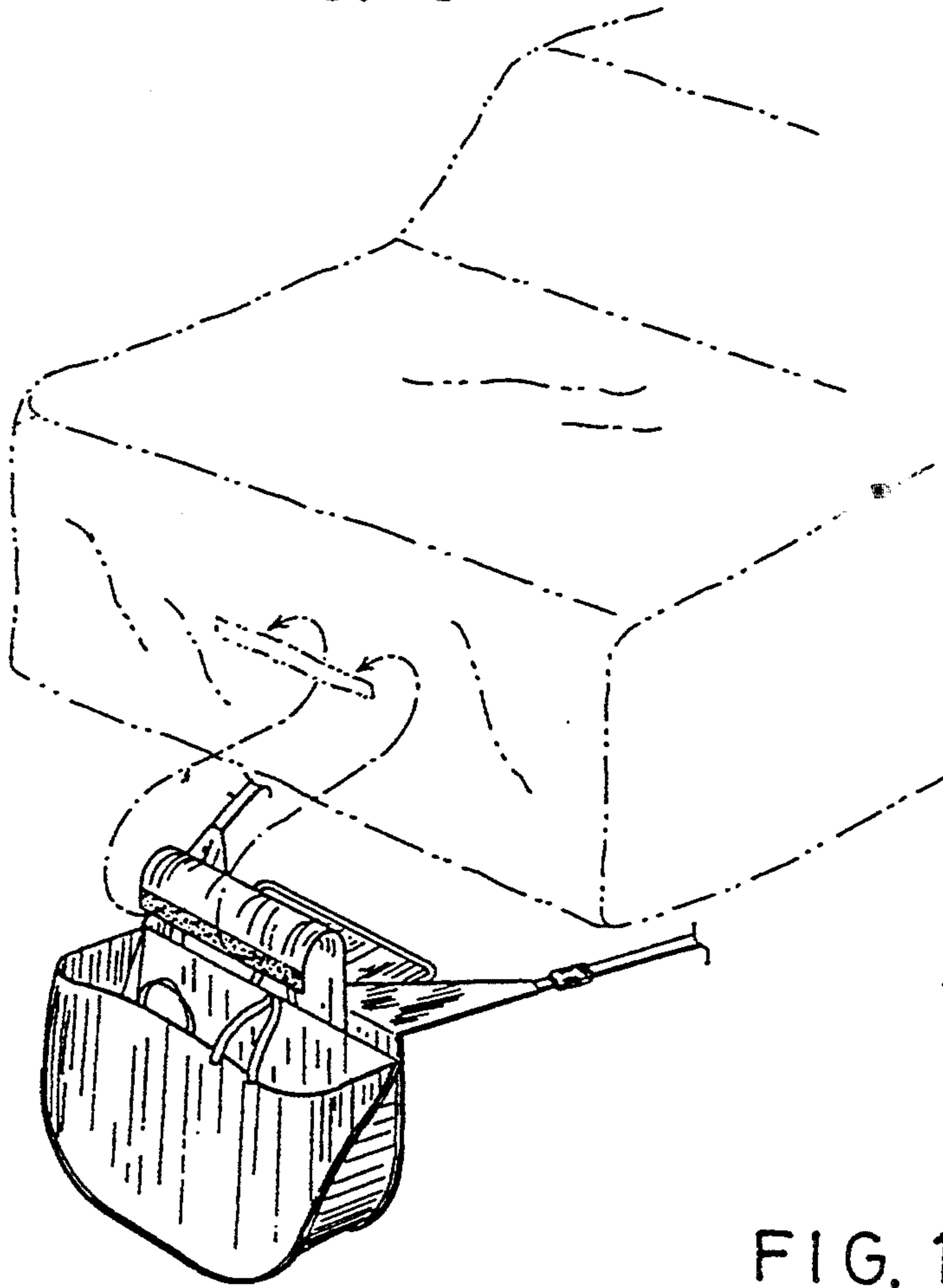

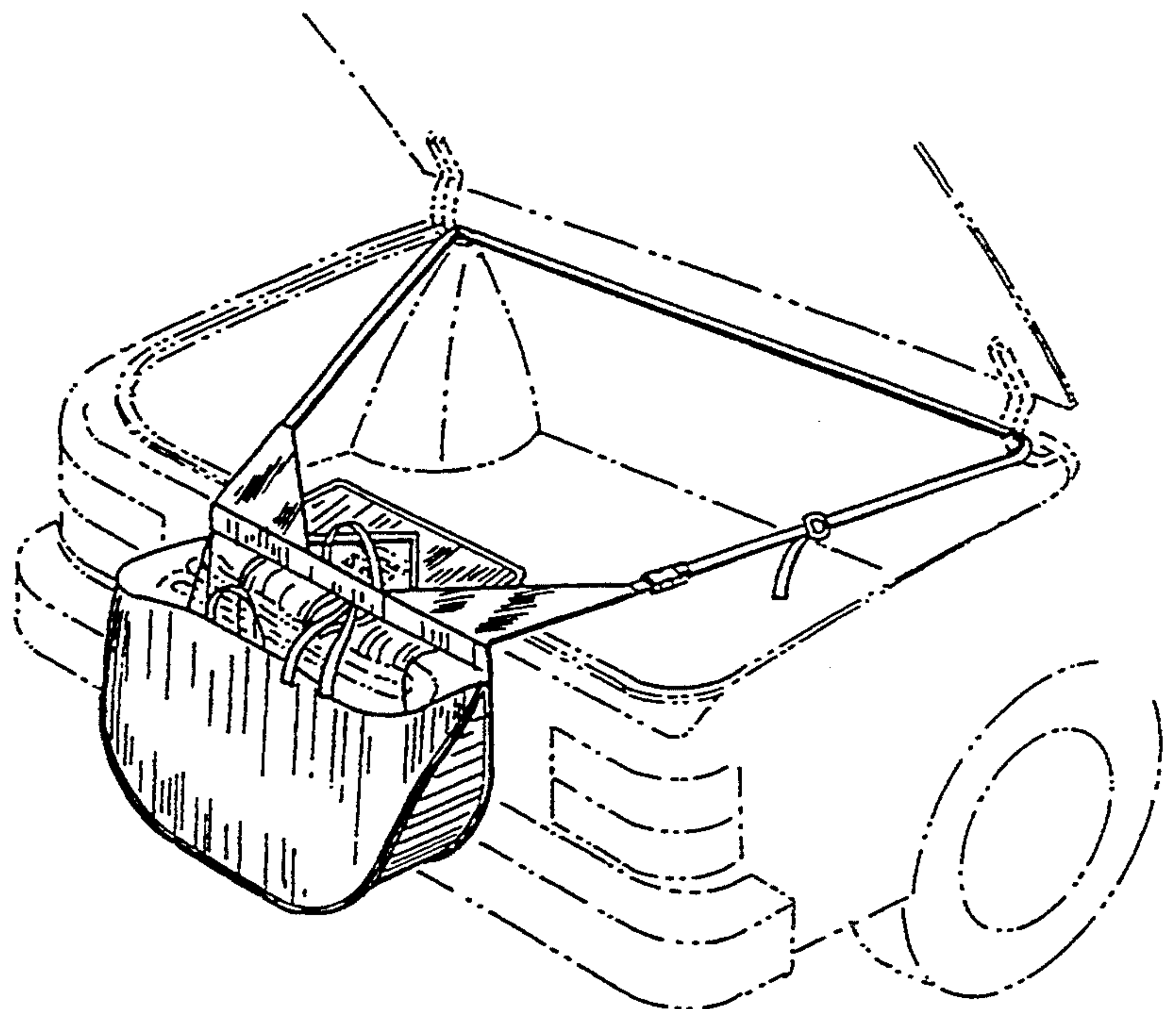
