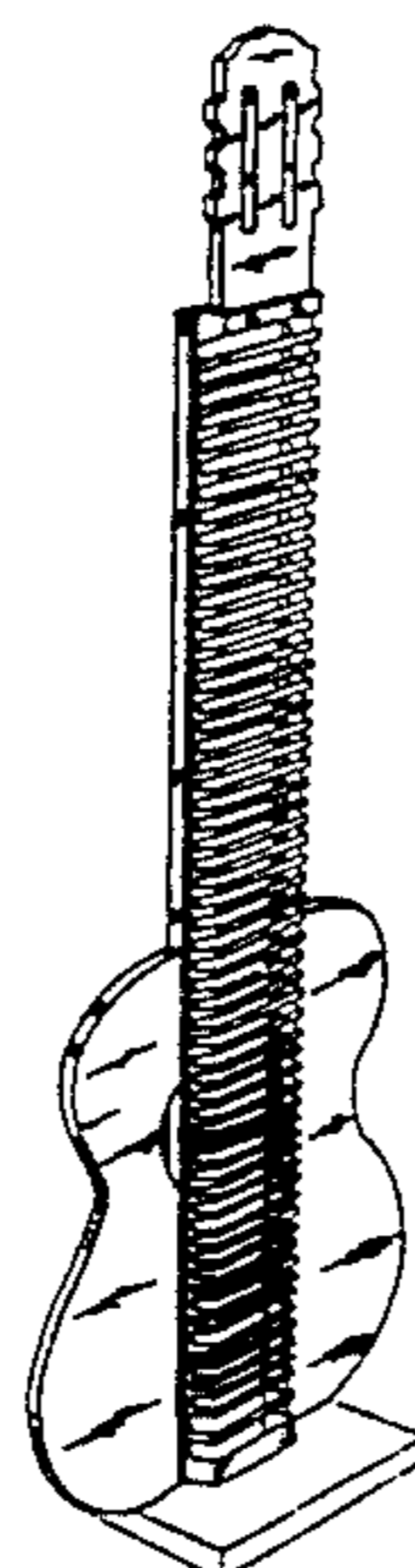

[57] **CLAIM**

The ornamental storage rack, as shown and described.

DESCRIPTION

FIG. 1 is a front, side perspective view of a storage rack, showing my new design; the broken line showing of the wall and floor mounting surfaces is for illustrative purposes only and forms no part of the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is another perspective view thereof; the broken line showing of the mounting base is for illustrative purposes only and forms no part of the claimed design.

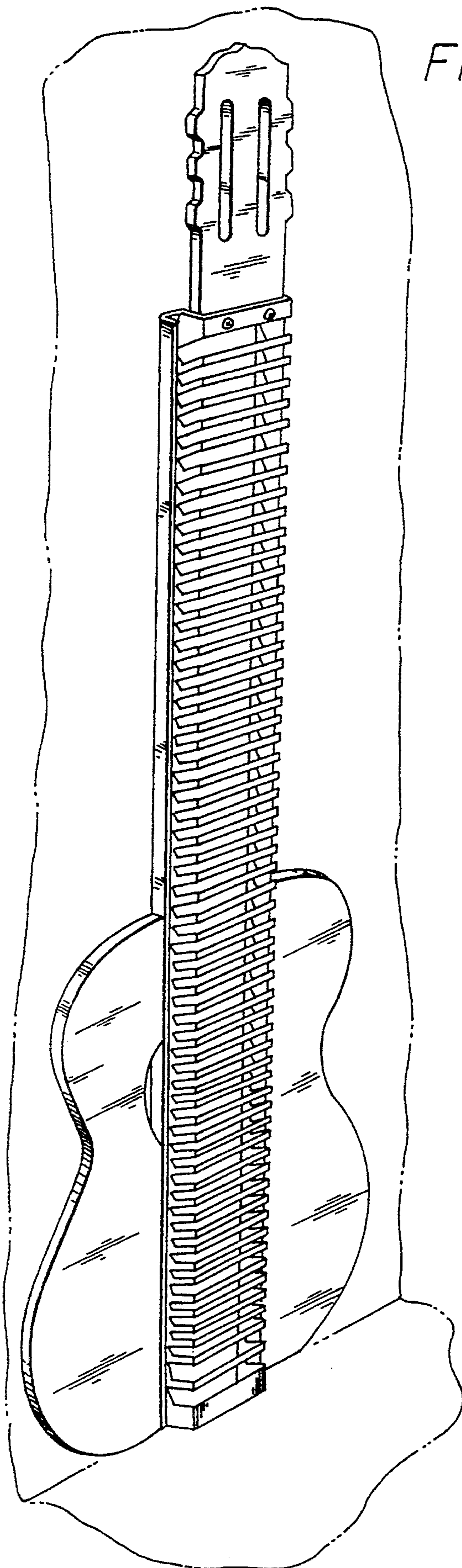

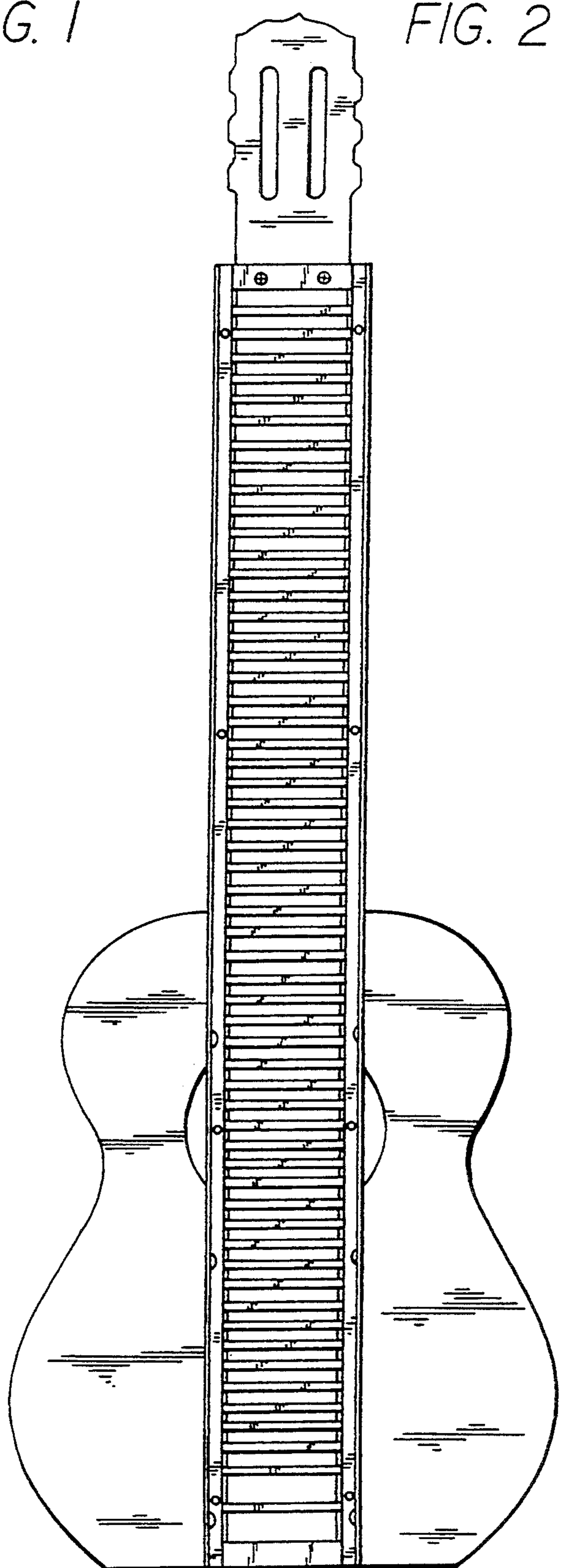

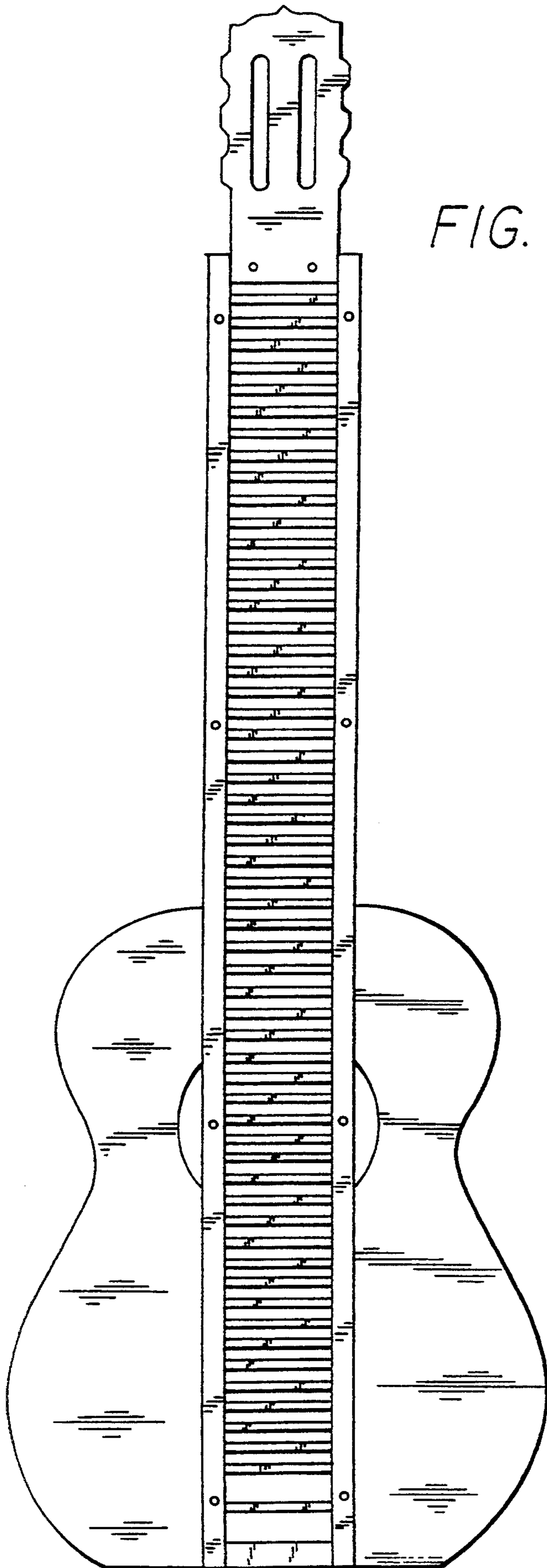

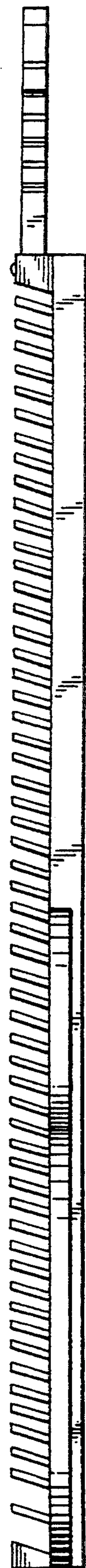
