[57] CLAIM

The ornamental design for a combined wrist watch housing and bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the combined wrist watch housing and bracelet;
 FIG. 2 is a front plan view of the combined wrist watch housing and bracelet;
 FIG. 3 is a rear plan view of the combined wrist watch housing and bracelet;
 FIG. 4 is a top plan view of the combined wrist watch housing and bracelet;
 FIG. 5 is a bottom plan view of the combined wrist watch housing and bracelet;
 FIG. 6 is a left plan view of the combined wrist watch housing and bracelet;
 FIG. 7 is a right plan view of the combined wrist watch housing and bracelet;
 FIG. 8 is a front perspective view of another embodiment of the combined wrist watch housing and bracelet of the present invention;
 FIG. 9 is a front plan view of the embodiment of FIG. 8;
 FIG. 10 is a rear plan view of the embodiment of FIG. 8;
 FIG. 11 is a top plan view of embodiment of FIG. 8;
 FIG. 12 is a bottom plan view of the embodiment of FIG. 8;
 FIG. 13 is a left plan view of the embodiment of FIG. 8; and,
 FIG. 14 is a right plan view of embodiment of FIG. 8.

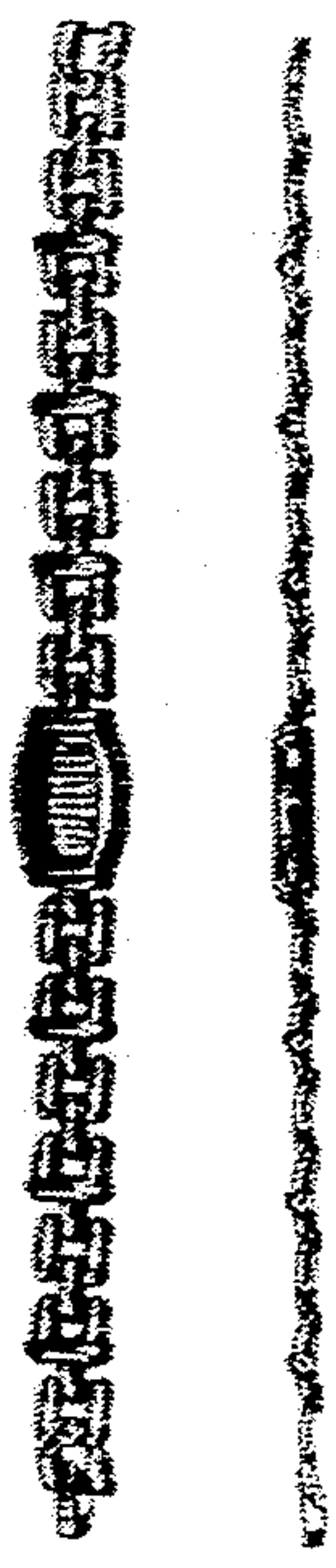

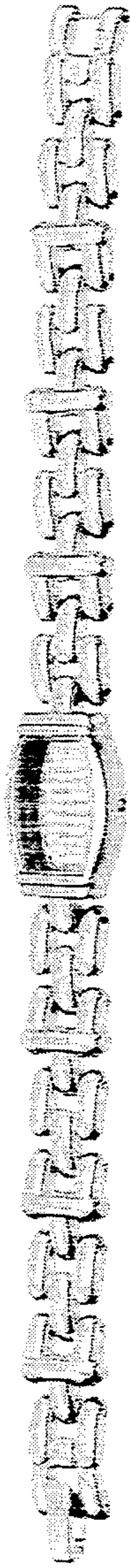

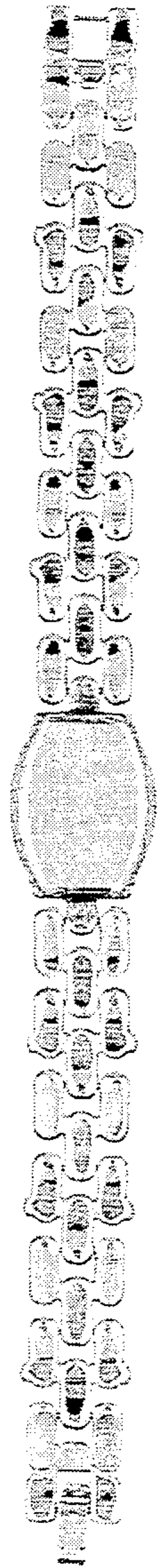

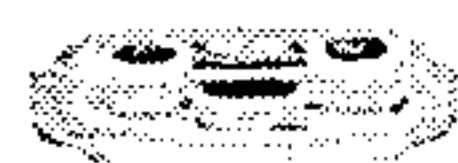

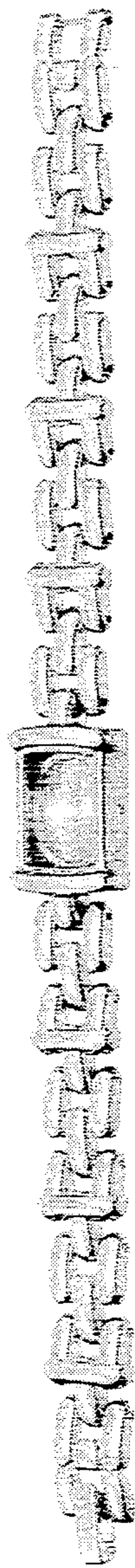

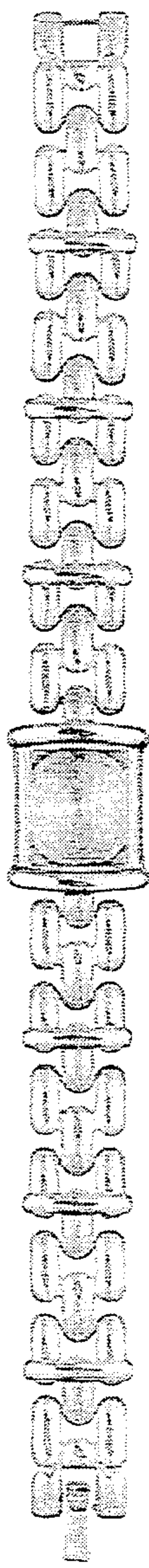

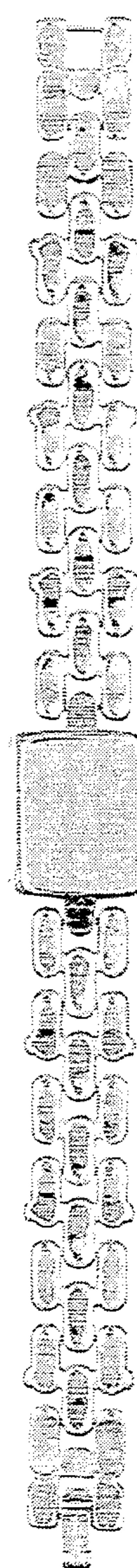
