DESCRIPTION

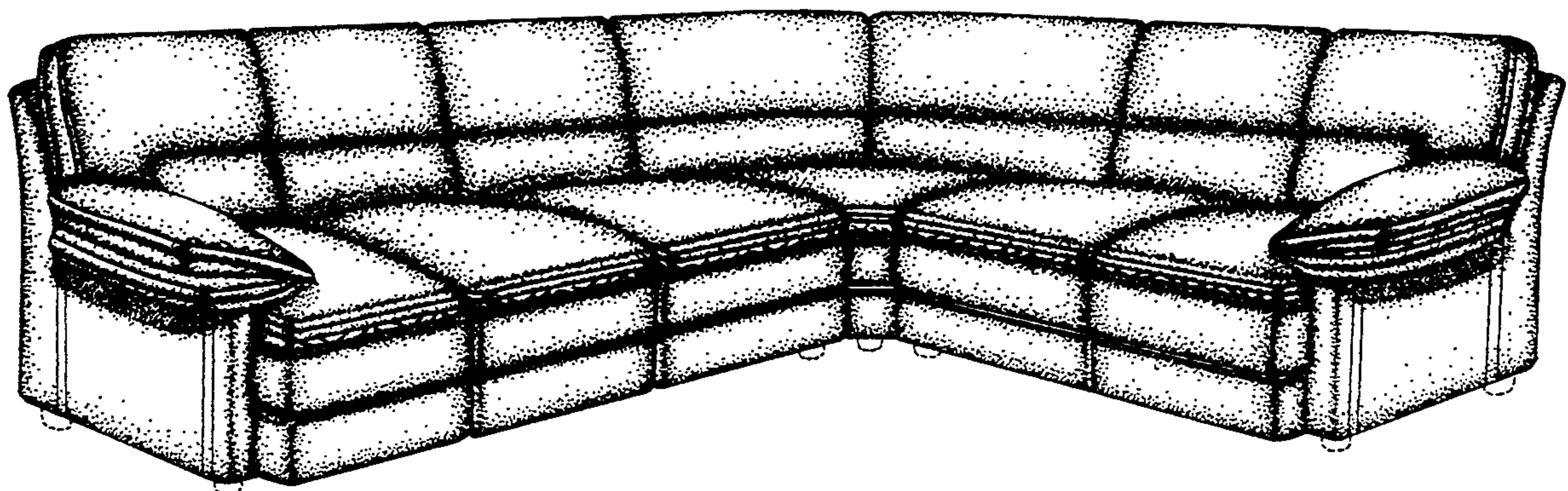
FIG. 1 is a perspective view of a sectional sofa showing our new design;

The portion shown in the broken lines in the drawings forms no part of the design being claimed.



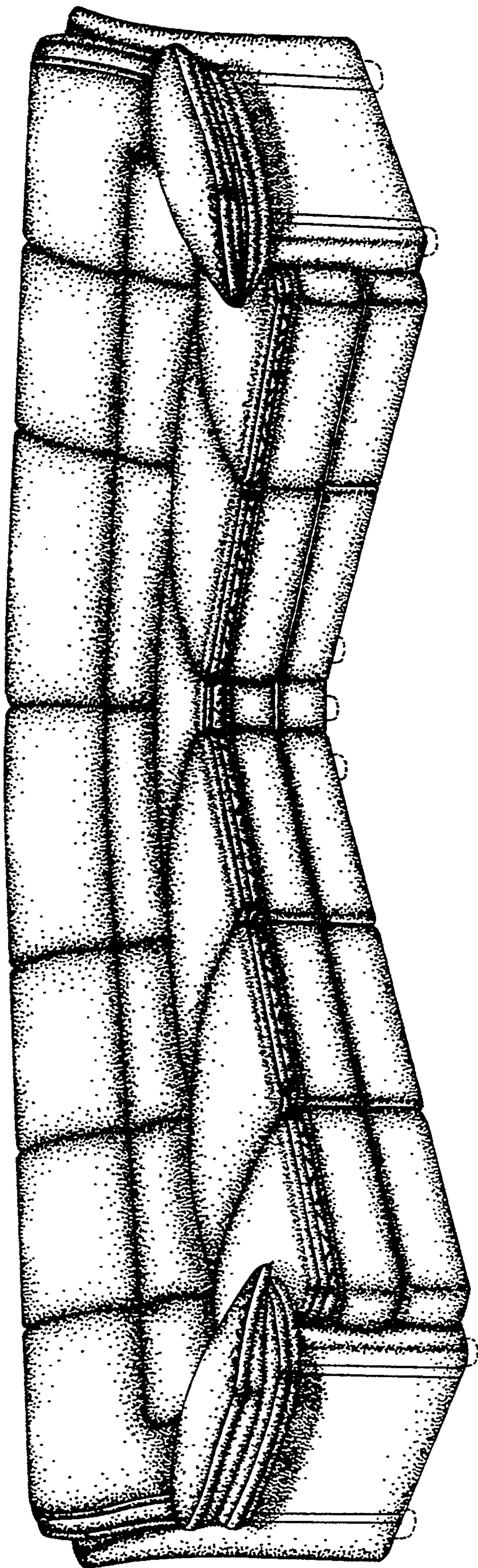

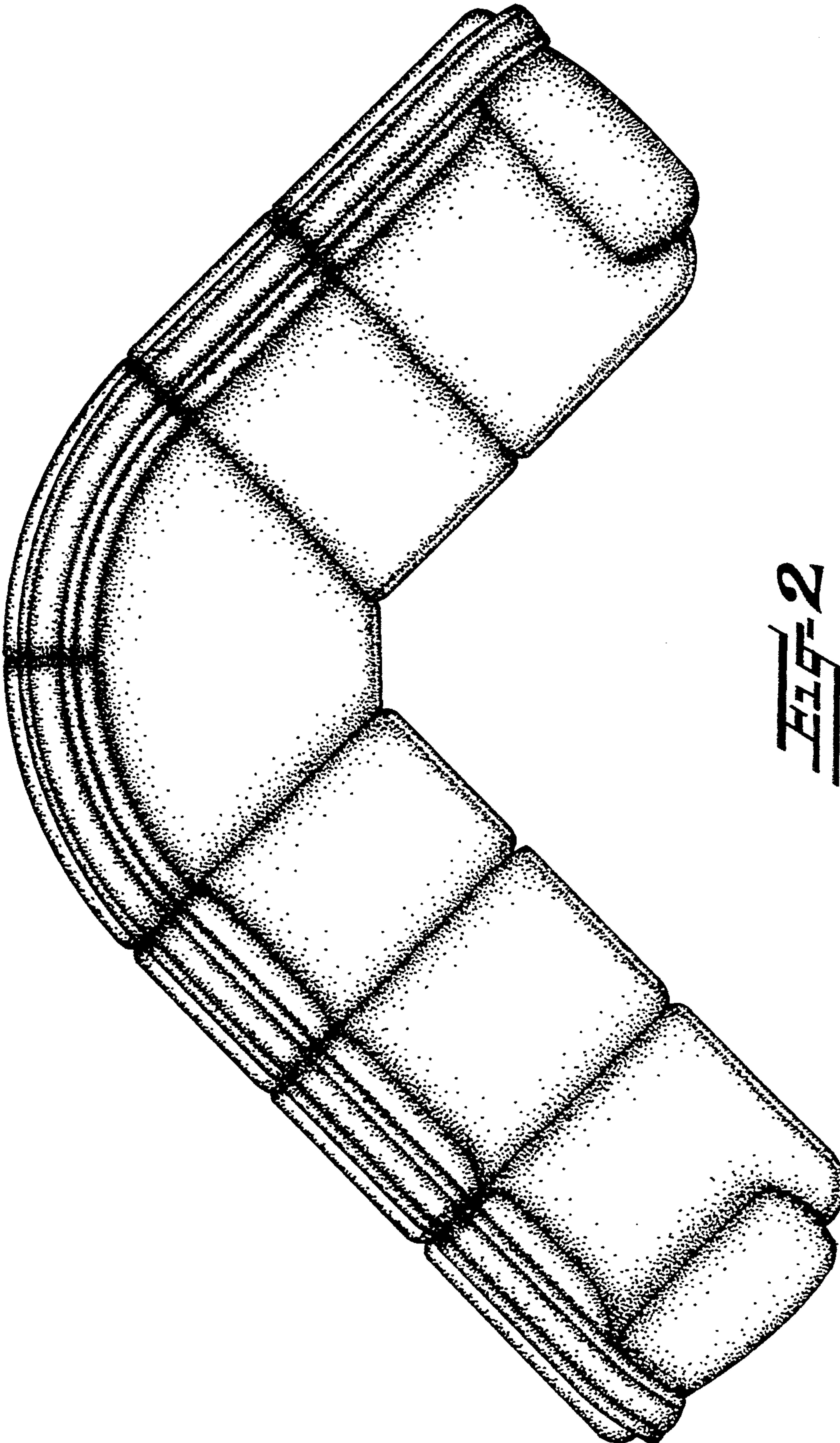

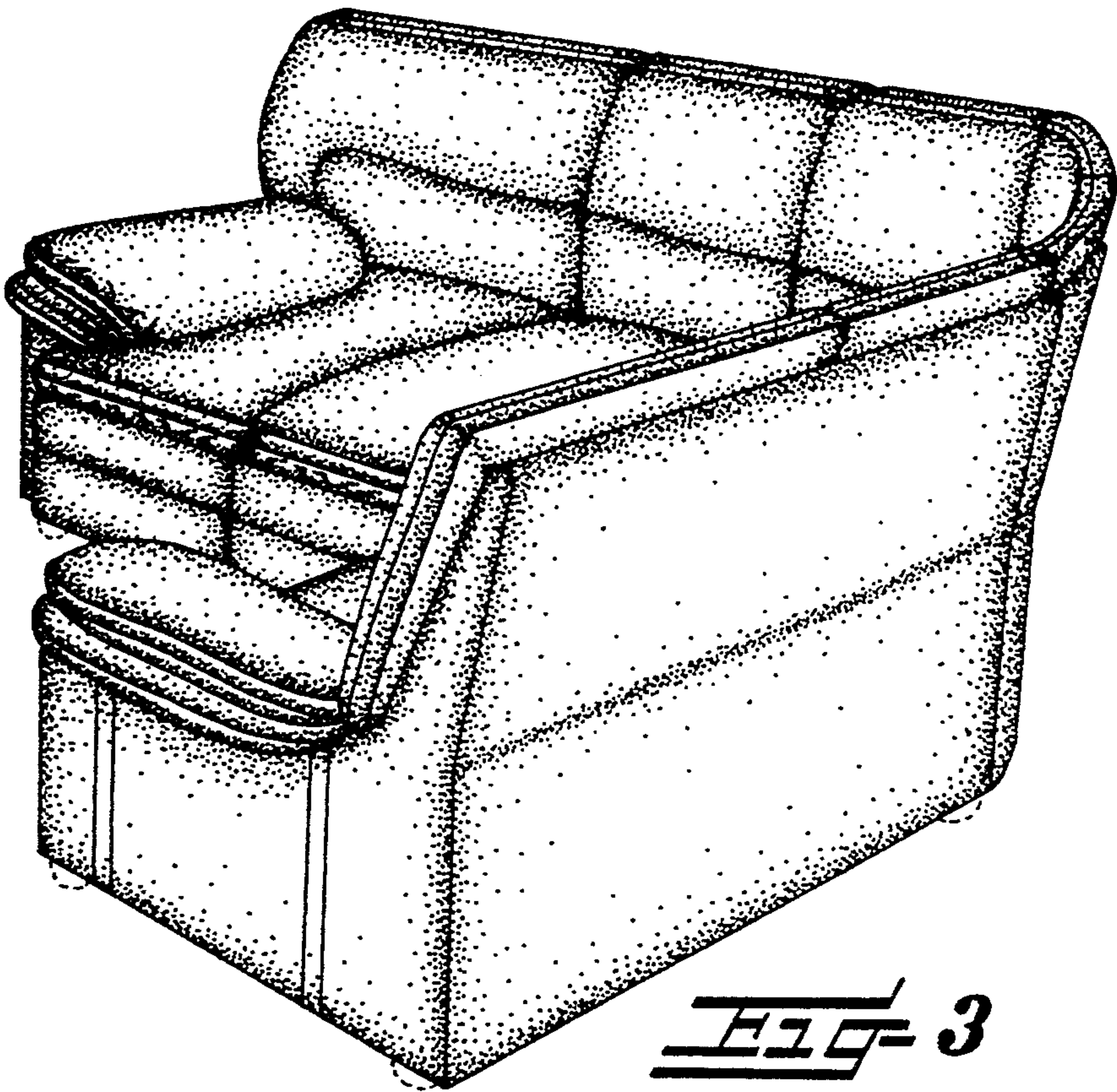

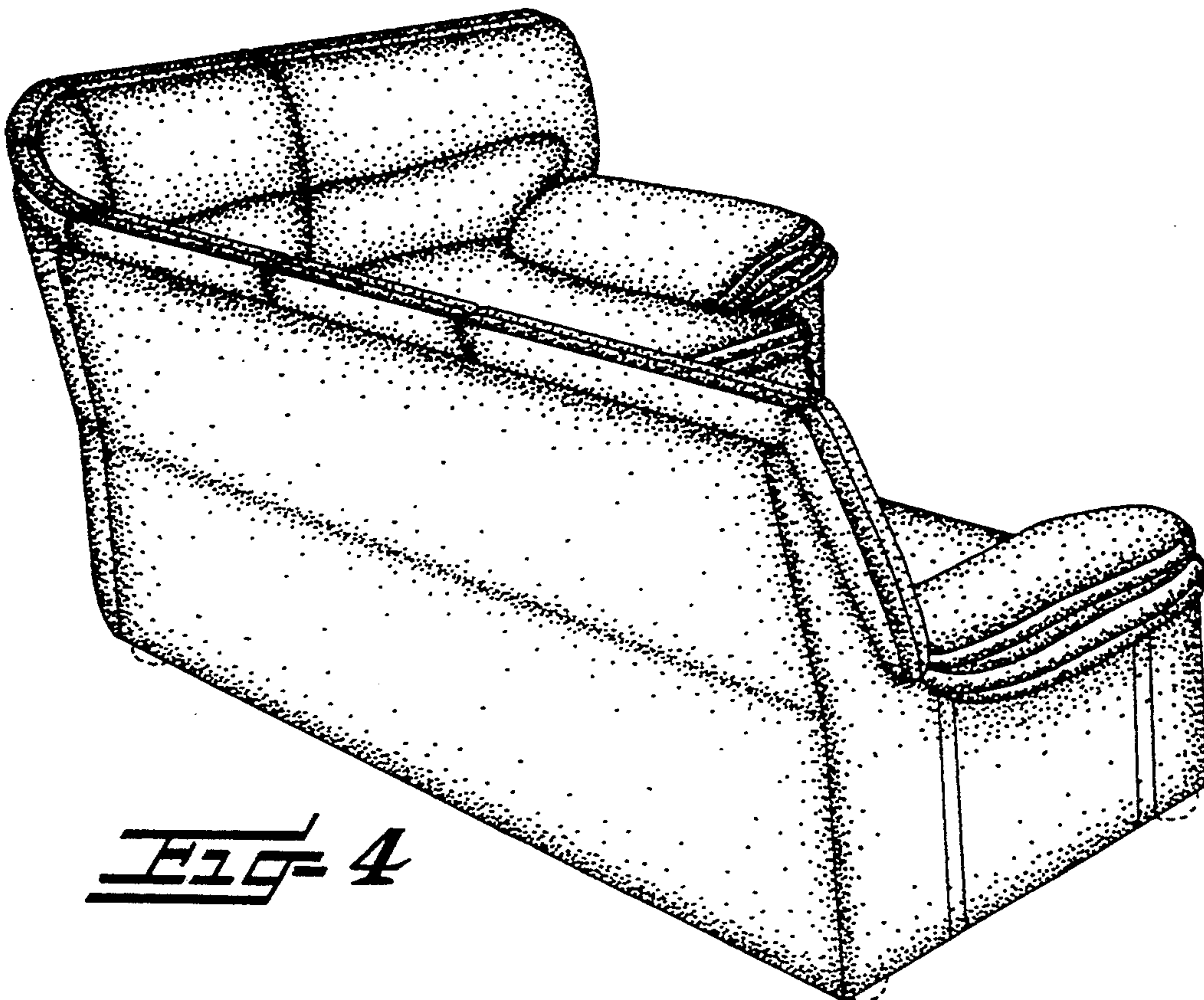
