The ornamental design for a sprocket cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of the sprocket cover showing my new design;

FIG. 4 is a rear elevational view thereof; and,  
FIG. 5 is a cross-sectional view taken along line 5—5 in FIG. 3.

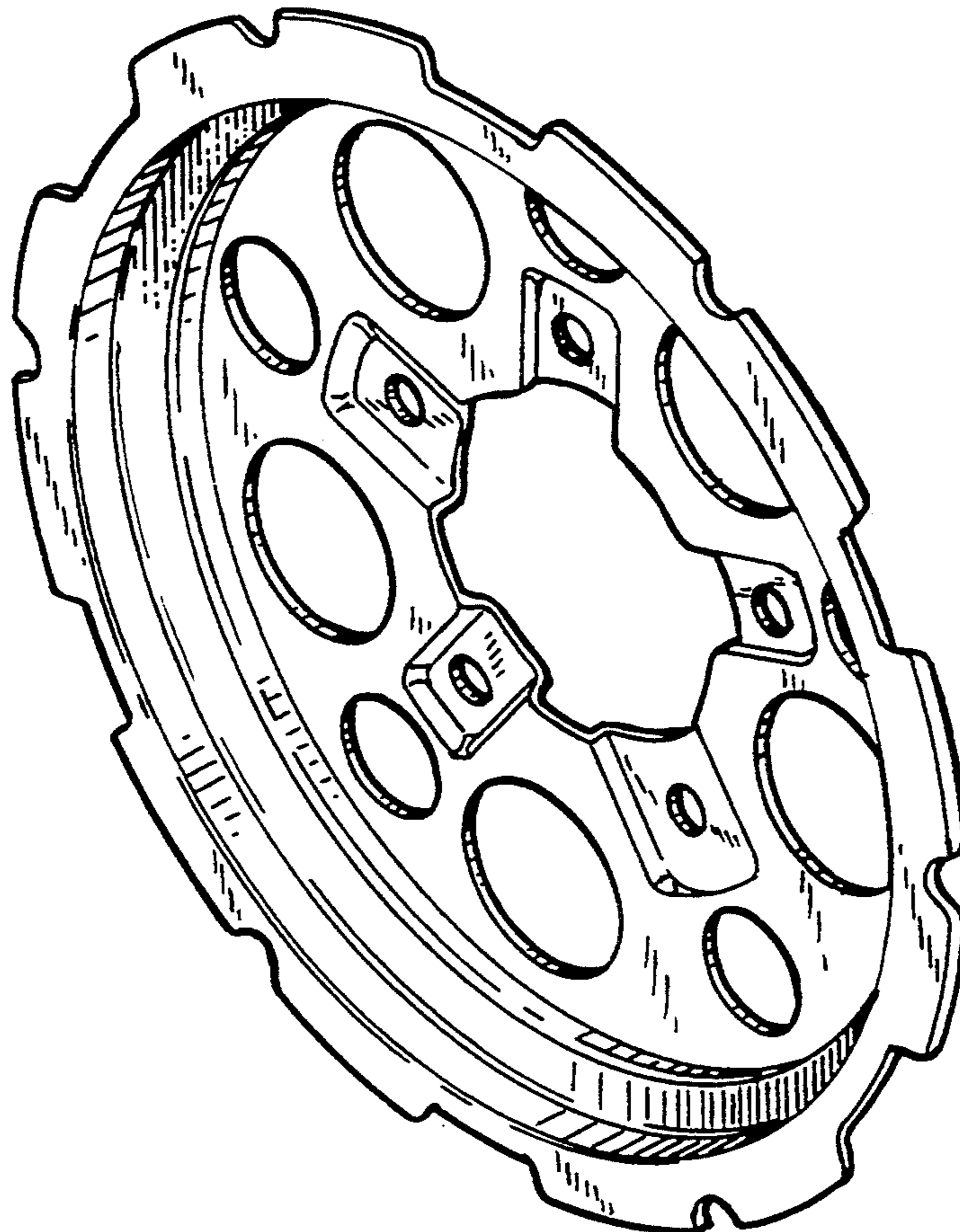

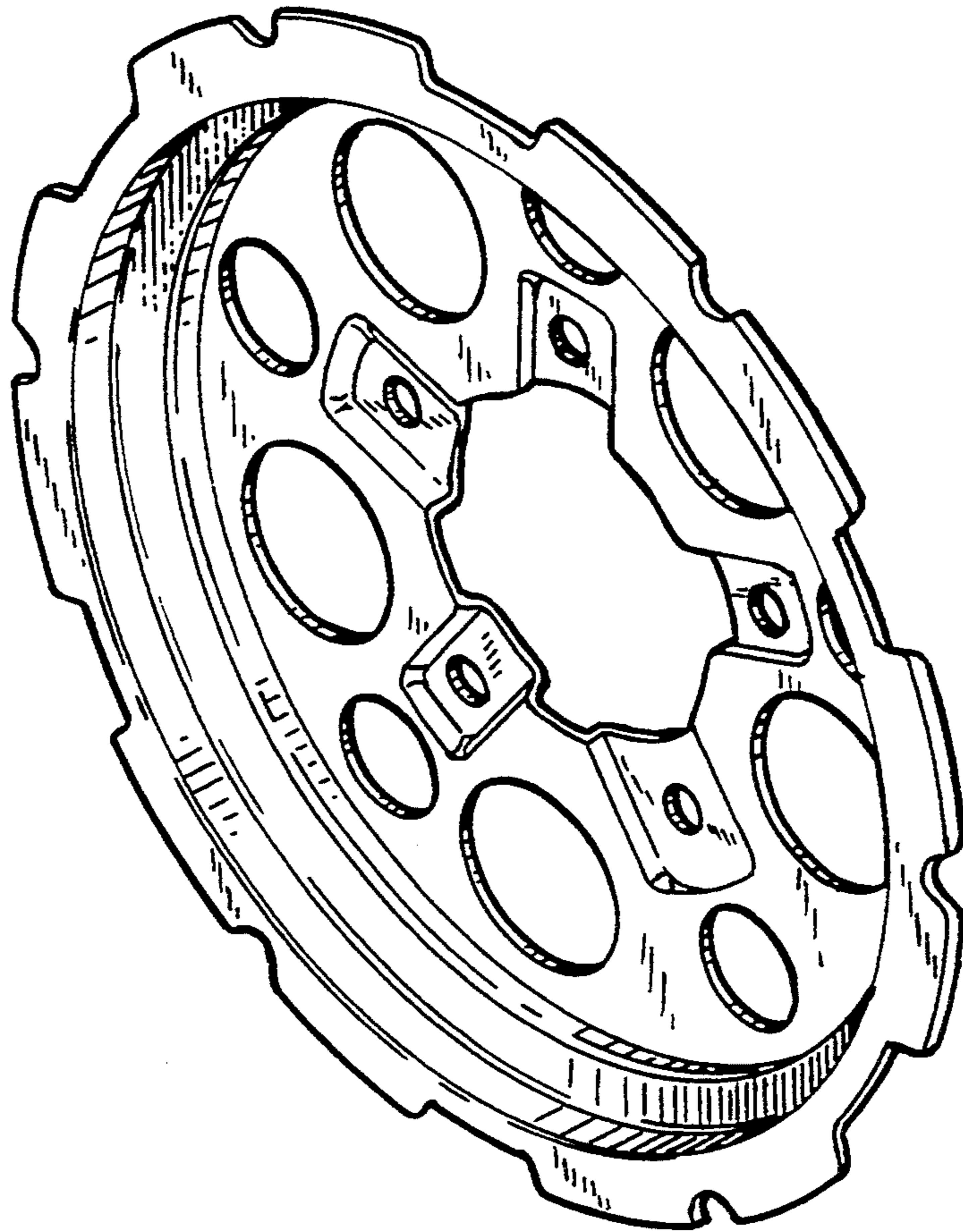

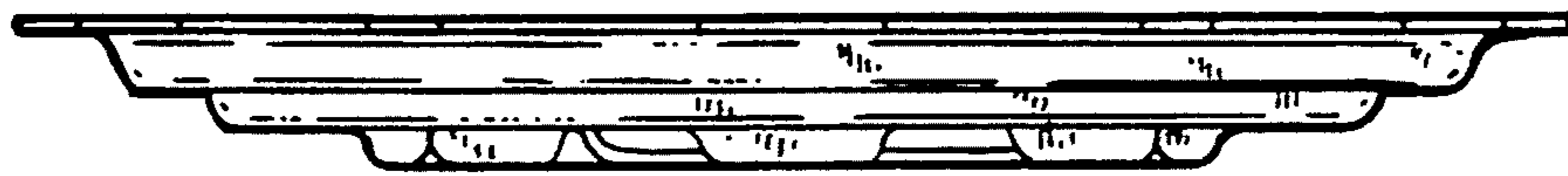
