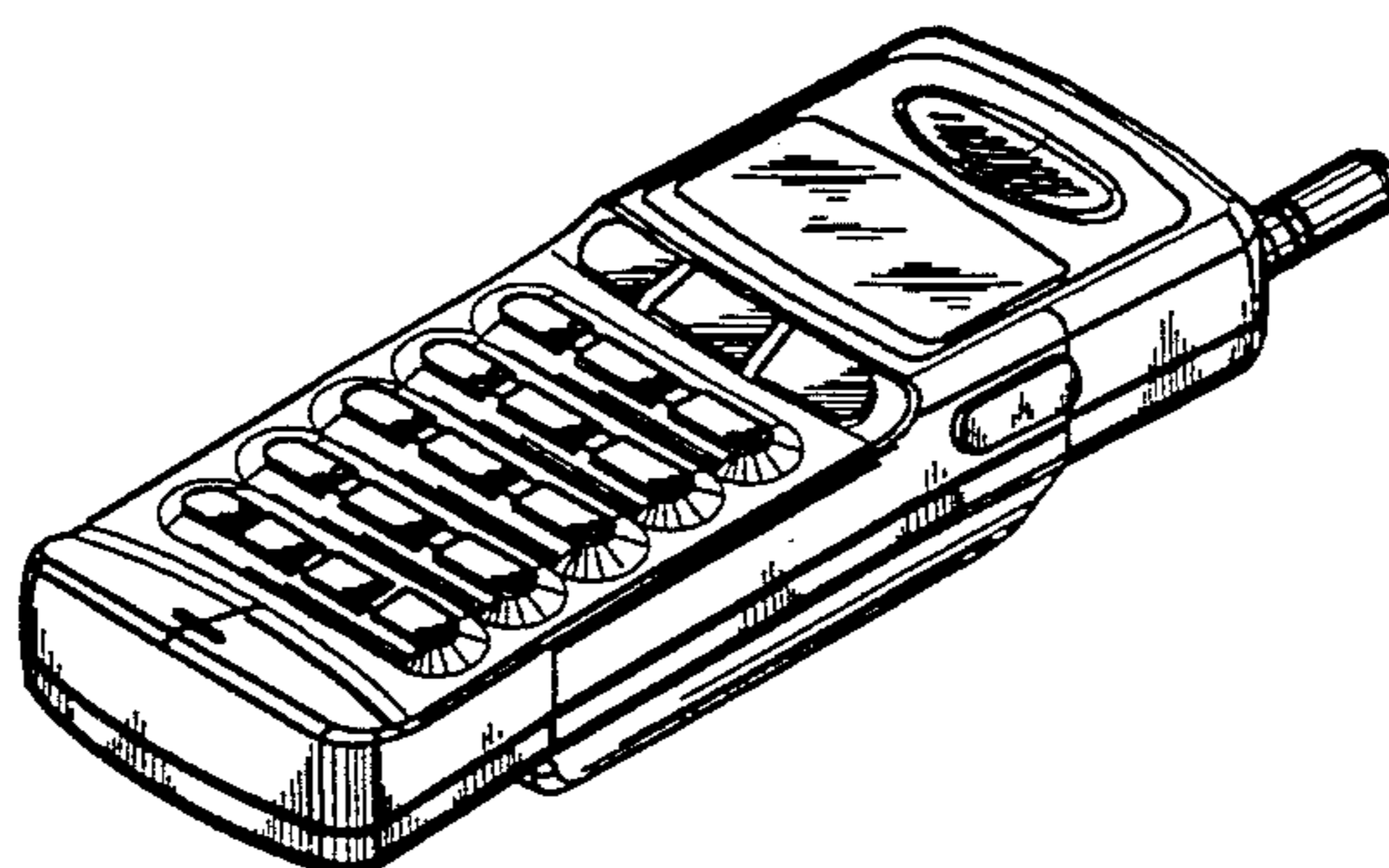
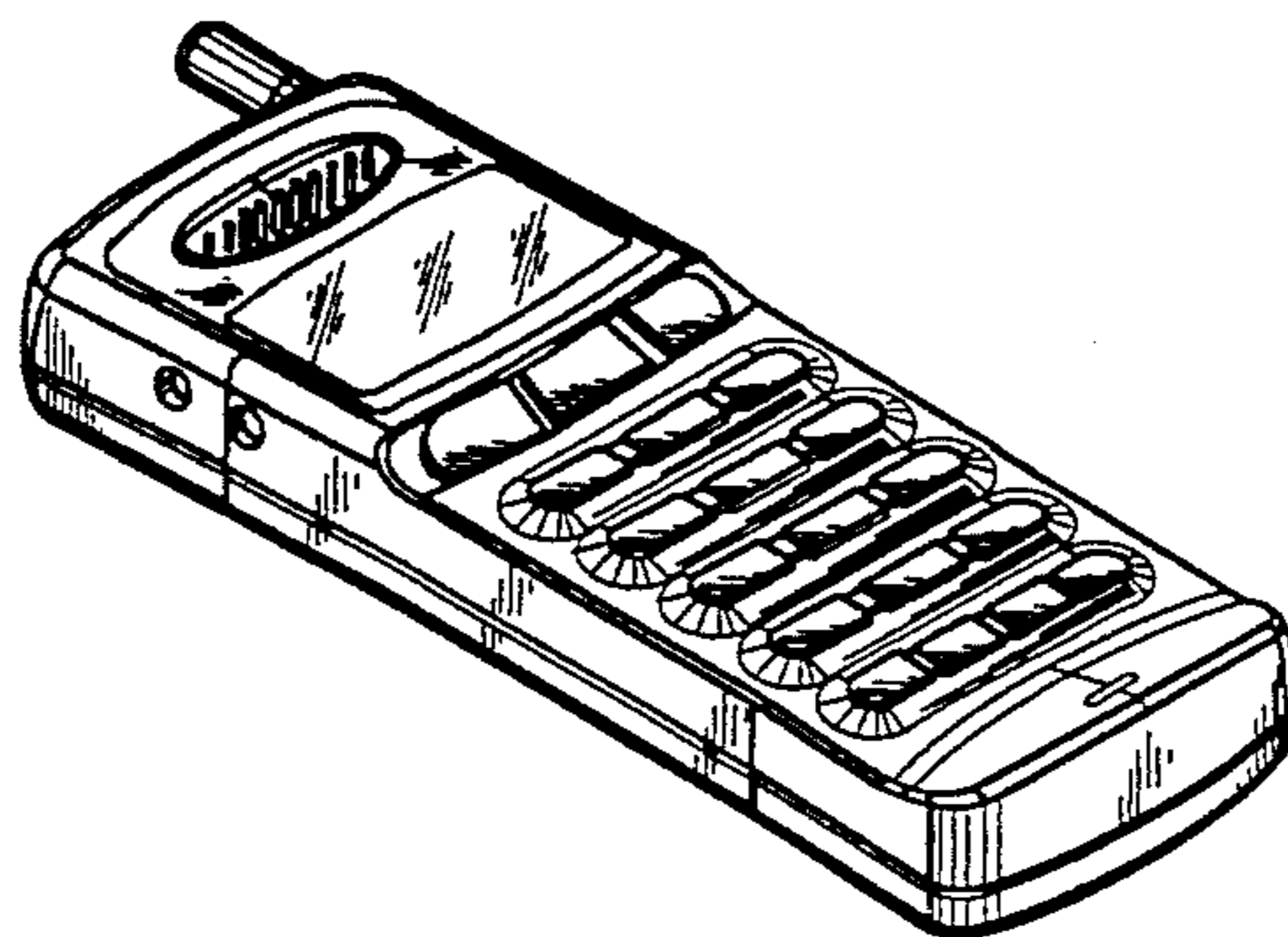

The ornamental design for a portable telephone, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the invention;  
 FIG. 2 is a right side plan view of the telephone of FIG. 1;  
 FIG. 3 is a top elevation view of the telephone of FIG. 1;  
 FIG. 4 is a left side plan view of the telephone of FIG. 1;  
 FIG. 5 is a bottom plan view of the telephone of FIG. 1;  
 FIG. 6 is a front end plan view of the telephone of FIG. 1;  
 FIG. 7 is a rear end plan view of the telephone of FIG. 1;  
 FIG. 8 is a perspective view of a second embodiment of the invention which appears identical to the first embodiment in a top elevation view;  
 FIG. 9 is a right side plan view of the telephone of FIG. 8;  
 FIG. 10 is a bottom plan view of the telephone of FIG. 8;  
 FIG. 11 is a left side plan view of the telephone of FIG. 8;  
 FIG. 12 is a front end view of the telephone of FIG. 8; and,  
 FIG. 13 is a rear end view of the telephone of FIG. 8.



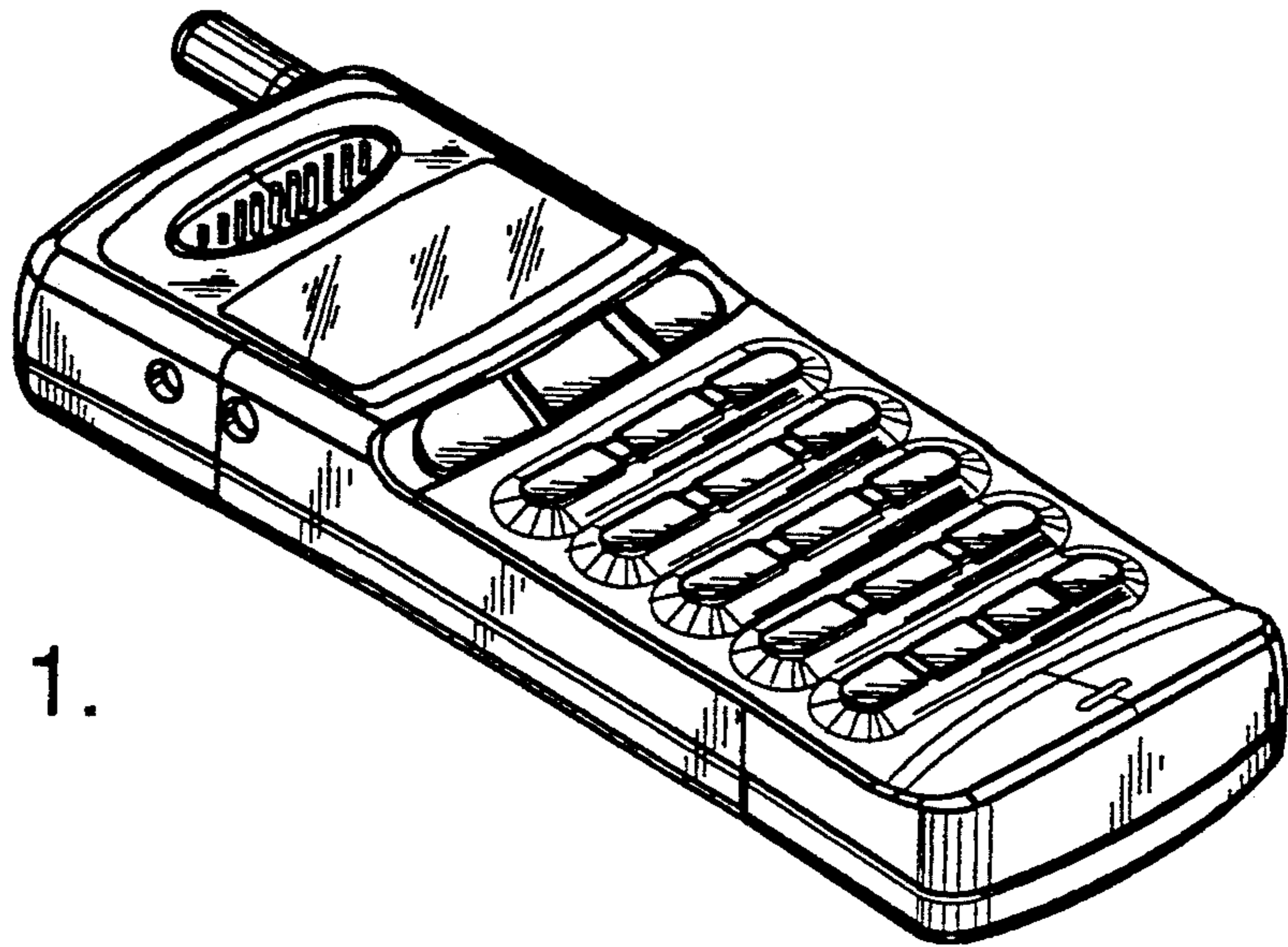

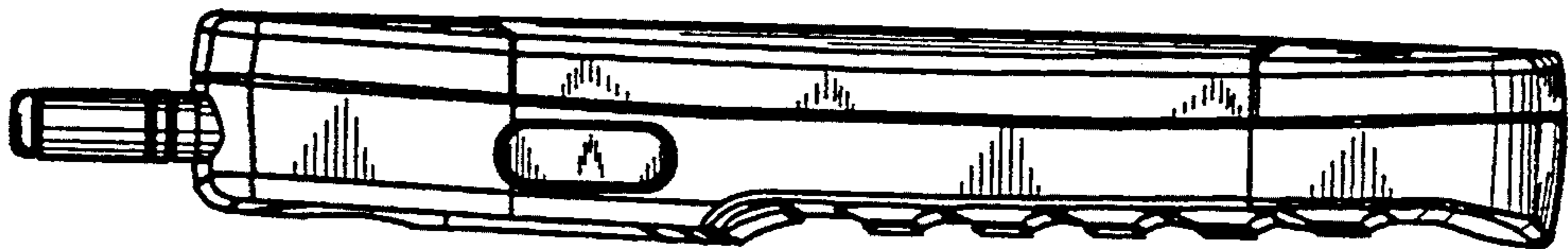

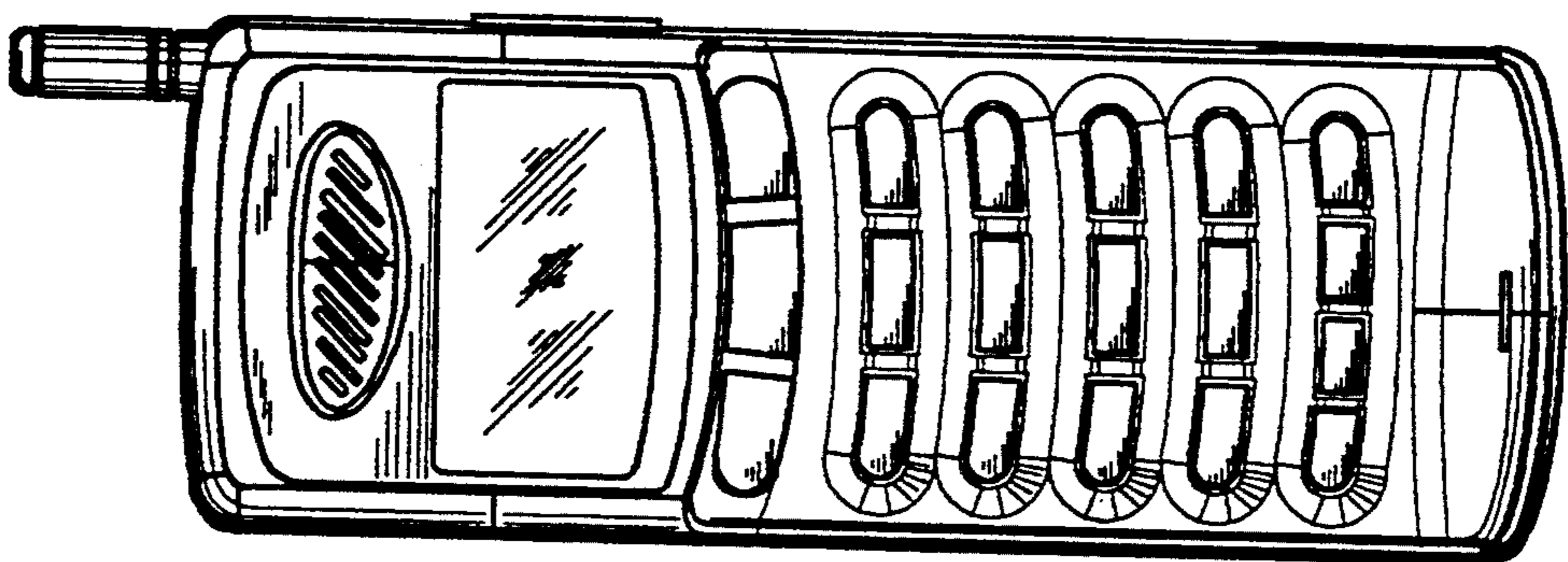
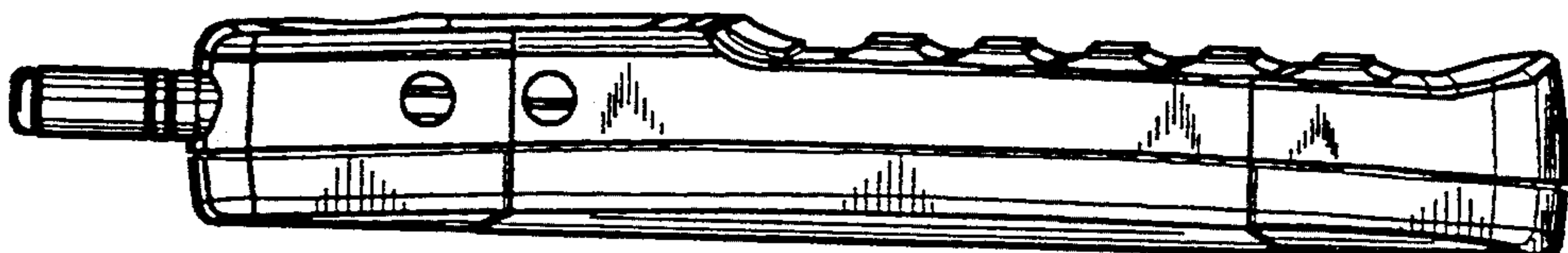

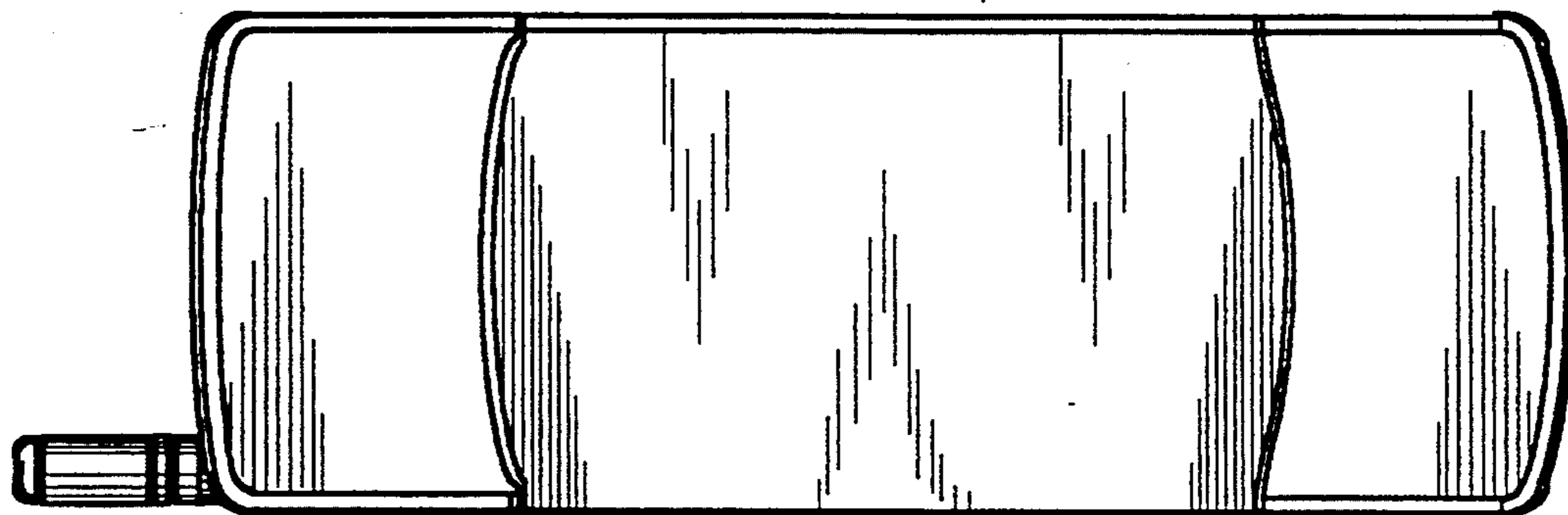

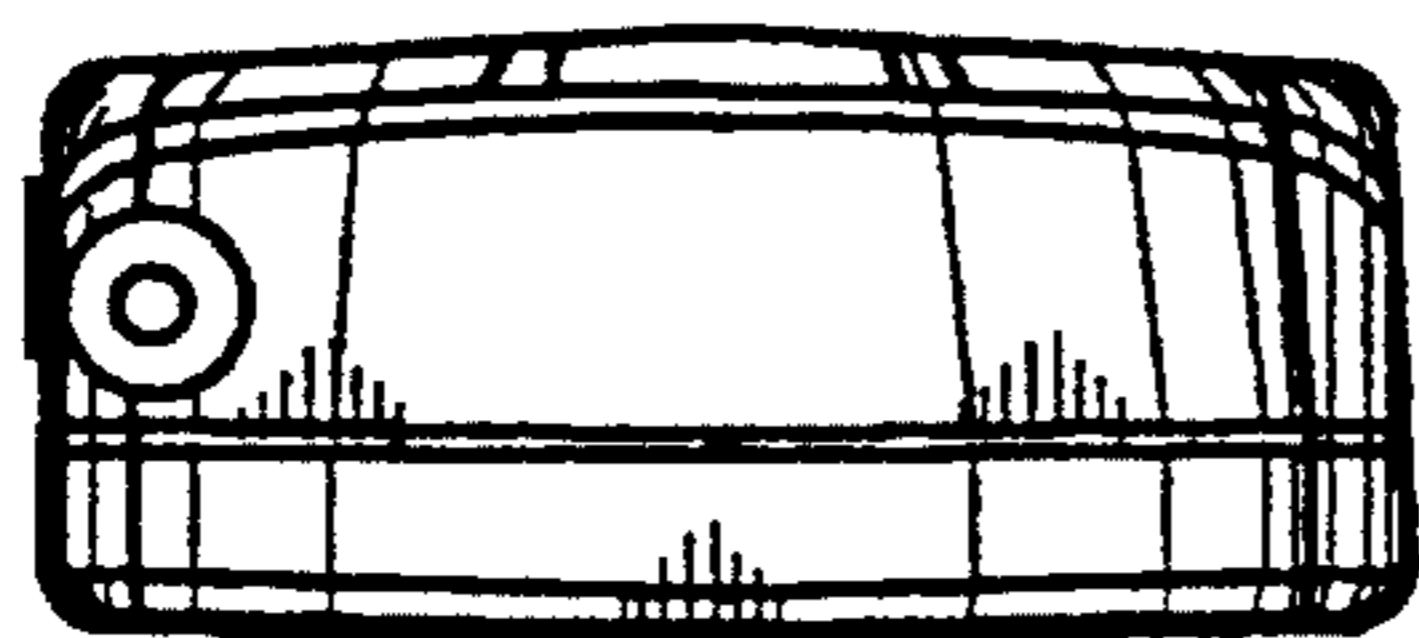

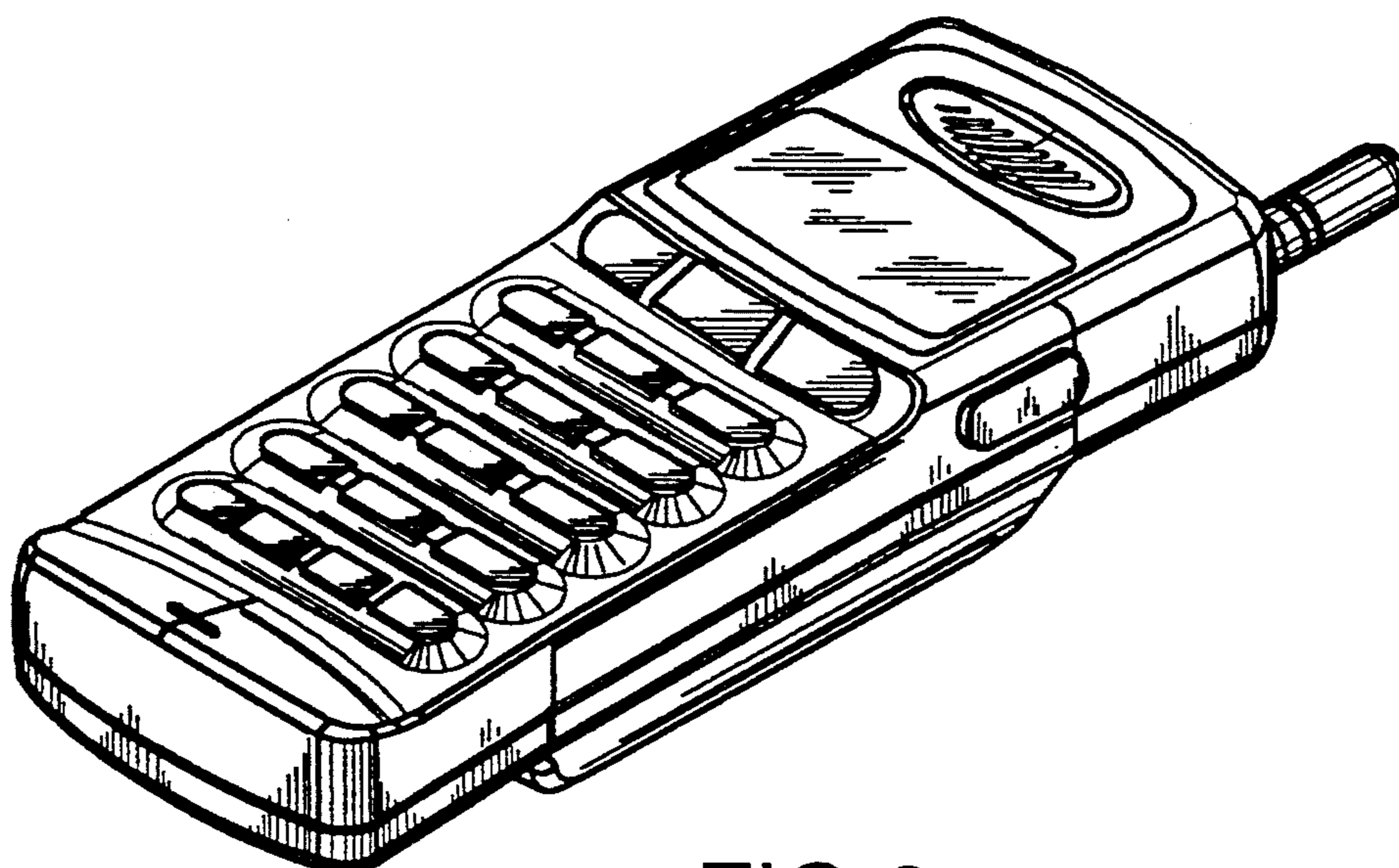

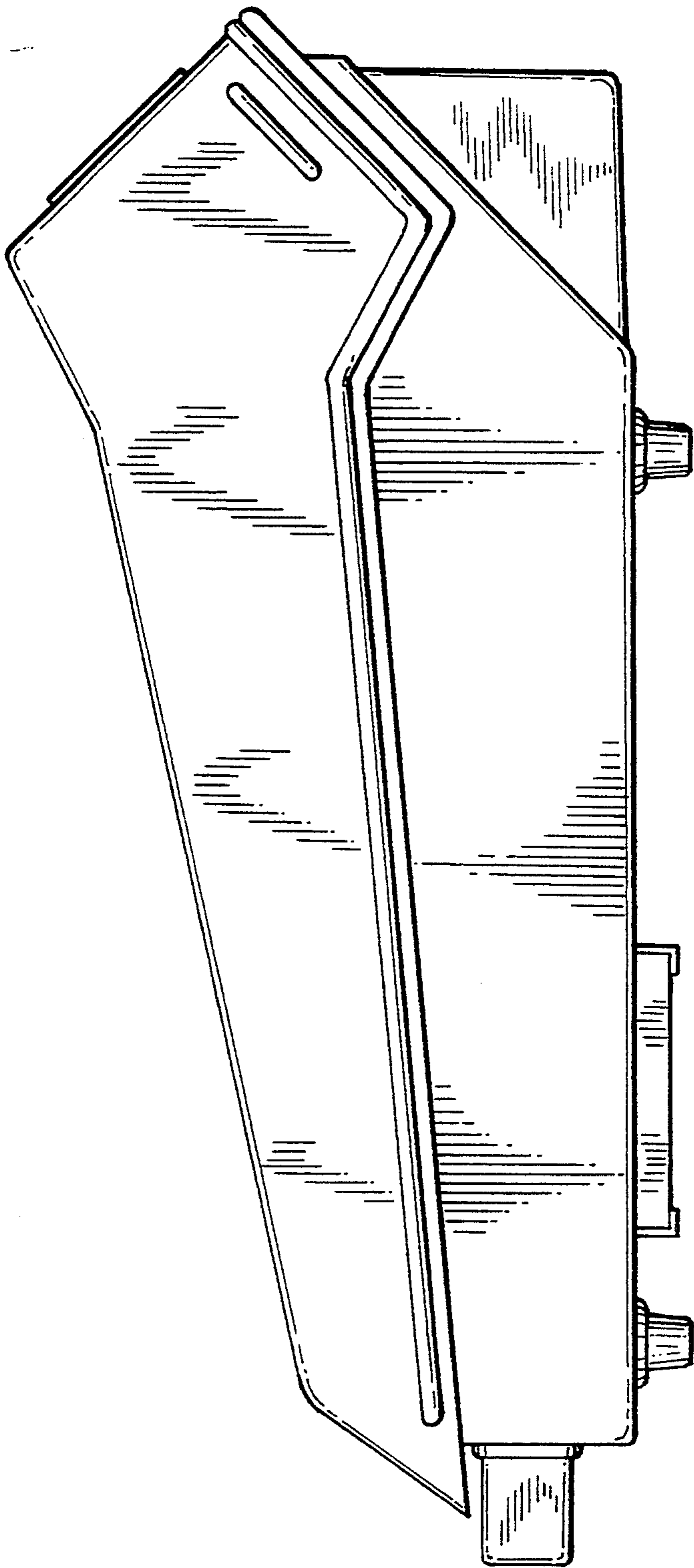

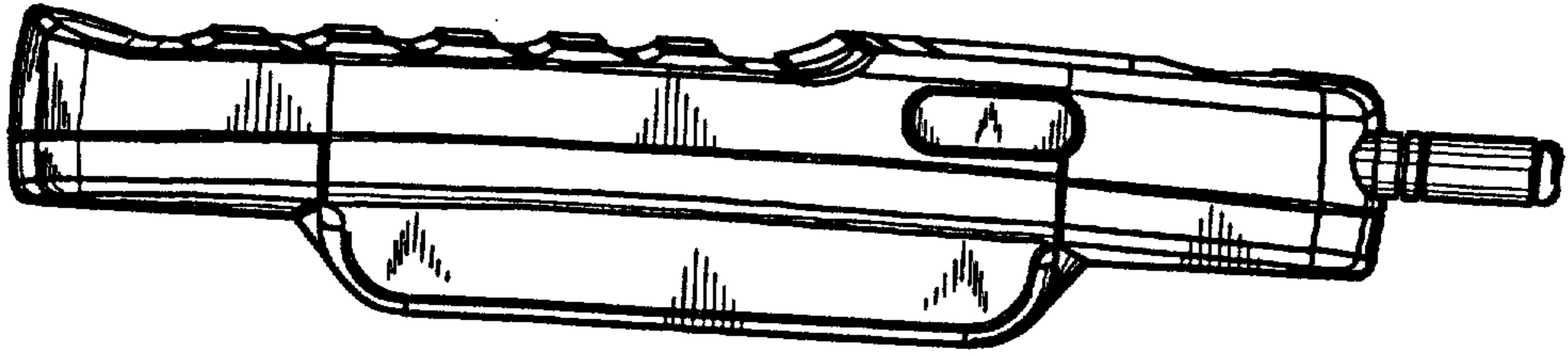

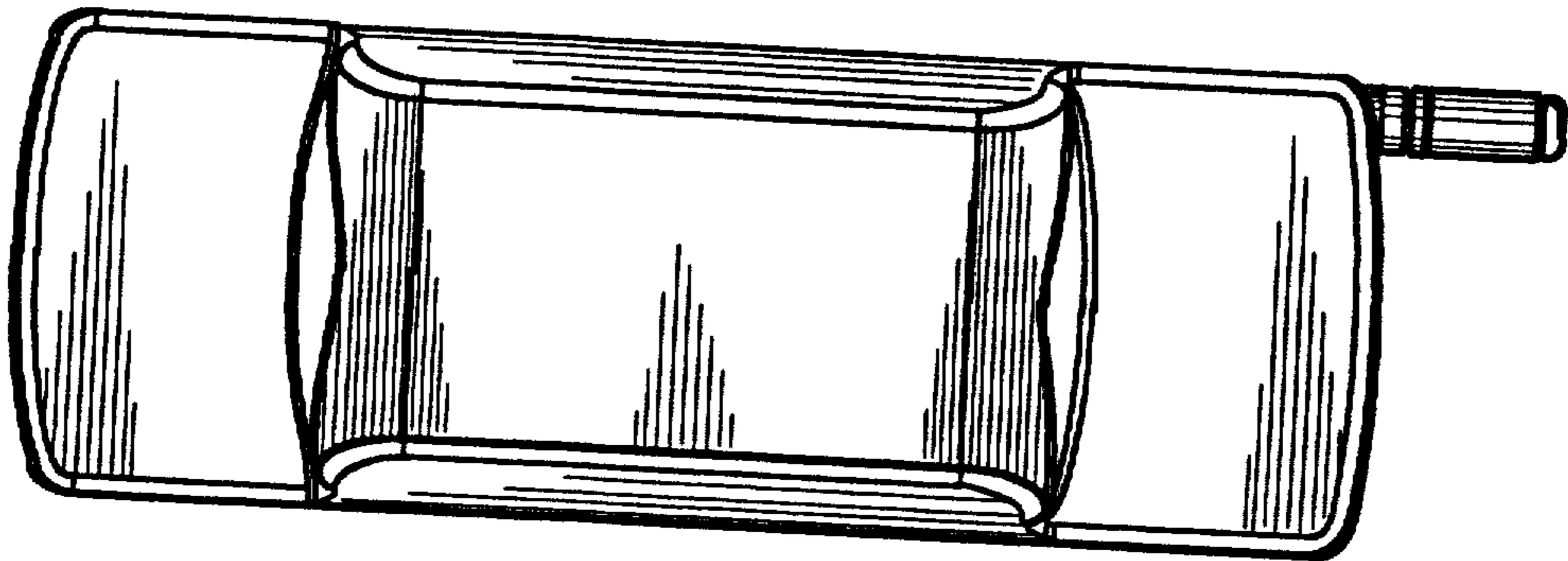

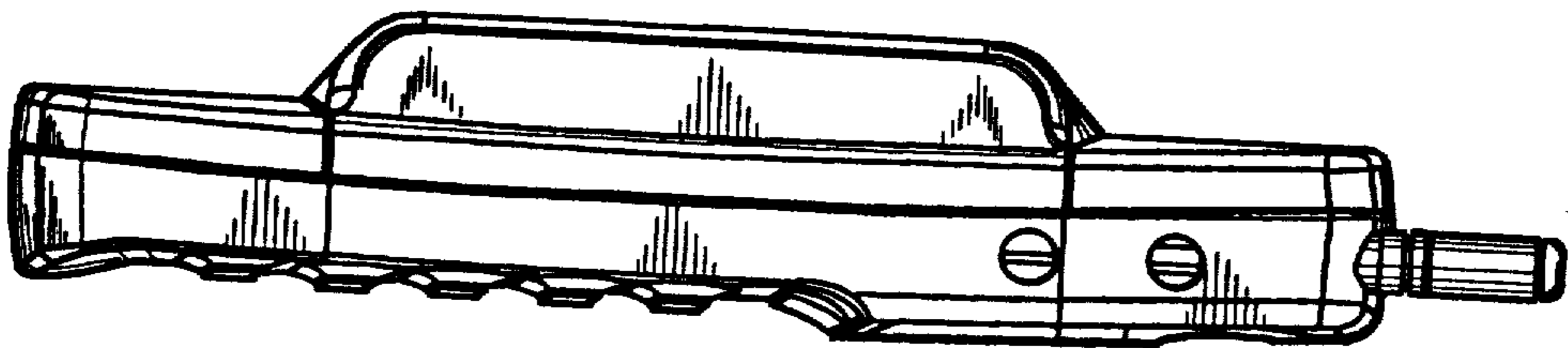

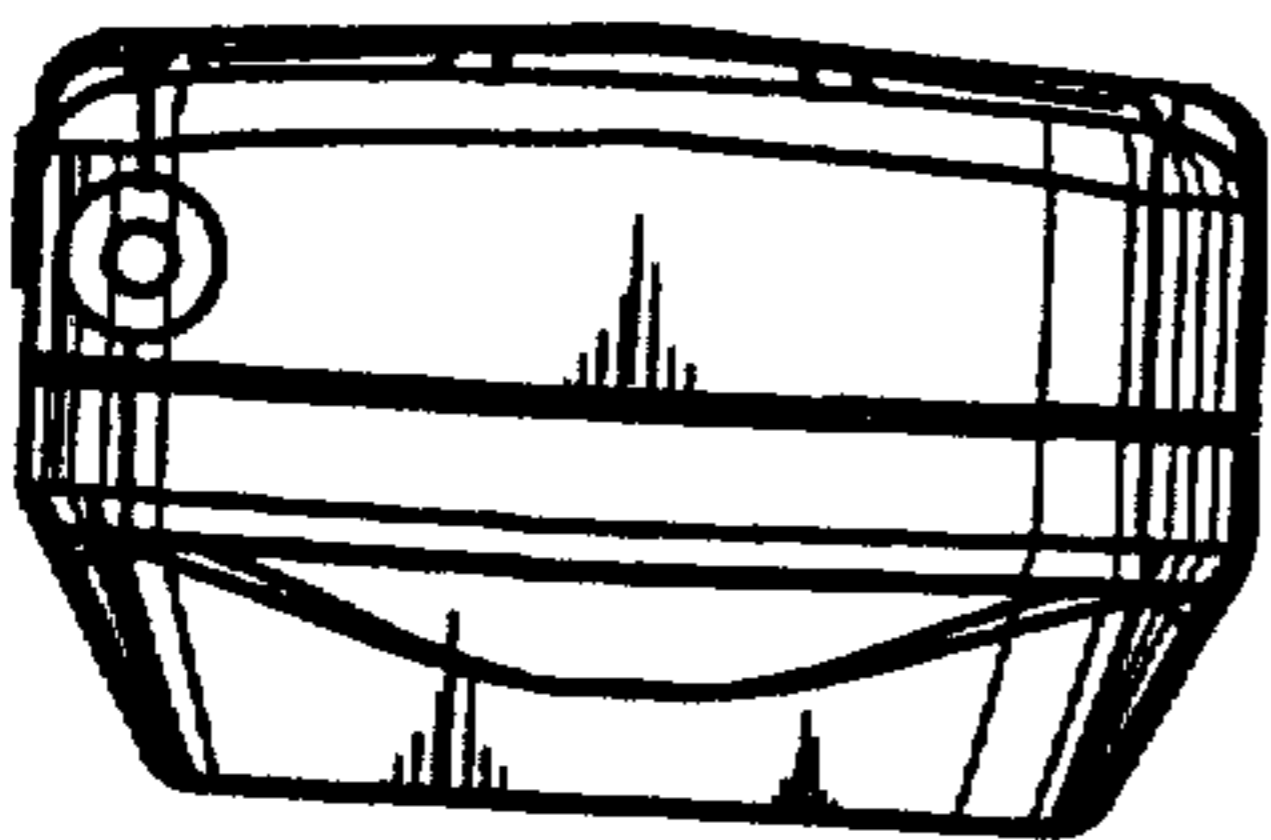
