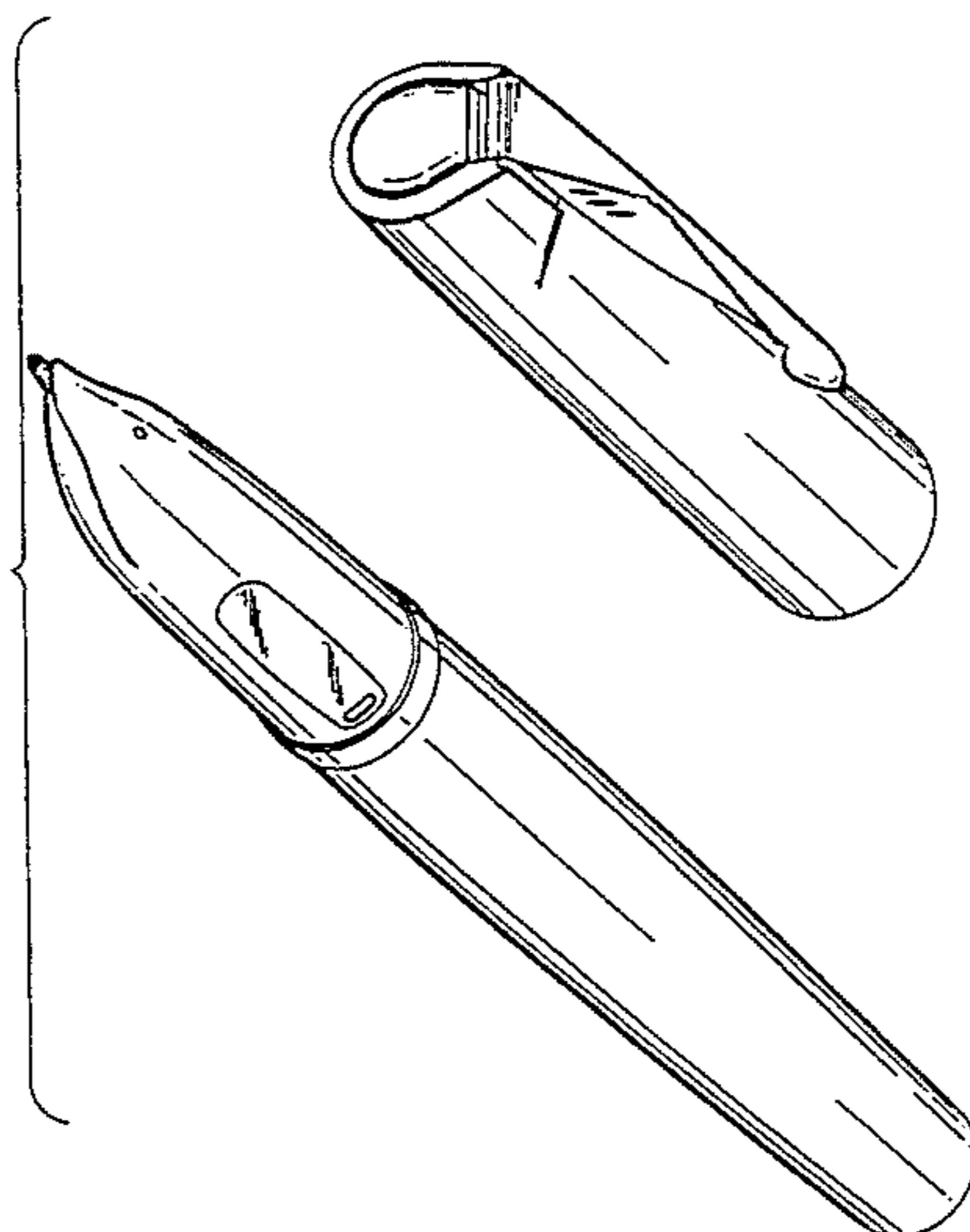

[57] CLAIM

The ornamental design for a writing instrument, as shown and described.

 FIG. 34 is a top plan view of FIG. 31.



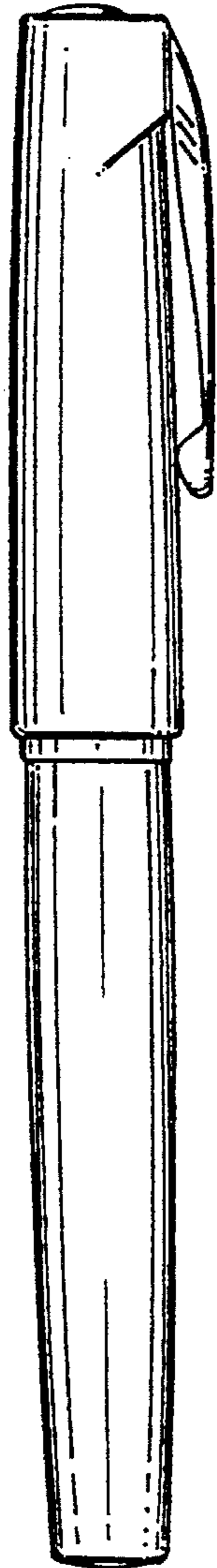

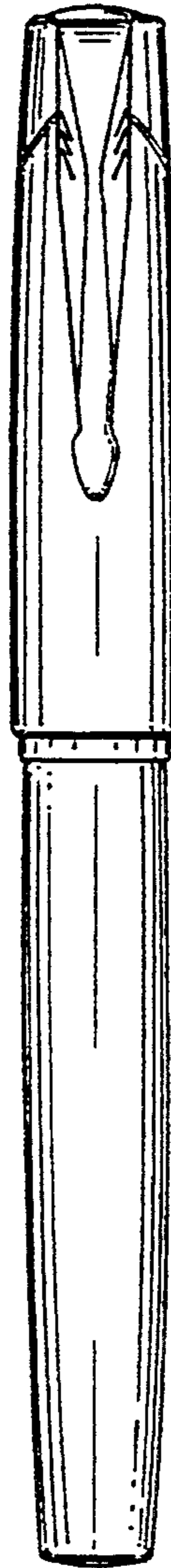

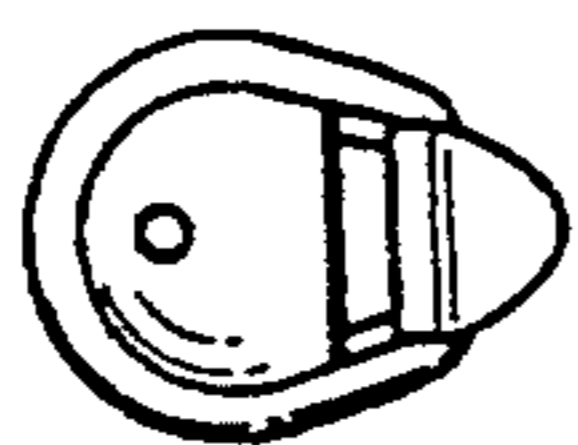

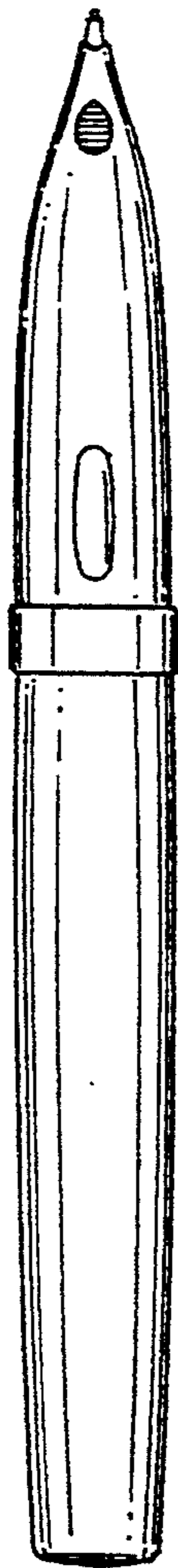

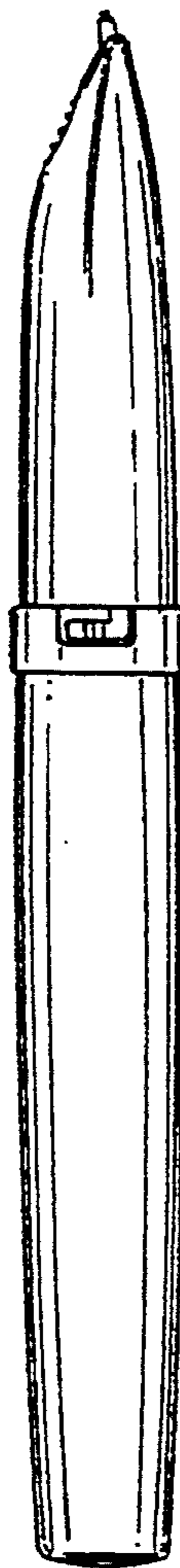

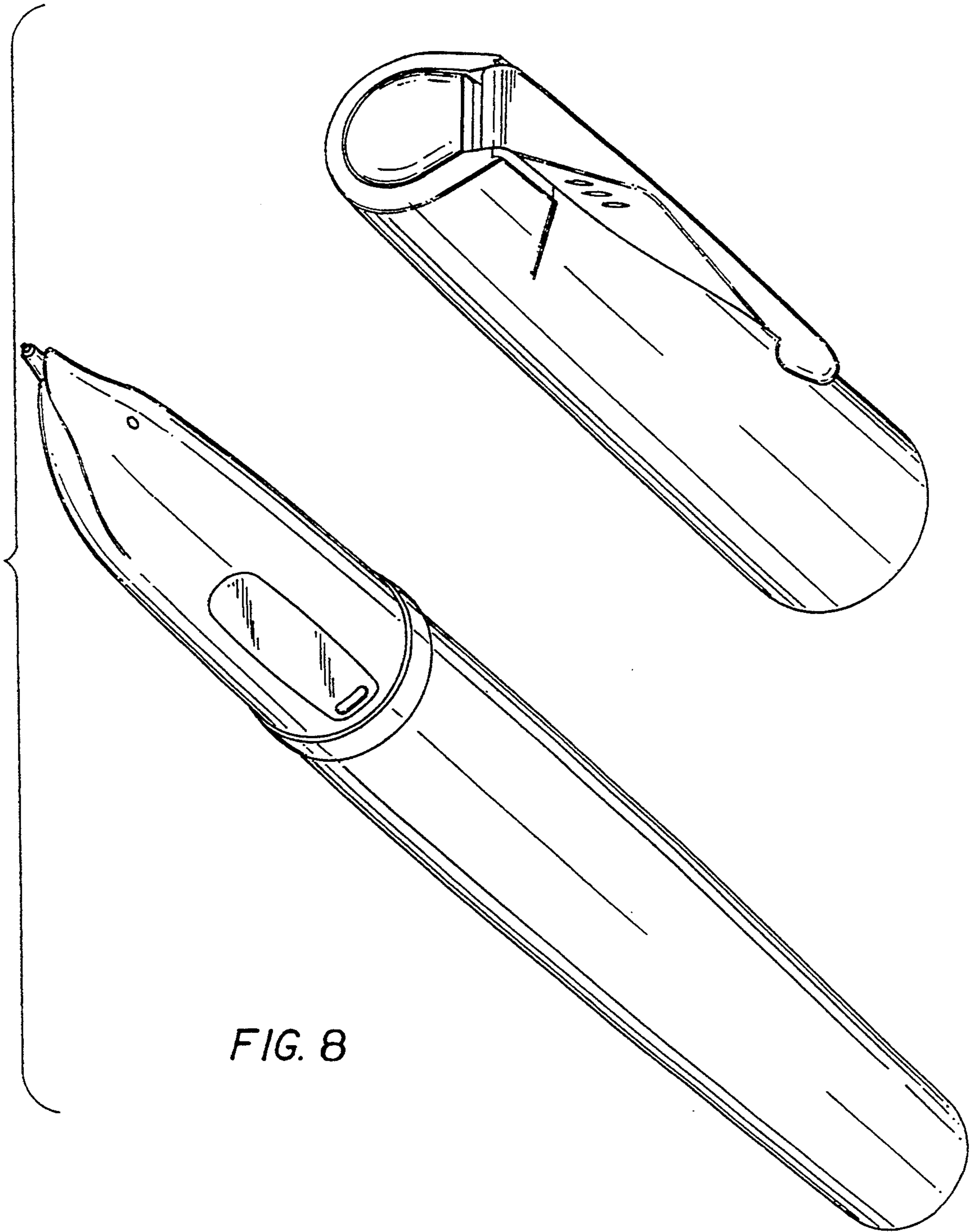

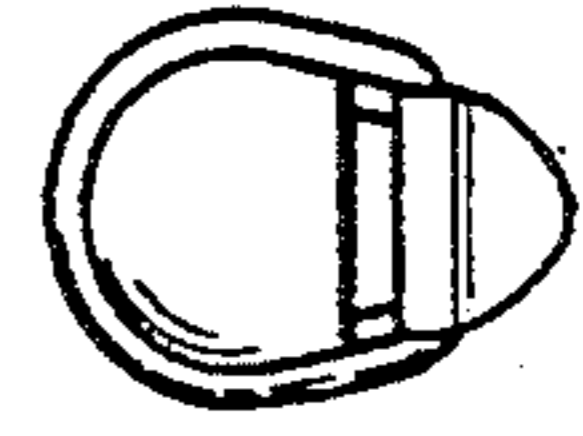

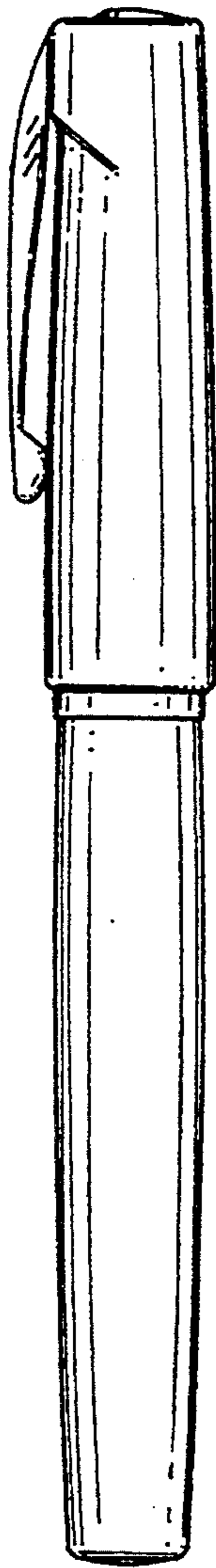

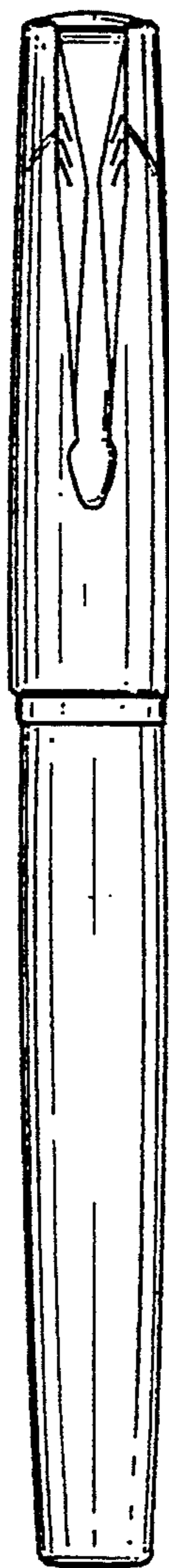

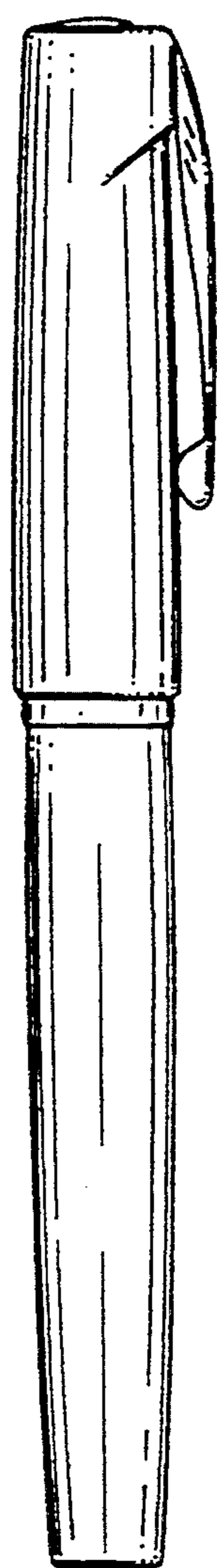

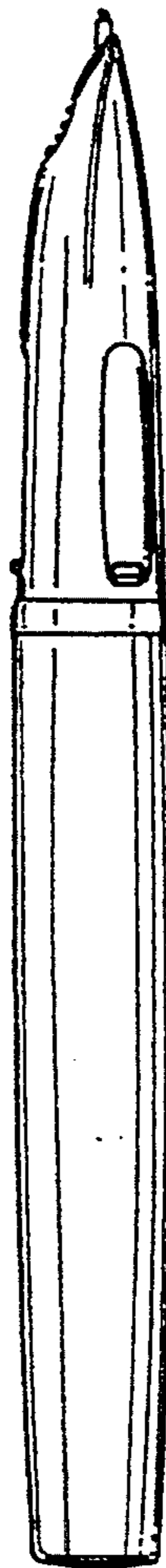

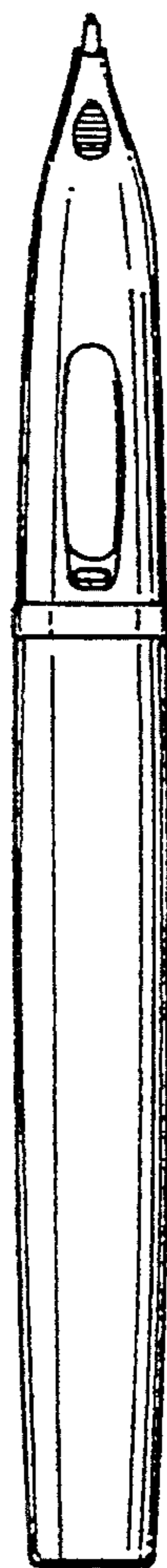

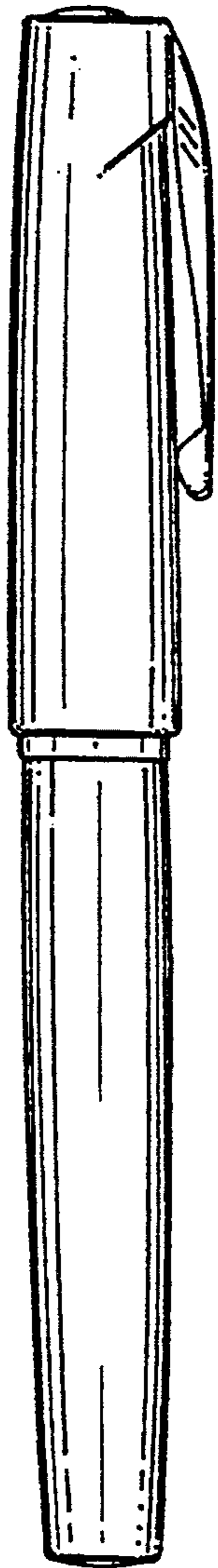

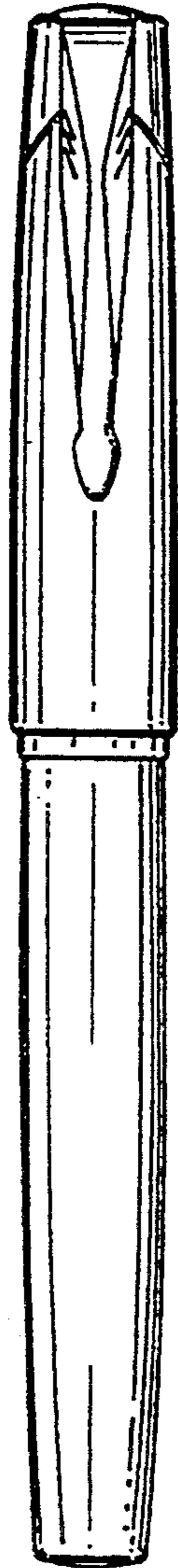

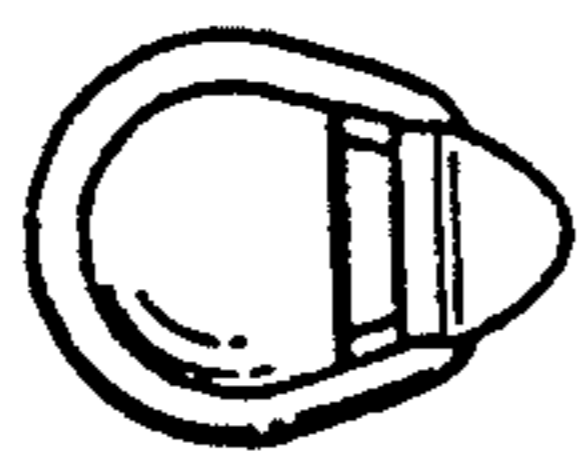

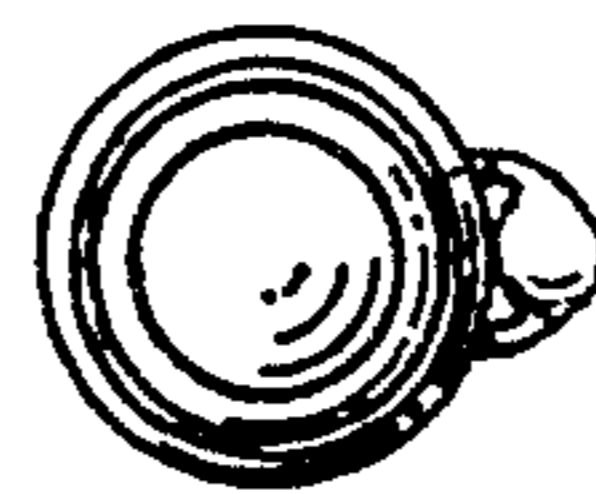

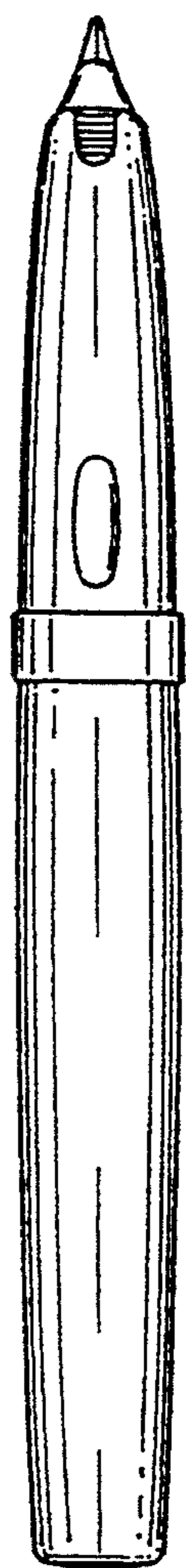

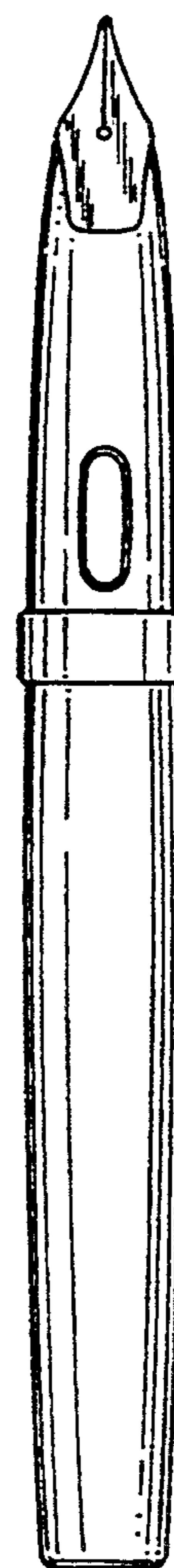

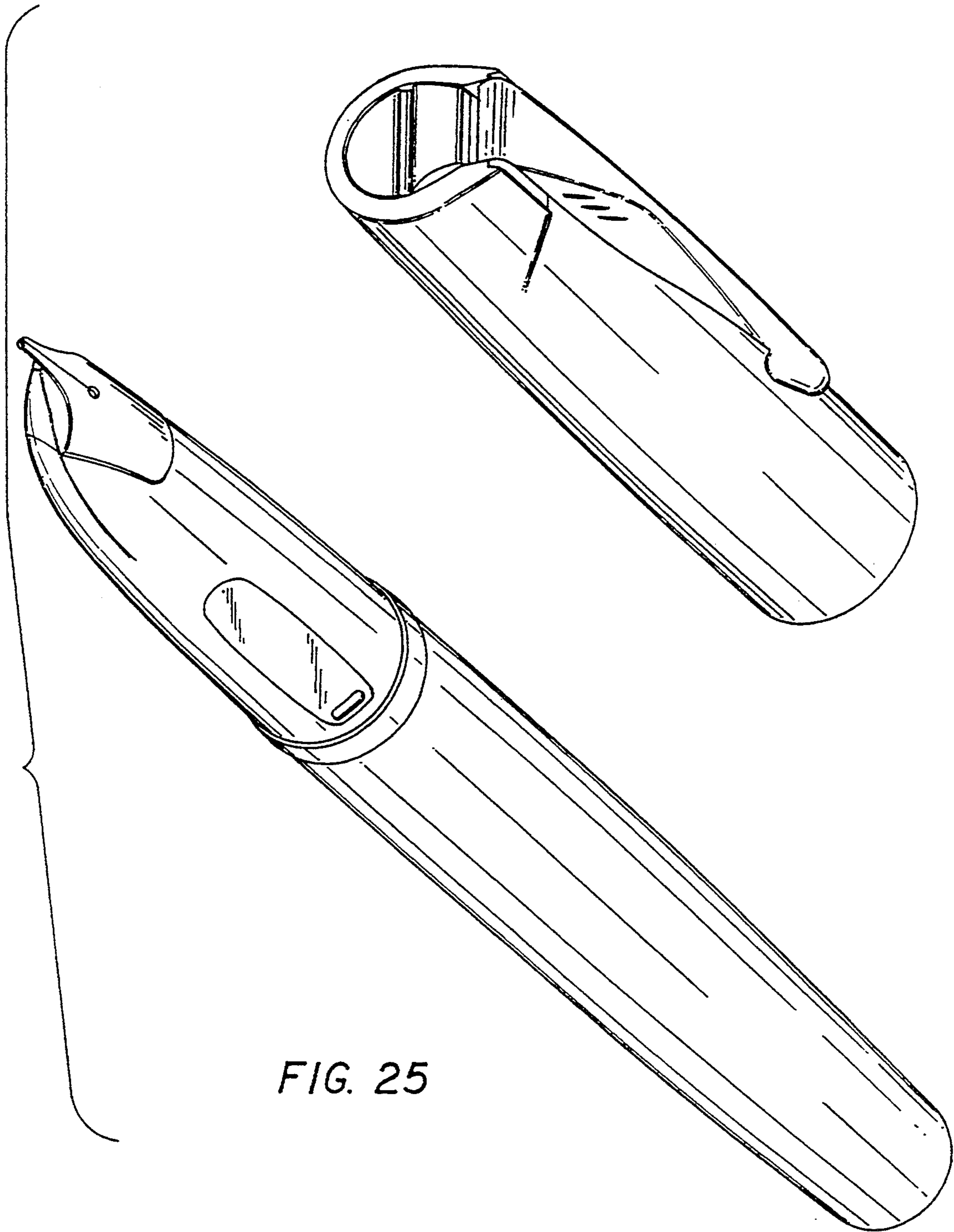

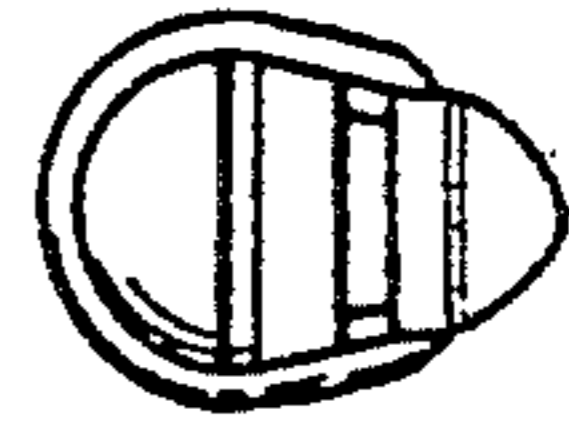

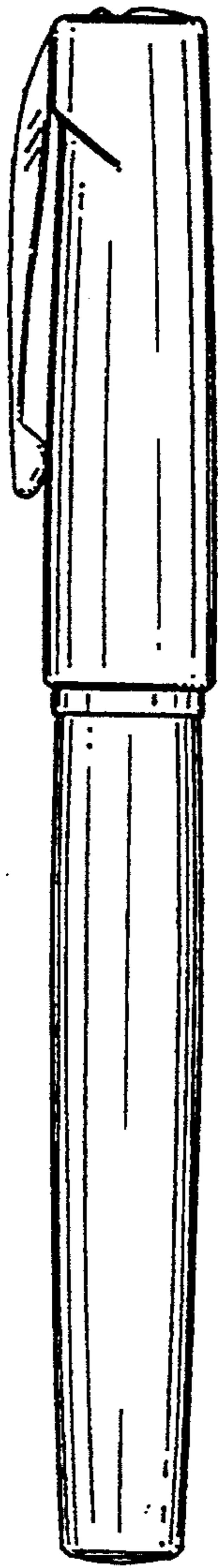

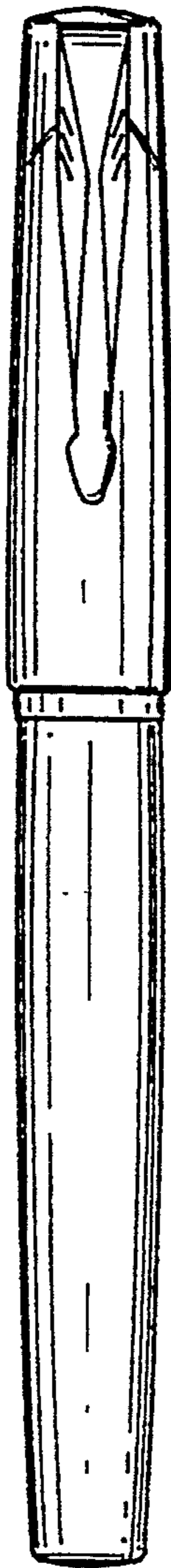

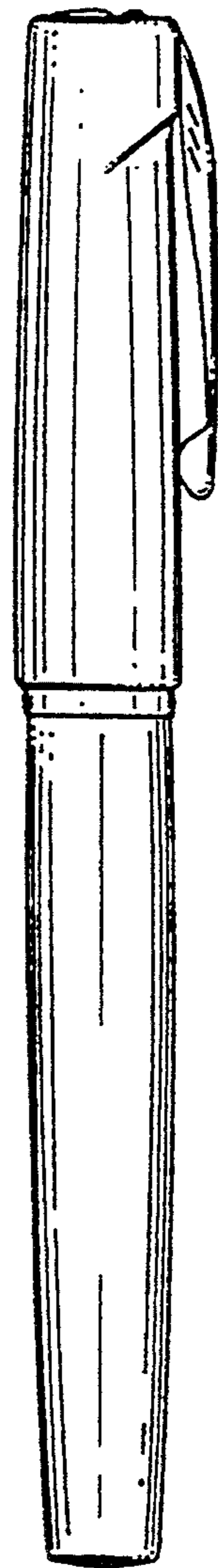

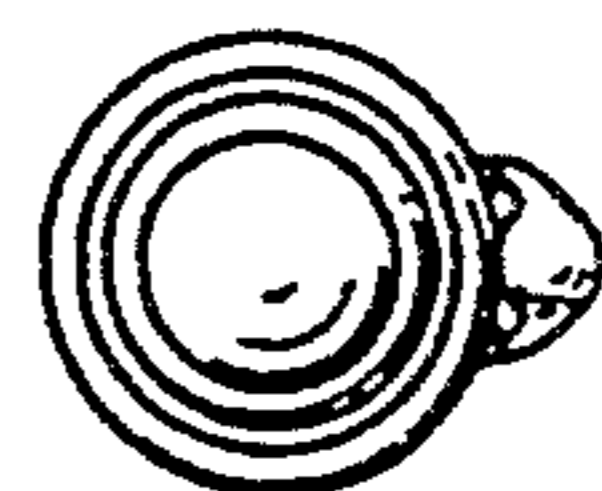

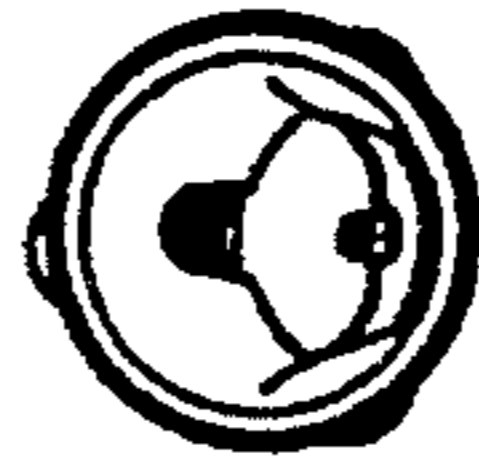
