### DESCRIPTION

FIG. 1 is a front elevation of a barrette attachment in accordance with my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a rear elevation thereof, and; FIG. 6 is a right side elevation view thereof. The broken line showing of the barrette in FIGS. 2, 3, 5 and 6 is for illustrative purposes only and forms no part of the claimed design.

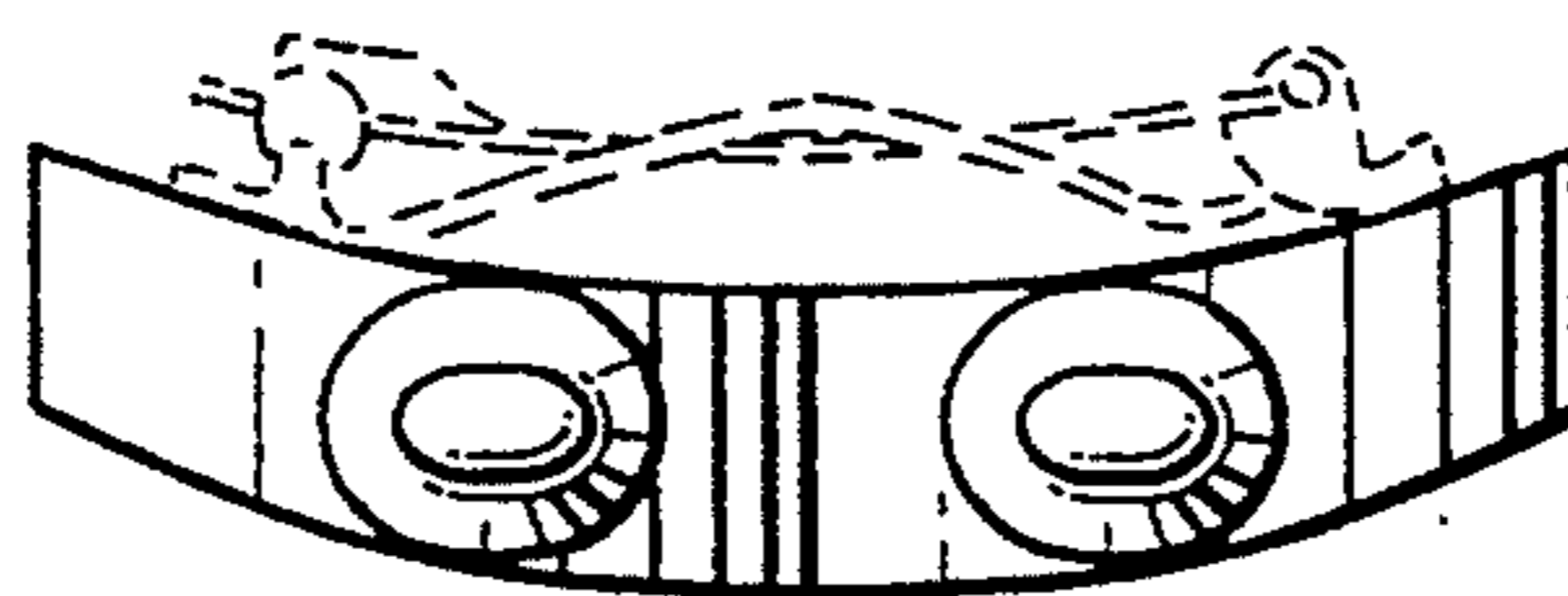
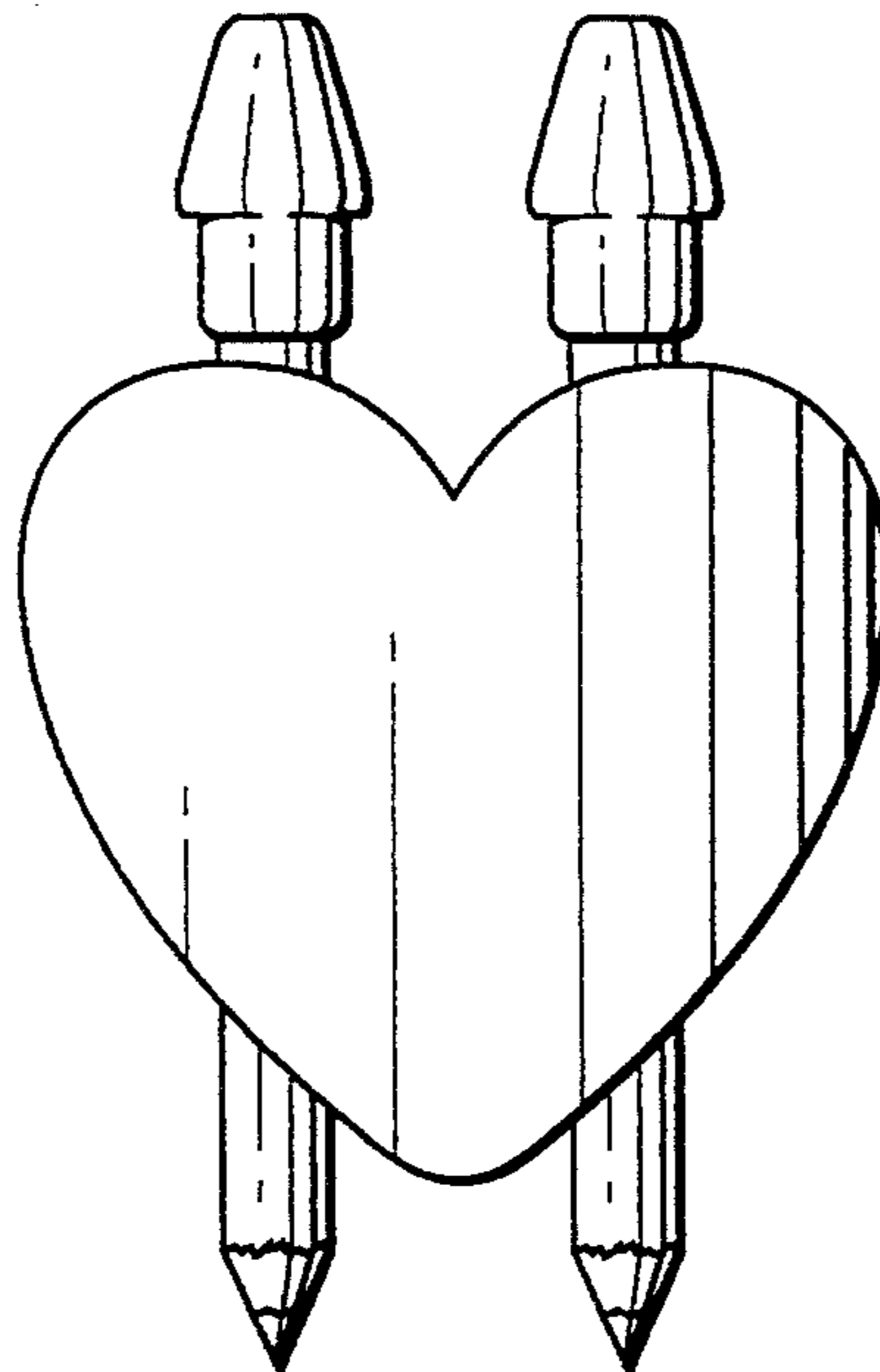

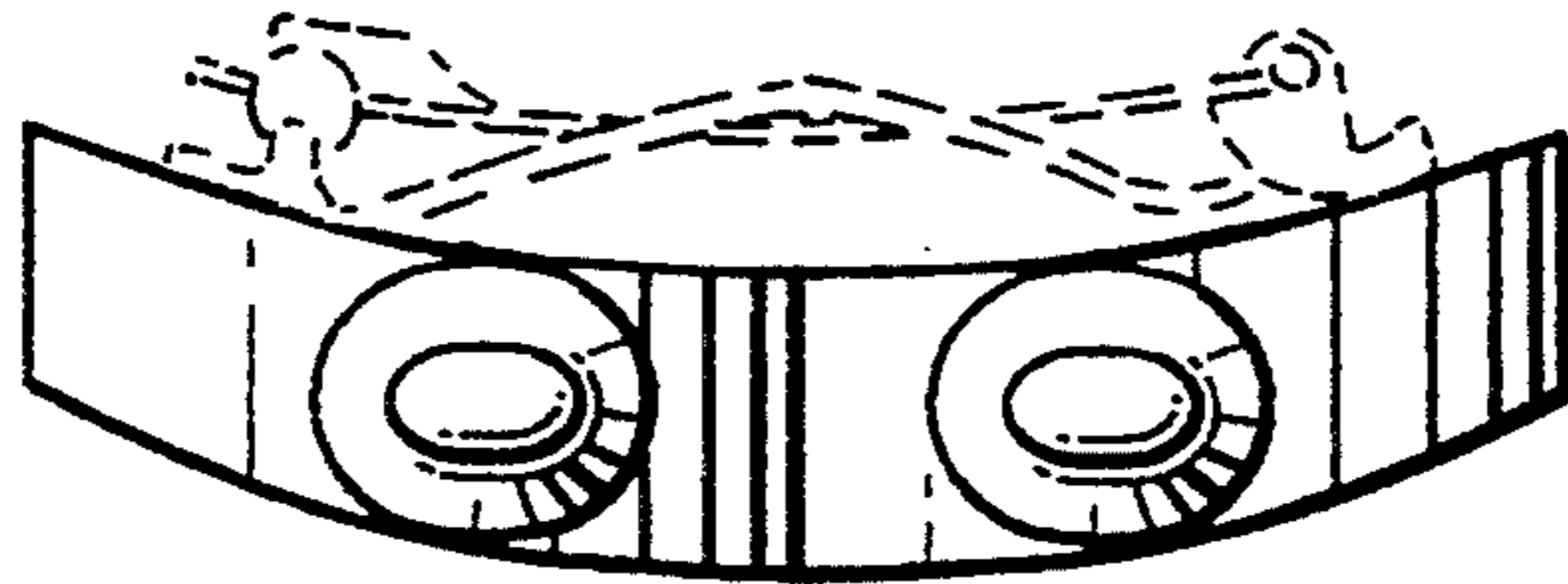

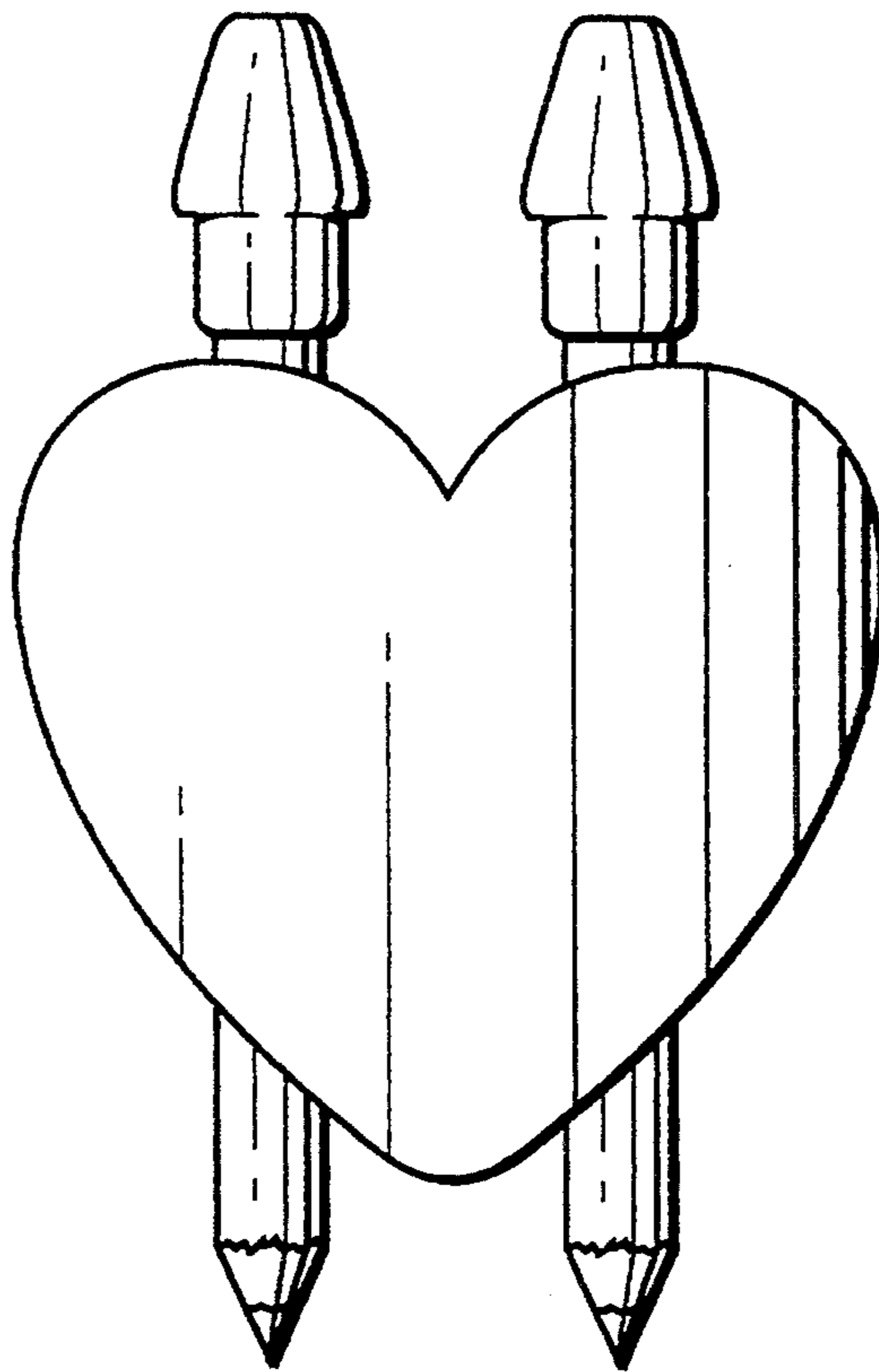

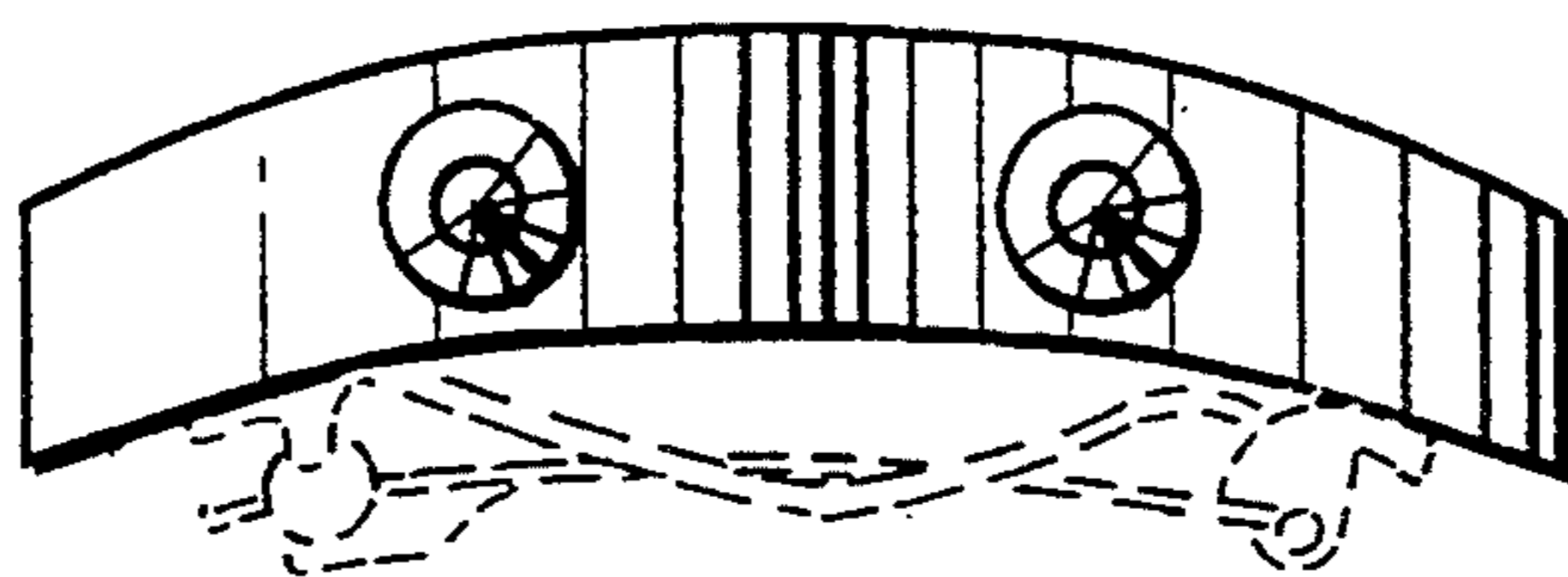

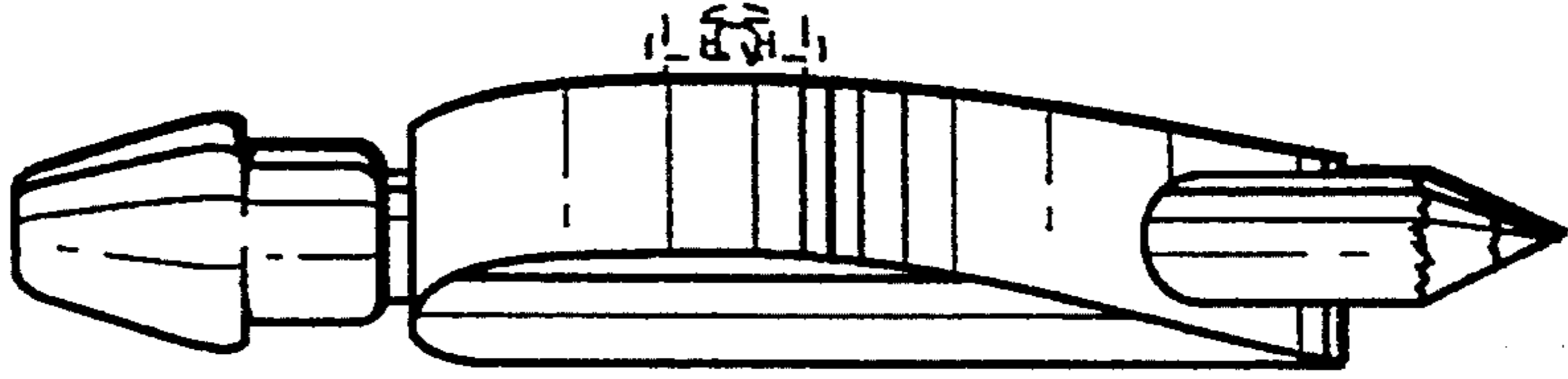

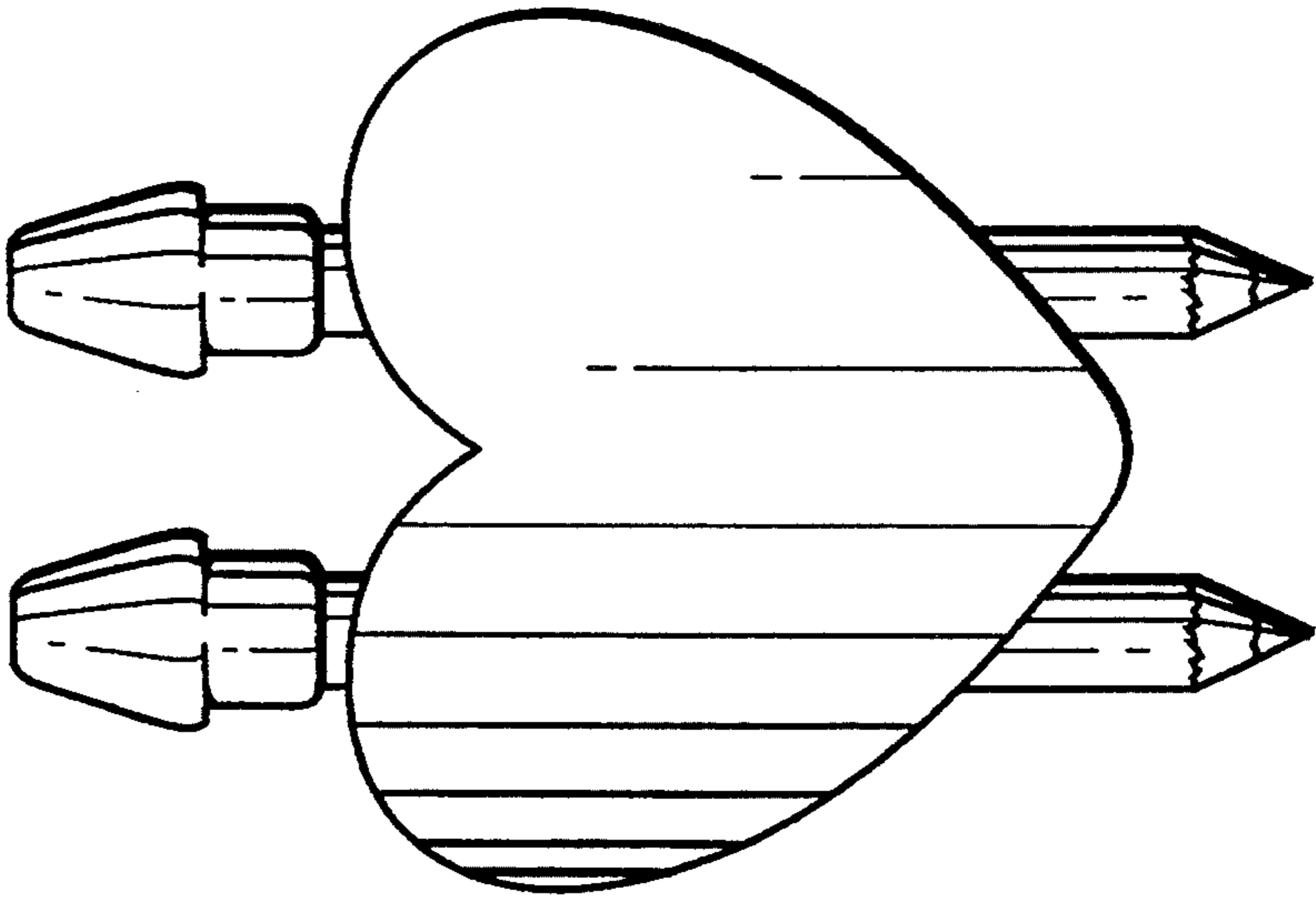
