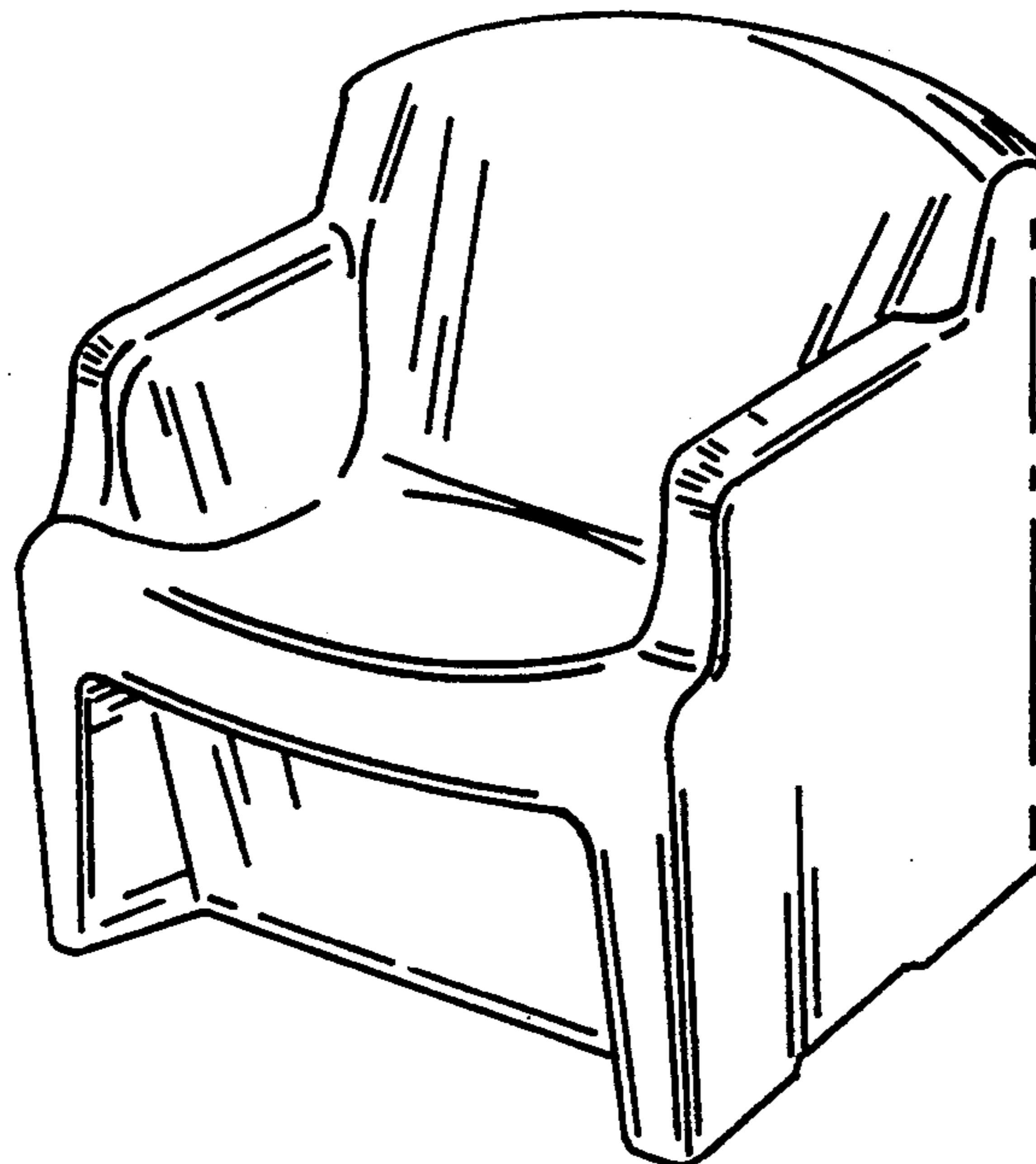

### DESCRIPTION

FIG. 1 depicts a front perspective view of a molded chair showing my new design;  
 FIG. 2 depicts a bottom plan view of a molded chair showing, which is a bottom view of FIG. 1;  
 FIG. 3 depicts a top plan view of a molded chair showing my new design, which is a reverse view of FIG. 2;

 FIG. 7 depicts a side view of a molded chair showing of my new design, which is a reverse view of FIG. 6.



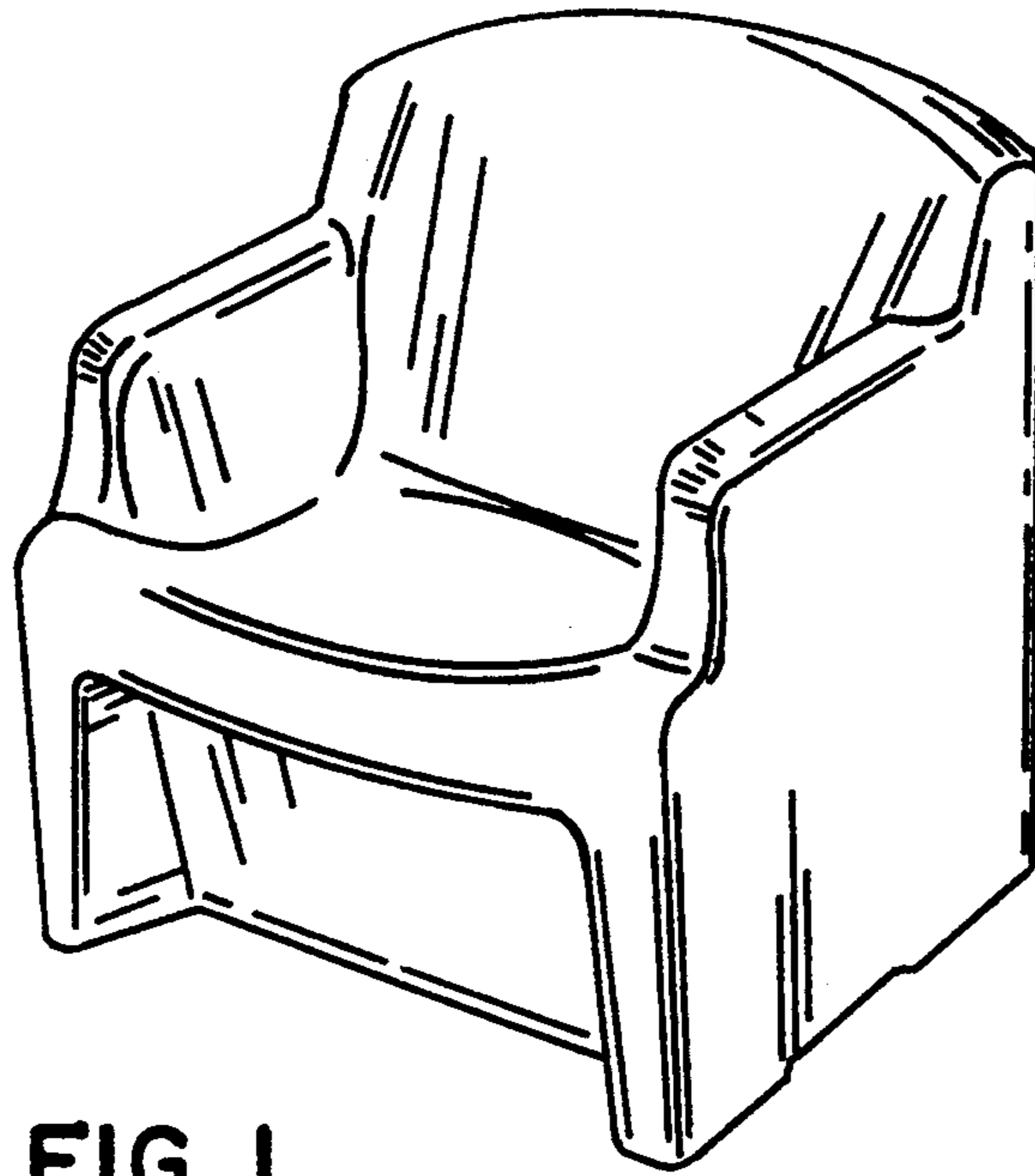

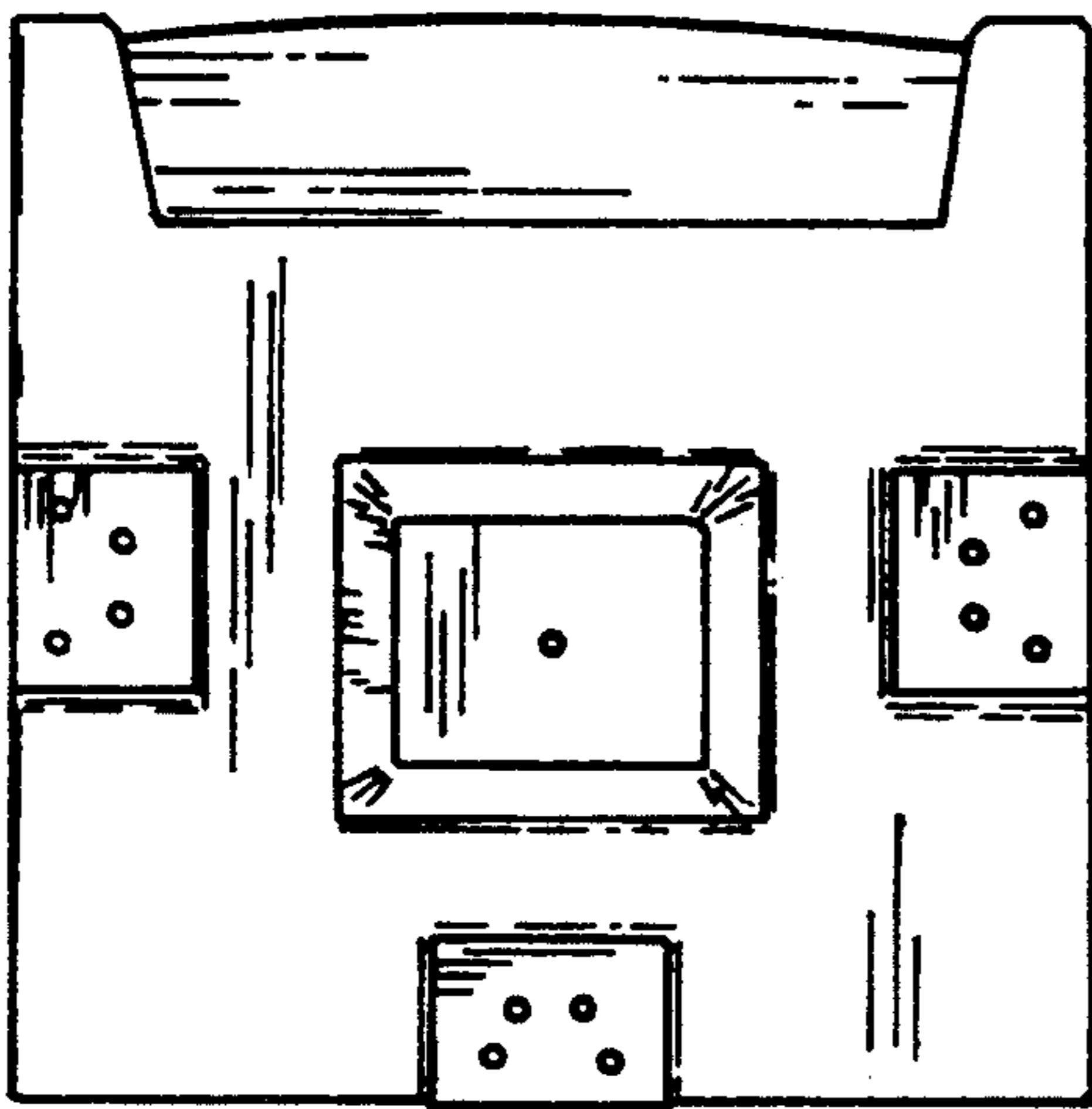

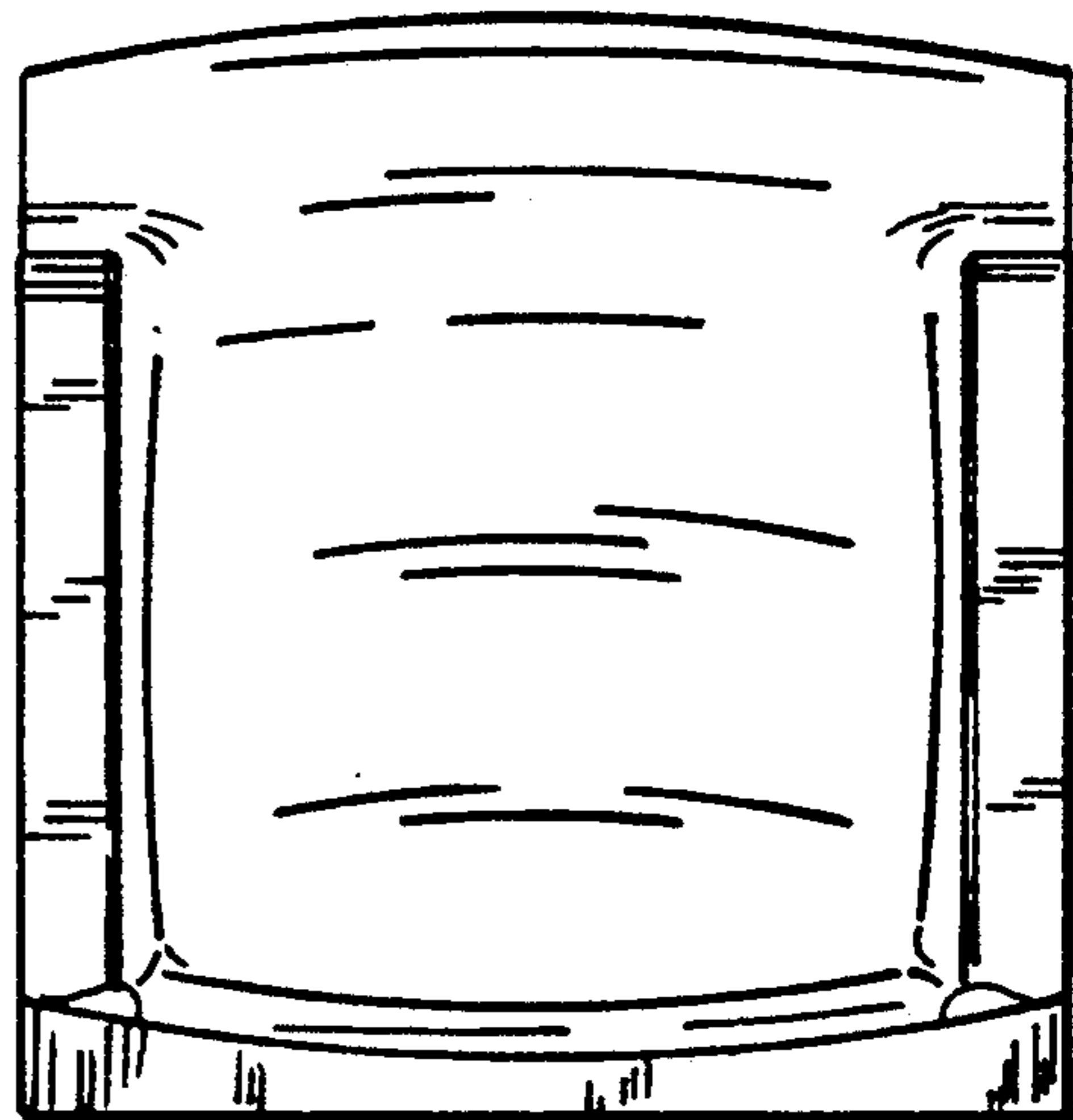

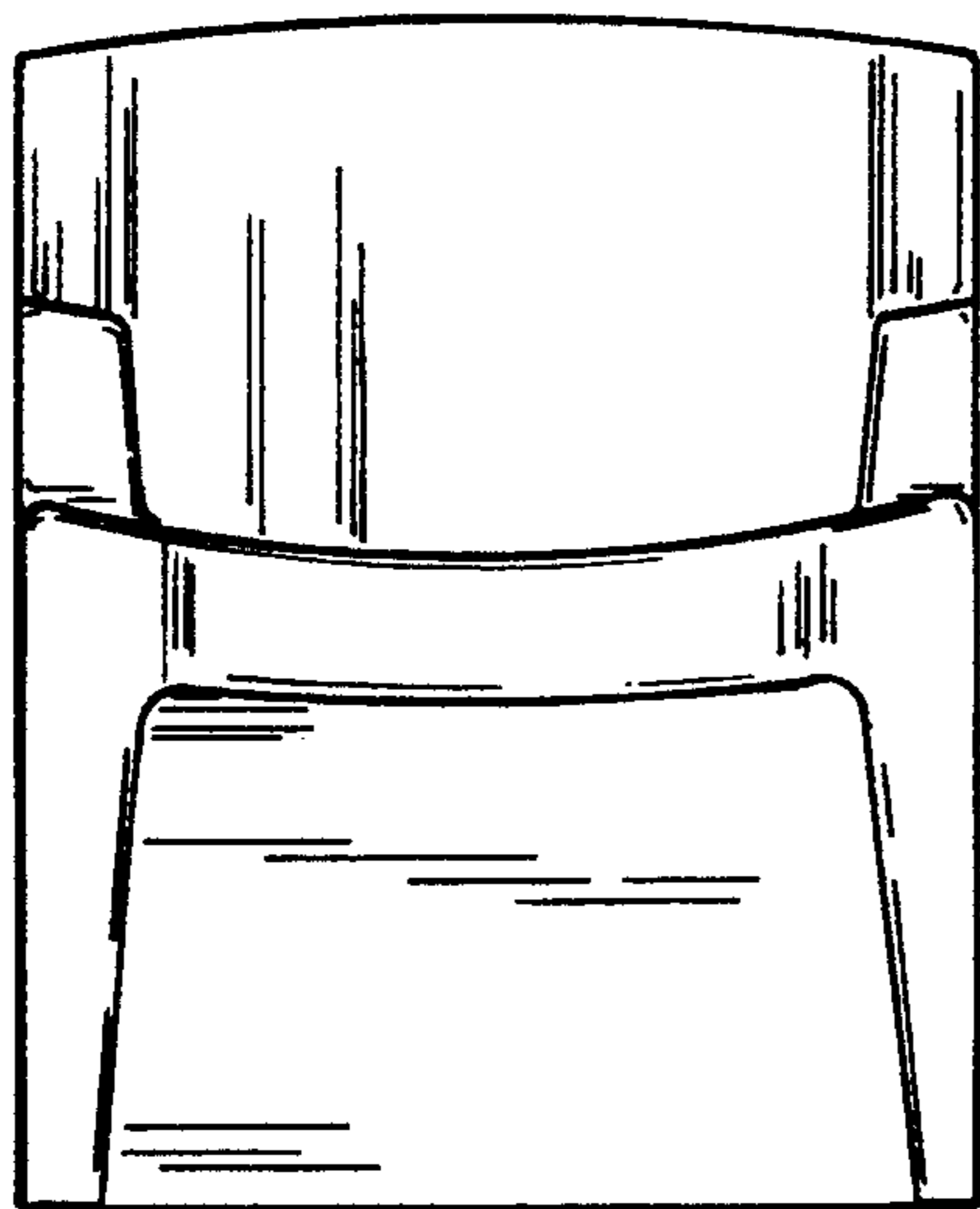

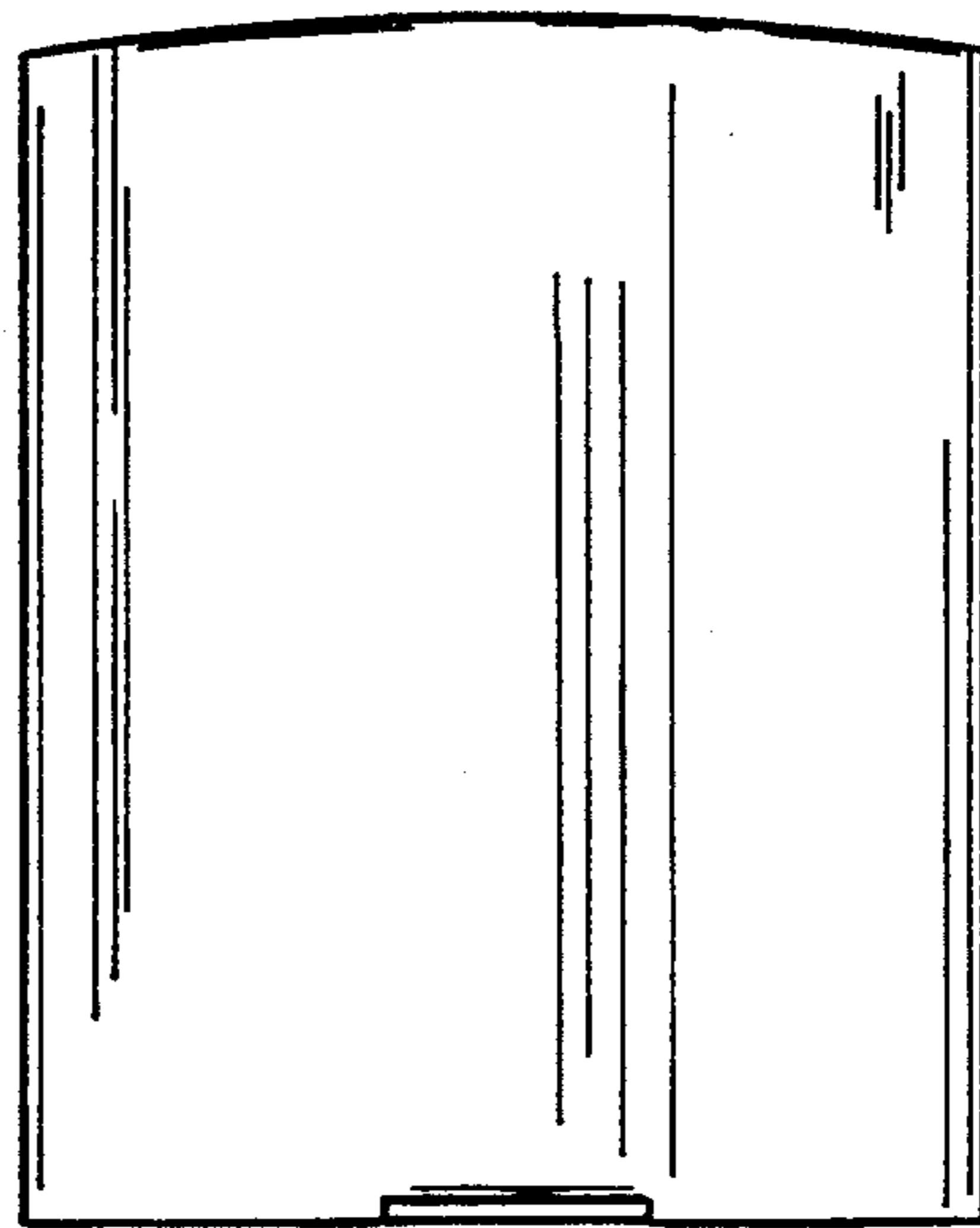

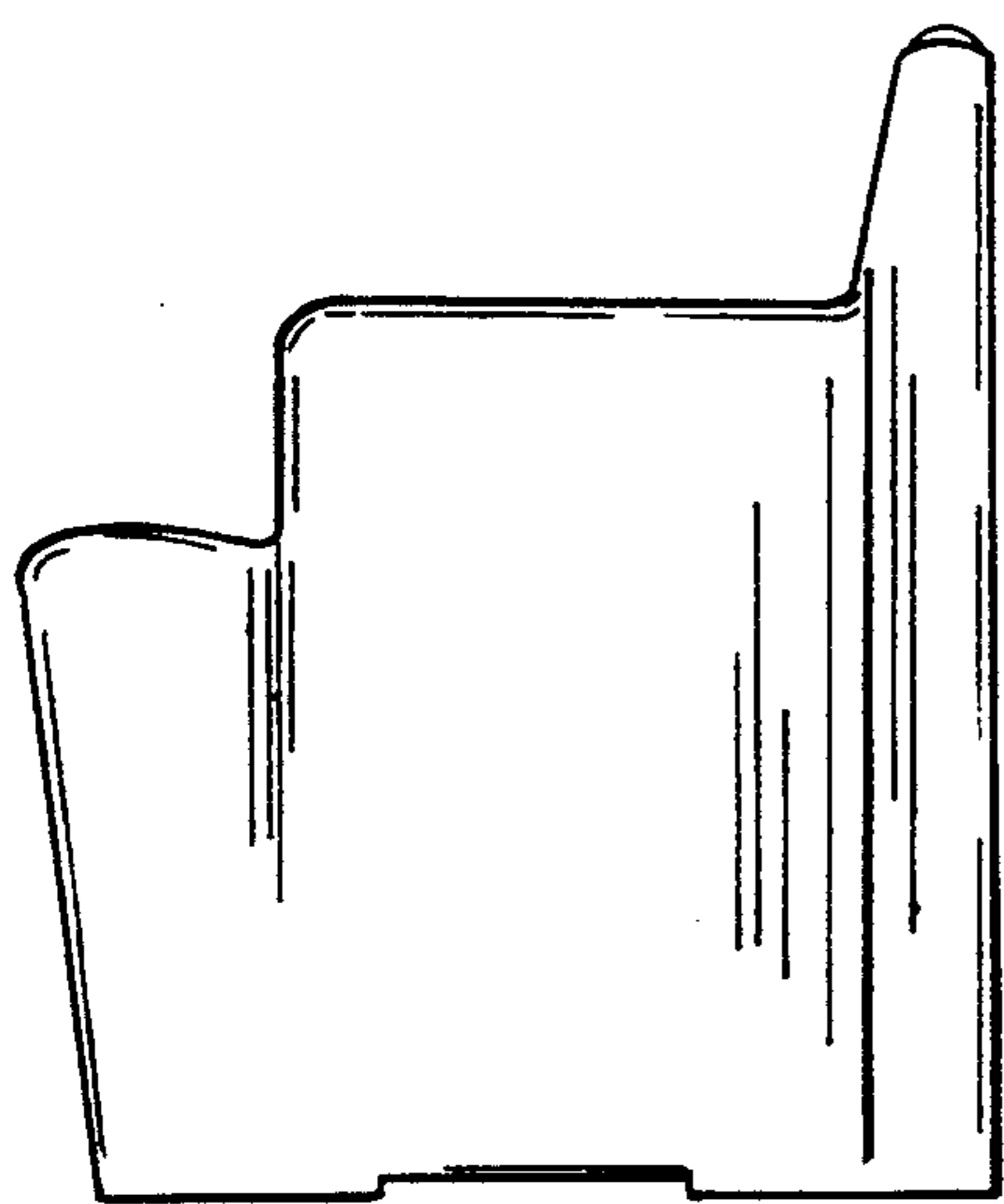

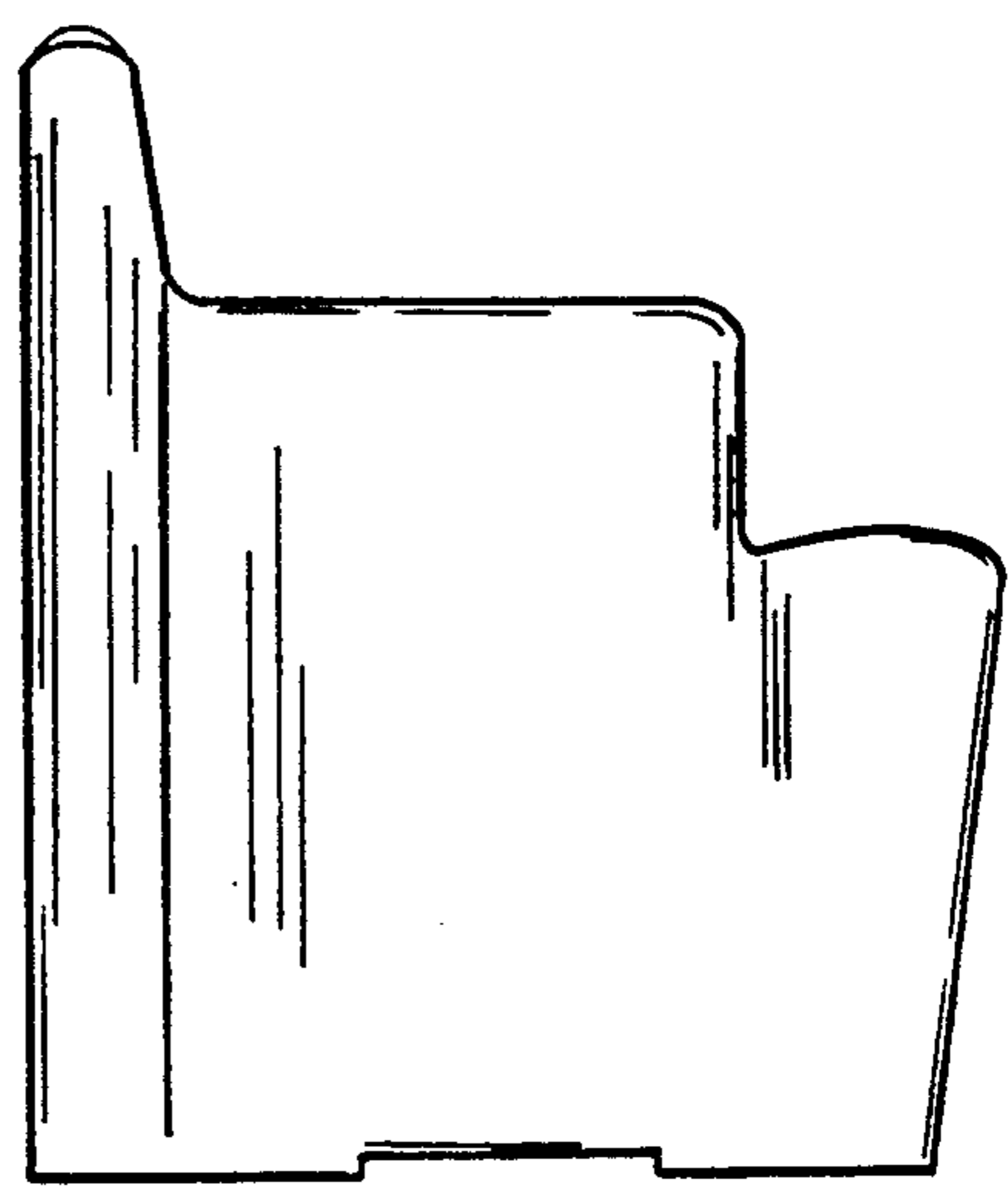
