The ornamental design for a sofa, as shown and described.

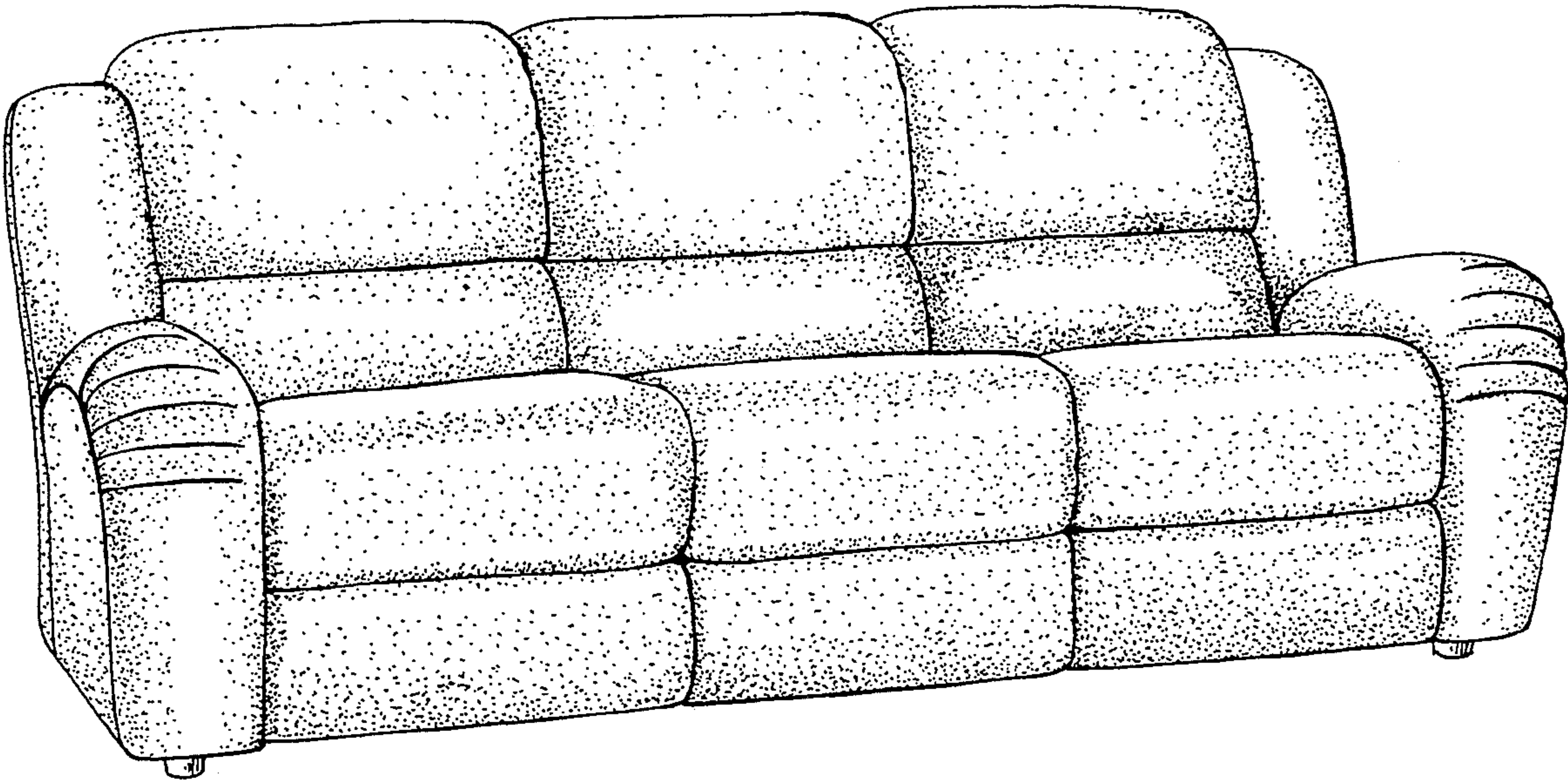
DESCRIPTION

FIG. 4 is a rear perspective view.



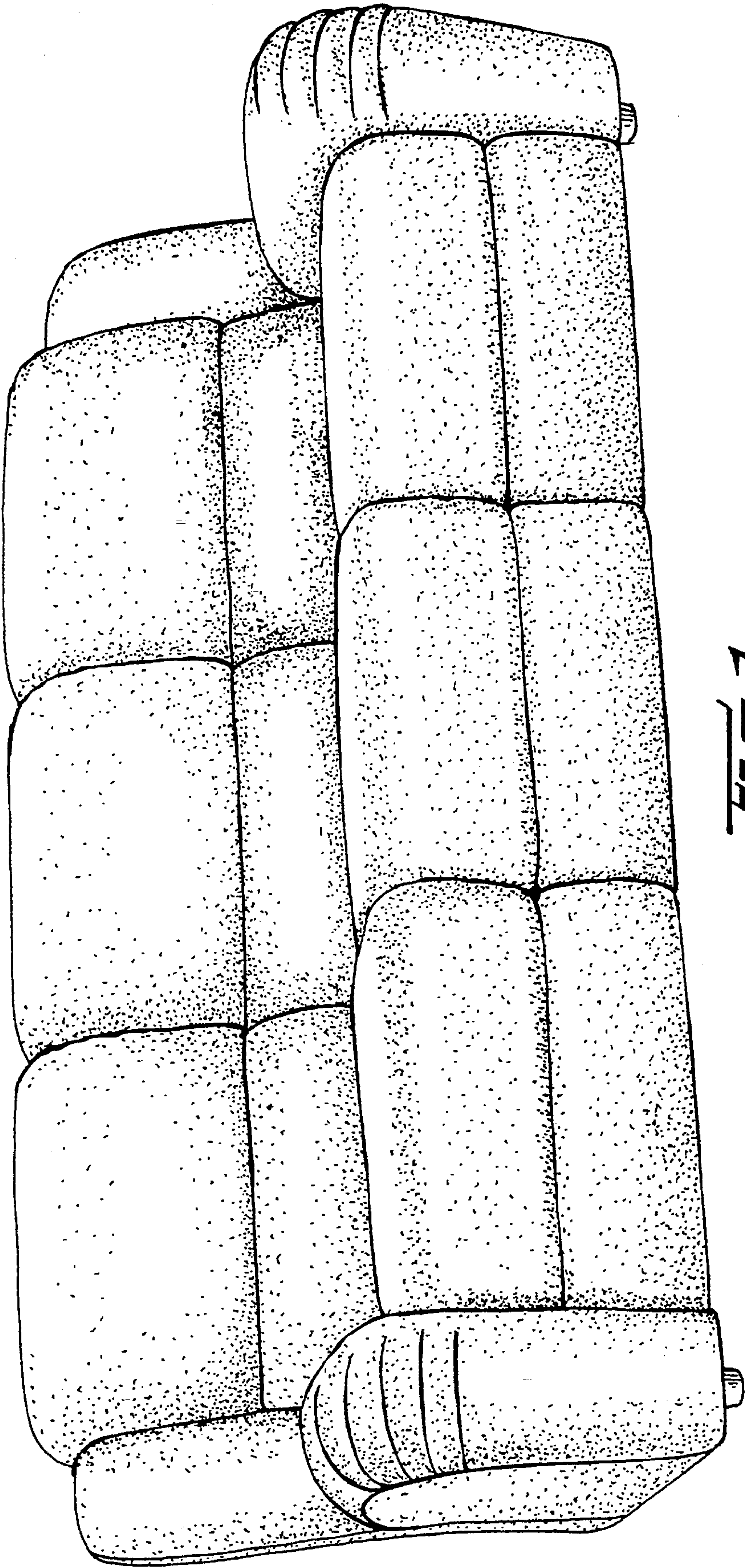

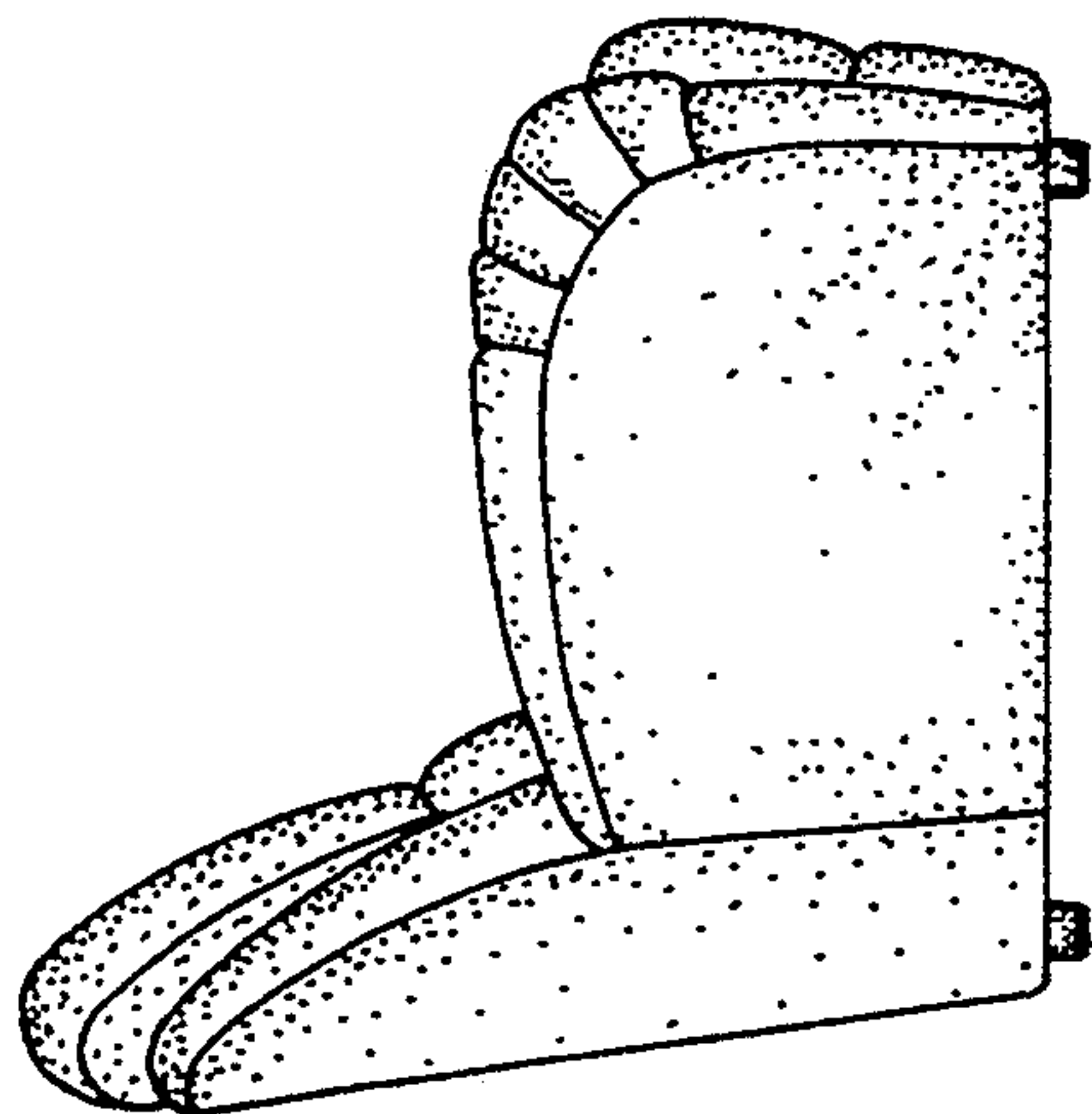

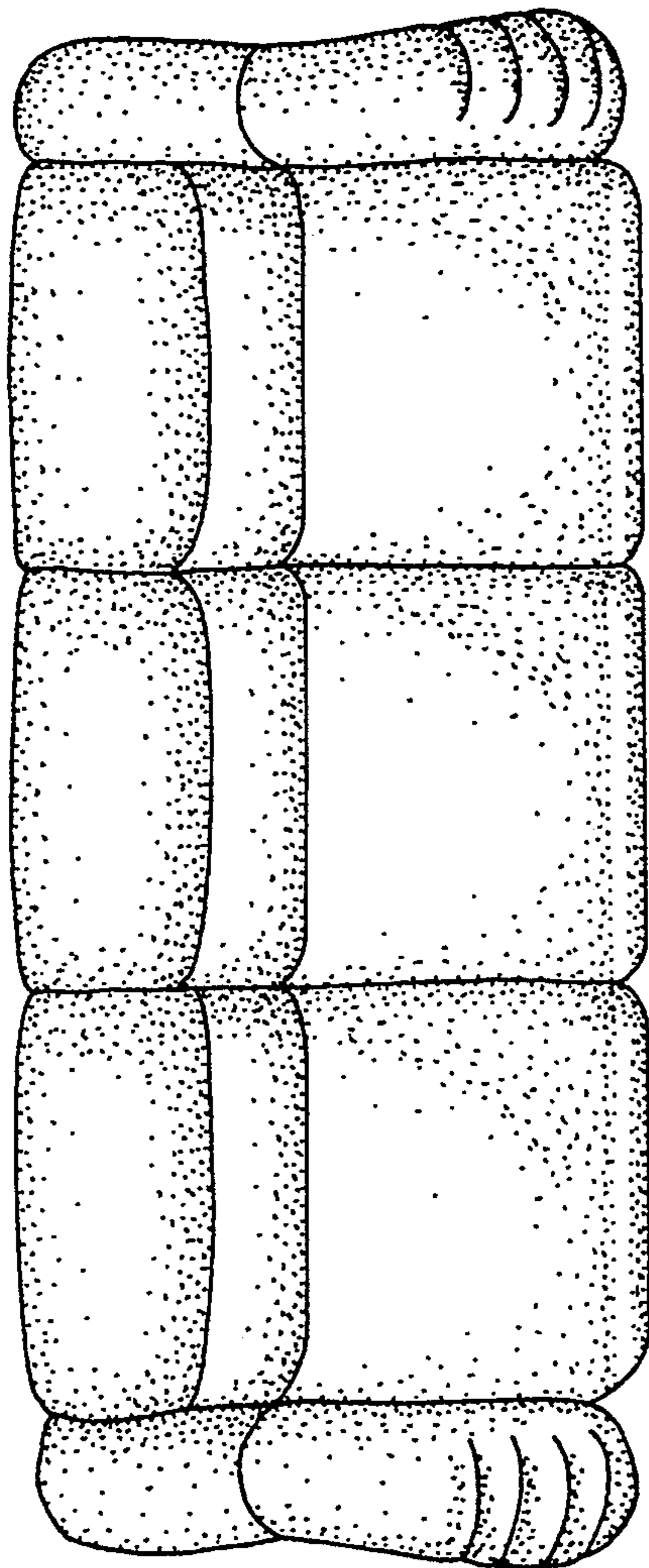

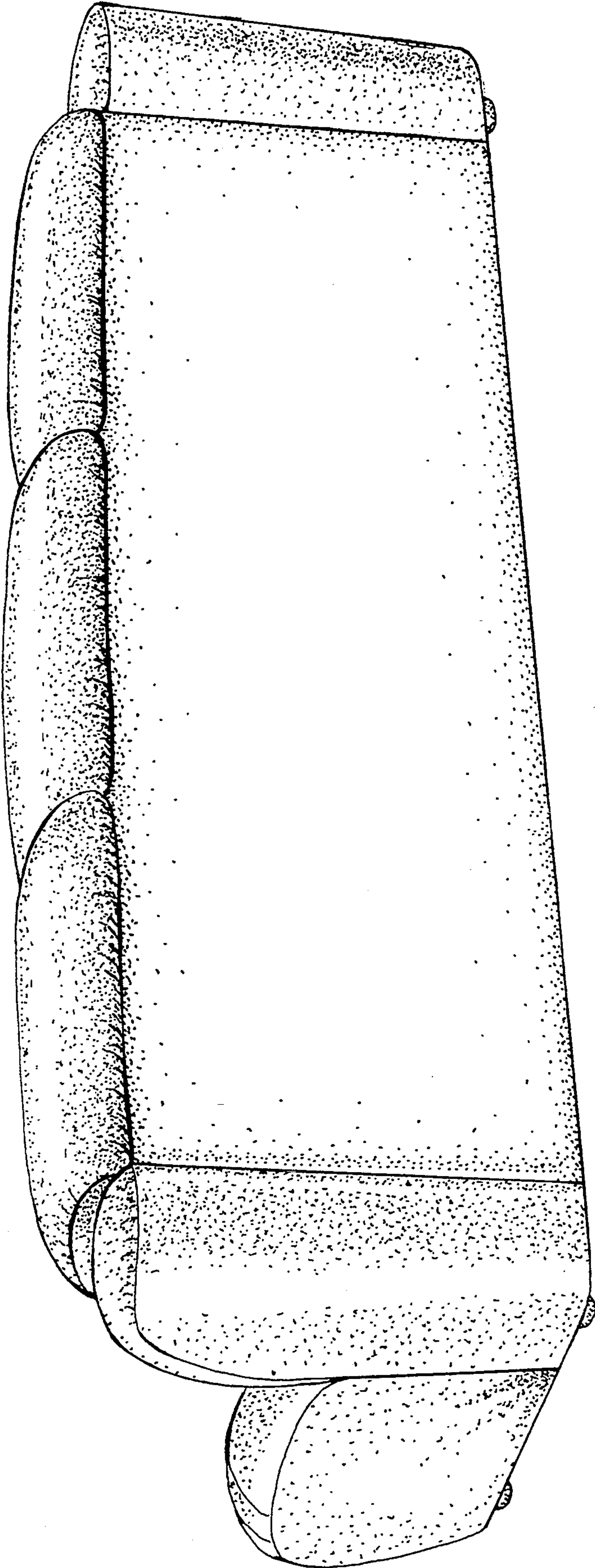
