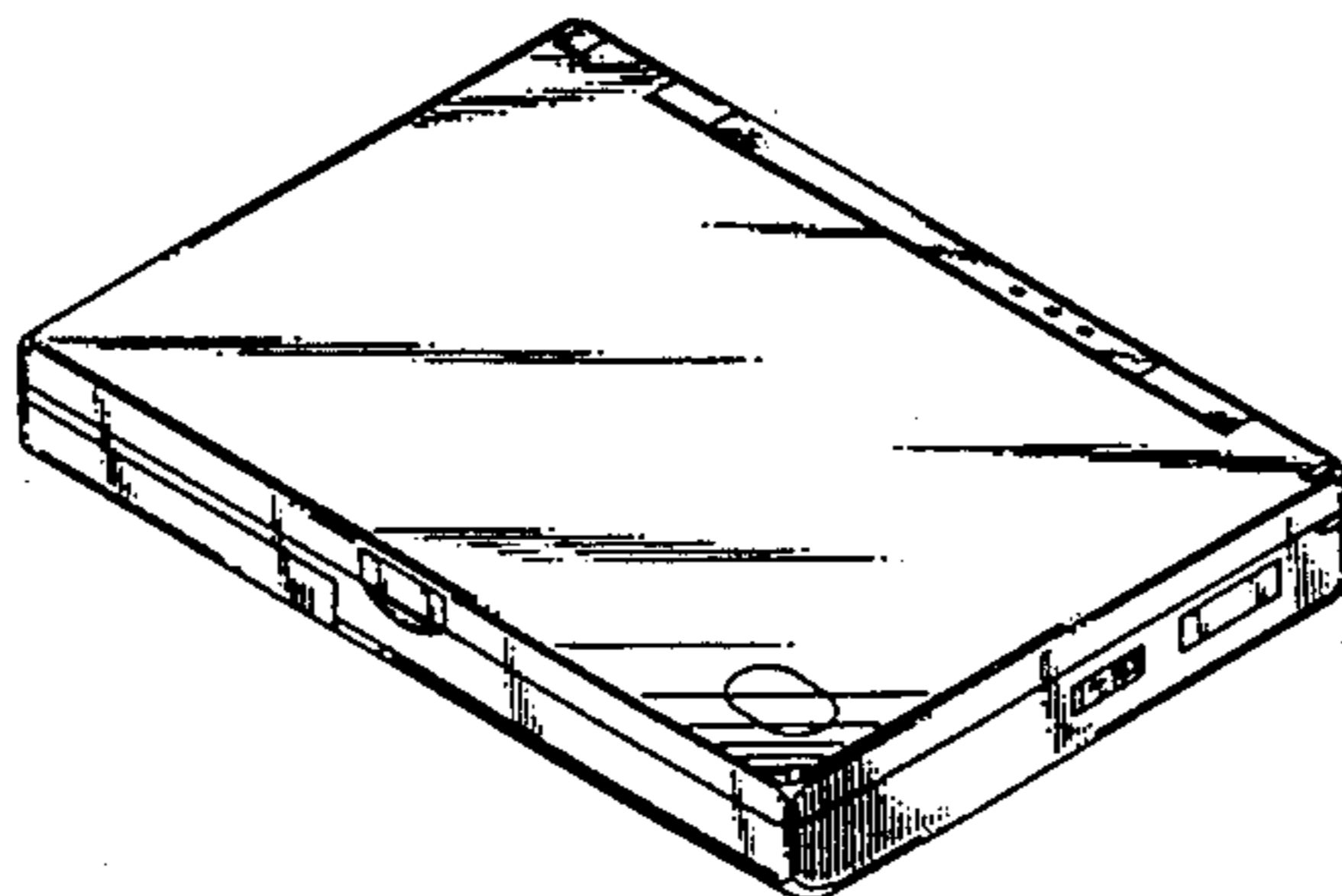
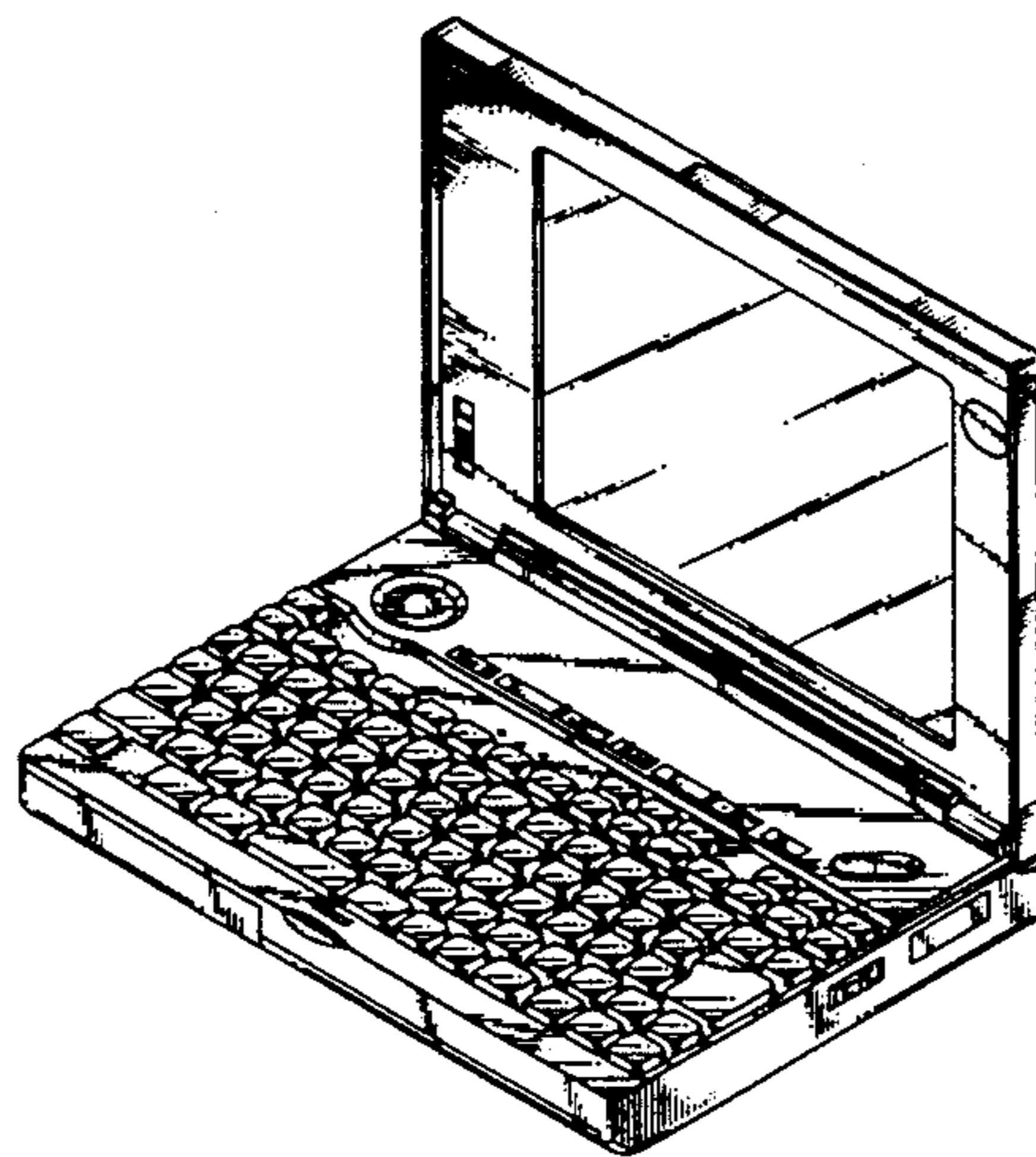
FIG. 12 is a bottom plan view thereof with the cover closed;

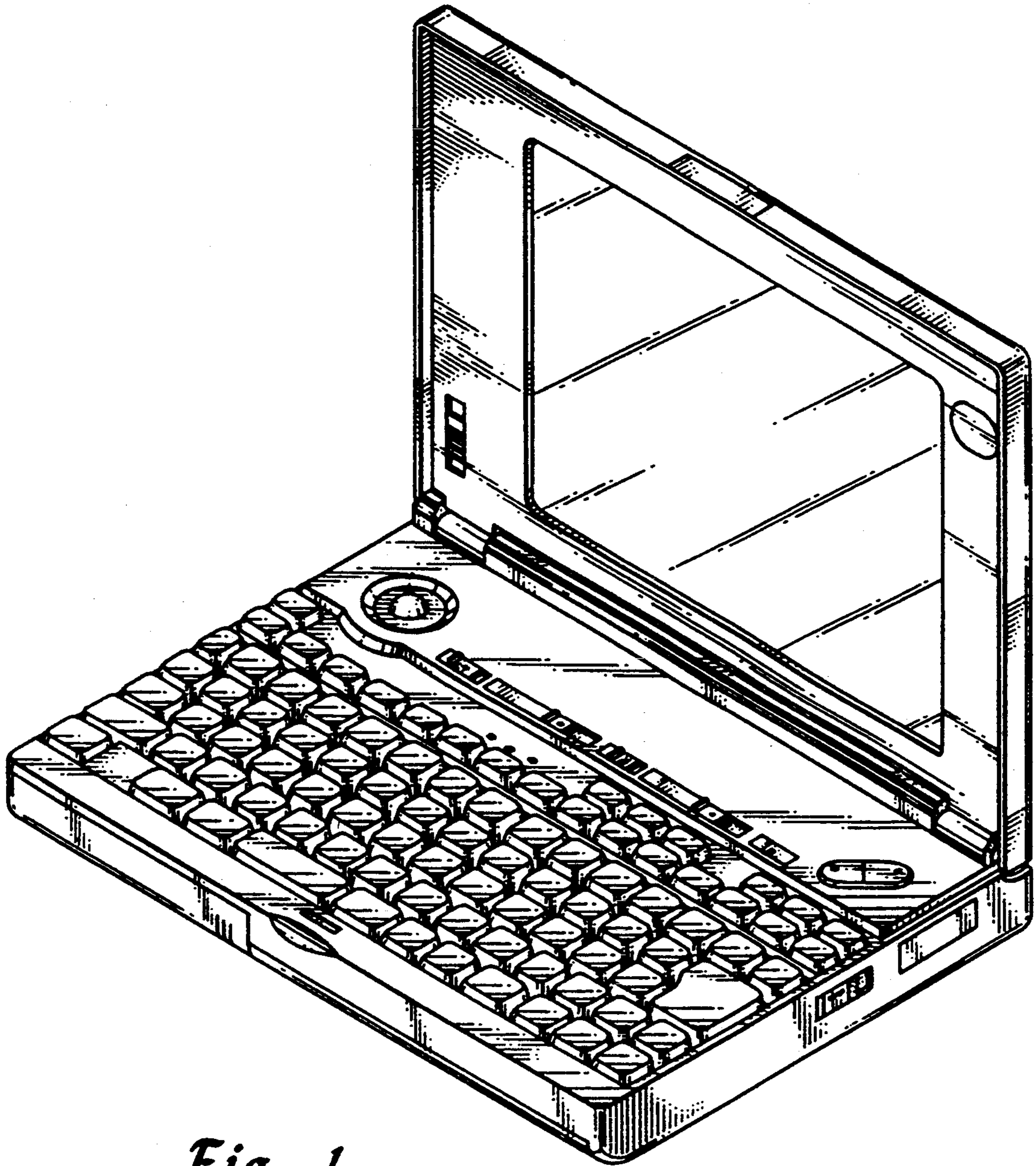
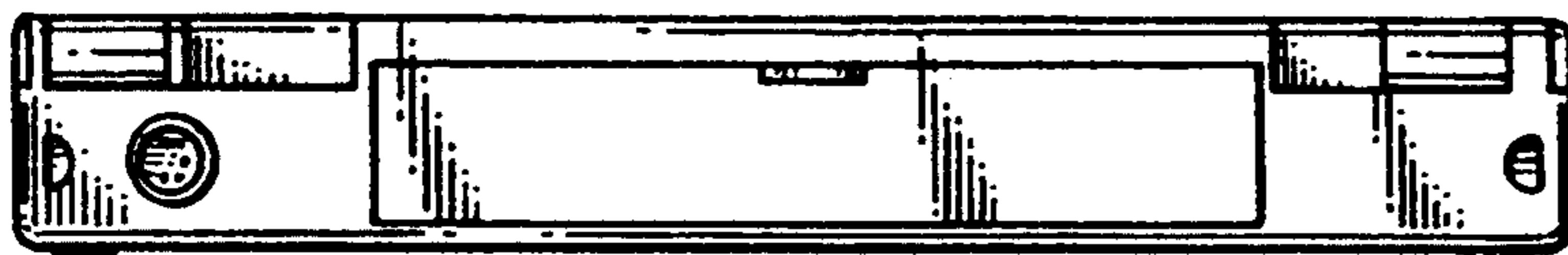

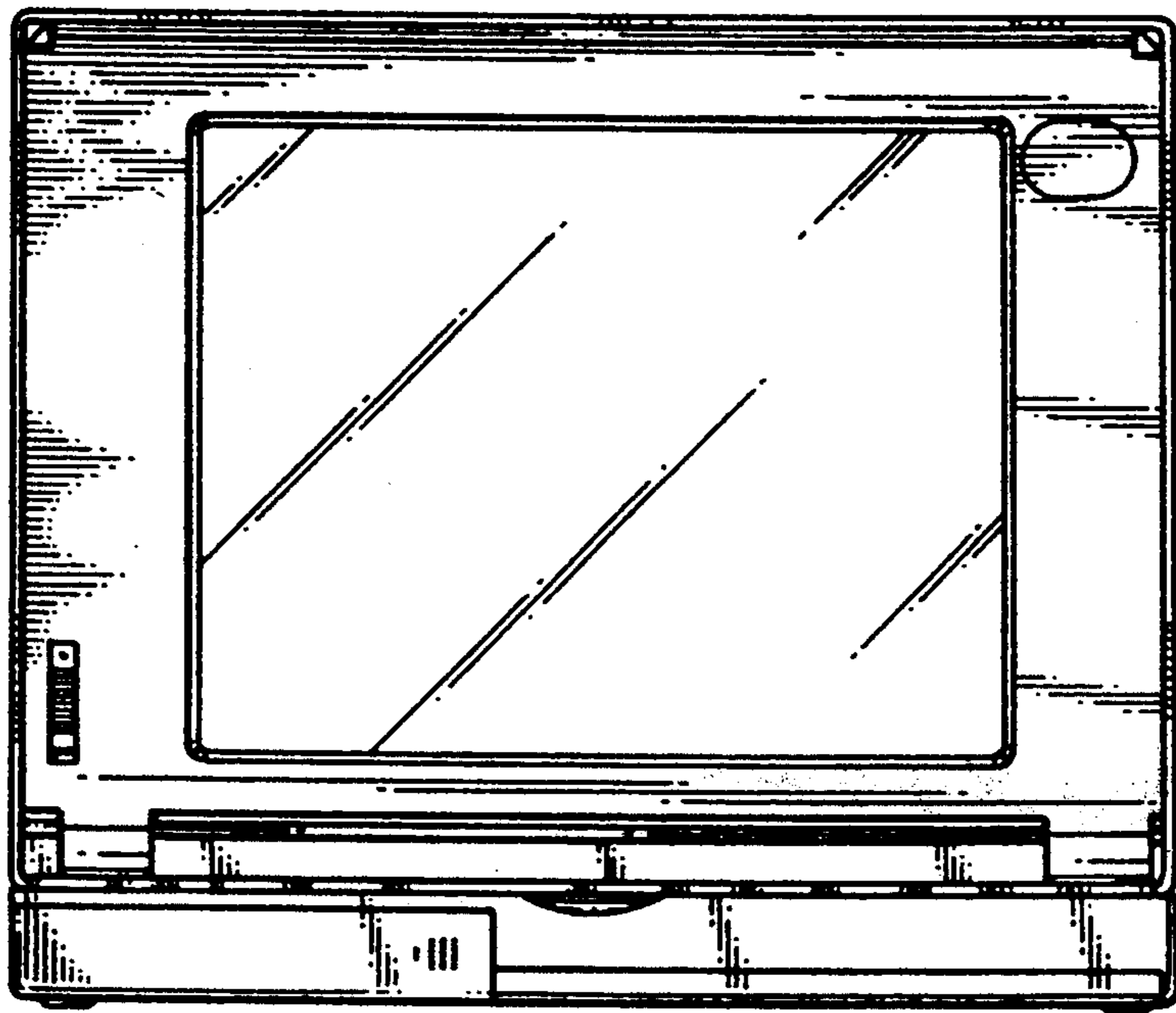

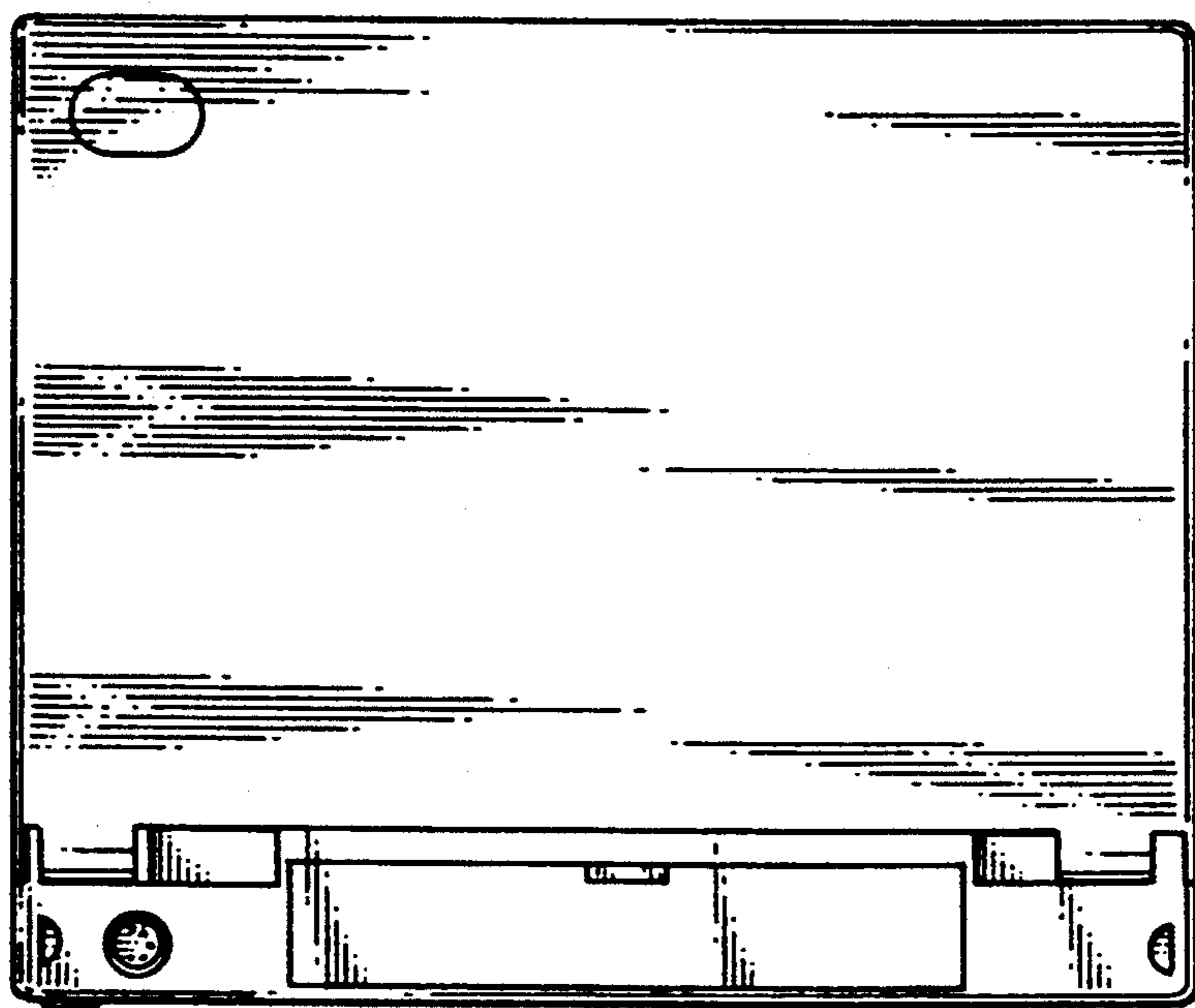

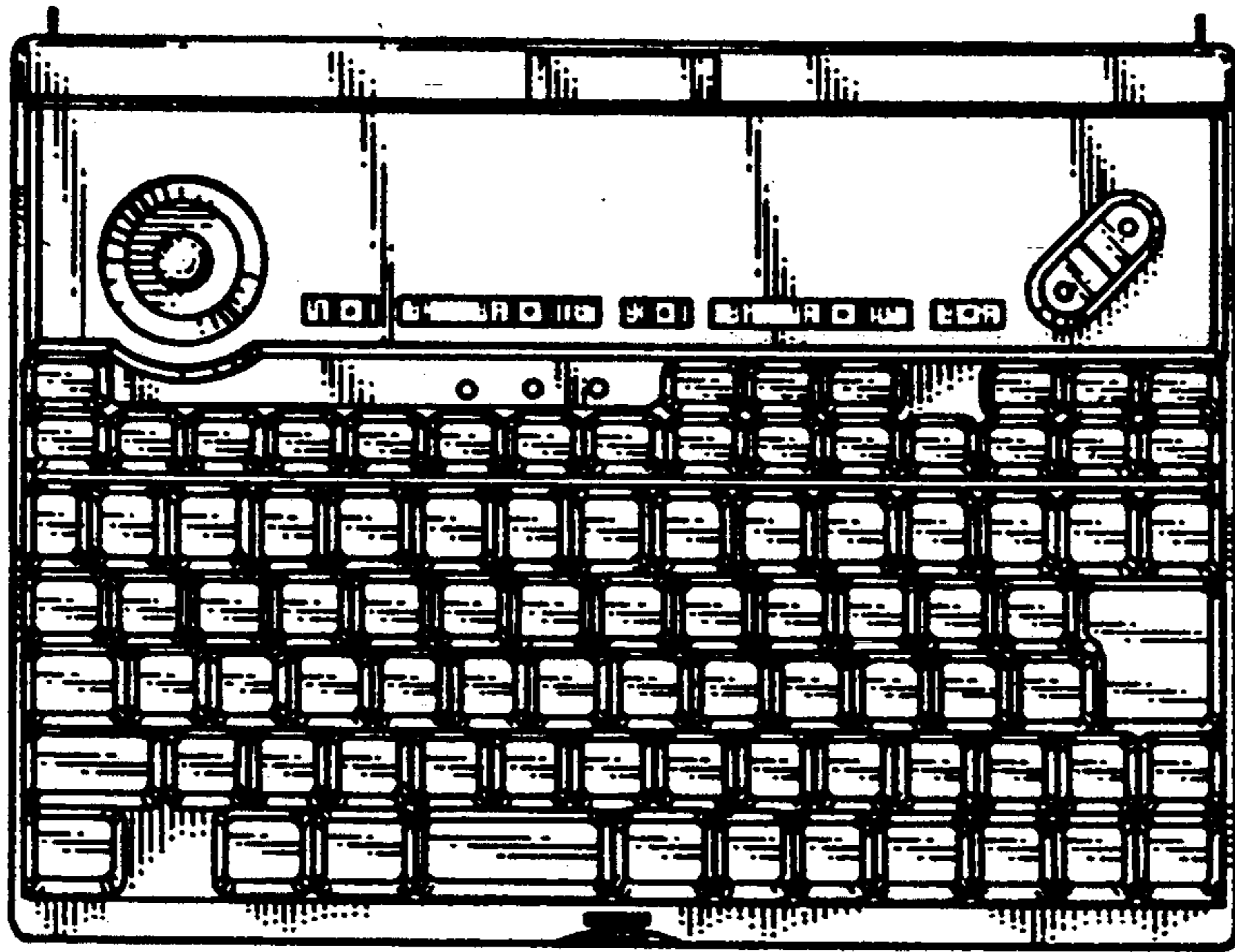

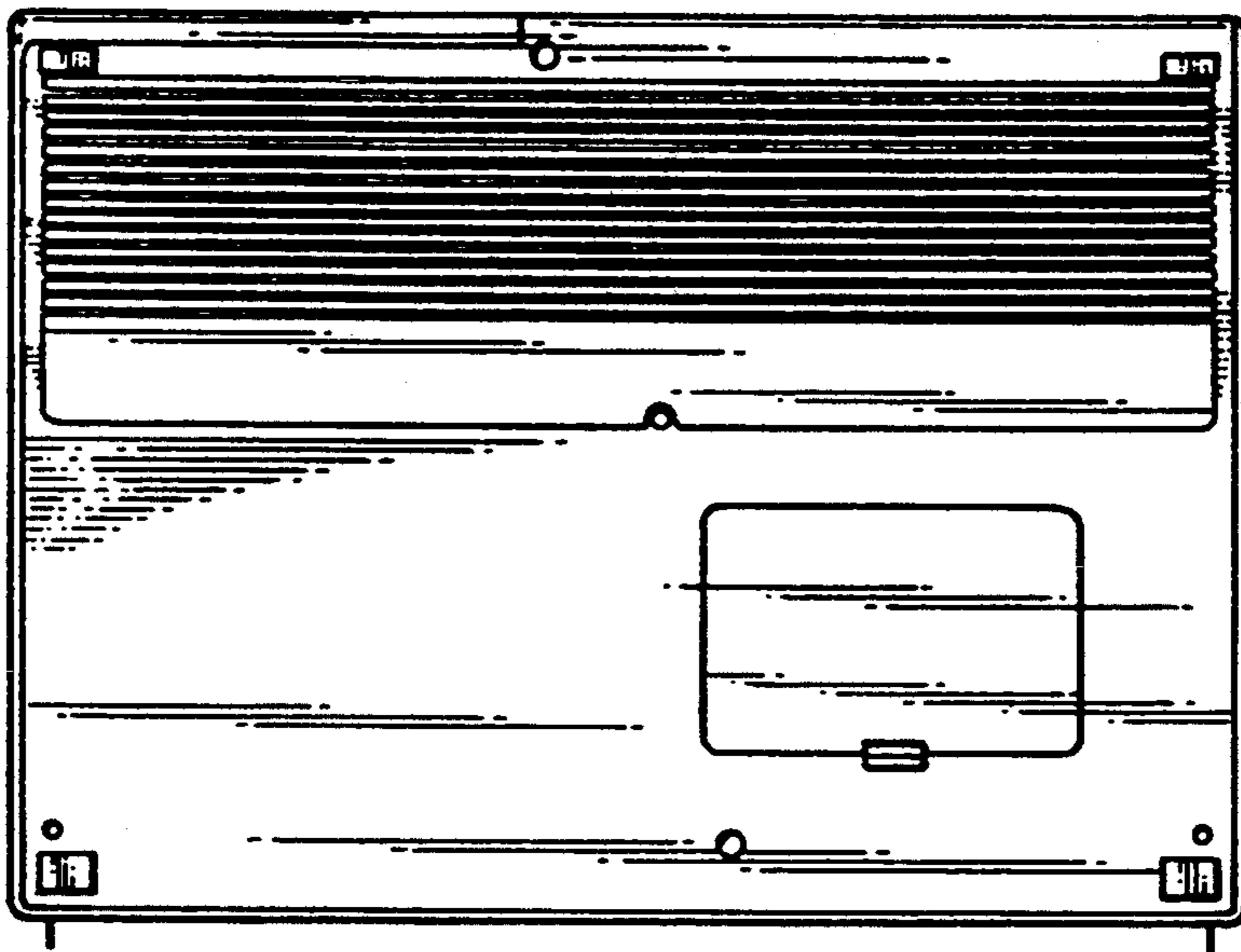

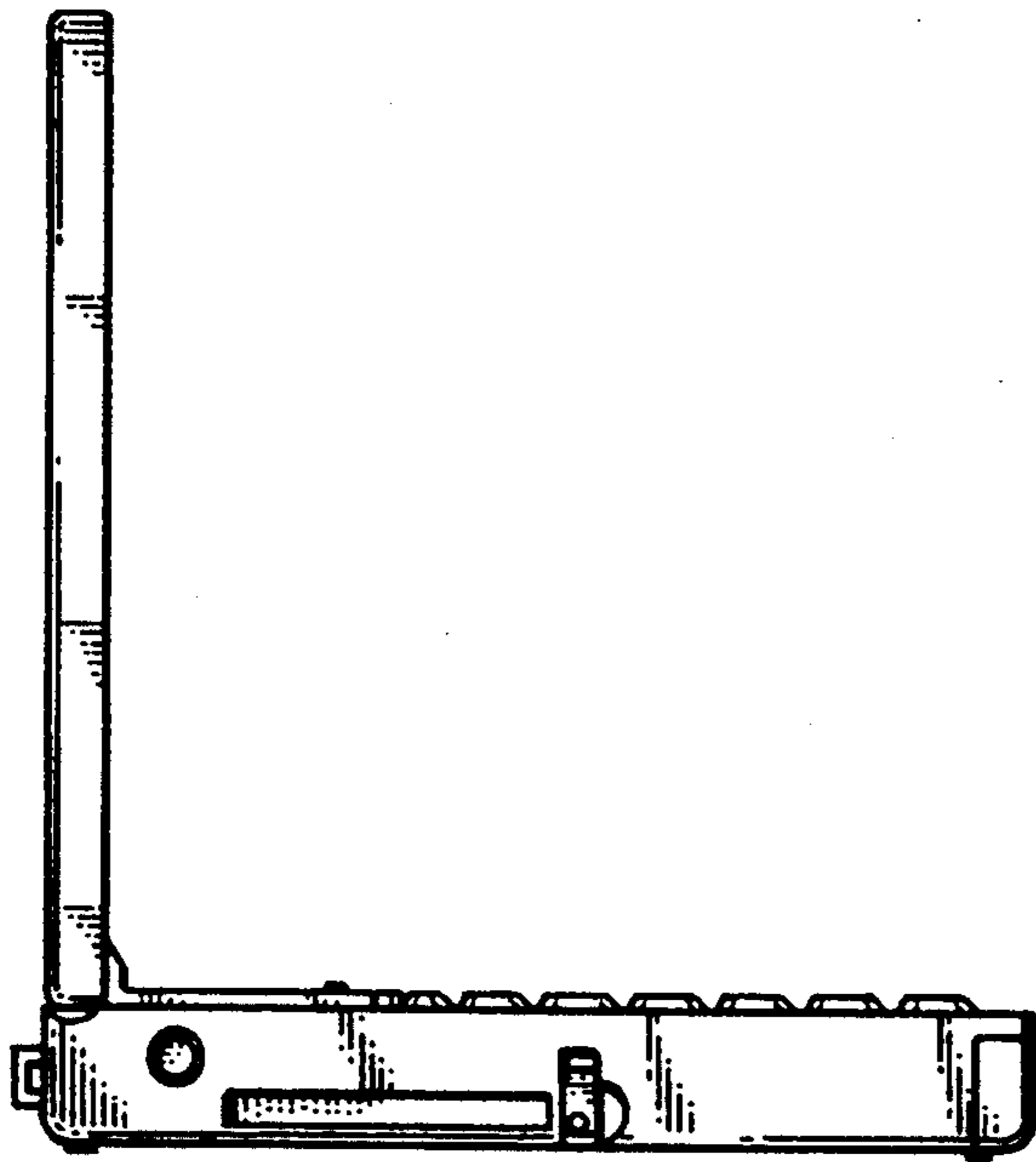

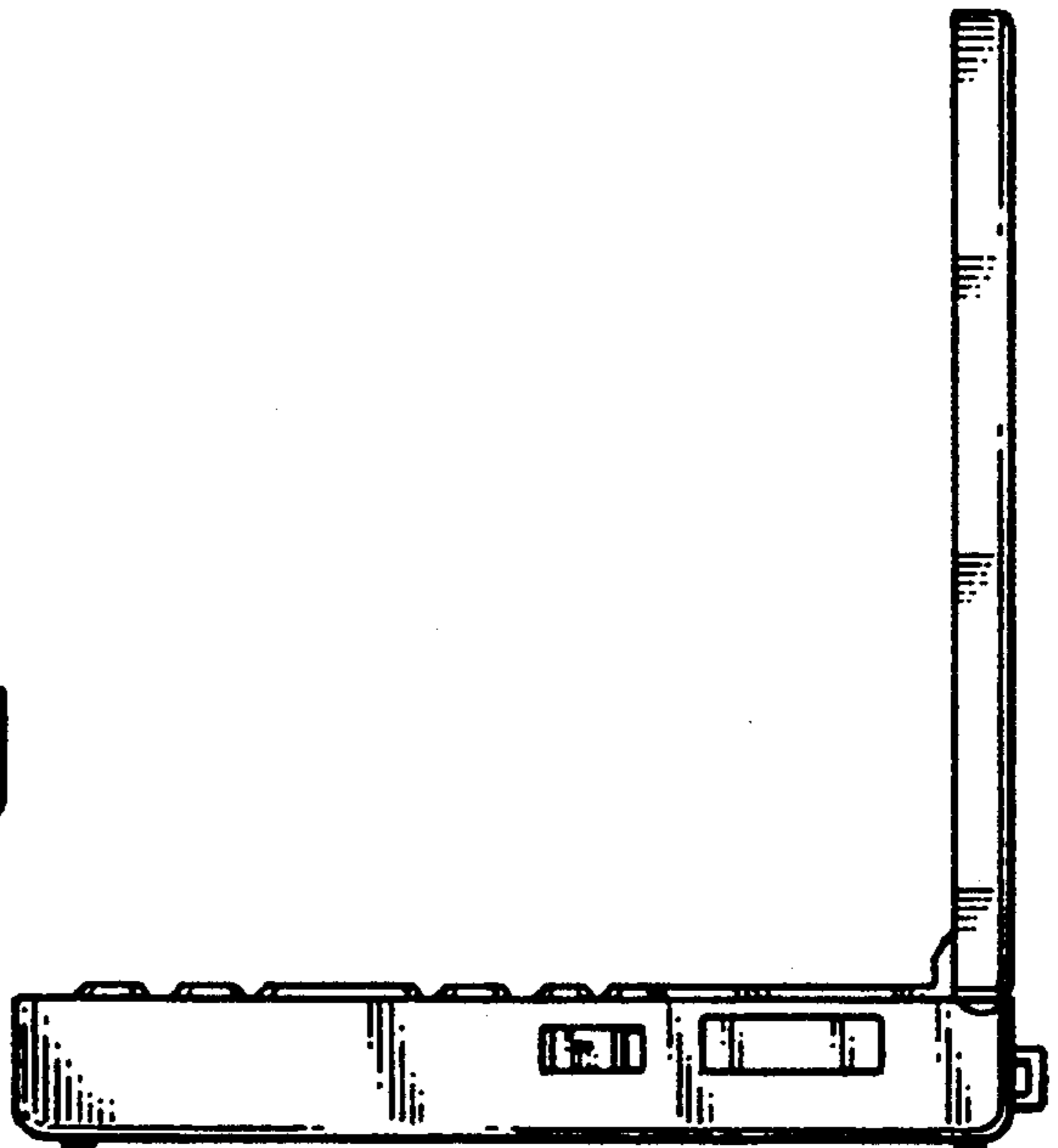

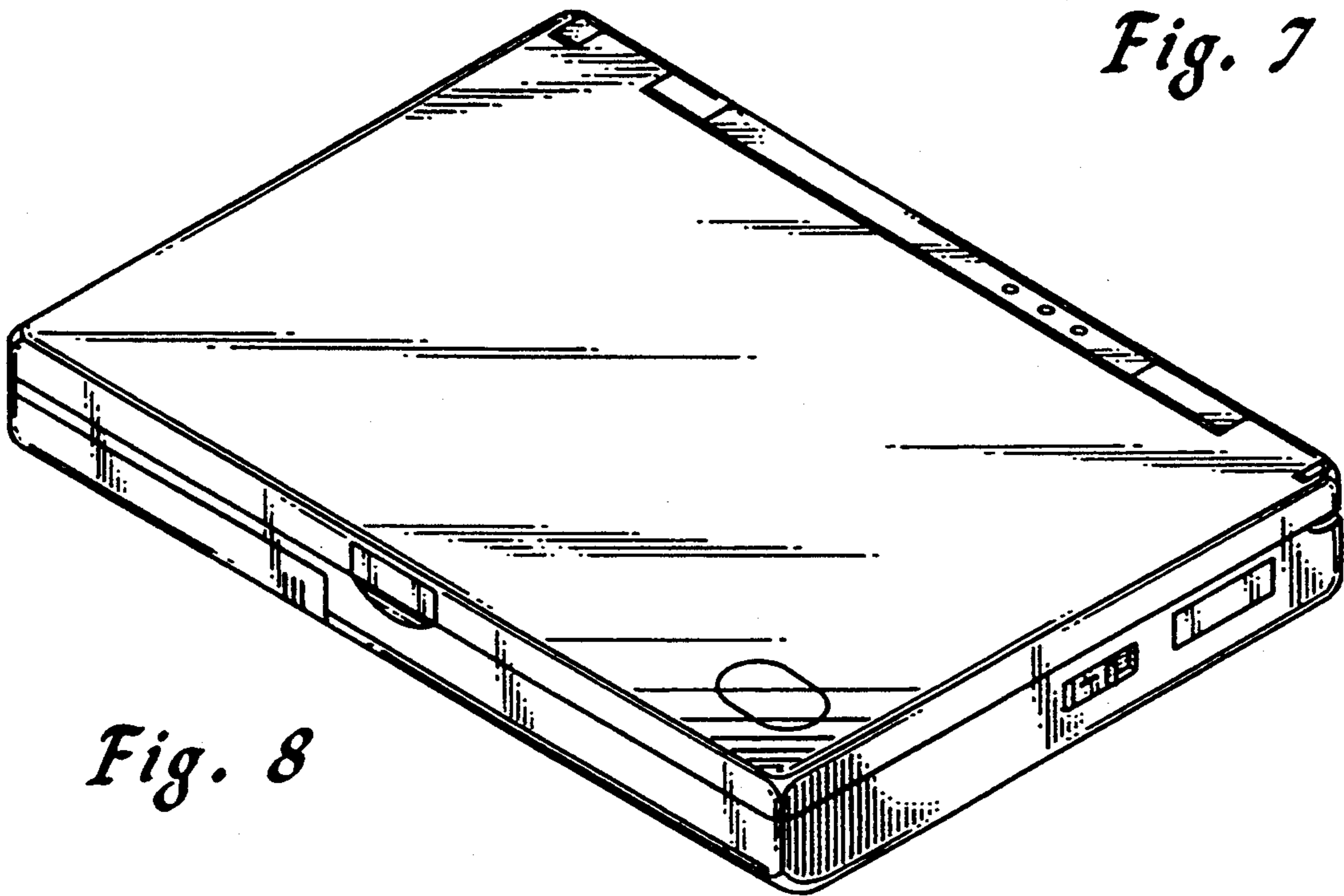

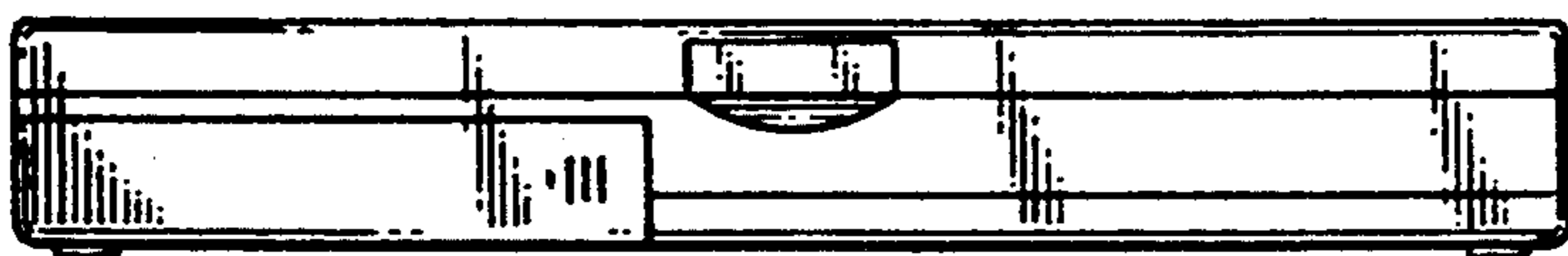

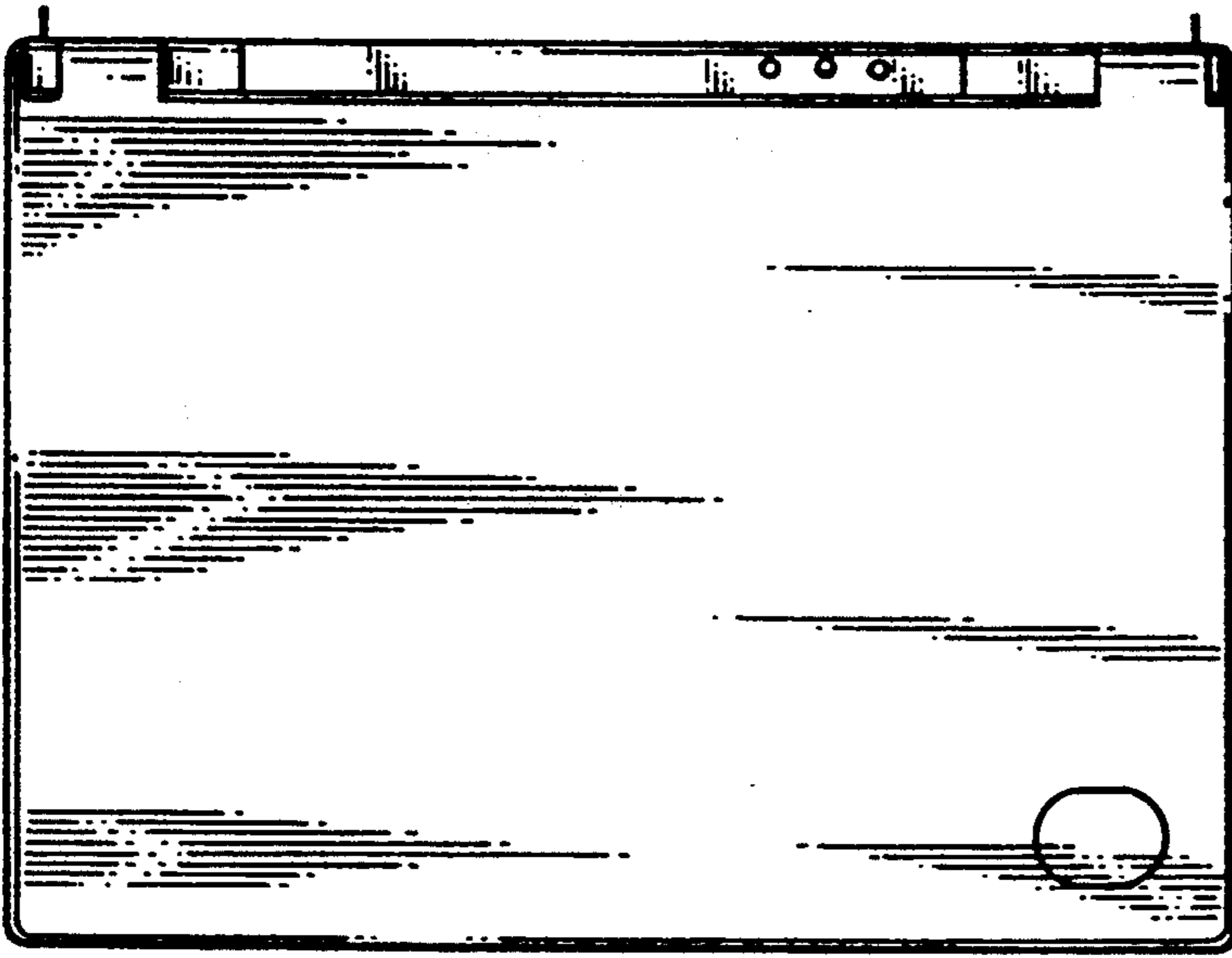

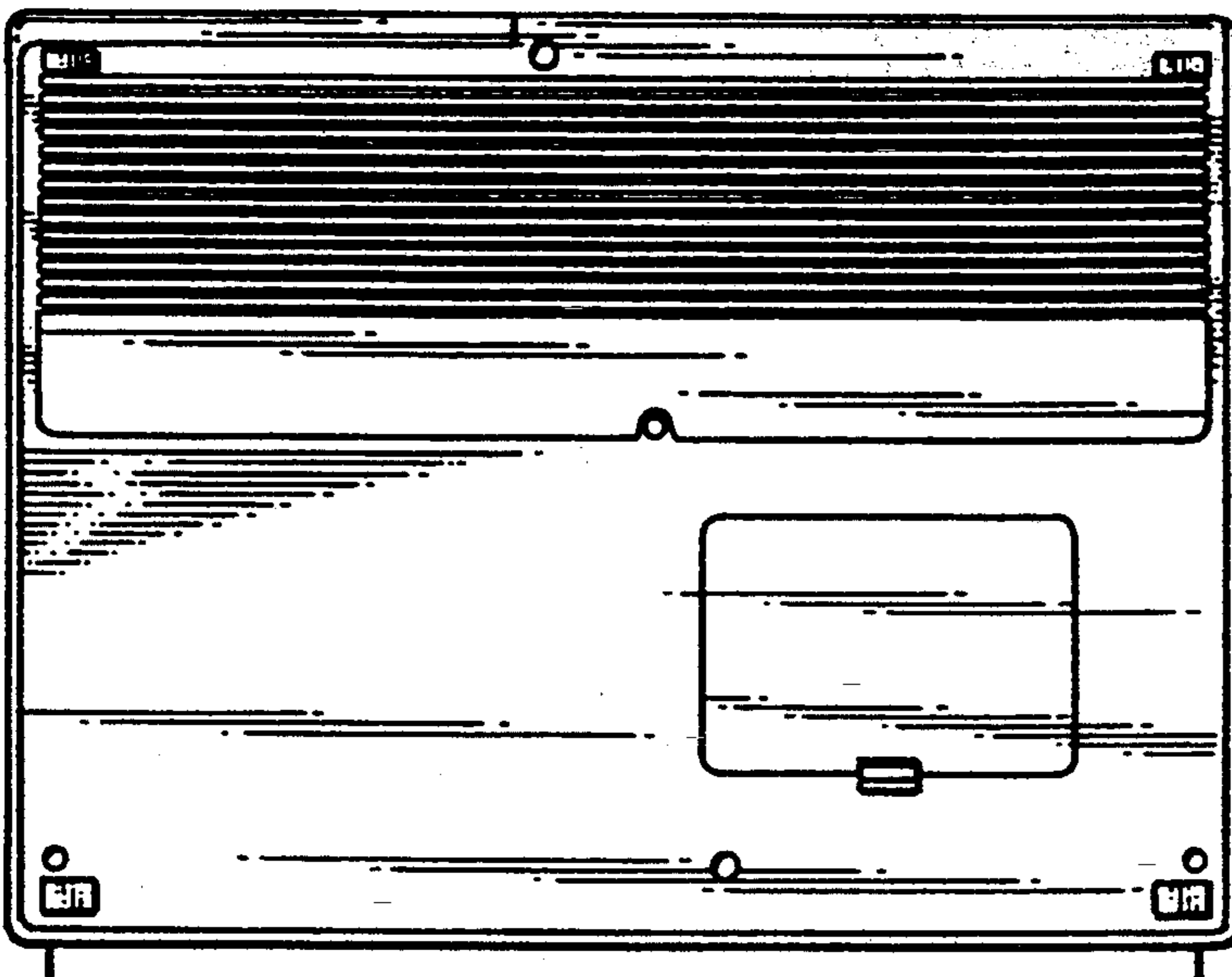

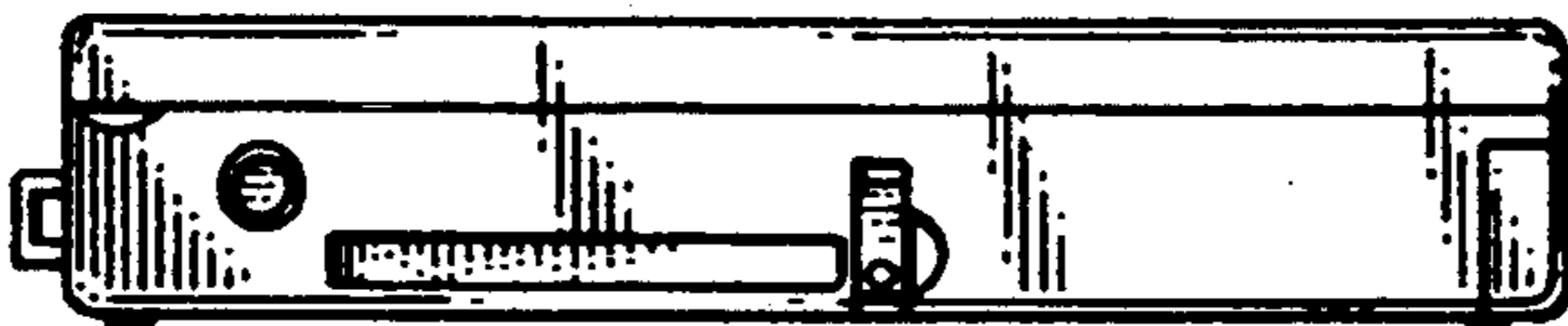

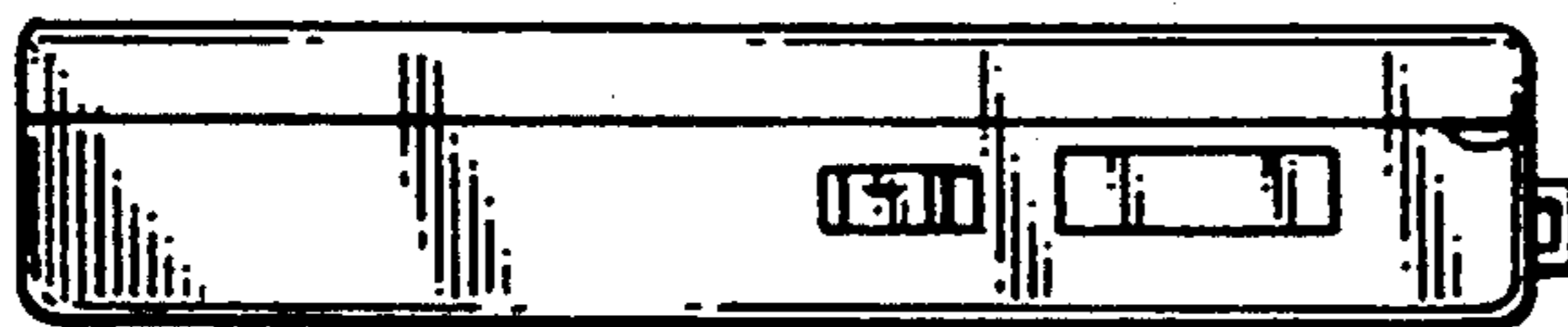
