### [57] CLAIM

The ornamental design for an adjustable keyboard for a personal computer, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of an adjustable keyboard for a personal computer showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top, front, left side perspective view of the embodiment with the two segments adjacent each other; and, FIG. 8 is a top, front, left side perspective view of the embodiment with the two segments split from each other.

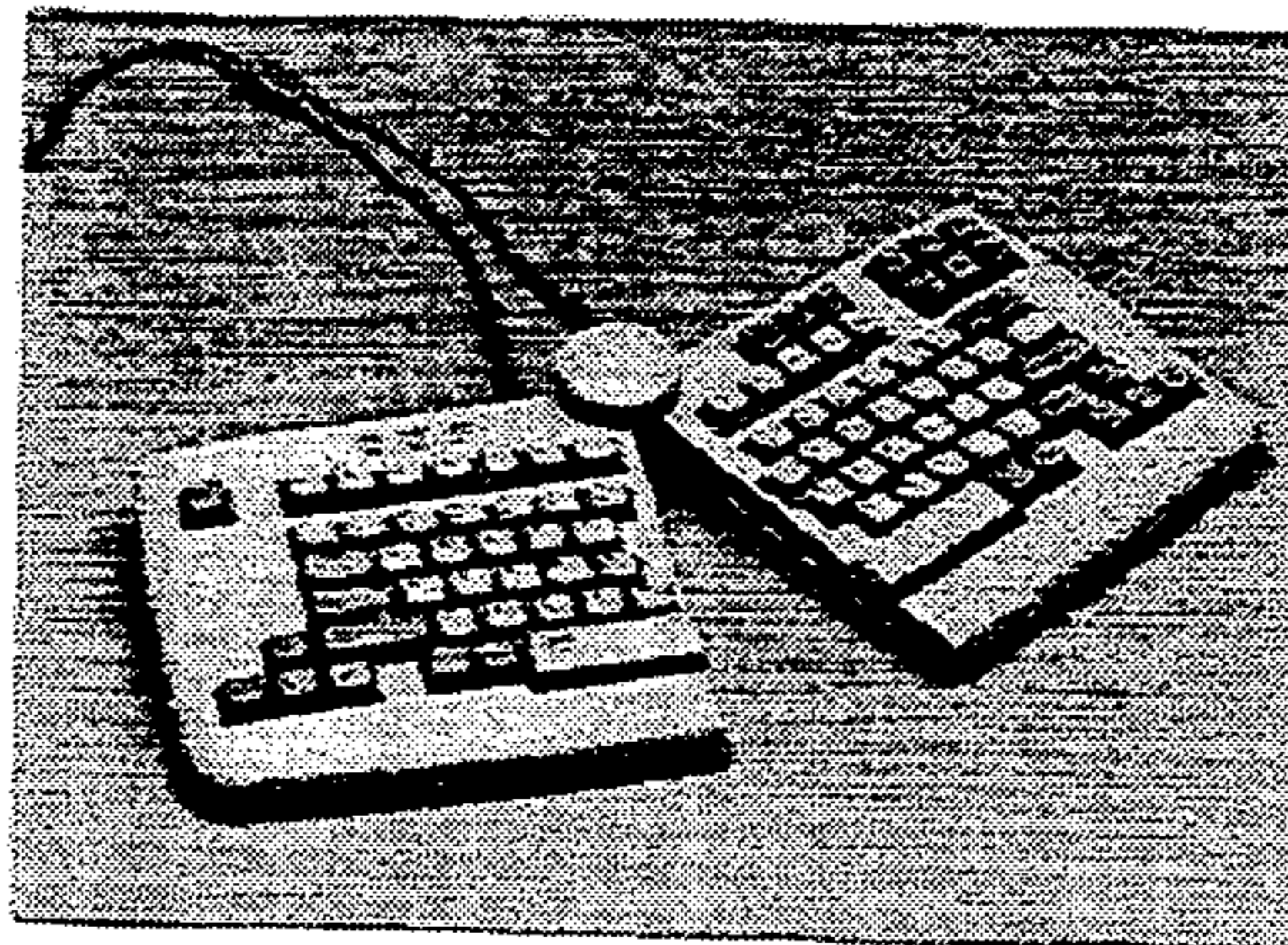
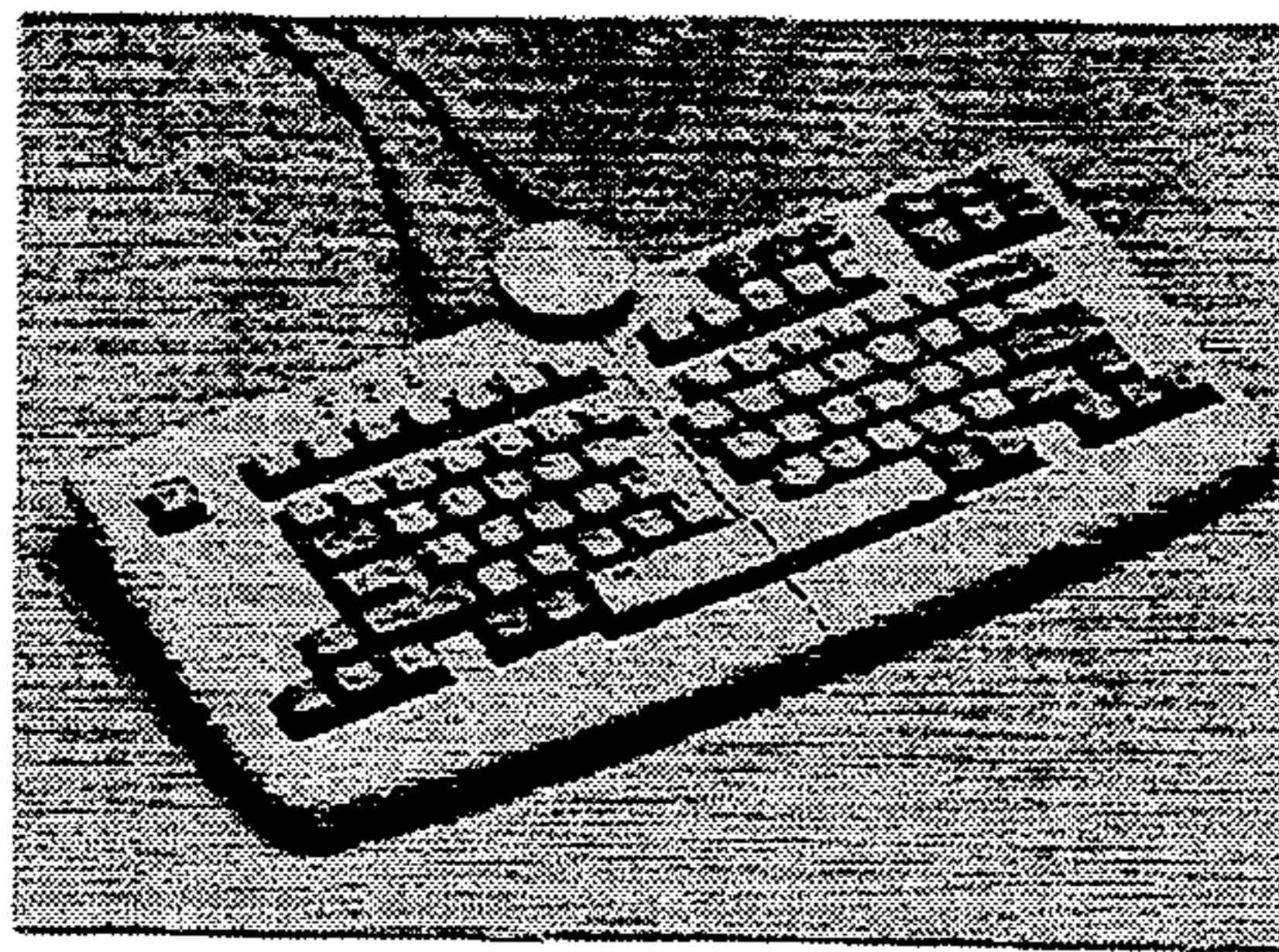

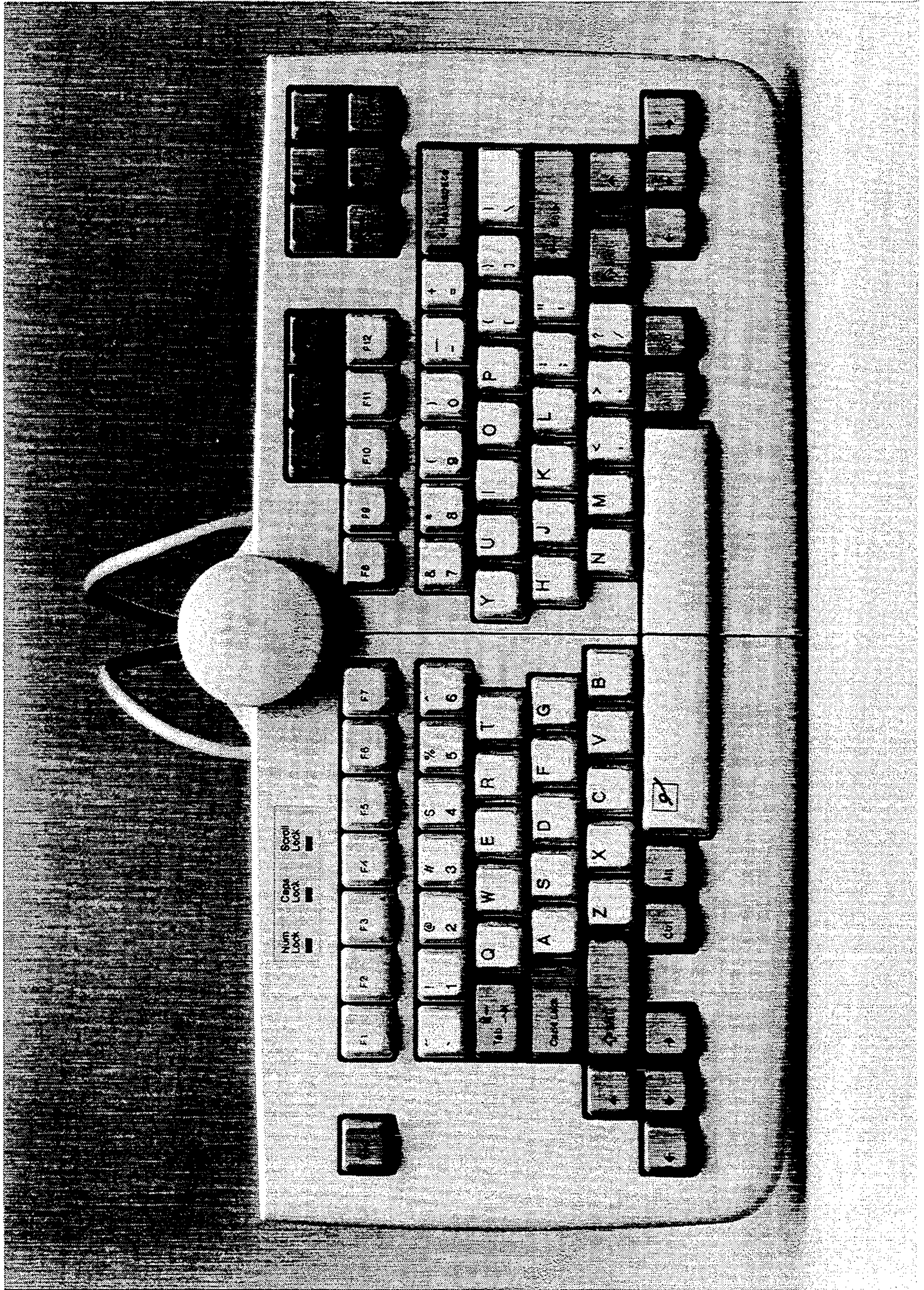

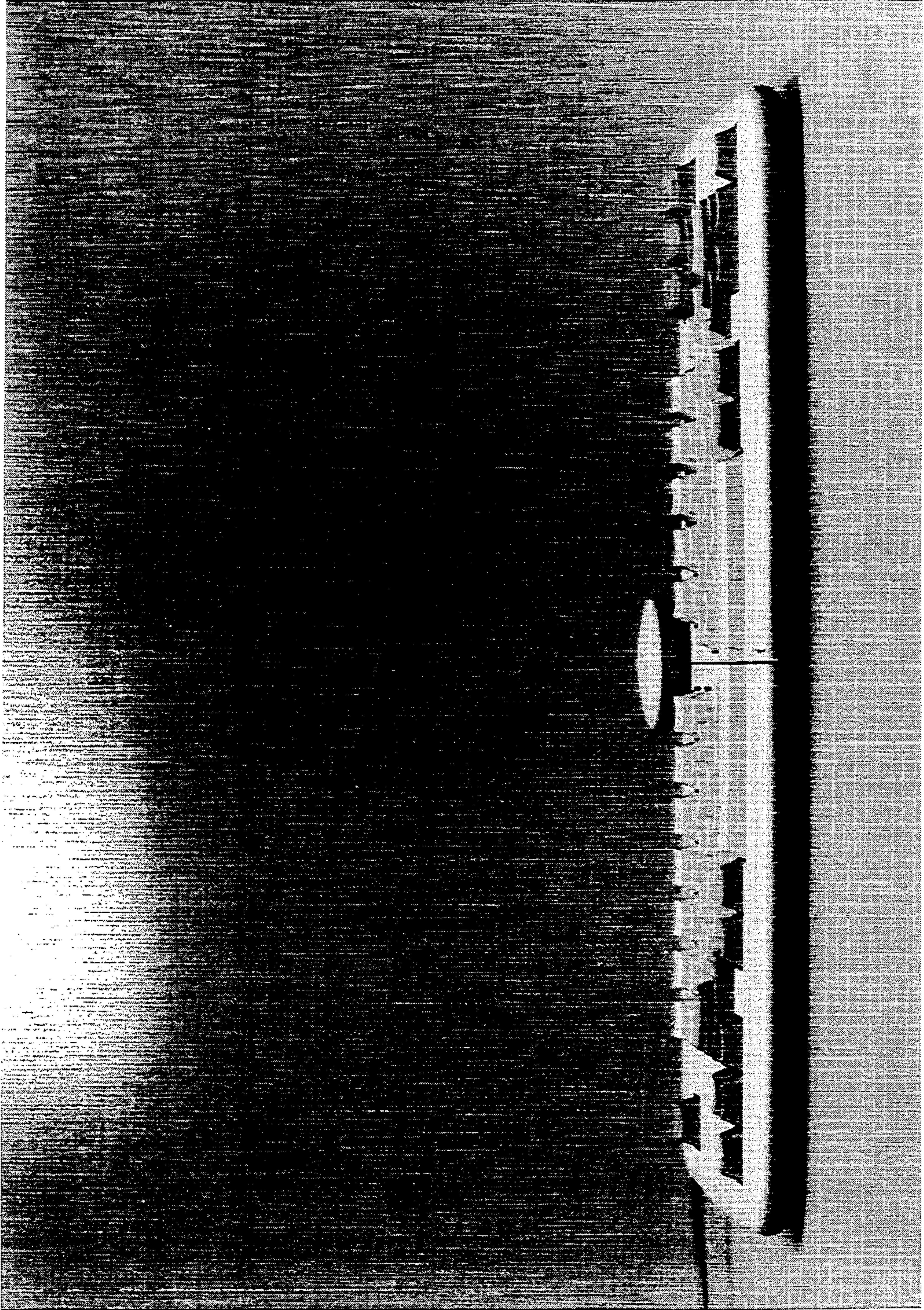

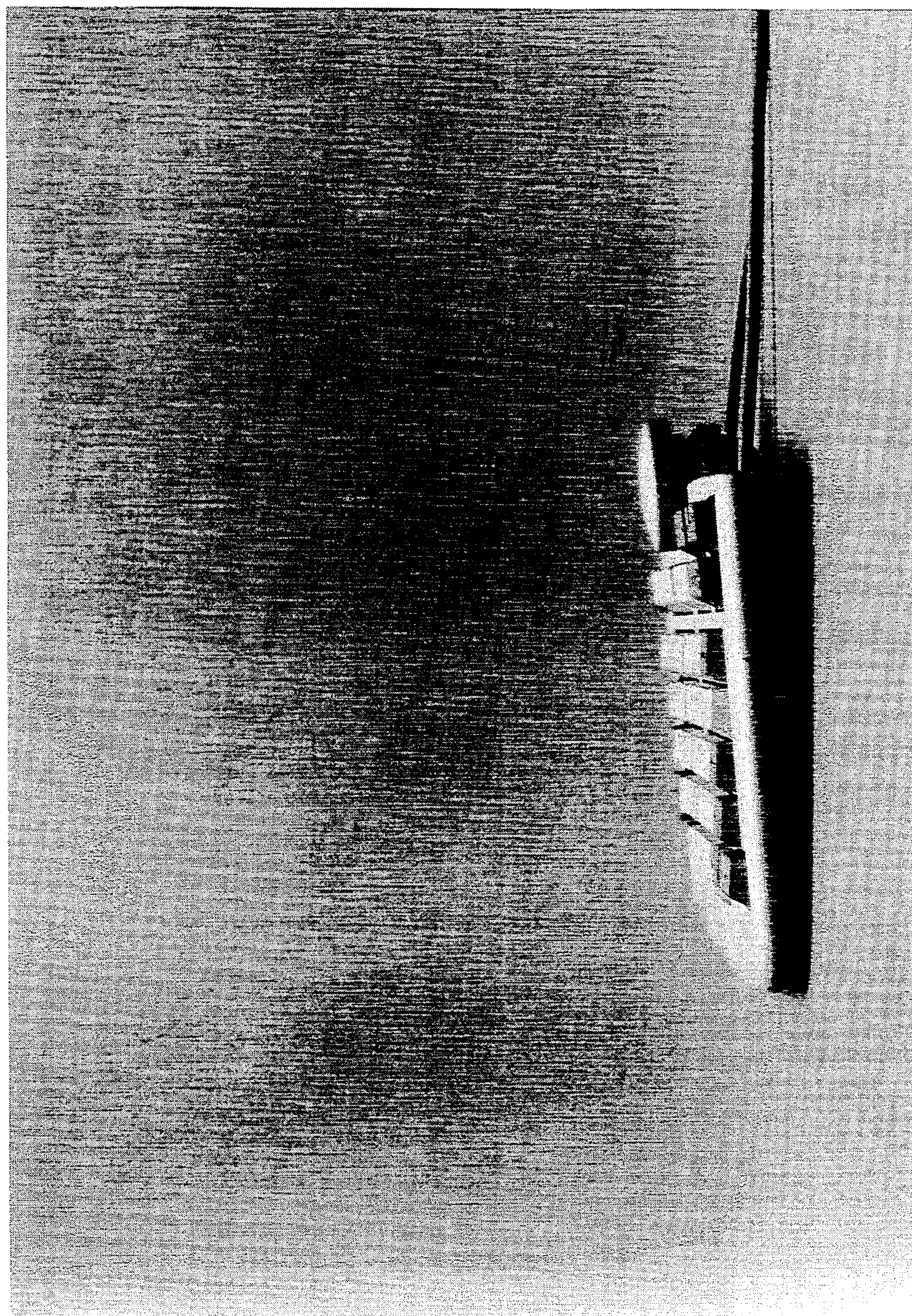

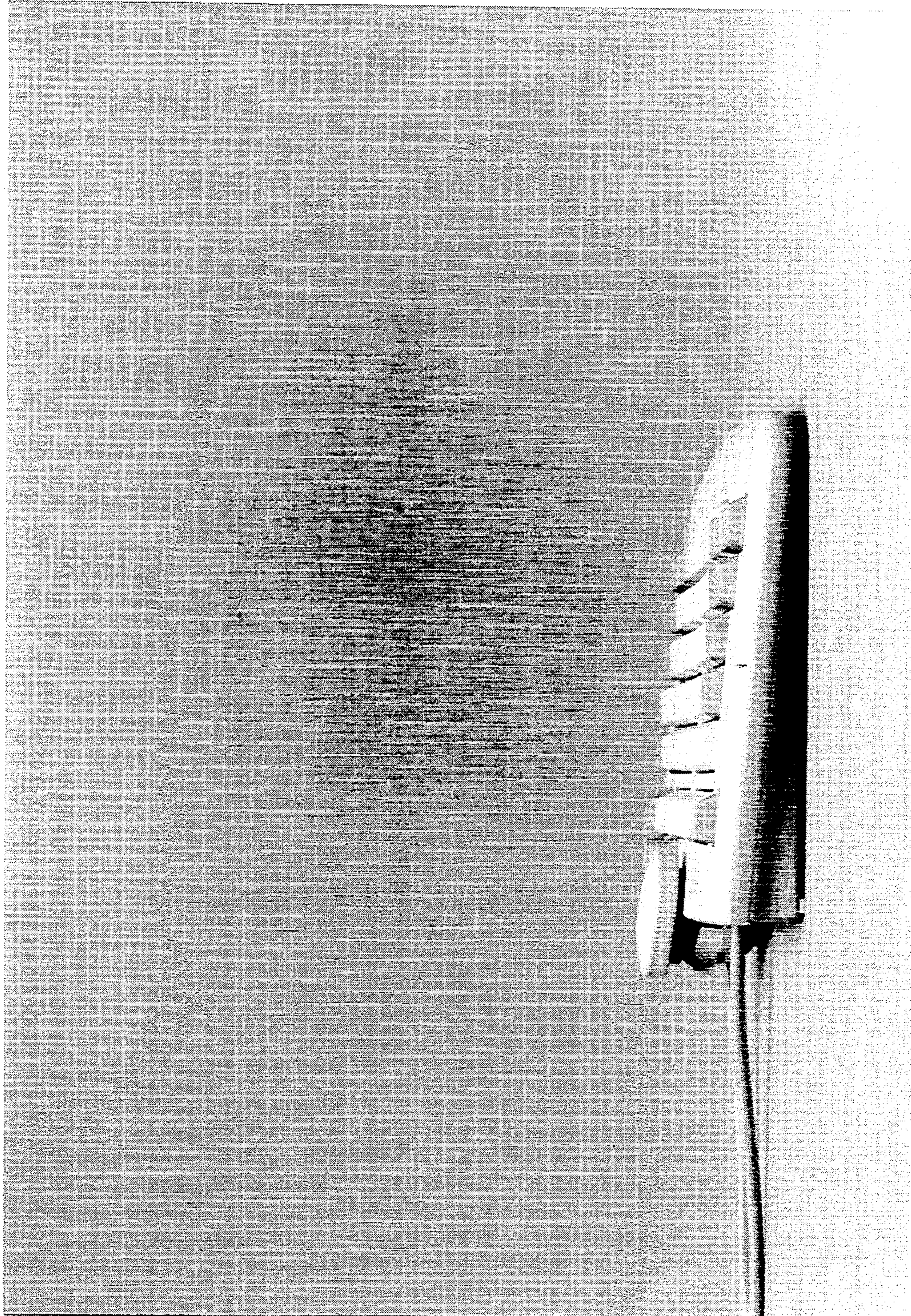

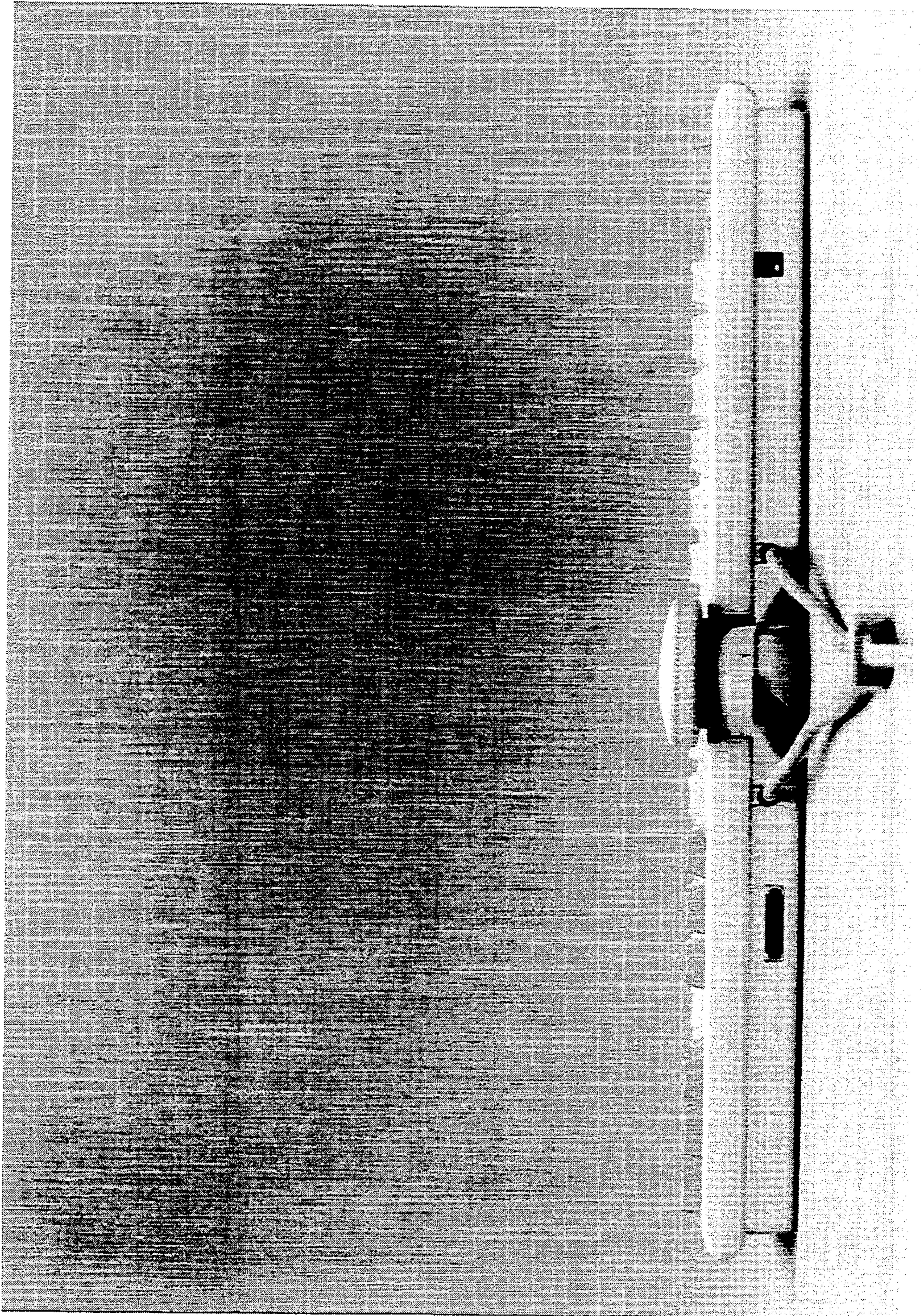

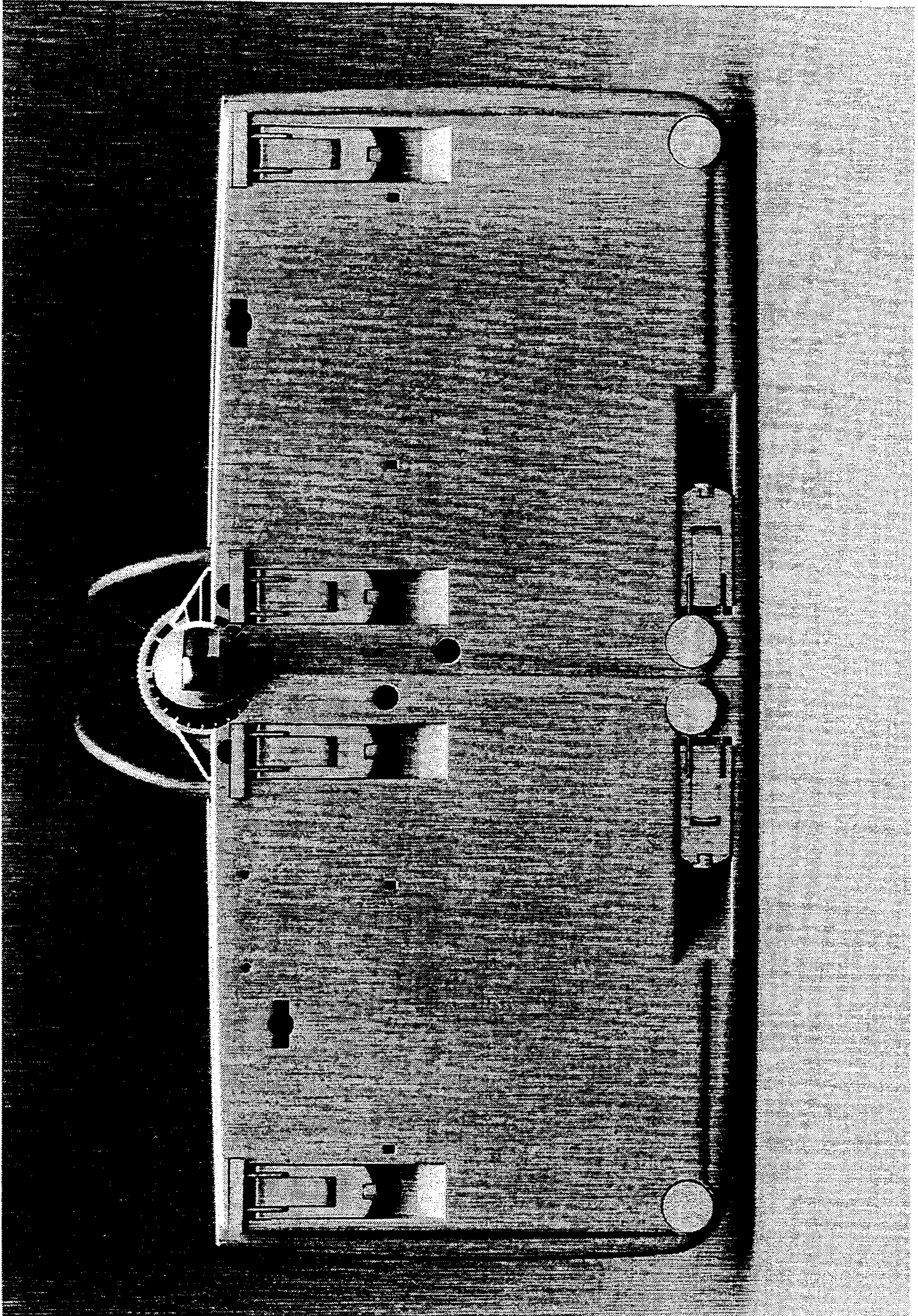

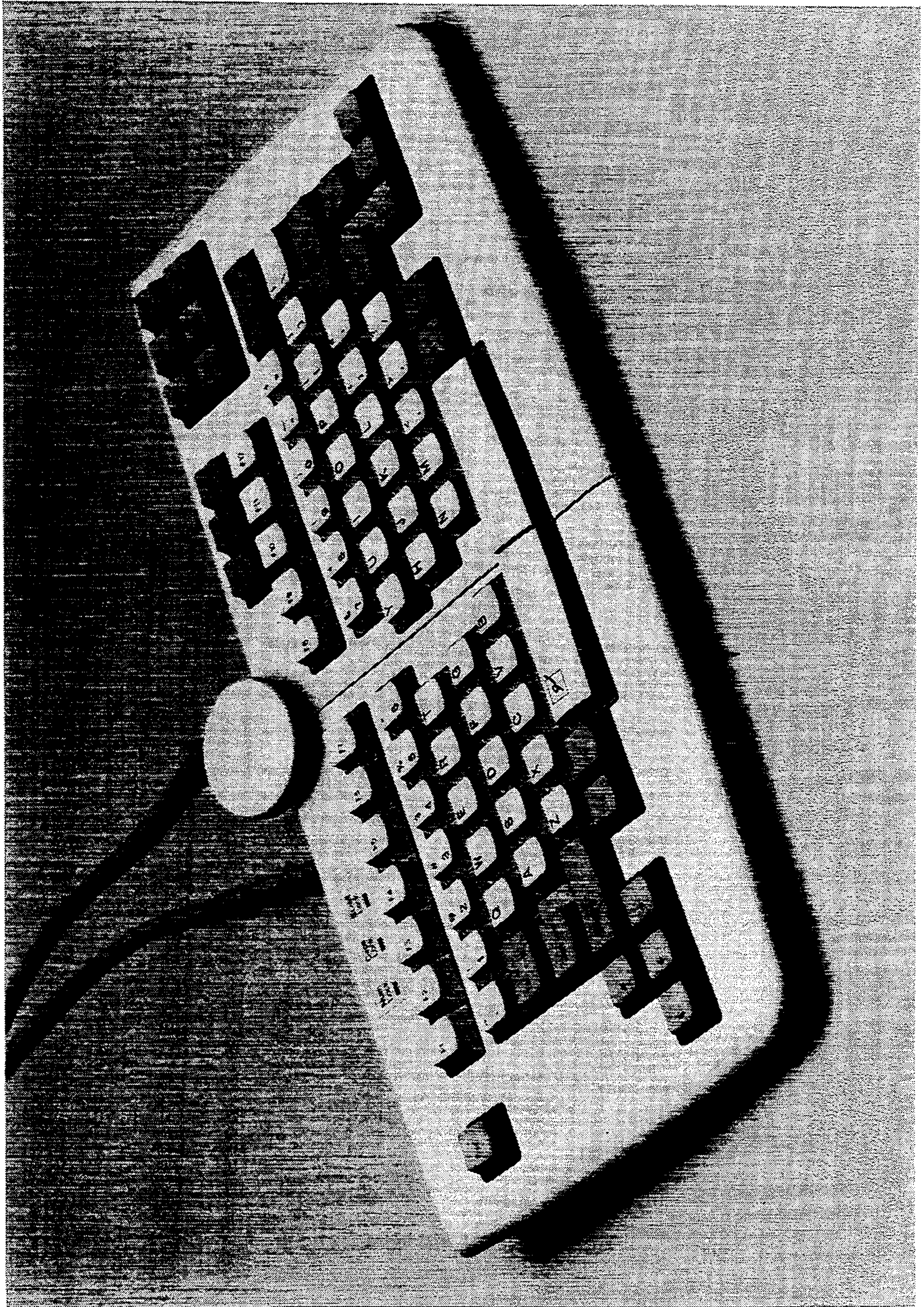
