FIG. 1 is a perspective view of a cart having a push handle arrangement;

FIG. 4 is a bottom view of the cart of FIG. 1.

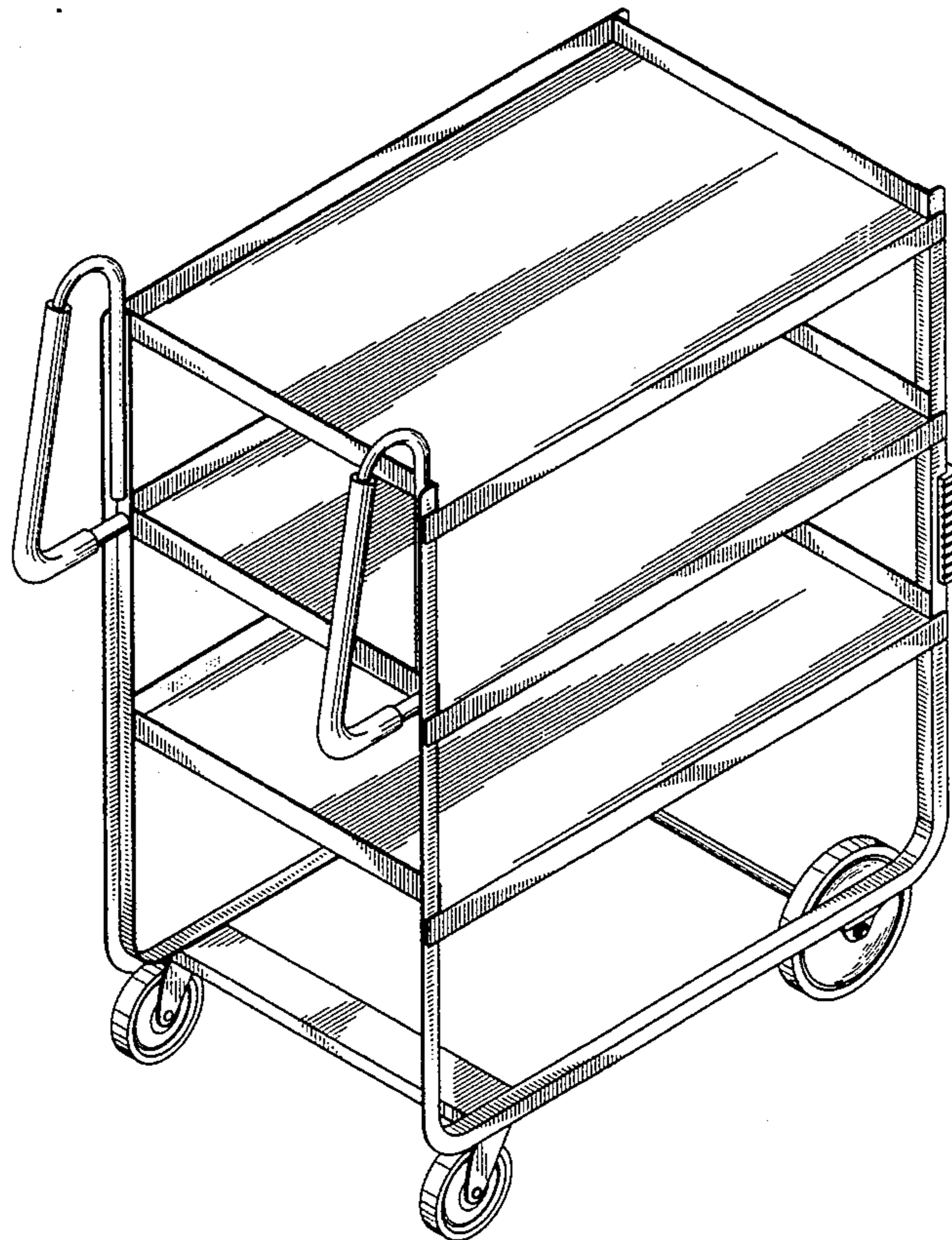

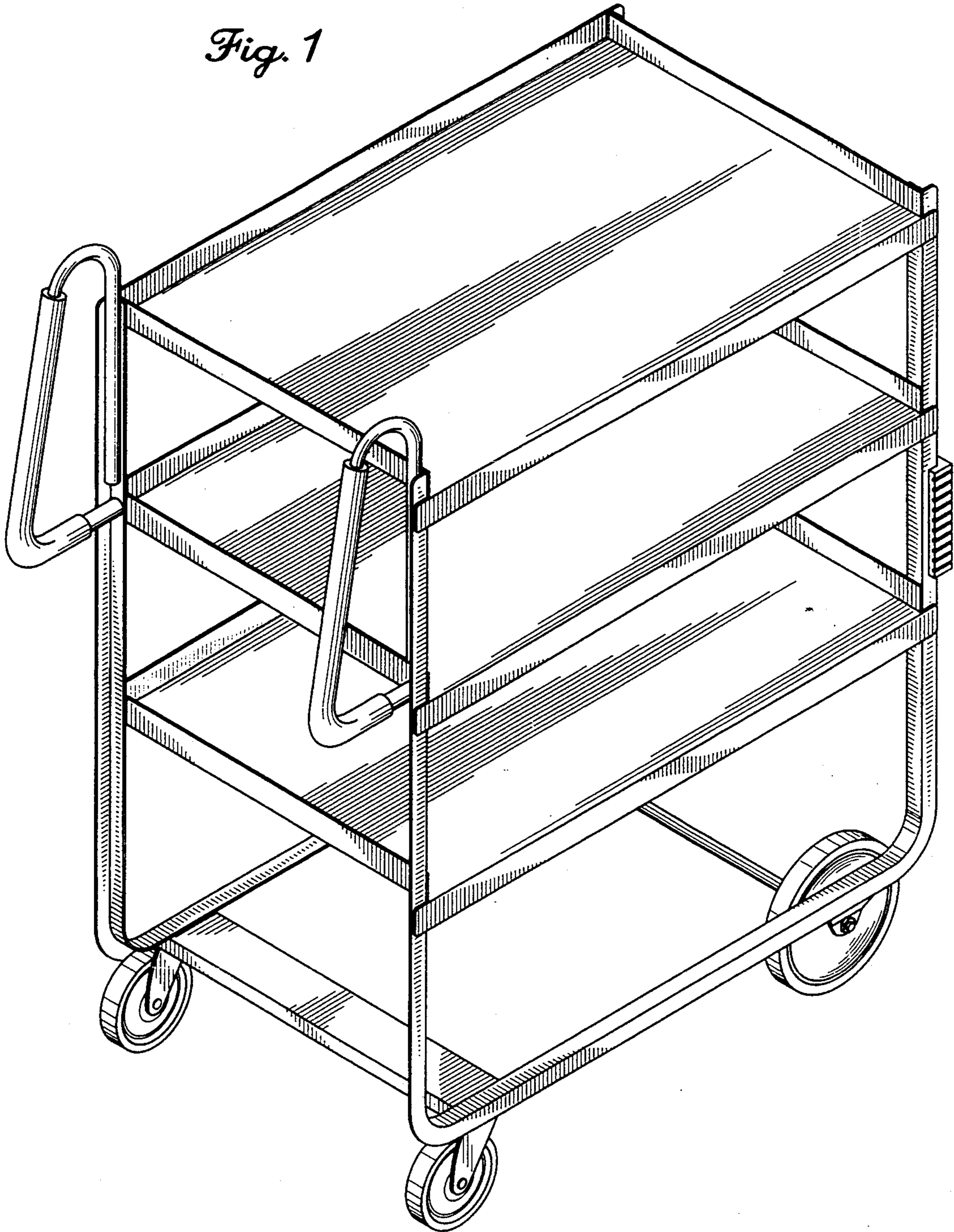

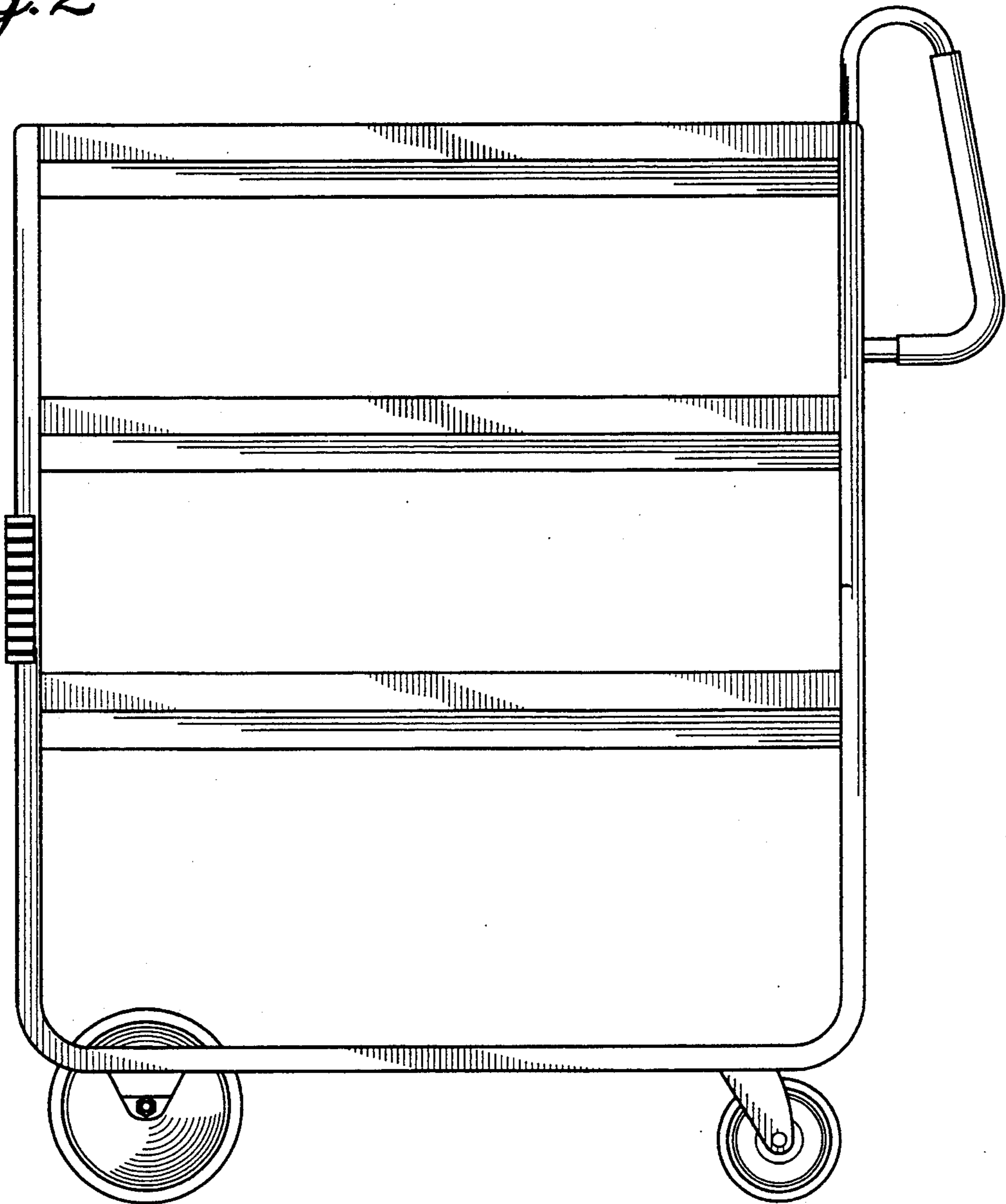

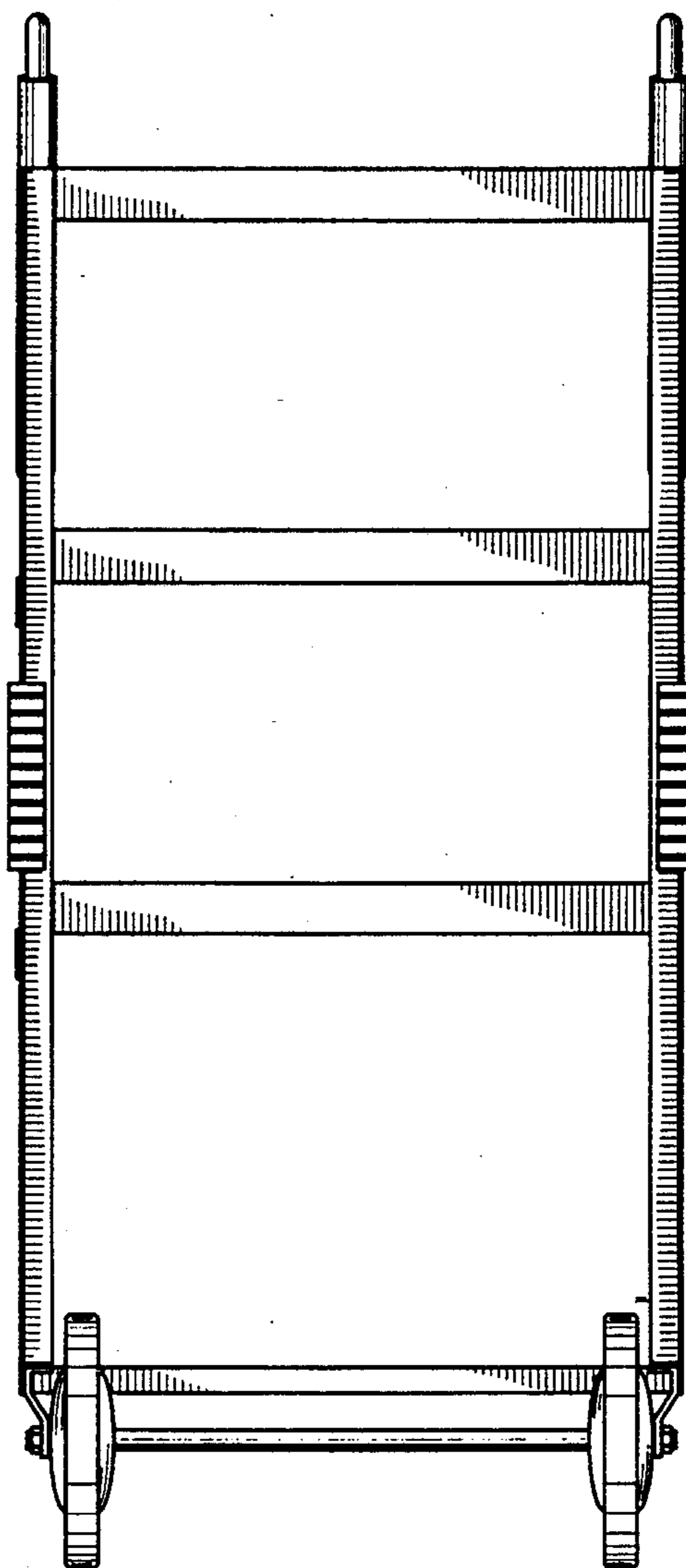
