FIG. 8 is a bottom plan view of FIG. 6; and,

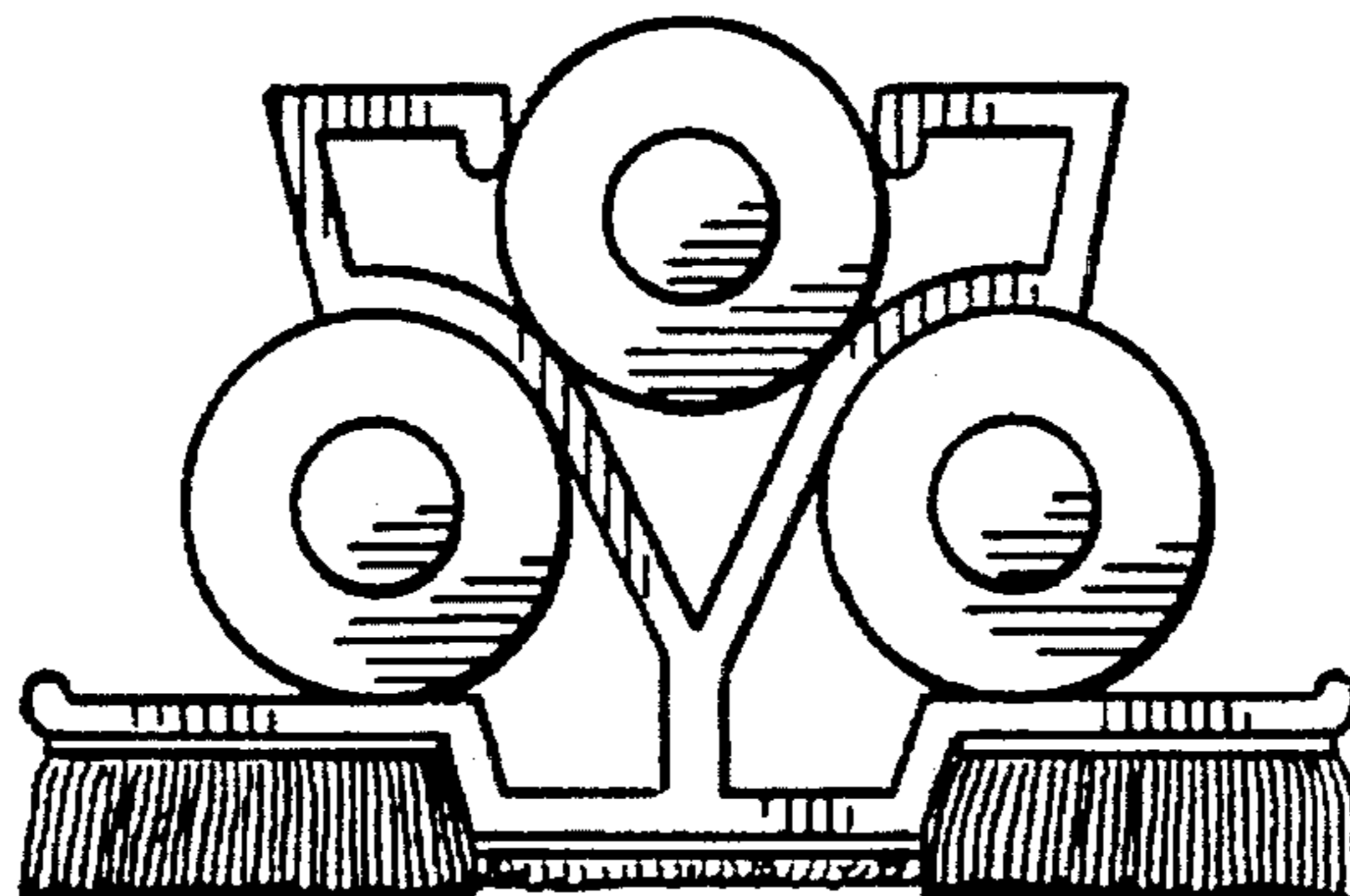
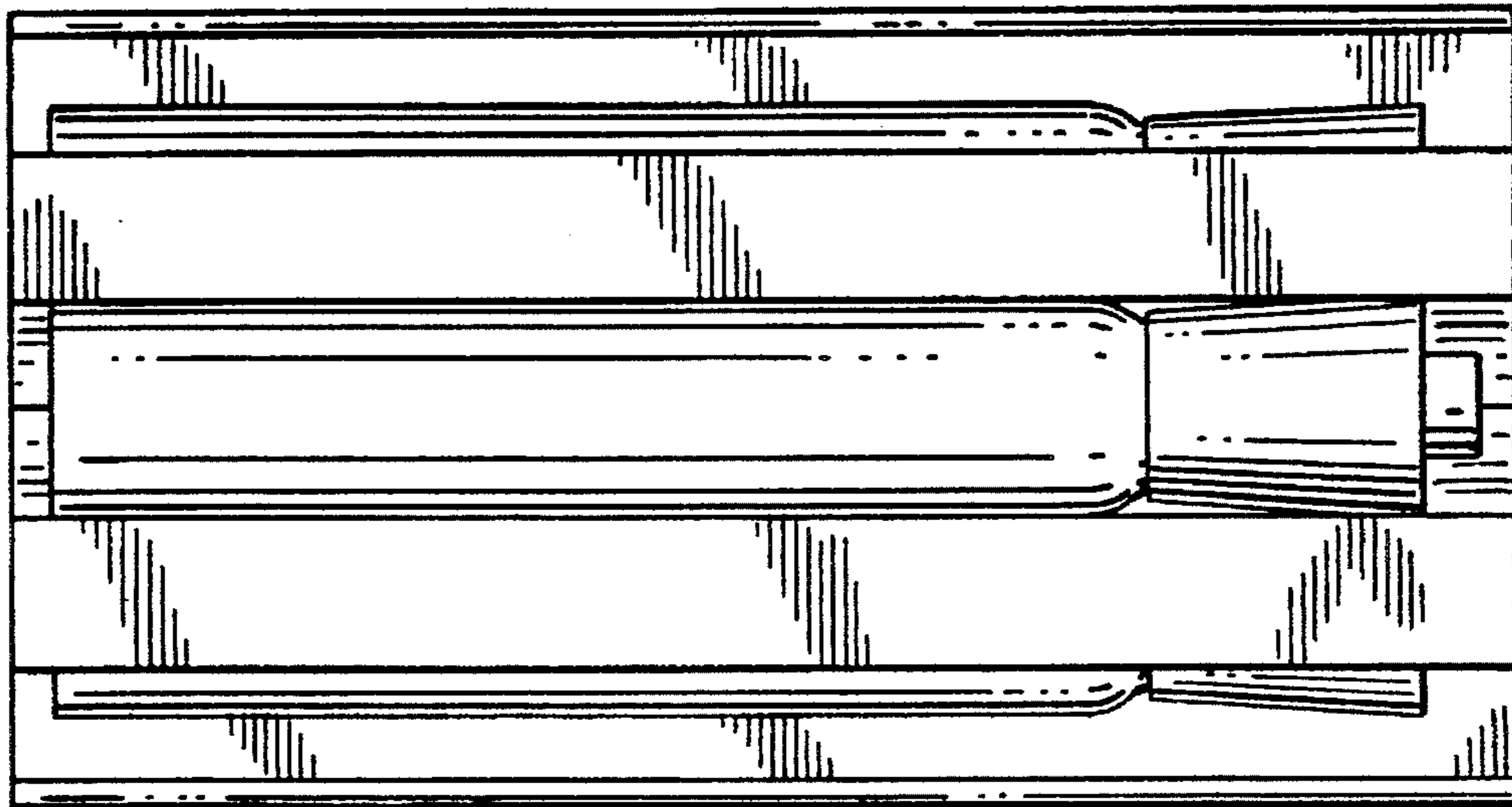
FIG. 9 is an end elevational view of FIG. 6, the opposite end being identical thereto.

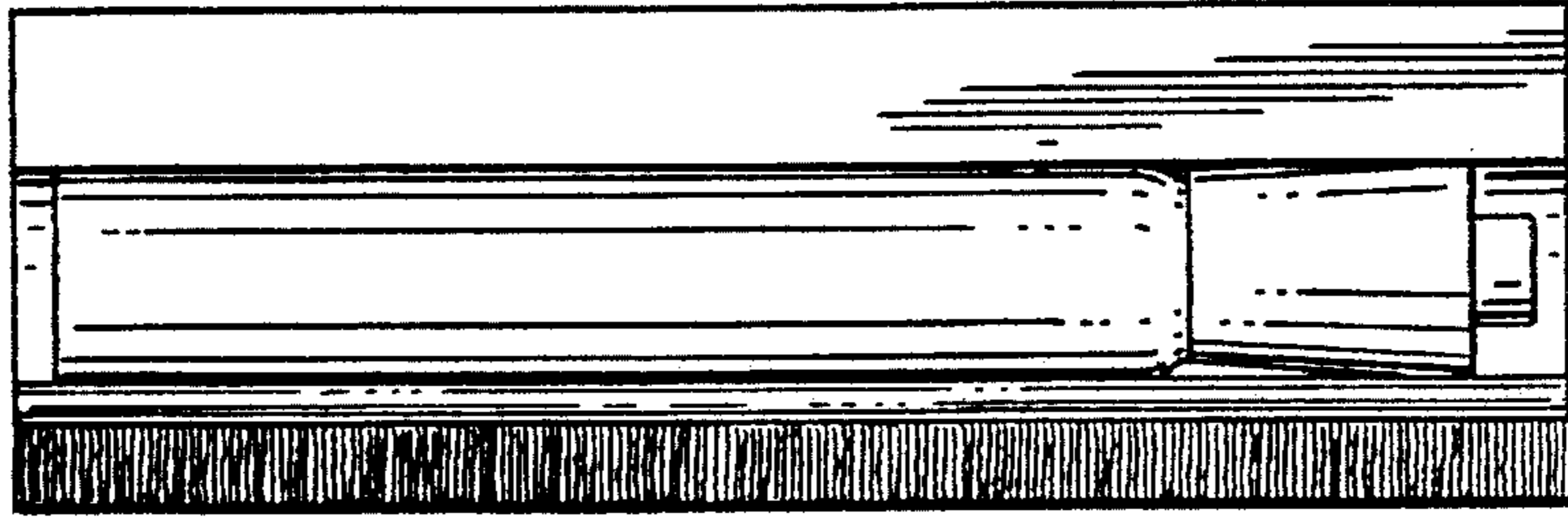

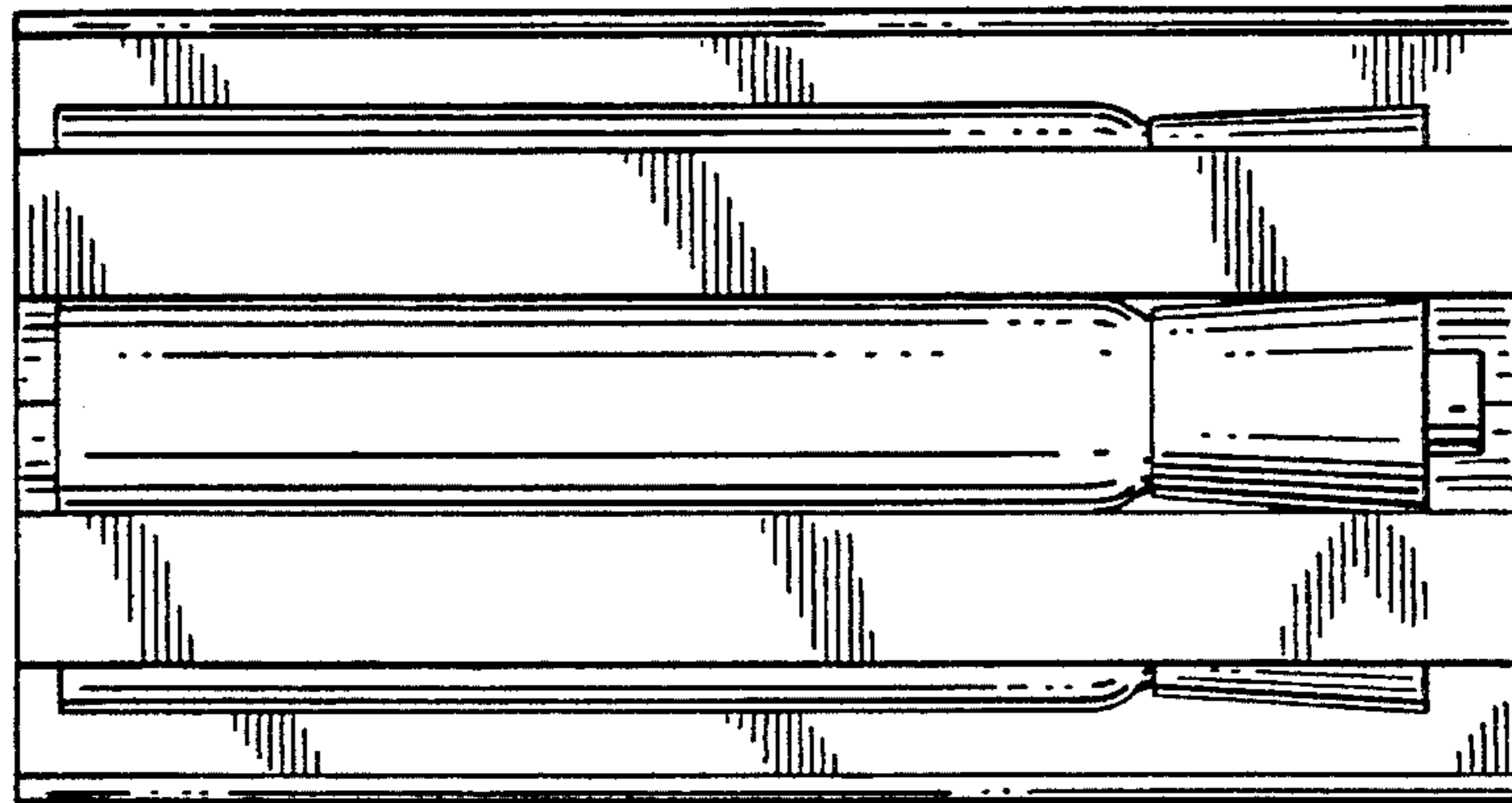

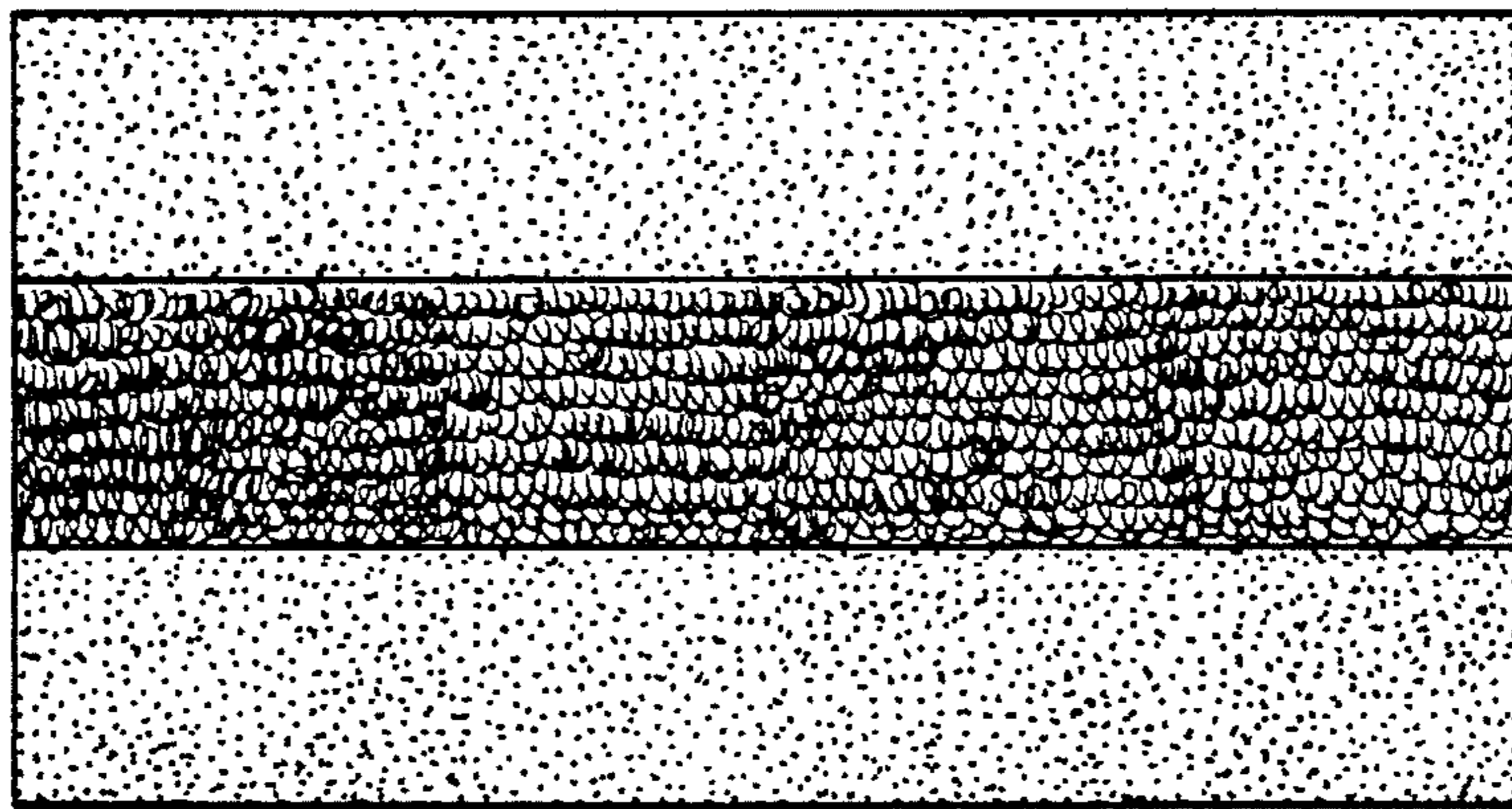

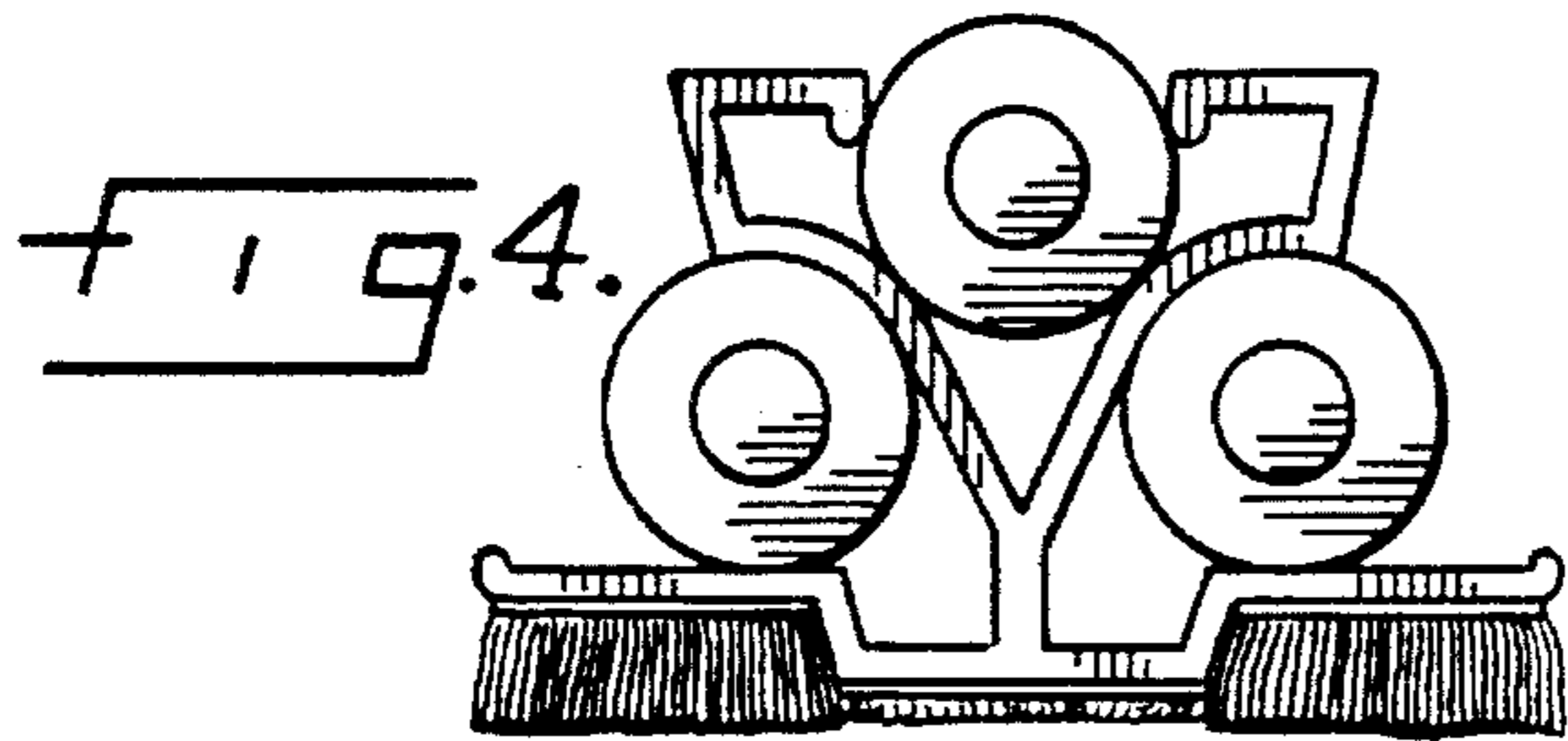

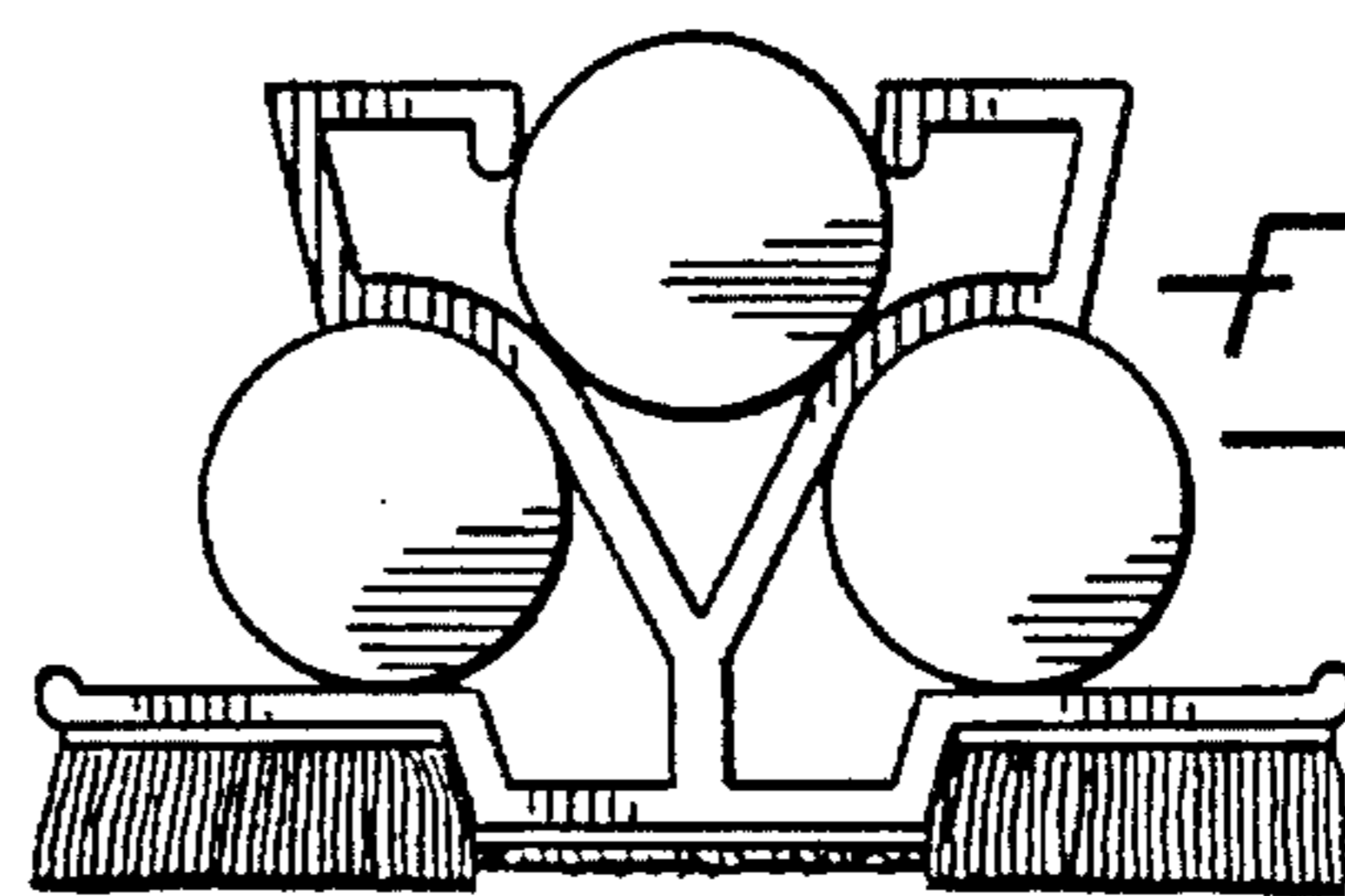

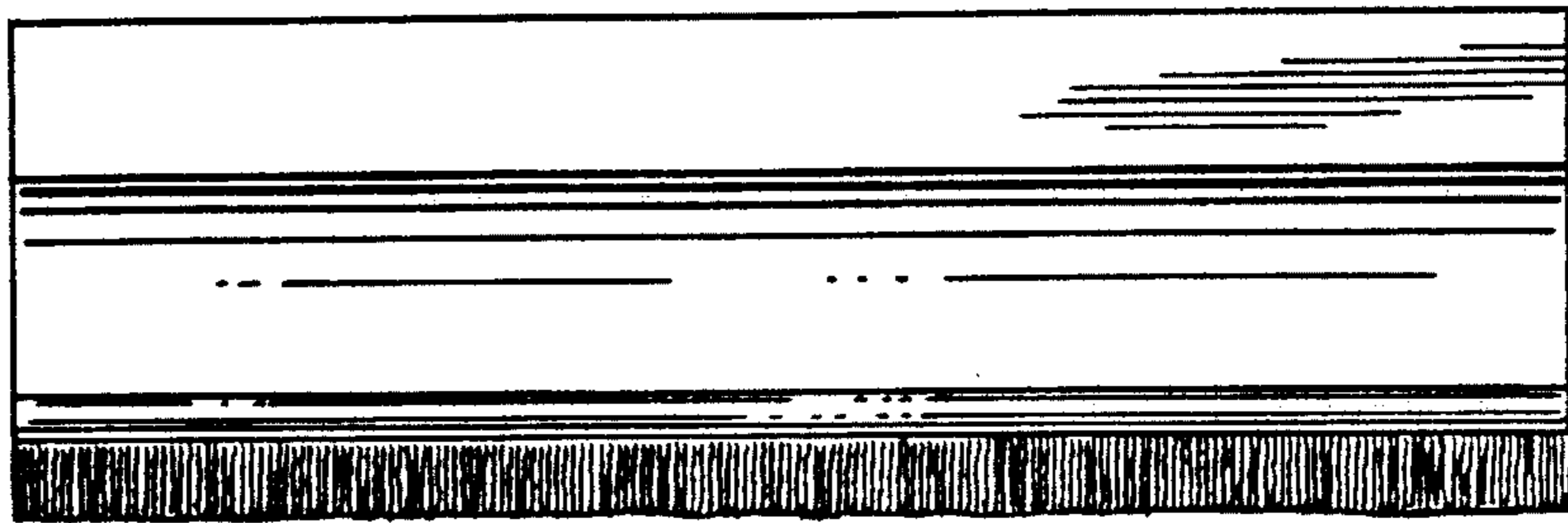

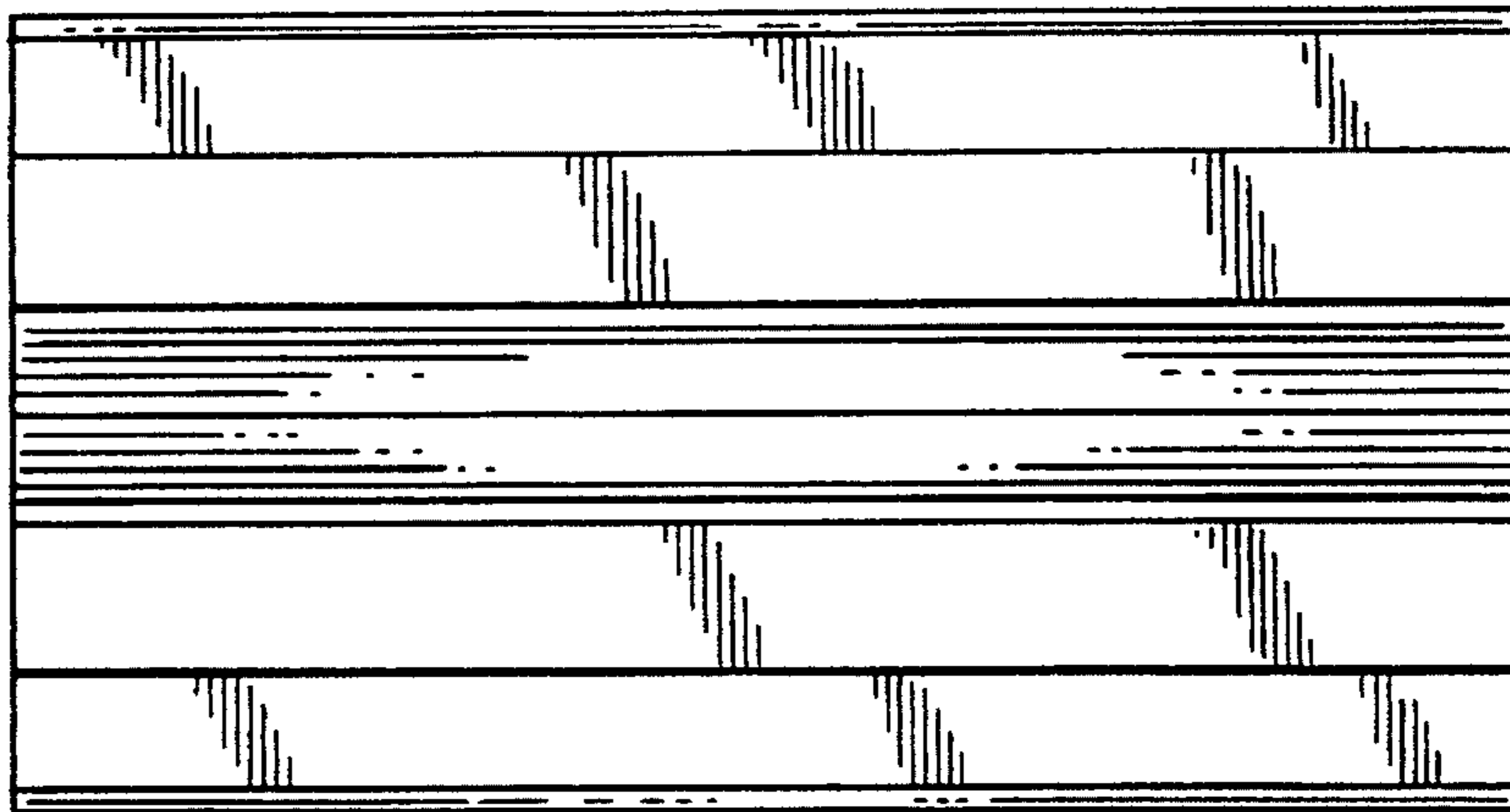

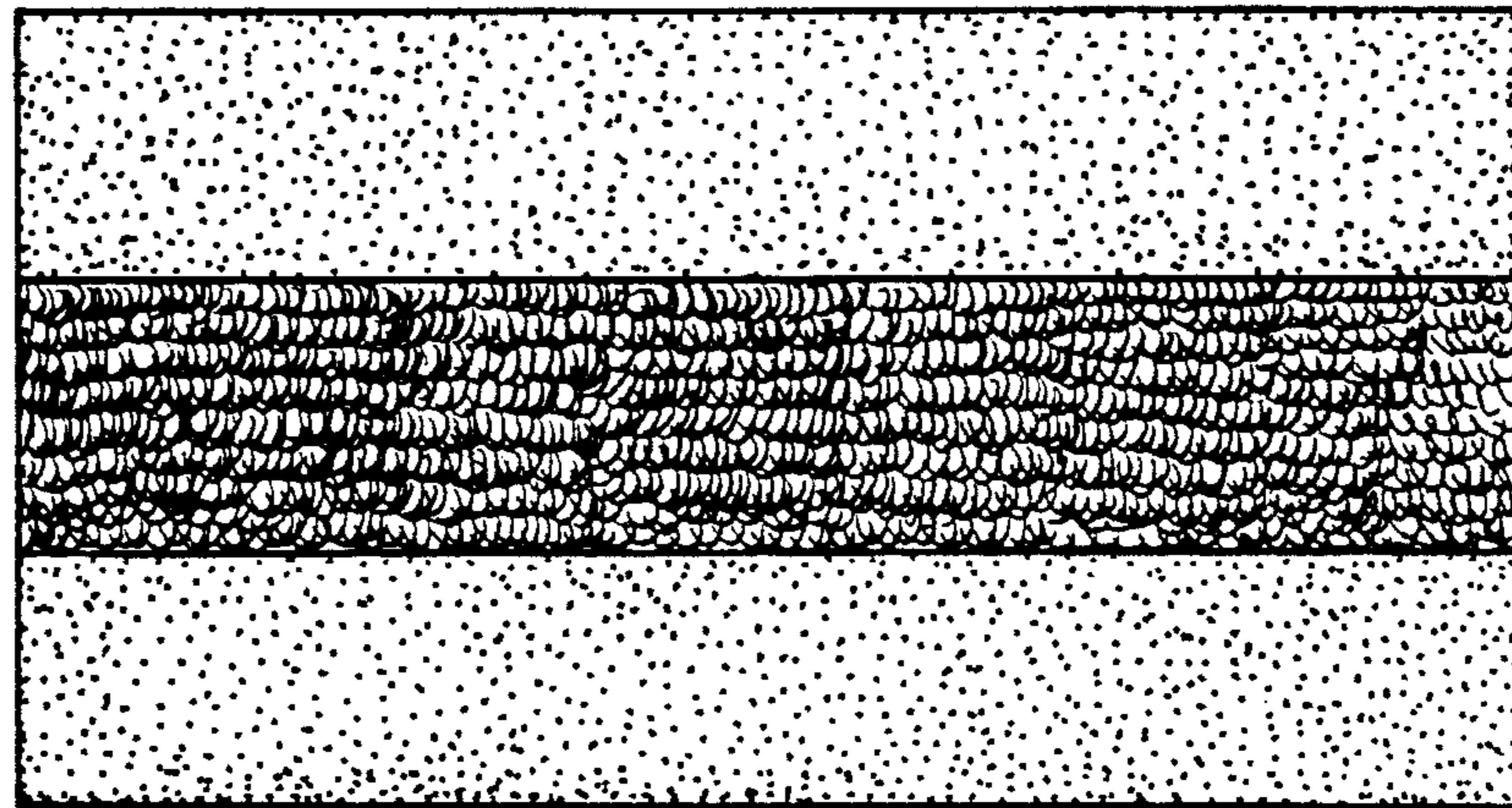

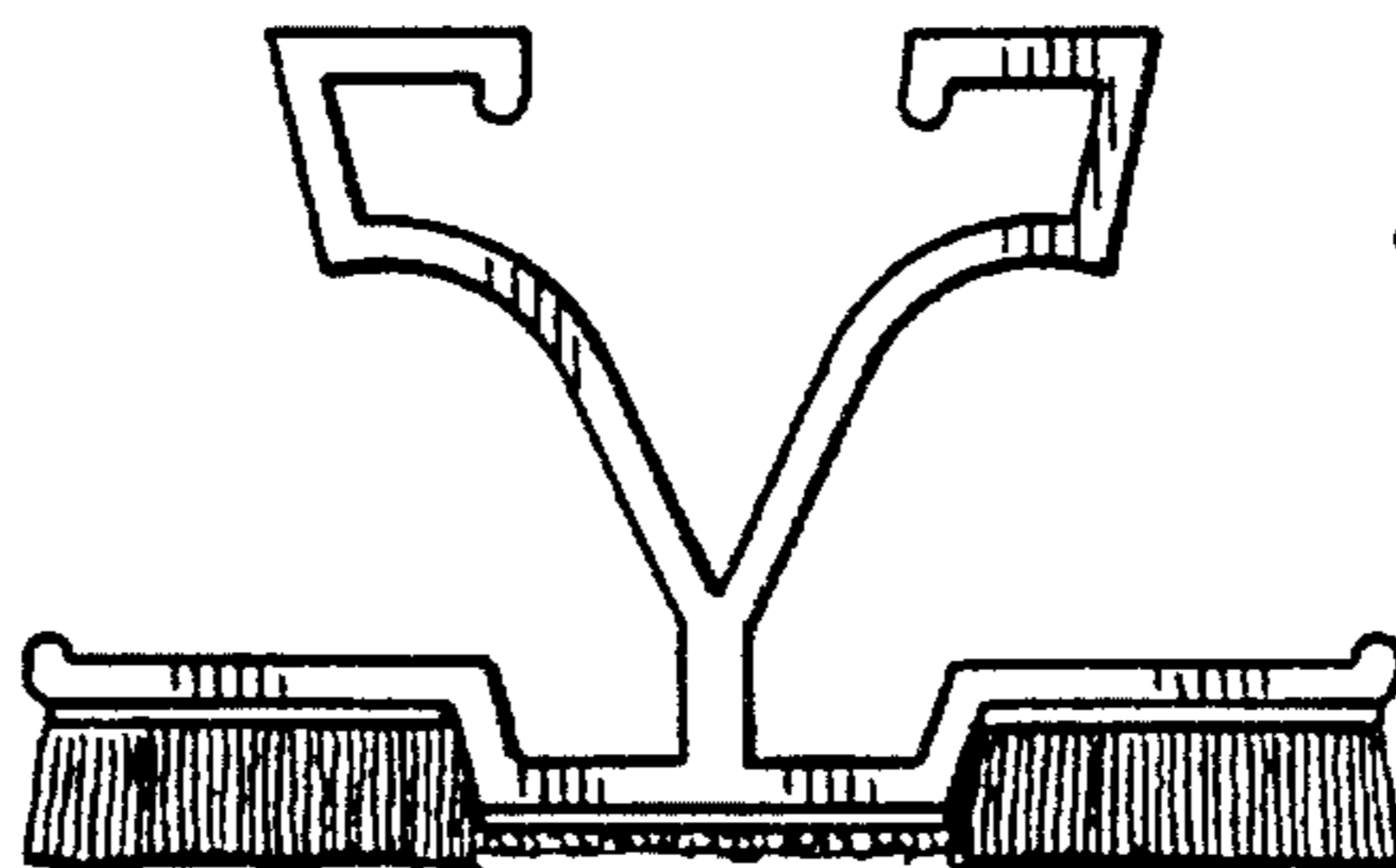
