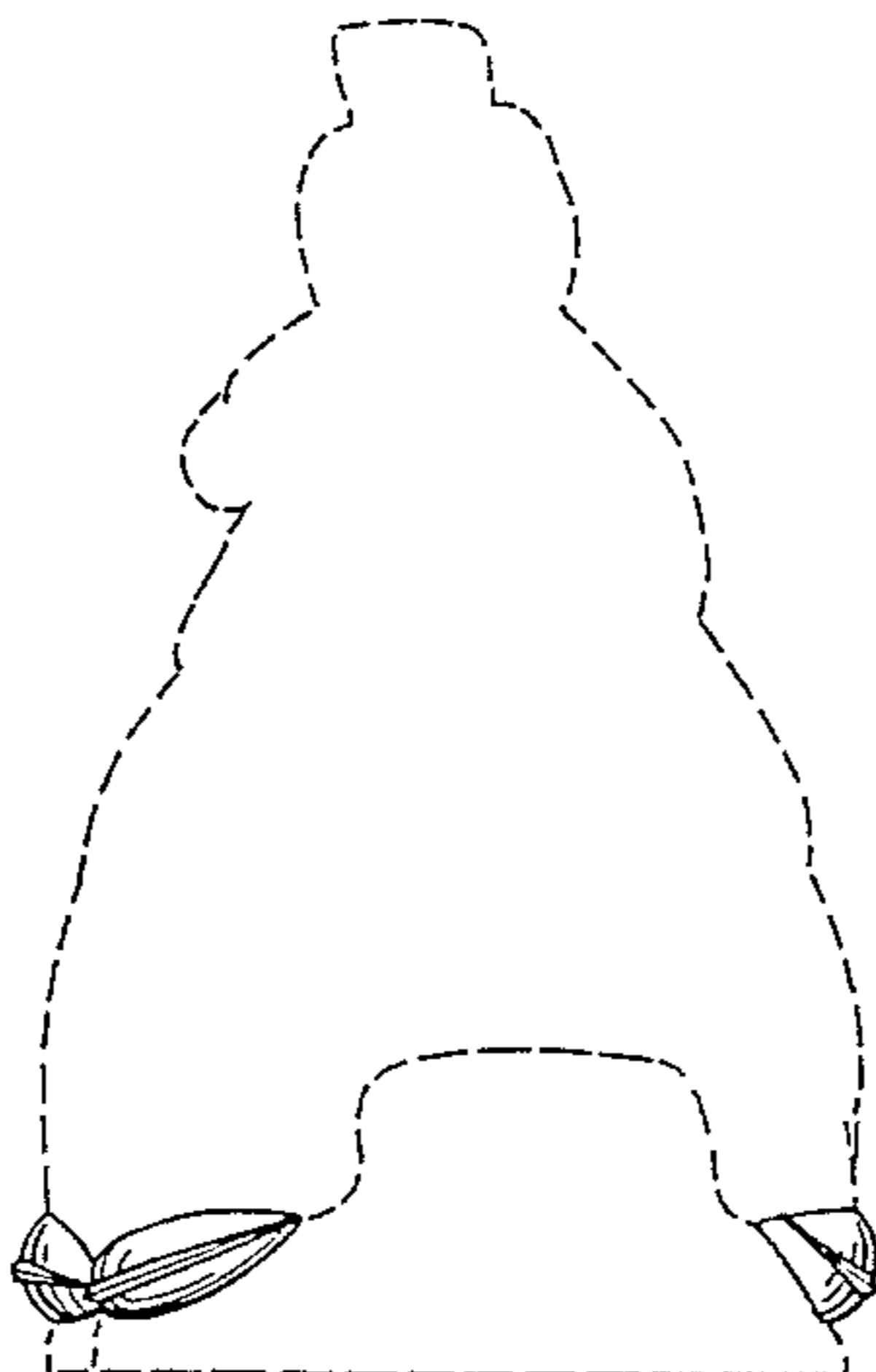
### [57] CLAIM

The ornamental design for an element of a shoe midsole periphery, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of an element of a shoe midsole periphery showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a side elevational view thereof; and, FIG. 4 is a side elevational view of the other side thereof. The broken line showing of a shoe upper and sole in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

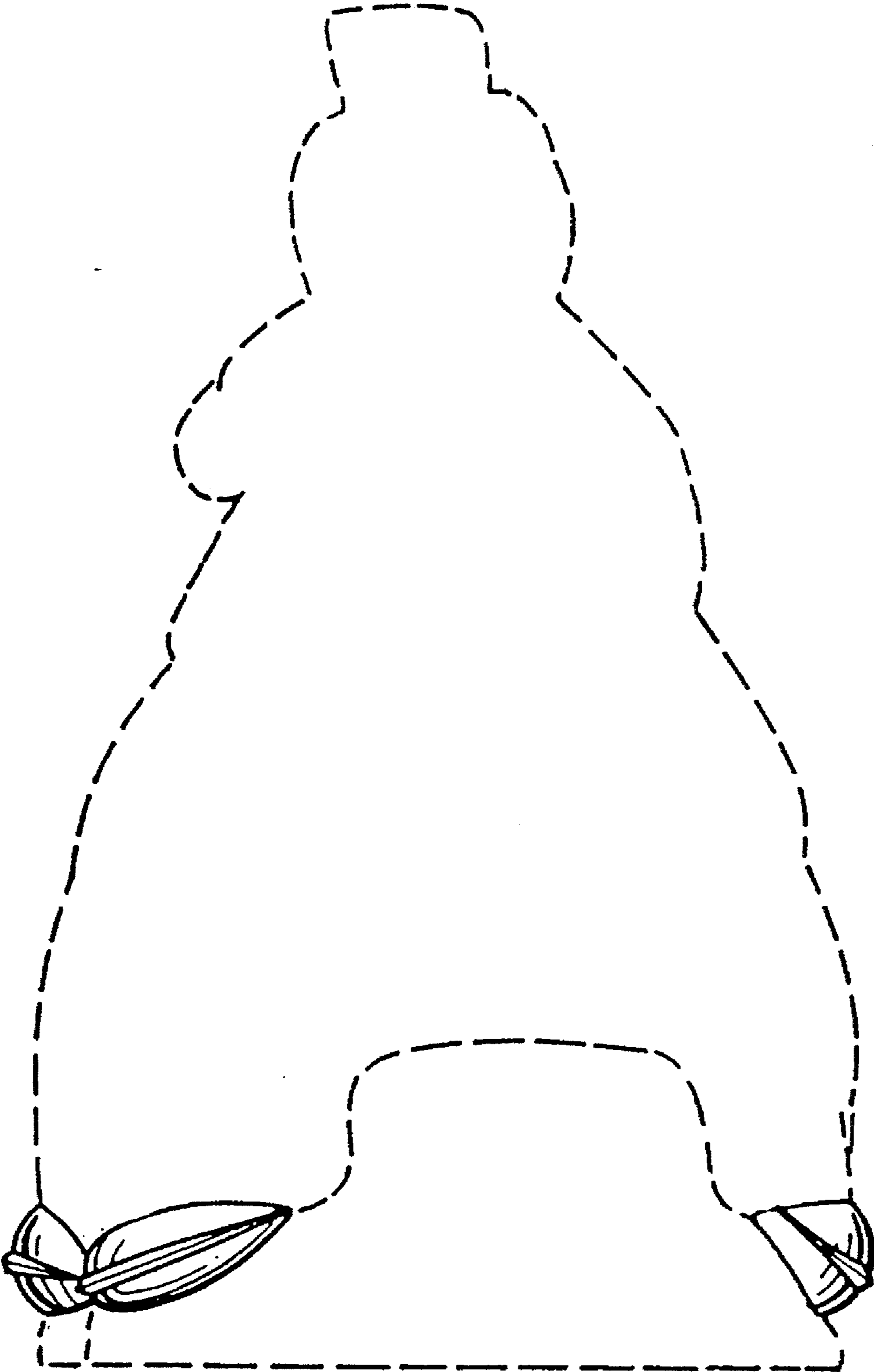

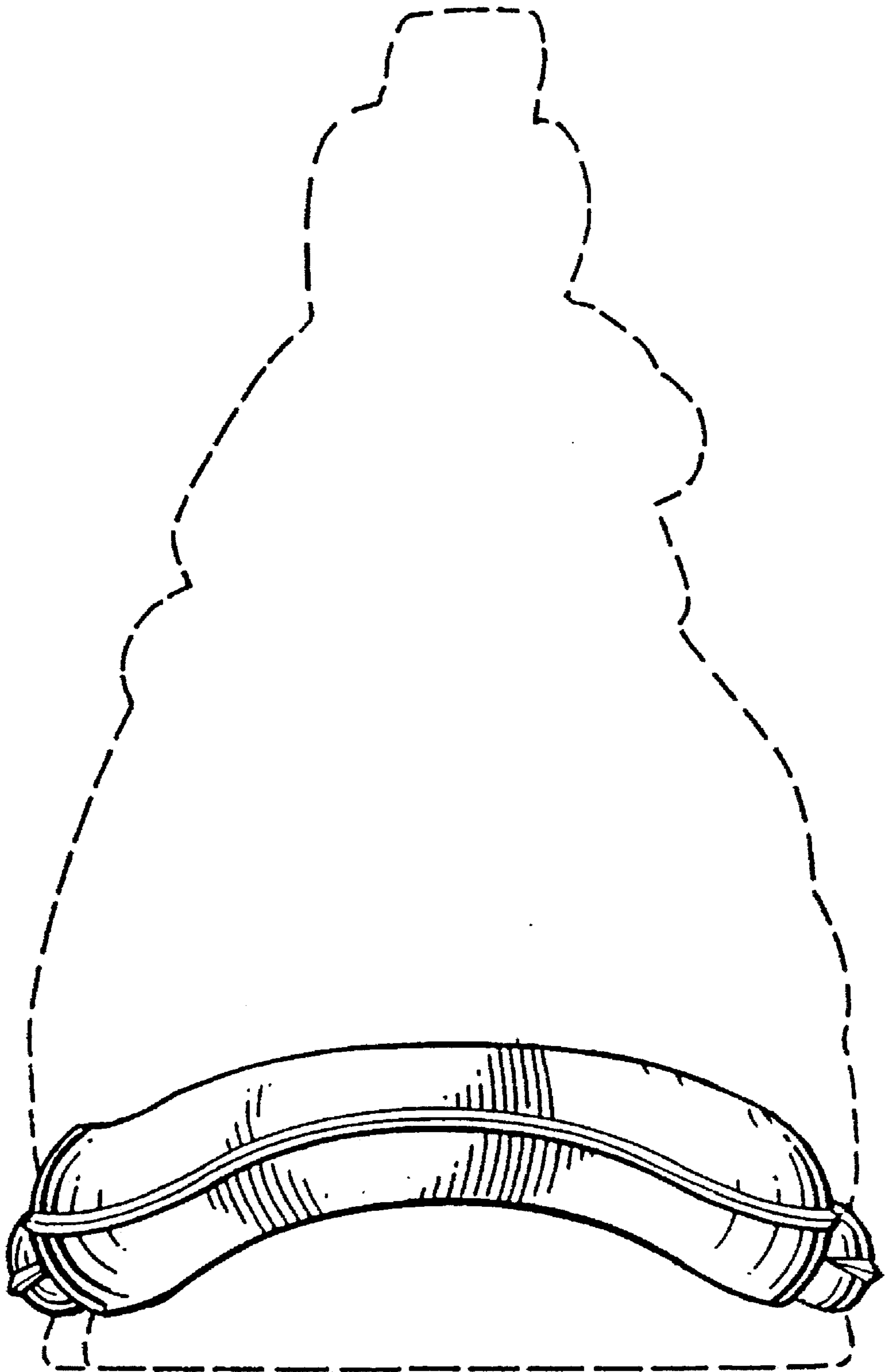

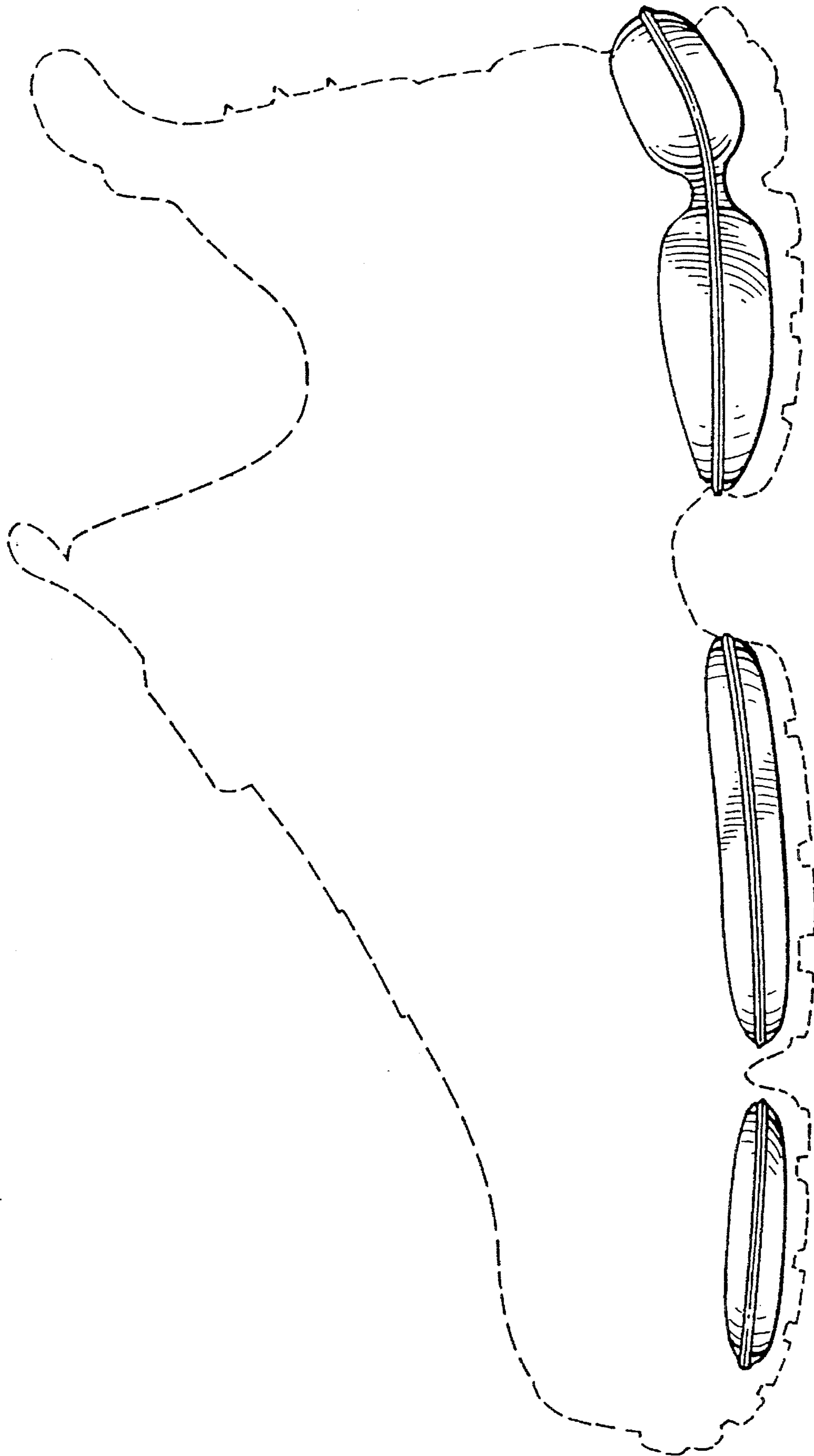

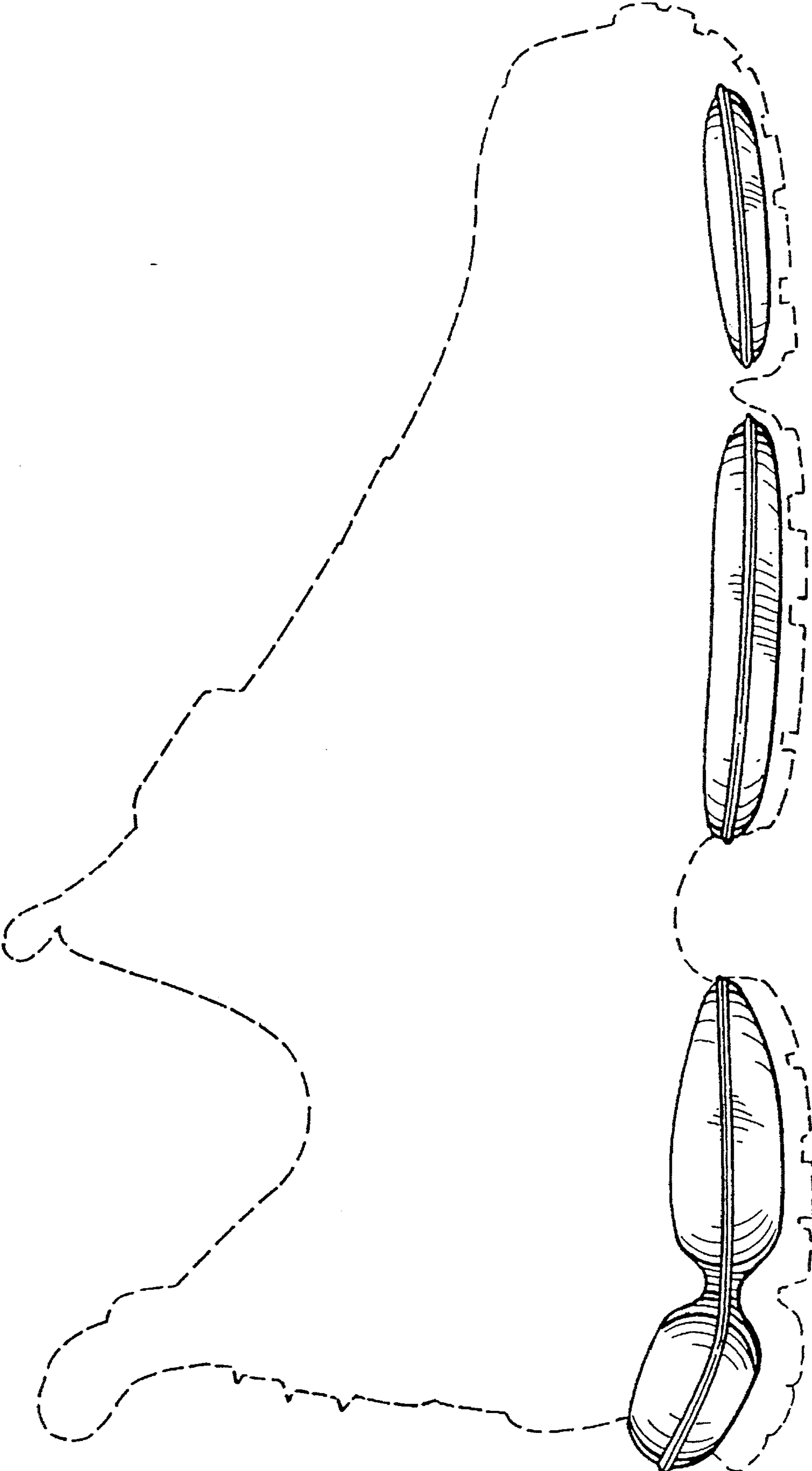
