[57] **CLAIM**

The ornamental design for a compact carrying case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective of the compact carrying case of the invention shown laying flat in its partially opened position; FIG. 2 is a front elevation thereof; FIG. 3 is a side elevation view, the opposite side being a mirror image thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

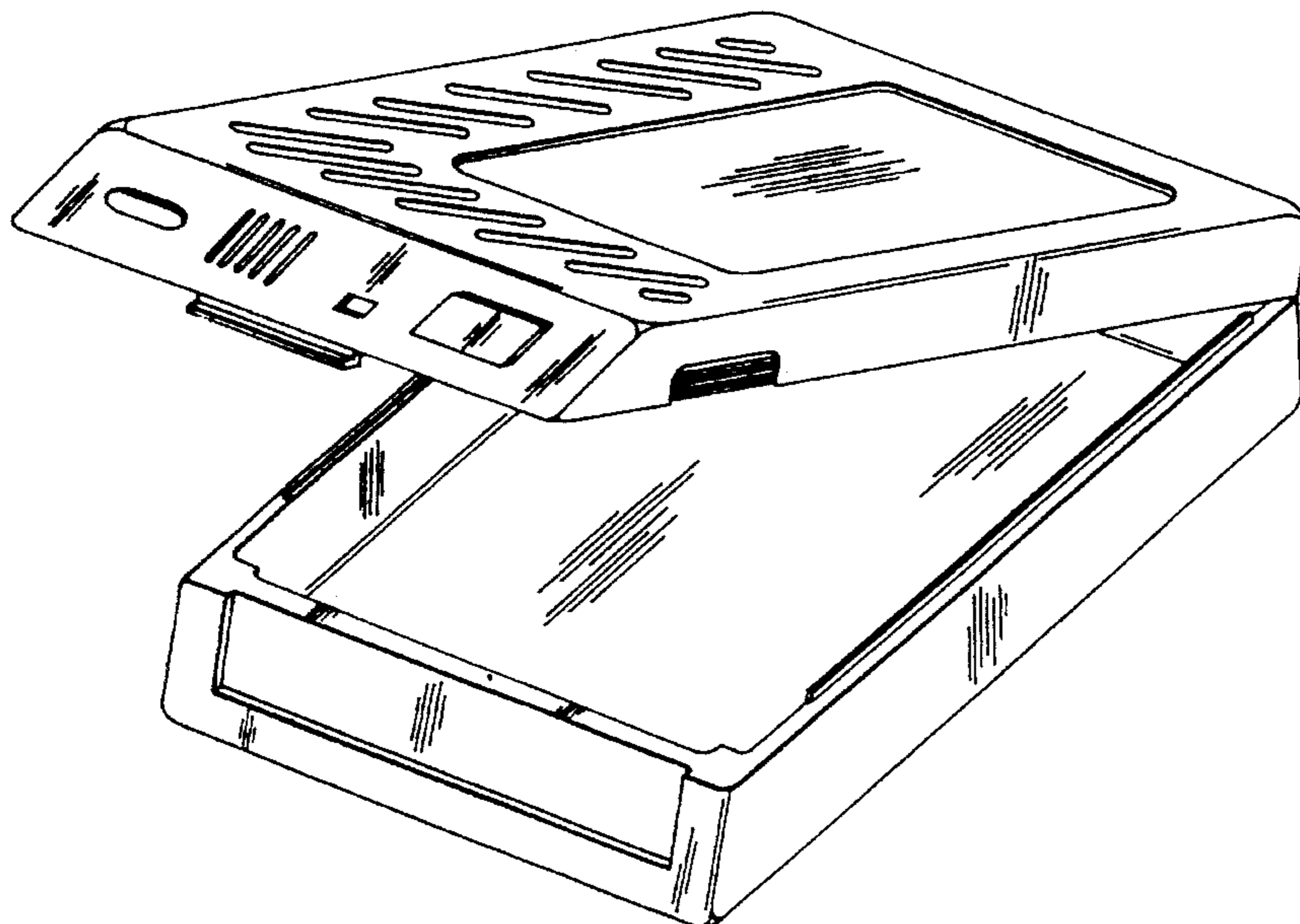

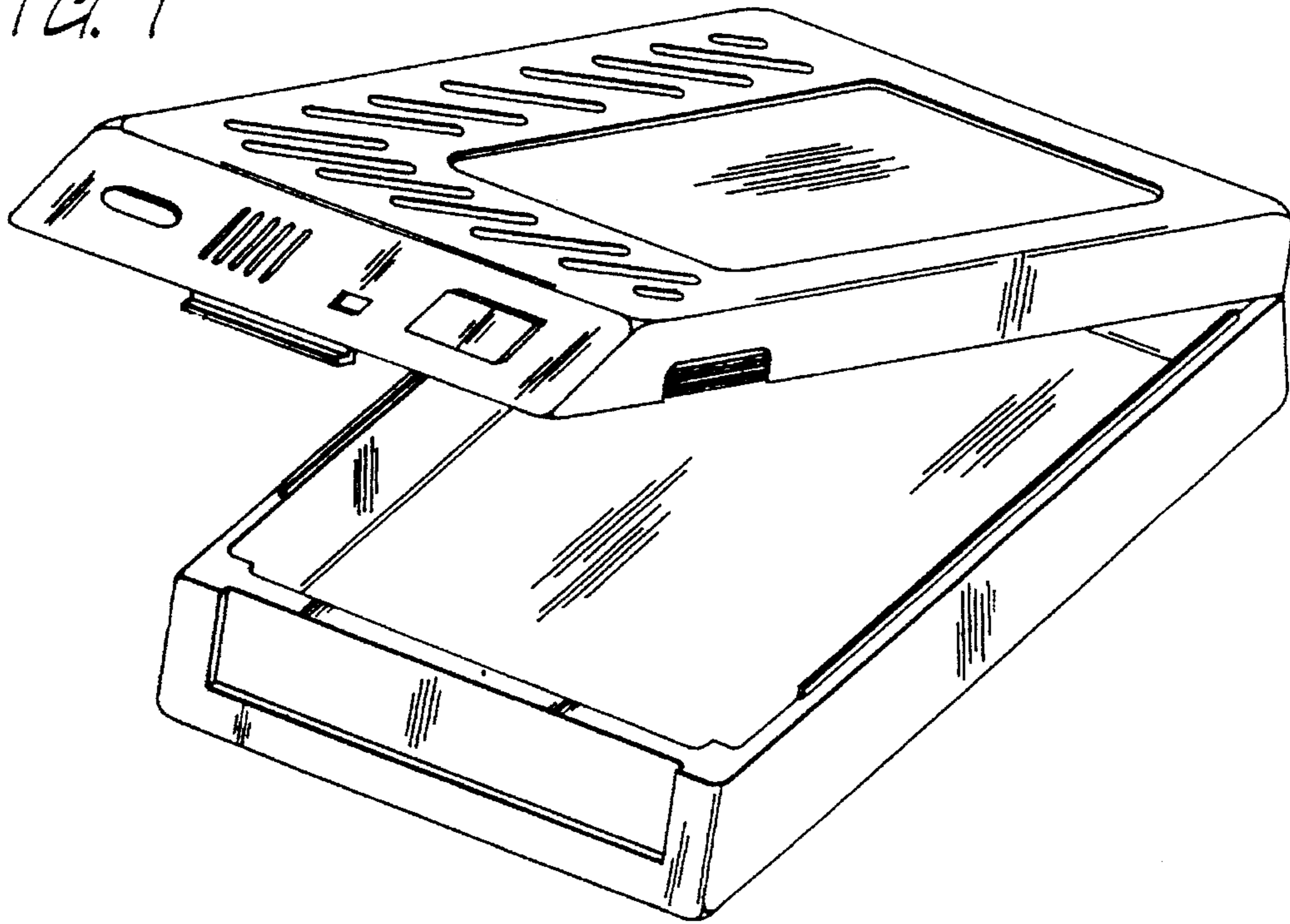

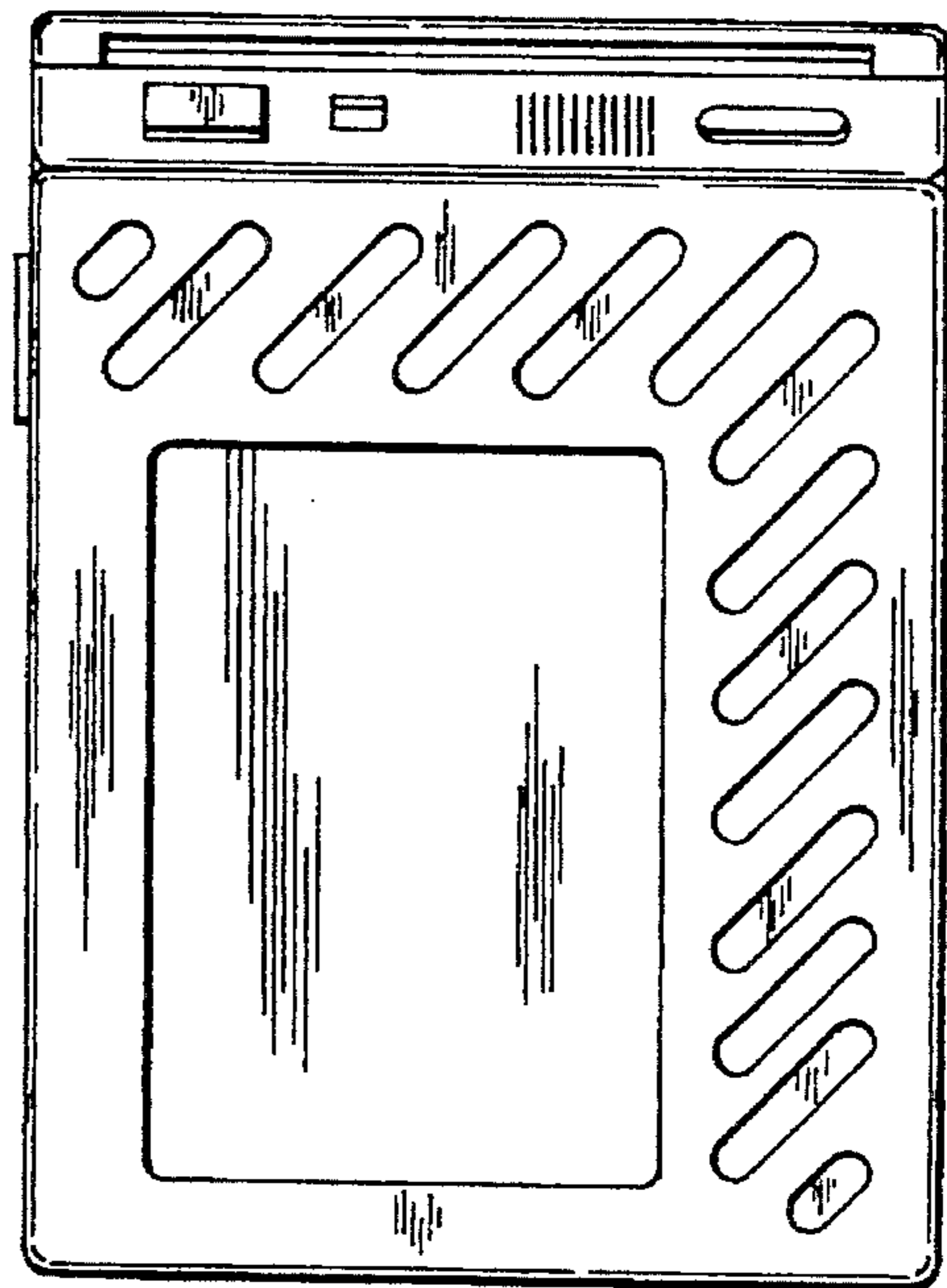

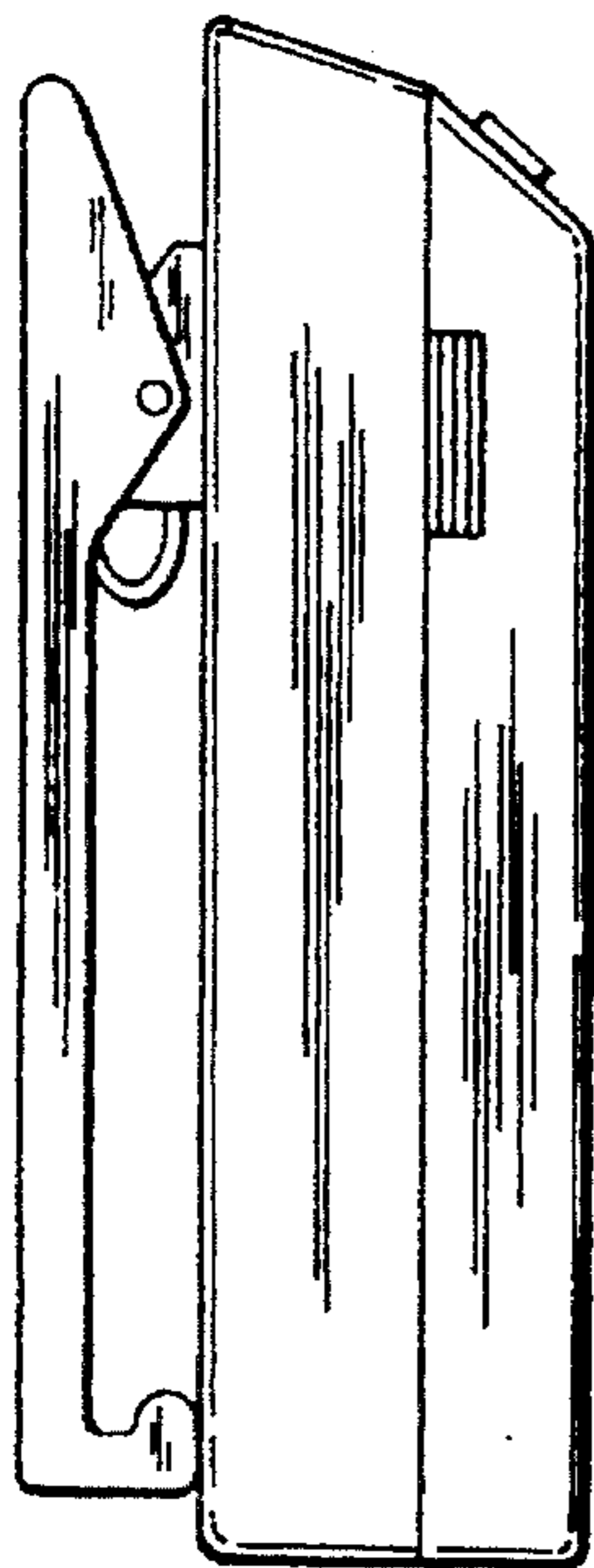

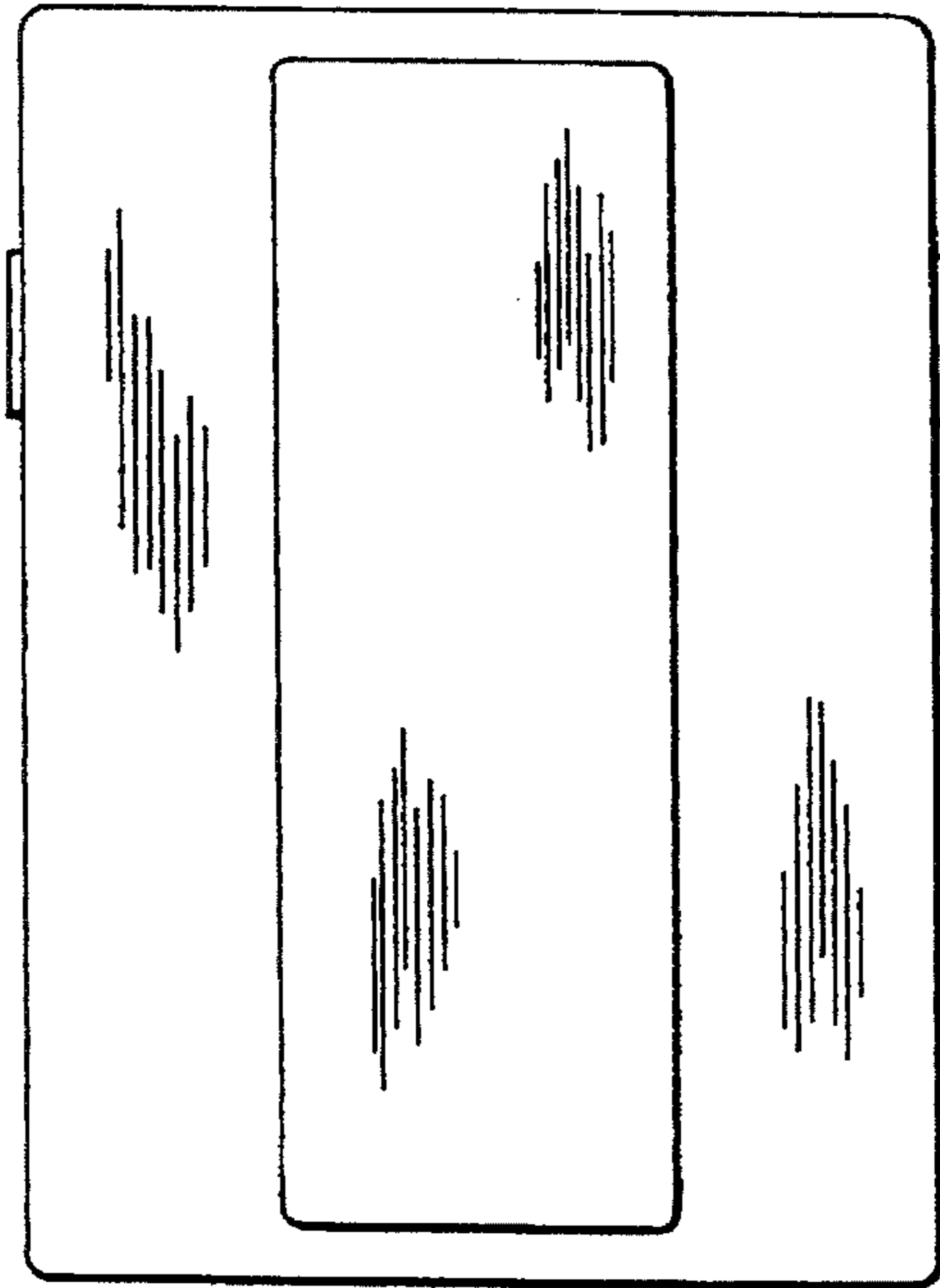

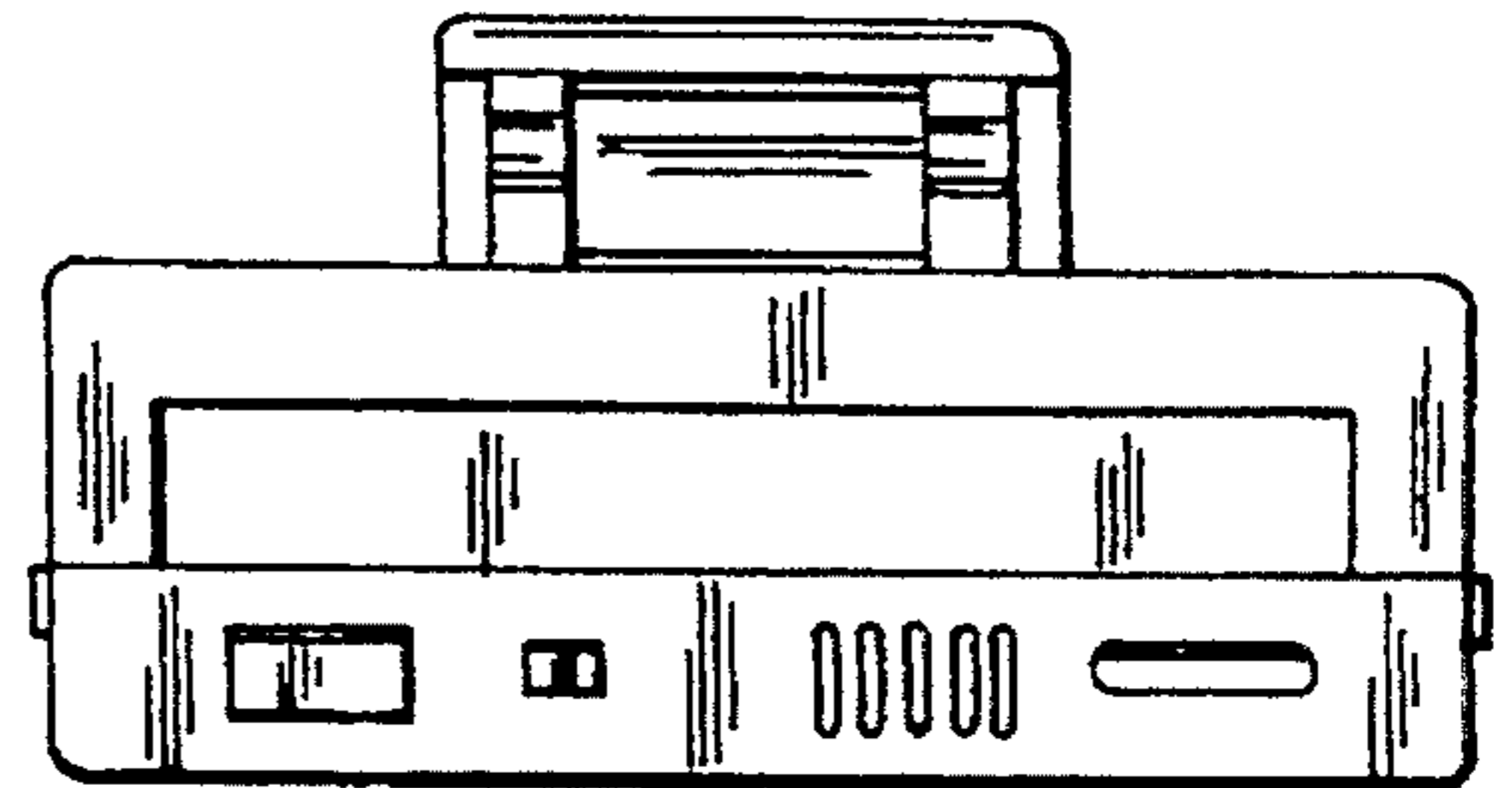
