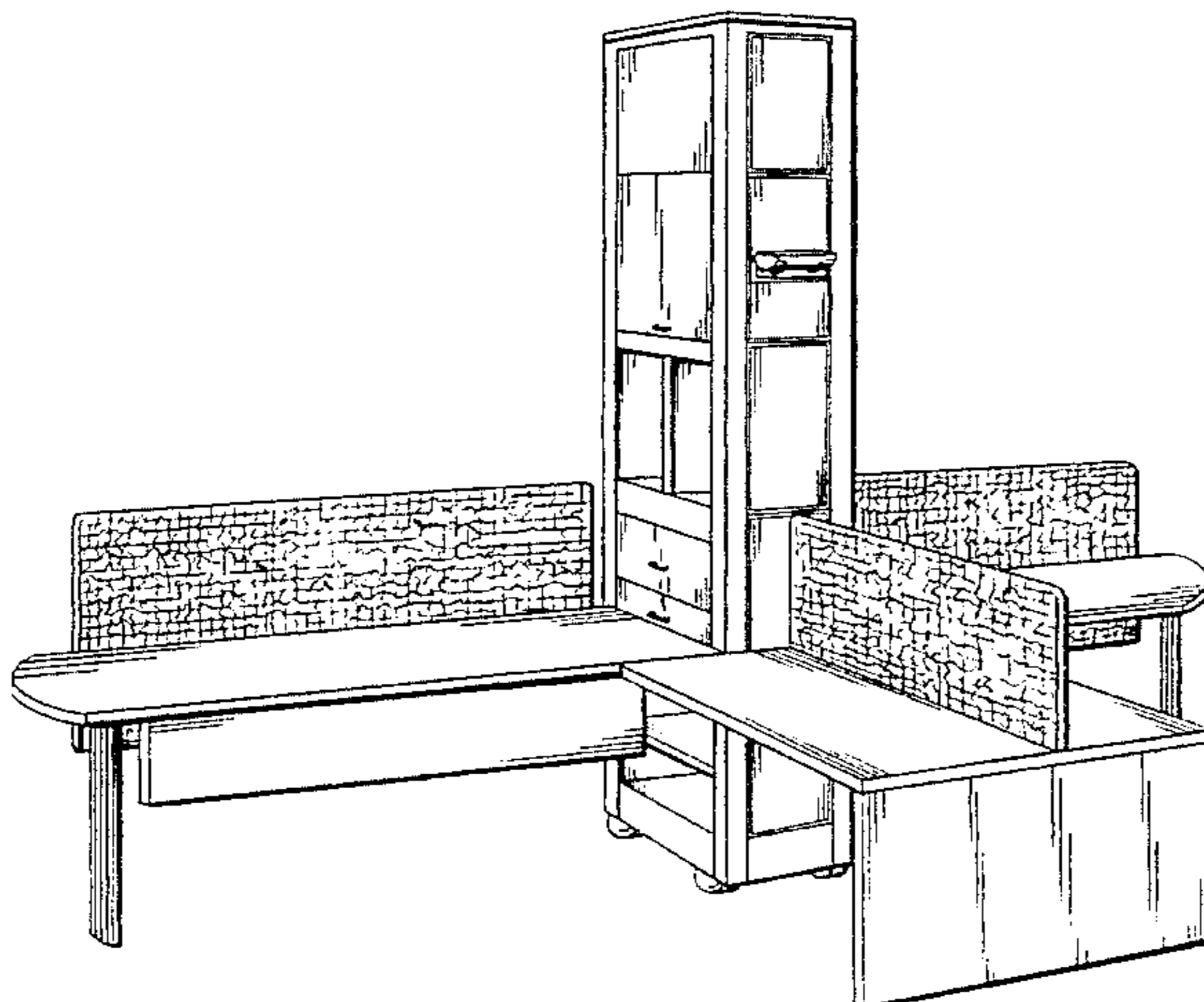
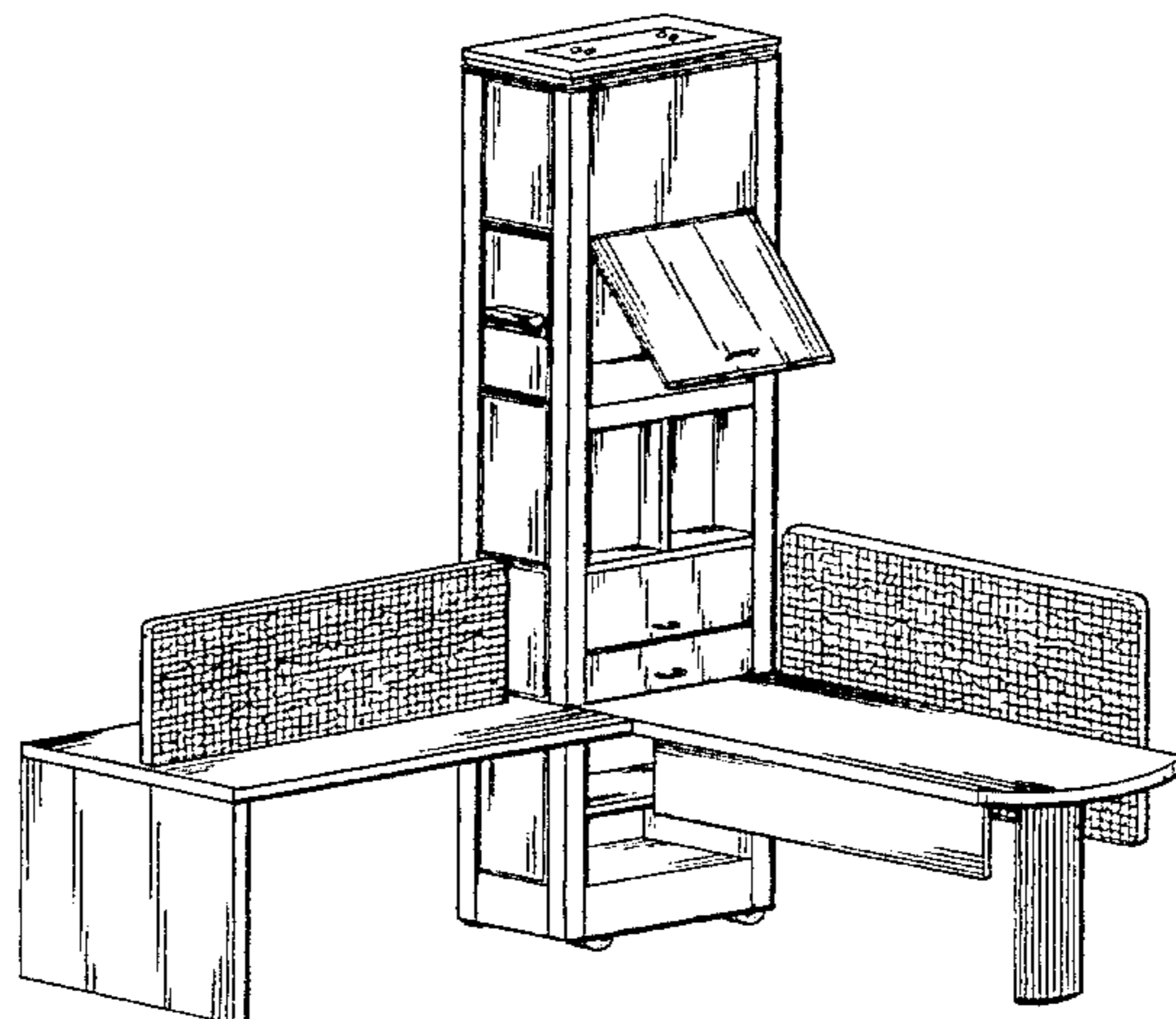
FIG. 1 is a front perspective view of the multiple desk and cabinet tower unit embodying my design;

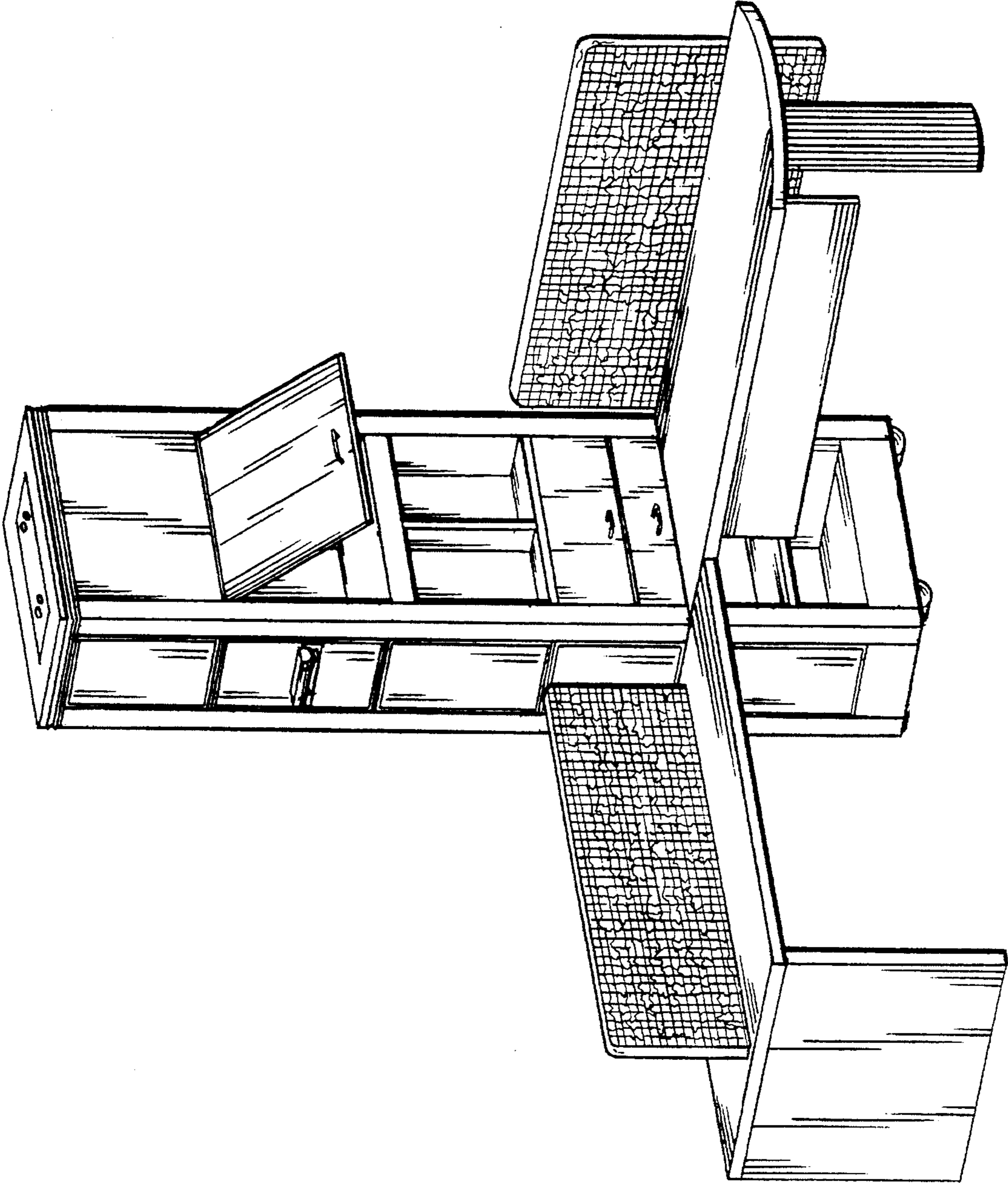

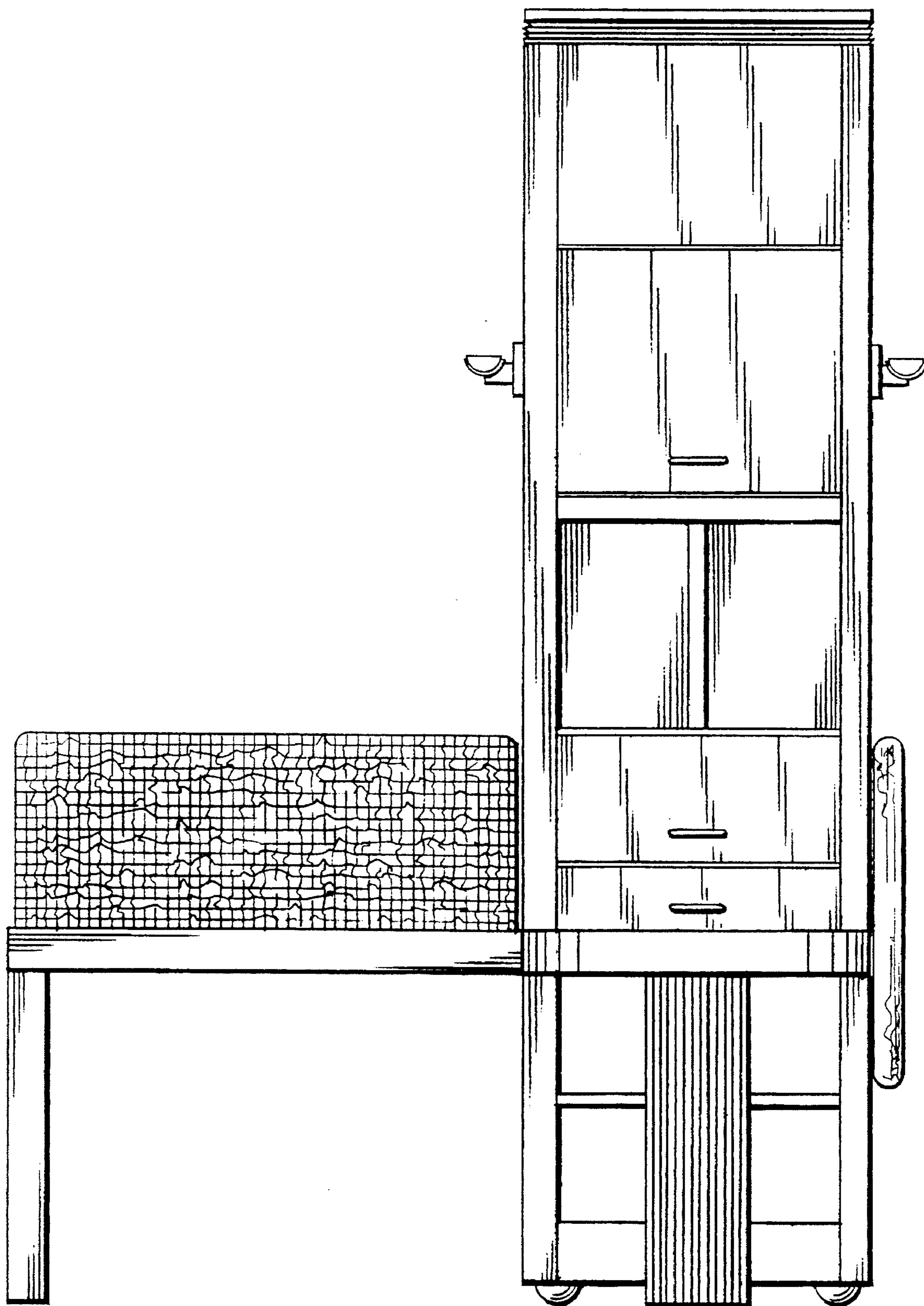

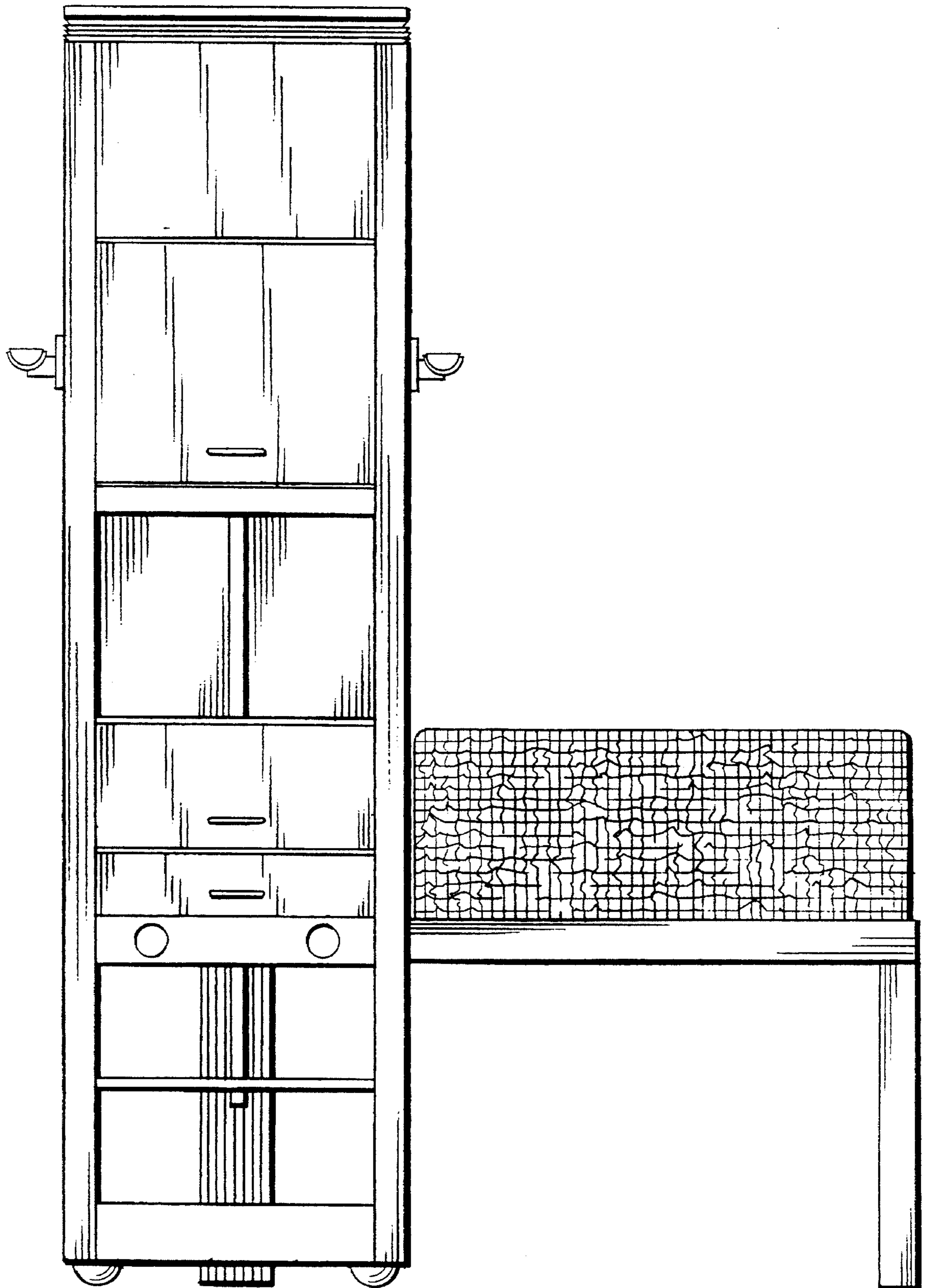

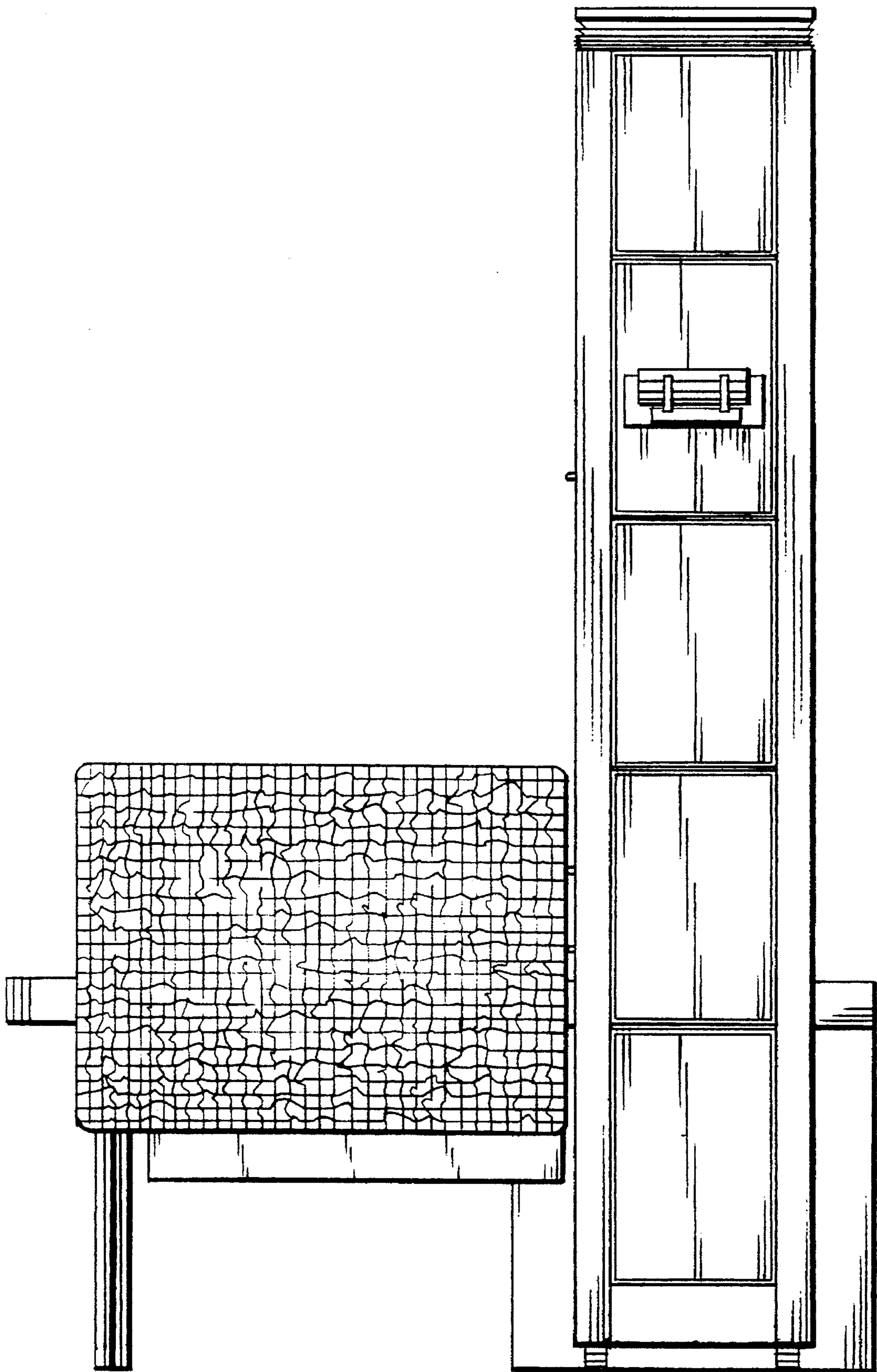

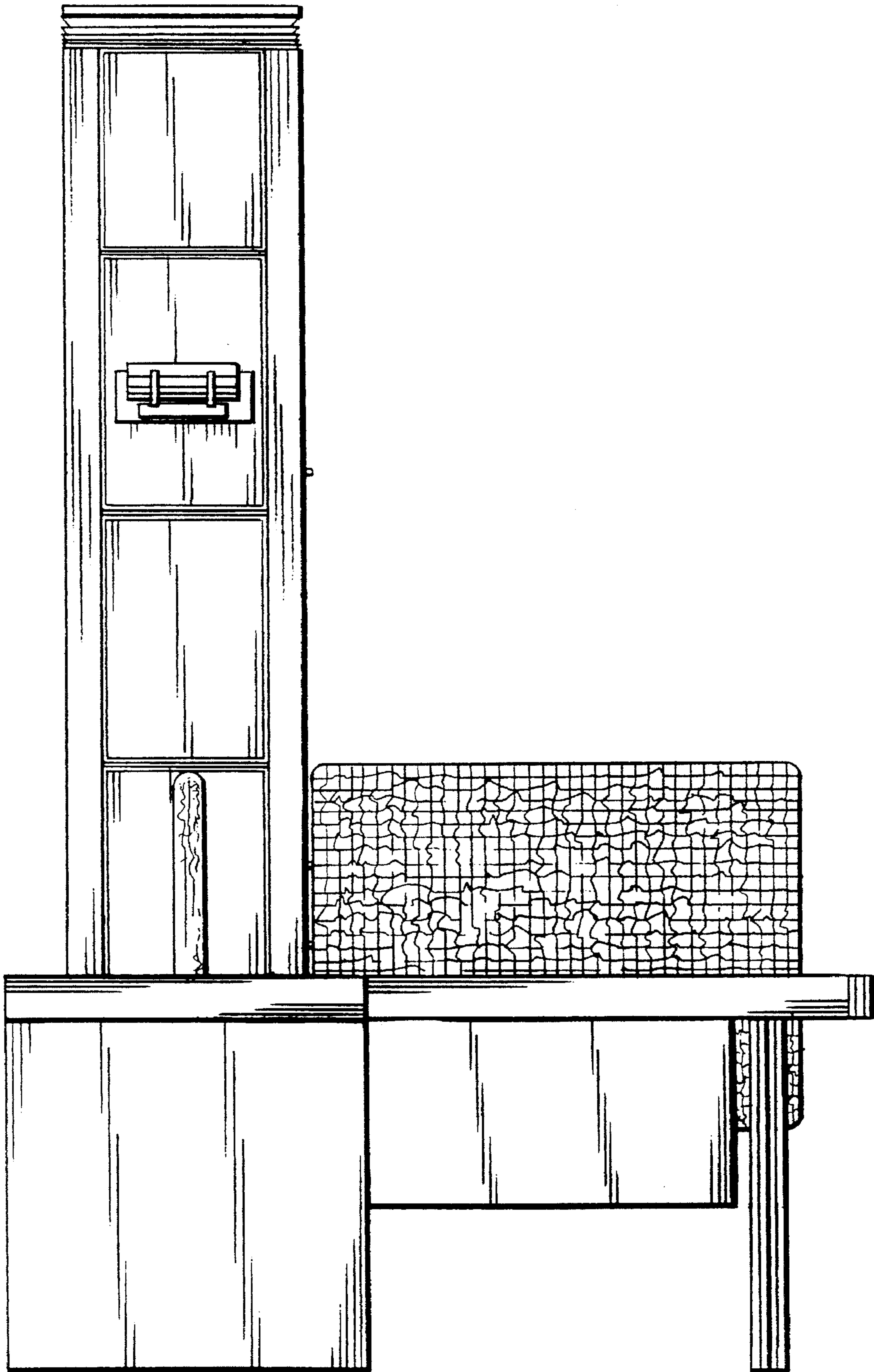

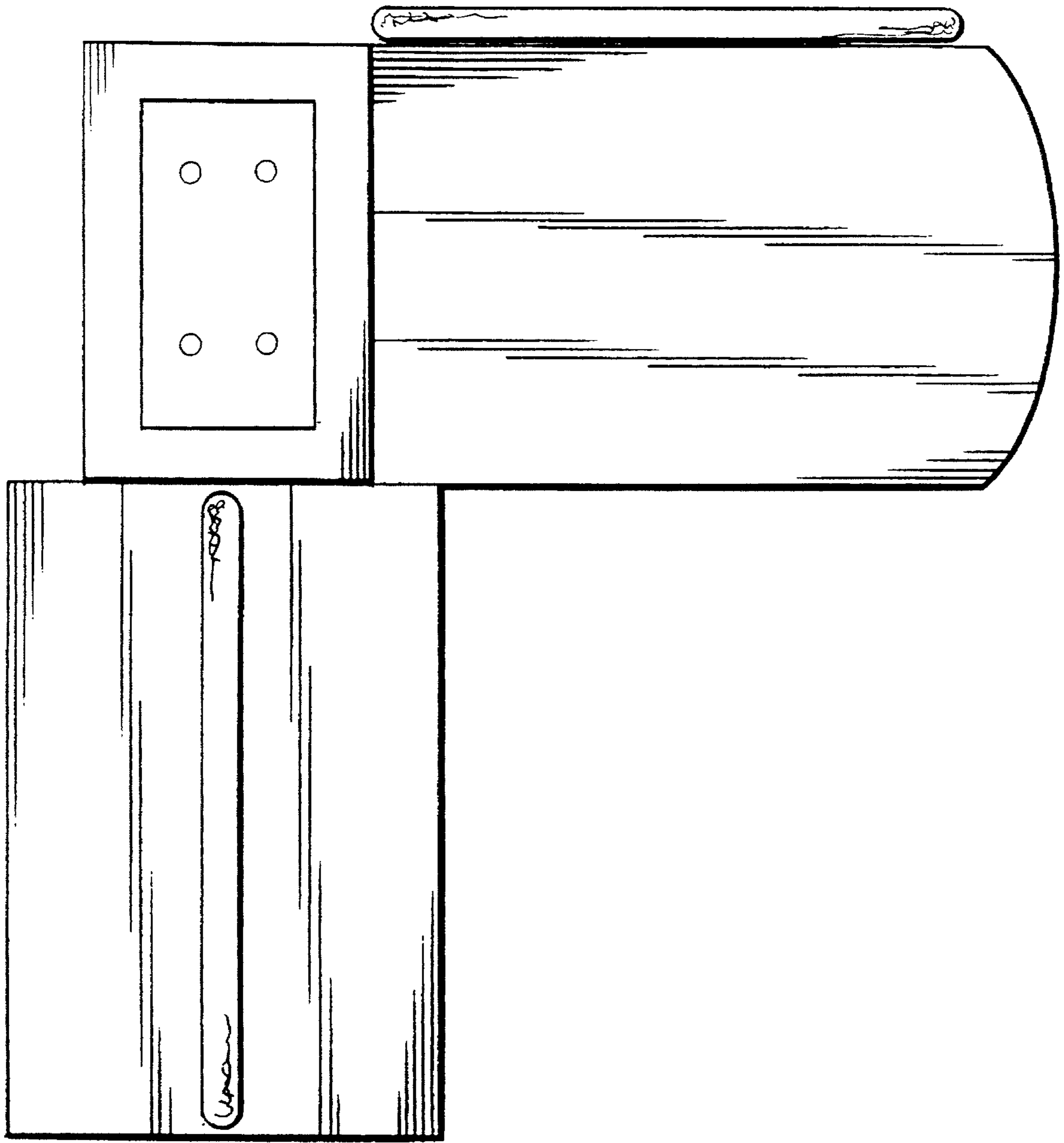

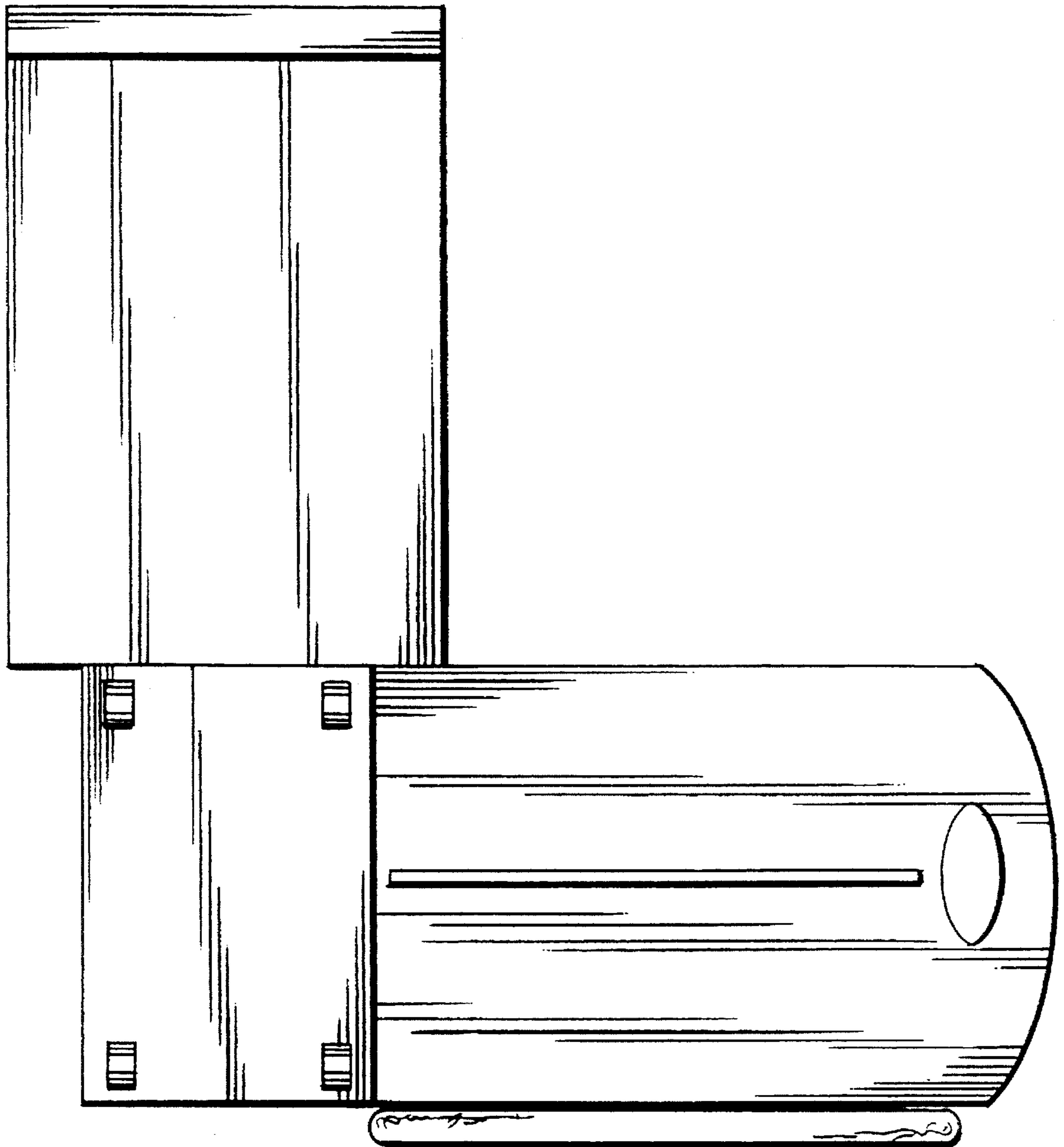

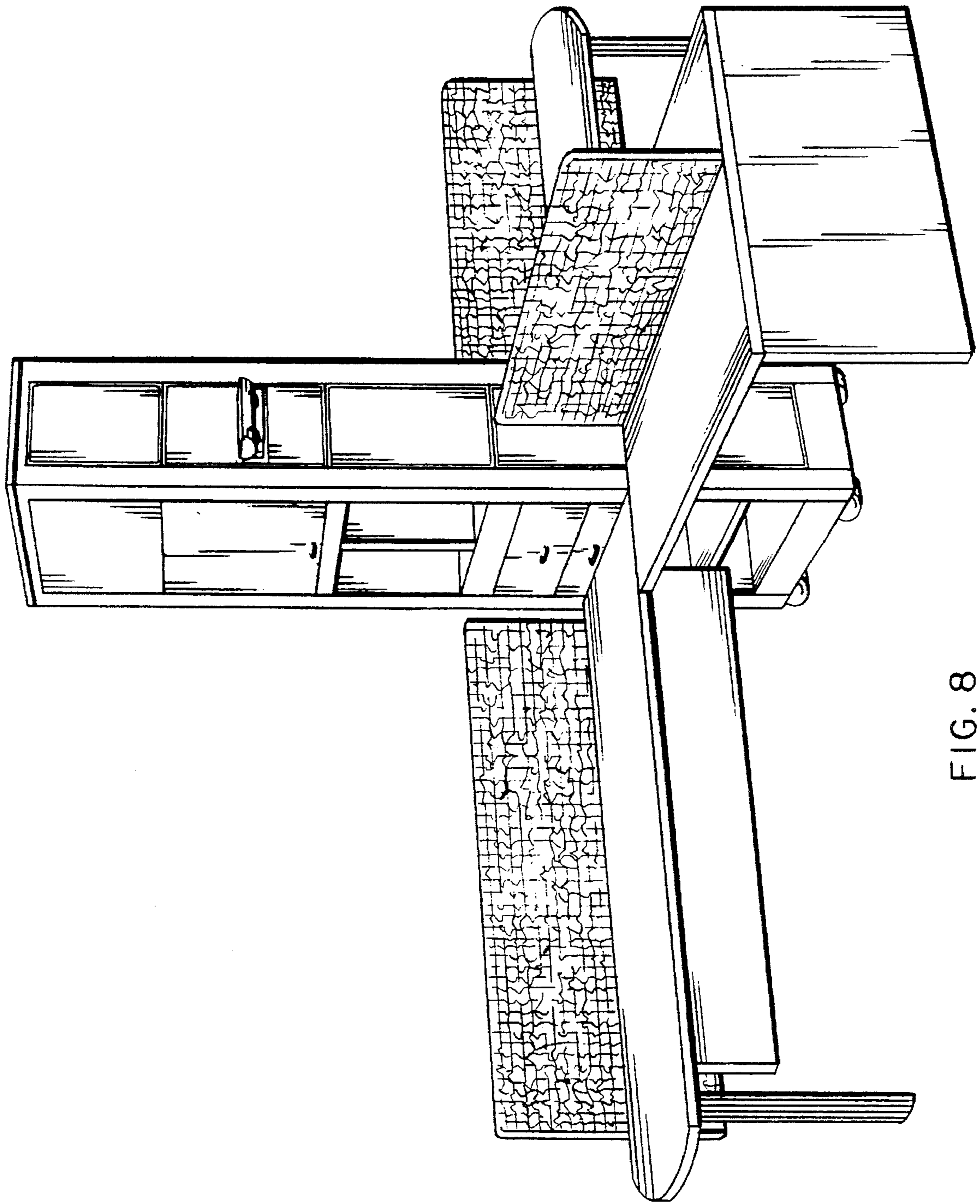

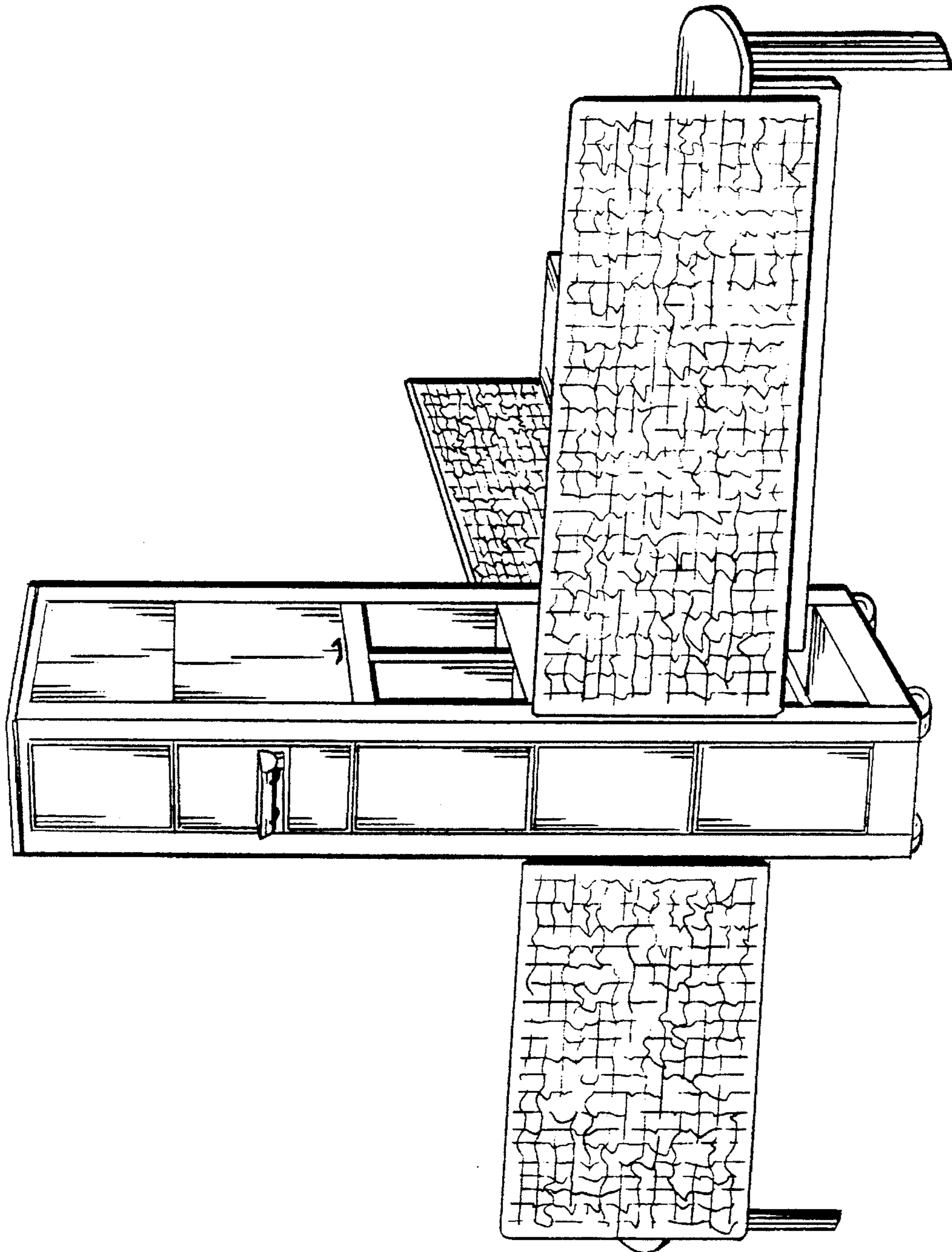
