[57] **CLAIM**

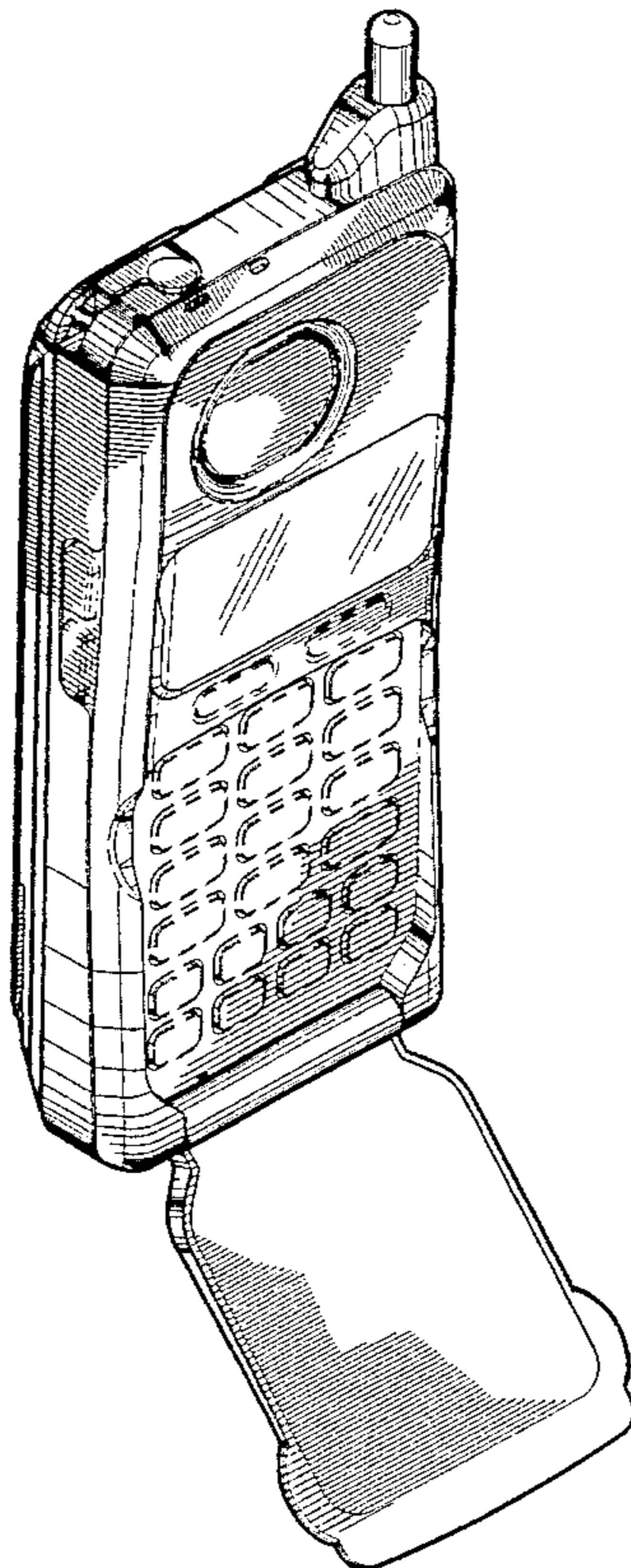
The ornamental design for a telephone handset housing, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left, perspective view with a flip extended of a telephone handset housing; FIG. 2 is a rear view thereof; FIG. 3 is a right view thereof; FIG. 4 is a rear view thereof with a flip extended; FIG. 5 is a right view thereof with a flip extended; FIG. 6 is a bottom view thereof with a flip extended; FIG. 7 is a top view thereof; and, FIG. 8 is a top, front, left perspective of the telephone handset housing.

The broken line disclosure throughout the views is for illustrative purposes only and forms no part of the claimed design.

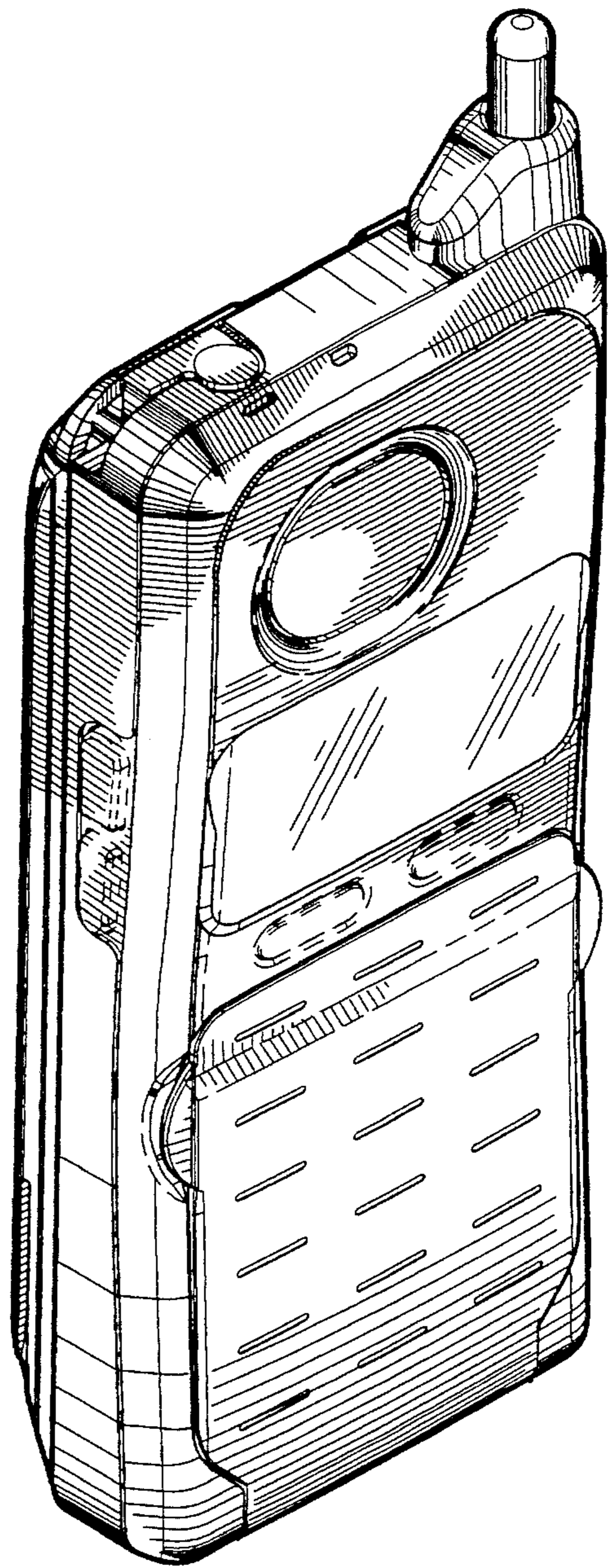
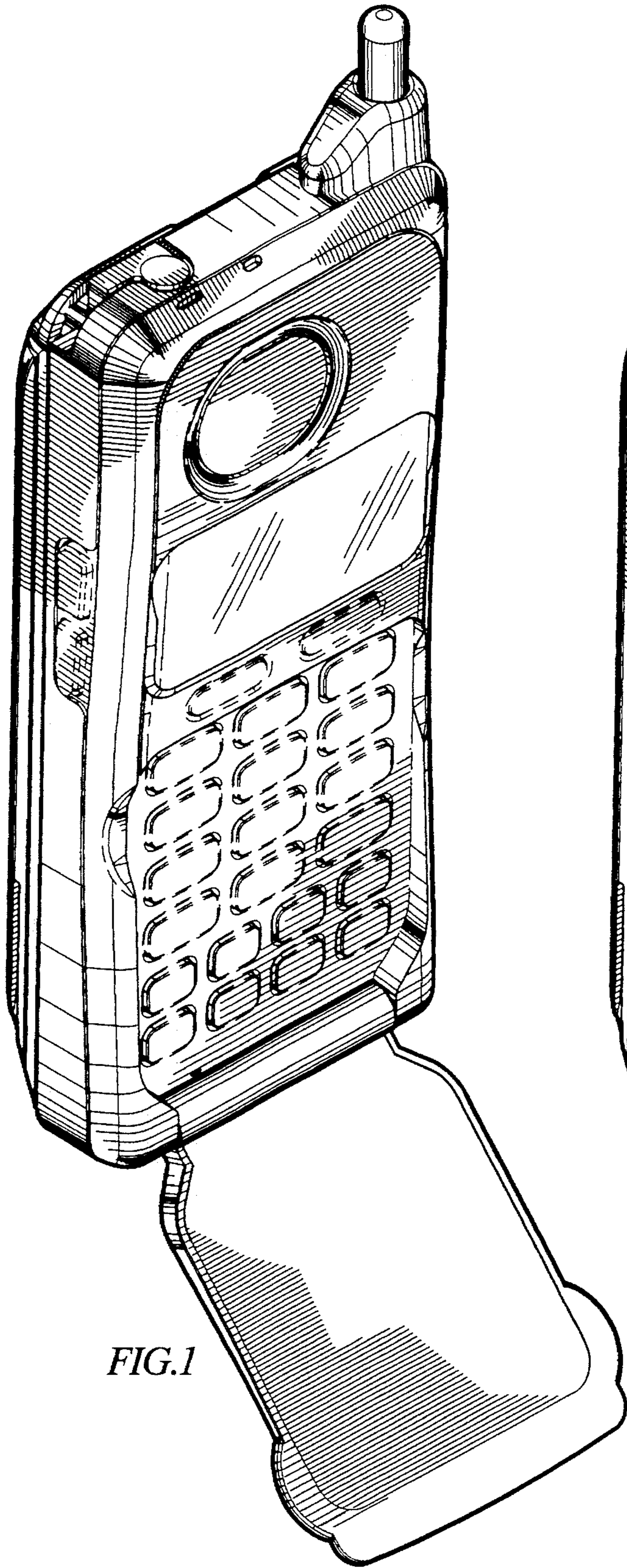

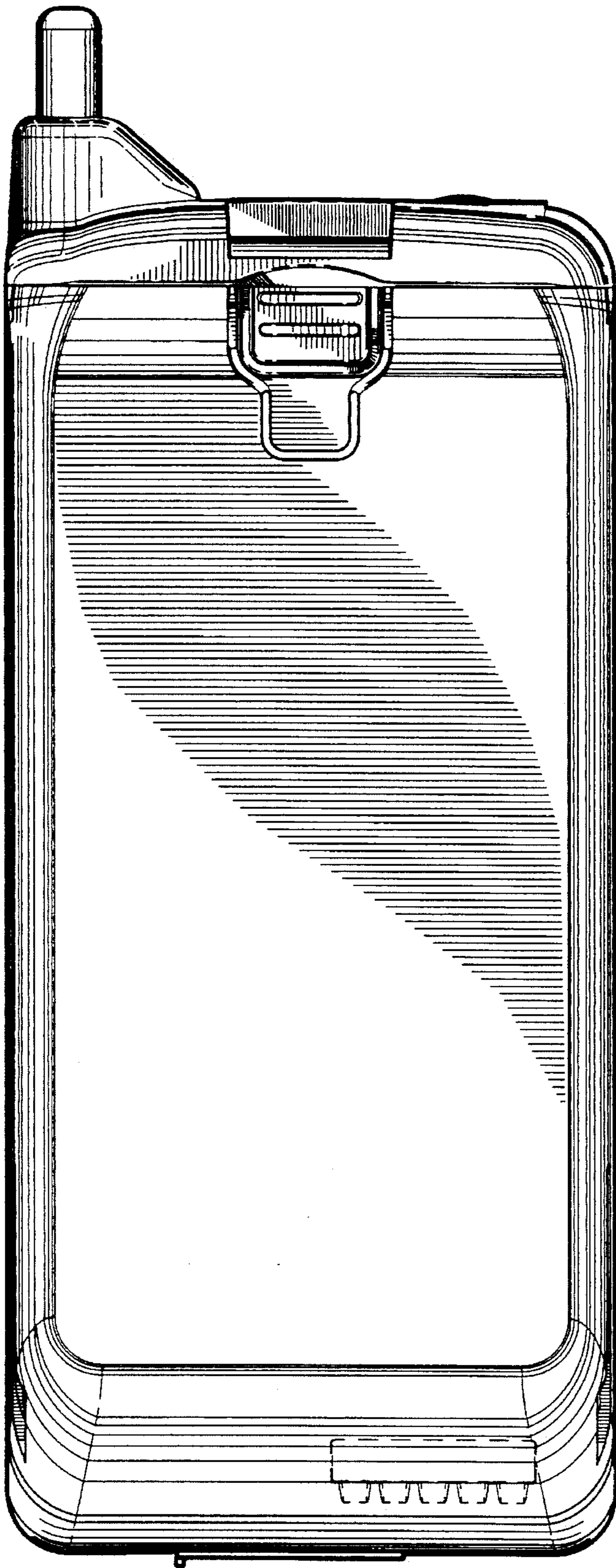

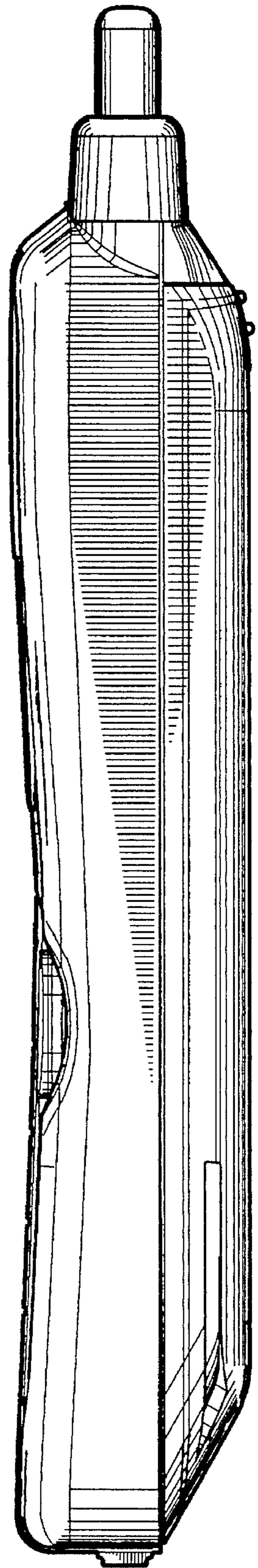

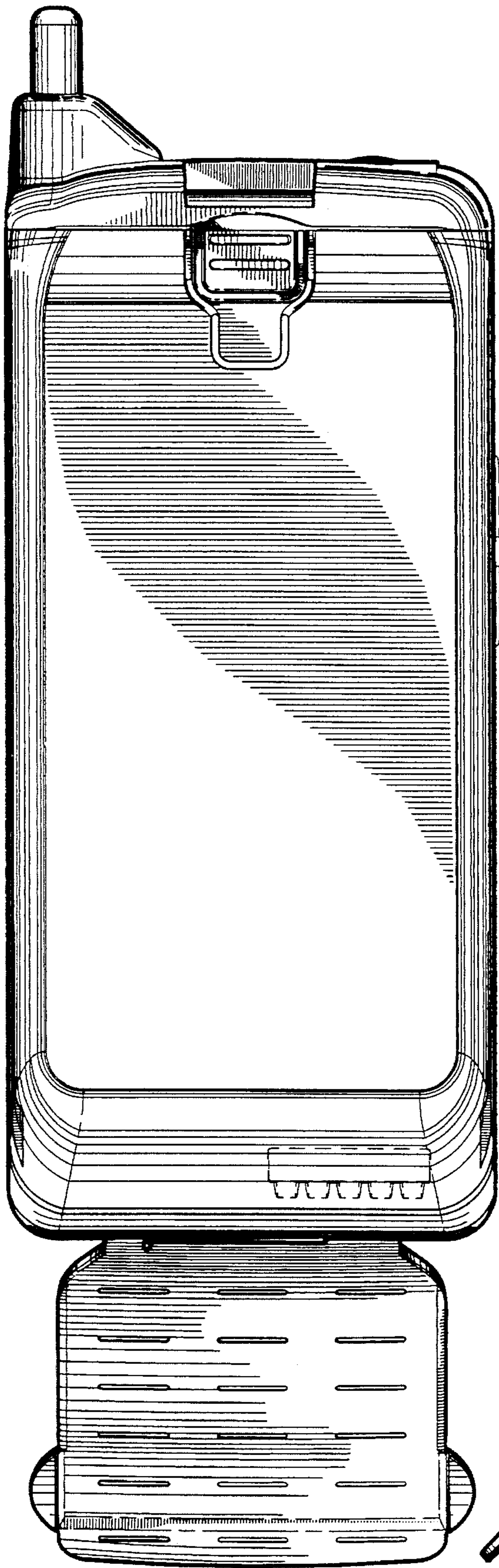

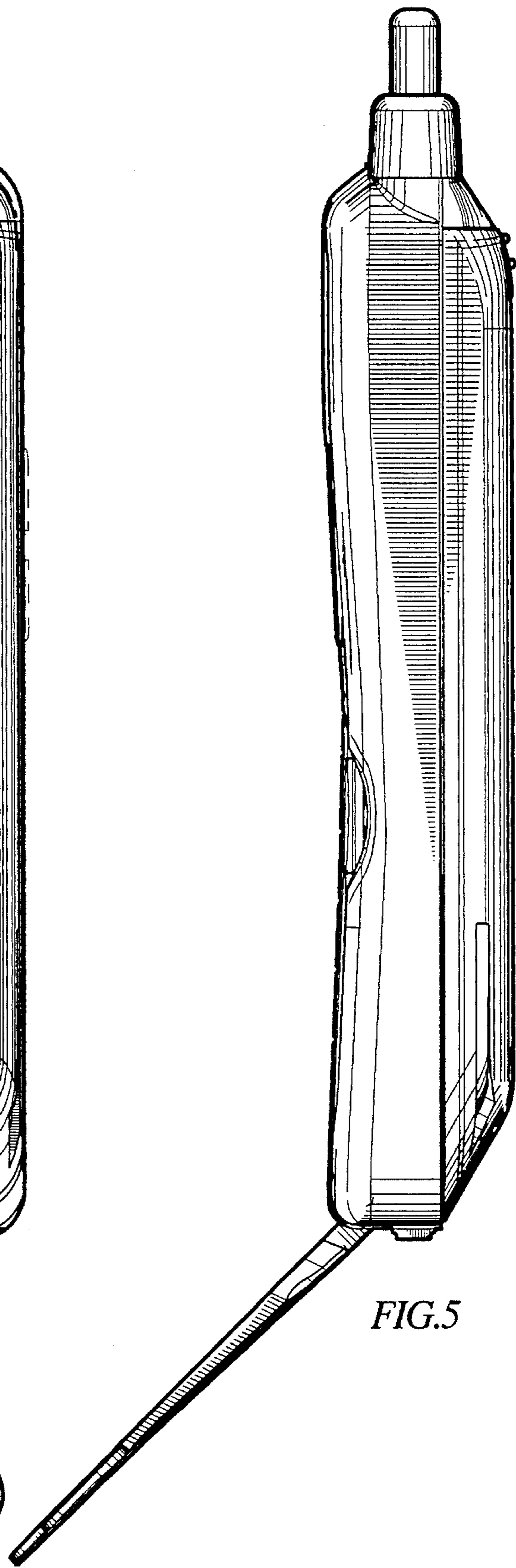

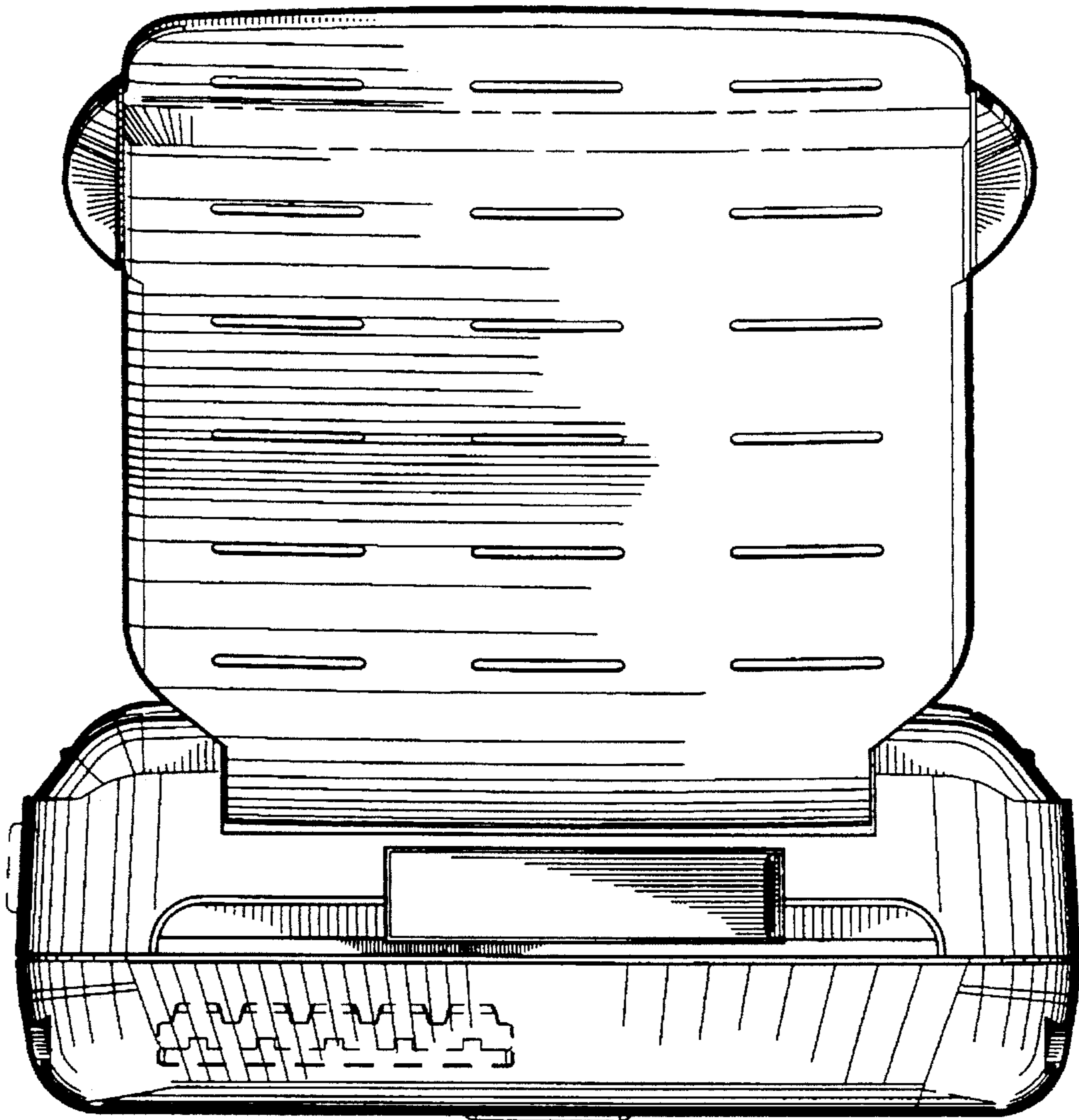

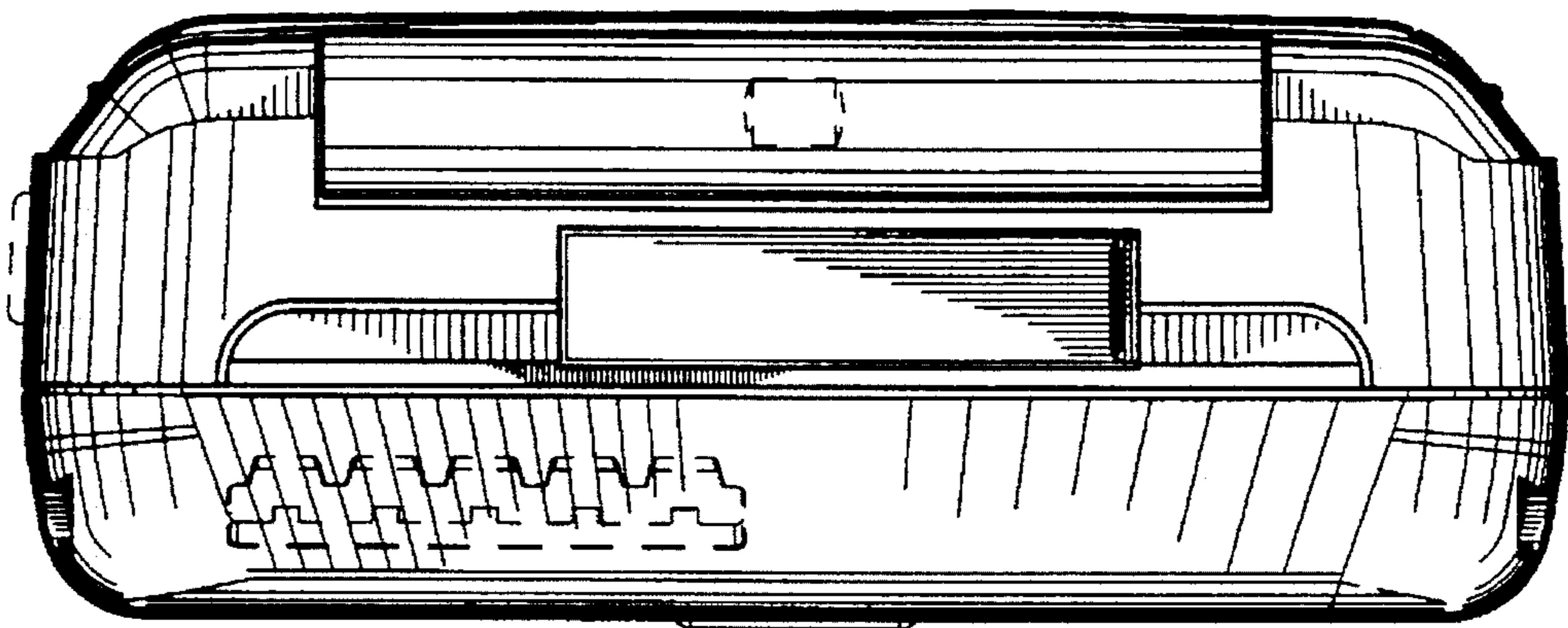
