FIG. 13 is a front elevational view thereof; and,

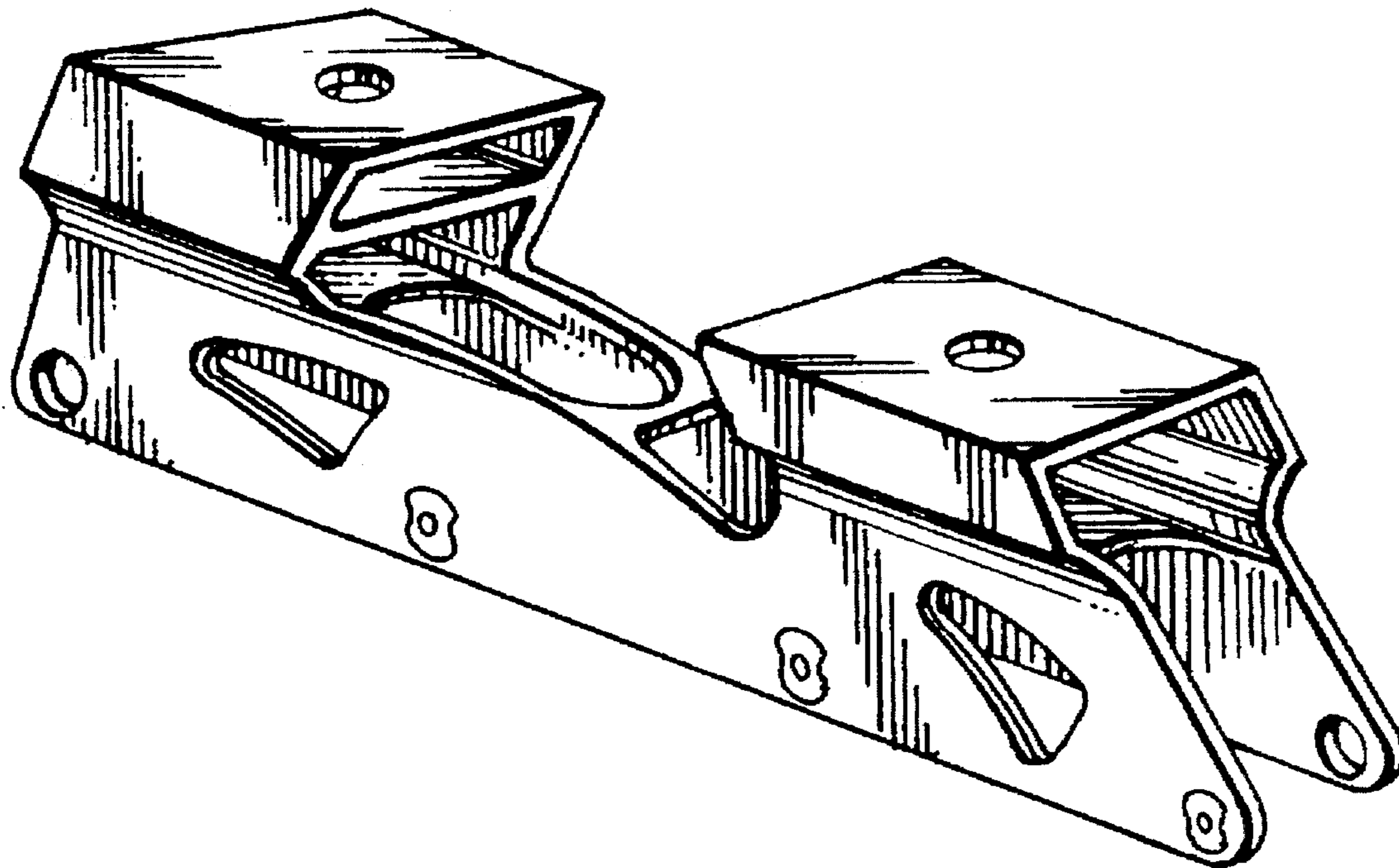
FIG. 14 is a perspective view thereof.

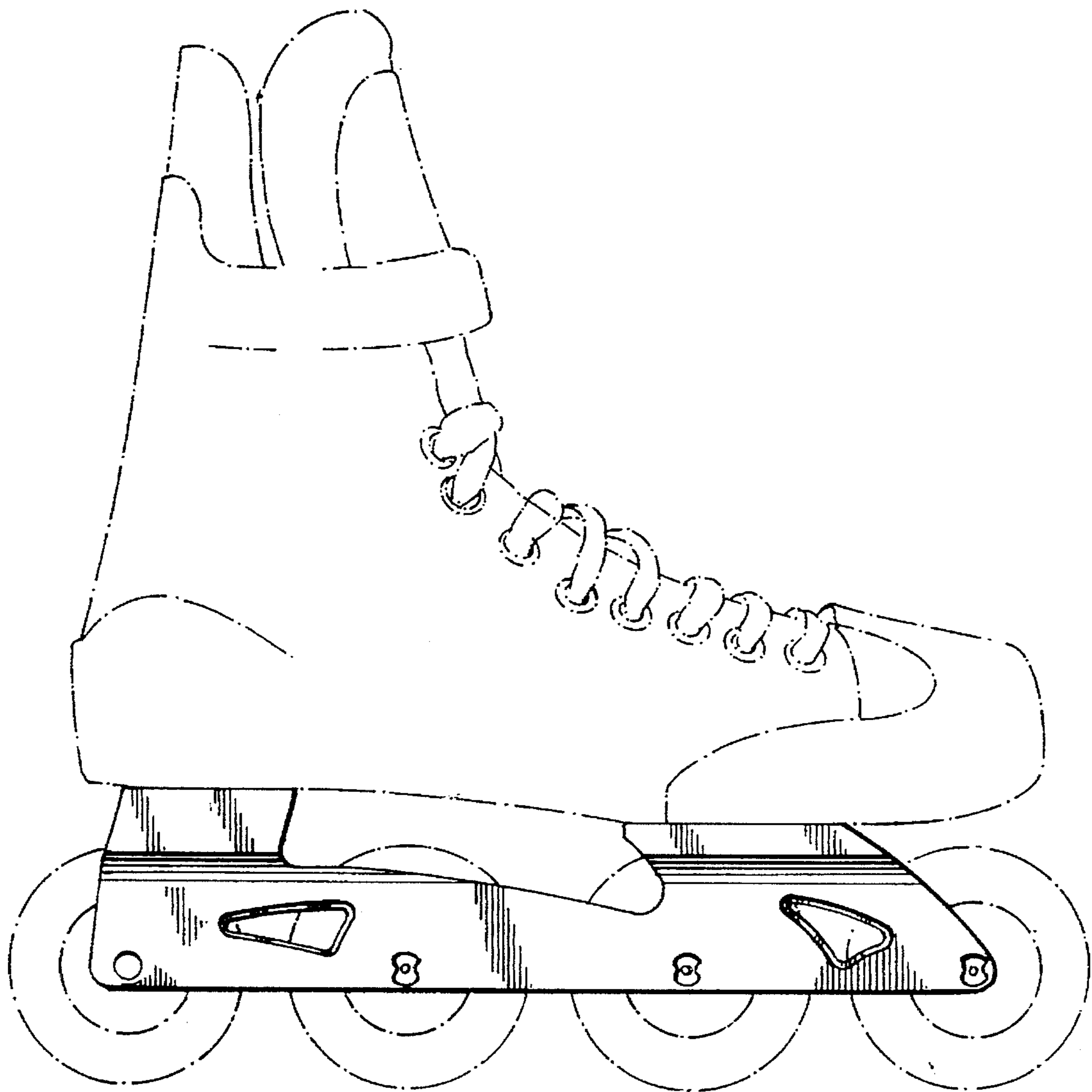

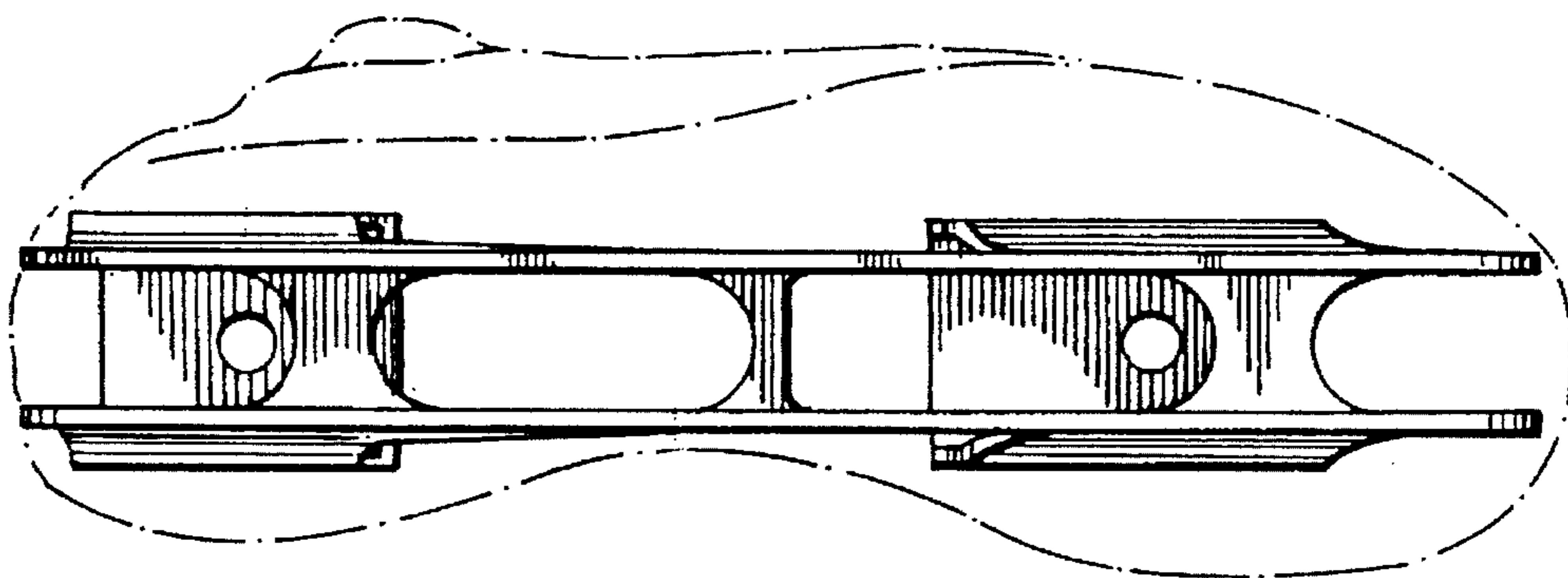

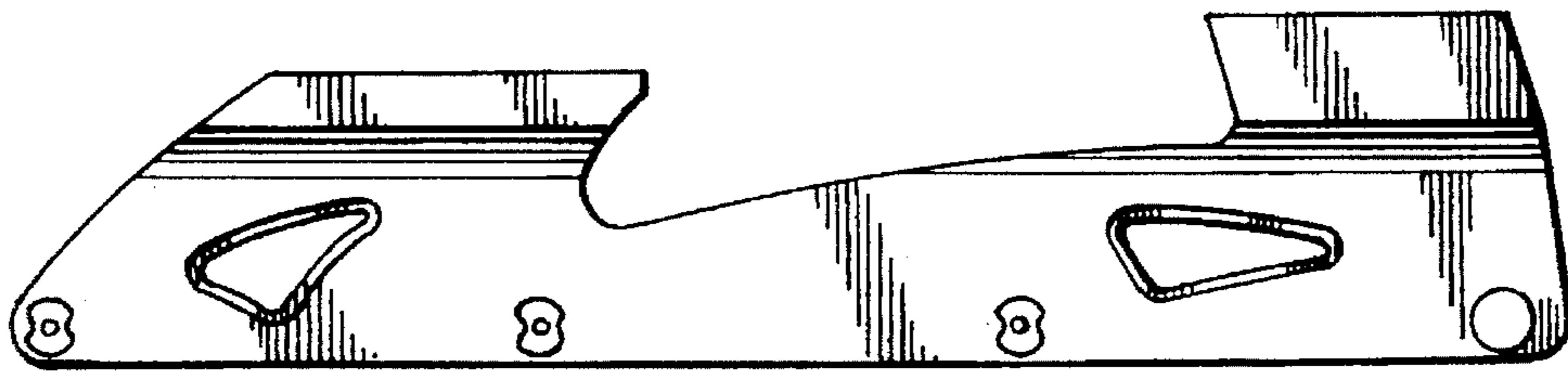

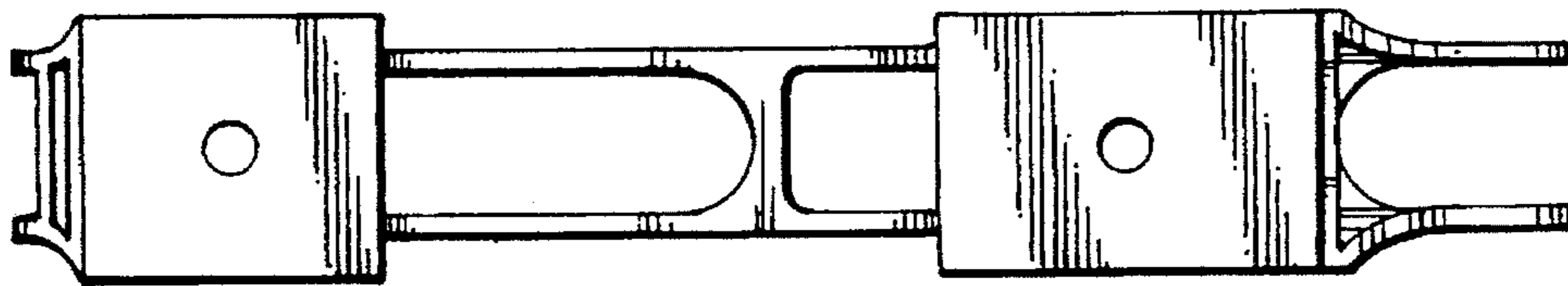

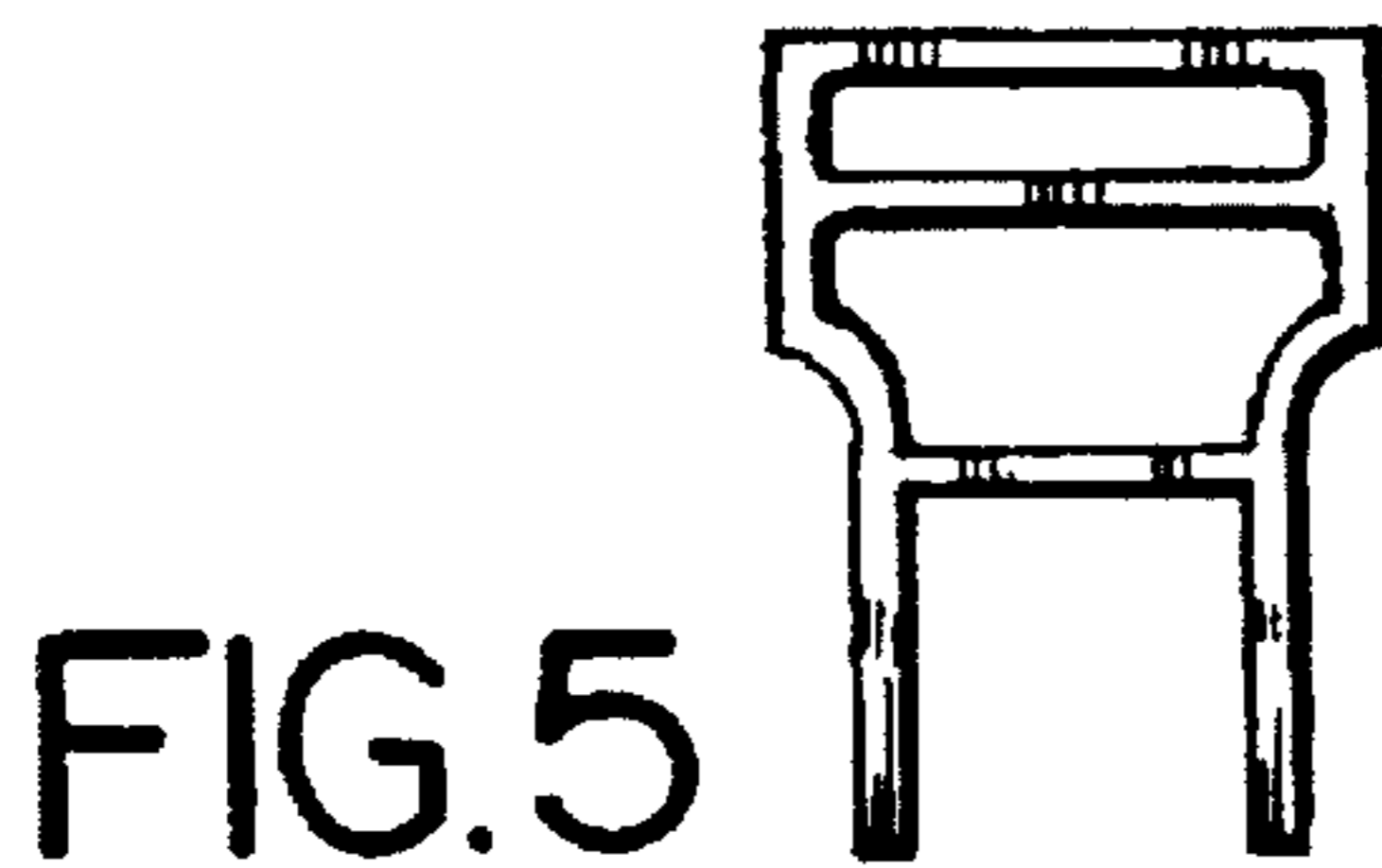

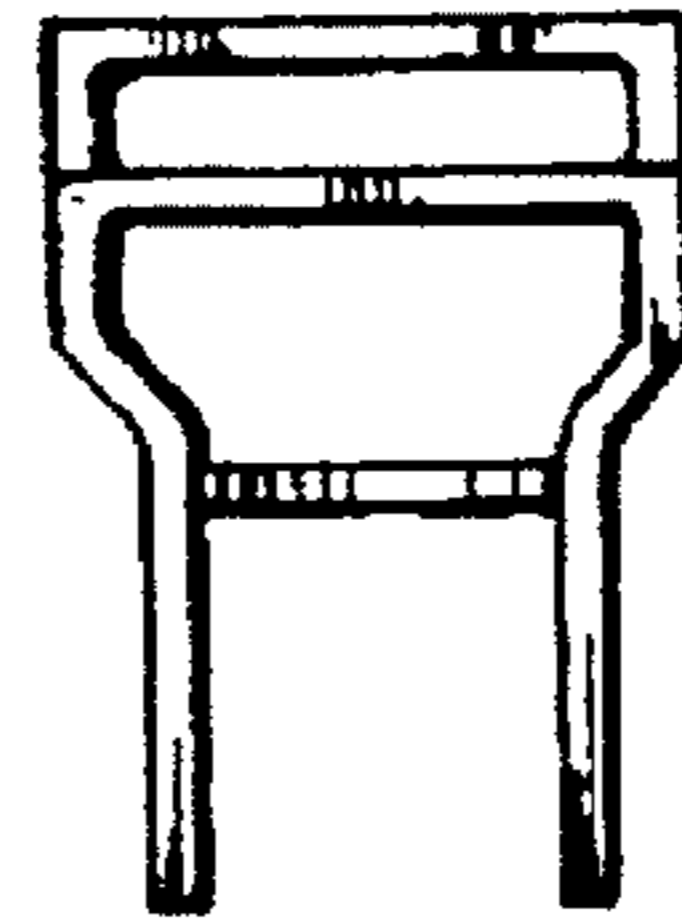

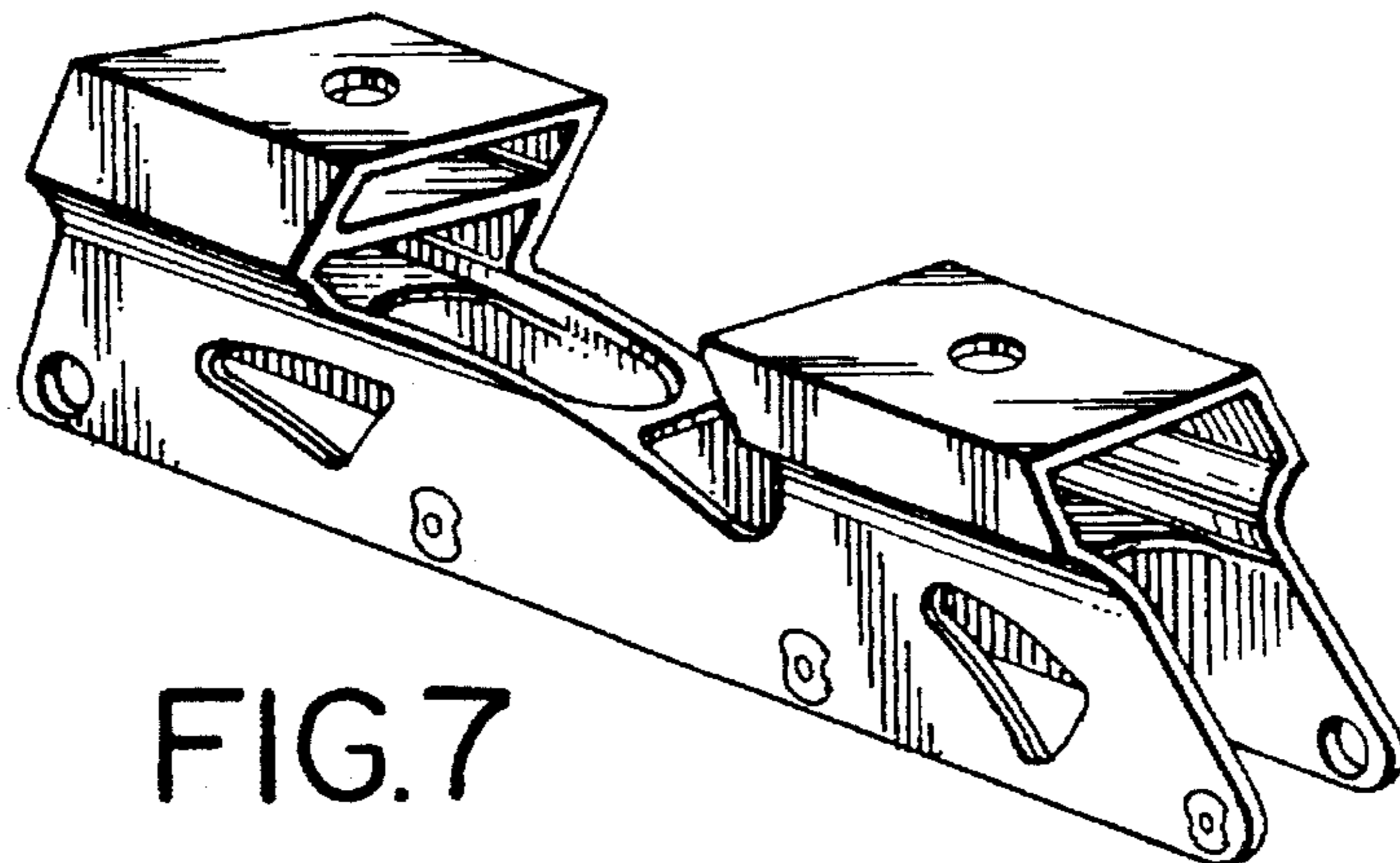

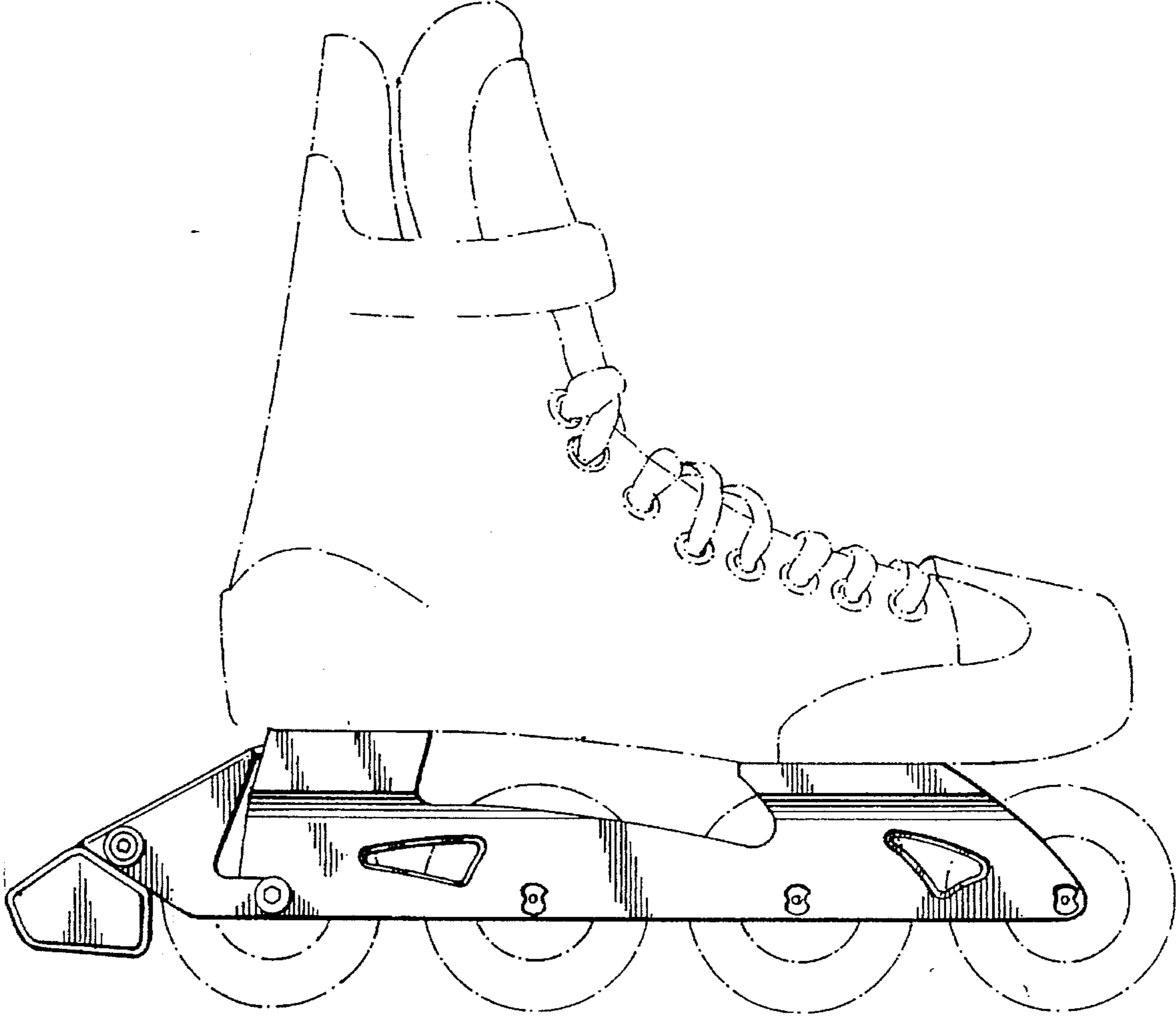

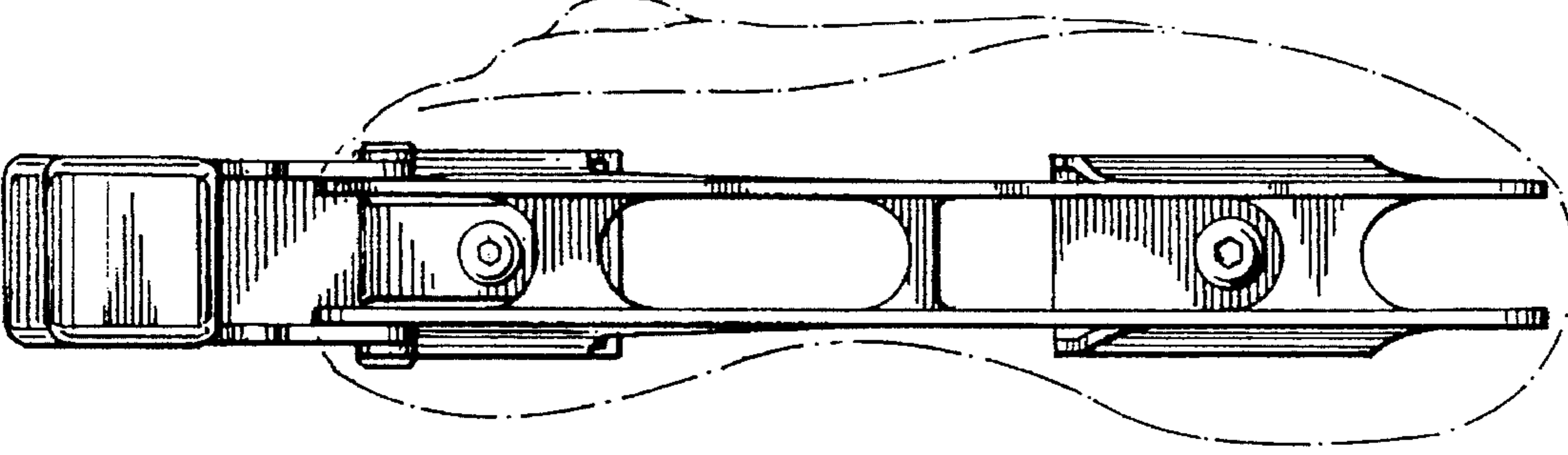

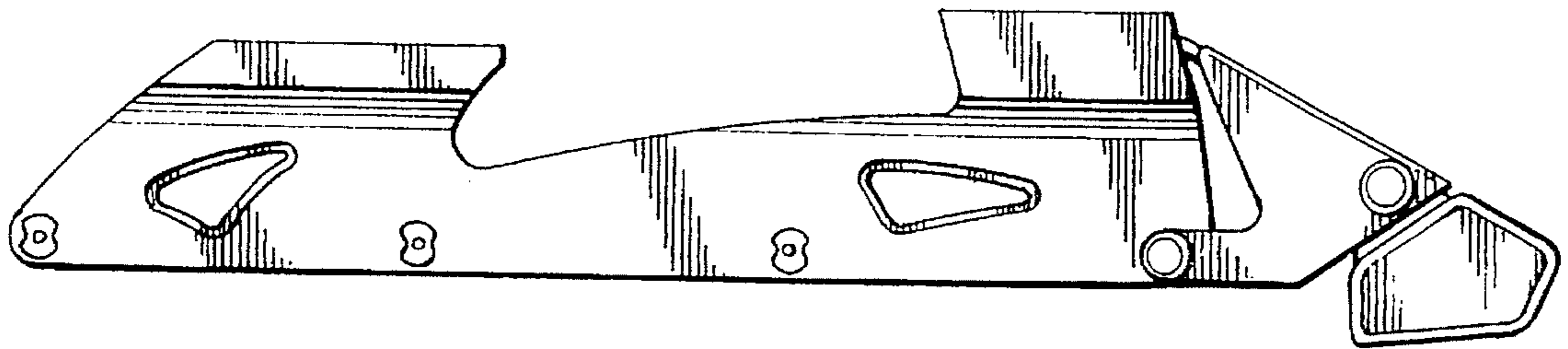

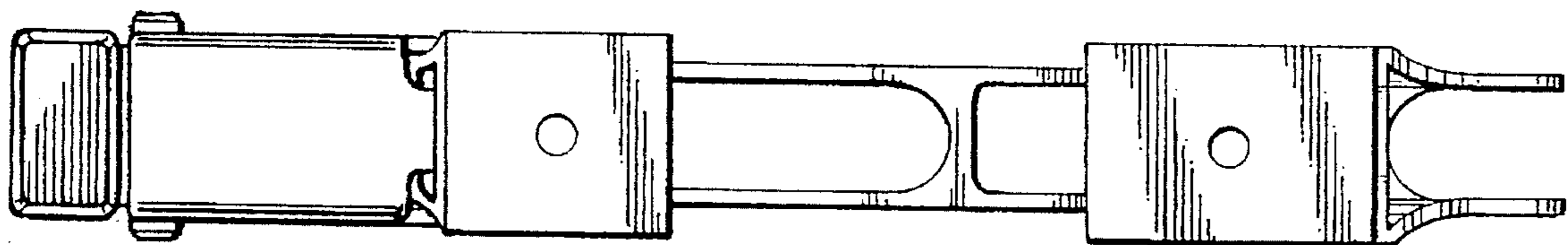

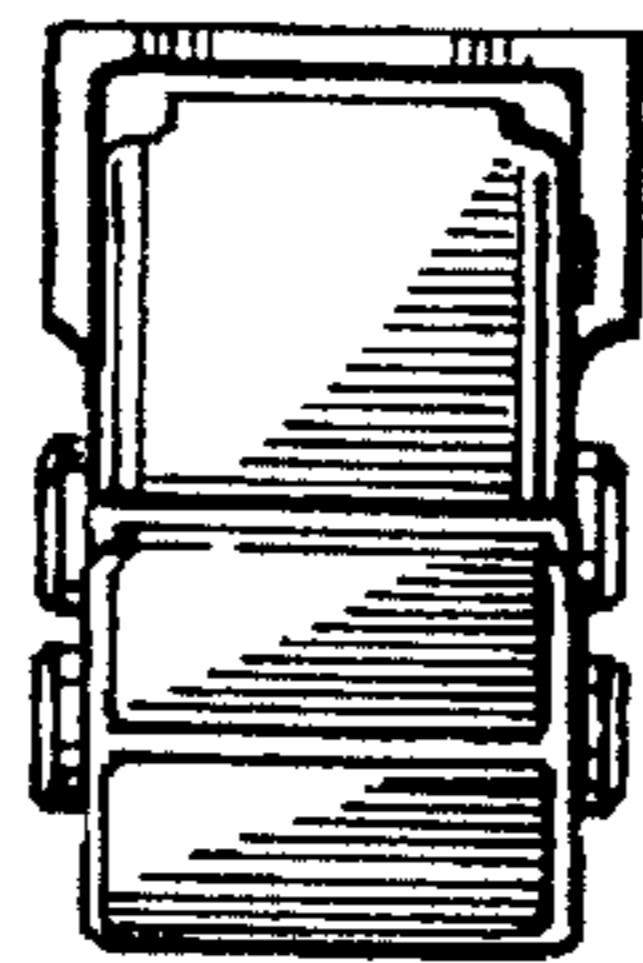

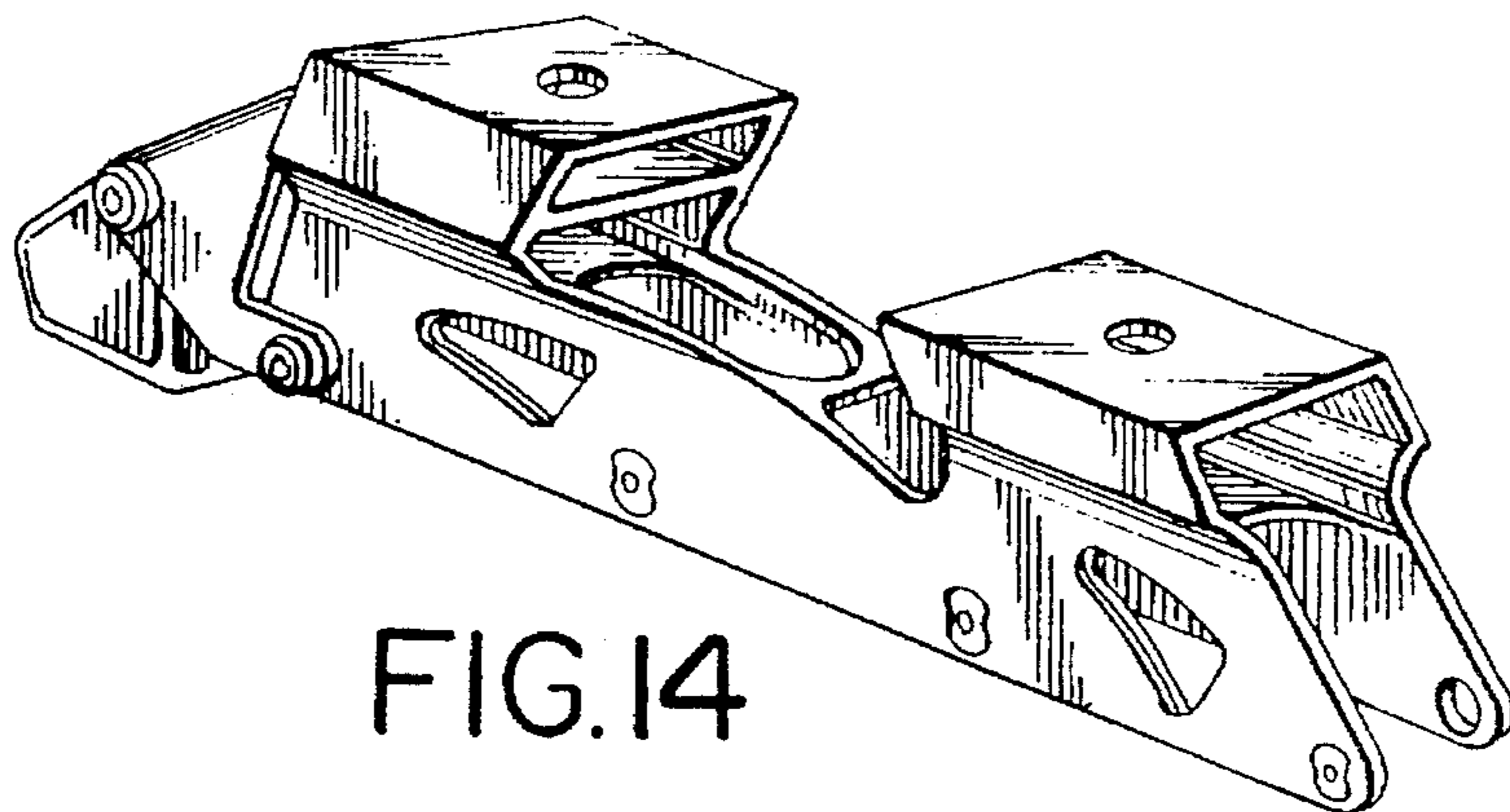
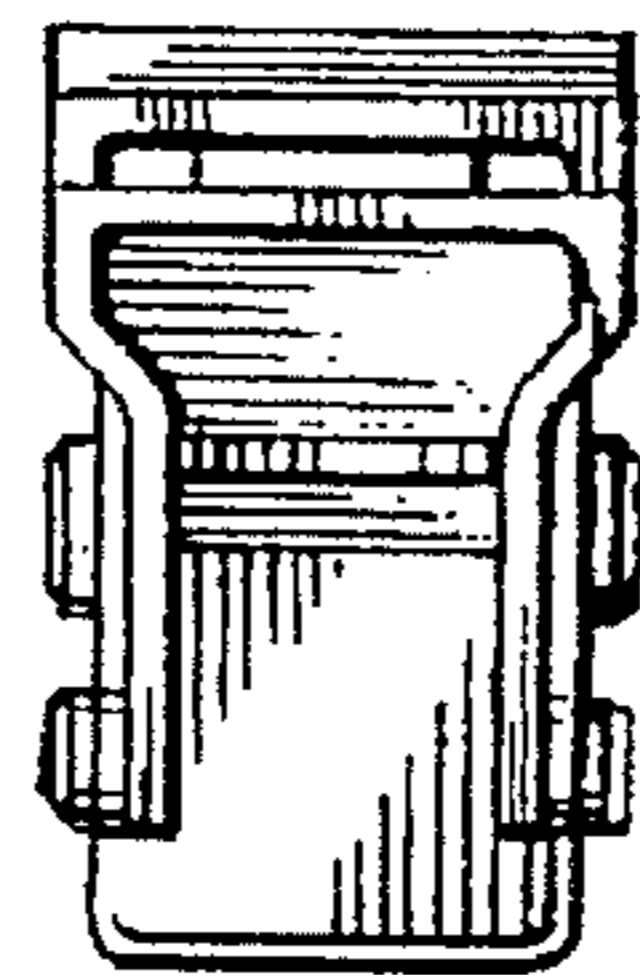
