[57] **CLAIM**

The ornamental design for a hamper, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a hamper showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

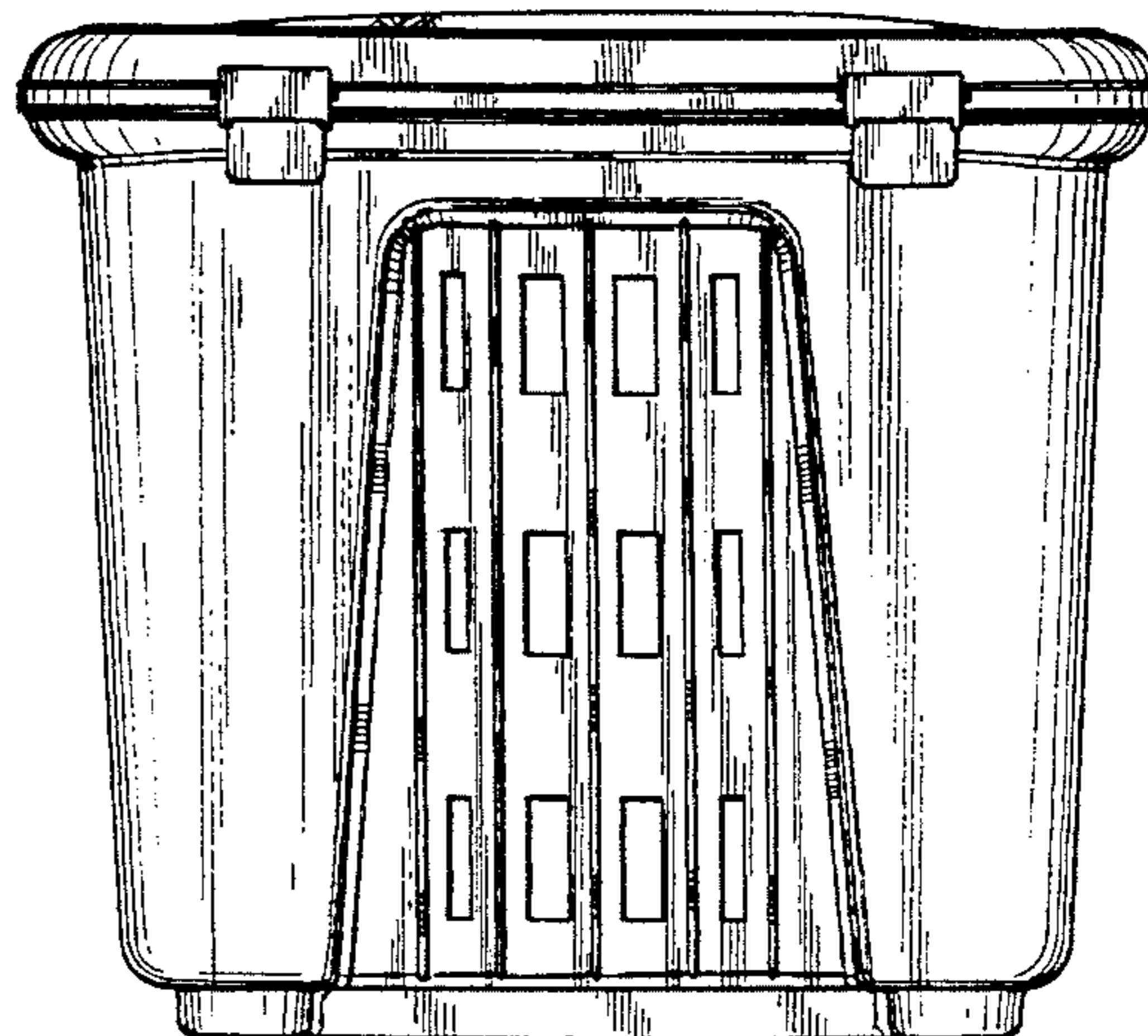
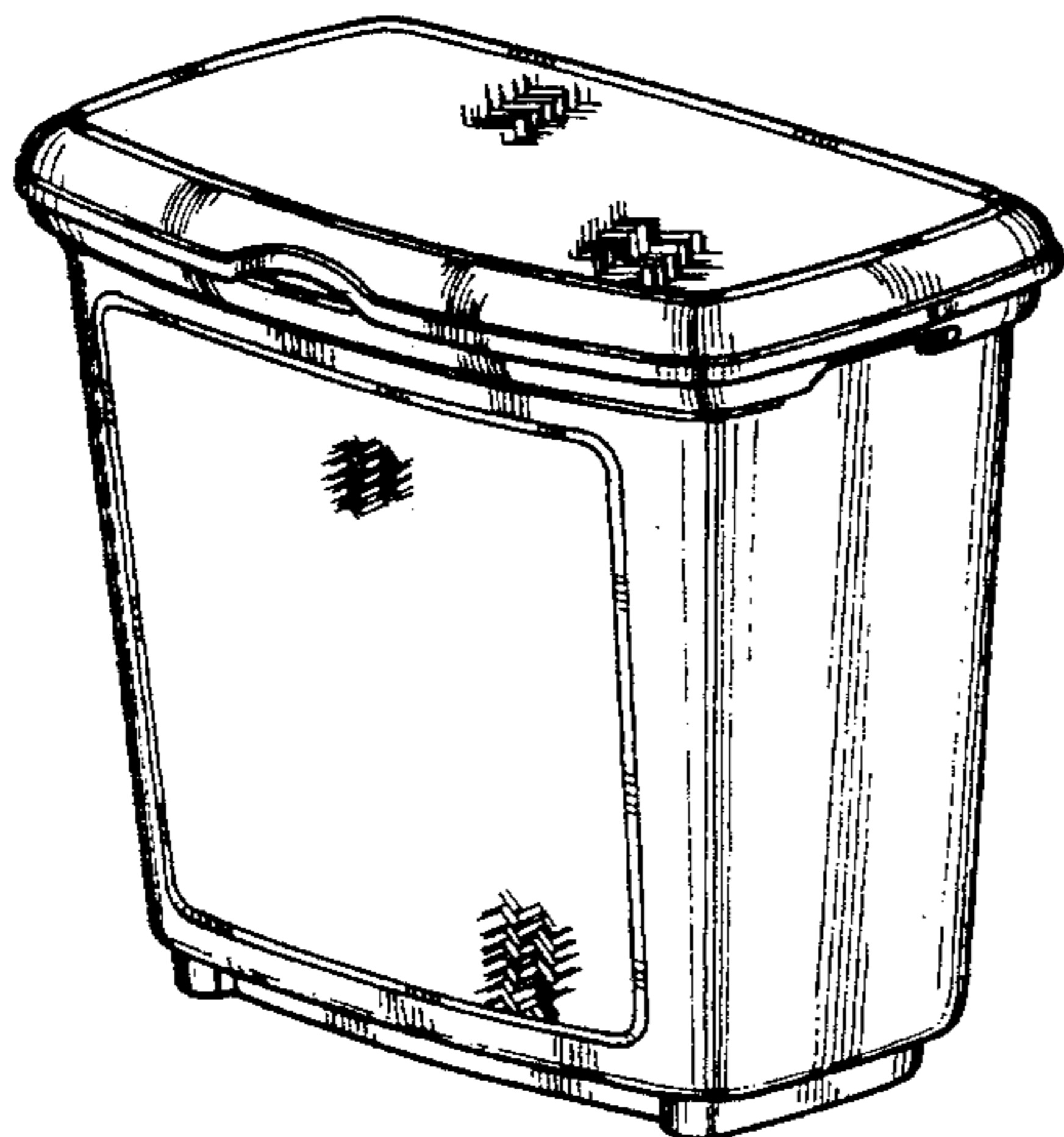
FIG. 4 is a top plan view thereof;

FIG. 6 is a right side elevational view thereof; the left side elevational view being a mirror image.

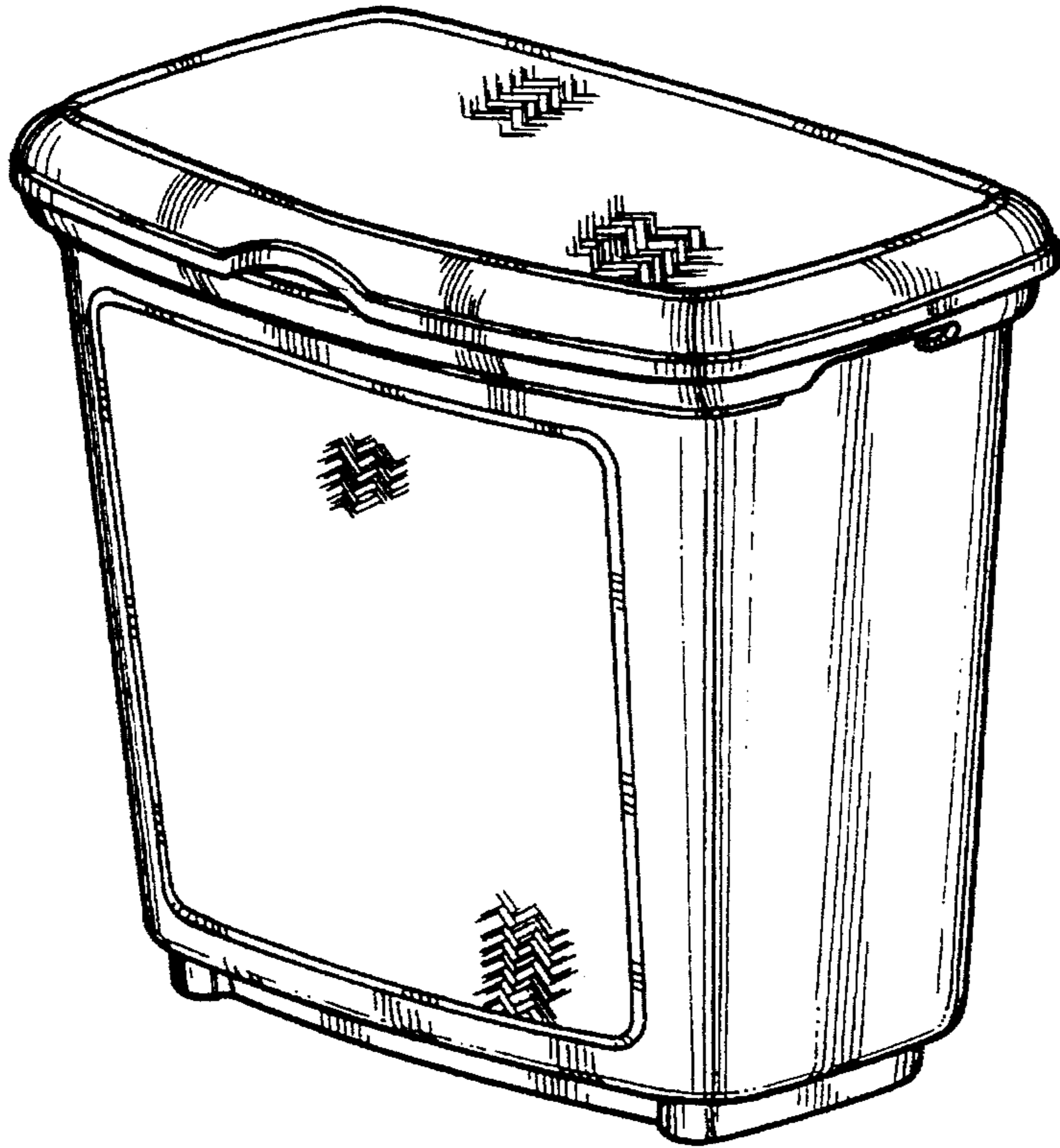

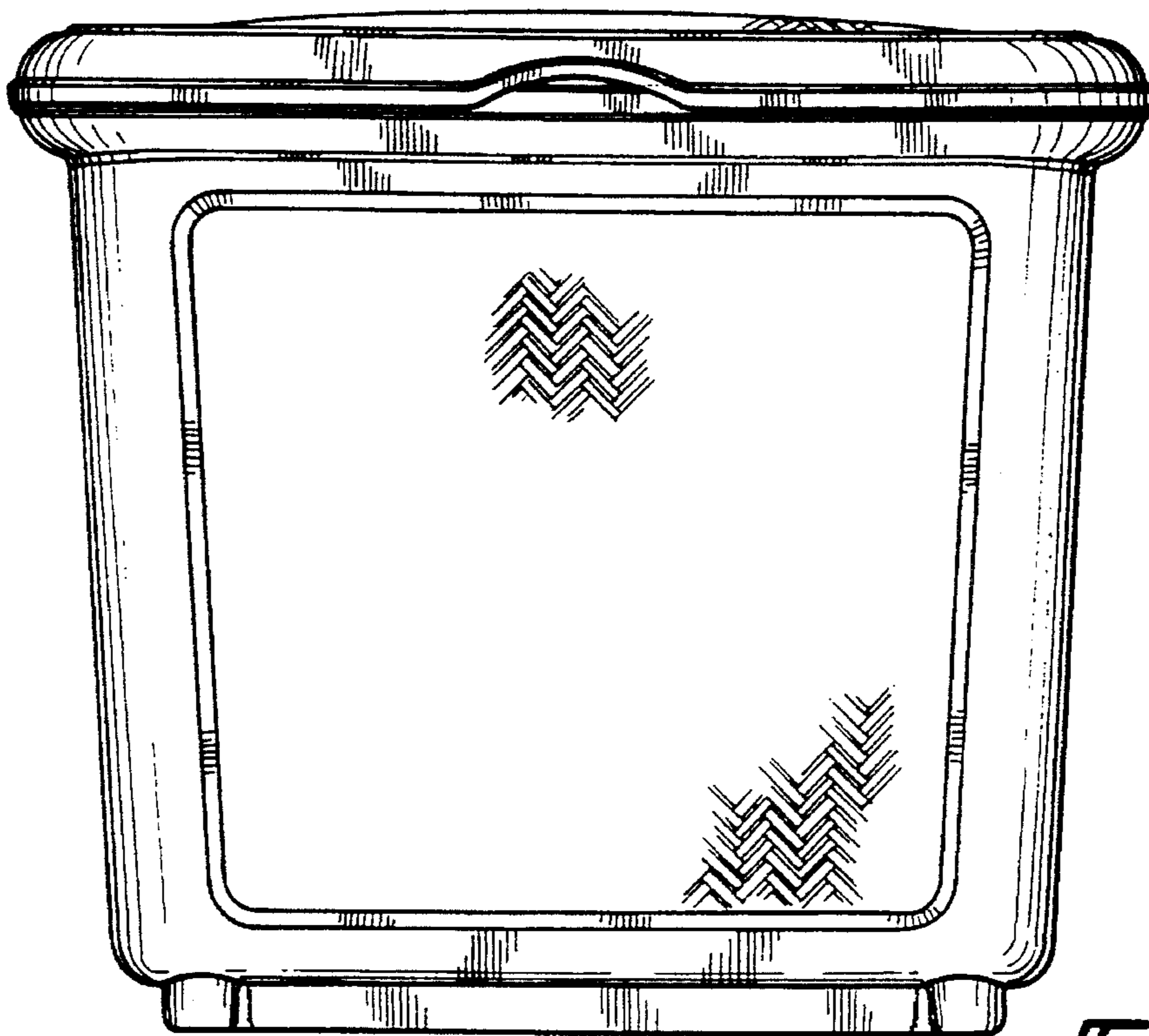

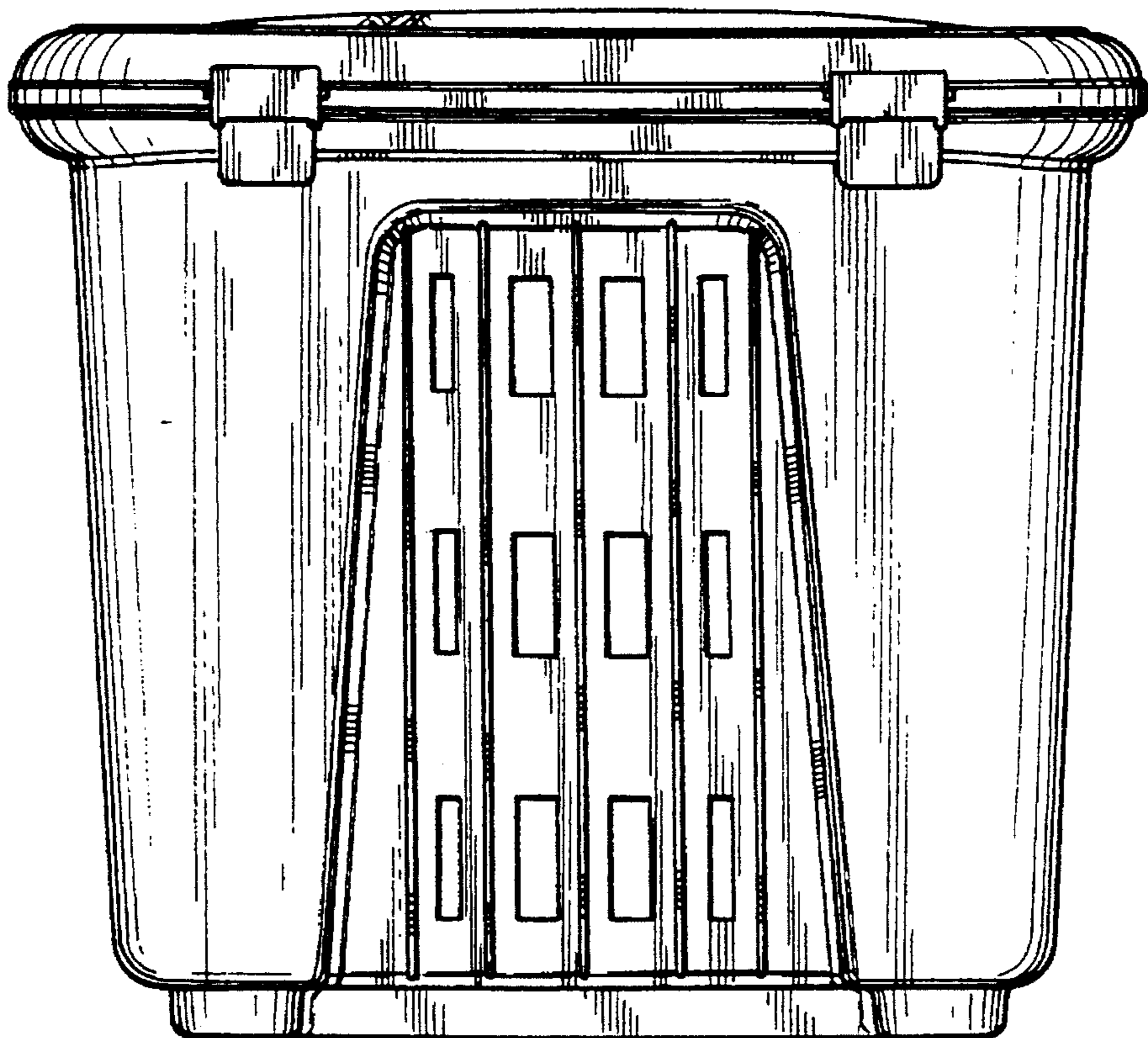

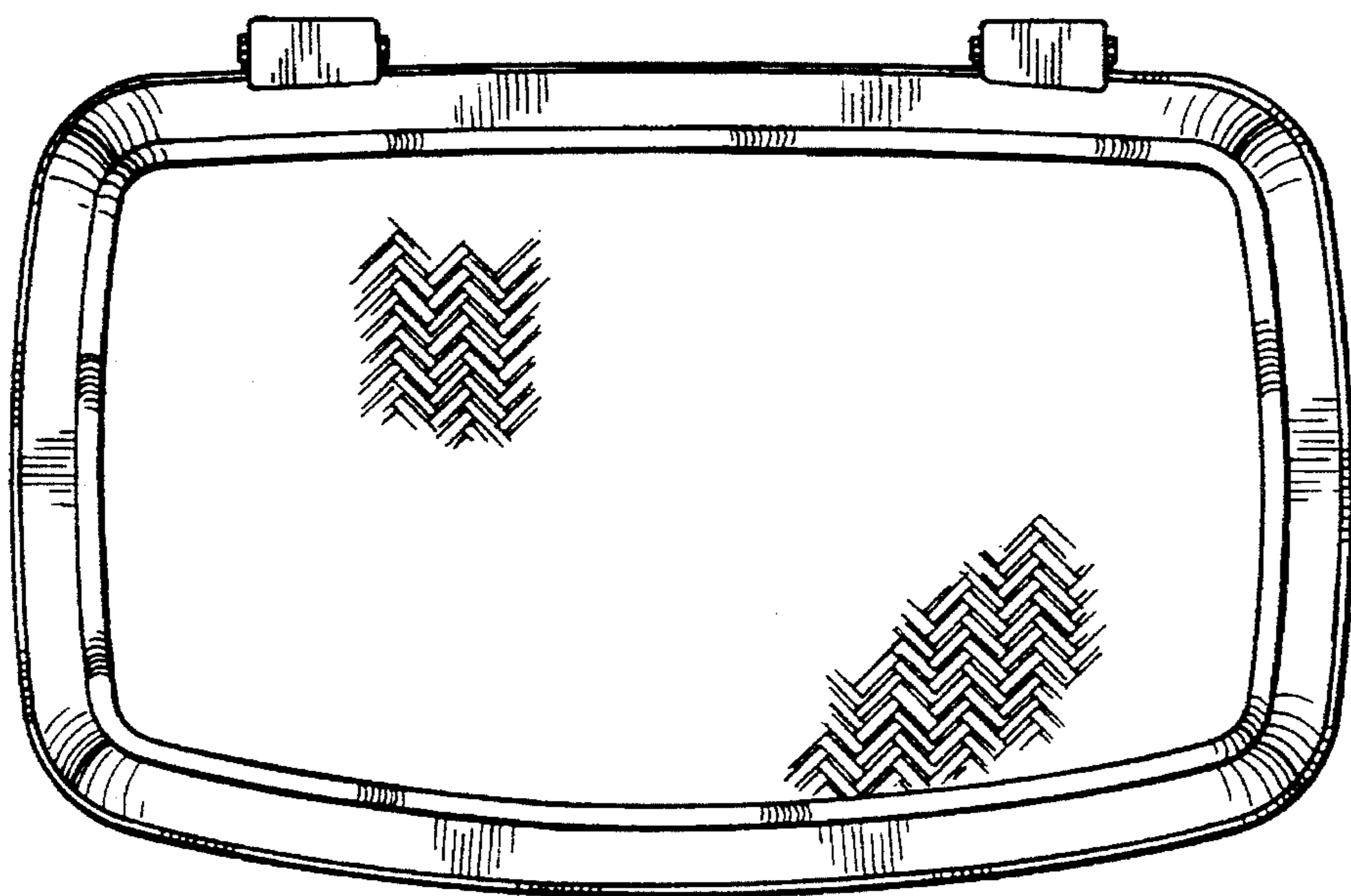

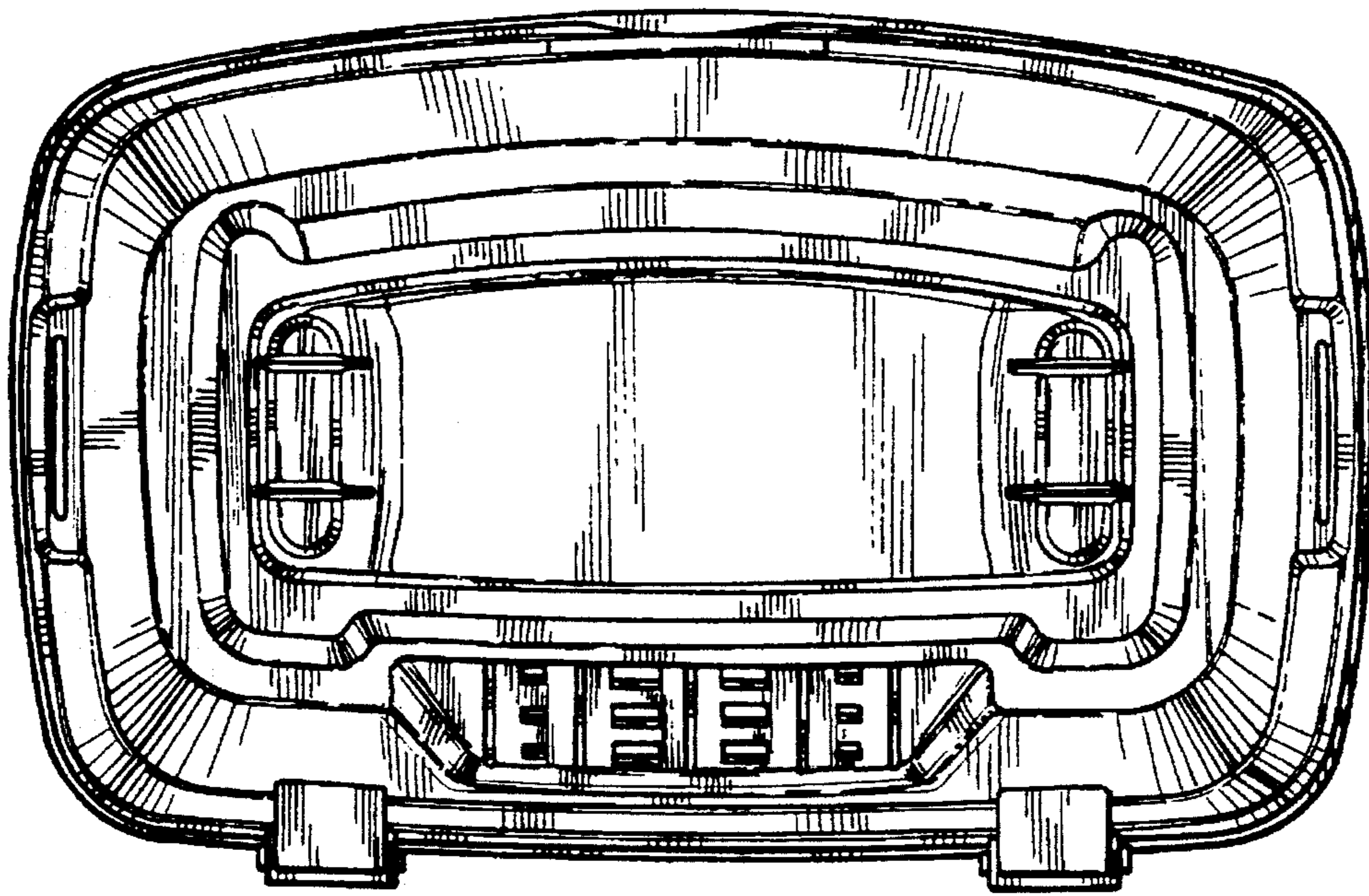

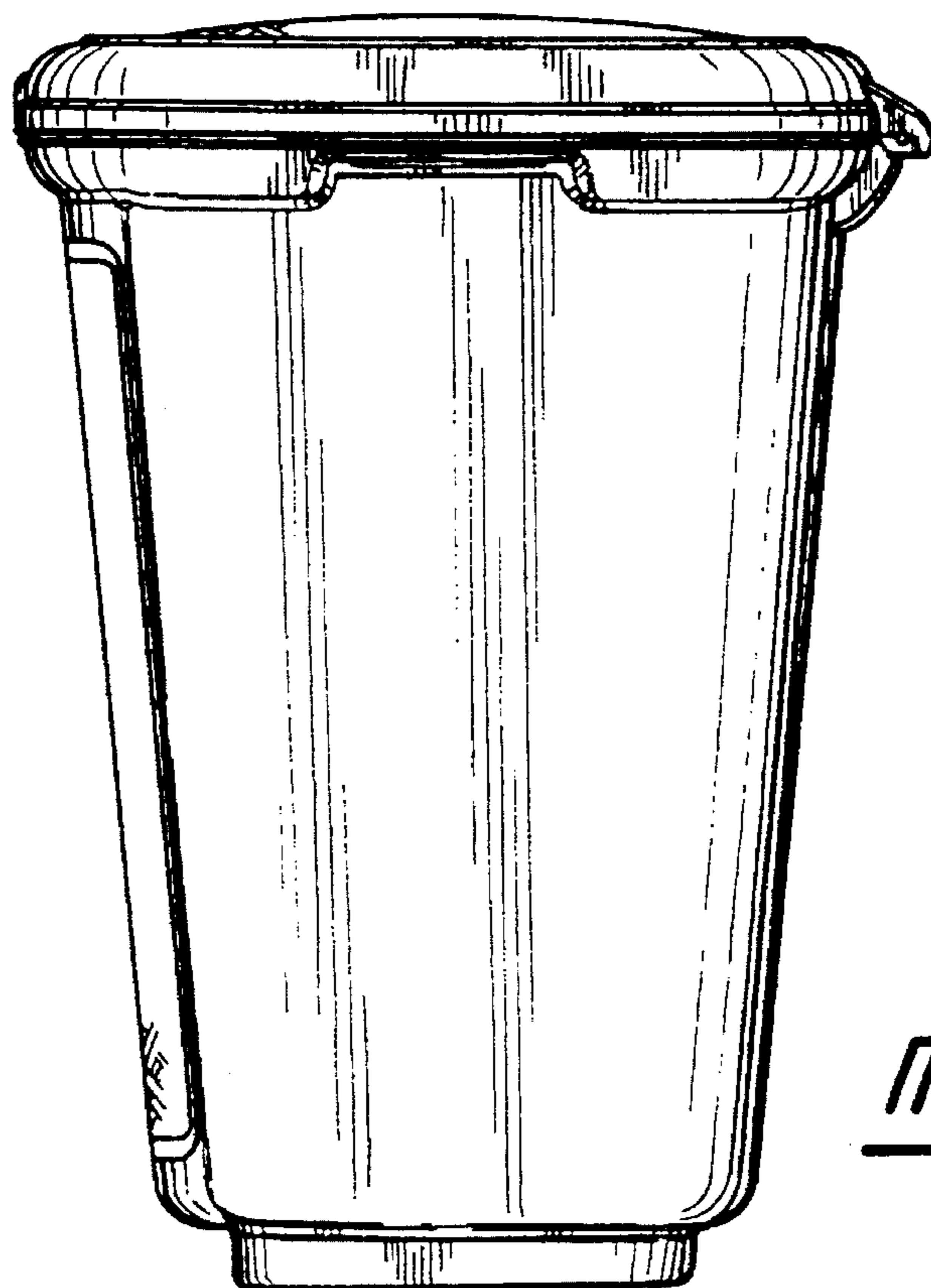
