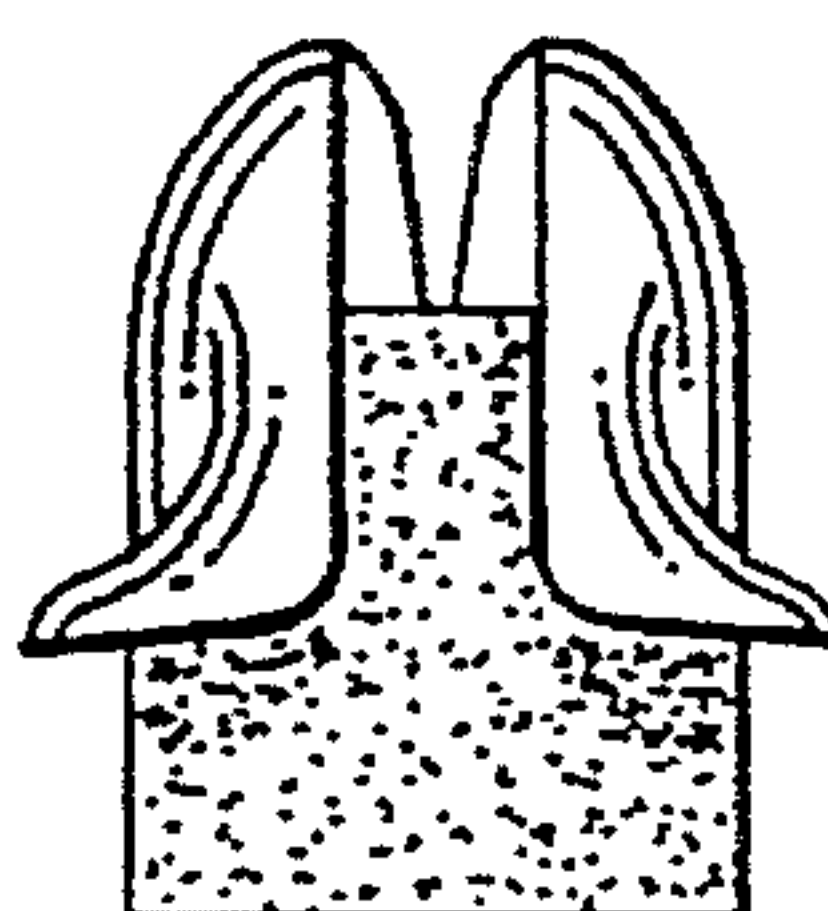
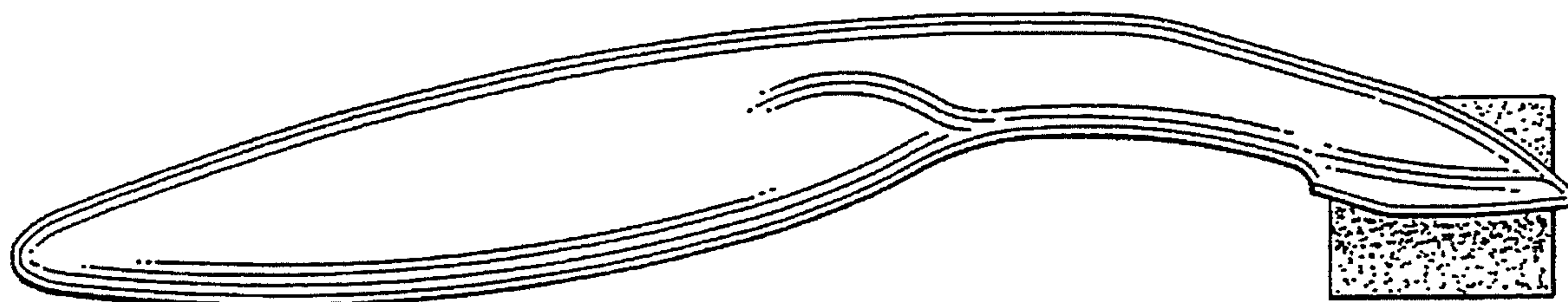
[57] CLAIM

The ornamental design for a combined swab and handle, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of my combined swab and handle, showing my new design, the opposite side being a mirror image thereof;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a left-side elevational view thereof; and,
 FIG. 5 is a right-side elevational view thereof.

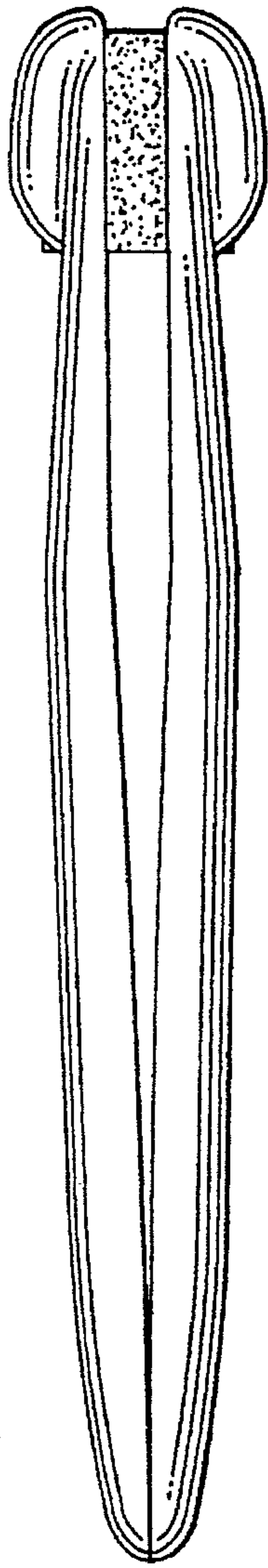

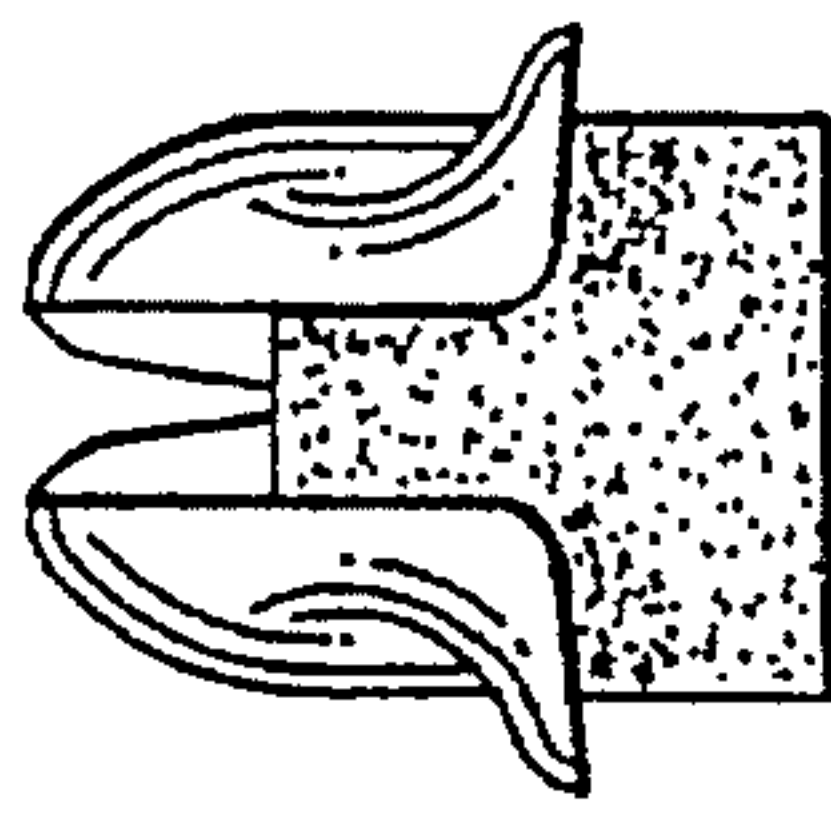

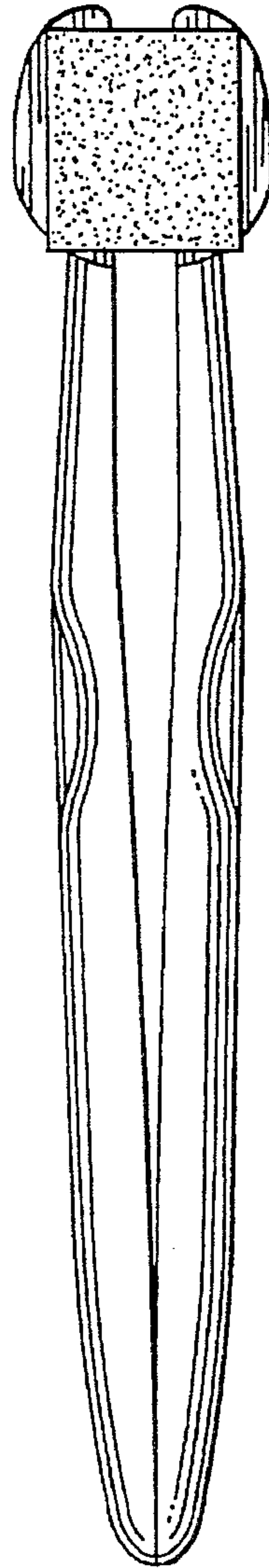

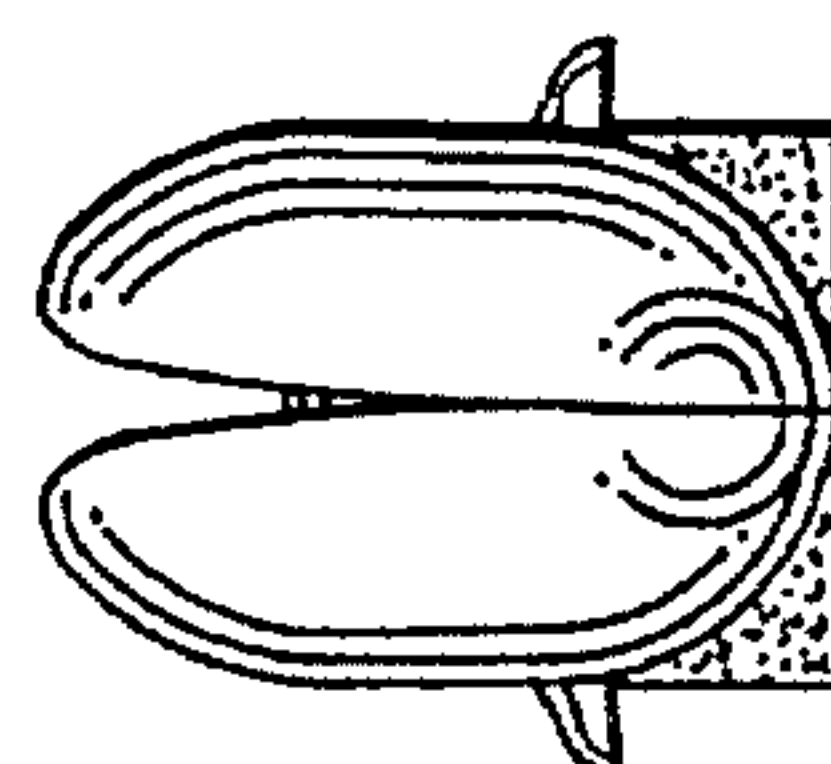
