FIG. 1 is a perspective view of a sofa showing our new design;

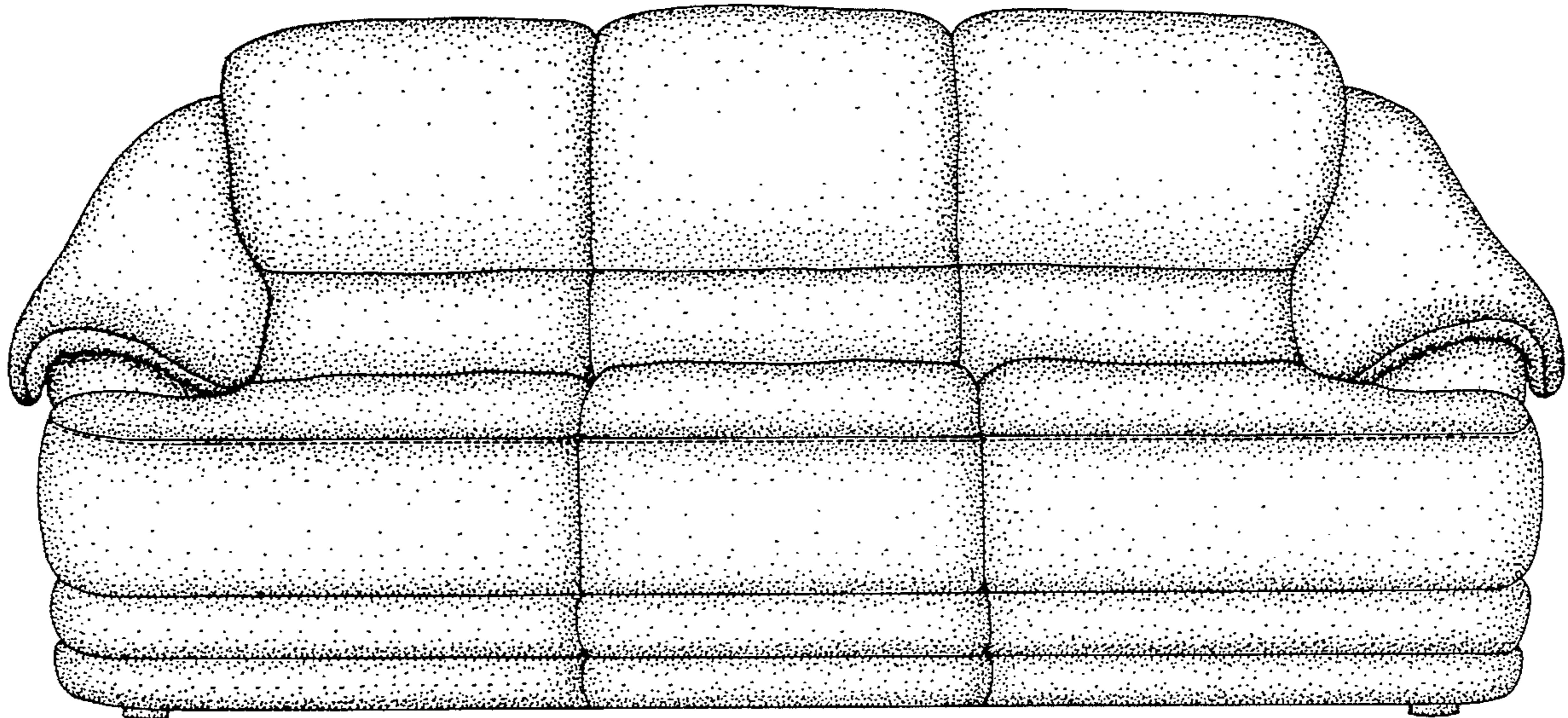
FIG. 2 is a front elevational view;

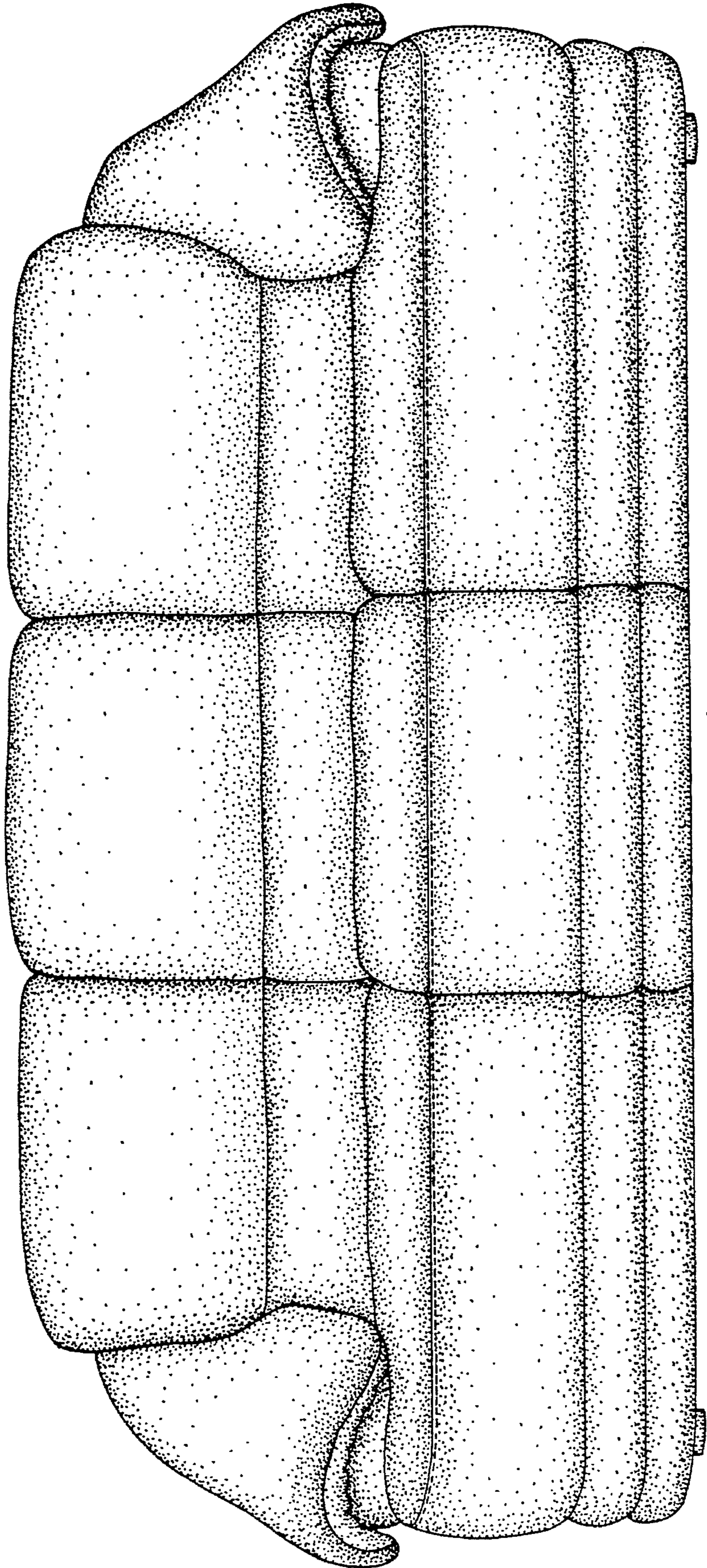
FIG. 3 is a top plan view;

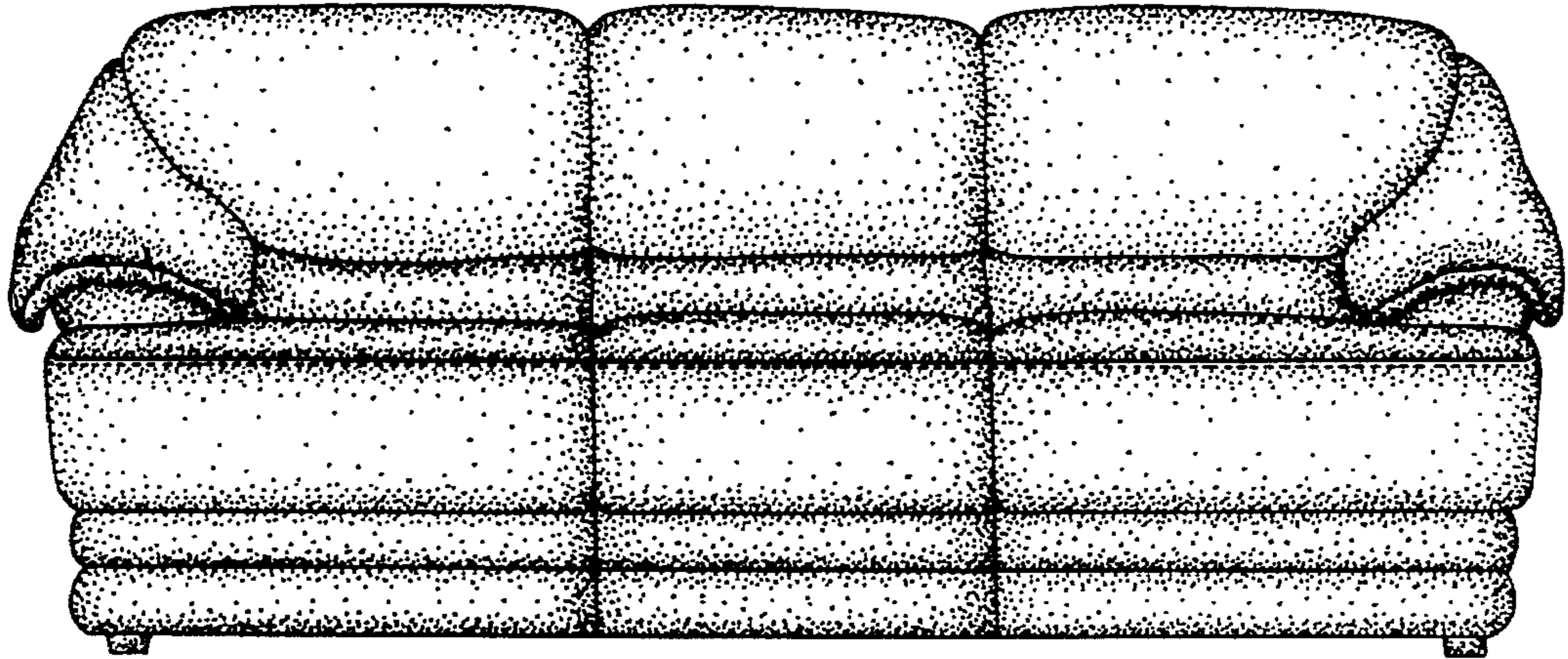

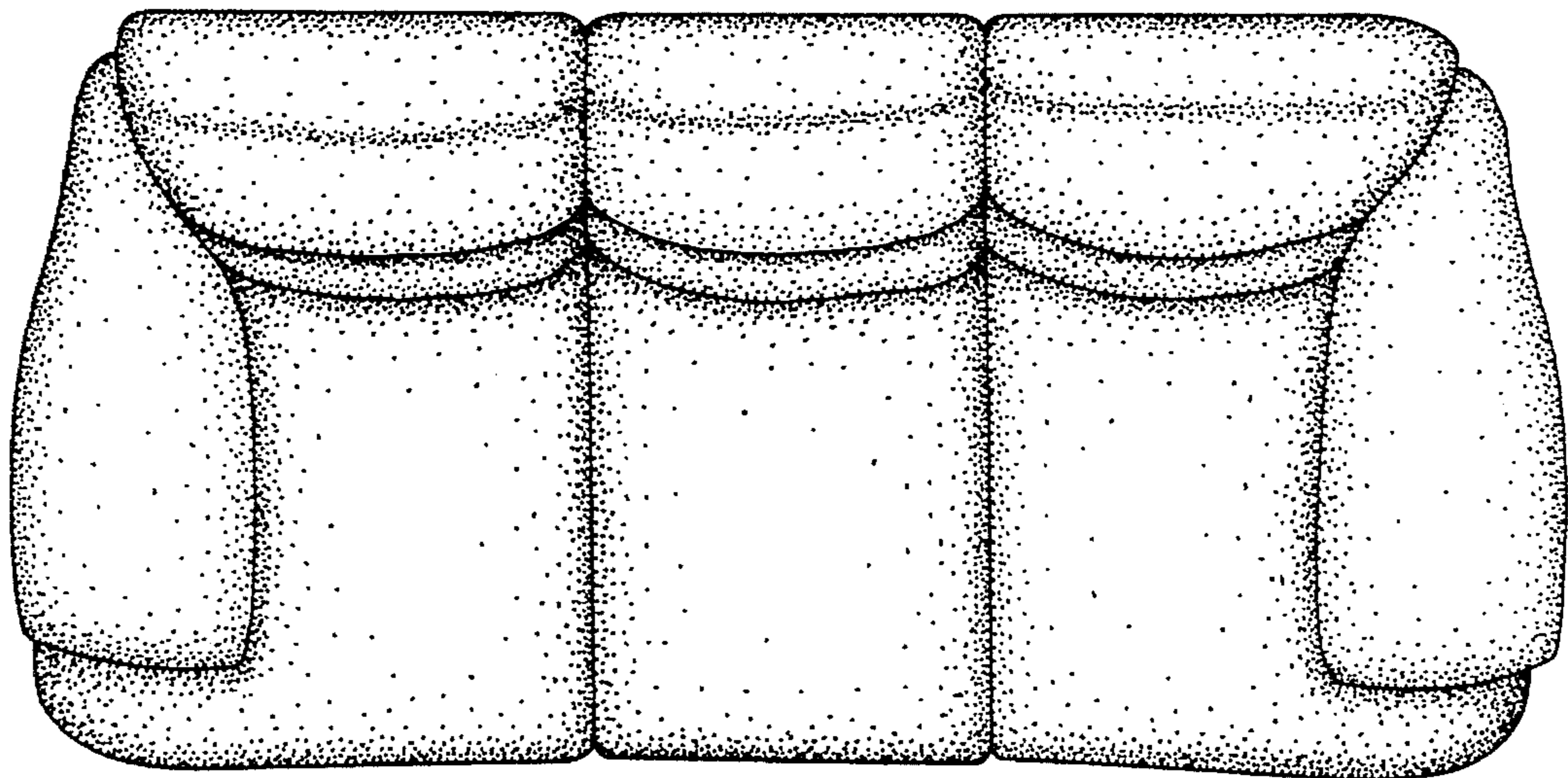

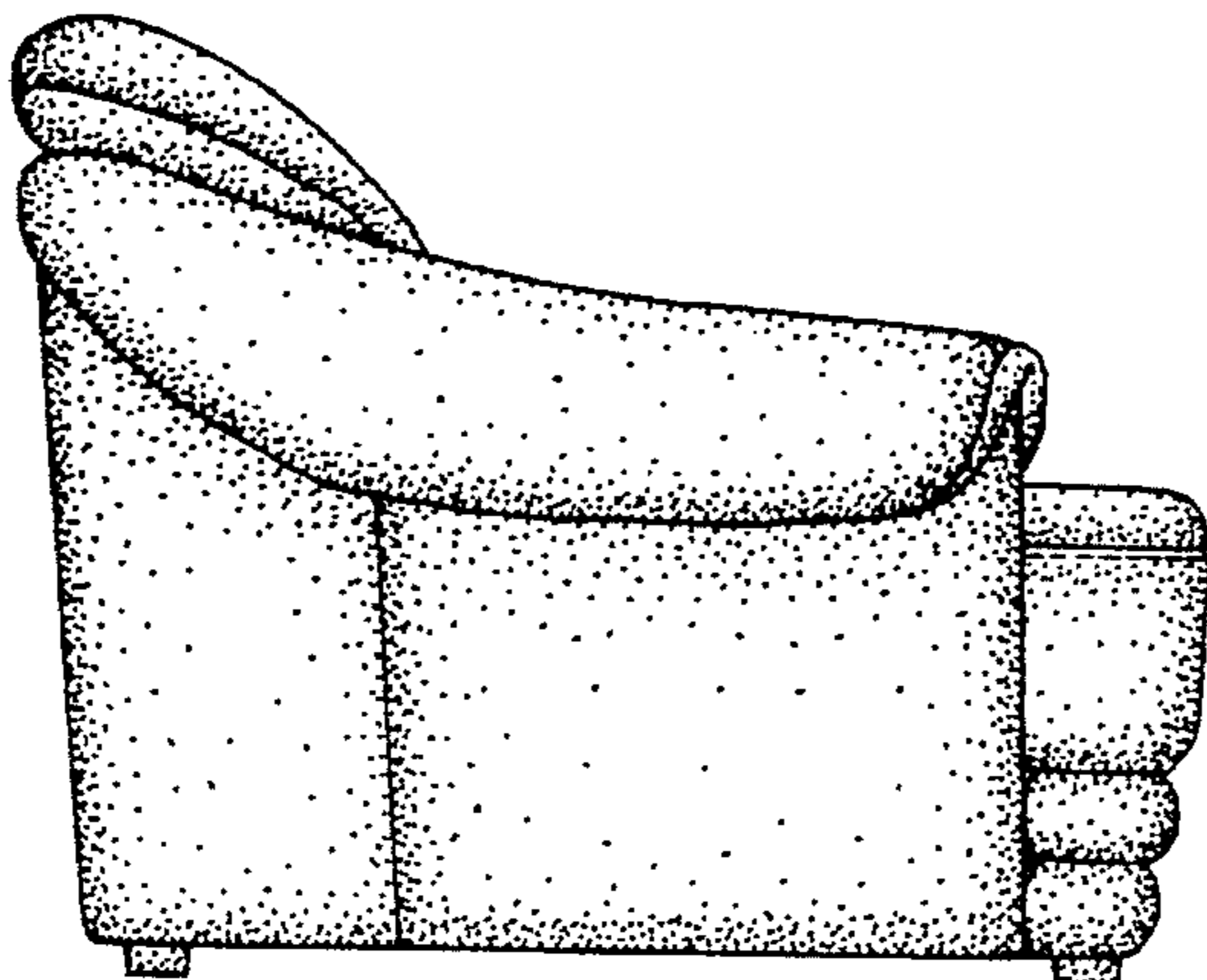
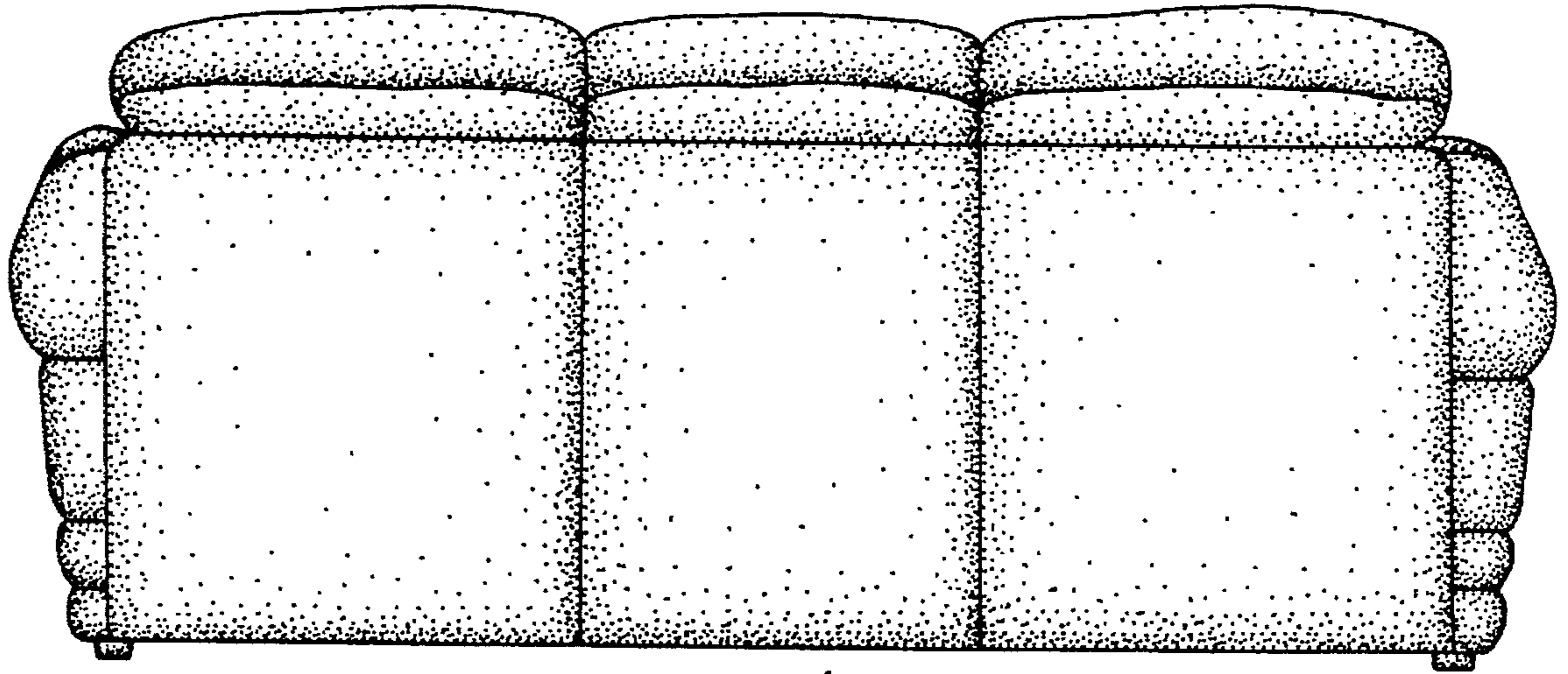
