design;

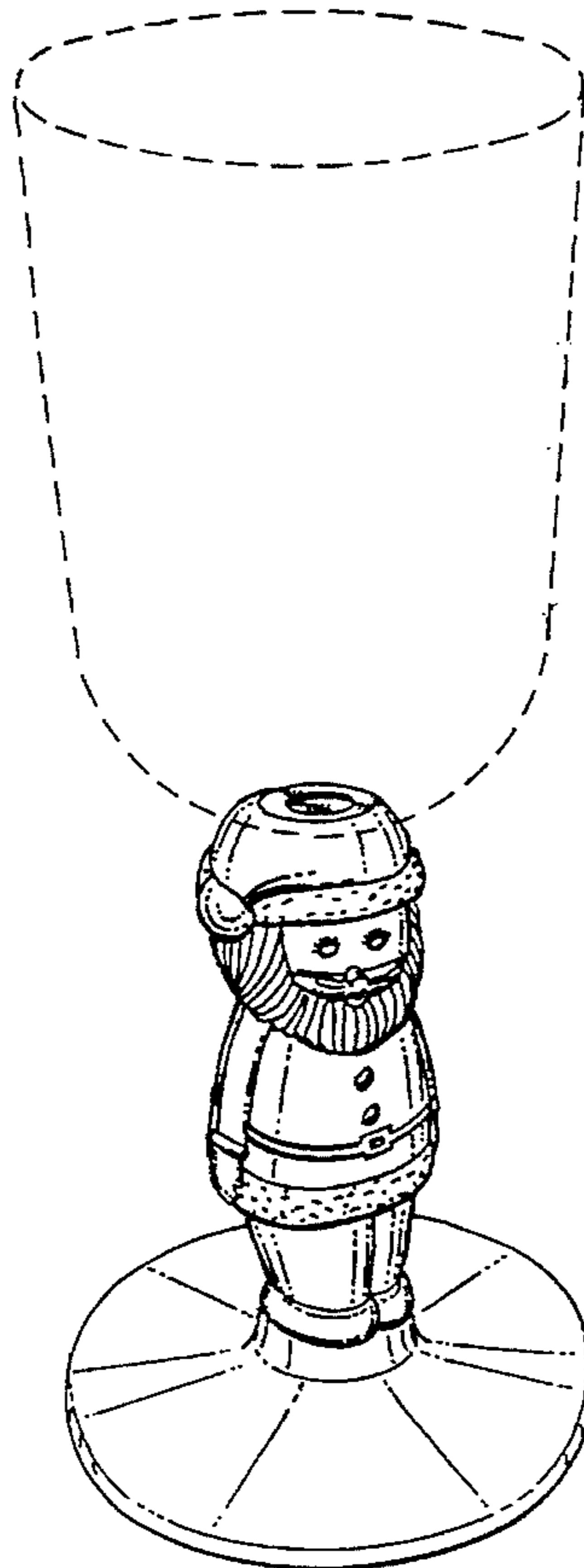
FIG. 2 is a top view of my design;

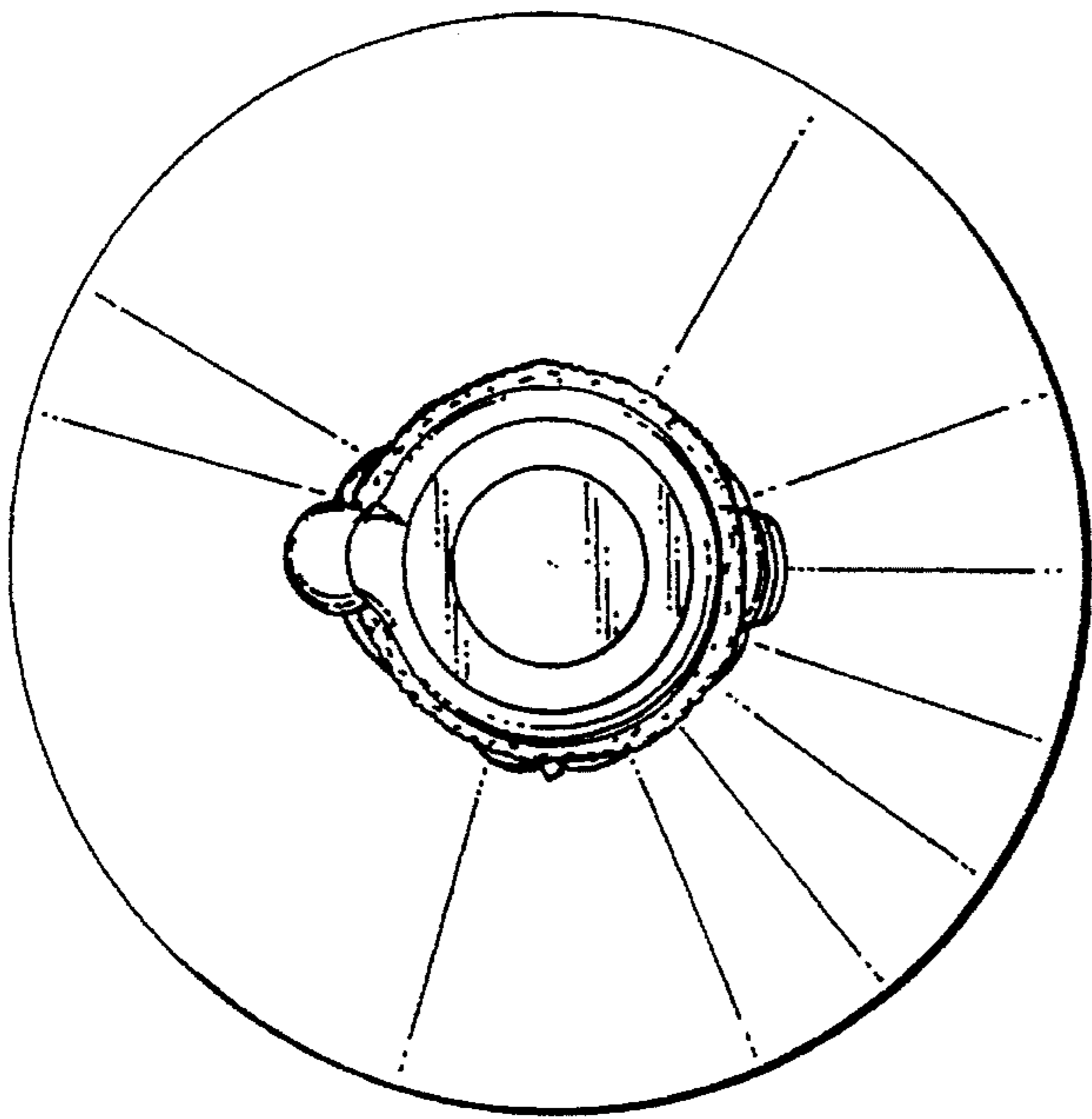

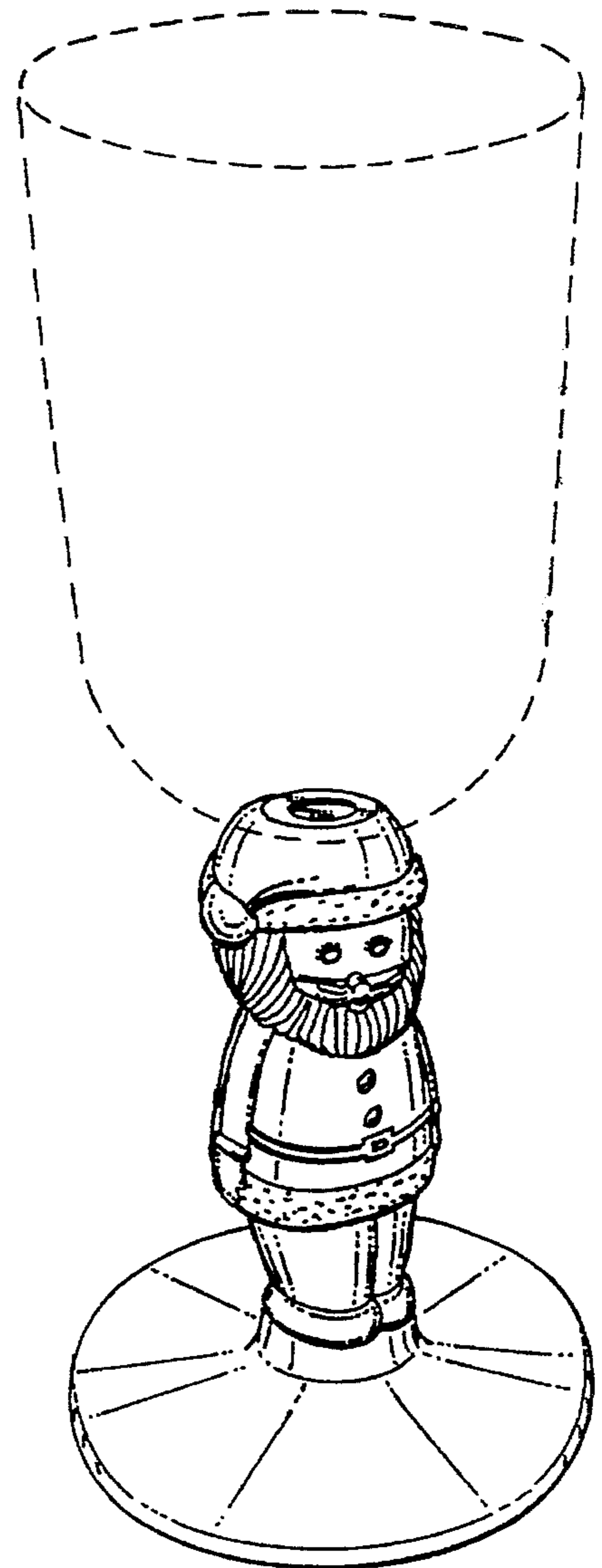

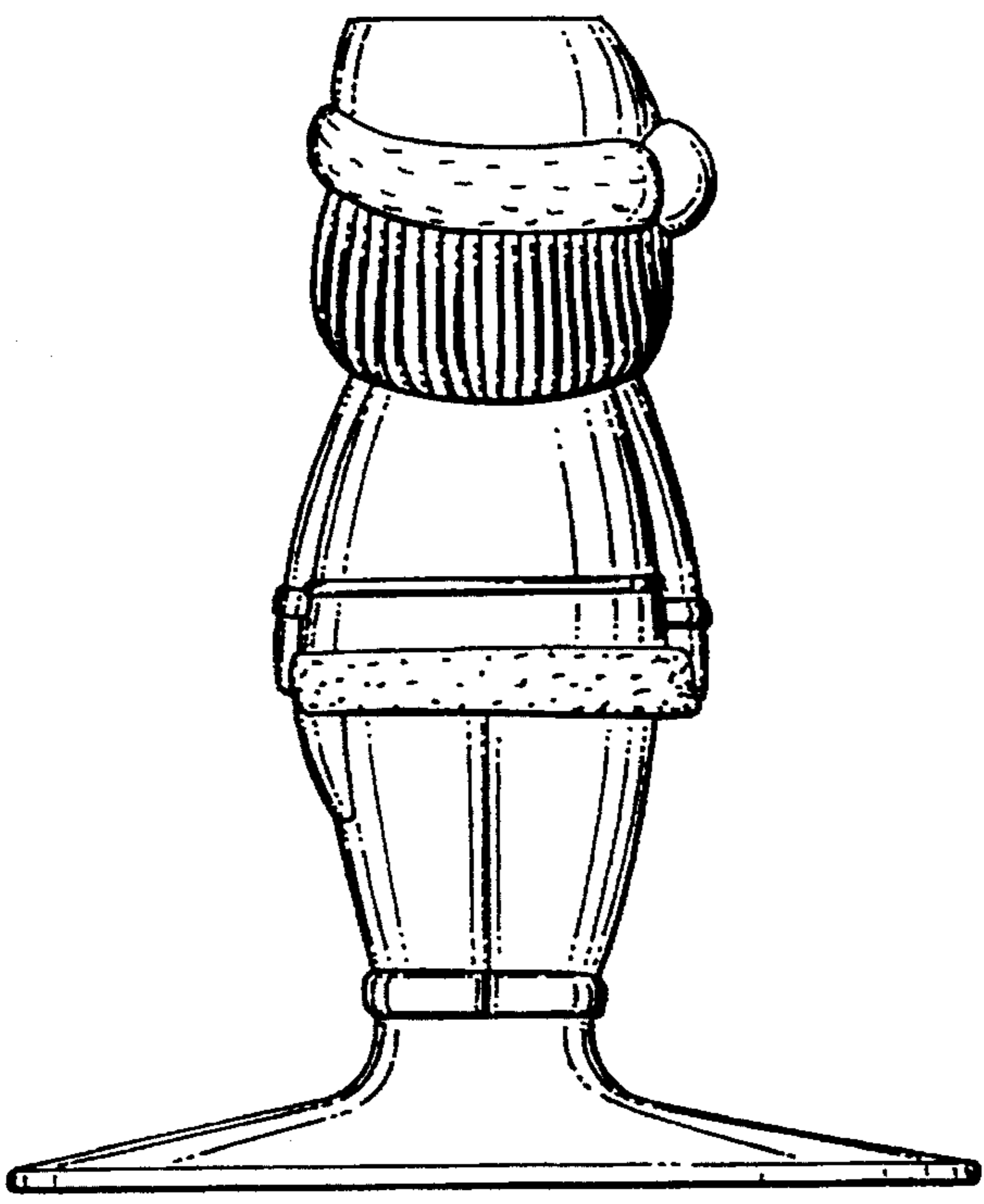

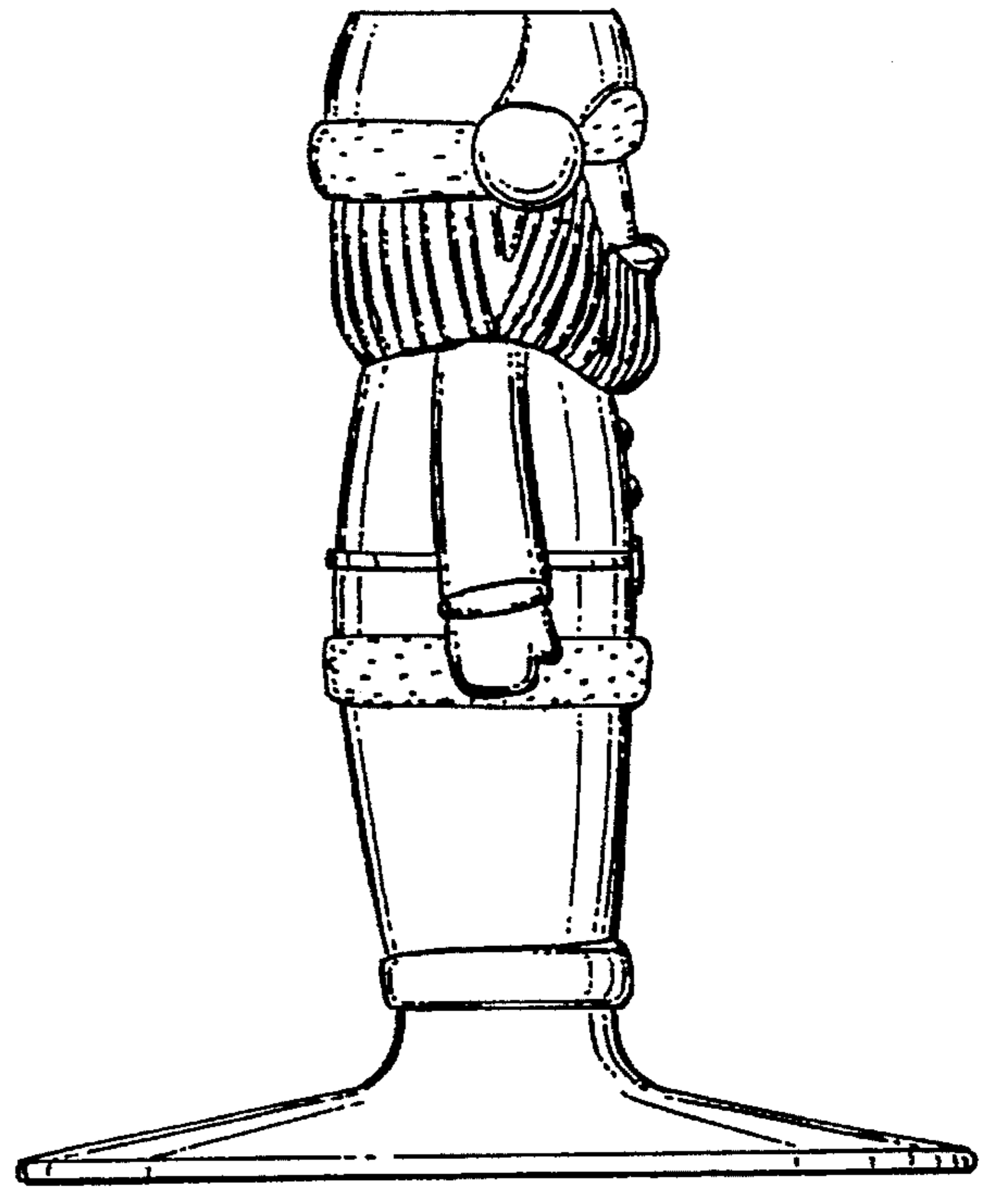

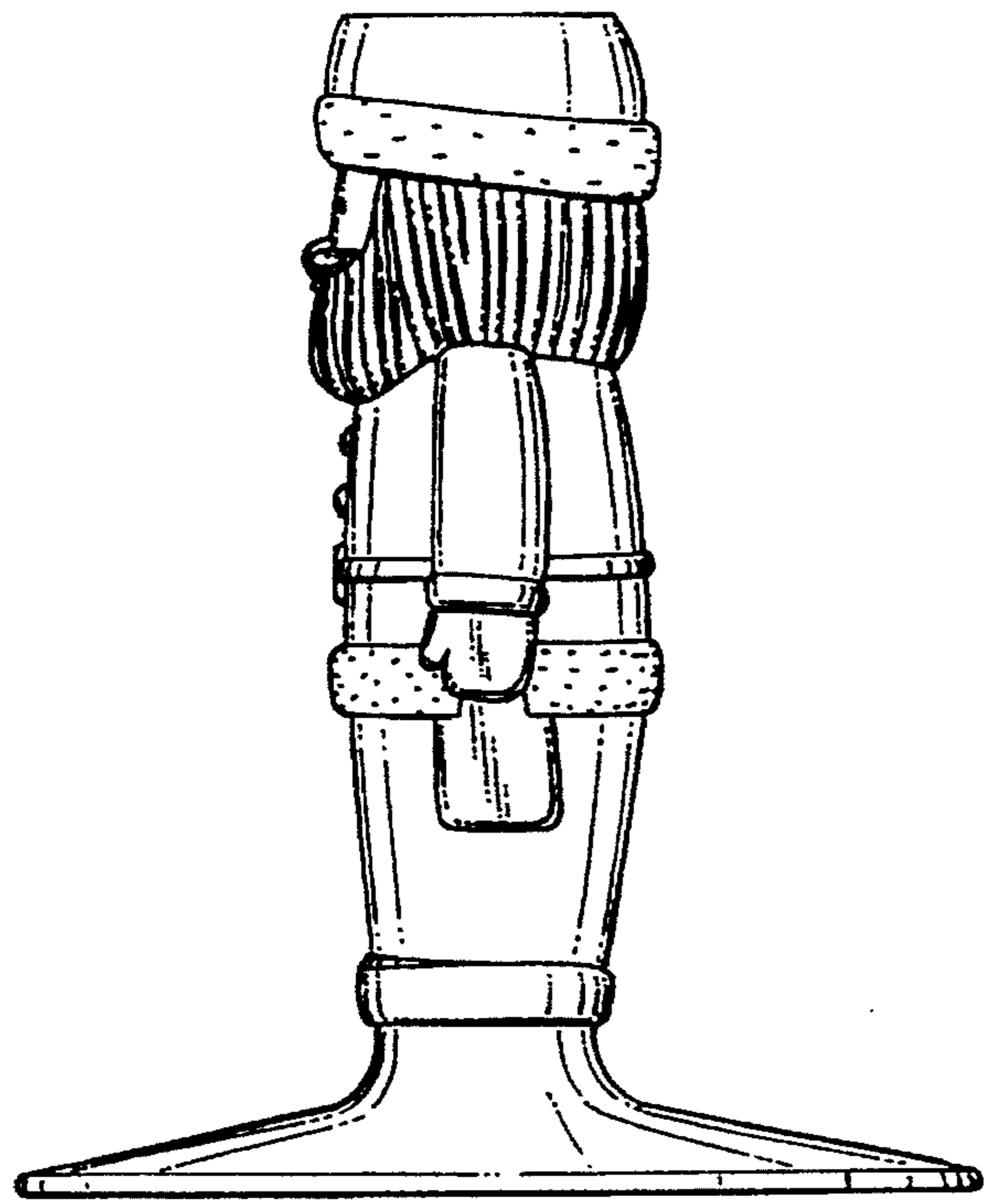

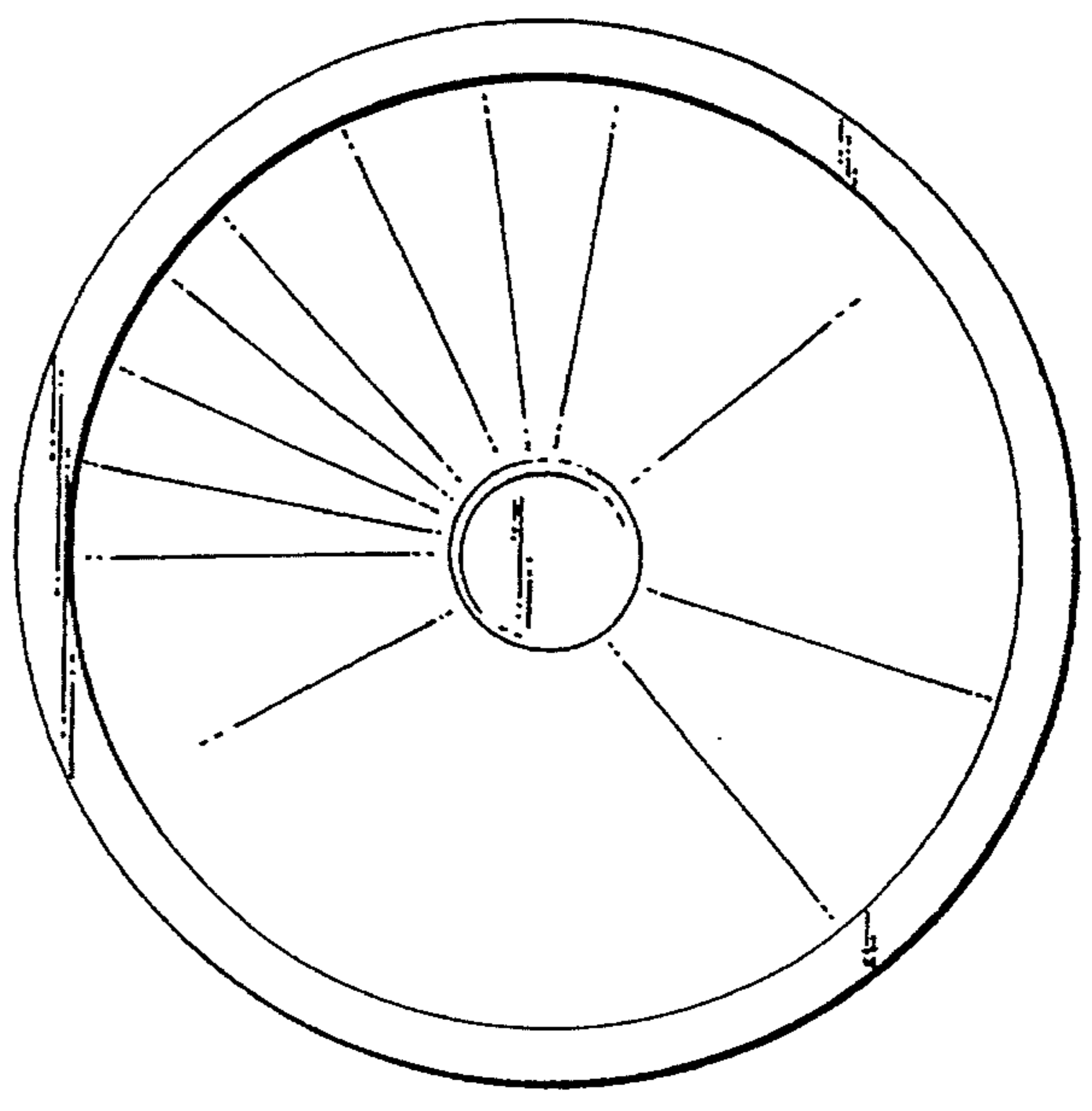
