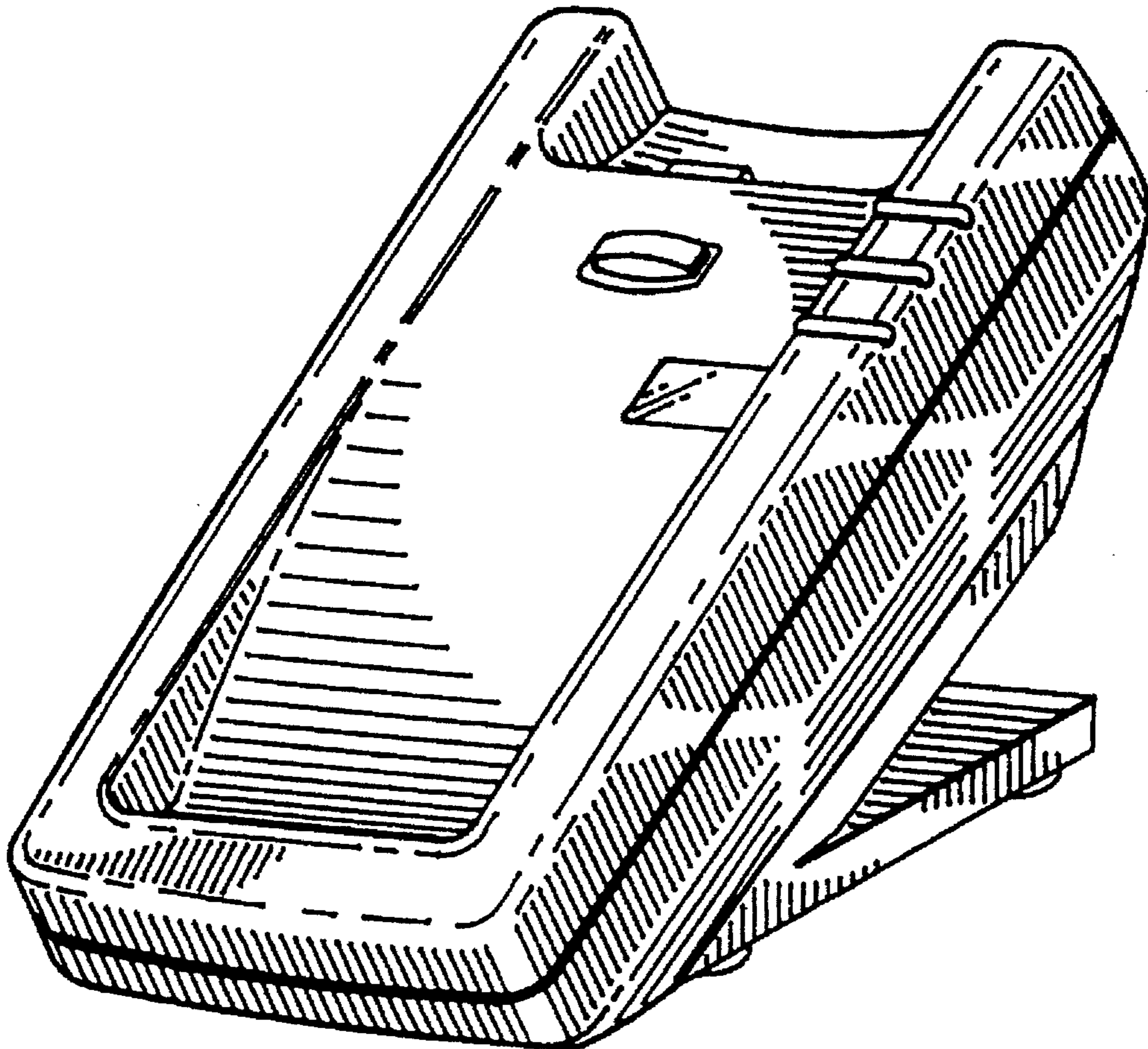
[57] **CLAIM**

The ornamental design for a combined telephone base and supporting easel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined telephone base and supporting easel, showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevation view thereof with the base and easel separated for convenience of illustration; FIG. 4 is a front elevation view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a rear elevation view thereof.

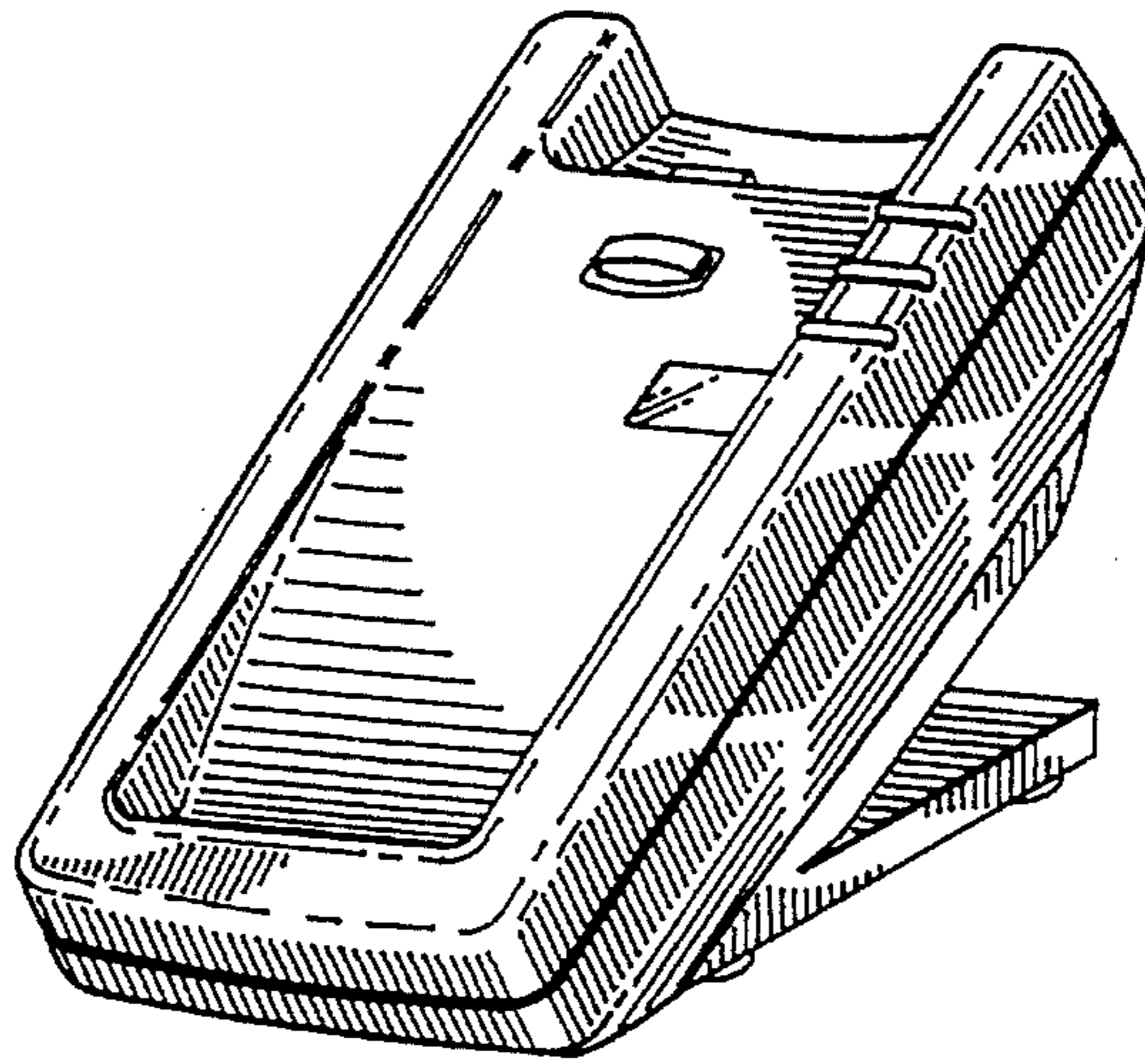

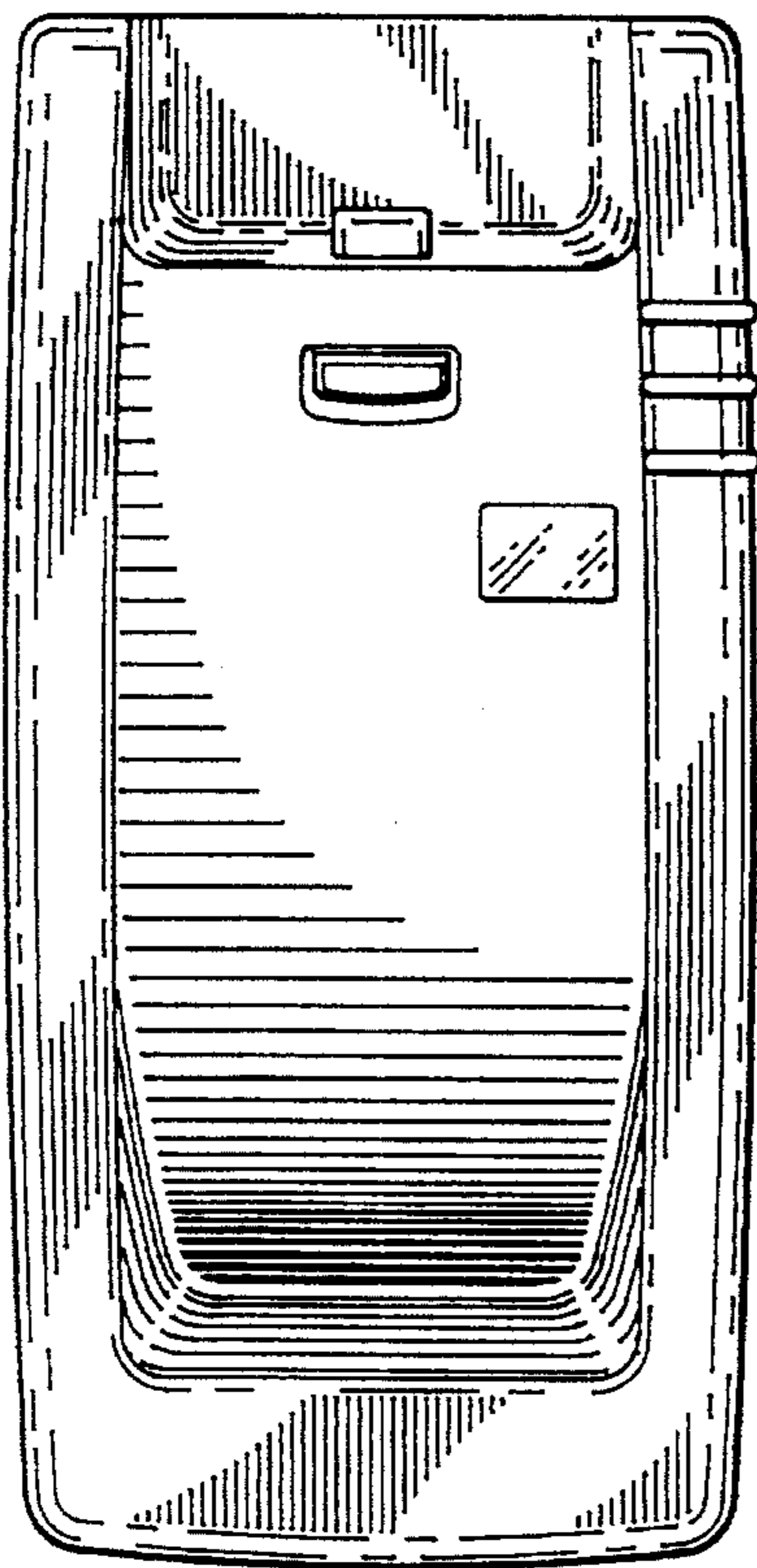

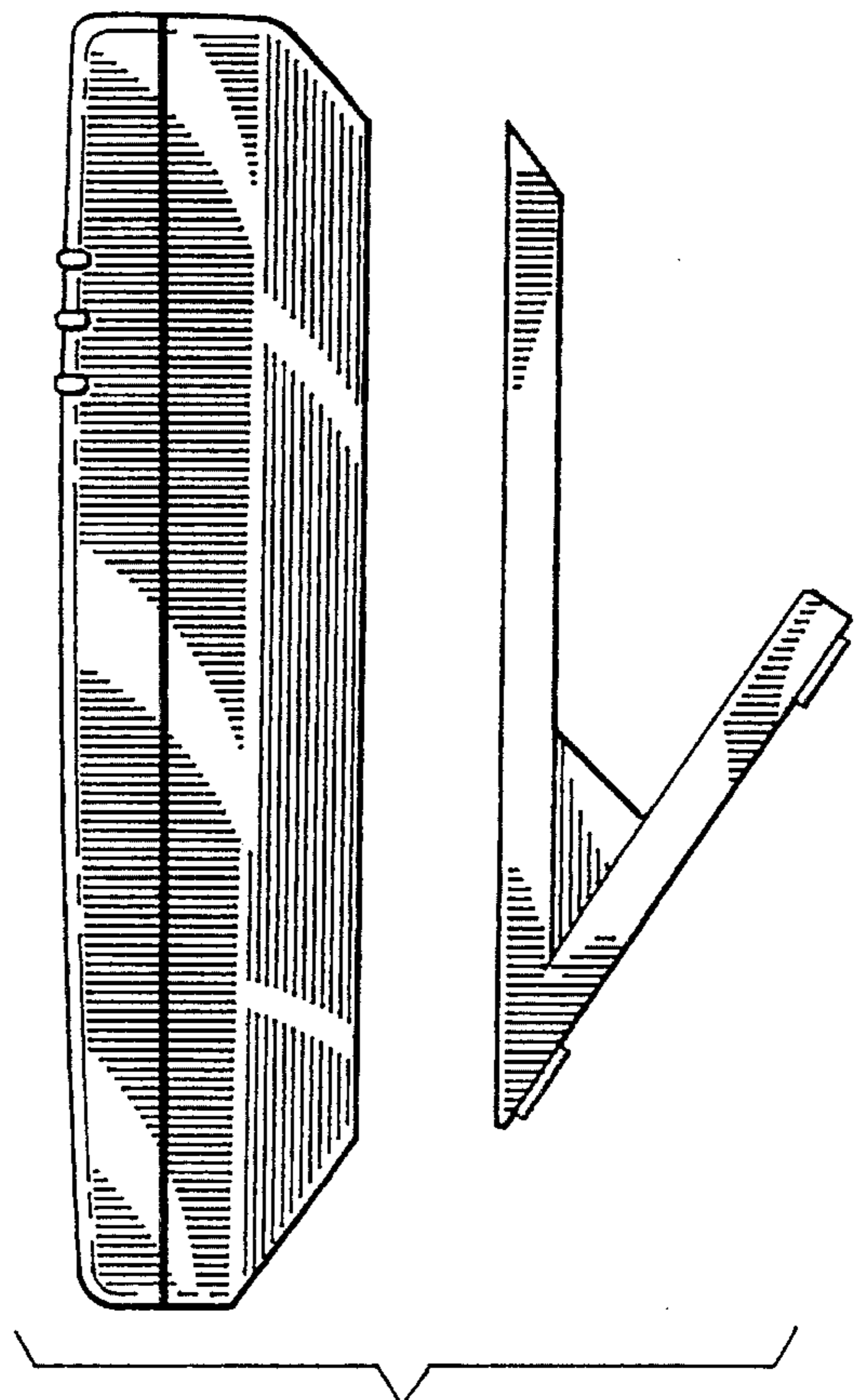

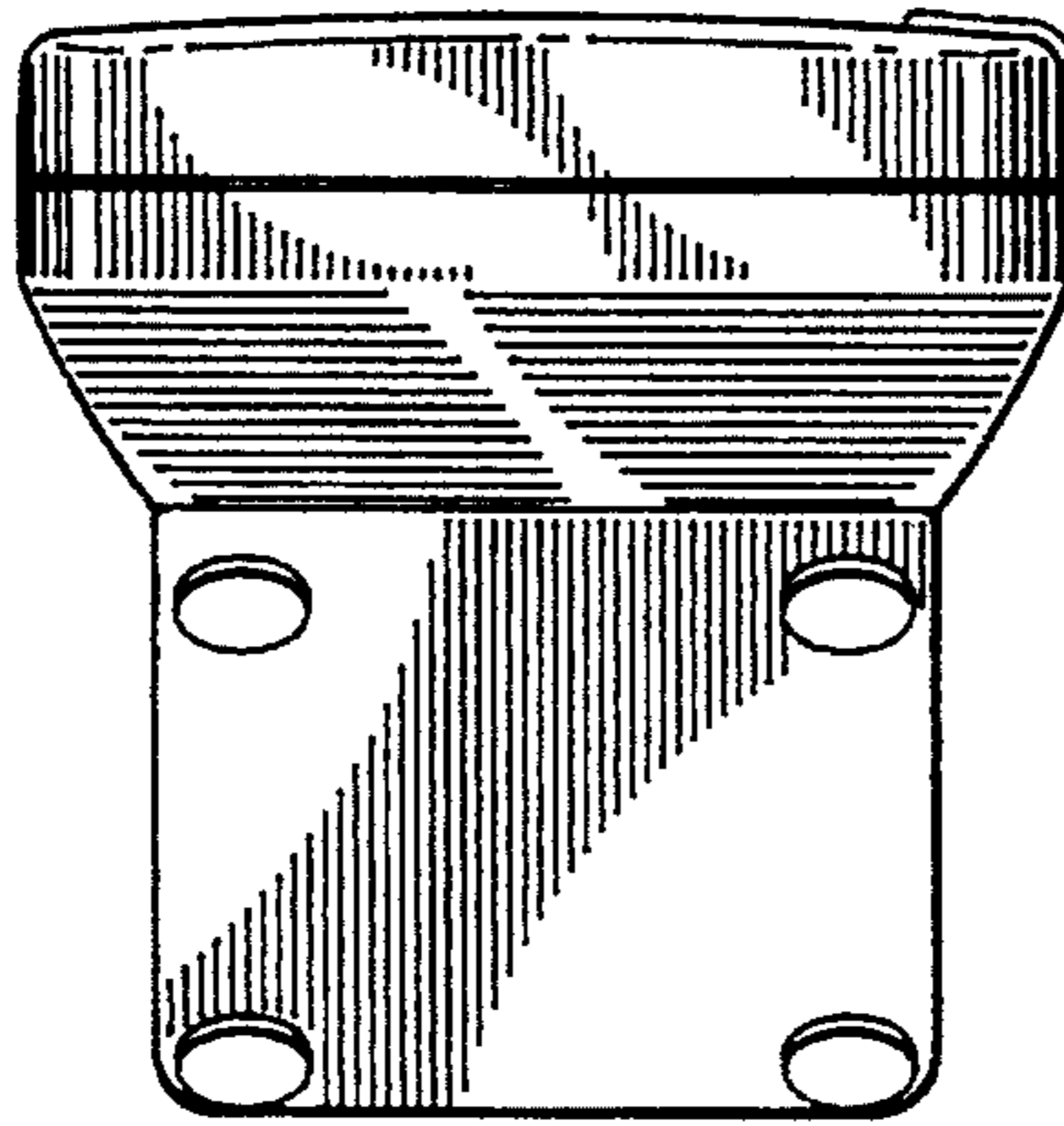

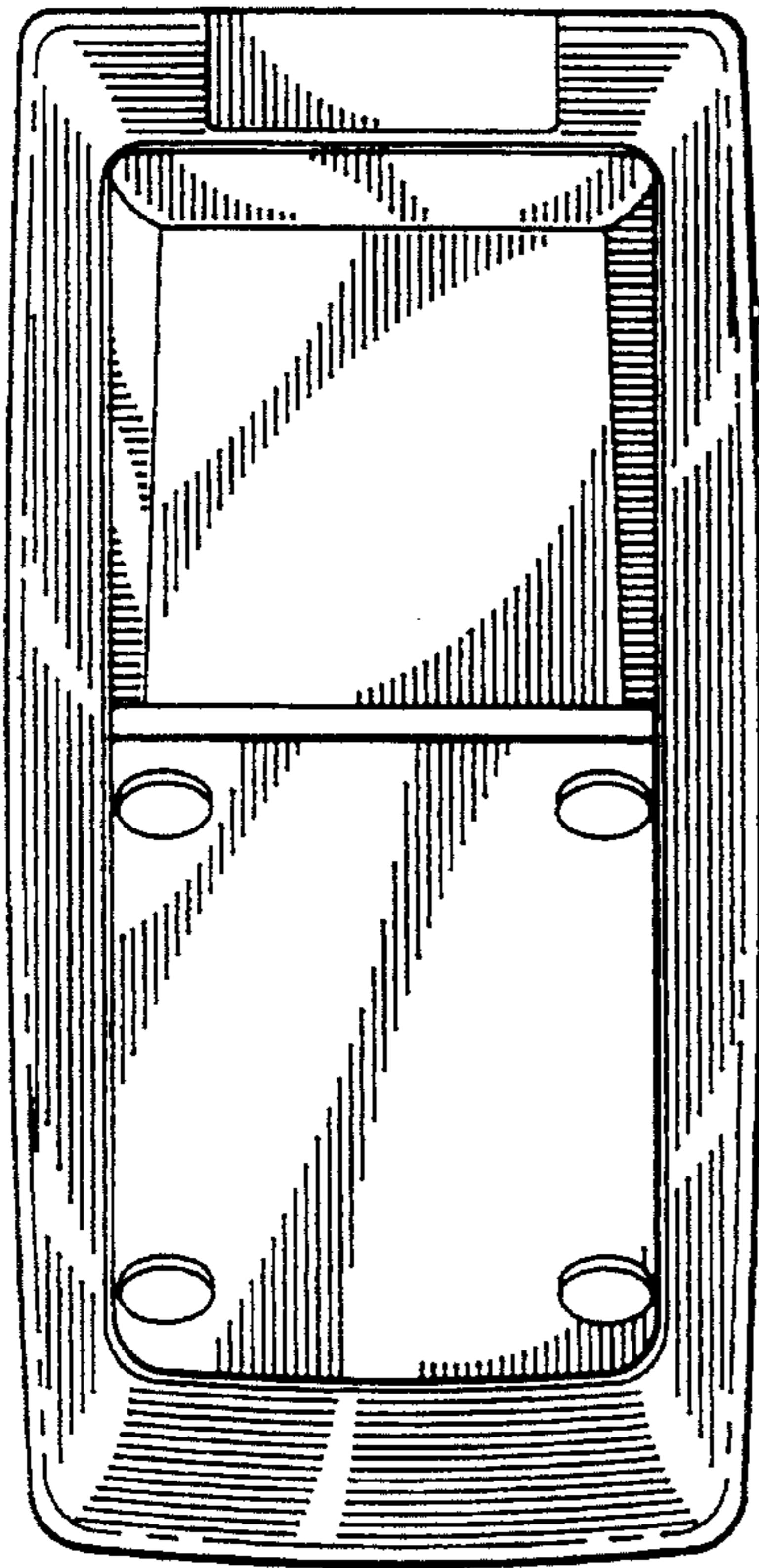

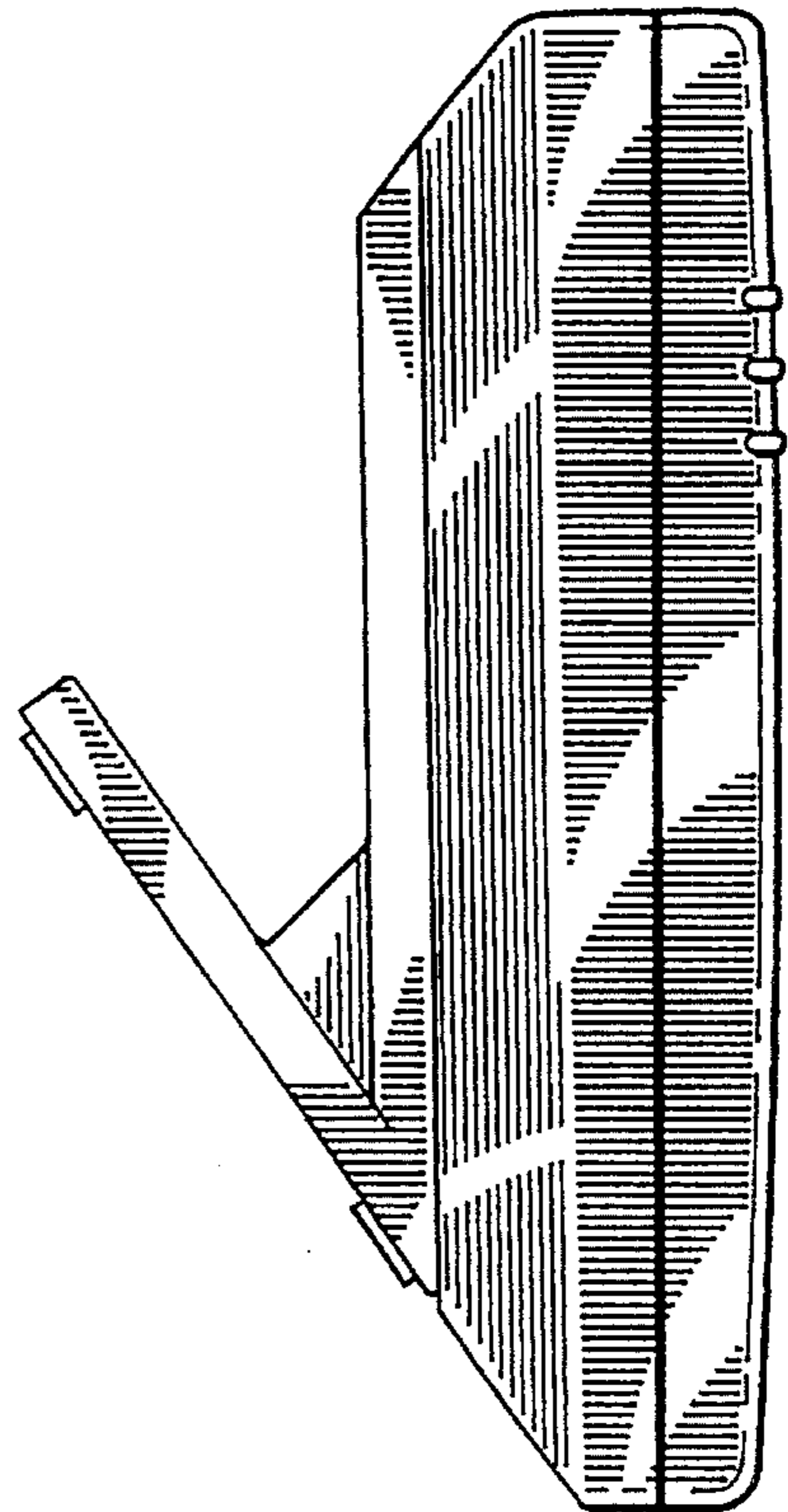

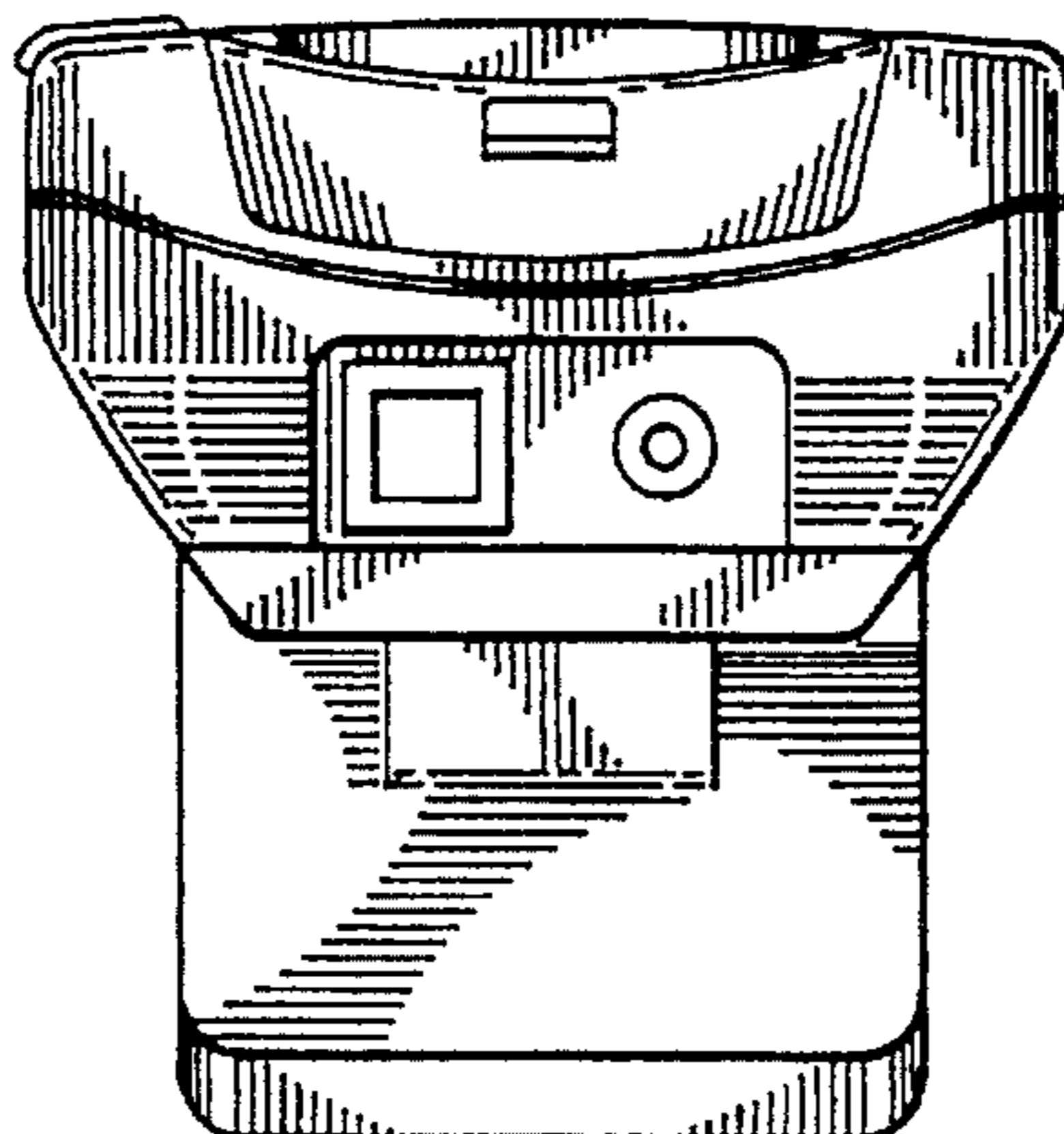
