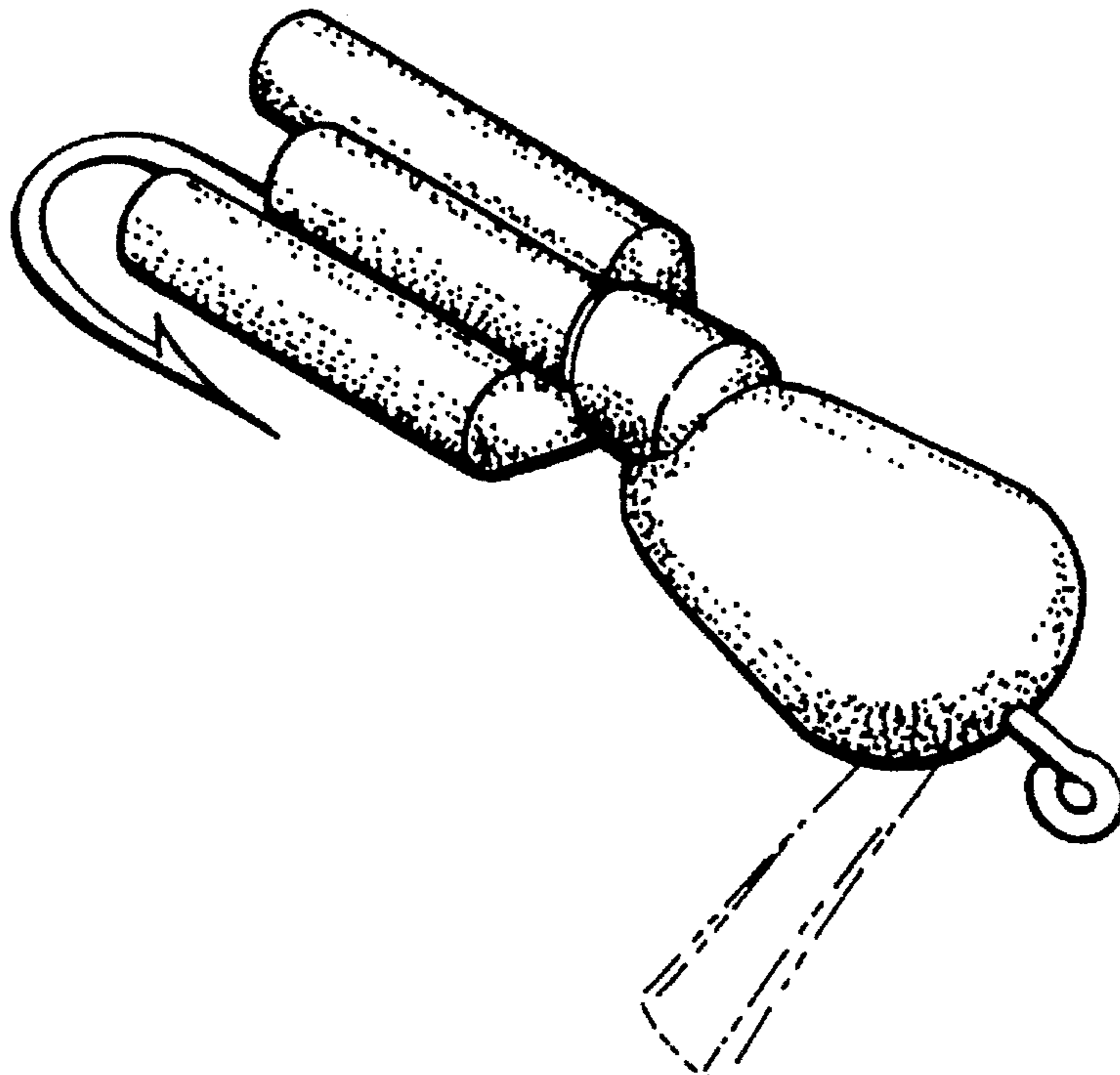
The ornamental design for a fishing lure, as described and shown.

DESCRIPTION

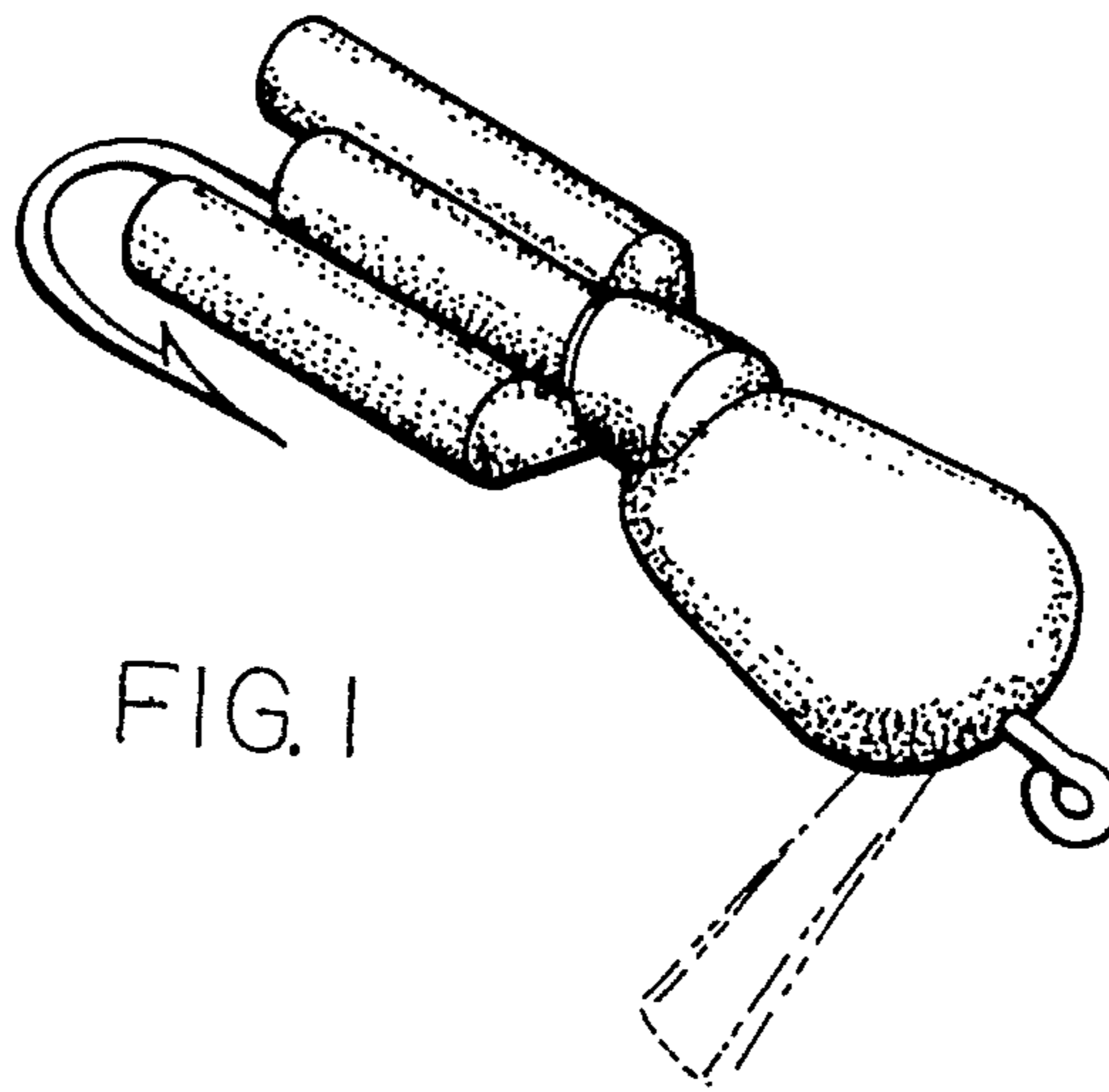

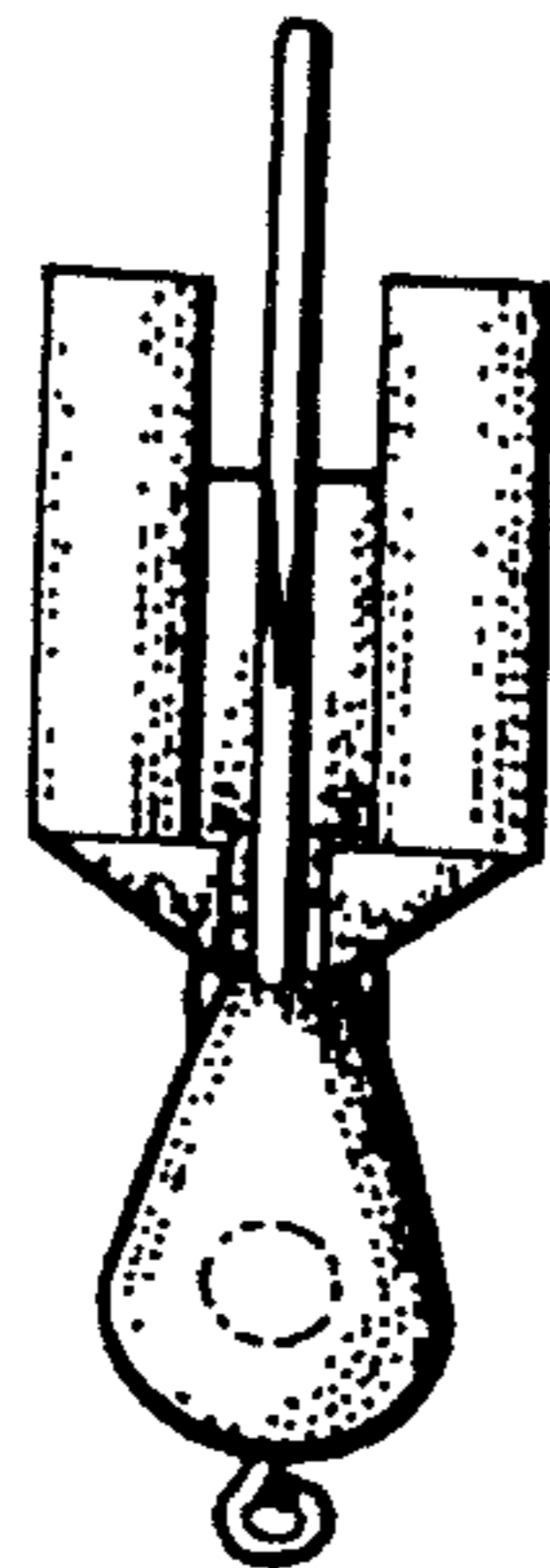

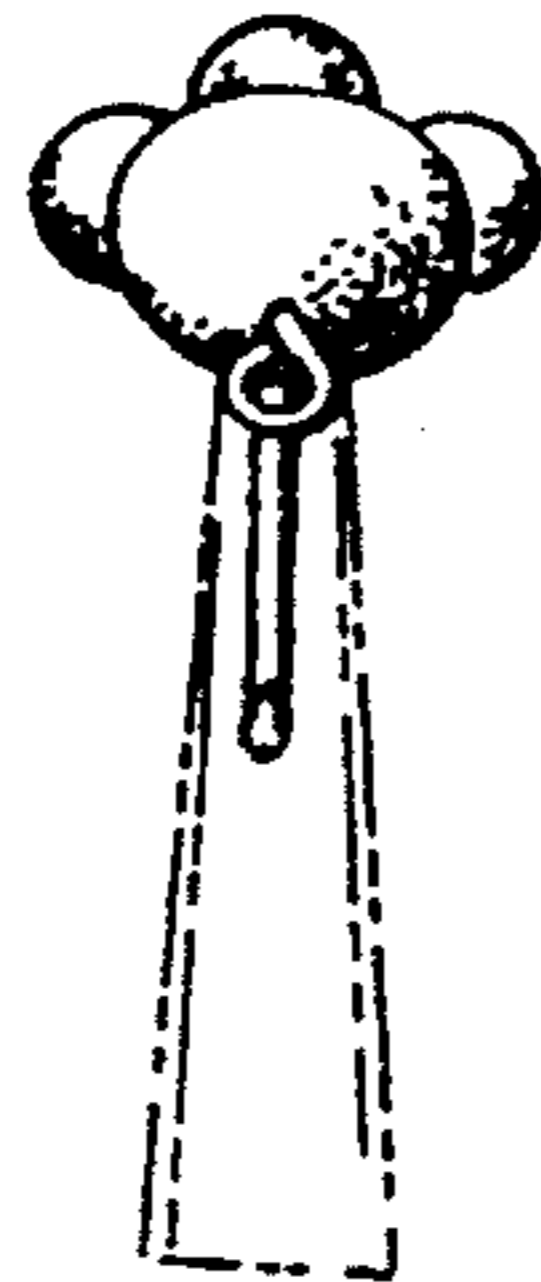

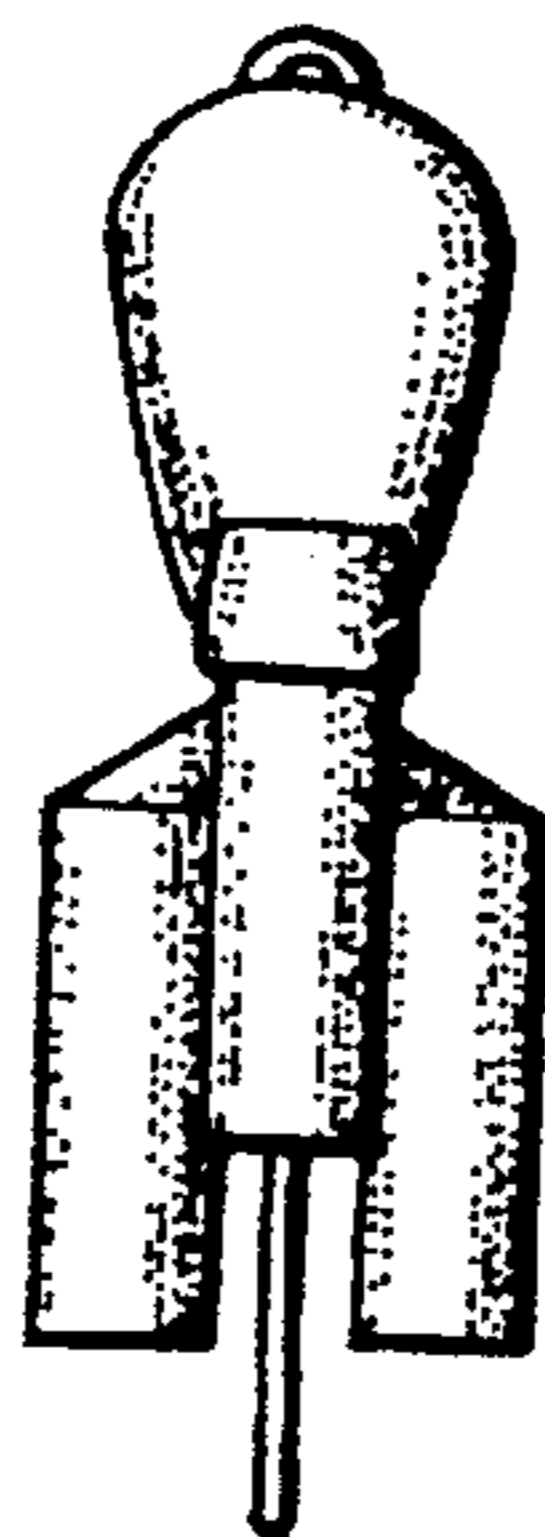

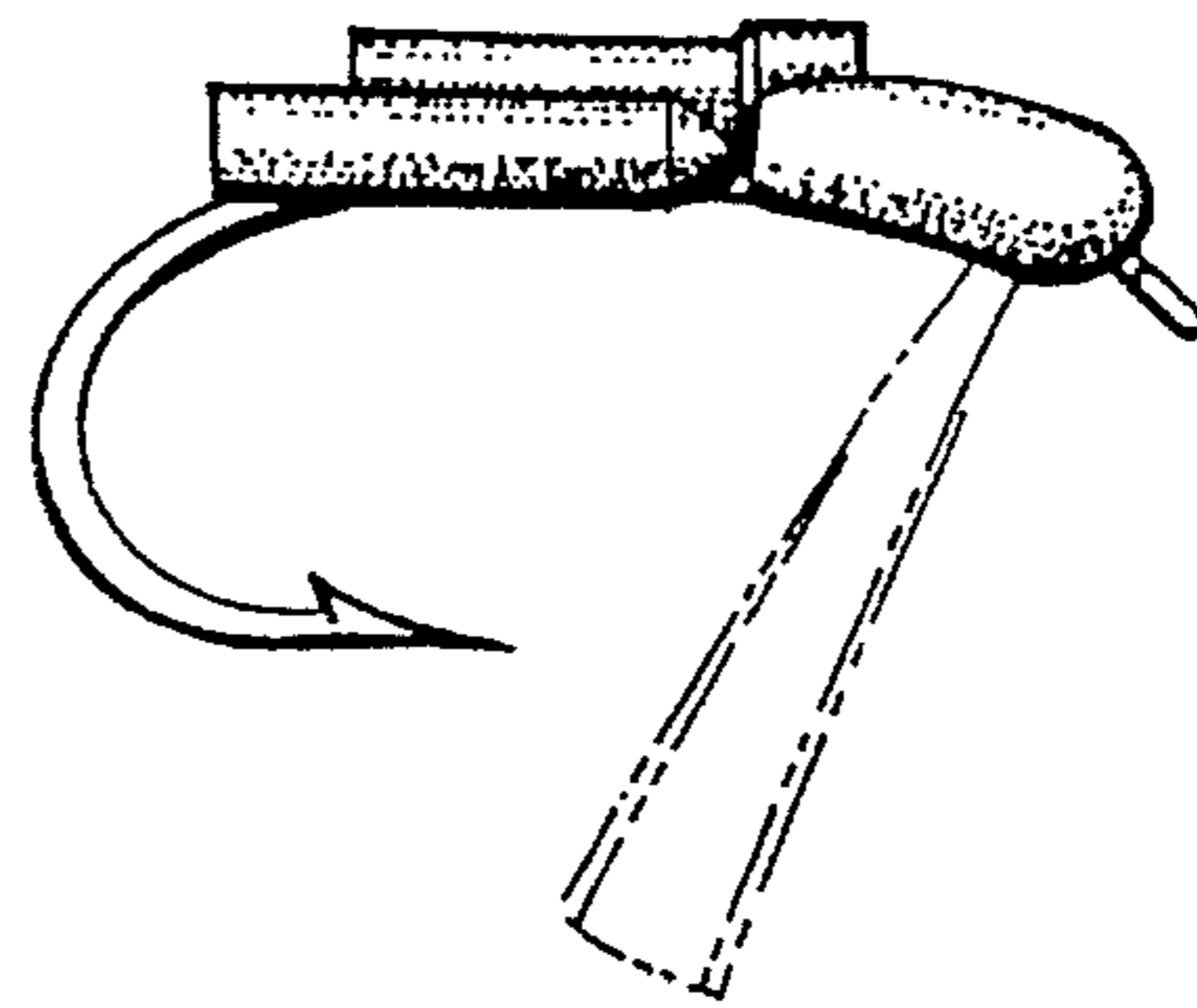

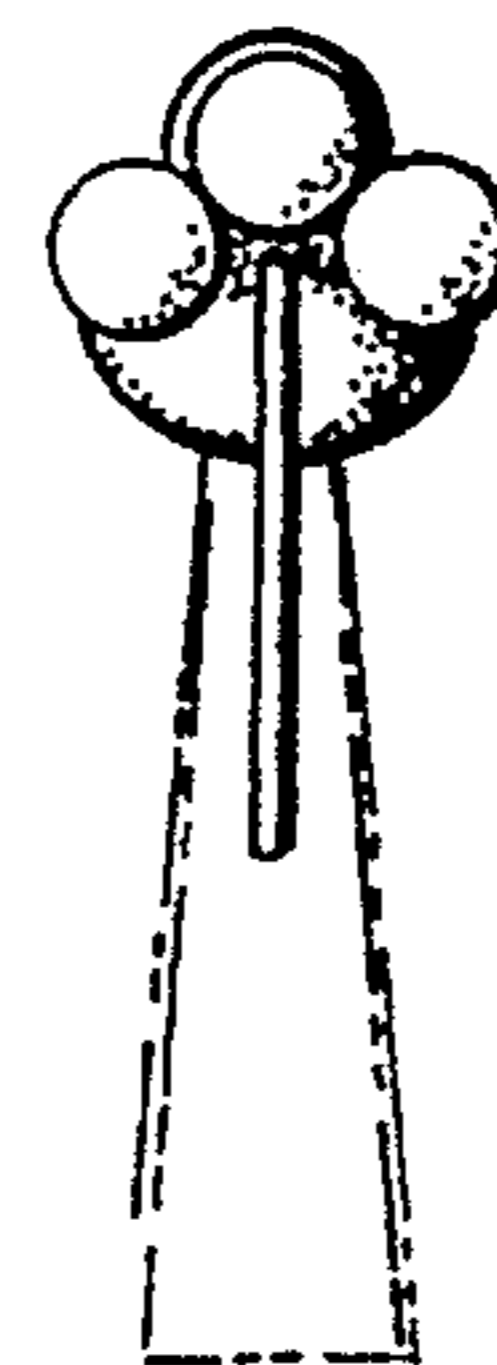

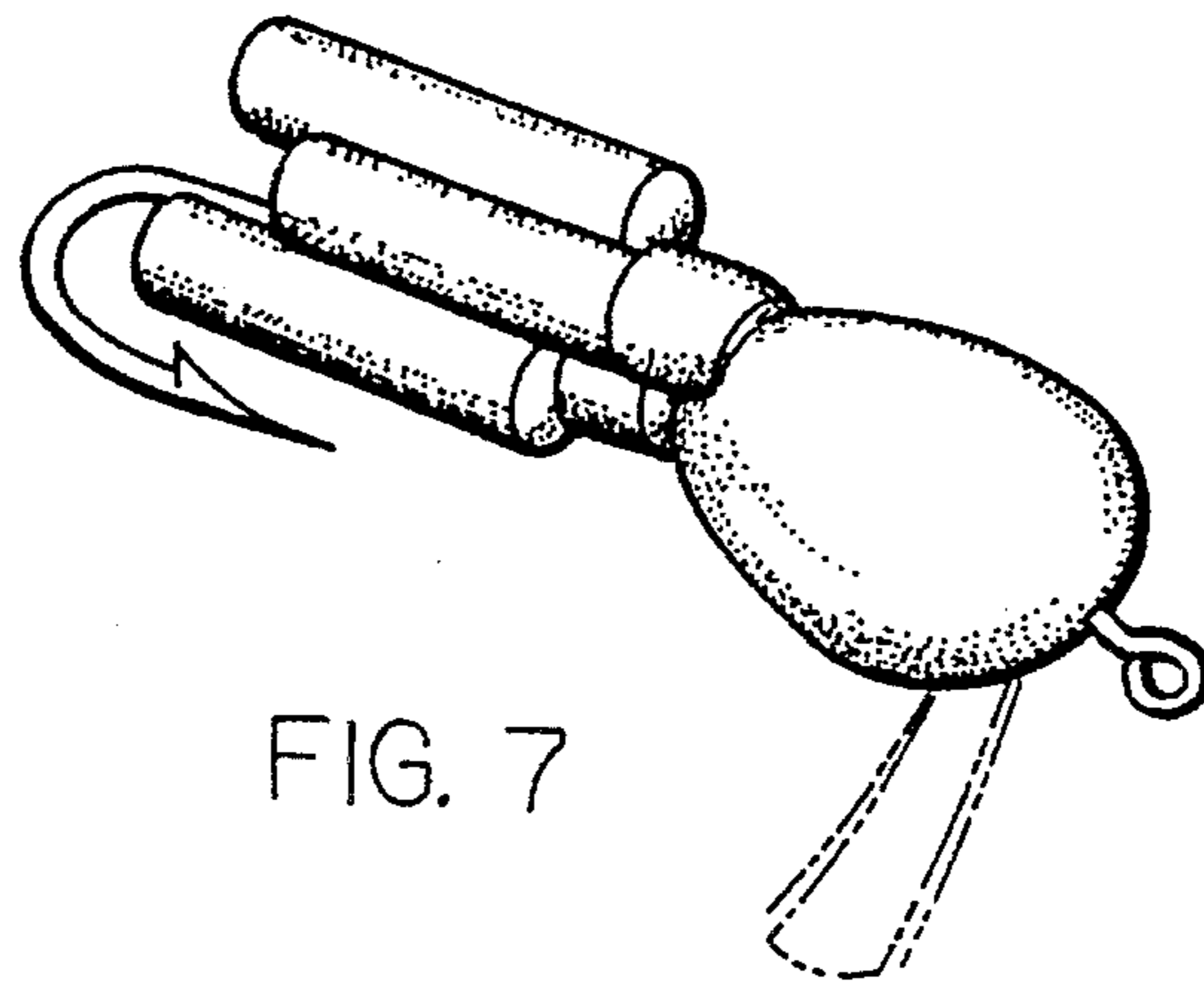

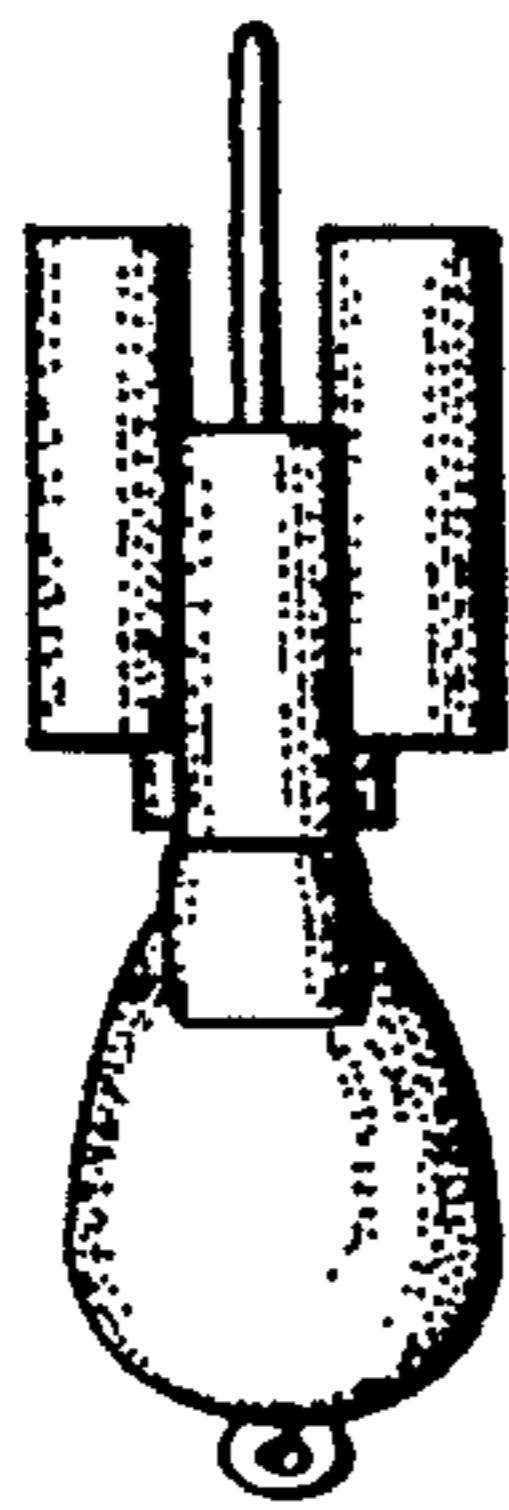

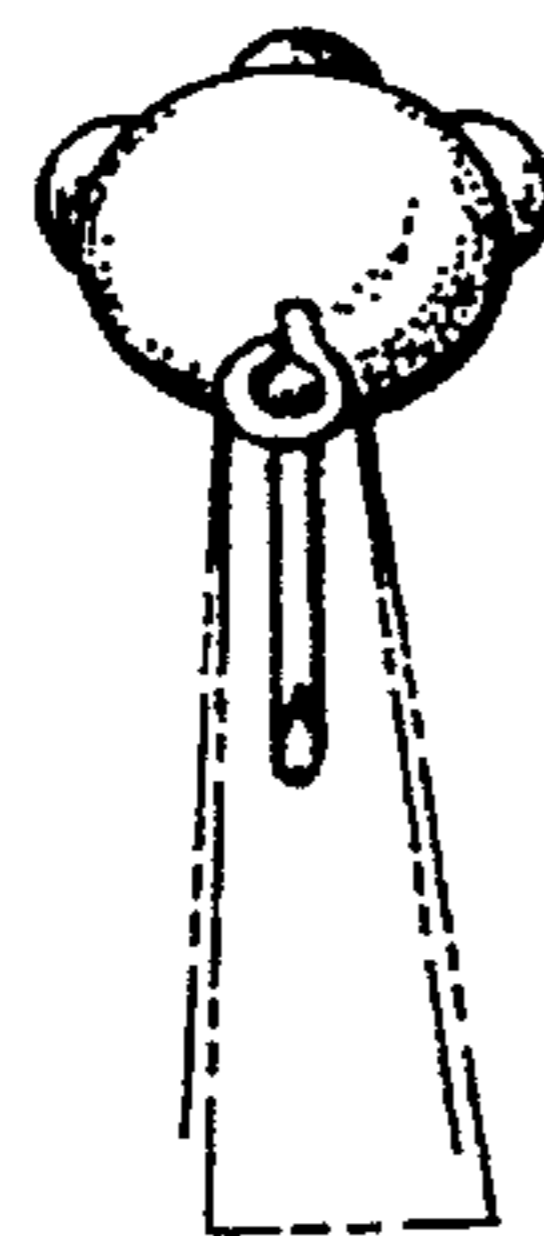

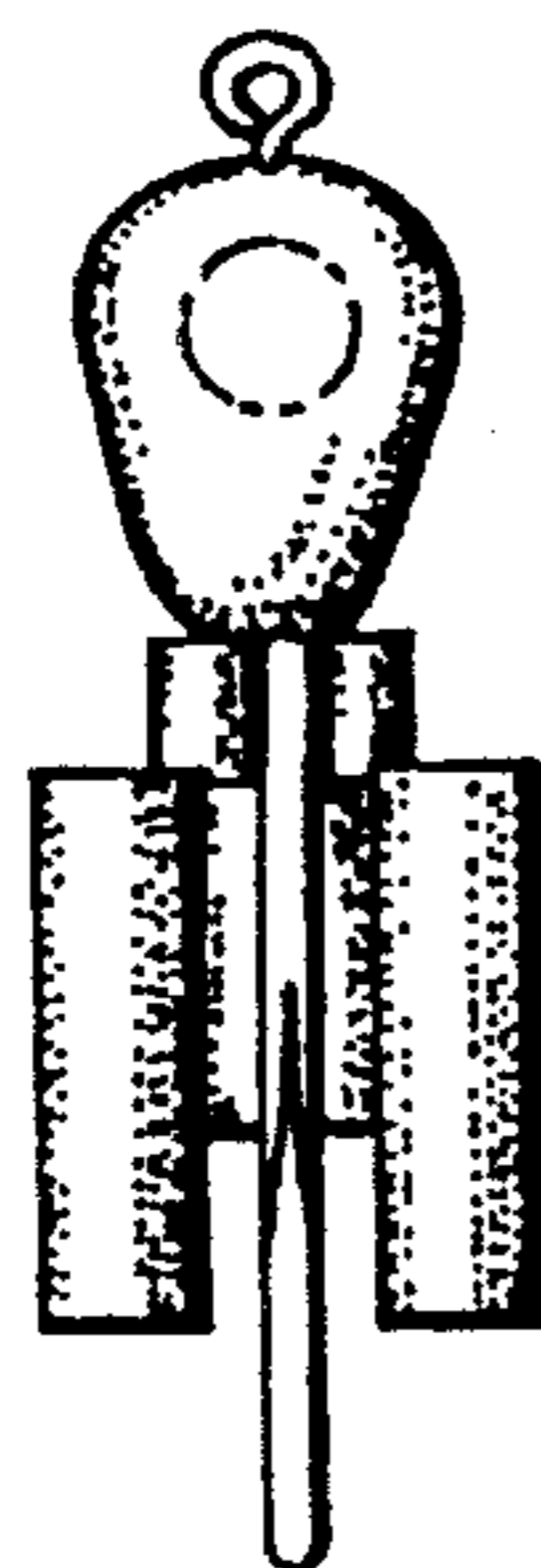

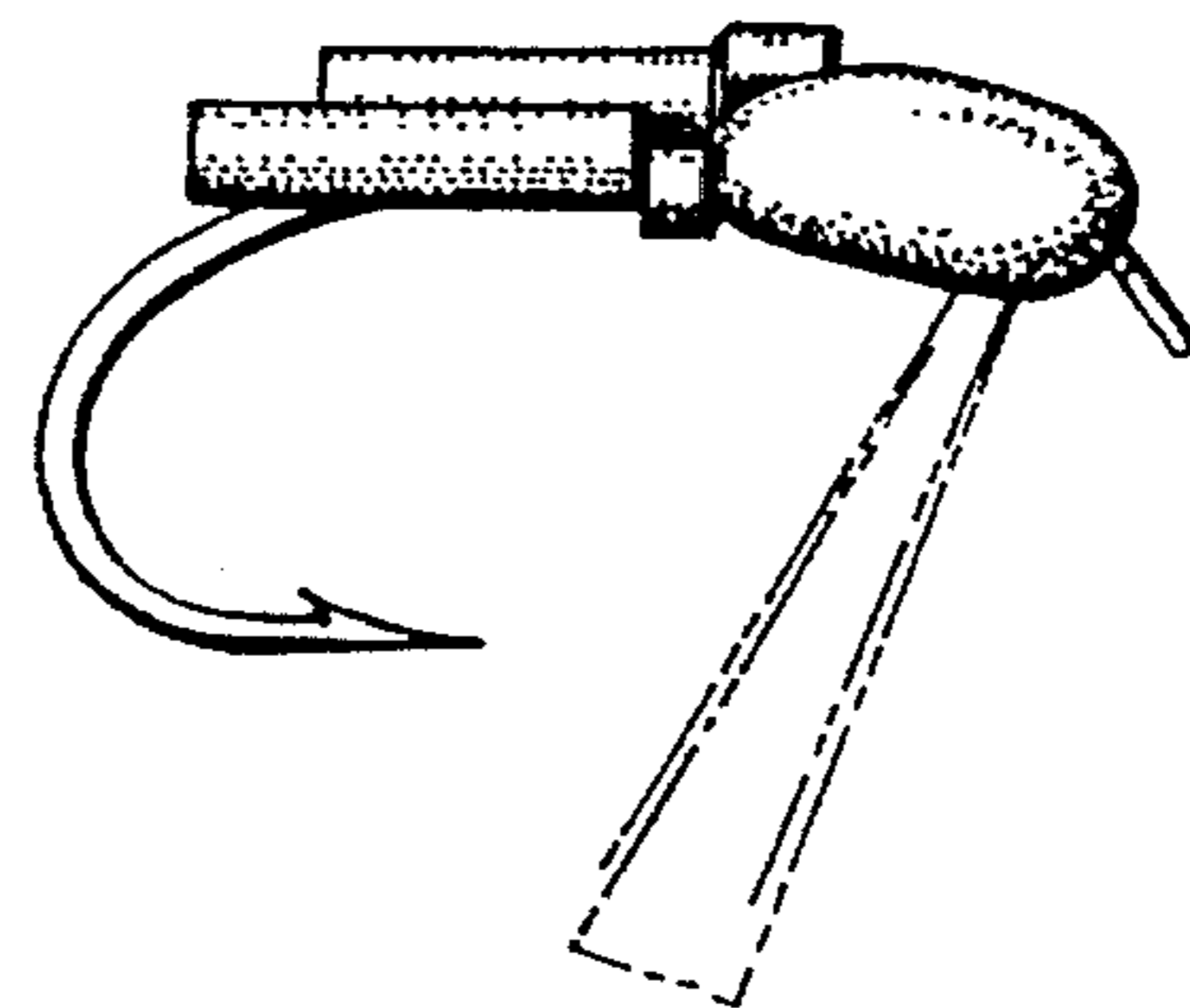

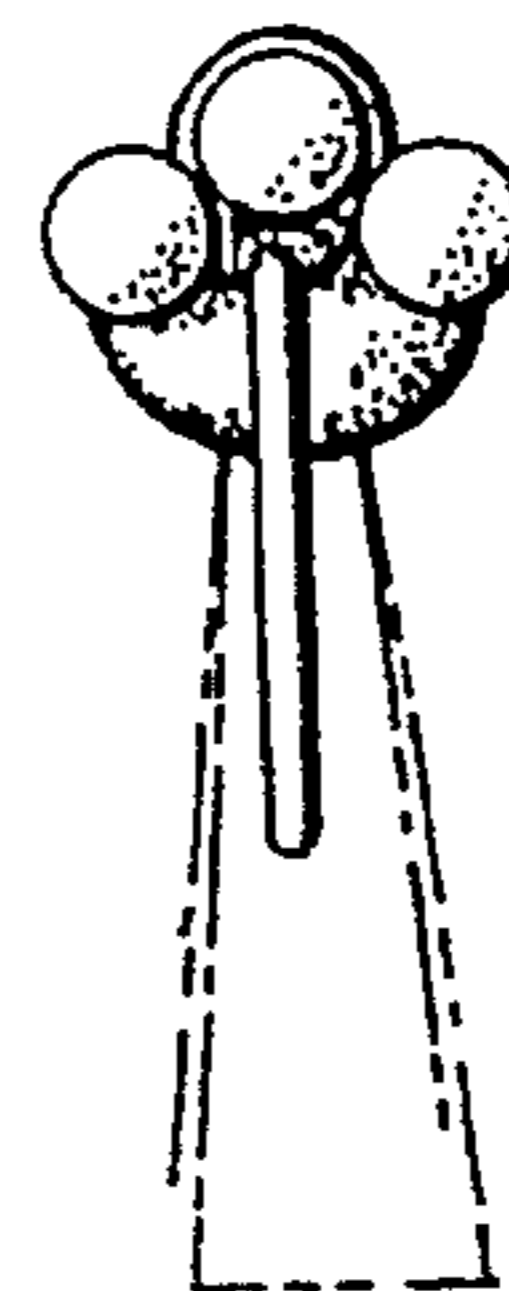

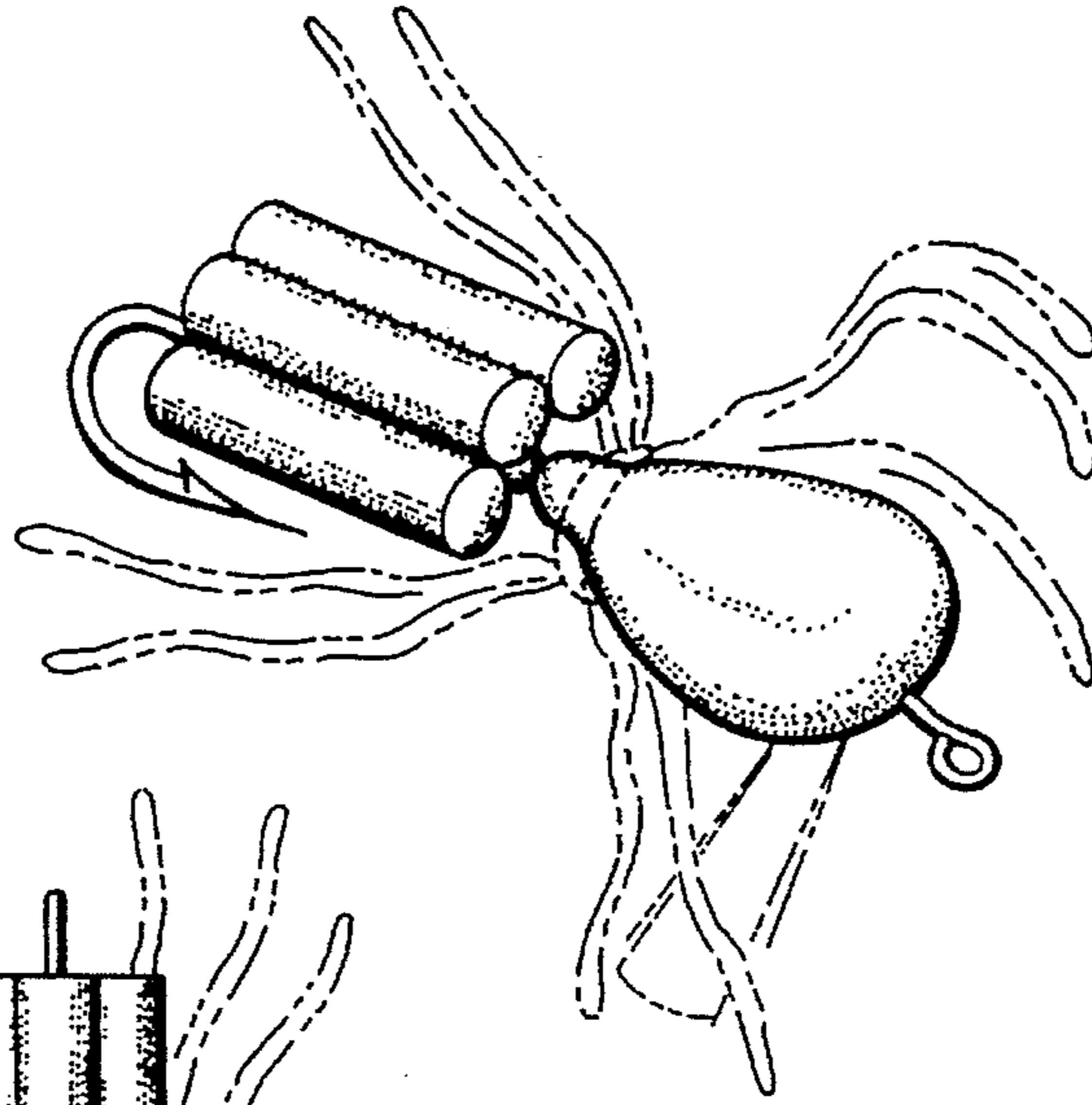

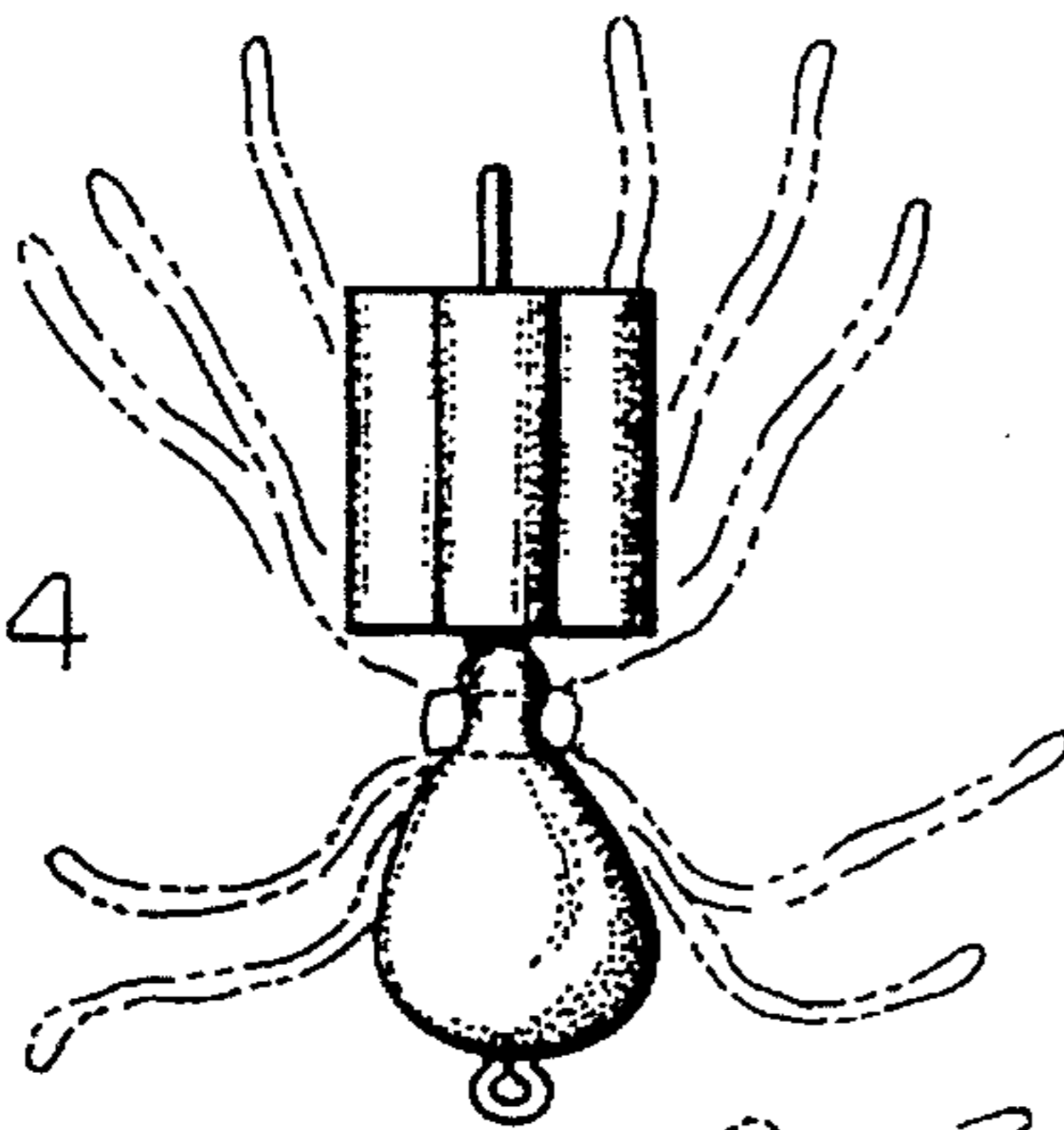

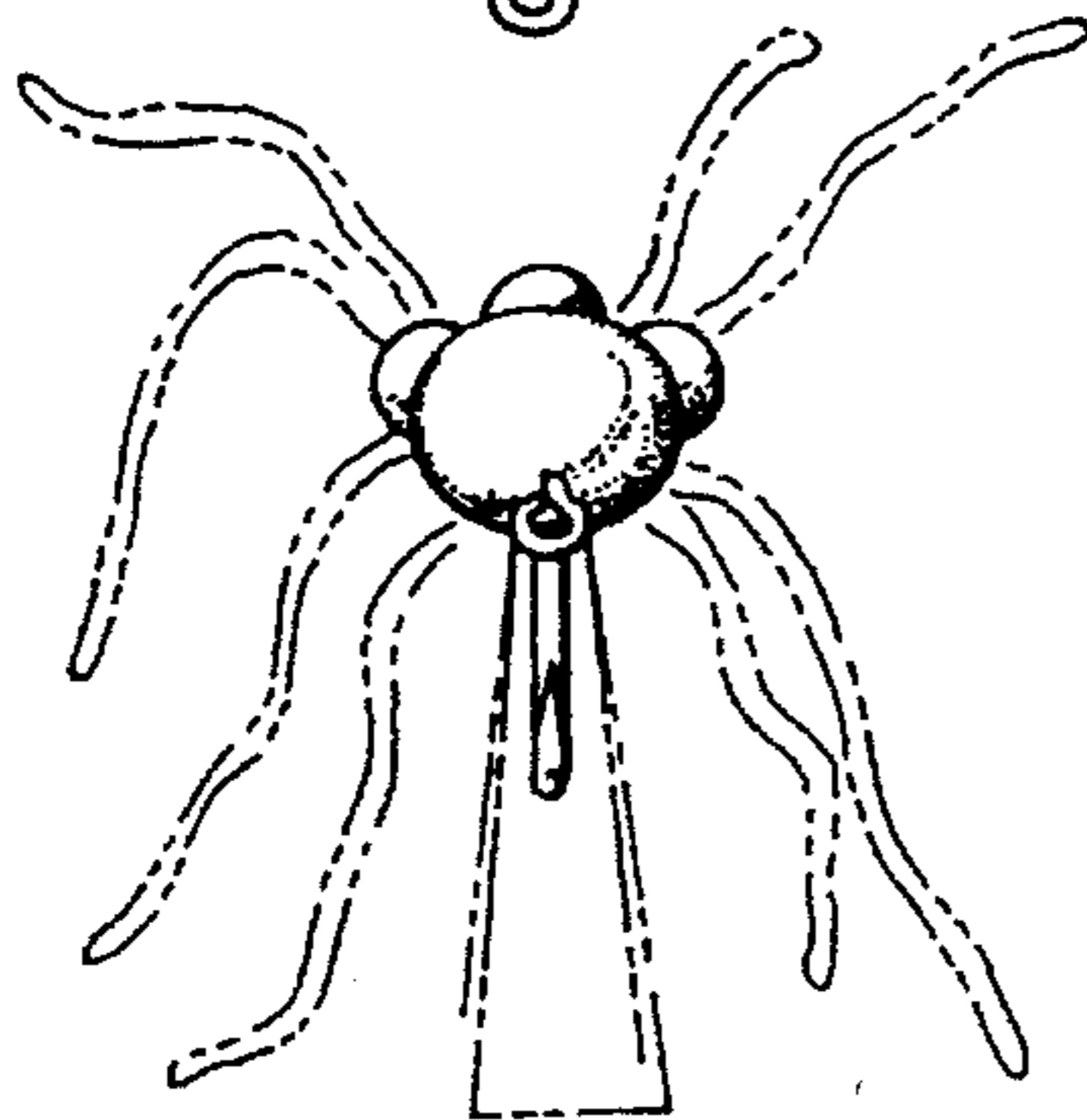

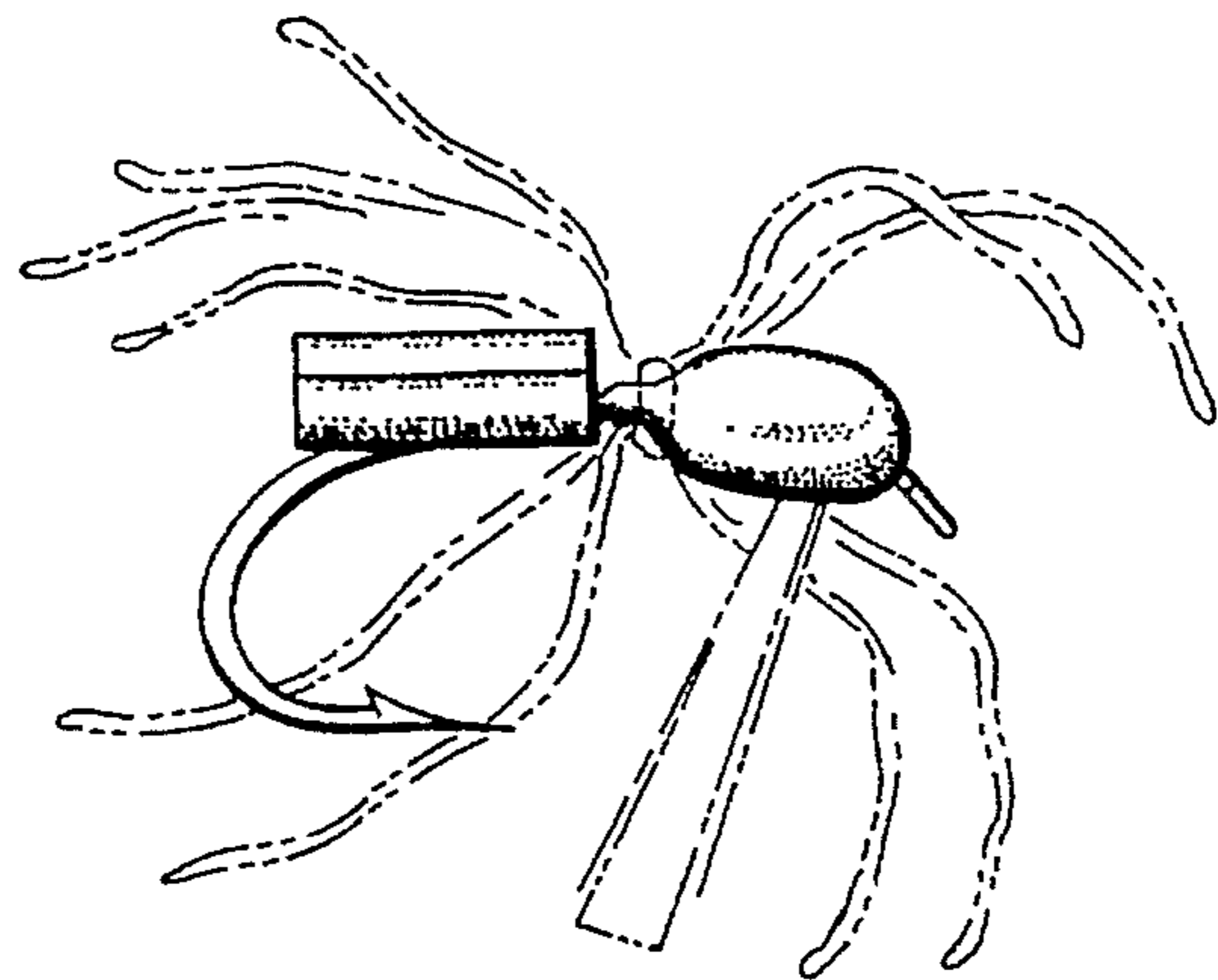

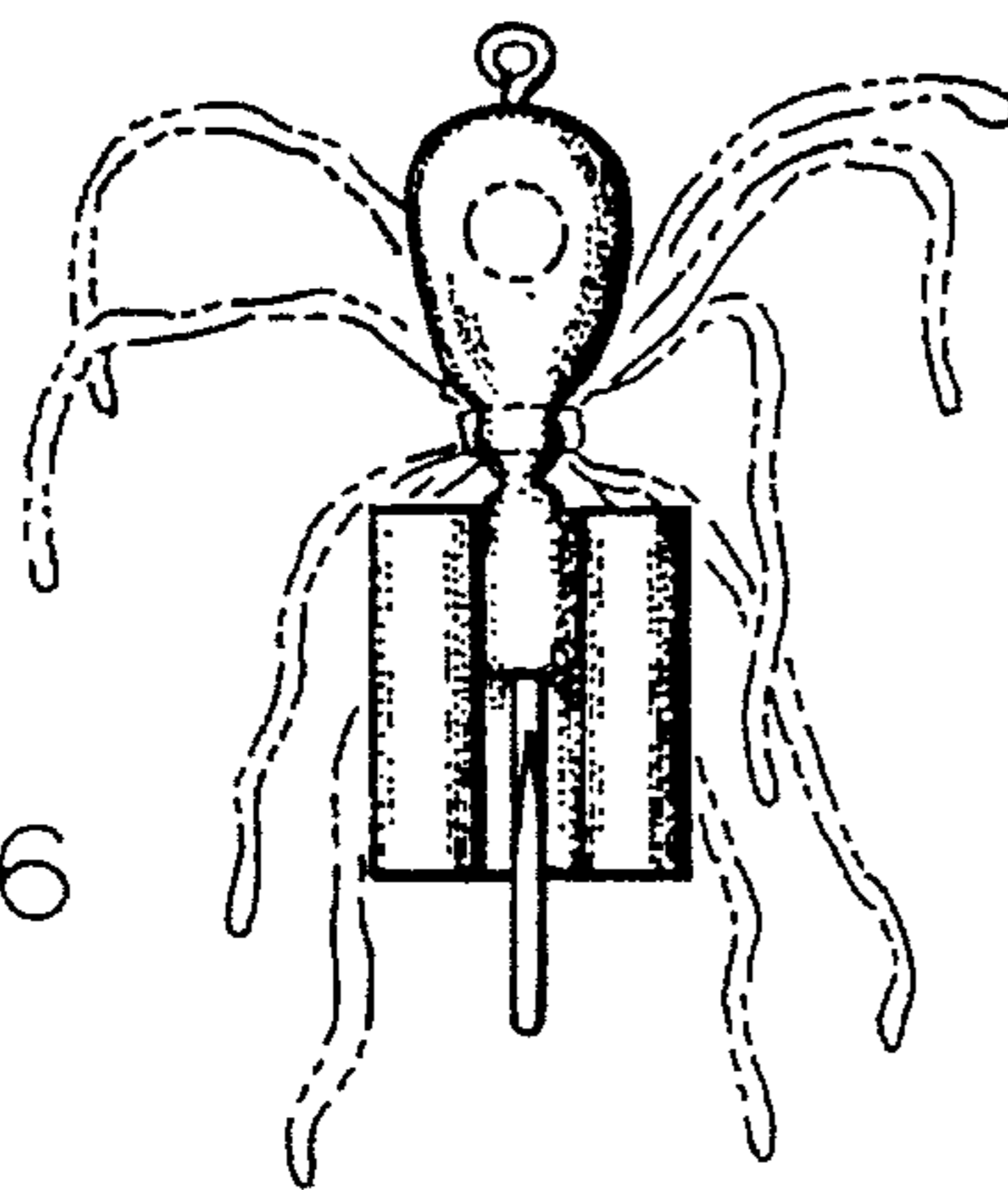

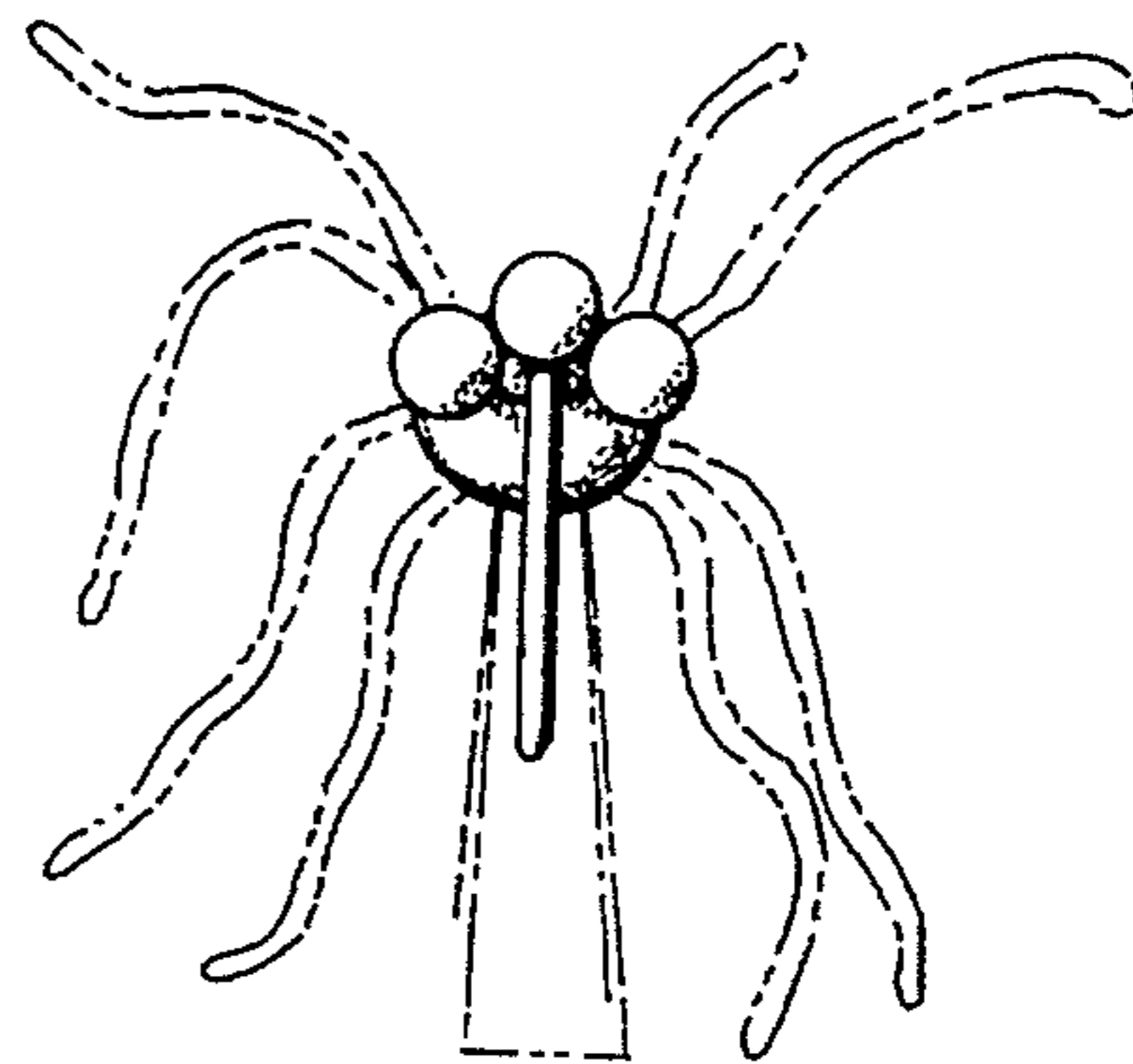

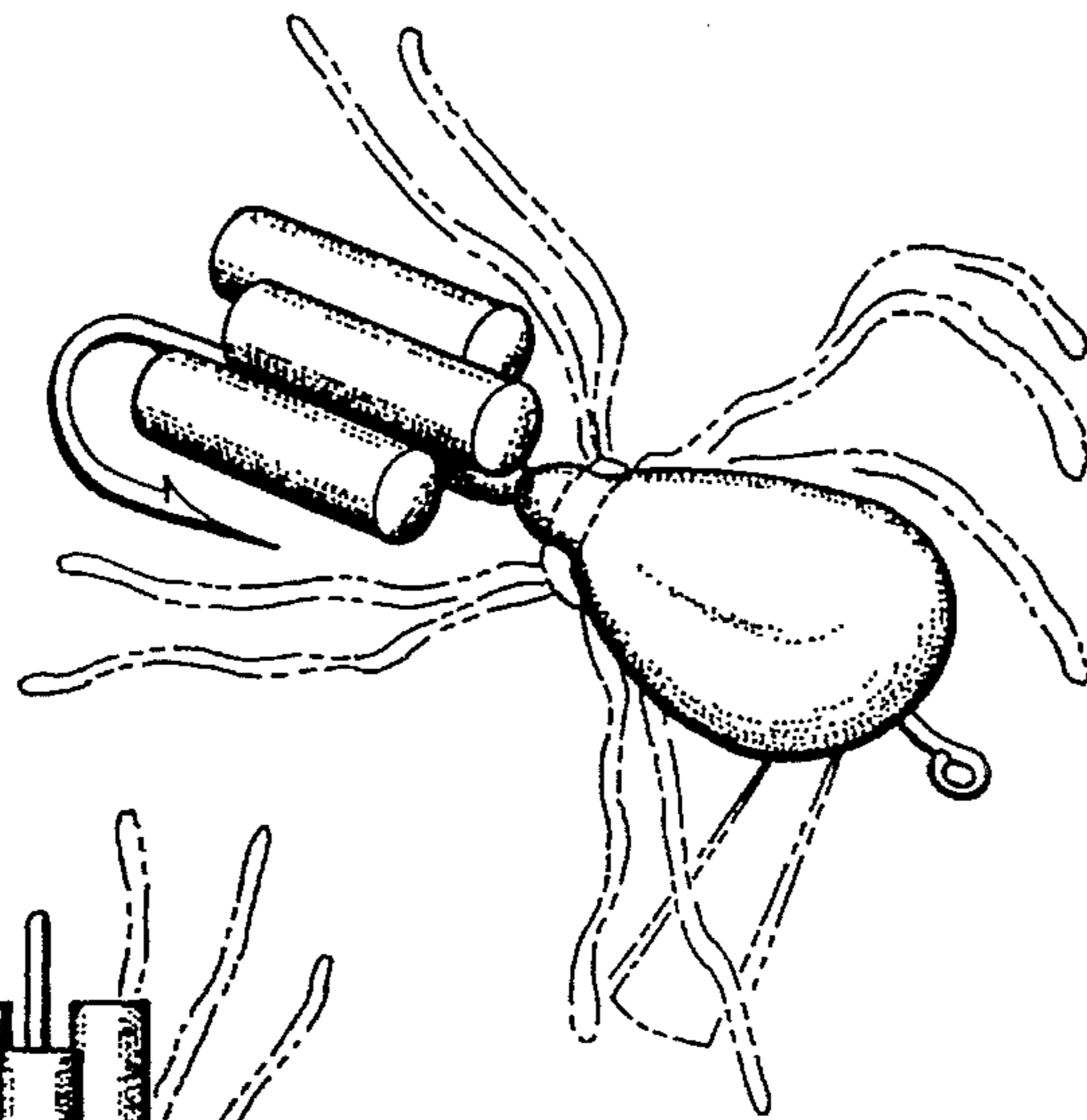

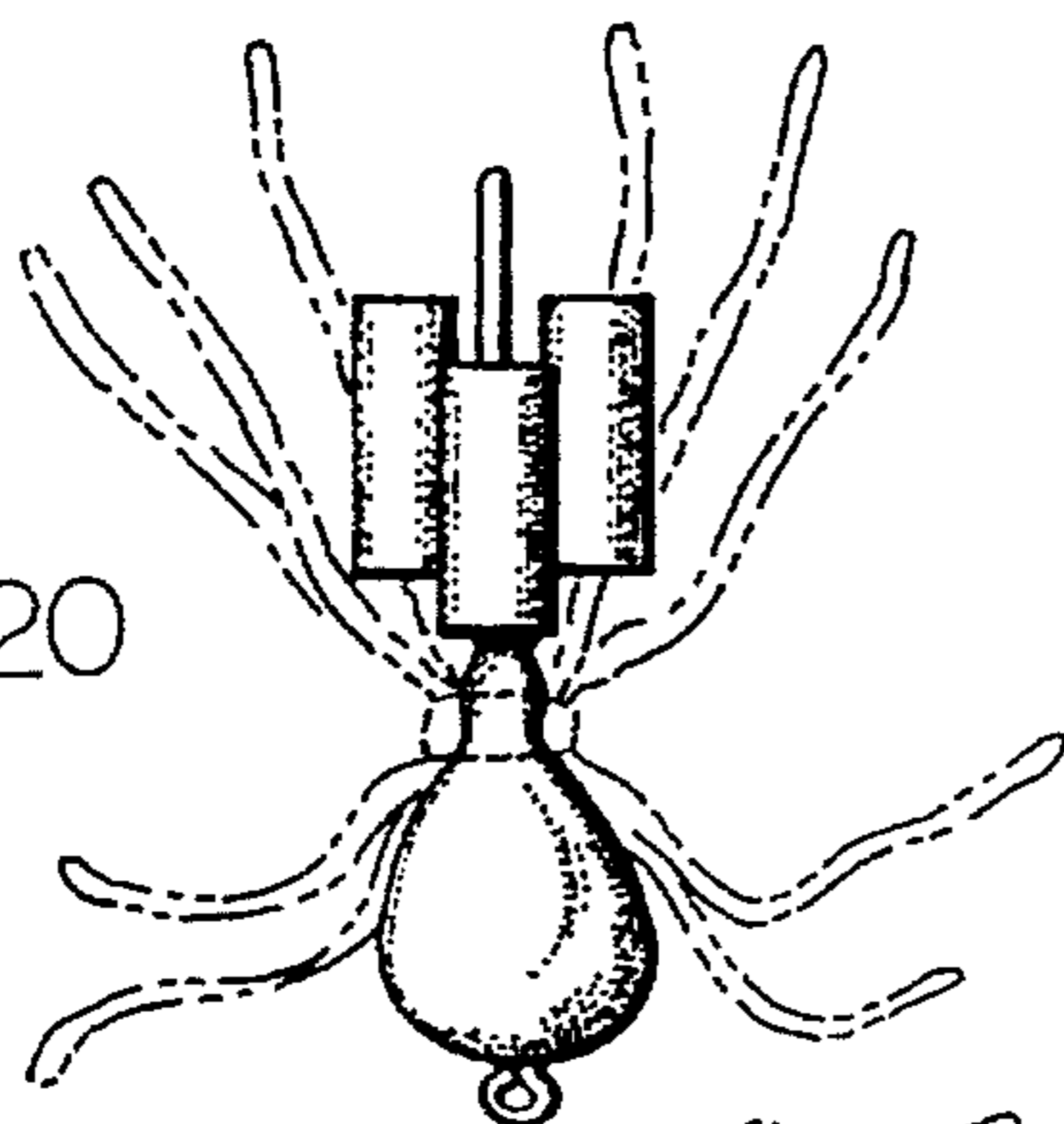

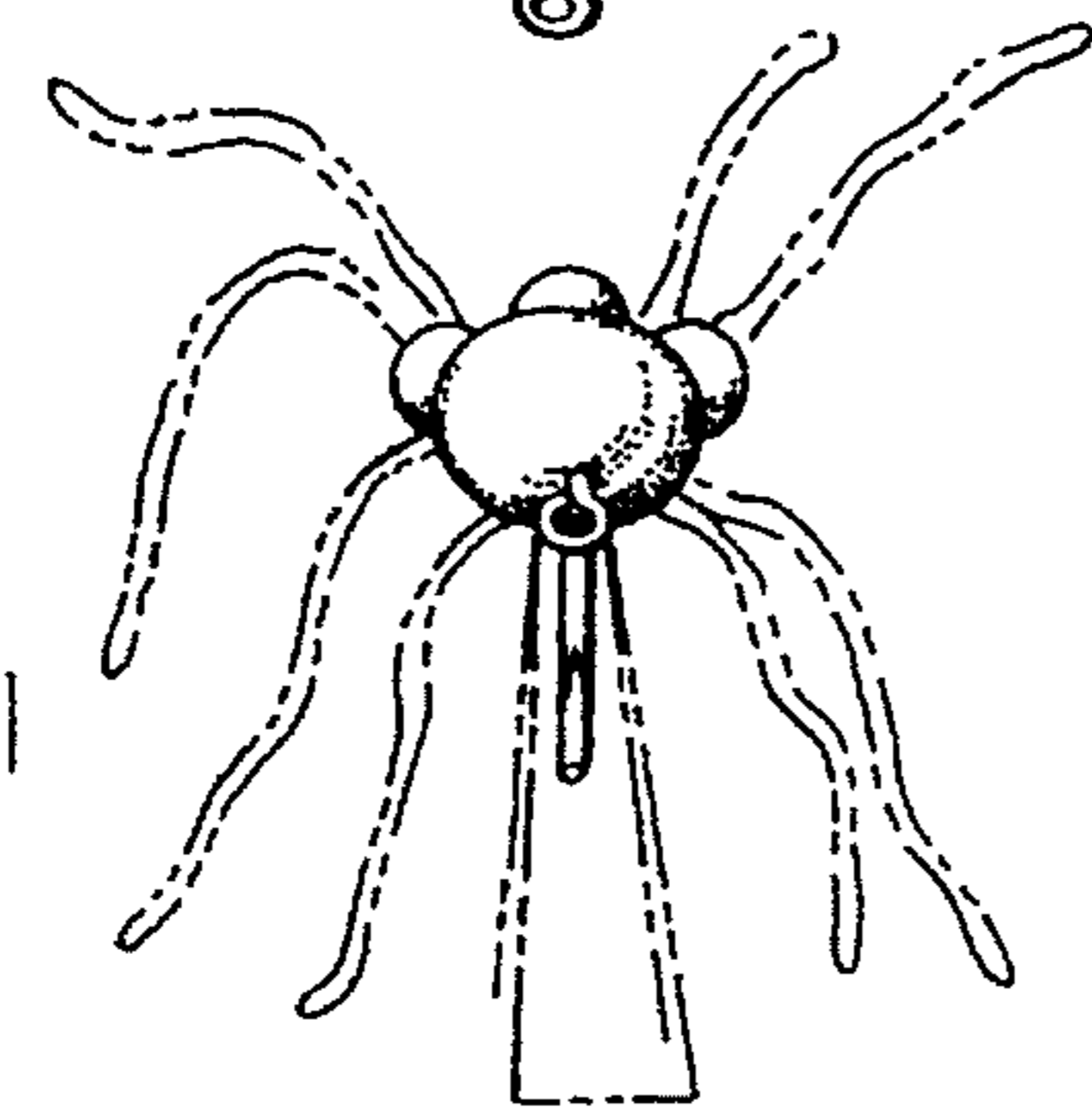

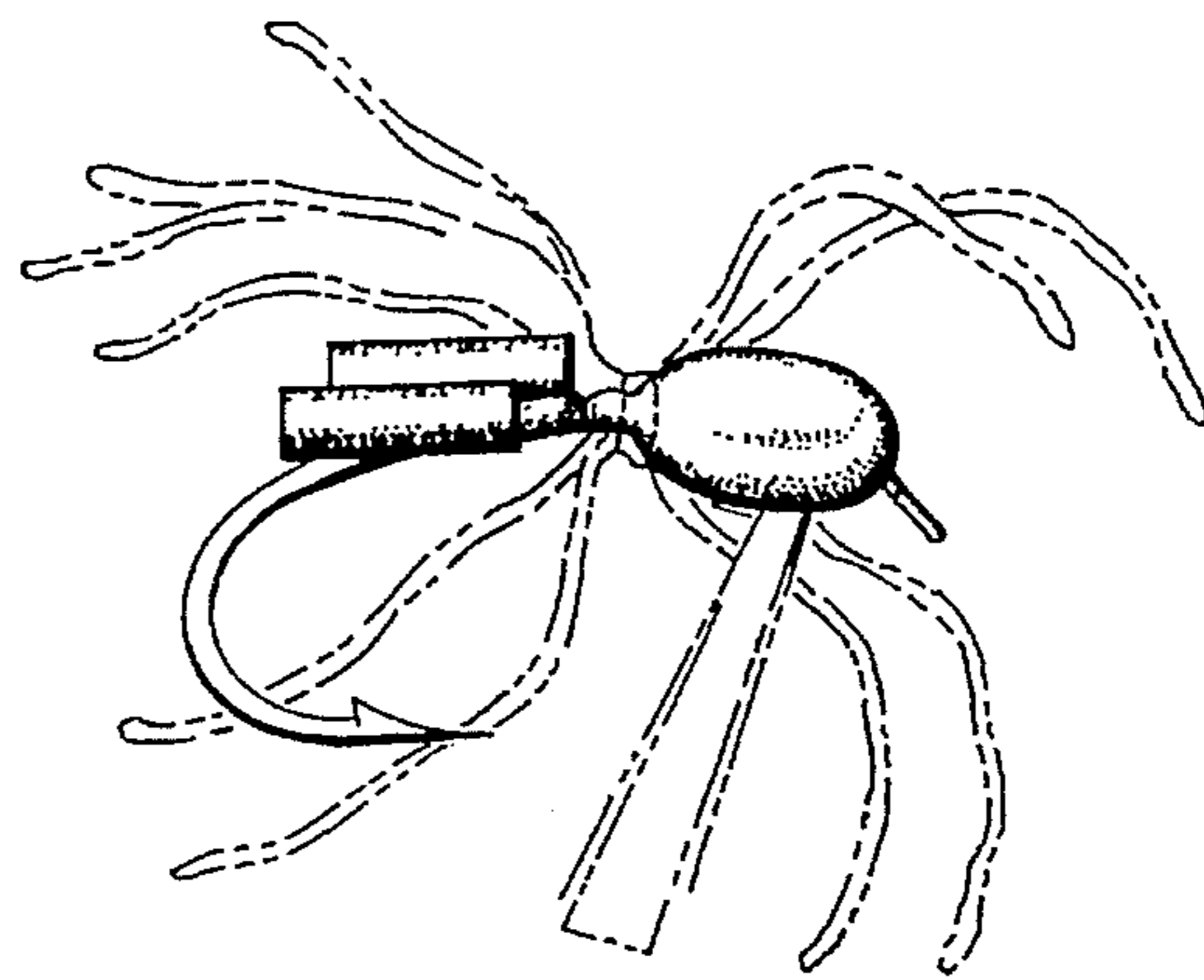

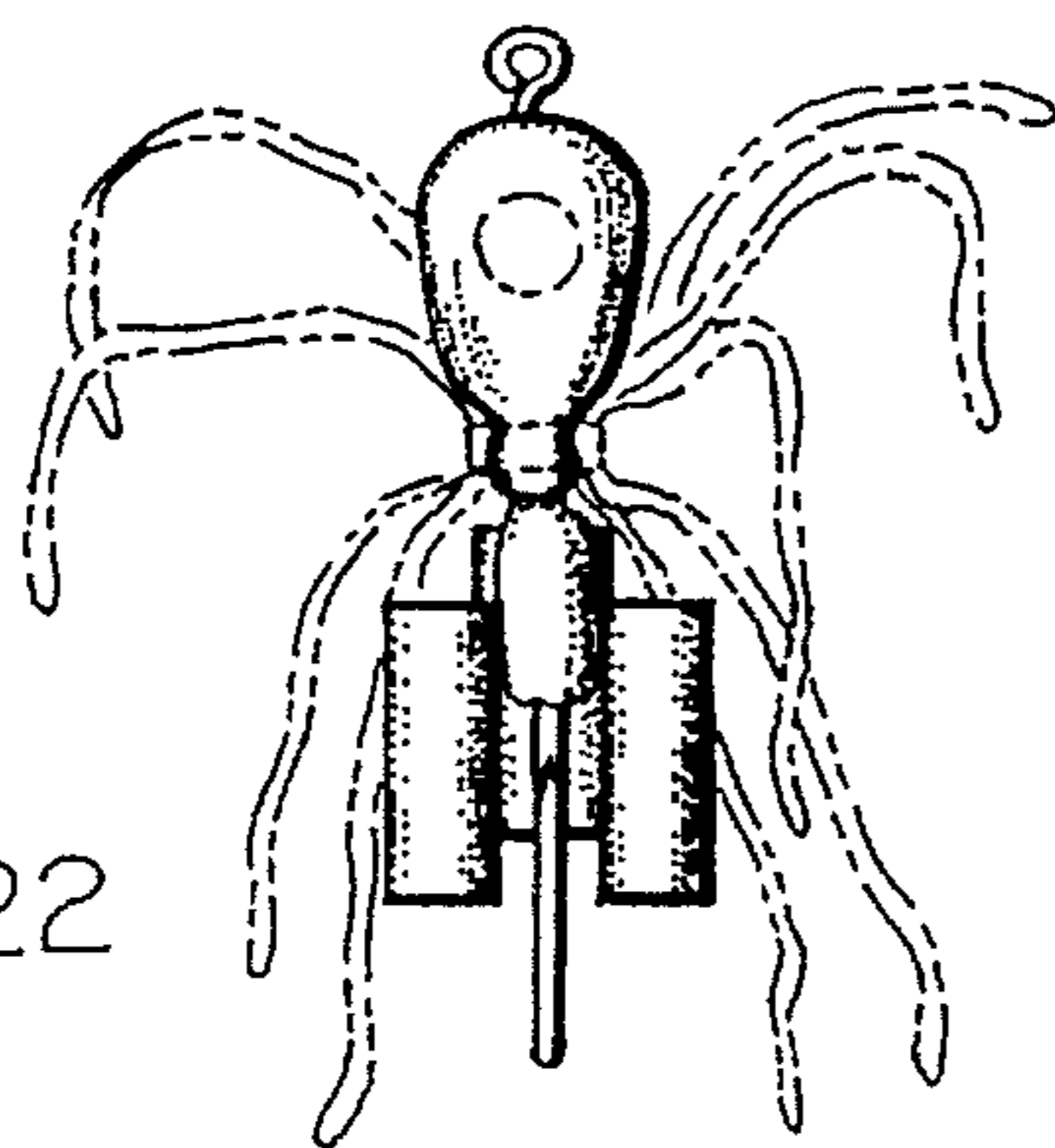
