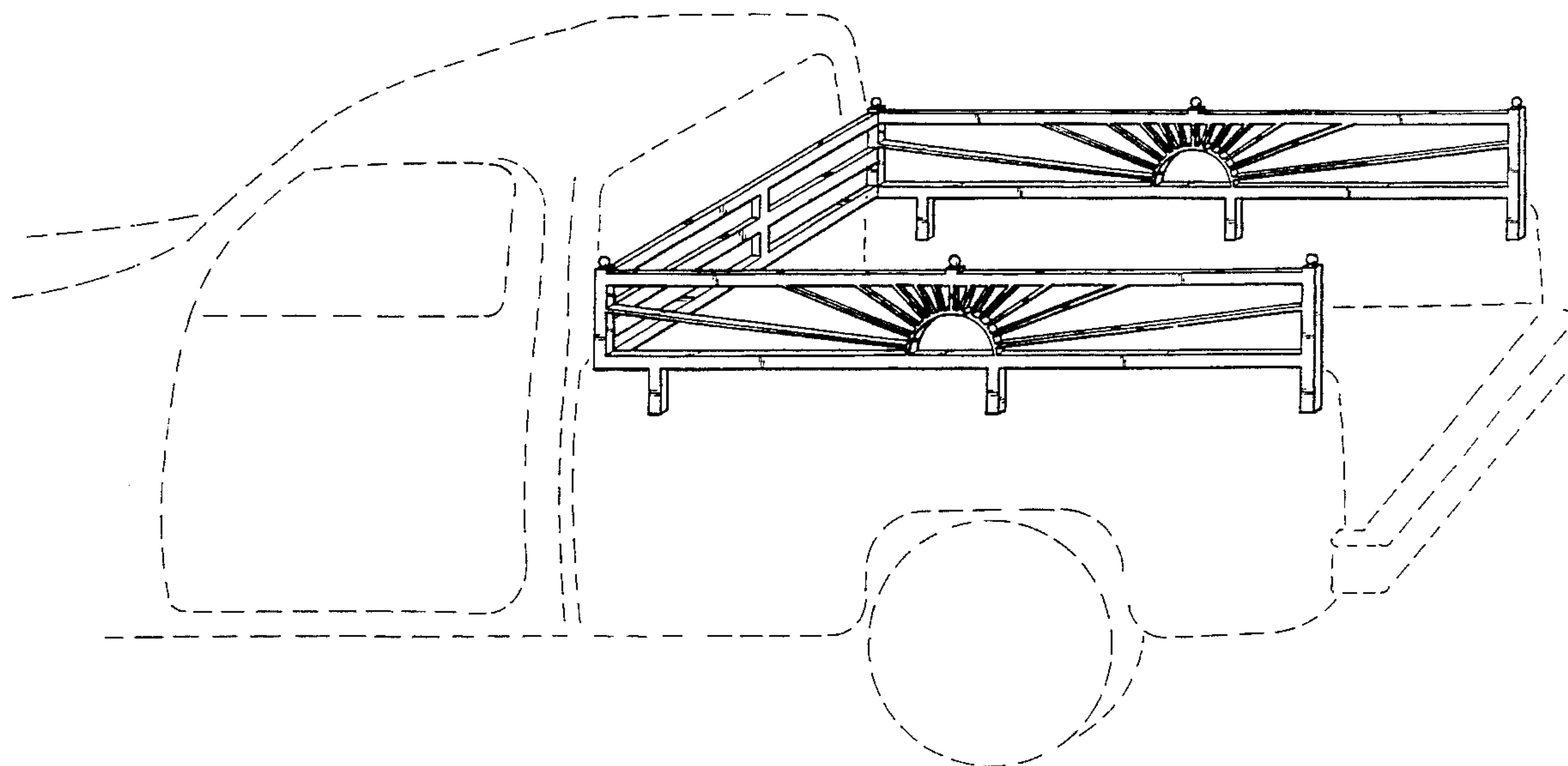
[57] **CLAIM**

The ornamental design for a truck rack, as shown and described.

**DESCRIPTION**

FIG. 1 is an environmental perspective view of a truck rack showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a left side elevational view, with the right side being a mirror image thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a front elevational view thereof; and,  
FIG. 6 is a rear elevational view thereof.

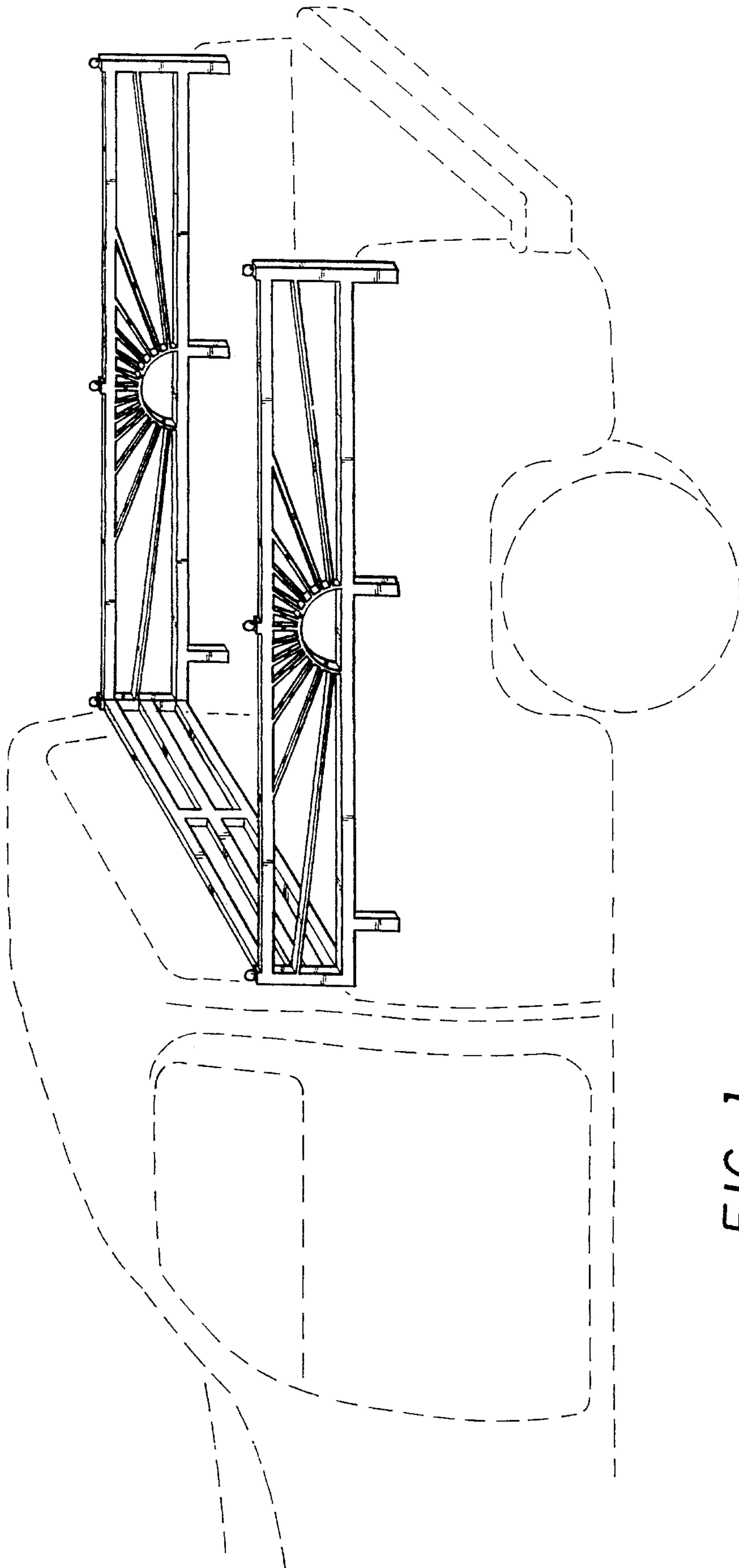

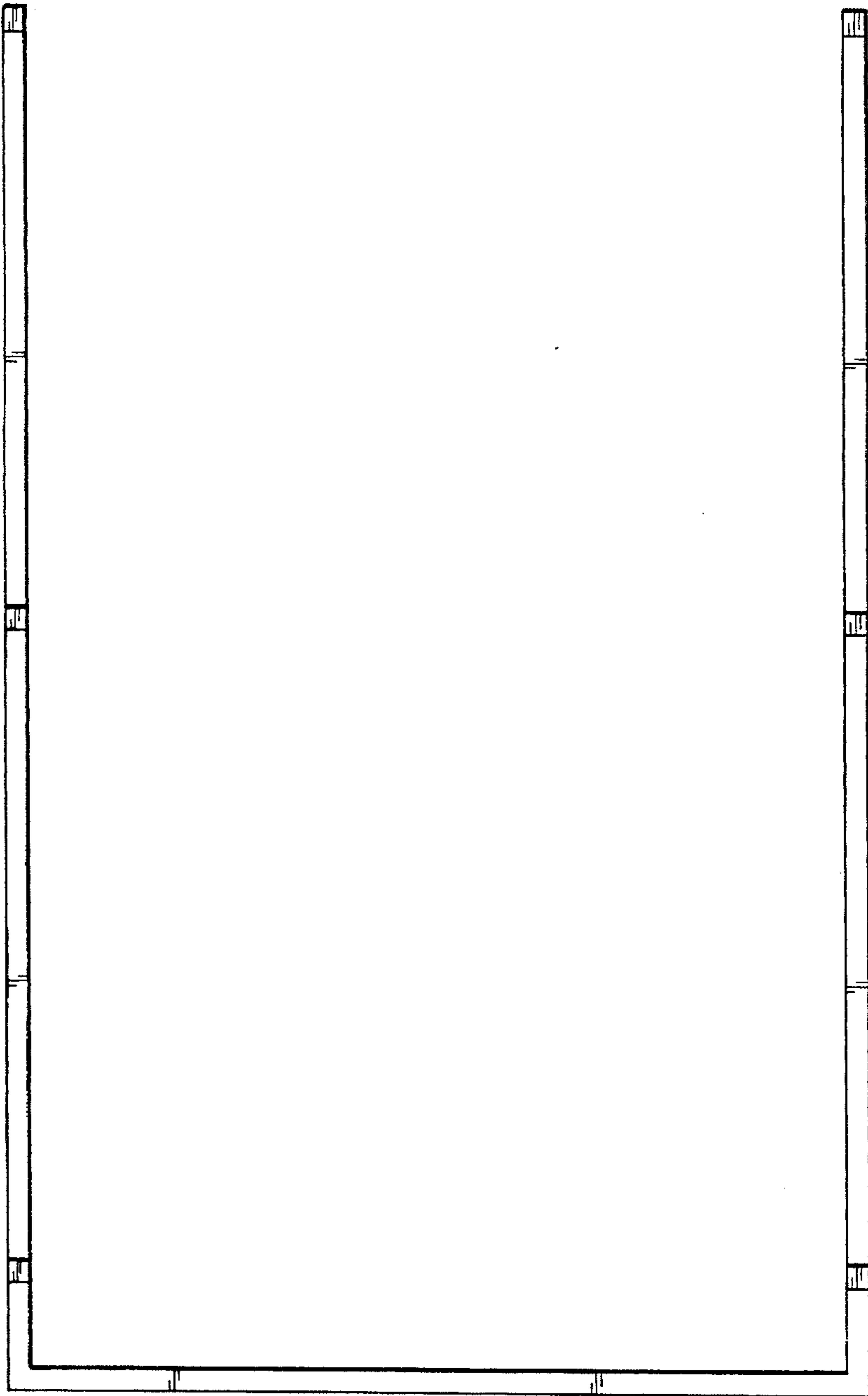
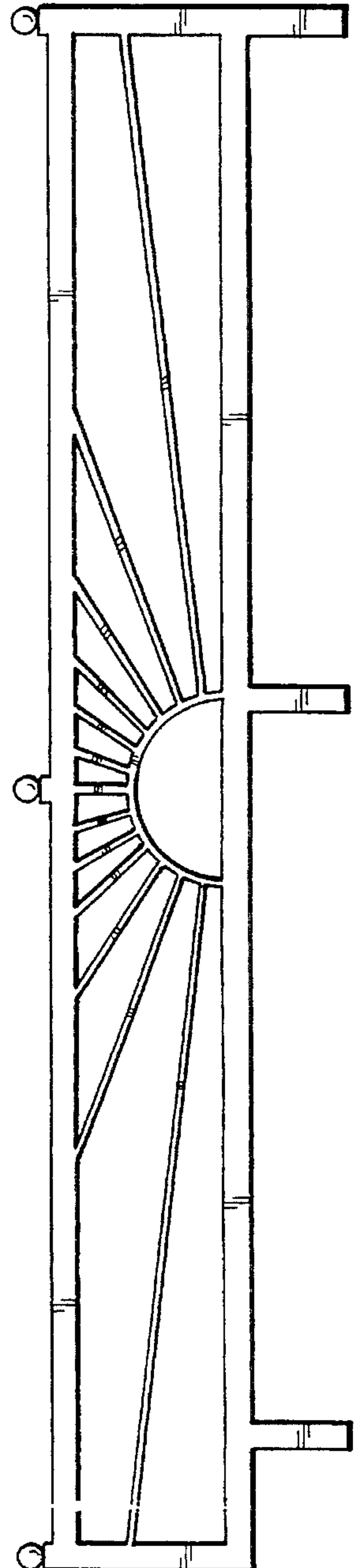

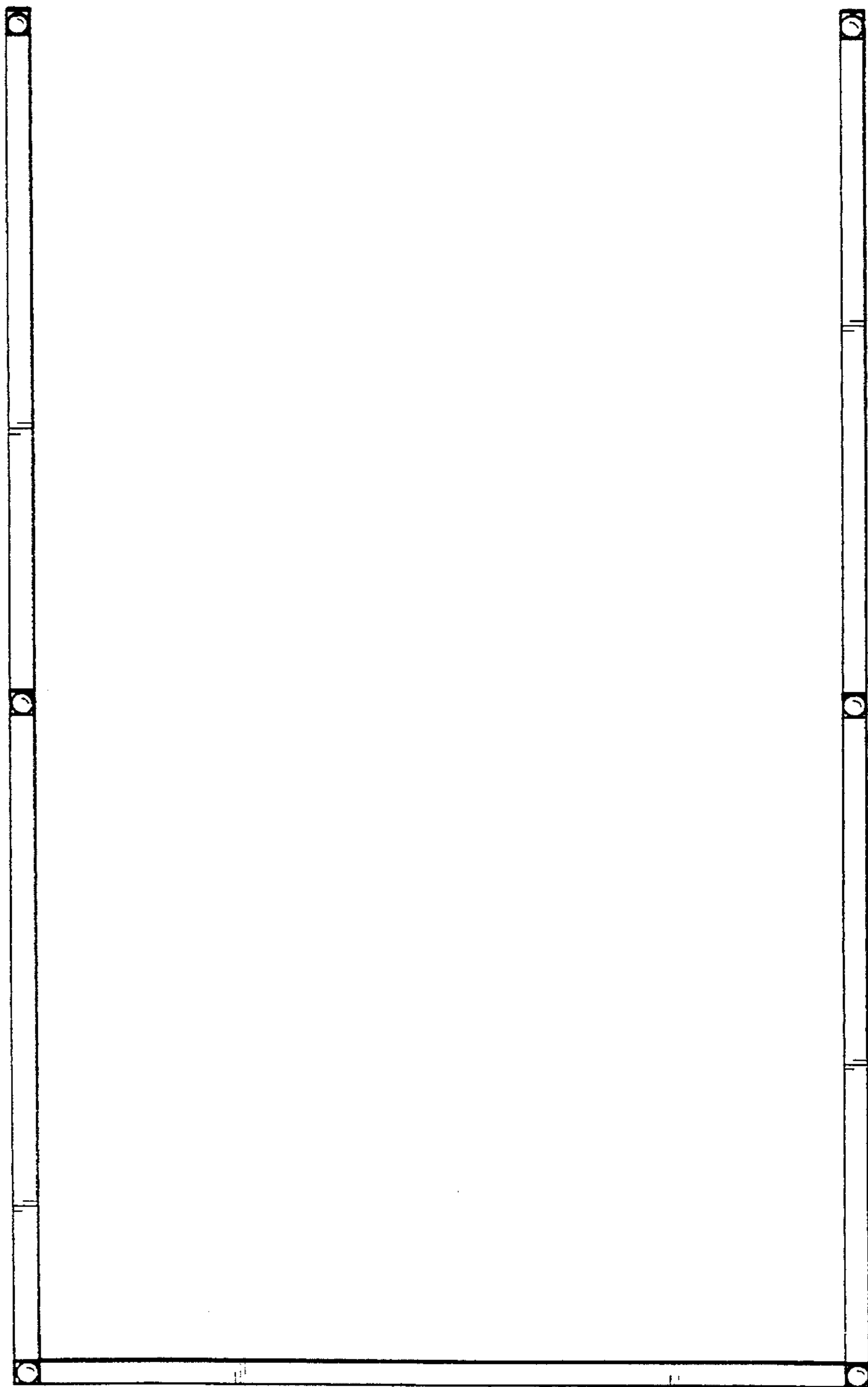

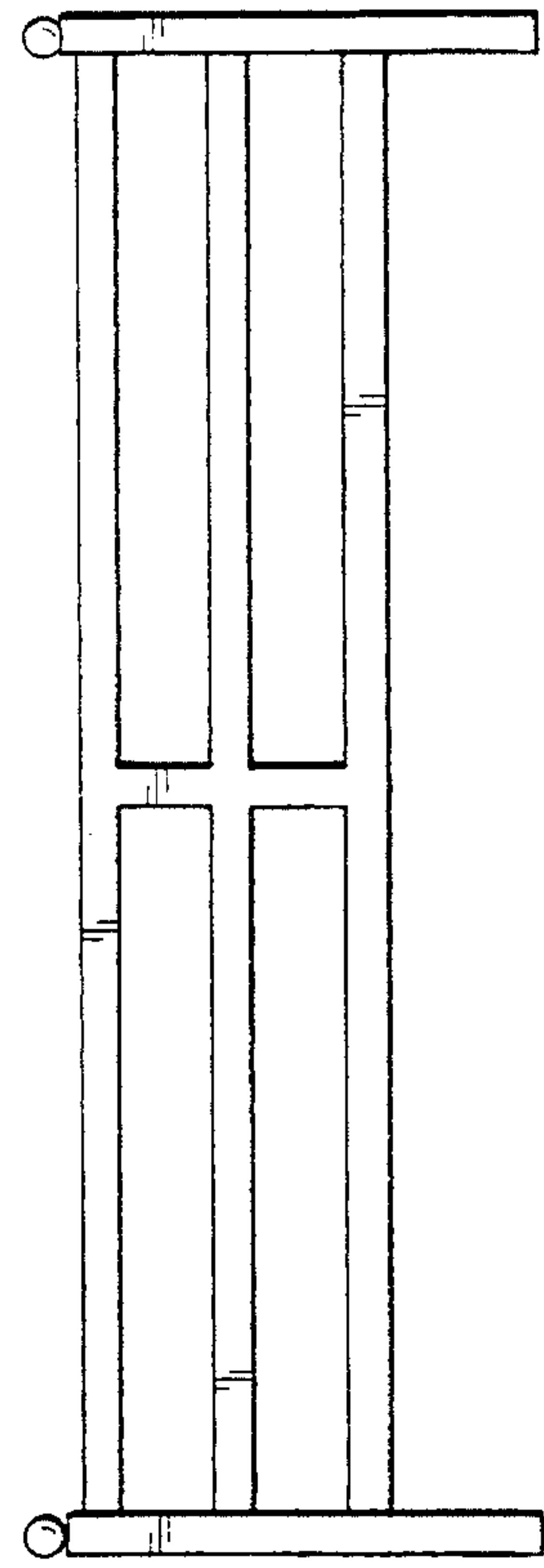

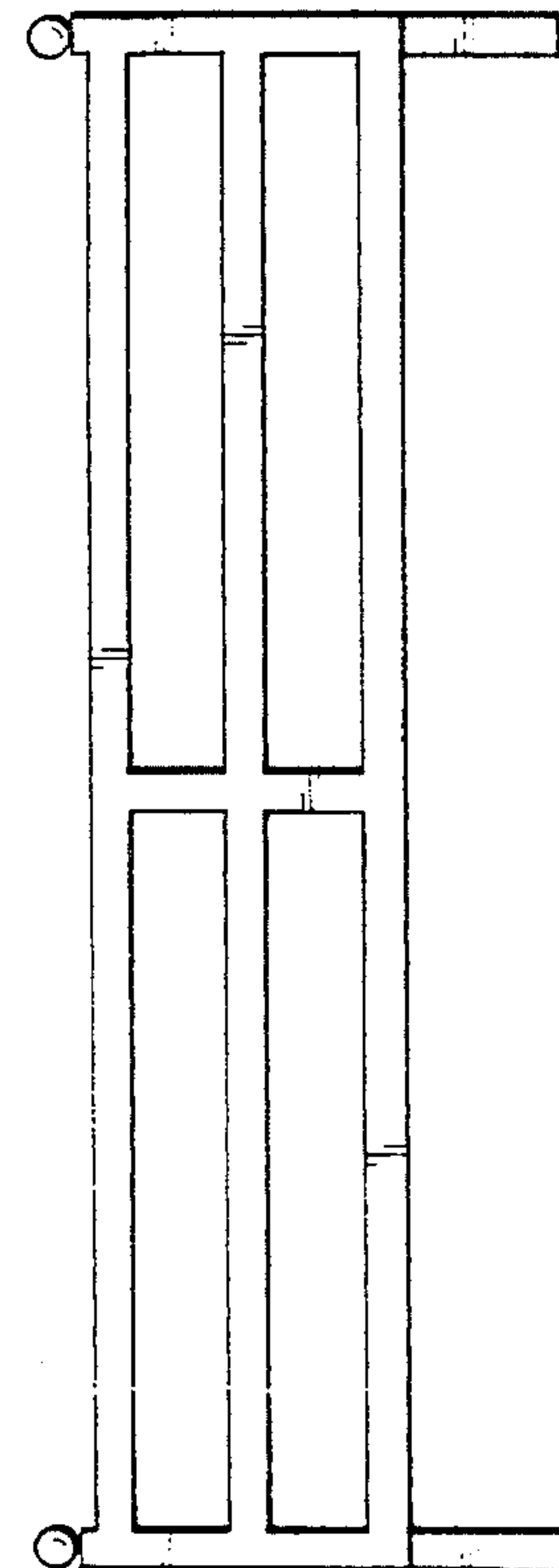
