The ornamental design for a bullet holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of a bullet holder according to the

present invention;

FIG. 2 is a left side view of the bullet holder shown in FIG. 1;

FIG. 3 is a front view of the bullet holder shown in FIGS. 1 and 2;

FIG. 4 is a back view of the bullet holder shown in FIGS. 1-3;

FIG. 5 is a bottom view of the bullet holder shown in FIGS. 1-4;

FIG. 6 is a top view of the bullet holder shown in FIGS. 1-5;

FIG. 7 is a left side view of an alternate bullet holder according to the present invention;

FIG. 8 is a side view of the bullet holder shown in FIG. 7;

FIG. 9 is a front view of the bullet holder shown in FIGS. 7 and 8;

FIG. 10 is a back view of the bullet holder shown in FIGS. 7-9;

FIG. 11 is a bottom view of the bullet holder shown in FIGS. 7-10; and,

FIG. 12 is a top view of the bullet holder shown in FIGS. 7-11.

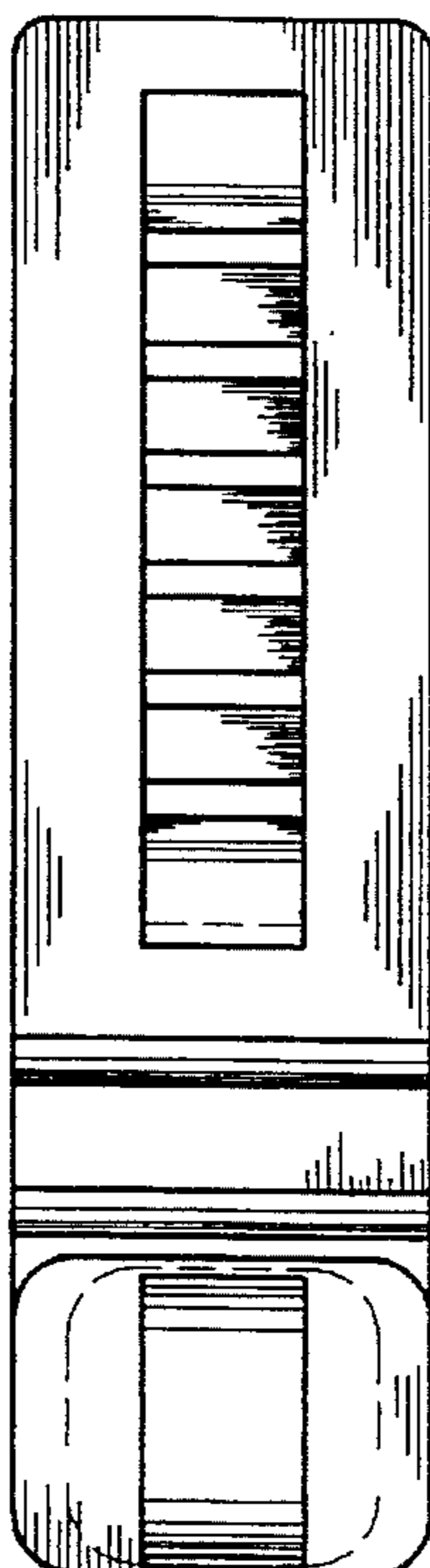

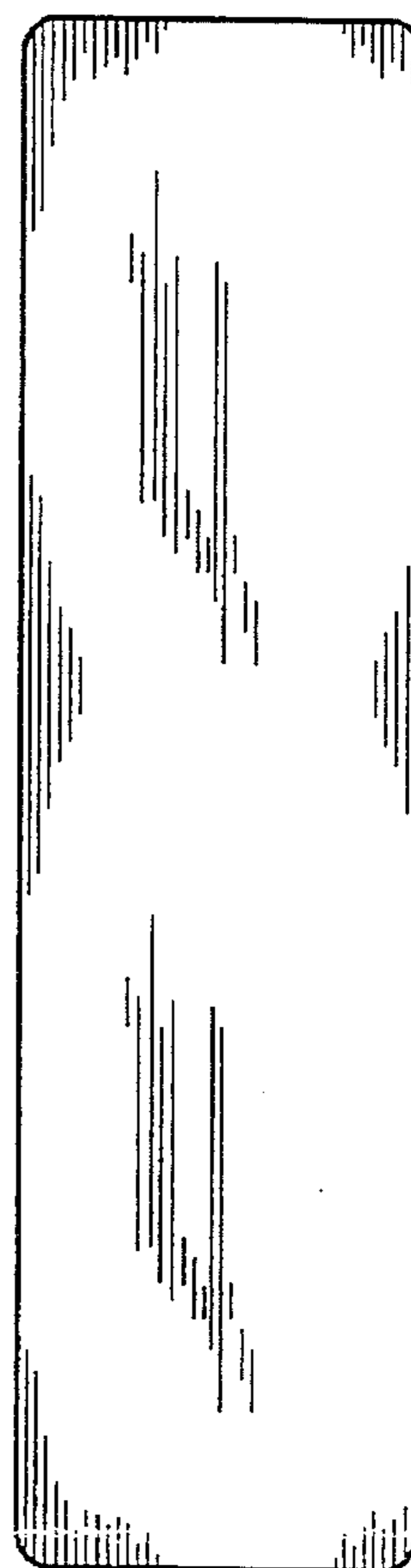
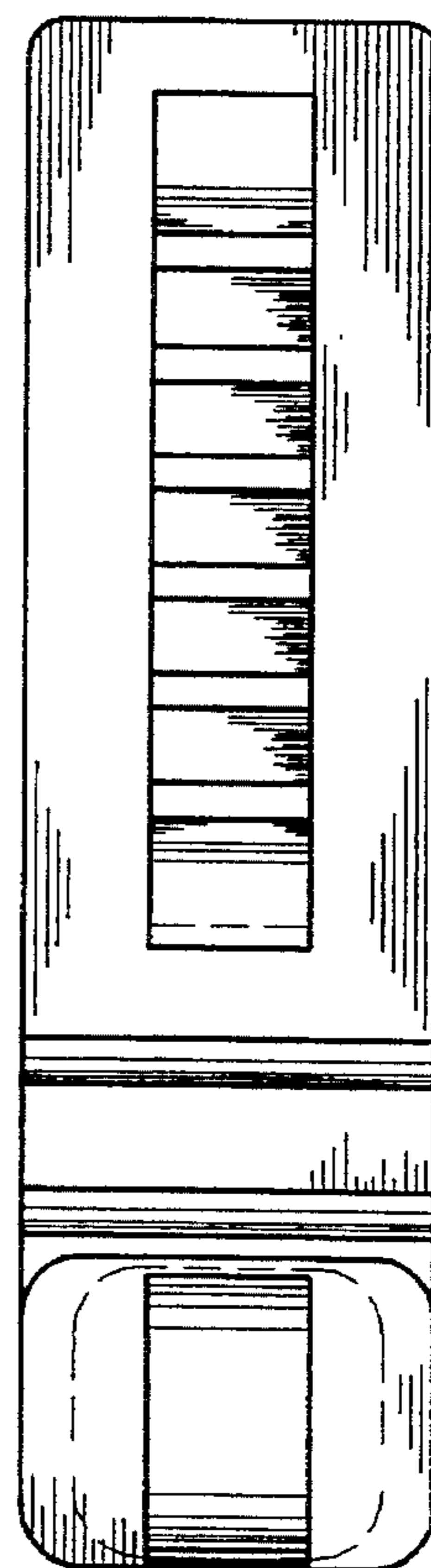

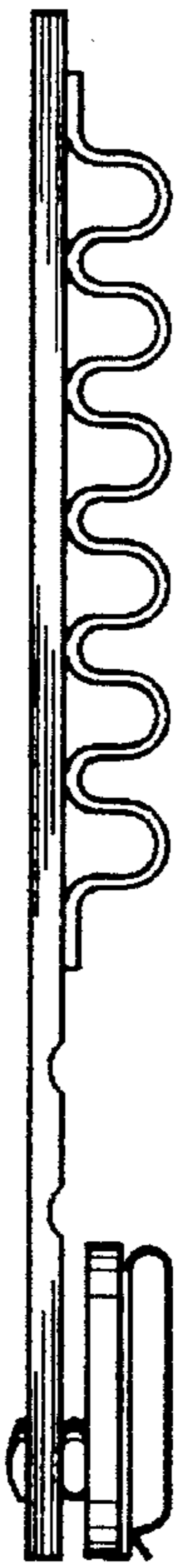

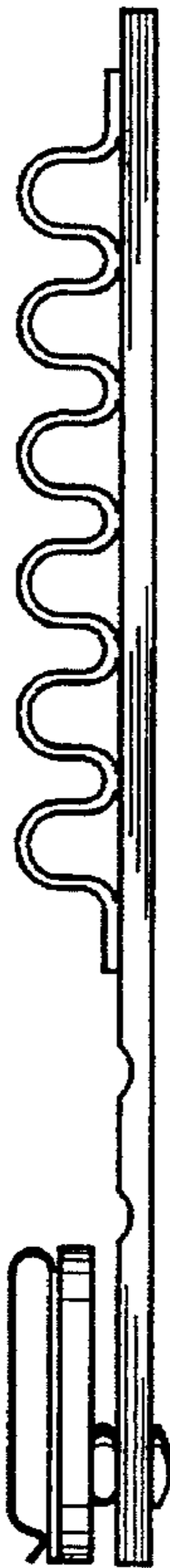

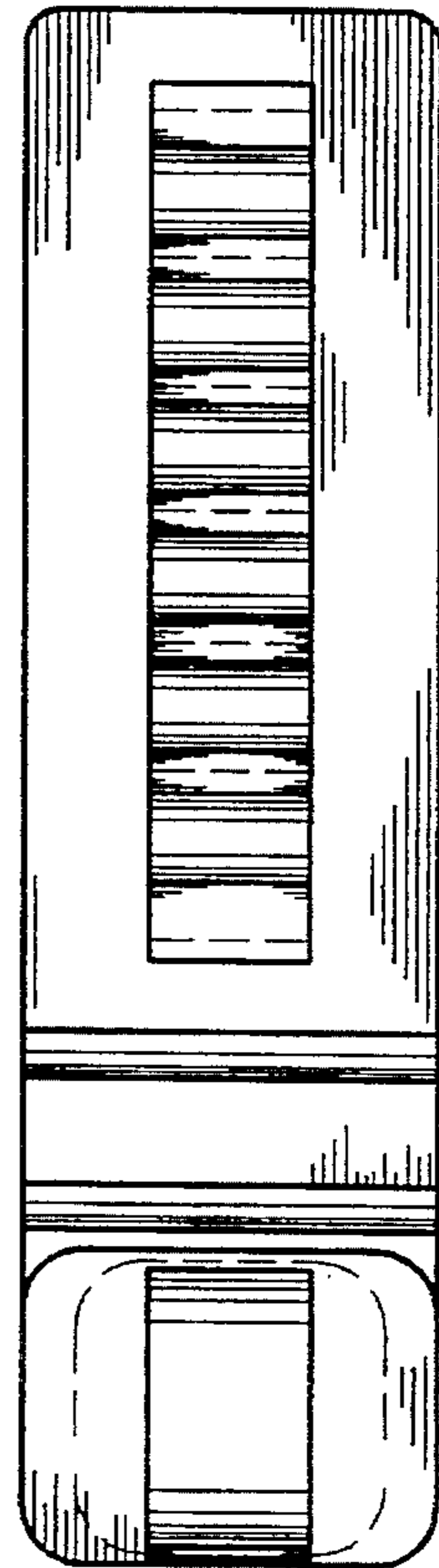
